More Bonds, More Taxes or Bust

Local citizens may be getting bond and tax fatigue. Their financial blood is being extracted from every direction - elementary and high schools, junior college, cities, and counties all want more money. Then the state has multiple bond requests for water, education and roads.

Don't forget the levee and sewage bonds. And then there are the new charges to use police and fire plus more than 100 other taxes that dollar and hundred-dollar a taxpayer to death.

For many, the added bond charges, government fees and school debt relief are greater than their property taxes. The question is why all the extra bond requests when property owners already pay county taxes, everyone pays sales taxes and then the myriad of government user fees for services citizens thought they already paid for.

Many homeowners are paying more than a thousand a month on their property tax bills alone. Then they have their mortgage payment, maintenance costs and utilities which are 60% higher than the national average and predicted to go up even more.

Fuel is more than a dollar higher than locations outside of California. The state has lost its financial mind and it's going for broke.

The No on Measure K people warned that County Administrator Bendorf, County Counsel Abril and all five supervisors drafted, endorsed and promoted a flawed attempt to raise the sales tax rate. They illegally spent hundreds of thousands of taxpayers' dollars to wrench a 1% sales tax increase.

After losing the Measure K case in Yuba County Superior Court they are now dragging out an appeal that is costing taxpayers \$8,000-10,000 a day. As of November 20, \$2,480,000 had been lifted from taxpayers and will be spent by supervisors whether they win or lose their appeal. County jails detain scammers for doing far less damage to the public.

Marysville is already planning to extend its existing 1% addition on top of the state sales tax rate.

Yuba Community College is now asking voters to approve yet another \$228.4 million bond. If passed on March 3, 2020 it would add another \$25 cost per \$100,000 of assessed property value. The amount to repay these bonds (borrowed money) is

House committee to discuss agricultural immigration bill

On Capitol Hill Wednesday, the House Judiciary Committee is scheduled to consider an agricultural immigration bill. The Farm Workforce Modernization Act of 2019 would improve agricultural visa programs and accommodate immigrant agricultural employees already in the United States. The California Farm Bureau Federation announced support for the bill last month, and more than 300 groups and compa-

nies wrote to House leaders this week, urging a vote on the measure.

Agreement boosts rice sales to South Korea

Rice farmers and marketers welcomed announcement of improved access to the South Korean market. Trump administration officials announced Tuesday an agreement they said would give the U.S. a record volume of guaranteed rice sales in Korea. The California Rice Commission described South Korea as one of the state's top overseas

customers, and said the agreement will provide greater access to Korean consumers.

Songbirds provide natural pest control on farms

Planting native trees, shrubs, grasses and wildflowers near farmland can attract songbirds, which in turn can help farmers control insect pests. A University of California study says songbirds can reduce insect pests by up to 46%. The researchers say planting habitat along the borders of fields benefits songbirds and provides natural pest control, because those bird species eat insects and don't damage crops.

Grant aids nutrition incentives at farmers markets

Access to fresh produce for food-assistance recipients will benefit from a grant provided to the California Department of Food and Agriculture. The \$7 million federal grant will help the state offer nutrition incentives to shoppers who use CalFresh benefits at farmers markets and small retail outlets. For every benefit dollar spent, the program provides an additional dollar to spend on California-grown fruits and vegetables.

The best fishing at this time is in the San Francisco Bay area. Rockfish are being taken on a regular basis with limits common at this time. The best area for these feisty fish is the Farallon Islands with a few lingcod for good measure caught in the mix.

Now is the time to get ready for sturgeon fishing? These monsters usually come up rivers after the rains muddy up the water but we have reports of some fish being caught at this time. Look for a good year for sturgeon when winter finally comes.

In regards to the weather we asked our weather guy for a prediction. He advised to expect rain by midweek in the valley and foothills with snow above three thousand feet. He said the snow will be light in the foothills with more in the high country above five thousand feet in elevation. In regard to the rain he predicts heavy rain at times with a possibility of two inches of rain. We asked him about the temperature and he said to get ready for a daytime drop in temperature of over 20 degrees with night time temps possibly dropping into the high twenties and middle thirties.

We hear the Department of fish and Wildlife dumped a bunch of trout into Scotts Flat Reservoir last week. This water is

located above Nevada City. Turn right off of State Route 20 from Nevada City at the Five Mile House to the recreation area.

Local anglers are in the spotlight. Congratulations goes out to Marysville's **Michael Brown** on his 8 ½ pound rainbow trout which was caught at Collins Lake near the dam fishing with night crawlers and to Yuba City angler **Jerry Kendrick's** on his 58.5 pound sturgeon. Jerry was fishing

at the Sacramento/Delta when the fish hit his salmon roe. Kudos also goes out to **Chandler Chan**, who lives in Grass Valley. Chandler landed a 7.25 pound rainbow trout while fishing at Collins Lake near the power lines.



The cost of power outages

Regardless of the massive inconvenience caused by the widespread power outages, it is a real cost to consumers and businesses alike.

The power company responsible for instigating the blackouts could suffer from a bad reputation and consumer ire true, but real economic damage is caused when consumers stay home while the businesses they may have utilized were shuttered due to the lack of electrical power.

It's hard to put a figure on just how much revenue may have gone by the way-side as the main streets of many towns and cities sat idle without power. Indeed my home town looked like a ghost town when the power was out and it wasn't hard to conclude business revenue was at a standstill.

Michael Ware of the Stanford Woods Institute estimates the potential losses in California reached a staggering 2.5 billion at small businesses and homes with at home endeavors. Mr. Ware excluded large businesses in the figure stating many have back up plans and systems for just such an event. No telling just how much these conglomerates lost but one can only imagine the hardship felt by small mom and pop stores that run on a shoe-string budget. Missing entire days of revenue, it's a foregone conclusion many now find themselves in dire straits as their monthly budgets turned red as the lights went black. For those businesses handling perishables, the damage was likely multiplied as the lack of refrigeration sent their wares into the garbage can out back which may have been a total loss and one not normally covered by insurance.

In my local town, some small businesses are reaching out on social media to get customers back in their establishments and rumors of hurting proprietors swirl around in conversation circles.

No doubt a handful of business running their finances close to the surface may find themselves facing bankruptcy due to their inability to make up the losses. An unfortunate statistic and a hard lesson to be learned about the need for financial cushioning when establishing business budgets for what-ifs.

Simply put some businesses barely turn a profit and any hole in the revenue stream can start a vicious downward financial spiral. Never being able to make up lost revenue, the fixed costs to operations don't mirror the deficit in income. Simply put, many business costs cannot be avoided regardless of whether the doors are open or not.

Those business owners with health balance sheets might be OK but others can't take a 5% hit to revenue, their profit margins are that thin. Case in point for turning a healthy profit and being a prudent business owner that watches costs and squirrels away funds for such occurrences as unforeseen power outages.

On the flip side those with generators did a landmine business. A testament to being prepared. For someone's loss can be someone else's gain. Although few anticipated massive power outages in their budgets, for those that did have power back up systems or those nimble enough to obtain such, the increase in business from desperate homeowners looking for supplies likely more than paid for those generator systems and some.

Needless to say those selling and servicing back up power systems also saw a lot of new business. An odd and likely welcome surprise from an otherwise unfortunate situation. From speaking with many in this indus-

try, most were exhausted from non-stop calls from desperate homeowners looking to get electricity to power at least a minimal of household appliances.

The question now becomes should a small business and indeed homeowners spend the money on a backup power system. Depending on individual power requirements, the cost could run from a few hundred for a small portable generator to many thousands of dollars for a larger system to power high square footage establishments.

No doubt there is likely at least a temporary shortage of available generators due to the sudden spike in demand and luckily the worst of fire threats may be over because of the turning of the seasons but the situation will likely be on us next year when the summer heat and seasonal weather patterns once again bring the threat of widespread area fires.

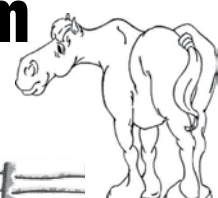

More Bonds, More Taxes or Bust

estimated at \$412 million, nearly double what is being borrowed.

By March 2020, taxpayers will still owe \$191 million on the 2006 bonds passed by voters according to the Yuba County Auditor/Controller. (Four bonds passed in 2006 will pay off as follows – A on 8/1/2031; B on 8/1/2046; C on 8/1/2050; D on 8/1/2039). If the new bond request is granted in March 2020 citizens will then owe \$603 million to repair and expand the various Yuba College sites. We are burying future generations in debt.

The new bond request is coming as state funding for Community Colleges has never been higher and attendance is

decreasing. While Community Colleges (junior colleges) nationally are booming California's have reached a 20-year low in enrollment.

In 1965-66 Community Colleges received 38% of all higher education funding with the State Colleges getting 25% and the University system getting 37%. By 2016, Community Colleges were guaranteed 58% of the higher education pie with State Colleges 20% and Universities 22%.

Community College funding is at an all-time high according to the Public Policy Institute of California approaching \$7,000 per student in 2017.

California has been

investing more in higher education than the rest of the nation. Between 2010, the beginning of the economic recovery, and 2015–16, California increased per student funding by 15%. Average investment nationwide increased 2% during this period, while some large states—like Pennsylvania and Texas—cut funding by about 20%.

The number of tax, bond and utility rate appeals is mind-boggling. The March and November 2020 elections may be a tipping point as to whether voters have tired of the state's socialist bent.

Leadership Paralysis

Furthermore, to make a "cash cow" and political points off those who are broken and downcast is despicable and deserving of punishment. Some leaders just aren't very intelligent. Others are disingenuous, dishonest and conniving. Aberrant leaders are a much more serious problem and threat to the nation than addicts running amuck.

Not arresting or often not even citing people for petty crimes, lowering penalties for thefts, and paying people to remain addicted and irresponsible is incentivizing aberrant behavior that leads to more serious crimes.

Society has the rehabs, the treatment skills and medicines to fashion an emergency response strategy to addiction. All inmates with a substance abuse past could be treated before release, prescriptions written and a rehab arranged where necessary. Gaps in the system of care and no exit plan lead to relapse, overdoses, and higher rates of recidivism.

When addicts in the

community ask for treatment they should be responded to like we address a medical emergency. Today, for medical problems we have urgent cares and also hospital emergency departments.

Addicts sent out of the emergency department and elsewhere without a treatment plan or with only recommendations is a formula for failure. If the addict is ready and needs a rehab the medical people should do any pre-entry exam, TB tests etc. and arrange for transport to a facility immediately.

Addicts often lack the money, transportation, medical insurance and the patience to jump through bureaucratic hoops while experiencing withdrawals. A coordinated intervention is necessary.

If the therapeutic community is serious about a holistic approach to addiction, there is no reason that an immediate response for addicts wanting treatment and a program cannot be established. The same

goes for the mentally ill. In fact, many people thought to be mentally ill, when detoxed and introduced to a healthy routine get their life and mind back.

The treatment community can learn from the food industry. At one time restaurants only offered food at their facilities and during limited hours of operation. Food entrepreneurs then came up with 24-hour service, take-out, drive-through, food trucks, catering and home delivery. They met the consumer where they were.

What's the matter with the medical and mental health world? We're much better at delivering a taco or pizza than saving an addict or alcoholic. The medical and treatment community have the goods but maybe lack the will to alter their methodology to deliver services in a way that could change and save lives.

Ranking Republican Explosive Remarks Should Have Put An End To 'Impeachment'

According to CNN politics on Tuesday, November 19, 2019, Ranking Minority Leader Congressman Nunes remarked;

If you watched the impeachment 'inquiry' last week, you may have noticed a disconnect between what you actually saw and the mainstream media accounts describing it. What you saw were three diplomats, who dislike the President's Ukraine policy, discussing second-hand and third-hand conversations about their objections. Meanwhile, they admitted they had not talked to the president about these matters, and they were unable to identify any crime or impeachable offense the President committed.

But what you read in the press were accounts of shocking, damning, and explosive testimony that fully supports the Democrats' accusations.

If these accounts have a familiar ring, it's because this is the same preposterous reporting the media offered for three years on the Russia hoax. On a near-daily basis, the top news outlets in America reported breathlessly on the newest bombshell revelations showing that President Trump and everyone surrounding him are Russian agents. It really wasn't long ago that we were reading these headlines:

From CNN: "Congress investigating Russian investment fund with ties to Trump officials." That was false.

From the New York Times: "Trump Campaign aides had repeated contacts with Russian intelligence." That was false.

From Slate: "Was a Trump server communicating with Russia?" That was false.

From New York Magazine: "Will Trump be meeting with his counterpart or his handler?" That was false.

From the Guardian: "Manafort held secret talks with Assange in Ecuadorian Embassy, sources say." That was false.

And from Buzzfeed: "President Trump directed his attorney Michael Cohen to lie to Congress about the Moscow Tower project." That was false.

There was no objectivity or fairness in the media's Russia stories—just a fevered rush to tarnish and remove a president who refuses to pretend that the media are something different than what they really are—puppets of the Democratic Party.

With their biased misreporting on the Russia hoax, the media lost the confidence of millions of Americans. And because they refused to acknowledge how badly they botched the story, they've learned no lessons and simply expect Americans will believe them as they try to stoke yet another partisan frenzy.

In previous hearings, I've outlined three questions the Democrats and the media don't want asked or answered. Instead of shedding

light on these crucial questions, the media are trying to smother and dismiss them.

Those questions are:

First, what is the full extent of the Democrats' prior coordination with the Whistleblower and who else did the Whistleblower coordinate this effort with?

The media have fully accepted the Democrats' stunning reversal on the need for the Whistleblower to testify to this committee. When the Democrats were insisting on his testimony, the media wanted it too.

But things have changed since it became clear the Whistleblower would have to answer problematic questions, including

What was the full extent of the Whistleblower's prior coordination with Chairman Schiff, his staff, and any other people he cooperated with while preparing the complaint?

What are the Whistleblower's political biases and connections to Democratic politicians?

How does the Whistleblower explain the inaccuracies in the complaint?

What contact did the Whistleblower have with the media, which appears to be ongoing?

What are the sources of the Whistleblower's information, who else did he talk to, and was the Whistleblower prohibited by law from receiving or conveying any of that information?

The media have joined the Democrats in dismissing the importance of cross-examining this crucial witness. Now that the Whistleblower has successfully kickstarted impeachment, he has disappeared from the story—as if the Democrats put the Whistleblower in their own Witness Protection Program.

My second question: What is the full extent of Ukraine's election meddling against the Trump campaign?

In these depositions and hearings, Republicans have cited numerous indications of Ukrainians meddling in the 2016 elections to oppose the Trump campaign. Many of these instances were reported, including the posting of many primary source documents, by veteran investigative journalist John Solomon.

Since the Democrats switched from Russia to Ukraine for their impeachment crusade, Solomon's reporting on Burisma, Hunter Biden, and Ukrainian election meddling has become inconvenient for the Democratic narrative, and so the media is furiously smearing and libeling Solomon.

In fact, the publication The Hill told its staff yesterday it would conduct a review of Solomon's Ukraine reporting. Coincidentally, the decision came just three days after a Democrat on this committee told a Hill writer that she would stop speaking to The Hill because it had run Solomon's stories, and she urged the writer to relay her concerns to Hill management.

So now that Solomon's reporting is a problem for the Democrats, it's a problem for the media as well.

I'd like to submit for the record John Solomon's October 31 story titled, "Debunking some of the Ukraine scandal myths about Biden and election interference." I encourage viewers today to read this story and draw your own conclusions about the evidence Solomon has gathered.

The concerted campaign by the media to discredit and disown one of their own colleagues is shocking. And we see it again in the sudden denunciations of New York Times reporter Ken Vogel as a conspiracy theorist after he covered similar issues, including a 2017 Politico piece entitled, "Ukrainian efforts to sabotage Trump backfire."

And my third question: Why did Burisma hire Hunter Biden, what did he do for them, and did his position affect any U.S. government actions under the Obama administration?

We have now heard testimony from the Democrats' own witnesses that diplomats were concerned about a conflict of interest involving Hunter Biden. That's because he had secured a well-paid position, despite having no qualifications, on the board of a corrupt Ukrainian company while his father was Vice President charged with overseeing Ukrainian issues.

After trying out several different accusations against President Trump, the Democrats have recently settled on "bribery"—according to widespread reports, they replaced their "quid pro quo" allegation because it wasn't polling well.

But if the Democrats and the media are suddenly so deeply concerned about bribery, you'd think they would take some interest in Burisma paying Hunter Biden \$83,000 a month. And you'd think they would be interested in Joe Biden threatening to withhold U.S. loan guarantees unless the Ukrainians fired a prosecutor who was investigating Burisma. That would be a textbook example of bribery.

Americans have learned to recognize fake news when they see it, and if the mainstream press won't give it to them straight, they'll go elsewhere to find it—which is exactly what the American people are doing.

Charlie's Comments: By the way, that baloney about Trump withholding military aide without Pro Quid Pro. **It was President Obama who would not deliver lethal military weaponry to the Ukrainians for defense against Russian aggression. Yuba Water Agency Helps Funds Water Supply Reliability, Flood Risk Reduction Projects, New Emergency Response Equipment

Marysville, Ca. Three local agencies received a financial boost today with the help of Yuba Water Agency.

Olivehurst Public Utility District steel water main project - \$1.4 million

A \$1.4 million grant provides funding to help OPUD replace the steel water main it uses to deliver water to approximately 10,000 residents in the disadvantaged community of Olivehurst.

The current steel water main has been in service well past its life expectancy and is prone to leakage and inefficiencies, which leads to the loss of approximately 78 million gallons of water each year.

"Replacing this outdated infrastructure is essential to improving efficiency and maintaining a reliable water supply for the residents in Olivehurst," said Yuba Water Agency Director Doug Lofton, whose district includes Olivehurst.

OPUD will replace approximately 14,000 feet of the aging steel water main with 8-inch-diameter PVC pipe. The district will also replace 25 fire hydrants, 69 8-inch valves and 40 tie-in locations to the existing water main lines.

This is one of several projects that are being presented to the Department of Water Resources to compete for \$24 million in funding for various water projects that benefit disadvantaged communities. That includes water supply and flood risk reduction projects for Yuba County, Reclamation District 784, Linda County Water District, and the cities of Wheatland and Marysville, and the lo-

cal contribution from Yuba Water makes the entire group of projects more competitive for the larger grant.

Yuba Water is able to grant these funds to OPUD because this project will help conserve water, and ensuring a sustainable water supply is a primary agency mission.

Three Rivers Levee Improvement Authority Hallwood flood risk project - \$500,000

Yuba Water Agency also approved a grant for the Three Rivers Levee Improvement Authority to help reduce the flood risk for the community of Hallwood.

The \$500,000 in funding will be used by TRLIA to continue its efforts to strengthen the Yuba River North Training Wall.

"We're happy to expand TRLIA's reach to take the lead on this important flood risk reduction project," said TRLIA Executive Director Paul Brunner. "Yuba Water Agency funding will be used for preliminary engineering, design and environmental work, which is an important first step in project implementation."

Originally, the purpose of the Yuba River North Training Wall was to confine, or train, the boundaries of the Yuba River to manage mining debris. However, during the high-water events in 2017 and 2018, Hallwood experienced localized shallow flooding due to erosion of the training wall. A temporary fix was constructed last year, and this funding will begin the process to find a long-term solution.

Yuba Water Agency's

grant to Three Rivers is part of the agency's long-standing mission to reduce flood risk for Yuba County. In prior years, Yuba Water has assisted TRLIA with policy, technical and financial aid, including carrying the local cost-share for the construction of the Feather River Setback Levee. Yuba Water is repaying \$5.5 million per year for that project.

Reducing flood risk is one of the primary reasons Yuba Water was formed.

Marysville Police Department emergency response vehicle and trailer - \$10,000

This grant will fund an all-terrain vehicle and an all-terrain vehicle rescue trailer for the Marysville Police Department as part of Yuba Water Agency's Bill Shaw Rescue Equipment and Training Grant program.

The new ATV will be used to quickly and effectively respond to people trapped in the river bottoms due to rising water levels, and the trailer will allow officers to stabilize people experiencing medical issues during those incidents.

The Bill Shaw Rescue Equipment and Training Grant Program, which was created in 2018, is designed for first-responder agencies in Yuba County and will cover the one-time costs of up to \$10,000 per applicant annually, associated with the purchase of rescue equipment and specialized personnel training. Since its inception, the program has supported 14 agencies with \$178,500 in grants.
