## Water Agency Partners for Forest Management

Marysville, Ca.

A diverse group of nine organizations announced their commitment to prioritize, plan, and execute forest restoration on an unprecedented scale in the North Yuba River watershed, covering 275,000 acres of the northern Sierra Nevada.

The memorandum of understanding spells out the group's commitment to work together to increase the pace and scale of ecologically-based restoration within the North Yuba River watershed and to prioritize community safety, forest health, and resilience through landscape-scale restoration.

The North Yuba Forest Partnership includes Blue Forest Conservation, Camptonville Community Partnership, National Forest Foundation, The Nature Conservancy, Nevada City Rancheria, Sierra County, South Yuba River Citizens League, The United States Forest Service - Tahoe National Forest, and Yuba Water Agency.

"Many forests in the North Yuba River watershed are criti-

cally unhealthy, overcrowded with small trees and brush," said Eli Ilano, Tahoe National Forest Supervisor. "Unhealthy forests are at a greater risk of high-severity wildfire due to fire suppression and historic timber harvesting practices, a risk that is exacerbated by a changing climate."

The North Yuba River watershed runs through multiple Northern California counties and two national forests, from Yuba Pass to New Bullards Bar Reservoir. The area includes thousands of acres of forest habitat, is an important source of water for downstream users, supports high biodiversity, is home to many rural communities, and offers excellent opportunities for recreation.

"We're loving our forests to death," said Willie Whittlesey, Assistant General Manager of Yuba Water Agency. "A 'hands-off' approach to forest management is no longer an option now that our communities, infrastructure and water supply are at significant risk. To make a

meaningful impact in this massive effort, it's going to take all of us who care about the watershed coming together."

Forests once characterized by large, widely-spaced trees and beneficial low-to-moderate severity fires are now overrun with vegetation that is not fire-resilient. This has increased the risk of destructive wildfire causing significant damage to local communities, entire ecosystems, and watershed health.

Projects to restore resilience to the North Yuba River watershed include clearing underbrush, thinning smaller trees, managed burning, reforestation, and meadow restoration, among other efforts. In addition, traditional ecological knowledge from the local Nisenan people will be incorporated into planning and design.

"We are planning ecological forest management projects using the best available science," said Rachel Hutchinson, River Science Director for South Yuba River Citizens League. "It's im-

## Rhode Island Opioid Treatment

Arresting addicts just might save their life. When the police arrested Paul Roussell with heroin, the 58-year old lobster fisherman had been using for a decade. He progressed from two to ten bags of heroin a day, then up to 17. He thought he was going to die in his addiction. He went to jail first.

While locked-up in Rhode Island's Adult Correctional Institutions Roussell was offered Methadone. "It was helpful. I started feeling like my recovery was kicking in."

Released after three months, Roussell was mandated to another eight months in residential treatment. Now he's living with his parents and working as a landscaper and maintenance man in a business park.

His case will be dismissed after his graduation from drug court. Every morning, on his way to work, he stops by an opioid treatment clinic for a daily Methadone dose. "That keeps me stable," says Roussell. He's gone a year without taking heroin. If not for his Methadone, he says, "There'd be a good chance of me using."

In 2016, shocked by the number of opioid overdose deaths Rhode Island began treating incarcerated addicts with Methadone, Suboxone, and Vivitrol. Most importantly, the inmates continue their treatment after their release, usually through the state's Medicaid program, when they're at the greatest risk of a relapse and a fatal overdose. It is not unusual for an addict to die using right after release from prison or rehab due to a change in tolerance.

Vivitrol blocks opioids from producing a high. But it doesn't help with withdrawal symptoms, so it isn't appropriate for newly incarcerated inmates. Unlike Methadone and Suboxone, Vivitrol doesn't relieve pain, and its users have to turn to non-opioid analgesics for pain relief.

This unique program is among the opioid crisis reforms touted by Governor Gina Raimondo in response to Rhode Island's overdose death rate, ninth-highest in the nation.

In the first half of 2016, 26 formerly incarcerated people died of drug overdoses upon release in Rhode Island. In the same period in 2017, only nine did. That's 61 percent fewer fatalities.

## Woke No Help to Addicts

The movement to minimize penalties for drug use combined with Prop 47's reduction of sentences for criminal behavior has provided the "perfect storm" for more addicts to remain free to commit crimes, become homeless, overdose and die.

Addicts eventually self-destruct like homosexuals contracting AIDS. However, society took a more compassionate approach to "curing" AIDS though AIDS is a self-inflicted disease resulting primarily from homosexual behavior.

Substance abusers commit a range of crimes to support their habit and violent acts in their addiction. In the past, law enforcement made arrests and brought the offenders to jail. Inmates would grumble that they got arrested or "caught a case."

However, former Yuba County Jail Doctor and County Health Officer Joe Cassady would remind them that "they were rescued." Officers and deputies may or may not see themselves as rescuers but they certainly are. Most addicts in jail would agree with that assessment after they get over being butt-hurt.

Many addicts, once sober, begin to consider the loss – their dignity, job, health, spouse and children. Most, if not all eventually want their lives back.

Untreated addicts get sick and encounter a premature death via suffering, illness or overdose. Addicts often die alone and poor. It is not merciful or humane to make it easier for users to end their lives while funded by the taxpayers and coddled by the institutions that should be rescuing them.

The Los Angeles County Department of Public Health states that between 2013 and 2018 the number of people that died while being homeless doubled from 536 to 1,047. Most of the deaths were caused by drug and/or alcohol overdoses between 2016 and 2018. The overdose death rate for homeless individuals in the county was also 26 times higher than the general population, according to the report.

On average, homeless people in Los Angeles died around the age of 51, while the average Los Angeles resident's life expectancy was 73.

Politicians, church do-gooders and government paper-pushers pooling their ignorance and touting myths are actually contributing to a humanitarian disaster mislabeled as "homelessness." The issue is not a missing home or job. The scourge is addiction and we are funding it and catering to it in the name of being charitable. Instead of helping, we are "pulling the plug" on

# More on Road Repairs from 2017

Marysville, Ca.

In last week's edition we published that repairing the damage from the 2017 storms was completed at a price tag of \$ 5 million. We now have pictures available for the before and after repairs on Fountain House Road.

The wettest winter in nearly a century brought significant damage to Yuba County roadways, the bulk being slipouts—where parts of embankments and road slipped down the hillsides. Re-

taining walls help hold in the embankment to rebuild a base for the roadway.

Nearly 430,000 recycled tires were utilized as fill materials in repairs along seven roads thanks to a separate grant from CalRecycle. The TireDerived Aggregate (TDA) is made from shredded scrap tires and is used in projects like retaining wall backfill, lightweight embankment fill, and landslide stabilization. The material is lightweight, cost-effective, and drains well in wet conditions.

portant to all of us that we strike that balance between the desperate need to restore the forest's resilience to wildfire and the need to preserve and protect vulnerable species and cultural artifacts."

"This public-private partnership holds promise as a model to restore the forests of the Sierra at a landscape scale," said David Edelson, Forest Program Director of The Nature Conservancy. "By using the latest science, innovative planning and new funding approaches, together we can accelerate the restoration of our

forests while maintaining the environmental safeguards and community input that are central to success."

This effort is expected to take up to 20 years to complete, with the highest priority given to at-risk communities, emergency response, evacuation access routes, forests of critical ecological importance, and areas that have the potential to stop a wildfire from spreading.

While planning efforts for the larger North Yuba River watershed are just beginning, the 14,500-acre Yuba Project is al-

ready underway, serving as a pilot for the larger-scale North Yuba River watershed restoration effort. The Yuba Project is benefitting from a new financing tool called the Forest Resilience Bond (FRB), a public-private partnership that accelerates the pace and scale of forest restoration through investment from private capital sources, including foundations, impact investors, and insurance companies.

"Investor demand for this first-of-its-kind private investment to support public land management greatly outpaced

supply. Investors are eager to finance future, larger projects," said Zach Knight, managing partner of Blue Forest Conservation, the lead developer of the FRB. "The North Yuba Forest Partnership plans to use the FRB model and other innovative approaches to finance planned work in the North Yuba River watershed."

### Wildfires damage crops, pastures, buildings

Nearly 200 acres of avocados and lemons have been damaged or destroyed in Ventura County, after wildfires that broke out last week. The county agricultural commissioner's office says it hasn't yet had a chance to assess all the farming areas affected by the fires. In Sonoma County, farmers and ranchers say the Kincade Fire destroyed pastures, barns and winery facilities. The fire also hit grapevines, which often acted as firebreaks.

### Power shutoffs lead to agricultural losses

The frequency and duration of public safety power shutoffs led to hardships for farmers and ranchers, especially small-scale operations that lost products during the blackouts. One Mendocino County farmer who runs a goat dairy said she had to milk her goats by hand and discard the milk,

because she couldn't use her milking equipment or cold storage. Other farmers said the shutoffs interrupted irrigation schedules and in some cases forced them to abandon crops.

### USDA releases new red spinach

In a development a plant breeder says will "bring excitement to the spinach market," the U.S. Department of Agriculture has released what it calls the world's first true red spinach. Known as USDA Red,

the new spinach variety was developed at the department's facility in Salinas. Other types of spinach have had red veins, but the new variety has red leaves - and also boasts higher antioxidant levels than other spinach varieties.

### Revenues from agricultural tourism increase

Agricultural tourism continues to grow, according to the latest U.S. Census of Agriculture. Figures show agritourism revenues

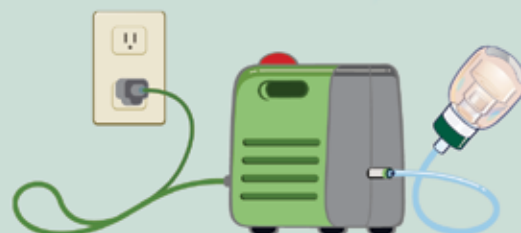

## The Swamp Watch: 'Whistleblower' Was Posted to White House by CIA's John Brennan

The Washington, D.C. Swamp Watch continues to identify heretofore unknown Swamp Rats oozing out of the murky depths of slimy bureaucracies in Foggy Bottom.

The latest comes from the shadowy workings of CIA and he just happened to be posted to the White House when Donald Trump took over as President. Problem?...he had a passionate bias against Trump. For the rest of the story, the following is an article, in part, by Paul Sperry, RealClearInvestigations October 30, 2019.

For a town that leaks like a sieve, Washington has done an astonishingly effective job keeping from the American public the name of the anonymous "whistleblower" who triggered impeachment proceedings against President Trump — even though his identity is an open secret inside the Beltway.

More than two months after the official filed his complaint, pretty much all that's known publicly about him is that he is a CIA analyst who at one point was detailed to the White House and is now back working at the CIA.

But the name of a government official fitting that description — Eric Ciaramella — has been raised privately in impeachment depositions, according to officials with direct knowledge of the proceedings, as well as in at least one open hearing held by a House committee not involved in the impeachment inquiry. Fearing their anonymous witness could be exposed, Democrats this week blocked Republicans from asking more questions about him and intend to redact his name from all deposition transcripts.

Federal documents reveal that the 33-year-old Ciaramella, a registered Democrat held over from the Obama White House, previously worked with former Vice President Joe Biden and former CIA Director John Brennan, a vocal critic of Trump who helped initiate the Russia "collusion" investigation of the Trump campaign during the 2016 election.

Further, Ciaramella (pronounced char-a-MEL-ah) left his National Security Council posting in the White House's West Wing in mid-2017 amid concerns about negative leaks to the media. He has since returned to CIA headquarters in Langley, Virginia.

**"He was accused of working against Trump and leaking against Trump,"** said a former NSC official, speaking on condition of anonymity to discuss intelligence matters.

Also, Ciaramella huddled for **"guidance" with the staff of House Intelligence Committee Chairman Adam Schiff**, including former colleagues also held over from the Obama

era whom Schiff's office had recently recruited from the NSC. Schiff is the lead prosecutor in the impeachment inquiry.

And Ciaramella worked with a Democratic National Committee operative who dug up dirt on the Trump campaign during the 2016 election, inviting her into the White House for meetings, former White House colleagues said. The operative, Alexandra Chalupa, a Ukrainian-American who supported Hillary Clinton, led an effort to link the Republican campaign to the Russian government. "He knows her. He had her in the White House," said one former co-worker, who requested anonymity to discuss the sensitive matter.

Documents confirm the DNC opposition researcher attended at least one White House meeting with Ciaramella in November 2015. She visited the White House with a number of Ukrainian officials lobbying the Obama administration for aid for Ukraine.

With Ciaramella's name long under wraps, interest in the intelligence analyst is so high that a handful of former colleagues have compiled a roughly 40-page research dossier on him. A classified version of the document is circulating on Capitol Hill, and briefings have been conducted based on it. One briefed Republican has been planning to unmask the whistleblower in a speech on the House floor.

**"Everyone knows who he is. CNN knows. The Washington Post knows. The New York Times knows. Congress knows. The White House knows. Even the president knows who he is,"** said Fred Fleitz, a former CIA analyst and national security adviser to Trump, who has fielded dozens of calls from the media.

Yet a rare hush has swept across the Potomac. The usually gossipy nation's capital remains uncharacteristically — and curiously — mum.

**"They're hiding him,"** Fleitz asserted. **"They're hiding him because of his political bias."**

A CIA officer specializing in Russia and Ukraine, Ciaramella was detailed over to the National Security Council from the agency in the summer of 2015, working under Susan Rice, President Obama's national security adviser. He also worked closely with the former vice president Joe Biden.

Federal records show that Biden's office invited Ciaramella to an October 2016 state luncheon the vice president hosted for Italian Prime Minister Matteo Renzi. Other invited guests included Brennan, as well as then-FBI Director James Comey and then-National Intelligence Director James Clapper.

**Several U.S. officials told RealClearInvestiga-**

tions that the invitation that was extended to Ciaramella, a relatively low-level GS-13 federal employee, was unusual and signaled he was politically connected inside the Obama White House.

Former White House officials said Ciaramella worked on Ukrainian policy issues for Biden in 2015 and 2016, when the vice president was President Obama's "point man" for Ukraine. A Yale graduate, Ciaramella is said to speak Russian and Ukrainian, as well as Arabic. He had been assigned to the NSC by John Brennan.

**He was held over into the Trump administration,** and headed the Ukraine desk at the NSC, eventually transitioning into the West Wing, until June 2017.

"He was moved over to the front office" to temporarily fill a vacancy, said a former White House official, **where he "saw everything, read everything."**

**The official added that it soon became clear among NSC staff that Ciaramella opposed the new Republican president's foreign policies.**

The Whistleblower, prior to filing, had met with Schiff's Democratic staff for "guidance." At first, the California lawmaker denied the contacts, but later admitted that his office did, in fact, meet with the whistleblower early on.

**Republicans participating in the restricted inquiry hearings have been asking witnesses about Ciaramella and repeatedly injecting his name into the deposition record, angering Schiff and Democrats, who sources say are planning to scrub the references to Ciaramella from any transcripts of the hearings they may agree to release.**

**"Their reaction tells you something,"** said one official familiar with the inquiry.

**Determined to keep the whistleblower's identity secret, Schiff recently announced it may not be necessary for him to testify even in closed session.**

**Ohio Rep. Jim Jordan, the top Republican on the House Oversight Committee, asserted the American people have the right to know the person who is trying to bring down the president for whom 63 million voted.**

**Added Jordan: "The people want to know. I want to get to the truth."**

Texas Rep. Louis Gohmert: Ciaramella was "supposed to be a point person on Ukraine, during the time when Ukraine was its most corrupt, and he didn't blow any whistles on their corruption."

## Rhode Island Opioid Treatment

“The magnitude of that drop in mortality is almost unheard of in public health,” says Dr. Josiah Rich, a professor at Brown University’s medical school and co-director of Rhode Island’s Center for Prisoner Health and Human Rights.

Some other states offer inmates Vivitrol. But because Methadone and Suboxone are also opioids, corrections officials usually ban them as contraband, concerned that inmates might divert them to others.

“It met with a lot of resistance over the years,” recalls Dr. Josiah Rich, a Rhode Island task force advisor, who wrote unsuccessful grant applications for a prison Methadone program in Rhode Island 20 years before. “People who have this disease are thought to be somewhat subhuman.”

In the 1990s, Dr. Rich got into a disagreement with a prison nurse over whether to help an inmate suffering from drug withdrawal. “I said we

should give him medication to make him feel better,” he recalls. “She said, ‘No, we don’t do that. He’s supposed to suffer. That way, he won’t come back again.’”

Rich sounds like retired Yuba County Jail Dr. Joe Cassidy. Cassidy brought the first Methadone clinic here and then introduced Suboxone to the Yuba-Sutter area. Cassidy de-toxed addicts in the jail, and allowed them to have Methadone if already prescribed.

Rhode Island calls their approach MAT, medically assisted treatment. New inmates who are withdrawing from opiates go straight into an induction program—a few days of Methadone or Suboxone to ease withdrawal symptoms. They start people on treatment right when they come in the door.

Inmates with histories of addiction can choose to go on Methadone, Suboxone, or Vivitrol a few months before their release. “This was, I think, the most difficult for

people to accept,” says Dr. Jennifer Clarke, the medical programs director for Rhode Island’s Corrections Department, “that we were taking people who’d been off opiates for years and putting them back on MAT.” But just-released former inmates are at the highest risk of dying of an overdose. They’ve lost their physical tolerance for opioids, but may not have lost their cravings.

“It’s the same thing as smoking,” says Clarke. “(If) somebody’s here for five, 10 years, it doesn’t mean they’re not craving a cigarette the whole time. They haven’t actually quit. They’re not actually in recovery. They’re just away from the substance.”

California politicians like to brag about being America’s trend-setter state but it is sorely behind little Rhode Island on the right coast in treating addiction.

this population.

It is no different than crippling a child’s thinking by catering to their bad choices and protecting them from consequences by doing everything for them rather than making them work and serve others. Not disciplining and training up a child is cursing them to a chaotic and dysfunctional future.

We are treating rebellious and addicted adults like a good parent would never dream of managing their own children whom they love. Society is deceived by thinking that giving addicts what they want, paying them, and allowing them to live in their own filth on public property, unconscious on a sidewalk or under a bush is somehow a good thing, a humane approach. Stray animals are treated better.

It is the “woke” community that has lost its mind. No sane landlord or business owner would

rent to or hire an addict circling the drain. Only government bureaucrats can throw that kind of money away.

Californians’ deluded vote in 2014 to reduce penalties for drug and property crimes led to a spike in car burglaries, shoplifting and other theft, researchers say. Thefts from motor vehicles accounted for about three-quarters of the increase. San Francisco alone recorded more than 30,000 auto burglaries in 2017.

Addicts and gang members are literally walking-off with the store. Helpless merchants are reducing their evening hours, closing off multiple entrances at night and considering closing altogether in some communities. Stores may have great sales but thefts devour profits.

Proposition 47 lowered criminal sentences for drug possession, theft,

shoplifting, identity theft, receiving stolen property, writing bad checks and check forgery from felonies that can lead to prison terms to misdemeanors that often bring minimal jail sentences.

Reduced penalties meant that fewer drug addicts are getting treatment and then “are stealing to support their habit,” said San Luis Obispo County Chief Probation Officer Jim Salio, president of the Chief Probation Officers of California.

Enforcing the laws and incarcerating addicts saves lives and makes a healthier and safer community. Addicts need treatment leveraged by the courts. Sobriety leads to family reunification, work and money for the needs of life.

## Walnut Buying Period Announced

**Sutter and Yuba Counties Sutter County**

Sutter County Agricultural Commissioner Lisa Herbert announced that the walnut buying period began Friday, November 8th, beginning a window period that will end April 30, 2020, pursuant to the County’s Walnut Theft Prevention ordinance.

Rice remains the top-ranking crop in 2018 with a 29% increase in acreage. A slight decrease in yield was offset by an increase in price pushing the total value to \$178.5 million. Rice was first planted commercially in Sutter County in 1913. In that year 395 acres were planted in the south east part of the Sutter Basin. In the past 30 years, rice has remained the number one crop 28 times only yielding the top spot to prunes in 1989 and walnuts in 2014.

In second place, walnuts total value decreased 34.1% to \$85,956,000 due to a dramatic drop in price, even though acreage was up considerably. Clingstone peaches rose from fifth place to third due

to increases in acreage, yield and price to a total value of \$59,798,000. Prunes dropped one spot to fourth with increases in acreage, yield and slight drop in price to a total value of \$57,041,000. In fifth, nursery products remained strong with a 12.8% increase in total value to \$53,414,000 due to increases in acreage and quantity sold. Rising to sixth, processing tomatoes had a 36.0% increase in acreage as well as increases in yield and price to a total value of \$37,887,000. Almonds dropped to seventh with slight increase in acreage and slight drops in yield and price to a total value of \$33,155,000.

Yuba County walnut buying period also began on November 8, 2019.

The Walnut Buying Period is the declared end of harvest of the Chandler variety of walnuts by the Agricultural Commissioner, after consultation with a committee of walnut growers-- during which non-processing walnut buying operations within Yuba County may lawfully purchase and receive walnuts that have not been dried or processed. Walnuts are the second highest-valued agricultural commodity in Yuba County, with 16,269 harvested acres with a market value of approximately \$42,299,000, according to the 2018 Yuba County Crop Report.

# The Opioid Crisis: Where to Get Help?

## Adventist Health+Rideout's Emergency Department

We have all heard of the Opioid Crisis, but what is anyone actually doing to help fix things? Enter the California Bridge Program. This spring, the Emergency Department at Adventist Health + Rideout was one of only 31 hospitals in California selected to participate in this evidence-based and common-sense program to help people who suffer from opioid use disorder, 24/7.

The Opioid Crisis often hits rural counties the hardest, and ours are no exception. According to the CA Department of Public Health, the rate of opioid overdose deaths in Yuba, Sutter, and Nevada counties all exceed the California state average. There are many reasons for this, but one main reason is how difficult it has been to seek help. Adventist Health + Rideout's Emergency Department is changing that.

When patients in opioid withdrawal come to the Emergency Department, they will be offered a dose of the medication buprenorphine (brand name Suboxone) to ease severe symptoms of withdrawal, and then they will be connected with outpatient treatment in the community. Our Emergency Department physicians, PA/NPs, and nurses have all been trained to treat an individuals' opioid withdrawal symptoms with this medication which is quick to work and very effective.

The Bridge program also brings our community maybe the most important piece of this program – the Substance Use Navigator (SUN). Our highly experienced and very down-to-earth SUN, Mr. Todd O'Berg, works closely with our Emergency Department staff and each patient to support them throughout the entire process, from admission into the Emergency Department through transition to continued outpatient treatment. We have partnered with several local primary care clinics and substance use treatment centers in the area, creating a network ready to meet each individual's unique needs.

Since the Bridge program started six months ago, Mr. O'Berg has been able to meet with over 300 patients in need of help with substance use disorders, be that opioid use disorder, alcoholism, or issues with other substances. He is incredibly dedicated to helping patients be successful. By scheduling a clinic appointment to continue

treating their opioid use disorder in only a few days' time, following up with them after their ED visit, and helping them overcome any unforeseen barriers, over 80% of these patients have successfully made it to this appointment.

One anonymous patient gave us this statement to share: "I would say, I felt completely hopeless and lost in my addiction. I had no clue what to do to help myself get sober until I called the ER. I think it's amazing that the hospital offers what it does to help opiate addicts like myself get the help that they need by providing suboxone and drug counselors on site. If it hadn't been for the great staff there I don't know where I'd be right now regarding my sobriety. Not only did they care about getting me clean, they also made me feel safe and that I mattered. Thanks to the program at Rideout, I am now three months clean and plan to keep working hard to stay sober. I will be forever grateful for them and their program."

Many people don't know where to begin to seek help for their opioid use disorder. And if they do ask their doctor, often the wait time for appointments or referrals is long. Having the Bridge program at Adventist Health + Rideout's Emergency Department means that anyone, anytime, in our community can access the best evidence-based treatment for opioid use disorder.

In addition to the Bridge program, another way the Emergency Department is working to save lives from the Opioid Crisis is our participation in the Naloxone Distribution Project. Naloxone (brand name Narcan) is a nasal spray medication

that reverses opioid overdoses. This medication is given out free of charge, with teaching on how to use it, to any patient or visitor in the hospital who thinks they might be in a situation to save a life when witnessing an opioid overdose. Whether you are a police officer or fire fighter, someone who regularly uses opioids, a parent of small children who might accidentally get into someone's pill bottles, etc, many of us may be in the situation where we can save a life by administering this medication to someone in need. If you are in the Emergency Department, just ask any staff member for this medication, and then you too can be prepared to save a life.

If you or anyone you know is concerned about their opioid use and wants to discuss ways to get into treatment, please call our Substance Use Navigator, Mr. Todd O'Berg, anytime at 530-490-1285.
