## Private Prisons Out

Governor Gavin Newsom signed AB 32 into law phasing out for-profit prisons and immigrant detention centers by 2028. The law prohibits state officials from signing new agreements with private prisons or renewing existing contracts starting next year, unless needed to comply with court-ordered population caps.

AB 32 will also ban all private detention centers from operating in California by the time their current contracts run out, including private immigrant detention facilities that contract with fed-

eral immigration authorities. However, it wouldn't prohibit the federal government from building its own detention centers in California.

This is a bad law but liberals and no-border activists love it.

"Closing immigrant prisons is an essential step towards dismantling a system that profits off of abuse and lines the pockets of private prison executives and industry shareholders," Christina Fialho, executive director of Freedom for Immigrants, said in a statement. "AB 32 is truly a model for the rest

of the nation."

Fialho is a nut job. She advocates not arresting those violating our laws and considers incarceration abuse. As a socialist she believes private prisons should not make a profit which is nonsense. Maybe she is 'lining her own pockets' off immigrants.

Private prisons meet a need and can save the taxpayers money. They came about because federal and state governments were unable or unwilling to fund new prison construction to keep pace with increasing inmate

populations. California's private prisons are overseen by the California Department of Corrections (CDC) and whatever the CDC desires can be placed in the contracts.

The liberal idea that privately operated prisons are morally wrong to make a profit is insane. Liberals that think most prisoners are incarcerated unjustly.

AB 32 will not result in a reduction in federal immigration enforcement in California or the release of currently detained immigrants, as some immigrant advocates hope. Enforcement actions will continue, with those arrested, along with those currently detained, being transported to out of state facilities as far away as Texas, Louisiana, and Georgia. ICE has done this before to deal with detention bed shortages. Many of these alternative facilities will be privately owned and operated.

Citizens pay for incarcerating prisoners whether they are cared for by government or in the private sector. Without any private prisons, the alternative would be to reduce arrests, or release convicted criminals.

Fialho, like other liberals, hypocritically criticizes separating detainees from their families when this law will mandate exporting illegals arrested here to other states and farther from family members and visiting opportunities. Fialho ignores this in her quest to close all prisons and have open borders.

Immigration attorneys and nonprofit organizations that are plentiful in California to serve detainees will be harder to locate in other states as well.

Newsom did not need legislation to take this action as the CDC is empowered

## PG&E's Power Shutoff is Unacceptable

PG&E shut off power to residents of the North State shortly after midnight Wednesday. More shutoffs are expected today. In total, 800,000 customers will be negatively impacted. An estimated 2.5 million Californians will not have electricity.

Senator Jim Nielsen (R-Tehama), who represents Paradise where 85 people died as a result of the Camp Fire and thousands are still displaced, issued the following statement:

"PG&E's massive power shutoff is unacceptable. This policy has to change. PG&E's decision to protect itself from liability at the expense of

hardworking Californians will not be tolerated. This disregards people's livelihoods. We depend on electricity to live and earn a living.

"Millions without electricity is what a third world country looks like, not a state that is the 5th largest economy in the world.

"Schools closed. Government offices closed. Businesses closed.

"Employees were sent home as businesses had to shut their doors. Some workers are forced to go without pay.

"Parents scrambled to find babysitters, raced to buy battery-operated lights, and

rushed home to prepare their families in anticipation of days of darkness. This is no way to live. We are in the United States of America. Access to electricity is a basic necessity for life.

"This ham-fisted policy by PG&E appears to be nothing more than a very selfish approach to protecting corporate interests at the expense of customers who cannot shop elsewhere for this vital utility - electricity. This Legislature must rigorously examine whether PG&E is capable of responsibly delivering reliable, safe electricity to its rate-paying customers."

Reports keep coming in about the salmon run getting better. We hear the catch is better above Gridley and some anglers are having luck in the Sacramento River, but we have not heard of any outstanding success at this time.

Lake Tahoe is still on the mackinaw bite with lots of action from the South Shore of the lake. Fishing is also good to fair on the North Shore. The kokanee have entered Taylor Creek to spawn. This creek has access, trails and information available and if you go you can stand right next to the stream to see the fish. There will also be several mallard ducks to entertain you as they dive for the roe and once in a while a bear will appear out of the forest and brush areas. This would be a wonderful experience for the kids whether they fish or not. Best time to go is now and into October. The entrance to the area is located off of State Route 89 several miles from South Lake Tahoe. Watch for the signs on the right side of the highway.

The forest service is starting to close campgrounds in the high country and it is getting very cold up that way.

If you decide to give it one more shot we suggest warm clothes and prepare for a possible storm.

Lake Berryessa is putting smiles on anglers with success on bass very good at this time. The fish are good size with some in the three pound range.

We have another report of a big catfish caught, but this time it is not at Collins Lake.

We are told the catfish was over ten pounds and was caught in the Sutter Bypass. The bait used is unknown, but the lucky angler did say it was stink bait of a private recipe.

## Scholastic Writing Awards and Poetry Out Loud Programs Now Underway for Yuba-Sutter Students

Yuba Sutter Arts is especially proud of its many Arts in Education programs. The school year is well underway, and we are ready to send teaching artists into local classrooms to talk about two of our premier programs; Poetry Out Loud and the Scholastic Writing Awards.

Each year at about this time, we ask for the support of educators and administrators in promoting these programs to their students. First up is the Scholastic Writing Awards program. This is our third year as the northern California affiliate for the program which continues to grow at an exciting rate in terms of student engagement and submissions. The art awards portion of the program is administered by the Sutter County Museum. This is an open call for creative writing and there are many writing categories available to students including poetry, short story, critical essay, journalism, science fiction and others. The deadline for submissions is January 9, 2020. More information is available at [artandwriting.org](http://artandwriting.org). Yuba Sutter Arts can help with getting student work entered into the online system for judging. It will host the regional awards ceremony in its theater in February of 2020.

The second program with a deadline of next February

is Poetry Out Loud. Yuba Sutter Arts is in our 11th year of sponsoring the program. Poetry Out Loud involves poetry memorization and recitation. There are 1,000 approved poems that run the gamut of eras, themes and styles that can be found at [poetryoutloud.org](http://poetryoutloud.org). Students select a poem and commit it to memory. Again, Yuba Sutter Arts will host the local competition at its theater in Marysville early next February. The two county champions will go on to the state finals about a month later. The local first, second and third place winners from each county receive cash prizes. The California Arts Council produced a short video, "About California Poetry Out Loud," available at this link: <https://youtu.be/wF6qJAZVBqg>.

Yuba Sutter Arts hosts two spoken word open mic events each month for students that want to come out and practice reciting their poems for Poetry Out Loud or read an original piece of poetry or prose for a supportive audience. The first Thursday of each month, it meets at Yuba Sutter Arts, 624 E Street in Marysville and on the third Thursday of the month, the event is held at Justin's Kitchen, 628 Plumas Street in Yuba City. Both events start at 6:30 and are totally free.

Yuba Sutter Arts asks that interested teachers contact

them to let them know of their intent to participate this year. It will then schedule in-class visits by its teaching/artists who will come out to discuss more of the details of each program. Yuba Sutter Arts will work to make it as easy as possible for educators to integrate these programs into the school year.

We feel that now, more than ever, it is important to recognize creative endeavors and accomplishments and provide students with the support and resources they need to make creativity a lifelong pursuit. Please encourage any students that you know to get involved in these two wonderful programs.

## A Celebration of Souls Day of the Dead at Yuba Sutter Arts

On Saturday, October 26, Yuba Sutter Arts will host its annual "Día de Los Muertos" or "Day of the Dead" celebration. The event will be held at Yuba Sutter Arts' Marysville theater, courtyard and art gallery at 624 E Street from 11 - 4pm. This community cultural celebration is free and suitable for all ages!

The holiday has become a part of our popular culture through the whimsical skeleton figures and other artwork along with films like "Coco" and "The Book of Life." Day of the Dead is celebrated throughout Mexico and is acknowledged around the world in other cultures. The holiday focuses on gatherings of family and friends who pray for and remember friends and family members who have passed, and to help support their spiritual journey.

The event will offer food, drinks, movies and vendors with Day of the Dead and Frida Kahlo inspired art! Come celebrate with and support local artists. Featured artists will include Lila Solorzano Rivera, an artist and the show's curator, Randy Rivera, an air brush artist who will also be creating art during the event, John Huerta, painter and sculptor and jewelry maker, Toni Rodriguez. Other artists will also be onsite showing their work.

Featured entertainers will be the Yuba-Sutter Folklorico Dancers, musical group Lalo and Friends and a surprise special guest artist.

Day of the Dead is celebrated at roughly the same time of year as Halloween and since the two share some common roots, Day of the Dead is sometimes referred to as the "Mexican Halloween", however, the focus of the two holidays is quite different. As celebrated today, Day of the Dead is essentially a family time, a time of reunion for both the living and the dead.

There are many traditions related to Day of the Dead. The flower most commonly associated with the holiday is the marigold which is thought to attract souls of the dead to the offerings. Traditionally, toys are brought for children who have passed (los angelitos, or "the little angels"). Families also offer trinkets or the deceased's favorite candies. Altares or altars are also created in homes, usually with foods such as candied pumpkin, pan de muerto ("bread of dead"), and sugar skulls. The

## Food and Farm

### Farms provide more agritourism opportunities

Pumpkin patches are popular destinations this time of year, but there are other ways for people to get a taste of the countryside and experience agriculture. Farms that open their doors to the public are increasingly offering overnight lodging, farm-to-table dinners and events, and workshops to attract visitors and generate more tourism revenue. These offerings often showcase the farm's property and what it produces.

### High-severity wildfires may indefinitely alter California's forests

A new study says California's increasingly intense fires may erase some of the state's forests indefinitely. Scientists found that five to

10 years after a high-severity burn, many forest stands had converted to shrub fields with low diversity of plant species. Authors said current fire trends could prevent forest recovery in large portions of the Sierra Nevada landscape, and suggested the expansion of forest thinning and prescribed burning as management tools.

### Underserved and veteran farmers to benefit from \$16.2 million in USDA grants

The U.S. Department of Agriculture announced it will issue \$16.2 million in grants to provide farmers, ranchers and foresters who are socially disadvantaged or veterans with training, outreach and technical assistance. Grants are awarded to higher education institutions, nonprof-

its and community-based organizations to reach historically underserved communities. The program has awarded 484 grants totaling \$119.5 million since 2010.

### New robotic arm aids workflow, safety in university lab

There's a new worker in Fresno State's citrus processing laboratory: It's a robotic arm designed to move and arrange boxes of produce. The automated arm has a nearly 7-foot reach and a 150-pound payload capacity, and can also be tasked with inspection, packaging and machine tending. ### DOJ Documents Show Rosenstein Advising Mueller 'the Boss' Doesn't Know About Their Communications

**It seems former Acting Attorney General Rod Rosenstein was one of the main Swamp Rat characters in the "Take Down Trump" effort from the Git-Go...according to Judicial Watch President Tom Fitton's October 2, 2019 missive that follows:**

**(Washington, DC)** Judicial Watch released 145 pages of Rod Rosenstein's communications that include a one-line email from Rod Rosenstein to Robert Mueller stating, **"The boss and his staff do not know about our discussions"** and **"off the record"** emails with major media outlets around the date of Mueller's appointment.

Judicial Watch filed the lawsuit after the DOJ failed to respond to a September 21, 2018, Freedom of Information Act (FOIA) request (Judicial Watch v. U.S. Department of Justice (No. 1:19-cv-00481). Judicial Watch seeks:

Any and all e-mails, text messages, or other records of communication addressed to or received by Deputy Attorney General Rod Rosenstein between May 8, 2017, and May 22, 2017.

The time period referred to in this suit is critical. On May 9, 2017, Rosenstein wrote a memo to President Trump recommending that FBI Director James Comey be fired. That day, President Trump fired Comey. Just three days later, on May 12, Rosenstein sent an email assuring Robert Mueller that "The boss and his staff do not know about our discussions."

In a May 16, 2017 email, sent the day before Mueller's appointment, Rosenstein emailed former Bush administration Deputy Attorney General and current Kirkland & Ellis Partner, Mark Filip stating, **"I am with Mueller. He shares my views. Duty Calls. Sometimes the moment chooses us."**

And on May 17 Rosenstein appointed former FBI Director Robert Mueller to investigate Russian meddling in the 2016 presidential election.

Also, during the same time period, between May 8 and May 17, Rosenstein met with then-acting FBI Director Andrew McCabe and other senior Justice Department FBI officials to discuss wearing a wire and invoking the 25th Amendment to remove President Trump.

The documents also show that, again during the same time period,

Rod Rosenstein was in direct communication with reporters from 60 Minutes, The New York Times and The Washington Post. In an email exchange dated May 2017, Rosenstein communicated with New York Times reporter Rebecca Ruiz to provide background for this article about himself. Ruiz emailed Rosenstein a draft of the article, and he responded with off-the-record comments and clarifications.

- In an email exchange on May 17, 2017, the day of Mueller's appointment, Rosenstein exchanged emails with 60 Minutes producer Katherine Davis in which he answered off-the-record questions about Mueller's scope of authority and chain of command:

Rosenstein: "Off the record: This special counsel is a DOJ employee. His status is similar to a US Attorney."

Davis: "Good call on Mueller. Although I obviously thought you'd be great at leading the investigation too."

- On May 17, 2017, in an email exchange with Washington Post journalist Sari Horwitz and the subject line "Special Counsel" Rosenstein and Horwitz exchanged:

Rosenstein: **"At some point, I owe you a long story. But this is not the right time for me to talk to anybody."**

Horwitz: "Now, I see why you couldn't talk today! Obviously, we're writing a big story about this. Is there any chance I could talk to you on background about your decision?"

**"These astonishing emails further confirm the corruption behind Rosenstein's appointment of Robert Mueller,"** said Judicial Watch President Tom Fitton. **"The emails also show a shockingly cozy relationship between Mr. Rosenstein and anti-Trump media reporters."**

On September 11, Judicial Watch released 14 pages of records from the Department of Justice showing officials' efforts in responding to media inquiries about DOJ/FBI talks allegedly invoking the 25th Amendment to "remove" President Donald Trump from office and former Deputy Attorney General Rod Rosenstein offering to wear a "wire" to record his conversations with the president.

On September 23, Judicial Watch released a two-page memo, dated May 16, 2017, by then-Acting FBI Director Andrew McCabe detailing how then-Deputy Attorney General Rod Rosenstein proposed wearing a

wire into the Oval Office "to collect additional evidence on the president's true intentions." **McCabe writes that Rosenstein said he thought it was possible because "he was not searched when he entered the White House."**

#### Court Forces State Dept To Release Smoking Gun Clinton Email

The Clinton email scandal is far from over. A federal court ordered discovery in a major Judicial Watch lawsuit that will ultimately result in nearly 20 witnesses having to testify under oath to our attorneys. And, and thanks to the court's orders, we're also getting new documents proving the Clinton email cover-up. Specifically, the State Department released a previously hidden email showing that top State Department officials used and were aware of Hillary Clinton's email account.

## ***Campfire Victims Can Transfer Proposition 13 Benefit to Yuba County***

### ***Certain Requirements Must Be Met***

Marysville, Ca.

Survivors of the 2018 Camp Fire in Butte County who relocate to Yuba County may now be able to transfer the base year value of their damaged or destroyed property to the replacement property, according to Yuba County Assessor Stephen Duckels.

A resolution adopted by the Yuba County Board of Supervisors earlier this year makes such a transfer of base value possible, in instances where there is a Governor-declared disaster.

“What this means is that, if certain requirements are met, you may be able to transfer the assessed value of

your property in Butte County to your property recently purchased in Yuba County and benefit from property tax based on your prior assessed value rather than the market value of the replacement residence,” Duckels said.

The main requirements that must be met are:

- The original property was owned and occupied as a principal residence
- The replacement property is owned and occupied by the same person as a principal residence
- The market value of the replacement property at the time of purchase is of equal

or lesser value than the market value of the original property immediately prior to the disaster

• The replacement property is purchased or newly constructed within three years, following the date of damage or destruction

## ***Anytime Metering Coming to Highway 65 in S. Placer County***

***Caltrans Also Activating Three New Ramp Meters on the Corridor***

Placer County, Ca.

In an effort to relieve congestion and make merging safer for motorists, Caltrans announced plans to activate three new ramp meters next week and initiate around-the-clock ramp metering on all freeway entrances to southbound State Highway 65 from Lincoln to Roseville.

Starting Monday, October 14, the three meters going live are: Northbound Galleria Boulevard to southbound Highway 65; southbound Stanford Ranch Road to northbound Highway 65; and northbound Industrial Avenue in Lincoln to southbound Highway 65. The meters will have expanded hours of operation, which will allow these signals to also manage non-commute congestion with on demand metering.

At the same time, seven other ramp meters on southbound Highway 65 from Rocklin to Roseville will ex-

pand hours of operation. Traffic metering will take place anytime or day during the daytime or nighttime hours when there is heavy traffic congestion on the freeway.

The seven ramp meters affected are:

- Eastbound and westbound Pleasant Grove Boulevard on-ramps to southbound Highway 65.
- Eastbound and westbound Blue Oaks Boulevard on-ramps to southbound Highway 65.
- Eastbound and westbound Sunset Boulevard on-ramps to southbound Highway 65.
- Westbound Whitney Ranch Parkway to southbound Highway 65.

Currently, six of these ramp meters – except for Whitney Ranch – operate from 6 a.m. to 6 p.m. Mondays through Fridays and 10 a.m. to 7 p.m. Saturdays and Sundays.

This is the first time

Caltrans will operate anytime metering for freeway on-ramps in the greater Sacramento Valley region. To alert motorists of the upcoming changes, the meters will rest on green this week.

Studies have found ramp meters are an effective way to reduce freeway congestion and collisions, improve travel time and make merging onto the freeway safer.

District 3 is responsible for maintaining and operating 4,385 lane miles in 11 Sacramento Valley and Northern Sierra counties. Caltrans issues updates about road conditions on Twitter @Caltrans-Dist3 and on Facebook at CaltransDistrict3. For real-time traffic, click on Caltrans’ QuickMap quickmap. dot.ca.gov/ or download the QuickMap app from the App Store or Google Play.

## ***CHP Receives Grant for Motorcycle Safety and Awareness***

Each year more motorcycles are ridden on California’s roadways. Through a federal grant, the California Highway Patrol (CHP) has developed the Get Educated and Ride Safe (GEARS) II campaign, to promote motorcycle safety and awareness.

The GEARS II goal is to reduce the number of motorcycle-involved crashes and crash victims. The number of motorcycle-involved crashes increased approximately five percent in Federal Fiscal Year (FFY) 2017 from the previous year and increased three percent in FFY 2018. Although crash numbers may continue to rise,

the CHP is working to make that percentage as low as possible.

“Motorcycle safety is a top concern,” CHP Commissioner Warren Stanley said. “Improving motorcyclist and motorist safety through education and enforcement is the focus of this year’s GEARS grant.”

With the \$700,000 grant, the regions with the highest number of motorcycle incidents will see enhanced motorcycle safety operations. A year-long series of motorcycle traffic safety education campaigns, including the “May is Motorcycle Safety Awareness Month,” is planned.

The campaigns will promote the use of U.S. Department of Transportation approved motorcycle helmets for all riders and will work to raise motorists’ awareness of sharing the road with motorcyclists. The campaigns will also focus on the most dangerous traffic violations, including speeding, improper turning, and driving under the influence of alcohol and/or drugs.

Funding for this program was provided by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.

## ***Fatal Crash on Hwy 20***

At 3:10 pm on Thursday, October 10, 2019 a previous collision had caused Hwy 20 to be blocked at Frontage Rd, west of S. Butte Rd.

The driver, a 54 year old male, of a 2008 Nissan on eastbound Hwy 20 in the #2 lane, either slowing or at a stop in traffic. Rich-

ard Brian Heryford, 56, was driving a 2016 Ford eastbound on Hwy 20 east of Lytle Rd in the #2 lane at a stated speed of 50-55 mph approaching the Nissan. Heryford diverted his attention from the road and failed to see traffic ahead. Heryford collided with the rear of the Nissan, causing fatal injuries to

the driver. Heryford remained at the scene and declined medical treatment. Alcohol or drug intoxication is not suspected to have contributed to this collision.

The name of the Nissan driver is being withheld pending notification of family.

## ***Three Vehicle Collision on Hwy 20 West of N. Township***

Yuba City

On Thursday, October 10, 2019, at approximately 2:22 pm, Zuber was driving a 2014 Kia was driving southbound on the frontage road just north of Hwy 20 and North Township Rd. The Kia stopped at the stop sign on westbound Hwy 20. Girod was driving a 1990 Peterbilt, towing a flatbed trailer carrying a bulldozer was traveling westbound in the #2 lane of Hwy 20, at approximately 55mph. Driving eastbound on Hwy 20, in the number #1 lane, was Graham Thorton in a 2005 Dodge. Both Girod and Thorton were approaching the frontage road intersection.

Zuber did not see the

1990 Peterbilt traveling westbound toward her locations, as she accelerated into the intersection and attempted to make a left-hand turn onto eastbound Hwy 20. The 2014 Kia traveled directly in front of the 1990 Peterbilt. The right front of the Peterbilt collided with the left front of the Kia. The Kia spun out of control into a ditch on the north side of Hwy 20 and Girod lost control of the 1990 Peterbilt. Girod traveled across the westbound lanes and into the center median. The vehicle continued across the median and into the eastbound traffic of Hwy 20, directly in front of the path of

the 2005 Dodge. The front end of the Dodge collided with the right side of the Peterbilt and the force of the collision forced both vehicles southbound across the eastbound lanes and toward the south shoulder. As both vehicles skidded onto the shoulder, the bulldozer detached from the flatbed trailer and collided with the left driver side of the Dodge. The vehicles came to rest on the south shoulder of Hwy 20.

Hwy 20 was closed to east and west bound traffic for several hours for the investigation, tow trucks and clean up. Traffic was diverted to alternate routes around the scene.

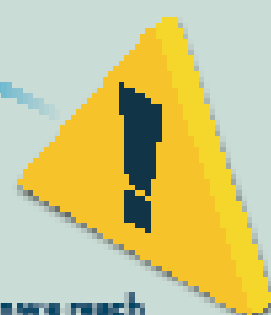

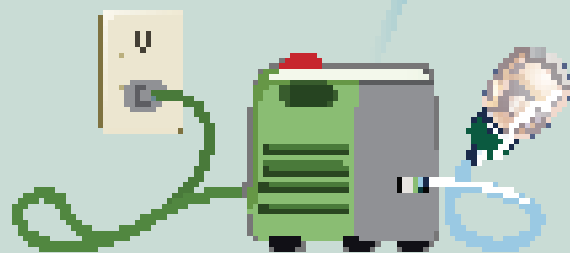

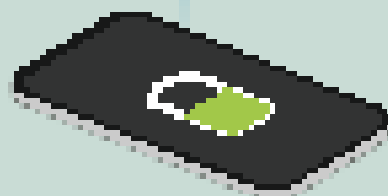
