California Swan Festival Returns

The CA Swan Festival is presented by the Yuba-Sutter Chamber & Visit Yuba-Sutter. It is the only one of its kind on the west coast of the United States and celebrating the abundant local and migratory wildfowl of the Northern Sacramento Valley, the California Swan Festival offers workshops, presentations, guided tours and educational programs catering to bird and nature enthusiasts of all ages and levels of interest. The California Swan Festival is timed to honor the return of the tundra swans to their winter home. Arriving in the tens of thousands and in close-knit family groups, they make a spectacular show for bird watchers and photographers.

This three-day event offers more than 35 guided tours at affordable prices, organized by experts in their respective fields, exploring a wide range of waterfowl habitats and other natural assets of the beautiful Yuba-Sutter region. Field trips include Swan Sighting, Ag/Wildlife Educational Tours, Historic Tours, Nature Hikes and trips to the region's National Wildlife areas. Registration for field trips began online

on August 28th, 2019.

Another great feature of the Festival is the free Junior Naturalist program, led by a team of Shady Creek Outdoor School naturalists. Children of all ages will enjoy hands-on learning experiences sure to inspire the budding birdwatcher. Activities include crafts, games, live animal presentations and much more.

The festival also hosts a vendor fair, all day Saturday and Sunday, in the Swan Central building. Onsite vendors specialize in wildlife information and retail goods. Yuba Water Agency Approves Grant for North Yuba Water District

will provide reliable, safe drinking water

Marysville, Ca.

Residents in Challenge, Rack-erby, Brownsville and Forbestown will have a more reliable, safe drinking water supply with the help of funding from Yuba Water Agency.

The grant, worth up to \$225,725, was approved on October 16, 2019 by the water agency and provides the necessary funds for the North Yuba Water District to continue its Forbestown Ditch to Pipeline Replacement Project, which is the conveyance system that provides water to approximately 3,100 customers in the foothill communities.

"This is a very good project that will be extremely beneficial

to the community," said Yuba Water Agency Vice Chairman Randy Fletcher. "It will ensure that North Yuba Water District customers have better access to a reliable supply of safe drinking water."

Water is currently delivered through an unpiped ditch, which has experienced multiple breaches in the past. Additionally, up to 60 percent of the water traveling down the ditch is lost due to seepage and evaporation, and the remaining is prone to contamination from dirt, trash, metals and illegal marijuana grows.

"Piping the ditch will vastly improve, if not completely resolve, the issues that we cur-

rently experience," said NYWD General Manager Jeff Maupin. "This will be extremely beneficial for delivering water to our customers and curtailing the amount of water that is currently lost."

NYWD will use the funding from Yuba Water Agency for the next phase of the project, which includes, but is not limited to, California Environmental Quality Act work, landowner agreements and further grant preparations.

Yuba Water Agency invests in infrastructure projects like this to ensure access to a safe, reliable water supply for Yuba County residents, which is one of the agency's primary mission areas.

PP Politicians and Judge Exposed

Founding Father John Adams said, "Our Constitution was made only for a moral and religious people. It is wholly inadequate to the government of any other." Today, we are seeing Adam's fears borne out in every institution as both morality and the Constitution are ignored.

Rather than being honored as heroes, investigative journalists David Dalieden and Sandra Merritt are being prosecuted by the State of California and sued in a civil trial for uncovering and exposing the clandestine harvesting and peddling of the parts of aborted babies.

This persecution of Daleiden and Merritt via Planned Parenthood (PP) vs Center for Medical Progress is not only evil but it is a mockery of the justice system. Daleiden and Merritt used filmed conversations with Planned Parenthood medical doctors talking openly about the baby parts industry.

PP claims the two video recordings of conversations were illegal being private and not public while the journalists conducted the interviews in public. Pro-life attorneys are also arguing that PP is in the baby body parts business which federal law prohibits.

This civil case is being heard by hard left, pro-abortion and pro-PP Justice Robert Orrick III in San Francisco. Anti-abortion activists noted previously that the judge's wife, Caroline Farrow Orrick, posted Facebook messages in 2015 and 2016 supporting Planned Parenthood and citing an article that attacked Daleiden's group as a "sham organization run by extremists." The judge did not disavow his wife's comments, and members of the public would assume that he shares her views, Daleiden and his group argued.

Former California Attorney General (AG) Kamala Harris who received campaign contributions from PP and current AG Xavier Becerra have been going after Daleiden and Merritt criminally.

Orrick had refused to allow the damaging videos to be shown before the jury. On October 11, 2019, PP abortionist Leslie Drummond-Hay claimed under oath that nobody could hear her conversation with David Daleiden (posing as a baby body parts buyer) and that he brought up the matter of money. The defendants' attorneys argued that the jury needed to see and hear for themselves whether the interview was public or private and what was said by whom.

Over numerous, aggressive objections from PP's lawyers, the judge finally agreed that the video could be played. As the 4 ½ minute video was watched the mood in the courtroom turned dark and somber.

The result was a disgusted jury that may now understand who PP is, what it does, and that these supposedly "confidential" conversations were recorded in the presence of numerous strangers and therefore public and legal.

Abortionist Drummond then admitted that others could hear her and the journalist and that she had been first to bring up the topic of money. Abortionist Deborah Nucatola spoke freely with every word captured on video.

Nucatola describes killing the baby but saving the parts, "So then you're just kind of cognizant of where you put your graspers. You try to intentionally go above and below the thorax so

Fed Moves the market

The latest in economic figures out from the Commerce Department (CP) shows Gross Domestic Product (GDP) at 2.1%. GDP for the second quarter of 2019. GDP is defined as the sum of the market values, or prices, of all final goods and services produced in an economy during a period of time. (Investopedia). 2.1% puts it on par with the post 2008 expansion which many regard as anemic (The 5 Min. Forecast).

Figures from the previous quarter (1st qtr. of 2019) were also revised downward and are short of the Whitehouse target of 3%.

Many economists argue GDP is non-representative of the living standard of the average American as the figure includes many parameters, adjustments and assumptions that don't apply to the day to day living expenses of the consumer.

The latest figures show government and consumer spending as the biggest contributor with business investment woefully lagging. Stock buybacks by companies took up some spending and that kind of makes some sense. If businesses aren't spend-

ing money on expanding, they might opt to spend some excess cash buying back stock from the public. By taking some stock back off the market which is what happens during a stock buyback, it has a tendency to lift the stock price. Not always mind you, as once again the caveat "nothing is for sure when it comes to the stock market" comes into play.

One of the big questions that seems to never leave the evening news when it comes to the stock market is are the GDP figures bad enough to prompt the Federal Reserves, here forth called the Fed, to lower interest rates again just like they did on July 31st, 2019 where they dropped it for the first time since the 2008 crisis. The most watched interest rate manipulated by the Fed (fed funds rate) went from 2.25% to 2%, a quarter percent reduction.

What's the thinking when it comes to dropping rates?

From USA Today: *"The Fed lowers the fed funds rate to stimulate the economy by making it cheaper to borrow money. Rates on credit cards and home equity lines of credit track the fed funds rate closely and provide more spending power for American".*

More often than not, in recent decades at least, what the Fed does can have a significant impact on market reaction. As always in the markets, one never knows what the market will do as a whole,

and if economic conditions deteriorate, the markets may run in anticipation of a Fed interest rate drop in response. On opposite side of the spectrum, if the economy shows itself to be booming, where normally one might think that would prompt stock buyers, the opposite might happen. Good economic news might lead to a drop in markets as investors anticipate a Fed rate increase.

What's to learn from all of this and how can we use it to guide our investing? In reality, the best move is not to worry about day to day movements in the markets. My personal opinion is the common belief of holding for the long haul exposes one to a 2008 type melt down and no one can say for sure whether next time it will stop falling like it eventually did in 09 (-54.1 % loss October 07 – March 09- The Dow-Wikipedia). Who is to say next time won't be worse right?

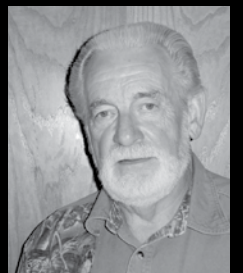
But day to day movements due to Fed interaction can be a flash in the pan. Economic fundamentals are a more reliable indicator, at least in my opinion, to better base investing decisions on, and those fundamentals can be better evaluated and communicated to you by an economic professional obviously.

Fishing in the Yuba Sutter area has slowed down. The Feather River has dropped down a bit and other waters have begun getting into the winter mode. I can recall many Octobers when the weather was actually on the hot side. This is not true so far this month. Our weather source tells us he expects the last part of October to be a bit warmer, but not anything in the 90's.

Lake Berryessa is still in the news, but some anglers are shaking their heads in disgust while others are jumping up and down with a big smile on their faces. We always called this kind of fishing and a hit and miss situation.

The fishing at Collins Lake for trout has been slow but this is about to change. The Lake received its first fall trout plant a week ago last Saturday. A thousand pounds of rainbows were dropped in the lake which should boost up the catch as soon as the fish adjust to the change. The catfish bite is still on and some nice fish have been caught.

Eagle Lake has turned over so the trout are near the surface at this time. Best bet is to forget about deep water and go after the trout with surface lures or flies. Stay in the shallow areas of the lake in 10 to 12 feet of water.

We hear from Lake Almanor. Conditions here

are about the same with few boats on the water. The water temperature continues to drop and the fish here are not co-operating with just about any type of bait fishing or trolling.

The brown and rainbow trout in Lake Tahoe are feeding in the shallows at this time. Best bet here is to troll with flashers and worms or minnows.

There is definitely a chill in the air early in the morning and the

leaves are beginning to turn color and fall to the ground. I love this time of year as Mother Nature signals the end of another summer and the beginning of winter. Of course, there is also a ton of work to be done in regard cleanup and of course getting the boat and tackle ready for a siesta until spring.

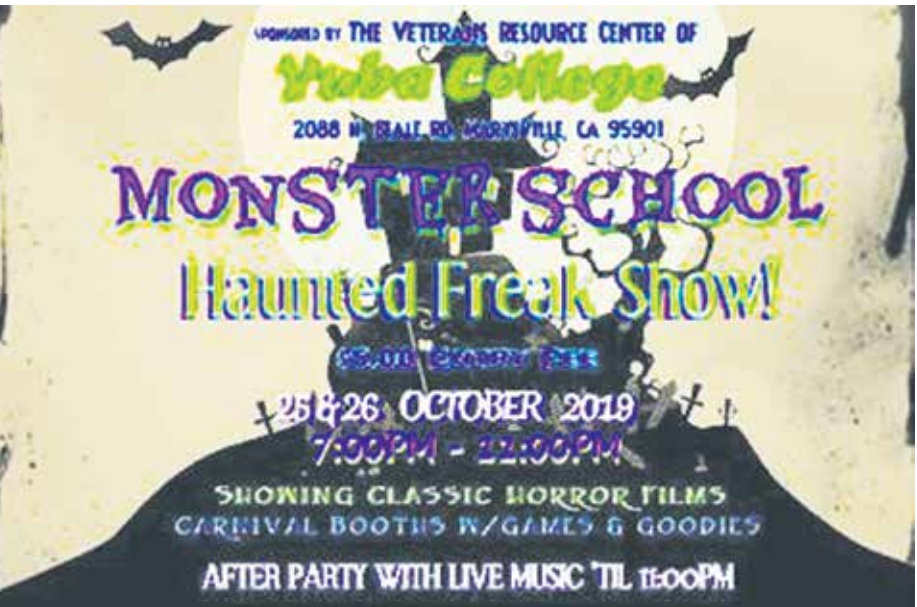
A zombie walk is simply an organized public gathering of people who dress up in zombie costumes. Participants meet, fine tune their

that, you know, we’ve been very good at getting heart, lung, liver . . . so I’m not gonna crush that part, I’m going to basically crush below, I’m gonna crush above, and I’m gonna see if I can get it all intact.”

“Because infant brains are in demand, Nucatola told Sandra and her associate David that Planned Parenthood abortionists alter their surgical technique to ensure the brain comes out ‘intact.’”

“They flip the baby in the womb, she said, so the head—the largest part of babies—comes out last, after the mother is more fully dilated.” Here’s how Nucatola put it. “Planned Parenthood abortionists change the

presentation (of the baby in the womb) so that (the baby) is not vertex (head first), because when it’s a vertex presentation, you never have enough dilation ... to deliver an intact calvarium (brains).”

Changing abortion procedures to collect “fetal tissue” is a violation of federal law.

PP Southwest’s Associate Medical Director Dr. Thomas Moran was caught lying under oath as claims of abortionists “fearing for their safety” fell apart in the San Francisco Federal Courtroom. ## Food and Farm News

### Farmers, ranchers assess impact of power outages

Operations are returning to normal at California farms, ranches and agricultural businesses that endured public-safety power shutoffs. The widespread outages interrupted harvest schedules for winegrapes, rice and other crops, and caused scattered produce losses due to lack of refrigeration. The outages also disrupted water deliveries for irrigation and livestock, and caused logistical problems for wineries and food processors.

### Crews complete delta habitat-restoration project

An intentional levee breach in the Sacramento-San Joaquin Delta Tuesday completed a years-long habitat-restoration project. Known as the Tule Red Tidal Restoration Project, the work aimed to create wetland habitat for endangered and threatened fish. Customers of the State Water Project provided funding for the work, and said the project would also benefit flood protection. Land for the project had previously been used for duck hunting.

### Volume of avocado harvest exceeds expectations

The avocado season officially ends at the end of October, and marketers say the California harvest could be as much as 30% higher than preseason estimates. Even so, the harvest was relatively small. The California Avocado Commission says the upcoming crop could be much larger, if weather remains favorable.

## FBI in Need of Redemption

der oath that he repaid the reporter for the tickets (\$65 each) and then later admitted he never paid the reporter. He also changed his testimony about who he attended the game with, admitting that the guest was a female FBI employee and not a civilian as he previously testified.

And, will we soon forget Robert Mueller, also a former FBI director, touted as a spotless public servant and charged with investigating "Russian Collusion?" The guy has dementia, is totally biased or a liar, maybe all three. (There are numerous other FBI and DOJ employees caught in the corruption that will not be addressed here due to space limits.)

Now, we learn about Michael Kortan, Director of the FBI's Office of Public Affairs, until his sudden retirement in early 2018. Kortan's communications with the reporters were noted as the Inspector General (IG) investigated the FBI and the DOJ's actions in advance of the 2016 election.

Kortan claimed un-

der oath that he repaid the reporter for the tickets (\$65 each) and then later admitted he never paid the reporter. He also changed his testimony about who he attended the game with, admitting that the guest was a female FBI employee and not a civilian as he previously testified.

He also admitted lying about the types of seats reserved with the tickets. The tickets were for a members-only area and not in general seating as Kortan initially claimed.

The report also found that multiple FBI employees accepted gifts from the liberal media in violation of FBI policy.

The IG stated that CNN and the New York Times reporters were considered "prohibitive sources" under the statute forbidding gifts to federal employees. Kortan failed to report the gifts also in violation of federal law.

Why is Kortan's integrity an issue? His name appears thirty times in the IG's report on the actions taken by the FBI and the DOJ to meddle with the 2016 election. The report says Kortan coordinated media coverage and participated in high-level calls. He did damage control on October 21, 2016 as FBI agent Peter Strzok

briefed former bureau officials about the handling of the Clinton-email probe.

Lisa Page indicated Kortan was trying to get former FBI officials to stop criticizing the FBI's Clinton email investigation. Remember, no charges were filed by Clinton friend FBI Director Comey.

The Deep State media taking care of government employees with gifts appears to have returned strategic rewards in the coordinated effort to overthrow the President of the United States. Records show Trump was targeted before he was elected as being unacceptable to the Deep State. The idea was to smear candidate Trump, rig the election and if that all failed then remove him from office via a contrived corruption scenario.

## Governor Signs Camp Fire Housing Bill

### AB 430 Will Expedite Home Construction

Sacramento, Ca.

Governor Gavin Newsom has signed into law Assembly Bill 430 authored by Assemblyman James Gallagher (R-Yuba City). The Camp Fire Housing Assistance Act of 2019 will help expedite home construction in the North State region by streamlining environmental regulations that often delay or stop housing developments.

Specifically, AB 430 allows housing projects that meet specified criteria to utilize an expedited ministerial review process, including an exemption from the California Environmental Quality Act (CEQA).

"I want to thank Governor Newsom for singing this important housing legislation into law. This action shows what we can do when we work together as a community, across party lines, working with all the stakeholders to provide much needed relief to those who have been devastated by the Camp Fire," said Gallagher. "Many say that CEQA reform legislation in California is impossible; we showed that with the right focus all things are possible."

Gallagher concluded, "This legislation will give these cities an exemption from CEQA to fast track housing projects they had already planned for in their zoning and General Plans. It will provide an excellent tool and shot in the arm to beef up the housing supply in the region post-Camp Fire."

Cities that will benefit from AB 430 include: Biggs, Corning, Gridley, Live Oak, Orland, Oroville, Willows, and Yuba City. Each city benefiting from this bill is in full support of the new law.

Pete Carr, Orland City Manager, said recently that CEQA can often add time and expense to housing projects. "AB 430 helps us to be able to more quickly get new housing approved. Hopefully developers will use this as an opportunity to bring some more housing to Orland, where it's needed and welcomed,"

said Carr.

Willows City Manager Wayne Peabody noted that AB 430 will help cut through the red tape, "The bill is going to help speed things up and that's big," said Peabody.

Citing unwavering support for CEQA and growth concerns, the Chico City Council asked Gallagher to remove Chi-

co from the bill.

Assembly Bill 430 enjoyed bi-partisan support in Sacramento since its introduction. Throughout the legislative process, only 2 of the 120 lawmakers in the California Legislature opposed the bill. The new law goes into effect January 1, 2020.
