NYWD Investigation Results

After five months of investigation of the North Yuba Water District (NYWD); the conclusions were that "the investigation did not find credible evidence of an intentional omission of facts, misrepresentation, or fabrication of data that would alter the eligibility of the grant application."

For five months there were weekly accusations from the Yuba Water Alliance, a local group of citizens, not all NYWD customers, whose contact person is Alton Wright, painting a picture of corruption and fraud on the part of the NYWD Board and the General Manager, Jeff Maupin,

NYWD is lying" "NYWD's never-ending negligence is now a
public safety issue."

The actual findings of the investigation by the State Water Resources Control Board, Office of Enforcement (Fraud, Waste, and Abuse Prevention Unit are:

"The investigation did not find credible evidence of an intentional omission of facts, misrepresentation, or fabrication of data that would alter the eligibility of the grant application. The Quit Claim relationship between NYWD and SFWPA was provided in the application. Reliable aluminum data showing exceedances of the MCL in the ditch water was provided by the NYWD in their application,

and that data was not treated by the DFA as significant in ranking the application. The DFA acknowledged the benefit to irrigation water customers as well as to domestic users in their evaluation of the application prepared by Northstar and Mr. Maupin on behalf of the NYWD. The grant application was reviewed, in accordance with the DFA's standard practice, in a 19-step process documented in the application assessment package. The application package provided by NYWD was compliant with State Water Board requirements, and as a result the Forbestown Ditch Planning Project was determined to be eligible for funding."

County Wins Even by Losing

In 2018, County Administrator (CAO) Robert Bendorf and

the Yuba County Supervisors made a determination to seek a 1% sales tax increase to "save public safety." The scheme to sell the increase as a public safety tax but then put it on the ballot as a general fund tax has undermined the credibility of the Board of Supervisors and the county administration.

The supervisors' excuse that they would put this measure

on the ballot and "let the people decide" was a "heads I win and tails you lose" ploy. They played the citizens and/or they followed their CAO's deceptive lead.

The entire media campaign from multiple fliers designed to instill fear, public safety town hall meetings, fire and law enforcement themed signs, the sheriff chairing the campaign committee and the ballot ordinance itself shouted public safety is suffering, there is not enough money and we guarantee the money will go for public safety.

Bottom line, it was another "give us more" campaign touted with guarantees but it was all a mirage.

Up until the 1990s county general funds were sufficient to take care of law enforcement and fire needs. Then after the jail expansion in the early 1990s Sheriff Gary Tindel contracted out beds to the federal government and millions of dollars came to the county annually. The excess revenues over costs were a cash cow that supervisors had control over. The monies were fungible, produced by law enforcement, but could be directed anywhere in the county by supervisors and they were.

In the late 1990s and early 2000s, supervisors saw more money than ever before and began to raise salaries, even retroactively to the date of hire. That spiked salaries and pensions tremendously. In union negotiations supervisors would even pay the employee share of pension contributions. (In the private sector, employees normally pay for their own pensions.)

The Immigration and Customs Enforcement (ICE) money began to be known as ICE "Crack" around the sheriff's department making an analogy to the addictive quality of the drug "Crack" cocaine. County administration was living above its means, salaries and pensions had been spiked, supervisors' salaries were doubled, ICE and sheriff's funding diverted for other uses and then the 2006-7 housing crash occurred.

County leaders so overcommitted the budget that it was now a disaster. The final straw would have been losing the ICE contract which today brings in over \$6 million a year and

Law Makers and Law Breakers

Each year the state legislature passes more than 900 laws by finding something new the citizens are doing wrong. We started with the Ten Commandments but now have thousands of laws in the "Golden State" to keep us in check?

The most egregious law breakers are those that make them. In fact, law makers live like they are above the law.

The Freedom of Information Act instructs government to provide requested documents in 10 days but it took months for Yuba County to produce the initial costs of the Measure K campaign. In fact, using the public's money for a campaign to convince people that they should pay more taxes is illegal but it was done by Yuba County Supervisors anyway.

The free speech clauses of the Federal and State Constitutions prohibit the use of governmentally compelled monetary contributions (including taxes) to support or oppose political campaigns since "Such contributions are a form of speech, and compelled speech offends the First Amendment." Smith v. U.C. Regents (1993) 4 Cal.4th 843, 852.

And, the "Use of the public treasury to mount an election campaign which attempts to influence the resolution of issues which our Constitution leaves to the 'free election' of the people (see Const., art. II, \S 2) ... presents a serious threat to the integrity of the electoral process." Stanson v. Mott (1976) 17 Cal.3d 206, 218.

Yuba County has been spending money furiously for legal fees, public relations and campaign paraphernalia now for 2 years to trip-up voters. There really is no one to hold them accountable. The district attorney who is supposed to be impartial and prosecuting wrong doing was an advocate of the campaign.

Some leaves have fallen and nights have been a bit cooler. The next five or six days will be pleasant without the hot afternoons. This is a sure sign Fall is just around the October is the month

to catch the big trout along with their smaller cousins. This time of year and into October trout in the streams, rivers and creeks of the Golden State are feeding heavily in preparation for the coming days and night of winter. The food supply has reduced due to most of the insect hatches being over and done with. Don't get me wrong.....there are still insects in the water, but fewer can be had for a trout to feed on.

the water, to be able to read the signs. Only in this way can you catch lots of trout and also have a chance at hooking into the big trout which live in streams and rivers. The fish will hold in certain parts of the water, usually where the current is a bit slower. This can be caused by underwater obstacles such as boulders, submerged tree branches or roots and stumps. A natural dam created by debris and logs will always hold trout in the pond created by same. Look for a change in the water surface such as a swirl or "V" shaped area. Always observe across the stream to find where the fast water meets the slower water. Look for it and you will find it...a change in the surface. Remember that when the fast white water slows and turns green or blue

of red worms above the spot you figure the trout are holding and let the natural current flow deliver the bait makes it look more natural and will not spook the trout. The worse thing a person can do is plop the bait right on top of the trout. Let the current present you're offering. This also goes for cut banks where trout like to hide.

Never, ever let your shadow be seen on the water and when you approach a good spot to fish walk quietly because your vibrations caused by heavy walking will be felt by the trout. I have actually crawled to a stream and flipped my line into the water. Silly? No, not if it catches fish and I have caught hundreds of feisty rainbows, browns and brook trout in the streams, creeks and rivers of the Sierra Nevada Mountains.

Boot's fishing tip of the week: "When trout fishing in the high country never wear bright colors but always greys and browns."

Dogs trained to detect bacteria that cause a fatal plant disease found signs of the bacteria in Ventura County citrus groves, and farmers have begun removing trees as a result. The detector dogs check citrus trees for the bacterium that causes HLB, which has killed trees at Southern California residences but has not been found in a commercial grove. After the dogs alerted to more than 200 trees, farmers agreed to remove the trees as a precaution.

UC helps residents combat citrus threat

To prevent the citrus disease HLB from spreading, University of California specialists recommend Southern California homeowners remove citrus trees within two miles of known HLB infections. UC created a web app so residents can enter an address and see how close they are to confirmed HLB outbreaks.

A fish habitat project north of the Sacramento-San Joaquin Delta will proceed, according to an announcement Tuesday from a federal agency. 










open rather than being done behind closed doors. Since Measure K had been a very public debate and a measure put on the ballot by the board why did they meet in closed session following the judge's ruling? It was inappropriate and unethical.

The people had a right to hear and be heard by the board about the appeal of Measure K. President though Trump opened the account as a personal account before his presidency and would retain personal control over account after his presidency.

So, Supervisors Bradford and Fletcher along with any others utilizina blockina to censure speech of their constituents is illegal.

Finally, though not illegal, hypocrisy by county officials is troubling. The county administrator was quoted in the Appeal Democrat saying "It's unfortunate that out-of-town organizations and an expolitician felt they had to twist the purpose of Measure K in order

to undo the will of our voters."

Plaintiff Howard Jarvis Taxpayers Association is the most highly respected public service nonprofit in the state helping people stay in their homes and protect their rights. And law firm Bell, McAndrews and Hilltachk, LLP of Sacramento (representing Measure K opponents) is regarded as top election law experts in the state.



The movement of markets however, is just the sum of all the beliefs of all the millions of investors in it at any given time. And that my friend is sociology, not science.

Tell me what hundreds of millions of people will do at any given day in the market as a whole and the stock market will be your oyster. But then again, that's not quite possible is it?

Rosenstein Coup Plan **Involved Wearing A** Wire, Invoking 25th Amendment, **Appointing Special Counsel**

Judicial Watch reports new documents reveal the Department of Justice made an effort to craft a response following then-Deputy Attorney General Rod Rosenstein's 25th Amendment report.

TOM FITTON, JUDI-CIAL WATCH: This is the first official confirmation based on government documents that discussions took place or allegations that it took place. There was some testimony about it.

But here you have Rod Rosenstein and his team tried to craft a response, a non-denial denial to the allegations. When you look at the materials you see Rosenstein saying, "Hey, we're hopeful, we're successful in preventing people from talking about it." Rod Rosenstein plotted Trump coup, Judicial Watch says ...

Former Deputy Attorney General Rod Rosenstein acknowledged he discussed with the FBI of wearing a wire when talking to President Trump but insisted the comment was in jest amid tumultuous times at the Justice Department.

His acknowledgment is contained in a series of emails exchanged in 2018 in response to a New York Times story. The September 2018 story was apparently sourced to fired Deputy FBI Director Andrew Mc-Cabe, a fierce enemy of the president's and now Democratic Party back-

The emails were obtained under the Freedom of Information Act by Judicial Watch, a conservative investigative non-profit.

Judicial Watch President Tom Fitton said the emails stand as more evidence that the FBI mounted a coup to try to bring down Mr. Trump.

HJTA Wins Lawsuit to Stop Use of Public Funds for Campaigns

The Howard Jarvis Taxpayers Association and retired state Senator and Judge Quentin L. Kopp prevailed Monday (26) in a lawsuit to invalidate Senate Bill 1107, a 2016 California law that would have allowed political campaigns to be financed with taxpayer dollars.

"California voters passed Proposition 73 partly to prohibit taxpayer dollars from being used as political slush funds," said Jon Coupal, President of HJTA. "If politicians want to change that, they have to take the issue back to the voters."

In a unanimous deci-

sion, the Third District Court of Appeal ruled that voters outlawed public funding of political campaigns when they adopted Proposition 73, co-authored by Kopp, in

Proposition 73 provided, "No public officer shall expend and no candidate shall accept any public moneys for the purpose of seeking elective office." Senate Bill 1107 would have provided instead that "a candidate may expend or accept public moneys for the purpose of seeking elective office." The Legislature, in passing Senate Bill 1107, included a finding that the bill

furthered the purposes of Proposition 73. The Court of Appeal rejected that finding.

Howard Jarvis Taxpayers Association opposed SB 1107 and consistently opposes public funding of campaigns.

HJTA and Kopp are represented by Charles H. Bell, Jr., a leading California political law attorney with the firm Bell, **McAndrews** and Hiltachk; Anthony T. (Tom) Caso, with the Center for Constitutional Jurisprudence; and Allen Dickerson, with the Center for Competitive Politics.

U.S. D.O. Justice Agrees That CalSavers Program is Illegal

Friday September 13, 2019 the United States Department of Justice filed a "Statement of Interest" in the U.S. District Court agreeing with the Howard Jarvis Taxpayers Association (HJTA) in its legal action against California's so-called "CalSavers" program. Originally called "Secure Choice," CalSavers is a state-run retirement plan for private-sector employees. HJTA contends that it is an illegal program that leaves taxpayers, businesses and

private sector employees exposed to unnecessary costs and risks.

"We are very pleased that the United States Department of Justice agrees with our core position that the program is facially invalid under the federal Employee Retirement Income Security Act (ERISA)." said HJTA president Jon Coupal.

He added, "There is no need for this program. Private employees already have access to Social Security which is backed by the Full Faith and Credit of the federal government. Moreover, individual retirement accounts (IRAs) are easy to set up. Given the poor performance of CaIP-ERS and CalSTRS, both in terms of investment performance and governance, why would we give state politicians and bureaucrats access to another pension program?"

The case is currently pending in the United States District Court for the Eastern District of California.

Search Warrant Served at Illegal Cannabis Grow in Oregon House

Oregon House, Ca. At approximately 7:30 a.m. on September 12, 2019, the YCSO Marijuana Enforcement Team (METYU) with the assistance of the Yuba Sutter Regional SWAT Team and Yuba County Code Enforcement executed a search warrant in the 9000 block of Marysville

Rd in Oregon House. The location was an outdoor cannabis grow that did not comply with state law or local ordinances for cultivation of Mariiuana.

During the search, Deputies located and eradicated 101 marijuana plants that were approximately 6-8 feet tall and

wide. Investigators had been previously alerted to the illegal grow from citizen complaints and confirmed by overhead flyovers. There were no suspects present at the time of the search and the investigation remains active and ongoing.

NYWD Begins Process Forbestown Pipeline Project

Brownsville, Ca. - A presentation by Northstar Engineering was given to the North Yuba Water District and the public at a special meeting on September 10, 2019. The presentation was the first step toward beginning the Forbestown Pipeline Project.

The board was asked to accept the engineering specifications and plans for the project. The goals of piping the ditch were explained as #1 Conserve water through stopping seepage and evaporation. #2 Preventing water contamination from the environment including animal waste. #3 Stop ditch blow outs. The plans call for access to water in the pipeline every 1,000 feet, This could be used for fire in an emergency. The vote to accept the engineering plans and specifications was unanimous.

Sacramento Democrats Crush Californians' Dreams

AB 5 Kills Independent Contracting and Flexible Hours

Along party lines, Sacramento Democrats ended millions of Californians' ability to earn a living while working flexible hours that fit their schedules. Citing the support of groups that received special exemption from the legislation, Sacramento Democrats passed Assembly Bill 5, a measure to redefine the definition of "employee" and require millions of independent contractors to be classified as employees.

"California has become a hostile place to do business," Senator Jim Nielsen (R-Tehama) said. "Tonight, the Legislature turned this hostility toward millions of independent contractors. With the exception of a few professions, Assembly Bill 5 will restrict a worker's ability to work flexible hours that fit their needs."

Specifically, AB would codify and apply the state Supreme Court's misguided decision in Dynamex Operations W. v. Superior Court, which prohibits independent contracting unless very restrictive conditions are met. The burden of proof is placed on employers.

Senator Nielsen add-

ed, "The quality of life will change for many families who rely on the flexibility to tend to children and/or their elderly relatives. North state residents have loudly expressed their concerns."

Senator Nielsen's office received 770 correspondences regarding AB 5 and only 33 supported this measure. AB 5 now moves back to the Assembly for concurrence, before heading to the Governor's desk for his decision, and he is expected to sign it into

Illegal Cannabis in Strawberry Valley

On September 9, 2019 at approximately 7:30 a.m. the Yuba County Marijuana Enforcement Team with assistance from the NET-5 drug task force, served a search warrant at an illegal

cannabis cultivation site located in the Deadwood Creek area near La Porte Rd and Juniper Lane, in Strawberry Valley.

188 marijuana plants were located in the creek bed, along with pumps in the creek that were being used to water plants; and an illegal water diversion to capture water for the pumps. No suspects were located at the site.

Yuba County Board Adopts 2019-2020 Budget

Marysville, Ca.

The Yuba County Board of Supervisors this week passed the final \$227 million 2019-20 budget. which sets aside more funds to guard against any future downturn in the economy.

In a presentation at the September 10 Board meeting, Yuba County Administrator Robert Bendorf noted the Reserve Fund reached historical highs of \$3.7 million—a \$1.6 million increase from the 2018-19 budget. He said that puts reserves at 11 percent of the General Fund, exceeding the county's policy level of 5 percent and going beyond the Board's stated goal of 10 percent.

In addition, the budget also includes a newly-adopted \$1.5 million Fund for Economic Uncertainties.

Other notable facets of the budget include:

- \$250,000 in additional funds is set aside for the pension liability fund established earlier • Half a million dol-
- lars in one-time funding goes to the County Capital Improvement Fund for future technological enhancements or replacements of aging public administration and public safety legacy systems.
- Code Enforcement receives an additional \$300,000 in one-time funding to help address complaints related to homelessness, blighted properties and other activities.
- Bendorf said the budget sets the stage to effectively serve Yuba County residents, having met the goals of the Board while also looking

to the future of making Yuba County a thriving place to live, work, and play.

The tentative budget was adopted in June of this year, to meet mandated requirements to have a budget in place by the July 1 start to the fiscal year. The adoption of the final budget consistently occurs in September, after the county is able to get better estimates on funding sources and anticipated

expenses. The final budget now heads to the county Auditor-Controller's Office, which will file the document with the state Controller's Office by December 1. The final budget will be posted on the Yuba.org website shortly after this process is completed.

Large Marijuana Grow North of "Beer Can Beach"

Linda, CA - On September 4, 2019, Yuba County Sheriff's Department and Net-5 located a large outdoor marijuana grow at the Yuba River north of what is known as "Beer Can Beach" in Linda. No suspects were located at the grow site; but a hose line leading from the river to the garden was located along with over 480 Marijuana plants. The grow site was discovered following an anonymous report from a citizen.

This in another example of illegal water diversion and environmental/fish and wildlife violation issues surrounding illegal cannabis grows in Yuba County.


