# The Great Race Coming to Grass Valley on June 24

Grass Valley, CA.

On Monday, June 24, 2019 downtown Grass Valley will travel back in time as over 120 vintage road racers will rumble down East Main then onto Mill Street in the only stop for the Great Race in the Sacramento area.

The Great Race is a one-of-a-kind event held each year at a different location/route in the U.S. In 2019 the Great Race will begin in Riverside, CA on Saturday, June 22 and end in Tacoma, WA on Sunday, June 30. The race will stop for lunch in Grass Valley on Monday, June 24, with the first car coming into town at approximately 12pm, and the final car leaving at approximately 3pm.

A time-speed endurance rally for vintage cars 1974 and older, the Great Race began in 1983 as a means of celebrating classic cars and the American landscape with entrants vying for prize money. The 2019 Great Race prize purse is \$150,000. Teams and cars from Japan, England, Germany, Canada and every corner of the United States will be participating in their vintage automobiles dating back as

far as 1916.

"There are more than 500 people just in our entourage from all around the world taking part in this incredible adventure," director Jeff Stumb said.

To celebrate this historic race, Nevada County Habitat for Humanity and Grass Valley Downtown Association have partnered to hold a downtown rally where people can get an up-close experience of these vintage road machines. The event begins at 11am and ends at 4pm. Portions of Main and Mill Street will be closed to create a lunchtime pit stop for racers, while also accommodating a classic car show by the local Roamin' Angels car club. Making this event possible are sponsors Douglas Automotive, RCD Engineering and Owens Estate and Wealth Strategies Group.

"When the Great Race pulls into a city it becomes an instant festival," Stumb said. "Last year we had a couple of overnight stops with more than 10,000 spectators on our way to having 250,000 people see the Great Race during the event."

The event is an excellent opportunity to witness cars dating back as far as the early 1900's in peak operation as they enter and exit the staging area in historic downtown Grass Valley, creating a unique aural and visual spectacle. A 1916 Hudson Pikes Peak Hillclimber, a 1916 Chevrolet Phaeton, a 1917 Peerless Racer and a chain-driven 1918 American LaFrance Speedster are the oldest cars scheduled to be in the 2019 Great Race.

Nevada County Habitat for Humanity became involved through board member Bill Croker. Croker is a 10-year veteran of the Great Race, and will be competing with his 1936 Packard. Three race teams from Grass Valley are entered into the race - the most ever from a town of its size. Joining Croker will be Den Reinholdt in his 1937 Packard, and Robert Brocke will be heading a high school team driving a 1972 Datsun. Each team is raising money for the Habitat mission by accepting mileage pledges from supporters.

## Don't Mess With The Sheriff

California liberal legislators want to create citizen committees to rule over and supervise sheriffs elected in the state's 58 counties. The ultimate goal is to see sheriffs appointed like Chiefs of Police, rather than elected.

Sacramento democrat Kevin McCarty's Assembly Bill 1185 would establish citizen oversight boards for elected sheriffs in each county and even an Inspector General to investigate complaints involving law enforcement. The oversight panel and the Inspector General could come to be by a decision of the Board of Supervisors or by an election if AB 1185 becomes law.

The bill narrowly passed the Assembly. If it is approved by the Senate and signed by Gov. Gavin Newsom the Constitutional independence of the elected sheriff would be undermined.

The bill's introduction states, "Existing law establishes the office of the sheriff in each county to preserve peace, and authorizes the sheriff to sponsor, supervise, or participate in any project of crime prevention, rehabilitation of persons previously convicted of crime, or the suppression of delinquency. Existing law requires a Board of Supervisors (BOS) to supervise the official conduct of all county officers and ensure that they faithfully perform their duties."

AB 1185 would add a new level of governance over the sheriff.

The current requirement of the BOS to "supervise the official conduct of elected officials" etc. is a puzzler. Exactly what would the BOS do to address ethical, moral or legal failure by an elected official?

The Sutter County BOS claimed they could do nothing after former District Attorney (DA) Carl Adams had a moral failure with an escort whom he granted immunity in a murder trial and then lied to a Yuba City Police Investigator about it. The DA's office was said to be a sexually charged environment where one employee sued for sexual harassment and prevailed.

The Sutter County BOS then sided with troubled District Attorney Amanda Hopper in her mission to slander and fire investigator Jason Parker even after a Sacramento Administrative Law Judge agreed with Parker that he should get his job back.

The Sutter County BOS has also done nothing publically to ad-More on Page 7

## No Fathers Not Slavery the Problem

When certain black-Americans blame their unemployment, lack of success, educational underachievement and incarceration on events happening to Africans in the 18th and 19th centuries, can anyone think of other ethnic groups suffering injustice and then later generations getting a free pass by society?

How about the children of Israel or Jews that have suffered world-wide with more than 6 million of their people killed during WWII. Furthermore, for thousands of years they were enslaved, persecuted and exterminated.

They asked to return to their homeland of Israel following WWII, it was granted them, and the place was a disaster. Though they were and are regularly threatened with annihilation they complain not, but have caused their desert home to bloom and thrive.

African slaves were bought to the 13 Colonies and throughout the Americas for farm labor and held "against their will." Land in Liberia was purchased by the U.S. and an offer made to freed slaves to return to Africa. Very few did. Today, Africans want to move to America.

In 1975 and thereafter millions of democracy-loving Vietnamese were killed, put in re-education camps or drowned trying to float their way to freedom. Most of the tens of thousands of refugees in Hong Kong were forcefully repatriated to Vietnam to be treated as traitors by the communists.

A quick review of the hundreds of millions of dead representing hundreds of ethnic groups suffering persecution (in Soviet Union, China, North Korea, Laos, Cambodia, Vietnam, Myanmar, Africa and elsewhere) may offer perspective to American blacks wanting reparations, entitlements etc.

There is no evidence that slavery, 150 plus years ago, is still affecting blacks today. The true culprit is the modern welfare state and the War of Poverty launched in the 1960's by Democrat President Lyndon Johnson. Welfare, not slavery caused the black family to fail quickly. Black economist Walter Williams says, "The No. 1 problem among blacks is the effects stemming from a very weak family structure. Children from fatherless homes are likelier to drop out of high school, die by suicide, have behavioral disorders, join gangs, commit crimes and end up in prison. They are also likelier to live in poverty-stricken households. But is the weak black family a legacy of slavery?"

In 1960, only 22 percent of black children were raised in sin-

## **Disaster Preparedness For Your Pets**

When the call comes to get out, have you prepared to take your pets with you? Natural disaster is a risk no matter where you've made your home in northern California: flooding in the valley, fire in the hills, and an earthquake anytime.

There is growing recognition that our pets, such as cats and dogs, are considered members of the family and need to be included in a disaster program. preparedness After you've reviewed the numerous guidelines available to keep the humans in your family safe, consider these practical suggestions to protect the furry members of your family.

#### Microchip

The risk of getting separated from your dog or cat during a crisis is high. All it takes is an open car door and a cat that can't be found, or a dog that slips its collar and runs. Taking the time to implant a small microchip, about the size of a grain of rice, into the pet's scruff can make the difference between reuniting with your pet, or not.

One common misconception about microchips is that anyone with a microchip scanner will have your personal information. This is not true! When an animal with a microchip is scanned a unique number of 10-15 digits appears on the scanner screen. The number is reported to the microchip database, where the number and contact information can be matched. The microchip databases will only release contact informa-

tion to certain organizations such as shelters, which will reconnect you with your pet. This is why it's so important to periodically check your pet's microchip contact information in the database. The information is only as good as the last time you updated it.

#### **Current photos**

The latest selfie pic with your cat, showing off its gorgeous eyes is great for posting on social media, but not so great for finding them in the chaos after a disaster. Take a few quick pictures in good lighting of your pet from each side, including the front. If there are any unique distinguishing marks, take pictures of those too. Keep the pictures in a safe location that will be accessible if vou are away from home. such as an online cloud storage or a social media account.

#### Pack a Go-bag

A bag with your essentials is ready to go, but what do your pets need?

Pack important paperwork including a copy of the latest vaccines, rabies certificate, proof of license, and copy of their microchip number. If your pets are on any long-term medications that are not perishable, discuss including an extra week's supply in the bag with your veterinarian. You may also want to discuss whether it is appropriate to include any oral sedatives in the bag that might help your pet feel less stressed during and after an evacuation.

Include an extra collar and leash for each dog, and a water bowl. For cats, a good safety precaution is to keep collapsed cardboard carriers for each cat in your vehicle or underneath your go bag. Cats are safest when they are contained. They can easily escape from your arms and be difficult to retrieve in a stressful situation. In an emergency, pillowcases

can be used to transport a cat to a vehicle or other contained location if a carrier is not available.

Remember that items such as pet food are often easy to obtain once you are in a safe place. For this reason I suggest not keeping food in the go-bag because it takes up unnecessary space, weight, and is a pest risk. However, if your pet is on a special diet because of a medical condition, consider packing a can of the appropriate food with a can opener.

#### **Preparation and Training**

Remember, there are likely many animal lovers who will be in your same situation, and it may be crowded at shelter locations. Under stress, dogs and cats can behave unpredictably. The priority to is to keep all animals and humans safe. Keeping pets on leash and in carriers and kennels is the best way to ensure there are no accidents. All dogs should be able to wear a secure collar or harness if needed. Adjust these tight enough so a dog cannot back or twist its way out. Kennel training your dog will significantly lessen their stress if they need to be boarded or kept in a kennel at a shelter.

Not all recommendations may be appropriate for your specific situation, and it's important to always follow firstresponder's instructions. Remember, you can't keep your pets safe if you don't first keep yourself safe. If your situation is complicated, with multiple animals and complex needs, consider evacuating or asking for help earlier than mandated. With thoughtful preparation and a plan in place, pet owners will greatly increase the chances that all family members, both human and furry, will escape whatever Mother Nature has in store next.

If you are looking for some fun try the striped bass fishing in the Feather River. Cut bait is the name of the game and you can catch fish under 18 inches all day long with a keeper or two. Be gentle when you remove the hook so as to not injure the small stripers. These hard fighting fish are the ones we will enjoy next year. The Department of

Fish and Wildlife hit Nevada County last week. Catchable trout were planted in both Fuller Lake and Scotts Flat Reservoir. Fuller is one of my favorite places to fly fish. This small lake, which is located off of State Route 20 on the road to Bowman Reservoir. The lake is accessible by small boat, a float tube or kayak.

We will be at Lake Tahoe next week and will be fishing for Mackinaw Lake trout. These fish run large in Lake Tahoe but the average fish caught is in the 3 to 6 pound range and can be found down to over three hundred feet deep.

We have reports of shad swimming in just about all rivers in the Sacramento Valley. These cousins of the tarpon are cooperation, as usual, with anglers anxious to try their luck at catching these fish who put up one heck of a fight for their size.

Kokanee Salmon, which are found in many reservoirs throughout the state, are on the bite with Stampede Reservoir and Bullard's Bar Reservoir producing fish on a reqular basis.

We are told the Thermal to After bay at Oroville recreational area is not producing any fish due to the cold water being pumped from the bottom of Oroville Reservoir on its way down the Feather River.

Access to Gold Lake

and the region around it should be open by the time the Dispatch hits the streets. Gold Lake is still almost covered with snow. This is a real surprise to many since it is mid-June.

Access roads to Jackson Meadows Lake above Truckee is still closed at this time and there is an abundance of snow here

which means it is not known when the lake will be accessible.

Many anglers who went to Hat Creek recently have been disappointed at the size of the trout they are catching. Bait fishermen are not doing much as far as size of fish goes with most pan size, but the fly anglers are scoring with bigger fish at this time.

While Brooks Koepka took home the coveted Wanamaker Trophy as the 2019 PGA Champion, four military Veterans with disabilities from Northern California, including Mike Kopacz, a U.S. Soldier from Marysville, enjoyed a special experience during PGA Championship week.

After traveling 3,000 miles across the country, the Veterans representing the Northern California PGA Section, arrived at Bethpage State Park, Long Island, NY on Monday, May 13th to participate in the PGA HOPE Secretary's Cup, a spirited 9-hole golf competition for military Veterans that served as the kick-off to 2019 PGA Championship week.

The 4th Annual Secretary's Cup featured 12 teams competing in a scramble format on Bethpage State Park's composite Red and Blue layout. Each team consisted of 1 PGA Professional & 4 military Veterans living with physical or cognitive challenges

including PTSD, TBI and amputees, among others



#### **Tariff or Tax Credit**

In a recent article

from Money and Markets entitled "Fed: Tariffs Will Cost Average Family \$831 More in 2019", the argument was made that after the latest increase from 10% to 25% on \$200 billion in tariffs on Chinese goods, the average U.S. family will pay \$831 more a year for the same goods they bought last year. What the article didn't include was the next round of tariffs on Mexican goods. Also not factored in is the rising costs of goods and services as a general result of inflation here in the United States. Indeed no one needs to remind you of the sudden increase is gasoline which pushed close to four dollars or more per gallon in recent months. This also means the approximate 6000 other things made out of petroleum will also likely go up in price.

The average American family is having a hard enough time making ends meet and the challenging effects of increasing prices undoubtedly put more strain on some families.

Tariffs are fees put on incoming goods coming from countries outside the U.S. under the auspices of protecting the American business counterpart of whatever it is you're applying the tariff to, and/or punishing the other country for some egregious act or violation, as the case may be.

Tariffs are not new and usually there are tariffs on a variety of imports at any one time. To the degree we are seeing them now however is something of a rarity historically.

Because the price of something in the market place is somewhat arrived at by the sum of all prices of the item with slight variances off the average price to account for local demand and conveyance, raise the price of any one major supplier of something and the price of that something will rise. Since tariff money goes to into government coffers and the consumer ends up paying the higher price, tariffs are generally believed to be ultimately paid by the consumer. I have made the argu-

ment in a previous article that should protection of U.S. companies selling into any market where imports are sold competitively, a tax CREDIT to the U.S. company would serve the same purpose. Although tariffs raise the price of a good to the consumer and therefore make a domestic made good that much cheaper in comparison, a tax credit would enable the U.S. company to sell its product cheaper and thus better compete with the import just the same. The difference being the average cost of the good would decrease thereby lowering the cost of the item to the consumer.

I don't hear the argument for tax credits anywhere in the media and that's baffling. Both a and Cambridge are not tariff and a tax credit accomplish the same thing which is to punish the importer and give an advantage to the domestic 0L34249 producer.

As to who pays the tariff and where the money ends up is quite different thing. In the case of the tariff Washington gets the money that the consumer pays in the price increase. In the case of a tax credit, the consumer would pay less for the good and therefore have more money left over to spend on other things. In the latter, the economy would also benefit from higher consumer spending which came from the consumer having more money to spend because of the savings.

#### Rural regions prepare for power shutoffs

As utilities begin shutting off power in an effort to prevent wildfires, California farmers, ranchers and rural residents plan for ways to manage the power loss. Some say they may invest in generators to maintain water pumps for livestock and crops, plus producecooling equipment and other facilities. Farmers say they understand the rationale for the shutoffs and hope they succeed, and that power interruptions will be as short as possible.

#### Late-spring storms leave damage in their

wake Onions, tomatoes, cherries and cotton are among the crops damaged by late-spring storms in the Central Valley. Farmers, pest control advisers and agricultural commissioners say the crops suffered damage from hail or from plant diseases linked to the

wet weather. Observers say the crop losses may be significant for individual farmers but not widespread enough to lead to disaster declarations in most cases.

#### Farm, food groups seek approval of trade agreement

Urging Congress to pass a pending trade agreement, a coalition of more than 900 farm and food organizations said the agreement would help U.S. agriculture while providing highquality, safe food at affordable prices. In a letter to House and Senate leaders, the groups requested "swift ratification" of the U.S.-Mexico-Canada Agreement. The letter's signers included the California Farm Bu-Federation and more than three-dozen other California groups.

#### **Nurseries track plant** trends to plan greenhouse space

Tracking trends in houseplants allows Southern California nurseries to fulfill customer demand. Nursery owners say social media can help drive demand for houseplants, and note that some plants that became trendy in the 1970s are now enjoying a comeback. Keeping up with the trends requires foresight, because in some plants cases need close to a year in the greenhouse before they're ready for sale.

dress the Yuba City Unified School District's dismissal of long-time teacher Jim Whiteaker for repeated improper contact with female students. Whiteaker is on the BOS and now is employed at Yuba County Office of Education teaching students.

The Sacramento Bee editorial board came out strongly in favor of curbing the independence of sheriffs and notes numerous abuses by sheriffs in various counties. The Bee cites trouble with sheriffs in Sacramento (Scott Jones), Fresno (Margaret Mims), LA (Lee Baca and Alex Villanueva) and even Trinity County (Bruce Haney).

The Bee says, "The power of the county sheriff is so unusual and prone to abuse that some sheriffs don't even do the job once they're elected. An investigation by The Sacramento Bee in 2018 found that Trinity County Sheriff Bruce Haney didn't even reside in his own county,

let alone California. He lived on 53 acres in Lebanon, Oregon. On 'medical leave,' Haney collected \$9,000 per month in salary while feuding with that county's board of supervisors, who had no way to hold Haney accountable."

No normal person wants a corrupt or lawless sheriff. However, others believe that an elected strongly independent sheriff is needed to defend the Constitution when boards, councils and committees have been politicized or proven impotent. And, if intolerable problems arise, then there is an election every four years or even a recall election option in extreme cases.

Many sheriffs rebuffed the Obama - Biden gun control moves by reaffirming their oath to defend the Constitution for their county. This is a current issue in California as many jurisdictions are declaring to be a 'Second Amendment Sanctuary' city or county to uphold the Constitution

regarding gun rights. And other sheriffs are rejecting the state's ideas about protecting illegal aliens and not cooperating with federal authorities.

## **No Fathers Not Slavery** the Problem

gle-parent families. Fifty years later, more than 70 percent of black children were raised in single-parent families. Did slavery cause the increase in single-parent black families after 1960?

According to the 1938 Encyclopedia of the Social Sciences, that year 11 percent of black children were born to unwed mothers. Today about 75 percent of black children are born to unwed mothers. Is that a delayed response to slavery? The black family was stronger the first 100 years after slavery than during what will be the second 100 years according to Economics Profes-

sor Williams. At one time, almost all black families were poor, regardless of whether one or both parents were present, Today, around 30 percent of blacks are poor. However, two-parent black families are rarely poor. Only 8 percent of black married-couple families live in poverty. Among black families in which both the husband and wife work full time, the poverty rate is under 5 percent. Poverty in black families headed by single women is 37 percent. The welfare state, not slavery or racism has doomed black families.

Are blacks lazy? In every census from 1890 to 1954, blacks were either just as active as or more so than whites in the labor market. During that earlier period, black teen unemployment was equal to or less than white teen unemployment. As early as 1900, the duration of black unemployment was 15 percent shorter than that of whites; today it's about 30 percent longer. Labor laws and regulations promoted by liberals

and their unions that cut off the bottom rungs of the economic ladder and encourage racial discrimination are the problem.

Labor unions have a long history of discrimination against blacks. Frederick Douglass described this in his 1874 essay titled "The Folly, Tyranny, and Wickedness of Labor Unions," and Booker T. Washington did so in his 1913 essay titled "The Negro and the Labor Unions." However, today's black politicians and hucksters blindly give support to labor laws pushed by unions and white liberal organiza-

In the 1950s, our county leaders had the incredible vision and fortitude to conceive and construct a series of dams and hydroelectric plants for the betterment of Yuba County. This was an incredibly bold mission for such a small, poor county to take on to reduce flood risk and secure our water supply reliability for the future. I am proud to say that Yuba Water Agency has continued its tradition of taking and implementing bold actions for the benefit of the people of Yuba County.

June 4 marked Yuba Water Agency's 60th anniversary. I truly believe this anniversary represents an impressive six decades of actively fulfilling our missions of reducing flood risk, generating carbon-free energy, supporting recreation opportunities at New Bullards Bar Reservoir, providing reliable water supplies to local irrigation districts and groundwater management programs to ensure a reliable valley groundwater aquifer, which is the sole source of water for 80 percent of Yuba County residents.

We've worked hard with our local community, state and federal agencies, Congress and many others to positively impact Yuba County. Through our planning with the U.S. Army Corps of Engineers, and our support of the we are moving forward

provement Authority and the Marysville Levee District, the urban areas of our county are on the verge of being one of the best protected urban areas at risk of flooding in the region.

While we have accomplished a lot, there is much more to do. We are focused on ensuring that our current and future projects, programs and investments have a direct impact on those who live and work in Yuba County.

As a requirement of the Federal Energy Regulatory Commission, we must renew our license that permits us to use public water for energy generation, which is estimated to cost \$230 million over the term of the license. The license allows us to continue operating the project, generating and selling power, and it includes requirements designed to ensure safety, and to protect and enhance environmental resources and recreation.

While there have been incredible improvements in urban flood protection, a similar effort is needed for the rural levees in the years ahead.

To further reduce the risk of flooding, enhance dam safety and provide climate resiliency for Yuba and Sutter counties, Three Rivers Levee Im- with the permitting and

design of an estimated \$160 million secondary spillway at New Bullards Bar Dam (that's an early cost estimate). This new spillway will allow us to release more water from the reservoir, in advance large, of threatening storm events, freeing up space in the reservoir to hold back peak flows when the biggest part of the storm arrives. It will also enhance dam safety by providing a second, independent spillway that by itself can handle a major storm event like 1997. In the meantime, where

we can find a connection to our missions, we're investing in the community through forest resiliency efforts to improve water supply and quality, while reducing fire risk in the foothills. We are additionally partnering in residential water conservation programs for low income households, to help them improve water conservation, which will save money on water bills, and in grants for first responders to improve public safety, just to name a few.

We're also seriously exploring several new educational activities, including a possible water education center in Yuba County, and we will be in discussions with school officials and educators to figure out the best way to educate students and the public about the Yuba River, as well as universal, watershed-based information.

Yuba Water Agency has done remarkable things for Yuba County in the last 60 years, and there is so much more that we can do in the next 60. I'm proud of our accomplishments, but I'm more excited to make an even bigger impact for the people who live and work here.

#### **Over Five Million Guatemalans (Mostly** Illegal) Want to Migrate to the U.S.



In case you missed this eye-popping story about the survey made by the Guatemalan City newspaper, Prensa Libre, the following is an article, in part, by Daniel Horowitz, the Senior Editor of the Conservative Review on May 6, 2019...

How much is too much when it comes to illegal immigration, or even legal immigration? At what point do we finally return to the universal principle expressed by Calvin Coolidge in 1925 that "our Government owes its first duty to our own people"? Well, unless the DHS finally slams the door shut, it appears that Central America is a bottomless well waiting to be emptied out into our country, primarily through dangerous smuggling over our land border.

According to a recent survey of Guatemalans conducted by the Association for Research and Social Studies and Barometro de las Americas, 39.2 percent of Guatemalans would like to migrate, 85 percent of them to the United States. Which means that roughly 5.6 million Guatemalans (plus unknown number of kids) would like to come here, not including the close to one million who already came here in recent years. The survey was reported in a local Guatemala City paper, Prensa Libre, and was picked up by the Daily Caller.

According to the survey, taken of 1,596 Guatemalans and published last Thursday, 58 percent of respondents said they had relatives in the United States. As the Prensa Libre article notes, family reunification and "lack of employment and poverty" are why they desire to come here. It's self-evident that this has nothing to do with asylum and everything to do with economic reasons. Liberals and many faux conservative supporters of amnesty defend illegal immigration as a natural consequence of a "broken" legal immigration system, where it is impossible to come here legally. The problem with that assertion is that the period of illegal immigration has overlapped with the most protracted period of legal immigration expansion and has originated from the countries that have had a monopoly on our legal immigration. According to Pew, 50 percent of all immigrants since 1965 have come from Latin America, the primary source of illegal immigration. Specific to Central America, before the recent surge, "the number of immigrants from Central America) has grown 28-fold since 1970, from 118,000 to nearly 3.3 million in **2018** — six times faster than the overall immigrant population," according to the Center for Immigration Studies. In fact, 18 percent of El Salvador's population (over one million) is already here, if you add the immigrant population in America to those remaining

in their home country. Now, in addition to legal immigrant chain migration, we are incurring illegal immigrant chain migration from Central America, whereby illegal aliens who are already here are "sponsoring" Central American teens in their families to be smuggled here by the cartels and resettled as "unaccompanied" refugees to live with families who themselves are supposed to be deported.

The bottom line is that unless the administration begins shutting off all migration requests at the border, the record numbers we are seeing every month with take years to abate. If the same percentage of people who would like to come here from Guatemala hold that view in El Salvador and Honduras, that would be roughly 10.7 million people ready to march north under the right circumstances.

Has anyone given any consideration to the cost of such a migration, much less the cultural, social, and security problems inherent with it? At a \$140,000-\$150,000 price-tag per migrant, using the input and methodology of the Center for Immigration Studies Steven Camarota to calculate the cost of illegal aliens to the American taxpayer, that would work out to be \$1.5 trillion for the net fiscal cost of such a flow.

And those are just the top three countries of origin of those coming here illegally today. Migration from Nicaragua is already picking up. Is that the next shoe to drop? A number of people are coming from Cuba and Haiti in the organized caravans. Then there are numerous individuals from African countries and even the Middle East as well.

Now then, back at The Territorial...according Reuters last week...

Under duress because of Trump's threat to impose tariffs unless Mexico stemmed a surge in migrants that has overwhelmed U.S. detention facilities and immigration courts, Mexico signed a pact last week agreeing to control the flow of people from Central America, including deploying 6,000 members of a new national guard along its border with Guatemala.

Mexico's foreign minister. Marcelo Ebrard, said Mexico also agreed to a 45-day timeline to show increased enforcement efforts were effective in reducing the people flows. If that fails. Mexico has agreed to consider a longstanding U.S. demand that Central American asylum seekers crossing through Mexico apply for refuge there, not the United States, making Mexico a "safe third country," a demand that Mexico would consider.

The vast majority of undocumented migrants arriving in the United States are from Central America, but significant numbers have also been arriving in recent months from Cuba and Haiti, via Panama, and from African countries, often via Brazil.

# Sirens in the Yuba Foothills

On Wednesday, June 12, 2019 the Yuba Fire Safe Council held their monthly meeting at the Alcouffe Center.

One of the items on the agenda was from the Early Warning System Committee. Residents of the Foothills had asked that "early warning sirens" be considered for notifications of fires. Pete Hammontre a member of the committee gave a presentation on what their research had provided.

Using Dobbins and Oregon House as an example the research showed that the price for that area alone was \$11,000,000. The sirens were not practical for the foothill terrain and the decibels needed to project the sirens would permanently cause deafness to anyone near the siren.

The sirens are historically used in the mid west where the terrain is flatter and they are a warning for tornadoes. When the siren goes off the people know to go to their basements. In the case of fires people need to know there is a fire, where it is and which way to evacuate. Sirens in the mid west are raised to a height that eliminates the possibility of permanent hearing loss.

The committee is continuing to explore ways of better communication for early warnings. On Thursday June 20th at 10:30 a.m. there will be a meeting at the Brownsville Community Center on Ponderosa Way to discuss Fire Preparedness.

## **Lifting of Truck Weight Limit to Ease Marysville Truck Traffic**

Yuba County Board of Supervisors took the first step in lifting truck weight restrictions on Tuesday for three roads that serve to connect Hwy 70 north of Marysville to Hwy 20 near Hallwood. The move is expected to slightly ease the number of trucks traveling through downtown Marysville.

Yuba County Public Works Director Mike Lee said Woodruff Lane. Mathews Lane Ramirez Road have been under a county-imposed 22-ton weight restric-


tion for many years, because of the deteriorating conditions of those roads. The restriction was put in place to slow further deterioration along the routes.

Last year, Yuba County secured federal funds to repair the roads and make them, once again, suitable for trucks hauling heavy loads. The work was completed in November of last year.

"We are excited to recommend this to the Board of Supervisors, because of the benefits to trucking commerce and the City of Marysville," Lee

said. "By allowing loaded trucks to once again use these roads, the City of Marysville will see a reduction in truck traffic, and truckers will be able to shorten their hauls by about 14 miles."

Removal of weight limit is being done through a change in a county ordinance. A second reading of the ordinance will take place later in June and, once finalized, truck weight limit restrictions would be lifted effective at the end of July.



## **Illegal Cannabis Cultivation Arrest**

At approximately 7:00 a.m. on 6/12/19, the YCSO Marijuana Enforcement Team (METYU) and Yuba Sutter SWAT Team executed a search warrant in the 7700 block of Skyview Ct. in Oregon House. During the search, Deputies located 2,913 marijuana plants of various sizes ranging from one to three feet tall growing in a large detached shop on the property.

The owner of the property, identified as 54-year-old Li Jian Cao, and six other individuals allegedly hired by Cao to work at the grow, were contacted at the site. Cao was arrested for 182PC/Criminal Conspiracy, 11358 H&S/Illegal Cannabis Cultivation, and 11359 H&S/Illegal Possession of Marijuana for Sale.

Cao is a dual resident of Oregon House, Ca. and the state of New York. Cao was booked into the Yuba County Jail with a bail amount of \$50,000.
