## **Oroville Dam Update**



I've received many questions in the past couple of weeks regarding Oroville Dam and wanted to share with you the most recent information available to me and the public.

On Friday of last week, DWR announced that the Department is preparing for the potential use of Oroville's main spillway this week. DWR says that once the decision is made on whether to use the spillway or not, they will provide regular updates to the public and the media. I will be sure to share this information on Facebook and other channels.

On May 30th, a report from the Board of Consultants was submitted to the Federal Energy Regulatory Commission (FERC). In their summary, the board concluded that the recent use of the spillway "showed that the efforts of the past two years have been successful."

Also, I posed a number of questions to DWR last week.

Here are the responses from DWR:

The current outflow ability of Hyatt Powerplant is 13,000 CFS.
The current elevation of

the lake is 894.65 ft. • There is currently 82,000

acre-feet of flood space in the reservoir. • The current inflow into

the lake is 10,901 CFS.

• Inflows have been tracking at about 9,000 - 12,000 CFS.

• Estimated daily average inflows over the next 7-10 days are between 10,000-12,000 CFS.

• Operations will maintain the lake around the current elevation (894-895 feet) over the next week.

• Lake elevation may increase through June, but will not exceed 899 feet.

• Releases will be subject to inflows, water demands and Delta needs.

I understand the distrust of DWR and the concern re-

garding lake levels. Know that we are continuing to bring a skeptical and protective eye to all of our meetings.

I believe the water management system at Oroville can and should be changed. This is what Butte County is also requesting. I have and will continue to push for what is called "forecast based operations," meaning that the water should be managed to better account for changes in our watershed and what we are seeing in real time with snowpack and potential storms.

In the winter months, this would allow for releasing water earlier to provide a better buffer in the reservoir to protect from a warm storm and large inflows like we experienced in 1986 and 1997. I am also pushing for further investments in infrastructure to ensure the highest level of safety at the Dam.

As always, I will remain engaged on this important issue and keep you informed.

# Darkness at Oberlin

"Oh, how the mighty have fallen." Out of the Second Great Awakening when more than 600 colleges were founded in the Midwest, Oberlin College was established in 1833 by Presbyterian ministers John Jay Sipherd and Philo P. Stewart to promote Christian values.

In 1835, Oberlin became the first white collegiate institution to admit African American male students and two years later it welcomed all women as well, becoming the first coed college in the country.

Oberlin continued to be a premier institution for blacks for the next century. By 1900, one third of all black professionals in the U.S. had undergraduate degrees from Oberlin.

In 1858, more than 30 Oberlin students and townspeople invaded a city nearby and freed a male slave held in captivity to be returned to his owners in Kentucky.

Oberlin's commitment to the abolition of slavery made it a welcoming and safe environment for 19th Century black students. As part of the Underground Railroad, Oberlin's intricate network of back road routes and safe houses, the college and town provided refuge for fugitive slaves bound for Canada with Lake Erie being just 15 miles away.

To this end, the school appointed one of its faculty Charles Finney, America's greatest revivalist and also a fervent abolitionist, to be their second President. Finney routinely denounced slavery from the pulpit and advocated the end to servitude through all means possible.

However, intolerance, "politically correct" group think and racism have consumed and now shamed this once amazing institution. The college is full off anti-frackers, socialists, gender activists, and social justice warriors touting government hand-outs. Oberlin College's unofficial slogan is clear: "We put the liberal in liberal arts."

Closing thought: "Never forget the miracles of Mother Nature...help to preserve all of the wildlife for our future generations."





Can you protect your stocks from a falling market automatically?

In the world of investing, protecting profits and limiting losses is tantamount to success. The most common method of protecting your money from downside whether it be to keep profits or limit losses, may be to sell out all or some of your holdings and turn that into cash.

You could have a preset price on percentage in mind, much like going to a casino to play a slot machine and the spouse says you can't lose more than \$200. Although most people exercise good money management at the one armed bandit, far fewer people have this exit point strategy in mind when dealing with their retirement funds.

Is it wise to have an exit strategy?

One only needs to remember how it felt during the 2008/09 market freefall. Thoughts of losing it all put the squeeze on many investors grey matter and more than a few investors and advisors lost some sleep during those dreadful times.

That said, having a predetermined sell point might be a good idea in case of a catastrophic market collapse. No one can say it will or won't happen of course.

That order will sit for a predetermined amount of time, usually 60 days, and if the stock never hits \$90 the order expires at the end of the term. If the stock does hit 90 anytime during the timeframe the stop order then becomes a market order. This means when your order hits the trade pits you get the market price for it. This also means you could get less or more than your stop price. In fast moving markets, your stop price, becoming a market order, means you get what they give you when your order hits the front of the line.

Another type of stop order is to add the word "limit" to the above order and enter a "stop limit" order.

The "stop limit "order means you want out at a certain price and will take no less than that price.

Although this sounds like a better way to go, the old adage there are no free lunches comes into play. Suppose you own the same stock at \$100 a share and you enter the order under a "stop limit" (versus a stop order) at the same \$90 price as before. The stock hits 90 and your order triggers. In this case, your order instructs the market makers to get you \$90 but no less.

Should the market be moving fast and because your order again has to wait in line, if the stock keeps dropping, you may not get out. The market makers have their marching orders from


der triggered, but while waiting to get filled the stock kept dropping, if it now is below 90 and because you said you want 90 and no less, you MIGHT NOT get out at all, or only get partially filled.

Summarizing: a "stop" order will certainly get you out but the price you get may be below your stop price. A "stop limit" will get your price but you might not get out at all or only be partially filled.

Keep in mind during the 1000 point flash crash (August 24th, 2015) the drop happened so fast, many stop orders were filled significantly below their stop price. Keep in mind stop-limit and stop orders may not prevent losses and there is no guarantee of being filled under ideal conditions but these types of orders do illustrate some strategies that many investors might not be aware of. Investors could just keep in the back of their mind a predetermined selling point. Something like if they lose a certain amount or if a stock hits a certain price, you call your broker and tell them to sell. The problem here is you might forget, lose your nerve, change your mind or worse yet, be unable to get through to your broker, which can happen during severe market upheavals.

However there is a way you can enter a sell order automatically on certain types of stocks and funds with some exceptions of course.

A "stop" order can be entered ahead of time by phone, computer or otherwise. These work by keeping your order on file and when the price is hit, the sell order is transmitted to the appropriate people in the market place who then attempt to sell your stock.

This order can be placed usually anytime and at any price you prefer. They work like this:

Suppose you have a stock that is \$100 a share today and you decide you want out at \$90.00 or lower. You enter your order as a "stop" order (in lieu of a market or limit order) at \$90.



#### Weather brings fewer but larger avocados

An intense heat wave 11 months ago has reduced the California avocado crop. Farmers who typically would harvest fruit into early July report they've already finished their harvest. Southern California heat last July damaged the developing fruit. But ample winter rains allowed the remaining avocados to grow to larger sizes. Forecasters estimate the avocado crop at 175 million pounds, about half the volume of a year ago.

#### Ranchers welcome benefits of grass growth

Plentiful grasses stimulated by abundant rainfall have improved the outlook for California cattle ranchers. The rangeland grasses will allow cattle to grow to higher weights before being marketed, helping ranchers offset part of the impact of weaker prices. Trade uncertainties have also put a damper on the market as beef production heads toward a potential record this year, but ranchers say the improved range conditions will help them save costs.

#### Tomato harvest may run late

Rainy, cool weather slowed California tomato planting, but crop estimators say they still expect the state's farmers to harvest more than 12 million tons of processing tomatoes this summer. An updated estimate says the later planting might delay harvest by about a week, but that the crop could catch up during warm summer days. Processing tomatoes are used for salsa, ketchup and other products. Fresno County leads the state in processing-tomato production.

#### Invasive species damage environment, economy

From the burrowing nutria threatening waterways to the small insect carrying disease to citrus trees, invasive species cause ecological damage and economic losses. As agencies commemorate California Invasive Species Action Week, they urge Californians to take care not to transport new species into the state. The University of California estimates a new invertebrate species establishes itself in California every six weeks, on average.

#### YES Students go to Mars!

Even though it will be years before humans step foot on Mars, YES students have the opportunity to send their names to Mars on a chip aboard the new Mars rover! In July 2020, NASA launches a new Mars Exploration Program. The exploration program will launch a new rover and will land on Jezero Crater on Mars. The Mars 2020 mission addresses high-priority science goals for Mars exploration, including key questions about the potential for life on Mars. The Mars 2020 rover introduces a drill that can collect core samples of the most promising rocks and soils and set them aside in a "cache" on the surface of Mars. The mission also provides opportunities to gather knowledge and demonstrate technologies that address the

challenges of future human expeditions to Mars. YES Charter students received the opportunity to have their names sent on the rover that will be going to Mars! The Microdevices Laboratory at NASA's Jet Propulsion Laboratory (JPL) in Pasadena, California, will use an electron beam to stencil the submitted names onto a silicon chip with lines of text smaller than one-thousandth the width of a human hair (75 nanometers). The chip will ride on the rover under a glass cover. In exchange, the students received honorary tickets to Mars from NASA. YES Charter Academy plans on following the progress of the rover and aligning engineering science curriculum with NASA's Mars Robotics program to create curiosity based learning.



# **Darkness at Oberlin**

ing wine at Gibson's Bakery and Market in downtown Oberlin, OH. Shoplifting by college students is a big problem in the town. You know, the poor take from the rich.

Gibson's had been in existence since 1885, was frequented by students, and also provided baked goods to the college dining halls. A scuffle ensued that day and was joined by two black female Oberlin College students accompanying and assisting the male shoplifter. three eventually All would plead guilty to shoplifting and aggravated trespassing, and would avow that Gibson's was not engaged in racial profiling.

However, prior to the guilty pleas, students at the college declared that Gibson's was guilty of racial profiling, and large protests were organized outside the bakery. Flyers were circulated saying the Gibsons were "racist" and had "a long account of racial profiling and discrimination."

Oberlin's Dean of Students Meredith Raimondo allegedly participated in handing out the flyers in front of the bakery. Oberlin College Student Senate passed a resolution claiming Gibson's "has a long history of racial profiling and discriminatory treatment of students and residents alike." The college administration allegedly helped circulate the student senate resolution.

Students launched a boycott of the bakery, initially joined in by the college. The college eventually resumed business with the bakery, but then terminated that business once the bakery owners filed a lawsuit.

Gibson's owners sued the college and Raimondo for libel, tortious interference with business relationships and contracts, intentional infliction of emotional distress, and trespass. Gibson's alleged long-term damage to its business and reputation for the allegedly defamatory accusations and other torts. The plaintiffs in closing argument asked the jury to award \$12.8 million in compensatory damages.

Last week, the jury awarded \$11 million to

the Gibson family. Allyn W. Gibson was awarded \$3 million, David Gibson \$5.8 million, Gibson Bros. \$2,274,500. Next, there will be a separate punitive damages which could be a double award (meaning tripling the \$11 million to \$33 million).

Lee Plakas, who handled much of the month-long trial and who gave the closing argument, said this case "is a national tipping point."

"What the jury saw is that teaching students and having them learn how to be upstanding members of the community is what colleges are supposed to do, not appease some students who they are afraid of," Plakas said. "People around the country should learn from this that you can use the legal system to right the wrongs, even if the one doing the wrong is some huge institution who thinks they can do anything they want."

Oberlin started-out shining brightly as a city on a hill, but like most all colleges today has descended to a place of philosophical and moral darkness.

### A Tangled Web by "Her Exaltedness"

candidate managed to sic the weight of the FBI and U.S. intelligence community on a rival nominee during an election, and by using a foreign-fed, uncorroborated political opposition research document.

### **PG&E Expanding Weather Station** and High Definition Camera Network to Monitor and Reduce Wildfire Risk

San Francisco, Ca.

More than 200 new weather stations and 25 new HD cameras installed to date in 2019

As part of its Community Wildfire Safety Program (CWSP), Pacific Gas and Electric Company (PG&E) announced that it is expanding its network of weather stations and high-definition cameras to improve the company's ability to predict and respond to extreme wildfire danger. By the end of 2019, PG&E plans to have at least 600 weather stations and 100 high-definition cameras in high fire-threat areas. These new installations are one of the many additional precautionary measures the company is implementing following the 2017 and 2018 wildfires to further reduce wildfire risks. "The enhanced meteorological data we are receiving from these weather stations is bolstering our ability to forecast high fire-risk weather conditions with further granularity so that we can take swift action to protect public safety," said PG&E CWSP Vice President Sumeet Singh. "Personnel at PG&E's 24/7 Wildfire Safety Operations Center will use these weather stations and cameras to better monitor wildfire risks and coordinate prevention and response efforts, and the data is shared publicly and with agencies such as CAL FIRE."

in 2019, prioritized in areas at elevated and extreme risk for wildfires, based on the California Public Utilities Commission (CPUC) High Fire-

Threat District Map. To help protect customers and communities during extreme weather events, electric power may be shut off for public safety in an effort to prevent a wildfire. This is called a Public Safety Power Shutoff (PSPS). PG&E's meteorologists will feed data from these new stations to the company's Wildfire Safety Operations Center team, where it can be utilized to help inform actions such as PSPS. Before any PSPS, PG&E will carefully review a combination of criteria including predictions of strong winds and very low humidity levels; additional weather stations will assist PG&E's Meteorology team to better predict conditions specific to local geographic areas. Data collected by the weather stations is available to state and local agencies and the public through online sources such as National Weather the Service and MesoWest. "These new weather stations help us monitor conditions around the clock, improving our ability to understand when and where it is necessary to take this precautionary action in the interest of public safety," said Aaron Johnson, PG&E vice president of Electric **Operations.**

#### HD cameras being installed throughout high fire-threat areas

PG&E has installed 25 of the 100 high-definition cameras planned for this year. The company has now installed 34 HD cameras since 2018, with a goal of installing 600 new cameras by 2022 as part of the ALERTWildfire Camera Network. The ALERTWildfire Camera Network is a situational awareness tool built by the University of California, San Diego, the University of Nevada, Reno and the University of Oregon. The high-definition, pan-tilt-zoom cameras allow firefighters, first responders and companies like PG&E to confirm and monitor potential wildfires. The system is used by fire managers and has been instrumental in tracking more than 500 fires since it was first developed in 2013. Images from the ALERTWildfire system are viewable online at www.alertwildfire.org. Counties that have received cameras so far include Amador, El Dorado, Humboldt, Lake, Marin, Mariposa, Monterey, Napa, San Benito, Shasta, Sonoma, Tehama, Trinity, Yolo and Yuba.

# Wheatland Event to **Help Paradise Recover**


