Illegal **Cannabis Cultivation** Investigated Oregon House, Ca.

At approximately 8:00 a.m. on 6/25/19, the YCSO Marijuana Enforcement Team (METYU) with the assistance of Net-5 and Yuba County Code Enforcement officers executed a search warrant 8200 block of Marysville Rd in Oregon House. During the search, Deputies located approximately 2,400 marijuana plants among four residences converted to grow houses on two parcels that are believed to be connected.

During the execution of the search warrant, personnel on scene required the use of masks due to black mold inside the homes used for the illegal grows. Code Enforce-



ment condemned the homes as unsafe to occupy due to the mold infestation.

Two illegal rifles were located and seized. One suspect, identified as 39-year-old You You Kuo of Sacramento, was arrested at the location and cited for 11358 H&S/ IIlegal Cannabis Cultivation and 11359 H&S/Illegal Possession of Marijuana for Sale.

No King but Jesus

In 1836, Noah Webster, often considered "The Father of American Education," believed that the purpose of schools was to advance the Christian faith. "In my view, the Christian religion is the most important and one of the first things in which all children, under a free government ought to be instructed...No truth is more evident to my mind than that the Christian religion must be the basis of any government intended to secure the rights and privileges of a free people."

Tragically, the Biblical values upon which the nation was founded and thrived have come under continual assault and it continues today. John Dewey, a philosopher and psychologist born October 20, 1859, is known as "The Architect of Modern Education." He said, "There is no God, and there is no soul. Hence, there are no needs for the props of traditional religion."

Is it any wonder that America, the richest country in the world now falls behind even some Third World nations in student performance today? American schools now are considered a Jesus-free zone while poor village children in Communist Vietnam can wear backpacks declaring 'Jesus Loves Me' on them?

Abortions and deviant sexual lifestyles can be obtained at school here and a student has a shot at being molested or engaging in a sexual encounter with a teacher. Meanwhile, the union controlled schools protect the perverts and even knowing hire them.

It is no surprise that our founding history has been dumbed-down, revised, and attacked in schools today. Much has even been hidden or discarded. However, any serious look at the original writings, personal correspondence, biographies and public statements of the founders will reveal lives directed by a Christian worldview.



Orval Ray Fowler, Author of the WallyGumper™ **Book Series**

Ray was 92 years, and is survived by his two daughters and son, with a family that span from the mainland, to Hawaii, to Japan; comprised of grandchilnumerous dren, great grandchildren and great-greatgrandchildren, plus generations of nephews and nieces.

Rays personal legacy includes; being raised in a unique Educational environment in that both his parents were teachers, on a 166 acre farm In the mountains of Monongahela River Valley of Pennsylvania. His upbringing was during the Great Depression; where the values

of self sufficiency and independence were instilled. Upon leaving high school, where he was lettered in football, he served in the US Marine Corps during World War II. When discharged from the Marine Corps, he met the love of his life, Grace Irene, in San Francisco. They shared 54 years of marriage together. Additionally, he played semi pro baseball in San Francisco, and was a Teamster for four decades in the Dairy Industry, as well as being a Mason. Upon retirement, he began his second career for environmental services with Recology, at the Transfer

California. Since his wife passed in 2002, Ray turned towards writing the folklore of his country upbringing, blending it with her Native American heritage. During these years, Ray became known as a storyteller and musician throughout the foothills of the Sierra Nevada Mountains. The result was 17 years of writing that brought many artists together from the San Francisco Bay Area & the Sierra Nevada Mountain community; in book signings, soiree' gatherings of blue grass music, and round drum singing. 

Drive Sober or Get Pulled Over This 4th of July Holiday

Yuba City, Ca.

The 4th of July holiday is a time to enjoy fireworks and show country pride but is also traditionally one of the more dangerous times on the road.

To keep families safe this Independence Day, the Yuba City Police Department will have increased enforcement focused on impaired driving during the 4th of July holiday.

According to preliminary data from the California Highway Patrol, seven people were killed and 73 injured in alcohol-related crashes statewide on fourth of July last year. Every deadly crash involved a driver who had been drinking.

"Drinking and driving is a bad combination," Yuba City Police Department Sgt. Kim Slade said. "The consequences are abundantly clear, yet people still make the poor decision to drive after drinking. Please be smart and make this 4th of July holiday a fun and memorable one."

If you are headed to 4th of July parties, designate a sober driver before heading out for the evening. If you are hosting a party, offer nonalcoholic drinks for designated sober drivers and monitor who is drinking. See people leaving who have been drinking? Check how they are getting home. Offer to let them stay the night if a sober driver is not available to take them home.

"Driving with just a buzz doesn't cut it," Yuba City Police Department Sgt. Kim Slade said. "With the rise

in ride-share options there really is no excuse for driving impaired."

The average cost of a DUI arrest is approximately \$13,500, accounting for vehicle impound fees, fines, attorney fees, auto insurance hikes and other penalties. The Yuba City Police Department also reminds residents that prescription drugs, over-the-counter medications and marijuana can all be impairing and land you a DUI, especially in combination with alcohol and/or other drugs.

Funding for DUI enforcement was provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.



Open Frida Kahla's Garden June 2019

Frida Kahlo (1907-1954) is considered one of the most significant artists of the twentieth century. Her body of work, consisting of some 250 paintings and drawings, is at once intensely personal and universal in scope, and relies heavily on the natural world. The exhibition Frida Kahlo's Garden transports visitors to Kahlo's garden to experience her world as she did. Frida Kahlo's Garden opened June 15. 2019 at the Sutter County Museum.

The garden at Casa Azul (or Blue House), Kahlo's lifelong home in Coyoacán, Mexico City, was a creative refuge and a source of inspiration for the artist and her husband, Diego Rivera (1886-1957). The garden, which was filled with native plants, housed Kahlo and Rivera's collection of pre-Hispanic artifacts and folk art displayed on a four-tiered pyramid inspired by the Mesoamerican city of Teotihuacan. This exhibition offers insights into the ways in which the garden at Casa Azul, the diversity of plant life in Mexico, and the rich cultural history of the country nourished the creativity of the world's great artists.

Often overshadowed by her husband's career and the traumatic events in her life, this exhibition approaches Kahlo from a different angle, to broaden the discussion of the artist by focusing on the influence of her surrounding environment, both natural and nationalistic. This approach examines her garden, her home, and the revolutionary influences that impacted her life.

Kahlo's works are filled with colorful and compelling depictions of flowers, foliage, and fruits, many native to Mexico. Her choice of botanical imagery reflects the embrace of archetypal Mexican indigenous and natural elements that defined art in the decades following the Mexican Revolution (1910-20). Through her profoundly personal paintings, which convey cultural, spiritual, and intimate messages, her reverence for nature, and her nationalistic fashion sense. Kahlo has become an icon within the artistic world.

Visitors to this exhibition will explore iconic photographs of the artist and her home and garden, in addition to reproductions of several of her paintings. Also included are information about native Mexican plants that were grown in her garden, a dress from the Mexican state of Oaxaca where Kahlo sourced much of her attire, and examples of folk art collected by Kahlo and Rivera. Additionally, visitors will learn about Mexican culture, including traditional festivities, food and drink, and agricultural practices.

This exhibition is made possible by NEH on the Road, a special initiative of the National Endowment for the Humanities. Frida Kahlo's Garden is adapted from exhibition, FRIDA KAHLO: ART, GARDEN, LIFE, organized by guest at The New York Botanical Garden. It was made possible with major funding from the Institute of Museum and Library Services, Karen Katen Foundation, The LuEsther T. Mertz Charitable Trust, MetLife Foundation, National Endowment for the Arts, National Endowment for the Humanities. New York State Council on the Arts with the support of Governor Andrew M. Elizabeth Warren and AOC insert them self's into Sears Acquisitions

Upstart Representative Alexandria Ocasio-Cortez (AOC) and Presidential candidate Senator Elizabeth Warren have sent a letter to Sears' former CEO Eddie Lampert, criticizing him for his efforts to avoid repaying Sears for \$43 million in severance to the retailer's workers. A war of words and accusations between Lampert and the now defunct Sears Holdings has Lampert claiming the pay back to employees is no longer valid. The argument stems from Lampert's acquisition of the beleaguered retailers assets.

Lampert bought Sears assets through an affiliate of his hedge fund ESL. Lampert as its CEO headed up Sears as it spiraled into chapter 11. The original deal, which saved the company from total liquidation, also stated that Lampert would reimburse Sears severance costs for workers who lost their employment in the bankruptcy. Further

muddying the waters is the fact Steven Mnuchin, Trumps secretary treasury, was on the board of directors at Sears and now both him and Lampert are being sued by Sears. Adding more conspiracy to the story is the additional fact that Sears bankrupt pension were taken over by the Pension Benefit Guaranty Corporation (PBGC), an organization that helps administer and settle pension's claims from involvement members. It just also happens to be overseen by Mnuchin, as well as the secretaries of commerce and labor. You can't make this stuff up.

Now that the smoke is clearing, or just starting to clear as the case may be, Lampert and his firm are claiming Sear's part of the deal is suspect and he may not pay the severance pay.

Yes it sounds complicated and it likely is, but my point is not the bankruptcy itself but the camel nose insertions by Warren and AOC, who for all intents and purposes, probably know less about Sears and its acquisition then the lowliest assistant accountant in any one of the number of firms that are handling the Sears

Not to say she's filed bankruptcy, she hasn't, but her net worth of only a few thousand (Weeklystandard.com) mostly stemming from a bartending job gives little reason to think she knows much about a corporate bankruptcy such as a size that is the Sears liquidation. More likely she is exercising her well known talent of riding the political bandwagon and shooting off her now infamous mouth.

Links and Lores A Man of Many Talents by Carol Withington



Drummond Dennis Carter, a prominent Nevada City resident, can be best described as a man of many talents. Born on January 1, 1814 in Drummontown, Virginia of Indian and African parentage, Carter moved to Philadelphia in 1825 where he would eventually receive a musical education. While there, Carter excelled on the Bass Viol along with a variety of other instruments.

In 1837, Carter joined the prestigious Frank Johnson Band, which was quite an honor for this young musician. Johnson was the first African American composer to have his work published in the United States in 1818. would become Carter's

mentor. According to the "Atlantic Black Star" newspaper, in 1838 Johnson, along with his group of musicians, traveled throughout Europe. It was a trip of a lifetime for Carter because of what occurred. Relating a special event in Thompson and West's "History of Nevada County", Carter revealed that "while in

of california

England, they, by request, played before Queen Victoria".

Following the European tour, Carter returned to Philadelphia where he continued with his music career. But by 1848, according to Delilah Beasley in "The Negro Trail Blazers of California", Carter actually worked time. Finding no success in this endeavor, Carter traveled back to Philadelphia where he became a music instructor. However, the lure of California remained. In 1851, Carter was back to stay in the Golden State where he settled in Nevada

Once again he taught music, forming classes in a circuit of cities, beginning with Grass Valley and ending in San Francisco. In addition, Carter became the leader of the Military Band of Nevada City, performing for many area events. Among his many private students was Abraham Freeman Holland, a Marysville pioneer, who, unlike Carter, found great success in mining as a member of the Sweet Vengeance Mine in Browns Valley.

In 1855, Carter attended the first Califor-

nia Colored Convention in Sacramento. As a delegate for Nevada County, he met Edward Parker Duplex of Marysville. Both, as activists, would become longtime friends. Carter's interests also included Free Masonry where he served as Most Worshipful Grand Master of the California Prince as a miner for a short Hall Lodge in 1863 and

from 1868-69. When African American men were granted voting rights in 1870, it was Carter that made a major effort to see that all who were eligible were registered. Three years later, Carter even ran for Town Marshall. And with his music, popularity and leadership qualities, it is no wonder that he was included in the "History of Nevada County".

Carter and his wife Jennie enjoyed the many events in Nevada and Yuba Counties that included parades, speeches and, of course, music. In the August edition, Part I of "Let's Celebrate" will include the 1867 and 1870 noteworthy happenings that occurred in Marysville, Grass Valley and Nevada City--often seen through the eyes of Jennie Carter.



Border Patrol Agents Revive Drowning Teen

(Commentator's Note: The Open Borders crowd and the opposition to the humanitarian crisis at the southwestern border continue to spew negative news about the handling of illegals crossing the border. The following news report gives a totally different mind-set of the border agents as they carry out their daily duties).

EAGLE PASS, Texas -U.S. Border Patrol agents assigned to the Eagle Pass South Station marine unit saved the life of an undocumented immigrant teen after he and his family, all from Honduras, attempted to cross the Rio Grande River Tuesday afternoon, June 25th.

"Words cannot express my gratitude nor convey the sense of pride I have for these agents," said

Del Rio Sector Chief Patrol Agent Raul L. Ortiz. "Without a doubt, their quick life-saving actions brought this young man back from the brink of death."

On June 25, Border Patrol agents performing maritime operations on the Rio Grande River observed two individuals struggling to stay afloat near the Eagle Pass Port of Entry. As agents moved to assist, they saw a third person a short distance downstream, submerged beneath the surface and unmoving. Agents moved closer and pulled the lifeless teen aboard their vessel. The 13-year-old male was unconscious and not breathing, and had been underwater for more than a full minute. The vessel commander quickly

by the vessel's crewman. Through the agents' efforts, the teen eventually coughed up water, began breathing on his own and regained consciousness. The other two people, later determined to be the rescued teen's parents, were recovered from the river and all were brought safe-

ly to the U.S. shore Border Patrol EMT agents were on scene and evaluated the family of three until EMS personnel arrived. They transported the teenage male, accompanied by his mother, to a local hospital for advanced care. After being medically cleared, the family was taken to the Eagle Pass South Station where they were processed per CBP guidelines.

 According to scientists who actually know something about the subject, tell us that sealevel trends "vary considerably because they depend not only on the average global trend, but also on tectonic movements of adjacent land. In many places vertical land motion, either up or down, exceeds the very slow global sea-level trend. Consequently, at some locations sea level is rising much faster than the global rate, and at other locations sea level is falling. One example is found in Stockholm, Sweden. There is no rise. In fact the sea-level is falling due to regional vertical land motion. Water intrusion problems around the Chesapeake Bay in Virginia and Maryland are also not due to sea-level rise, but instead to land subsidence (the sinking of the land surface) from human activity such as groundwater depletion. The author (renowned Swedish sea level expert Prof. Axel Mörmer) published in the International Journal of Earth & Environmental Sciences, dumps lots of cold water on the premise that today's sea level rise is caused by man and is unusual. Mörmer's paper looks back at the last 500 years of sea level rise and shows that natural variables are the major drivers, and not man-made CO2-driven global warming. (Oh, by the way, this was published in 2017).

 According to recent writers "the best available data" shows "evidence is lacking for any recent changes in global sea level that lie outside natural variation." The investigators point out that if the negative effects of the claimed rise in sea level, such as a loss of surface area, were to be visible anywhere, it would most likely be in the small islands and coral atolls in the Pacific Ocean. However, research indicates many of these islands and atolls are actually increasing in size. Simply, they are "not being inundated by rising seas due to anthropogenic climate change." As the authors carefully state in their treatise. "Fears of an accelerated rise in sea levels caused by anthropogenic climate change are misplaced and overblown. Further, this fear mongering should not be used by policymakers in coastal states and cities to advocate for policies that would seek to limit or eliminate carbon dioxide emissions."


our American values and any concept of personal freedom. And the idea that it is "necessary" to bring down the costs of healthcare and premiums is just laughable at this point.

This Month In Your Garden by Cecilia M. Rice





School is out for the summer and summer is for enjoying your yard and all the effort put into The most important thing to be done, of course, is keeping things adequately irrigated during the hot summer months we have. Irrigating is best done early in the day for maximum growth and health of your plants. Drip systems offer the careful use of water by delivering the water just to the targeted plant and not all the surrounding area, and is therefore a system that keeps weeds down as well. The problem we find with them is that they must be carefully monitored to be sure they are working properly and are not clogged. The use of mulch around and between plants help to keep the areas moist between watering. A really efficient system takes a bit of planning and alter-

ing as plants grow larger

and require more water.

you accurately decide how long they should run to do a thorough job of watering.

We sometimes have calls about the advisability of planting a tree in the middle of the July heat. It can be done if you are going to be there to be sure that the tree will be watered adequately. It would need a deep watering about three times a week through the heat of the summer. Deep watering requires a basin around the base of the tree. It should be just deep enough that a very light stream of water can be left on for several hours without overflowing, insuring that the water is soaking in around and into the tree's roots. Another easy way is to accomplish this by using a piece of 2" plastic pipe that is long enough to reach the bottom of the planting hole and extend several inches above ground level. About three sets of four or five 1/2" holes need to be drilled in a vertical line in the lower end of the pipe to allow the water to drain. Put that pipe in vertically to the bottom of the hole as you put the planting mix in around the tree. Hang the hose into the pipe and turn the water on slowly, leaving it for

several hours to deep

water the tree. One add-

ing how much water the ed precaution to insure emitters produce will let a good result is to add a capful of 'Superthrive' to the irrigation water the first time or two. Put some rocks into the bottom several inches of the pipe to help to keep mud from clogging the pipe.

For those folks in the foothills dealing with the rapid growth of wild blackberries, poison oak, poison ivy, and other bushy and woody unwanted growth, this is good time to spray them with a brush killer. must be done while they are growing vigorously for the best result. Using a product labeled as "brush killer" will do a better job than a general herbicide like Remuda or Roundup. These pesky plants it might require more than one spraying.

Do you like Monarch butterflies? Most of us seem to, and there is a plant available that will attract them. Asclepias curassavia, a variety of milkweed. It is quite an attractive annual plant with vivid red or bright yellow clusters of small flowers. The Monarchs lay their eggs on the stems which then hatch into caterpillars. They then feed on the foliage of the plant for nourishment. Nature has more interesting, clever and amazing ways of doing things than any of us will ever know, but it is fun to

watch when you see it.

Mower blades should be set at 2 " of height during the hottest months. It may not give as smooth a finish as a lower setting, but it will take less water to maintain a nice green lawn. The higher setting helps the longer grass to shade the ground beneath which helps to retain moisture, thus keeping the grass green with fewer waterings.

Fertilize your summer vegetables and annuals to keep them flowering and/or fruiting. Use B.T. on the big green worms that defoliate tomato Don't neglect plants. those pretty hanging baskets. They need thorough watering to keep them pretty and that tends to wash nutrient right out of the bottom of that basket. It is probably easiest to use a 3 or 4 month slow release fertilizer on them. Annuals that you may have planted for all the color they provide will bloom longer if you have the time to dead head them frequently, and give them a bit of fertilizer. Enjoy the pleasures of

summer.

Hall, T.E. Mathews High School, Feather River Academy and Albert Powell High School and provide unique, weekly arts experiences for the students. Arts instruction has included African drum and dance, ceramics, guitar, poetry and visual arts. YSA is one of 51

grantees chosen for the JUMP StArts program. The award was featured as part of a larger announcement from the California Arts Council, with grant funds totaling a projected \$24,508,541 for 2018-19, the highest investment in statewide arts programming since the 2000-01 fiscal year.



Hearing focuses on soil health

Programs to benefit soil health should be "locally focused and producer-led," according to a California Farm Bureau Federation officer who testified before Congress Tuesday. CFBF First Vice President Shannon Douglass told a House subcommittee about soilhealth practices she uses on her Glenn County farm. She said programs to encourage similar practices should be flexible, incentive-based and backed by up-to-date research.

Nutria eradication efforts may get boost

Additional resources may be on the way, to help control and eradicate an invasive rodent. More than 500 nutria have been trapped in Central California. The creatures threaten crops, levees and other water systems. The new state budget passed by the Legislature includes nearly \$2 million to boost nutria eradication work, and members of Congress have introduced a bill to revive a federal eradication program.

Cherry losses reach disaster status

Losses to cherry crops caused by springtime rains have led at least three California counties to file or consider crop-disaster declarations. San Joaquin County says more than half its cherries were lost to the storms, and has filed a disaster request. Madera and Stanislaus counties will likely do so, too. Ultimately, a disaster decree from the U.S. Agriculture Department could qualify affected farmers for low-interest loans and other aid.

Walnut promotions emphasize heart health

Encouraged by results of a retail marketing campaign focused on heart health, the California Walnut Board says it plans to expand the program nationally. Advertisements and in-store displays promoted walnuts as a heart-healthy food during American Heart Month in February. The Walnut Board says improved sales in test markets this year will lead to nationwide expansion of the program next year.

Public Safety Power Shutoff

or PSPS is a precautionary safety measure that may proactively turn off power lines when extreme fire danger conditions are forecast. We will do this to reduce wildfire risks and keep our customers safe.

To receive important outage alerts, update your contact information at pge.com/mywildfirealerts.





No single factor will initiate a Public Safety Power Shutoff as each situation is unique. The factors we generally consider include:

- A Red Flag Warning declared by the National Weather Service
- Forecasts of strong winds and wind gusts
- Low humidity levels
- Critically dry vegetation that could fuel a wildfire
- And on-the-ground, real-time observations from PG&E field crews

In the interest of public safety, we continue to update and refine our criteria and protocols on an ongoing basis.

How will I know if a PSPS has been called in my neighborhood?

Because extreme weather threats can change quickly, our goal is to provide notice through phone calls, emails and text messages to customers 48 hours in advance, again at 24 hours and again just prior to turning off the power for safety. Updates will also be shared through social media, local news, radio and pge.com until the time power is restored. How can I prepare for a PSPS?

We advise you to think in advance about your family's needs and how you might be impacted in the event of a power shutoff — or for any emergency.

- Do you have a personal safety plan for all members of your family, including pets?
- If you own a generator, is it ready to operate safely?
- Do you know how to open your garage door manually?
- Do you have cash and a full tank of gas, in the event ATMs and gas stations are unavailable?
- Are your mobile phones fully charged?
