## Sheriff's Town Hall

Brownsville, Ca. – Yuba County's new Sheriff, Wendell Anderson, began a listening tour throughout Yuba County; giving the public an opportunity to ask questions and inform him of their concerns.

A Town Hall meeting was held on May 29th at the Ponderosa Community Center in Brownsville with 59 people in attendance. The public conversation was mostly centered around Cannabis issues and Cartels in particular. Additional inquires included vacant properties, homeless

issues and drugs that are dividing the community.

Sheriff Anderson said that the staffing levels of the Sheriff's Department are at the highest levels in a decade. He has four unfilled positions at this time that will probably be filled soon. When these positions are filled there will be six deputies assigned to the foothills of Yuba County.

Deputies Baumgardner and Bronson are hill deputies, CHP Chad is a foothill resident, Sgt. Spear works with Net Five and Nick Morawcznski is the new

## Arrests Made in Fatal Hwy 70 Shooting

Yuba County Sheriff's Detectives have made three arrests in the Hwy 70 Shooting in Plumas Lake, which occurred on 5/22/19 at approximately 6:00 p.m., that left one Sacramento man dead and another injured. Over the course of the last week, investigators were able to track the suspect vehicle in over two dozen business security videos leading approximately 30 miles through the three counties of Yuba, Sutter and Butte which were along the suspects travel route prior

to the shooting. With the multi-jurisdictional business community assistance, detectives were able to generate suspect leads that ultimately resulted in the identification and successful arrest of the three currently in custody for the homicide.

At approximately 8:30 a.m. 5/30/19, Yuba County Sheriff's Office with the assistance of the Net-5 Task Force served a search warrant at a residence on Pinewood Way in Linda, where the first two suspects

were taken into custody. Arrested in Linda for 187 PC/Murder were 20-year-old Avery Sanchez of Sacramento and 21-year-old Vivion Wallace of Yuba City. Sanchez and Wallace, both males on parole, were identified as the two shooters in the suspect vehicle, which was determined to be a gold 2003 Nissan Altima.

At approximately 6:00 p.m. 5/30/19 in the 7200 block of Amsterdam Avenue in Citrus Heights; Yuba County Sheriff Detectives with assistance from the Citrus Heights Police Department Special Investigations Unit, located and arrested the third suspect identified as the driver during the shooting; 19-year-old Juan Antonio Barajas of Citrus Heights, along with the car used in the crime. Juan is charged with 32PC/Accessory.

All three suspects have been booked into the Yuba County Jail. The motive for the shooting remains unknown. None of the suspects were known to the victims.

## More Feces More Taxes

Arising in the morning in Marysville means a routine. Check for trash out front from diners disposing of their Taco Bell wrappers or from adult beverage containers discarded by transients. Look for unconscious vagrants. Dead or alive, call 911, then hose off the vomit and body fluids. Oh, and watch for deposits of human feces. Let's see, which tote, green, blue or gray?

Then it's off to see what tax or assessment is being pitched to us now. It appears that there is no turning back from full-on socialism. Longtime friends **Ted Johnson**, who resides in Yuba City and **Ken Malott**, who lives in Grass Valley decided to fish the opening weekend at Eagle Lake. In fact, they decided to stay at the lake five days. To their surprise the opener was not crowded as expected. The famous eagle lake trout was caught and on some days limits were taken. The fish averaged a couple pounds with two caught Memorial Day which ran close to three pounds. Trolling did the trick, according to Ted, with fish being taken in shallow water. Ken's Uncle **Carl Malotte** joined them on Sunday. The trip was completed with a wonderful meal of trout tacos and all the trimmings.

The Department of Fish and Wildlife announced the following waters were planted with catchable trout: EL DORADO COUNTY: Silver fork of the American River, Ice House Reservoir, Sawmill Pond, Stumpy Meadows Reservoir and Walton Pond. LAKE COUNTY: Pillsbury Reservoir. SHASTA COUNTY: Kilarc Reservoir. SIERRA COUNTY: Lower Sardine Lake. TEHAMA COUNTY: South Fork of Battle Creek, Deer Creek and Gurnsey Creek.

The kokanee salmon are being caught at **Bullard's Bar Reservoir** on a regular basis at this time with limits common. Over at **Collins Lake** above Browns Valley the trout were big last week and most of the large

rainbows were caught by boaters. We are told the trout are moving deep and can be found in the deepest part of the reservoir. The bass population at **Lake Oroville** is still on a huge bite with the fish being found at around 6 to 20 feet. On the other hand the landlocked salmon are also available in this lake. **Lake Davis** is fully accessible by boat at this time. The trout population is cooperating with anglers with hot

spots being at Mallard and Eagle Point. Trolling is producing some fish in excess of 20 inches. The gates at **Jackson Meadows Lake** should be open by the time this paper is published. We suggest calling in advance to be sure about road conditions there.

# Fly Overs Discover Two Illegal Grows

YCSO Sgt Spear said:

That on 05-30-19 at 8:30 a.m., Yuba County Sheriff's Marijuana Enforcement Team METYU along with code enforcement served a search warrant in the 14000 block of Begonia Way in Oregon House. Located pursuant to the search was a 22 cal rifle, several large hoop houses filled with marijuana plants and several marijuana plants that were located hidden in the brush within the creek bed. A total of 1,444 marijuana plants were located and eradicated. ## Rain, hail fall on Central Valley crops

Storms during the Memorial Day weekend threaten damage to a number of California crops. In the San Joaquin Valley, storms dropped large hail

that could affect crops including tomato and cotton plants, plus peach, nectarine and cherry trees. Agricultural commissioners say it may be several days before the impact becomes more clear. In

the Sierra Nevada, the snowpack now stands at nearly twice-average for the date.

## New project evaluates changing range conditions

To see how range and pastureland respond to changing rainfall and temperature patterns, researchers will simulate a variety of conditions at a University of California facility in Yuba County. UC specialists have earned a grant to create shelters that will allow them to control the precipitation and temperature on a research plot. The project will help the researchers learn how rangeland plants and weeds perform under predicted weather scenarios.

## California leads floriculture production

If you buy flowers or garden plants grown in the United States, chances remain strong that those plants come from California. A new government report shows California continues to lead the nation in production of floriculture crops. The Golden State accounts for more than three-quarters of U.S.-grown cut flowers, and also leads in categories including bedding and garden plants, and flowering potted plants.

## Prune marketers re-brand their crop

Once marketed as dried plums, California prunes will now be called just that--California prunes--in a new marketing campaign. The California Prune Board says the rebranding emphasizes the "premium reputation" of the state's crop, which is sold in the United States and dozens of countries around the world. The board's executive director says the idea is to change prunes from an occasional choice to a "daily pleasure" that brings a number of health benefits.

June weather usually starts to warm a bit and it also is the beginning of summer – June 21st is the first day of summer. It also brings the end of the school year, with lots of graduations. Summer vacations are anticipated along with the feeling of freedom from the daily routines. It is still a great time for gardening. Time does need to be given to care for the new plantings. It's always nice to get out in the cool of the morning and tend the garden. Or evenings checking watering. Because we usually have very warm weather during our summer months, maintaining adequate moisture to the newly planted additions is a must. Every year at this time of vacations, I try to emphasize the importance of having a good understanding between you and the person you rely on to care for your yard. The person you use, should come to see the yard and be made aware of any special care needed, how any watering system you might have works, and all those quirky little things that might be encountered by that person. If you write or type it so that no important details are missed, there should be no reason for mishaps. If you can laminate the instructions, all the better – they are not as likely to get wet or torn, etc., and all should end well.

The most frequent cause of plant failure during the warmer months is shortage of water. Most of us have learned quite a bit about watering adequately with care during the drought years and all those lessons still apply. Deep watering and mulching garden beds and around plants is something that everyone should do. Mulch keeps

the moisture in the soil and the roots of the plants cooler. Watering can be done less frequently because about two inches of mulch when dampened while watering will help retain the moisture in the ground much longer. It also helps to discourage weeds. Of course, drip systems have long been known to save water and discourage weeds by delivering the water just to the base of the plant and not all of the surrounding area. The emitters require some checking and maintenance occasionally.

In April there was a flurry of vegetables being sold, so I would guess that there some very nice vegetable gardens out there that will soon be producing crops. Home grown fruits and vegetables that ripen on the plant have such wonderful flavor. Tomatoes have to be the favorite. Keep watch for tomato worms – they like those tomatoes as well as we do and can be controlled with *Bacillus Thuringiensis*, better known as B.T., or Caterpillar Killer.

Roses have been spectacular this spring. The blooms have been large and beautifully shaped. When the hot weather comes, they will still be lovely, but the blooms usually shrink in size. Be sure to watch for any fungal or insect infestation, and take care of it as soon as it is seen. Dead head your roses frequently and fertilize them every 4 to 6 weeks to encourage more blooms and keep them green and healthy.

It is recommended that fertilizing be done three times a year – February or March, June and September. The early months are getting them off to a good start, June is maintenance, and September is preparing them for fall and

the coming dormancy of winter. These are guidelines and reminders that plants in our area will do much better with occasional feedings, especially in areas with the heavy clay soil that many of us deal with. Using organic fertilizer is generally a bit more expensive but much better for building the soil. Some use a soluble fertilizer frequently all season. You can see that there is no one definite right or wrong way – just listen to a group of gardeners. Each thinks his or her way is the best way – but whatever methods they use, they are all fertilizing their gardens! An especially nice plant that loves the hot weather and will bloom all summer is Crape Myrtle.. They are available in several different colors and can be found in either bush or tree form, and they are not excessively thirsty. They are quite drought tolerant once they are established but give best blooms with a good deep soaking once a week. Perennials also are good for summer bloom and they come back year after year. Summer annuals will give you abundant color through the summer and love the heat. There are lots of choices to give your garden color through the summer that thrive in the heat.

We hope you all have an enjoyable summer and pleasant summer mornings tending your gardens.

## More Feces More Taxes

The fund grew only from about \$170 billion to just over \$300 billion during the same period that the Dow erupted from about 6,400 to just over 21,000. If CalPERS had followed the same path as the Dow Industrials, the fund would be valued at or near \$540 billion rather than just over \$300 billion.

While CalPERS enjoys the luxury of choosing investments that promote its 'social justice' values, the meager returns are made-up by the member municipalities and counties. 'Social justice' also includes investing to promote carbon footprint reduction, gender diversity, wage equality, anti-fossil fuels etc.

South Yuba residents feel like they are getting hustled once again to fund spiking CalPERS payroll costs with threats of higher flood insurance rates and flood risks and no more development

unless they double the amount in assessments for Reclamation District 784 (RD784). PR fliers sent to residents were neither informative nor transparent.

Residents looking at Three River Levee Improvement Agency (TRLIA), RD784 and Yuba Water Agency (YWA) budgets see huge increase in salary and benefits at RD784 and millions of dollars available in TRLIA and YWA. So, why take more money from the taxpayer when TRLIA and YWA already have taxpayers' money for levees and flood control?

As for RD784, one citizen's budget analysis for 2019-2020 concluded that overall Expenditures have increased by 59% from \$1.8M (million) to \$2.9M. Primary increases in expenditures show Salaries & Benefits up by 87% from \$0.49M to \$0.9M. Maintenance costs have jumped by 62% from \$0.53M to

\$0.84M. And Services and Supplies have increased by 145% from \$0.17M to \$0.41M.

Aside from CalPERS ripping-off the taxpayer in pension and benefits costs let's assume that all other RD784 increased expenses represent a bare-bones lean-and-mean budget. Then, why does the county have to triple-gouge the citizens?

YWA keeps saying their primary mission is flood control, water management, hydro-power etc. and they only need a nexus to their mission to spend money. They amazingly found a nexus with flood control to pave North Beale Rd and Olivehurst Ave. and clean-up homeless camps. So, why doesn't the YWA mission with \$100 million in the bank include the Gold Fields levee construction and helping backfill RD784's budget shortfall?

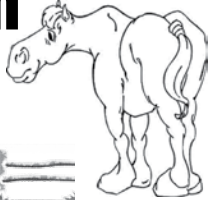
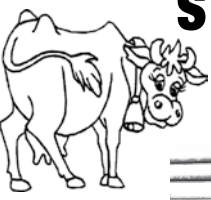

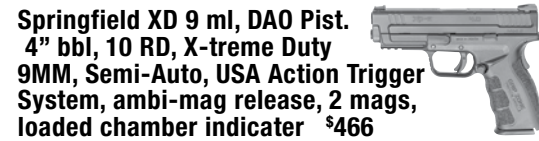

A Bunch of Bad Mexican Plotters

Well, if Washington finally decides to fix the country's immigration problem, Mark Morgan will be at the very heart of that. You've known from this show. He has been a frequent guest. We've been happy to have him every time he's been on. And he is now the President's new pick to run I.C.E. (Immigration Customs Enforcement). He joins us tonight for his first interview since starting the job.

**(Some Bullet Points from Mark Morgan):**

Congress has clearly showed its inability to do what they know they need to do to fix this crisis. And I've been on here many times and saying they could do several things within the legal framework. They could fix this in 15 minutes. So although I'm going to continue to work tirelessly with Congress to try to get them to do their job, I don't have hope that they're going to. So we need to continue to come up with innovative ideas within the legal framework where we can to stop this problem.

So I'll give you an example right now. So I.C.E. actually have three major components that the American people and unfortunately, I think a lot of Congress don't even realize. So they have the E.R.O. side. That's the Enforcement Removal

Operations that deports people, plus an incredible team of lawyers. That's an integral part of the overall immigration process that's absolutely needed. And then the last part of I.C.E. is H.S.I. -- Homeland Security Investigations.

H.S.I., for example, what we've done is we've taken about 150, highly- trained, experienced, H.S.I. agents, and we push them towards the border. And what they're doing is they're looking at child exploitation.

They (illegals) are renting kids. They're paying to rent somebody's kid and then fake themselves as a family -- and we've infused the DNA testing that we've talked about in the past, so between their investigative skills and the DNA testing right now in the pilot program, they're finding 25 percent of the so-called families come across -- absolutely fake and fraudulent.

Just the other day, they caught a 51-yearold man from Honduras... guess who he had with him as a family? A six-month-old. And because of work at H.S.I. They found that to be completely false. That's the kind of stuff that we're doing and we need to continue to do.

Right now, I.C.E. on the E.R.O. side, this year so far, just the first quarter, 66,000 individuals have been deported. Of the arrests that they've made, **65 percent of those arrests were actually people with additional criminal convictions.**

Ninety percent of those either had a criminal conviction or a pending charge. You get rid of I.C.E., think about that. So 66,000 not deported. You have just an incredible amount of people who are doing bad things that are going to remain in the United States.

On the H.S.I. component. Last year alone, 34,000 arrests, Tucker -- 34,000 criminal arrests. Almost five thousand gang members, human trafficking cases, child exploitation cases, 1.2 billion in currency they seized, and the list goes on and on and on.

So when you have somebody that puts out the reckless, irresponsible rhetoric about I.C.E. being abolished, that's what's going to happen. This country will absolutely be less safe because of that.

They absolutely need to continue to increase the funding for I.C.E. specifically on the detention bed space. It's just common sense, Tucker.

## Farm Leader Responds to Tariff Assistance Package

Expressing appreciation for the Trump administration's broadened programs to ease the impact of retaliatory trade actions on American farmers, the president of the California Farm Bureau Federation reiterated the need to resolve the disputes at the root of the issue.

CFBF President Jamie Johansson was in Washington, D.C., when the administration announced the tariff-assistance package.

"It's clear that the administration wants to do what's best for American farmers and ranchers," Johansson said, "and we appreciate this second round of assistance for those who have suffered loss of markets and crop

value due to retaliatory tariffs."

Johansson noted the new package provides assistance to more California-grown crops not previously included in certain programs, specifically direct assistance through the Market Facilitation Program for walnuts, pistachios, table grapes and potentially others.

"Farm Bureau worked in concert with members of Congress from California, advocating for inclusion of more fruit, nut and other 'specialty' crops in the assistance package. Adding those crops will help further buffer rural California from the impact of the trade disputes, and we thank the administration for doing that," he

said.

Johansson noted that farmers are heading into a second straight harvest season in the middle of a trade war.

"Ultimately, the best assistance for farmers and ranchers would be to resolve the trade disputes and open markets for California farm products," he said.

Johansson said Congress can also help improve foreign markets for agricultural products. "The U.S.-Mexico-Canada Agreement will solidify agricultural trade with two of California's top customers for farm goods," he said. "The USMCA deserves swift, bipartisan passage."

## Major "Cash for Food" Drive Underway

Yuba-Sutter-Colusa — Unbeknownst to many people, the need for food for families in need is high in the summertime as donations to our local food closets drop. Yet, the demand actually rises as kids are out of school.

Each year, the Yuba-Sutter-Colusa United Way runs a major "Cash for Food" drive at the start of summer, last year raising more than \$15,000.

"The concept of raising money for local food closets has received great reviews from the food closets which collect and dispense foods as the cash donated allows the food closets to purchase what is needed to round out their summer inventory, instead of taking just what product is donated," said Bob Harlan, Executive Director of Yuba-Sutter-Colusa United Way.

"In addition, if we raise our 2019 goal of \$18,000, the equivalent number of pounds could reach 90,000 because of the food closet's buying power with cash," Harlan said.

Harlan stressed that no one will take any cash off of the top. 100% will go to 11 local food closets and the Yuba-Sutter Food Bank to purchase nutritious non-perishable foods for individuals and families in need this summer.

The participating food organizations are: Catholic Ladies Relief Society; Christian Assistance Network (CAN); First Presbyterian Church of Marysville; Foothill Food Pantry; Marysville First United Methodist Church; Our Lady of Lourdes Catholic Church in Colusa; The Salvation Army; St. Andrew Presbyterian Church; St. Vincent de Paul; Twin Cities Rescue Mission; The Yuba-Sutter Food Bank; and St. John's Episcopal Church.

# Life Jacket Loaners

(YUBA CITY, CA) – The Sutter County Children & Families Commission has launched a partnership with the City of Yuba City to provide a Life Jacket Loaner Program for infants and toddlers under the age of 5. Beginning Memorial Day weekend, life jackets will be available at the Feather River Parkway recreation area and can be borrowed for the day.

According to the World Health Organization, drowning is the 3rd leading cause of unintentional death worldwide. Globally, the highest drowning rates are among children 1-4 years of age, followed by children 5-9 years of age. “With area rivers running high and swift, our Commission and valued partners like the City of Yuba City, recognized an opportunity to improve the safety of Sutter County’s youngest residents during warm Summer months,” said Michele Blake, Executive Director for the Sutter County Children & Families Commission.

A total of ten (10) life jackets will be available for loan at the Feather River Parkway location, 5 infant (up to 30 lbs.) and 5 toddler (30-50 lbs). Each life jacket will be branded with a “Property of Yuba City” logo for easy identification. To ensure the longevity of the program the Partnership is relying on the honor system. “Feather River Parkway recreation area is an incredible asset to the citizens of Yuba City and our neighboring communities,” said Yuba City Mayor, Shon Harris. “Yuba City values the opportunity to partner with the Sutter County Children & Families Commission to improve public safety.”

This will be the third Life Jacket Loaner location launched by the Sutter County Children & Families Commission countywide. The first two loaner stations were established in 2017; one at the Live Oak boat launch and the other at the Tisdale boat launch through a Partnership

with the Sutter County Deputy Sheriff’s Association.
