## **Oroville Spillway Releases Begin**

The Department of Water Resources released the following press release on April 2, 2019.

Due to forecasted storms and growing snowpack, the California Department of Water Resources (DWR) began to release flows at 11 a.m. on April 2nd from the Oroville main spillway. By early afternoon, releases from the main spillway were about 8,300 cubic feet per second (cfs). This is the first time the spillway is used since it has been reconstructed and its use will provide room for flood storage within the reservoir.

"The Oroville main spillway was rebuilt using modern engineering practices with the oversight of state and federal regulators on site and a team of experts assisting the Department," said Joel Ledesma, Deputy Director, State Water Project for DWR. "With an average concrete thickness of seven and a half feet, 12.4 million pounds of reinforcing steel, and approximately 7,000 anchors, the main spillway is ready to handle flows."

The information below reflects current reservoir level estimates. Forecasts can change quickly and may affect the estimates provided.

- Current Oroville Reservoir level: 854 feet elevation
- Planned Main Spillway Releases: approximately 8,300 cfs by early afternoon on April 2
- Planned Total Releases to the Feather River: up to 20,000 cfs from Oroville facilities and other natural inflows

DWR may increase flows to the Feather River again later this week to between 40,000 and 60,000 cfs to prepare for forecasted inflows. DWR also anticipates potential further releases to manage snowmelt and lake elevations later this spring.

Oro Dam Blvd. East will be open to pedestrian and vehicle traffic unless flows exceed 30,000 cfs. If spillway flows exceed 30,000 cfs, the road will be closed to ensure public safety. Credentialed media will be provided access past the roadblocks located at Glen Drive and Canyon Drive and can use turnouts along Oro Dam Blvd. East.

DWR has followed its standard process of notifying regulatory agencies, local law enforcement and local elected officials regarding the anticipated use. The Department will continue to update the public, media and local partners through emails, news releases and social media.

## Teacher Student Sex Epidemic

In August of 2014, World Net Daily (WND), an online news publication, produced an article "The Big List: Female Teachers with Students." The piece was updated on 1/25/17 giving 13 pages of accounts (approximately 20 per page) of female school teachers having sex with underage students, in most cases males.

WND has carried numerous stories about what it calls a national epidemic of sexual abuse in schools. The irony is how often the female predator or perpetrator gets off with probation. Similar acts performed by a male teacher with an under-aged female or even by adult non-teachers outside of school would get years in prison.

The joke used to be that in union-controlled government schools it would take a teacher sexually assaulting a student to get fired and lose their credentials. Not so true anymore. And poor work performance or bad character isn't a job killer because of the cost to prove it is prohibitive.

However, job termination for lustful misdeeds may not be an option in the future as sexual-deviancy interest groups lobby for new consent laws allowing for child / adult sexual relations. Rhode Island (RI) is one of a few states where it is legal for teachers and other school employees to have sexual relations with students once they turn 16.

Rhode Island also received a D grade from a year-long study by "USA Today" for how well states track and share information about teachers who are abusers. In Michigan, sex between a teacher and student is prohibited at any age. Laws vary state by state.

Both the National Education Association and the United Federation of Teachers opposed a Rhode Island bill this month to make it a crime to have sexual interaction with students after their 15th year. Union officials and their members are well aware that sexual predators move from district to district and state to state and that threat of termination and loss of credentials are not sufficient deterrents and do not protect children. A district may get rid of an abuser but they have no ongoing concern for where they end up.

In a 2018 report, NPR's (National Public Radio) Erin Logan says: "That cycle — abuse, dismissal, rehire and abuse again — is one that experts and researchers say is far too common across the nation. It has long been known as 'passing the trash,' and despite years of efforts to make policies to keep it from happening, no one really knows how often it does."

The Prison Rape Elimination Act (PREA) became law in 2003 setting standards of behavior in lockdown institutions and de-

# Yuba & Sutter Counties to Test Phone/Email Emergency Alerts

## Wednesday 4/10/19

Yuba and Sutter Counties emergency officials are encouraging residents to sign up to receive emergency alert through their phones, cell phones and emails, prior to next week's test of the CodeRED alert system.

Testing of the CodeRED alert system will take place on Wednesday, April 10. On that day, residents in one county will receive alerts in the morning, and residents in the other county will get their alerts in the afternoon. Officials say the Alert Day is taking place to raise awareness of the service and to get a better understanding of its effectiveness.

"Our communities have been confronted with both devastating fires and terrifying flooding threats over the past couple of years, and each time we began by using an alert systems to notify residents of the emergencies," said Yuba County Office of Emergency Services Manager Scott Bryan. "While no single notification method is perfect, the CodeRED system is the best way to send targeted alerts about real dangers to our residents in the shortest amount of time."

Yuba County has been using the CodeRED emergency notification systems for several years, and Sutter County switched to the same system last October. Emergency officials from both counties point the ability of the notification system to quickly send messages to specific neighborhoods, regions, or entire counties to alert residents.

To sign up, residents can go to their county's emergency preparedness website. Sutter County residents can sign up at BePreparedSutter.org and BePreparedYuba.org is the site for Yuba County residents. Both pages have links to the Co-

deRED registration page, which

is a free service.

Each person completing the CodeRED registration process are first asked to provide a name and address, in order to make it possible to alert them about an emergency specific to their neighborhood. The participant can also list any phone numbers or email addresses to receive messages in a declared emergency.

The April 10 message that goes out through text messages and emails will make it clear to those receiving the notification that it is part of a test and that there is no actual emergency.

## FISHIN' TALK

As the old saying goes, "April showers bring May flowers" which also applies to migrating fish in local rivers. One of these is the Shad which arrives in the Feather and Yuba River in late April. We all know when the cotton pods drop from the trees that it is time to go fishing for shad also known as the poor man's tarpon.

Shad were not a native fish and were placed in the Sacramento River in 1871. Like the salmon and steelhead plants in the Feather River they headed downstream to the ocean. When they returned to the river they expanded their have presence in all rivers and can be found throughout California and Oregon.

Shad are aggressive fighters. When one hits your lure most anglers are surprised to see the size of the fish when it is landed. A two pound male will fight like a four or five pound striped bass. Most male shad run up to two or three pounds but the female has been reported to get

up to eight pounds. The males arrive ahead of the females sort of like the striped bass runs each vear.

Shad do not spawn and die like the salmon, but spawn and return to the ocean to then return again and again. Some folks can testify they thought they had on a striped bass and it turned out to be a shad. Shad are fast, very fast in the water and are suckers for lures, spinners, darts and spoons, but will hit bait on a hook. However, their mouths are small and paper thin so it is highly unlikely a person will catch a shad on striped bass gear.

We who live in this area are in prime shade country. The Feather and Yuba River are excellent for shad as well as the American River and the Sacramento. The best time to fish these waters is early in the morning or late in the evening hours. Shad tend to move close to shore during this time and can be caught right next to the bank at the right time of day.

We have fished for shad from shore in the Feather River as well as other areas and by boat. All is needed is a spinning outfit, some shad darts and enough weight to reach the bottom. Cast upstream and follow the lure as it moves with the current. A strike is usual at the end of the drift as the line turns and heads to shore. A fast retrieve will also bring results. Over the years I have caught hundreds of shad, returning almost all to the water.

The biggest shad I caught was in the Feather River a couple of hundred feet downstream from the Fifth Street Bridge. The fish was a female and measured at 23 inches. When she hit my shad dart I thought I had a snag.....but the snag moved and it moved upstream. There were other people on the shore fishing, but only one upriver. He reeled in his line and stepped out of the way. The fish turned and headed downstream. What followed was utterly crazy. Anglers were reeling in and jumping out of the way as I passed with my Mitchell 300 reel drag singing. I had placed the small reel on the fiberglass rod which was filled with four pound test line.

I stumbled and talked to the fish as I continued working my way downstream. People yelling and some had already thought I had a striper or salmon on the end of the line. It was a couple hundred feet before I managed to bring the big shad to dry land. Everyone around me wanted to see the fish as I quickly measured her and gently placed her back in the water. She laid motionless for a few seconds and then was gone in a flash. What a

thrill that evening was! Boots fishing tip for the week: "If you go shad fishing this year make sure your reel has a loose drag."





















claring a zero tolerance for rape. Mandatory trainings are conducted for all employees to prevent fraternization with inmates as well as a sexually charged work environment and harassment. PREA seeks to insure that jails and other correctional settings protect inmates from sexual assault, sexual harassment, "consensual sex" with employees, and inmateinmate sex.

Yuba County Office of Education (YCOE)

41-year-old placing teacher Heather Frey on administrative leave for an alleged improper relationship with an incarcerated juvenile hall minor raises a number of questions. Do YCOE employees working in detention facilities or at the Thomas E Mathews (TEM) Court school have PREA training?

If not, are there teacher-pupil standards of behavior that instructors agree to when being employed by YCOE? In 2015, a 26-year-old

female teacher was arrested for having sex with a 15-year-old boy at TEM.

Is YCOE contributing to NPR Erin Logan's described cycle of abuse, dismissal, and rehire of predators to abuse again? To fill Ms. Frey's position, Jim Whiteaker, dismissed by Yuba City Unified School District for repeated accusations from female students of sexual abuse, has been hired by YCOE.

#### This Month In Your Garden by Cecilia M. Rice

April is a pretty name for what is usually a pretty month. The first day of spring greeted us on March 20th, and April is celebrating its presence with fresh shades of green as a backdrop for all the wonderful color we will begin to see. Our weather usually takes a turn for the better - not too cold and not yet uncomfortably hot. It is just right for gardening without having to face the water shortages we all struggled with during the long drought. Enjoy it!

Vegetable gardens are underway or in the planning stage for lots of folks. Sometimes early April still brings us some very cold nights. Keep in mind that the night time temperatures should be at a consistent 50 degrees to sustain the best growth. Seeds that have been planted should be fine, but small plants can be stunted by cold nights. Many people feel that April is a late start, but, that is an opinion, not a fact. Monitor the night time temperatures for a few nights and make your decision. Up in our foothill areas there are lots of microclimates depending on whether you are up on the hill or in a valley where the cold is more apt to settle the difference in temperatures can be significant. Many people in the higher foothills, such as Grass Valley or Brownsville wait until May because of the almost inevitable late cold spell that is apt to come along and freeze the small plants making it necessary

There is an abundant display of colorful plants to get into the soil anytime now to make your yard wonderfully colorful. There are many seasonal bedding plants that will

to start all over again.

bloom all summer long for your enjoyment - pansies, marigolds, snapdragons, petunias alyssum, annual vinca, portulaca lobelia and others. Some perennial plants will bloom though the season if planted now, such as foxglove, coral bells, coreopsis, gaillardia, dianthus and many others.

If you planted any fruit trees during bare root season or recently purchased any in containers, this is just a reminder that the tree trunk should be painted with tree-trunk paint from the ground up to the first limbs to protect them from sunburn. Sunburn can cause the young, still thin bark to crack creating a possible entrance for pests. As we progress into the hot weather, the young trees will need a good, deep watering two to three times a week, depending on how hot it is. This is very important to help them develop deep roots to become healthy trees. A quick watering every day or so will develop shallow roots that will not be able to sustain them well as they grow larger. This actually applies to any trees you may plant - especially with the hot weather that we know is coming along. Roots seek the water wherever it is. Citrus trees are avail-

able and have been blooming and soon the very small fruit will be seen in their place. They are probably no longer in need of protection from cold weather, but be ready to protect them should some freezing weather be predicted. Citrus trees should be fertilized regularly to keep them nice and green. If they begin to have yellow leaves with green veins they should be given some chelated iron.

Lawns should be fer tilized with a lawn food If your lawn areas have weeds invading them, it is helpful to use a lawn food that has a weed control in corporated in the formula This is also a good time to plant a new lawn if that is in your plans. It is much easier to do it now before the daytime temperatures become hot. That requires more frequent short wa tering sessions to keep the soil moist enough to help the seed sprout with out washing some of the seed away or drowning the first new little sprouts There are many opinions about lawns since the recent drought. It is a fact that they require lots of water and we are stil being cautioned abou not wasting water. Huge lawns can be avoided, bu even a small oasis of lawr can make the yard seen cooler and more inviting That, of course, is my personal opinion.

It has been nice to see all of the early bloom ing plants. Our fence line of daffodils at the nursery were beautiful. I have noticed orchards in ful bloom and the few frui trees we had left from bare root season were pretty to see in all their differ ent colors. Of course, the flowering quince along the roads and the yellow forsythia in yards are always early clues tha spring like weather wil soon be here.



**Emergency** response vehicle for the Camptonville Volunteer Fire Department - \$59,363

A \$39,575 grant and \$19,788 loan will help the Camptonville Community Services District replace the Camptonville Volunteer Fire Department's outdated emergency response vehicle.

The fire department's current emergency response vehicle was recently taken out of service due to safety concerns and exceeding its useful service life.

Over the last three years, the Camptonville Volunteer Fire Department used the recentlyretired truck to respond to more than 40 emergencies near Yuba Water's dams and the surrounding areas.

The Camptonville Volunteer Fire Department provides 24-hour Bullards Bar Dam and Reservoir and its recreation areas.

Yuba Water Agency Grants

Fire equipment for **Dobbins-Oregon House Fire Protection District** - \$10,000

This grant will fund a new self-contained breathing apparatus and associated bottles, wildland hose clamps and fire shelters as a part of the Bill Shaw Rescue Equipment and Training Grant Program.

self-contained breathing apparatus is a device worn by rescue workers and firefighters to provide breathable air in dangerous situations. Fire shelters are devices used by firefighters for protection from direct flames and heat when dealing with wildland fires.

The Dobbins-Oregon House Fire Protection District responds to medical emergencies, wildland and structure fires, vehicle and boat accidents, and search and rescue operations on the Yuba River and near Yuba Water Agency's facilities.

#### Rescue equipment for Wheatland Fire Authority - \$10,000

This grant will cover the costs to purchase water and confined space rescue equipment for the Wheatland Fire Authority as a part of the Bill Shaw Rescue **Equipment and Training** 

Grant Program.

The fire department's current water safety and confined space equipment recently expired, and these funds will allow the department to purchase the necessary gear to outfit its entire team, including ropes, webbing and harnesses.

The Wheatland Fire Authority provides rescue services for people recreating on the Yuba River, and through mutual aid agreements with first-responder agencies, may support emergencies at New Bullards Bar Dam and

#### Reservoir. **GPS** units for Yuba **County Mounted Sher**iff's Posse - \$10,000

As a part of the Bill Shaw Rescue Equipment and Training Grant Program, this funding will help the Yuba County Mounted Sheriff's Posse purchase upgraded GPS radio units.

The new GPS units will be used to relay the exact locations of posse members during search and rescue situations, while also increasing radio communication capabilities.

The Yuba County Mounted Sheriff's Posse provides search and rescue services throughout Yuba County, including areas around New Bullards Bar Dam and Reservoir and other Yuba Water Agency facilities.

host three unique displays that have never been seen anywhere.

Last year, a discussion was held explaining how a 1923 patented John Deere Hit and Miss engine ran a 1923 patented five gallon White Mountain Ice Cream machine worked and free samples were given out. A good sized crowd gathered about the curious contraption and enjoyed the special flavor of ice cream.

The speech was so successful the committee wants to try a follow-on experience.

Samples will not be given out because of the requirements of Environmental Health.

This year Rod Hisken and Don Tomlinson will team again to demonstrate how food for people and farm animals was prepared in the late 1800s and early 1900s.

The machines being used were sold by Sears and Roebuck and Montgomery Ward. The Sears machines were owned by residents of Brown Valley. Amazon grew out of the big box stores and box stores ancestors would be the mail order catalogs. The mail order catalog business became possible because of the railroads, enhanced by the development of the truck, and the coming of Rural Free Delivery in 1893 which evolved to a greater maturity by 1909. These businesses came into being as the rural population of America demanded products and did not have the ability to shop in the more metropolitan centers.

Sears was founded in 1886 by Richard Warren Sears and Alvin Curtis Roebuck. A new partner joined in 1906, Julius Rosenwald. They were based in Chicago. Their first store was in Evansville Indiana. The Sears Holding Company eventually built the famous Sears Tower and generated a worldwide revenue of \$13.8 billion.

Montgomery Ward began business in 1872 and produced a catalog of one page that boasted 163 items. The company grew rapidly in 1875 when they offered "Sat-Guaranteed". isfaction The catalog became the national "Wish Book", The first store was in Plymouth Indiana. Ward died in 1913. Another outstanding business generator

Wards was created by a

staff copywriter, Robert

Wray when he created the

caricature of Rudolph the Red Nosed Reindeer later popularized by Gene Autry in 1946. Unfortunately, the company selected a very conservative leader an he failed to see the future and the company did not prosper with the new culture that came after World War II.

Many outhouses, out where they belonged, had a used mail order on hand for the appropriate supply.

The machines used for the presentation are three. One is a David Bradley number 8 Corn Cob Crusher and Feed Grinder. It was distributed by Sears and the listed price in 1917 was \$18.95. The crusher was sold from 1912 to 1928. It would process 10-15 bushels per hour and required a 4-6 horsepower engine. The engine being used to run the crusher is a 1916 Economy Model E. It is a dual fuel, "Hit and Miss", and has a "Make and Break "ignition. The engine weighs approximately 2,000 pounds and was listed in the catalog for \$159. The engine can be traced to pumping water in the Copperopolis Gold Mine. The owner, Adolph Reusser, retired and moved to Browns Valley where he cut wood with it. It sat in Bertha's garden as yard art and was discovered by Carl Mehr. Carl restored the machine in 1998. It is affectionately known as "Big Bertha". The third machine is a 1936 "Wards Grain Buster". The original owner was Sid Campbell of Tehama, Rod hauled hav for Mr. Campbell as a teenager and effected his work ethic.

The presentation will occur at 12:30 to 1:00 on Saturday and Sunday.

This unique opportunity should be interesting and will demonstrate how history repeats itself and how our forefathers prepared food for farm animal power.

#### The Best of Enemies

Starring: Taraji P. Henson, Sam Rockwell, and Babou Ceesay. Rated: PG-13, Runtime: 2 hours, 13 minutes.

In 1972 Durham, North Carolina, a segregated school catches fire and the parents seek to integrate the school system to meet the needs of the students. This action stirs the social turmoil of the small town and with he help of a Charrette organizer drastically opposed sides are able to come together and through honest and respectful communication work issues out.

The Best of Enemies, earns five out of five, Coke Drinking Monkeys. The story is well written and does a beautiful job of showing both sides as humans locked in their perceptions of each other. How those perceptions are modified as they see each other as human and more similar to themselves than they previously thought. The acting is great. Sam Rockwell, fearlessly tackles his roll as Klan leader and Taraji p. Henson, is a force on the screen. Her character reminds me of my own mother. Fierce and quick to right injustices. The production is well done with subtly placed product placement.

The Best of Enemies, is well worth a trip to the movie house to see on the big screen and as a bit of trivia, it opened on the anniversary of the assassination of Martin Luther King Jr. His message is still working today. Not for one to dominate over another, but that all should be equal and treated as individuals according to the content of their character.
