## Northern California Sports Assoc. Hall of Fame 2019

**Kim McDougal and a Child Spy will be Honored at the Dinner**

Yuba City, Ca.

Kim (Morton) McDougal, arguably considered the best female athlete to ever come out of this area, and a "Child Spy" against the Nazis during WWII, will be honored on March 16th at The Veteran's Memorial Building in Yuba City. They will be hosting the 49th Annual Northern California Sports Association "Hall of Fame/Scholarship" Dinner on that Saturday.

The evening highlights the induction of 9 new members and a legendary team into this 2019 Hall of Fame, along with six college-bound students who will receive scholarships totaling \$15,000.

Kim McDougal attended Yuba City High School and was a Honker during the early 1980's. She played softball, basketball, tennis, and a year of volleyball. Other than being the team captain, MVP of many of those teams, and a perennial All-League choice, she competed in the 1983 and '84 Junior Olympic travel softball teams winning the National Championship.

Continuing on scholarship to play at Fullerton(#1 team in the nation) and then eventually to UOP Softball and Field Hockey, Kim excelled at everything. For 30 years she has taught and coached in the Elk Grove School District and won "California Teacher of the Year" in 1996.

Hannie Voyles lived in Amsterdam as a child about 100 yards from Nazi headquar-

ters during WWII. As a young girl she would report the Nazi's soldier and motorized equipment movement as well as the round-ups (razzias) of Jews. After moving to the states, she got her degree at Chico State College and a Journalism Certificate at the University of London. Joining the Butte College staff when they first opened the school, she has been the Department Head of 10 various departments during their 50 years in existence. She coached a Field Hockey Team to 8 consecutive GVC Championships and won the State Title in Field Hockey in 1978, beating Danza College by a 2-1 score. With Title IX eliminating some of the sports, women's soccer replaced it. No other women's sports ever equaled their records.

Two other local athletes from the Marysville Indians, who both went on to become standouts in football at Humboldt State University, will be present to receive their award.

Mike Lynch who excelled in Football and Wrestling at Marysville, then at Humboldt State, has been a teacher and a coach for over 40 years at various high schools. Mike was named to the Yuba College Athletic Hall of Fame in 2015 and was on the coaching staff of the Granite Bay High football team that won the CIF State Bowl Championship in 2012.

Another Marysville Indian,

Ralph Hendrix, was on the All-League teams in both Football and Baseball. He was considered the #1 pitcher in Northern California by the Sacramento Bee in 1969. He was also All-Conference #1 team in baseball both at Yuba College and Humboldt State.

## Measure K Legal Fight Commences

Sacramento attorneys Bell, McAndrews, and Hiltachk, LLP representing the Howard Jarvis Taxpayers Association (HJTA), Charles Mathew and John Mistler have filed a motion in Yuba County Court for Preliminary Injunction and Declaratory Relief regarding the Measure K sales tax increase. It will be heard on March 18, 2019, at 10am in Department 4 before Superior Court Judge Stephen W. Berrier.

Measure K received a simple majority of the vote 7,964 (53.04%) versus 7,051 (46.96%) on November 6, 2018 to add another 1% of local sales tax onto the state sales tax rate of 7.25%. All of the added 1 percent would go to Yuba County versus the State of California.

The contention by the plaintiffs and anti-tax increase people is that the way Measure K was written and promoted necessitated a two-thirds majority approval instead of a simple 50% plus one majority. Opponents say the Measure was written and promoted as a tax dedicated to a special purpose as opposed to a tax to benefit the general fund.

Election rules for new taxes have been established by Propositions 13 and 218 previously passed by voters.

On March 18, if Judge Berrier approves the injunction, then Yuba County would be prohibited from entering an agreement with the California Department of Tax and Fee Administration (CDTFA) to enact and administrate the "illegal, unconstitutional and unenforceable Yuba County special tax." If Berrier does not concur with the plaintiffs' motion then the tax will go into effect April 1, 2019.

The suit says "Yuba County Board of Supervisors proposed,

## El Dorado County Employees to Yuba

On July 1, 2017, Chief Deputy County Counsel Courtney Abril took over as Yuba County Counsel after Angil Morris-Jones' departure. "Over the last year, Mrs. Abril has developed a very good relationship with county departments and elected officials," said Yuba County Administrator Robert Bendorf in recommending her to the board. "Her hard work and effective management of the County Counsel's office is evident to all who work with her."

However, recently Abril resigned her position saying she needed to be more focused on family matters according to one source. The interesting timing was that Measure K had been challenged with a lawsuit alleging the improper crafting of the ordinance. Also, the county suffered the financial loss in attempting to nullify the 1979 jail consent decree. And, last year there was a million dollar settlement for a man ending his life while incarcerated.

Although Abril had been serving in the county counsel's office she was the Chief for about 18 months.

New applicants have been considered by the Supervisors with Michael Ciccozzi being the likely choice this Tuesday after he resigned his post in El Dorado County (EDC) February 7th. According to the Mountain Democrat, Ciccozzi served as County Counsel there since April 2016 though he worked for the county on and off since 2003.

Ciccozzi said his reason for leaving like Abril, was family, his wife's family lives in Chico. "Family comes first" he says after a 15-year connection to EDC government.

However, in a March 7, 2016 Mountain Democrat (MD) article Ciccozzi was criticized for the handling of the employment contract for retired Sutter County Administrator (CAO) Larry Combs who was going to work for EDC as interim CAO.

CalPERS, the state employee retirement system, has rules guiding when, how and if a retiree collecting benefits can dou-

Conditions have improved in local rivers for sturgeon. The big fish are being caught in the Feather and Sacramento Rivers. Hot spot in the Feather is at the Bear River, with good results coming in from Knights Landing on the Sacramento. The fish appear to be hungry, taking just about any offering which include sardines, shrimp, pile worms and night crawlers. Reports tell us striped bass are in the Feather River at this time, brought up by the recent planting of steelhead at Boyd's Pump below Yuba City. Dry conditions have cleared up the river which is still running low. The Bear River however is running high since Camp Far West Reservoir had water going over the spillway last week.

This is a new year and we advise to be sure your fishing license has been purchased prior to hitting the waters. As we all know from past experience the cost of the license goes up every year. This year it will set you back \$49.94 unless you are out of state. Then the license will be \$134.74. One day license will cost

\$16.20. All the high water makes for good catfishing. Our weather source advises storms this week which will last four to six days. This will again bring in the catfish in flooded waters and muddy up the rivers. We have a report from Collins Lake above Marysville that the reservoir is full and is spilling over. When this lake clears up a bit we can expect excellent fishing for planted trout. The plants will be made on a regular basis. Lake Oroville is still murky and muddy and the reservoir continues to rise four or five feet a day. This just about

makes fishing impossible or a waste of time. The new storm front coming in will certainly aggravate the situation here. Our weather source advised a couple weeks ago that we would be seeing winter conditions like we have had in past years. We are told the snow depth in the high country is the most people have seen in the last 40 or 50 years. Run-off from this deep snow should make for outstanding striper fishing on the Feather River this year. Closing thought: "Do not hang back with the compliments.....they might just make some ones day."

drafted and placed Measure K on the November 6, 2018 ballot. Measure K unequivocally proposed a special tax. By the terms of its own governing provision, funds generated by the tax were specially dedicated to “public safety” and related essential services. In addition, the funds generated by Measure K were to be placed in a special account to preserve them for their special purpose.” Special purpose taxes require a two-thirds passage by voters.

HJTA wrote the Supervisors prior to the

election warning them that the ordinance was improperly drafted as a Special Tax but only asking for a simple majority passage. HJTA advised supervisors to correct the misleading of voters. County Administrator Robert Bendorf declined the input of HJTA maintaining the Measure K verbiage was legal and accurate.

HJTA won a similar suit against the City of Roseville in 2003 opposing a utility user’s tax and the Roseville case is quoted in the Yuba dispute. “The Roseville court

then determined that a utility user’s tax, which generated revenues solely for police, fire, parks and recreation, and library services, was a “special tax” because it was imposed for specific purposes. This was true, according to the court, even though those purposes accounted for approximately 50 percent of the city’s general fund expenditures.”

The Yuba lawsuit further says the Measure K is similar to a number of other public safety taxes that have been “acknowledged” to be special taxes requiring a two-thirds vote for approval. In those cases voters approved the measure with more than a two-thirds majority. (San Marino, Oakland and California City are cited).

A preliminary injunction is requested by the attorneys as necessary to enjoin any agreement between the County and CDTFA for administration of the illegal tax until the Court can rule on the Plaintiffs’ underlying reverse validation action.

County residents are saying that Supervisors Fletcher and Bradford announced that the assessments of the higher sales tax of 8.25% will commence on April 1 and the revenues will be held in a fund by CDTFA until the suit is resolved. If that is the case and the county loses the suit, will taxpayers get a refund for being overtaxed incorrectly by businesses? Should consumers keep their receipts for purchases on April 1 forward? Who would refund the overcharge, CDTFA? How do people apply for the refund? It seems like undue chaos is being created by the Supervisors rather than waiting for a fair hearing on the matter.

ble-dip by returning to work for a CalPERS agency or county. Ciccozzi appeared to ignore them.

The MD article says, “CalPERS has strict requirements to prevent double-dipping of a CalPERS annuitant, such as Combs. It was public pressure from citizens who were outraged at public officials making \$200k a year in retirement benefits, like Combs, and then get another similar job, effectively doubling their income. Poor Mr. Combs, because of the double-dipping laws, is only pulling down \$300K annually.”

CalPERS requirements are spelled out in Government Code Sections 21221(h) and 21224. Two of those requirements are that an open recruitment for CAO is required before signing such a contract for an interim position and that the contract must have an end date. Comb’s contract had no end date and there was no publicized recruitment.

EDC personnel rules say “All recruitment announcements will be posted on the county’s website and other appropriate locations for a minimum of five days.” There was no posting on the county website or anywhere else for a permanent CAO on or before the Combs’ contract was executed. The article says Ciccozzi’s statements and/or emails as published in the Mountain Democrat are misleading and false.

Ciccozzi also served in EDC during the tenure of Terry Daly who was CAO before Combs filled in. Terry Daly eventually resigned under pressure and took a job as chief financial officer with Yuba County Water Agency.

Both Ciccozzi and Daly have been accused, and EDC is being sued over mishandling of Mitigation Fees. These are fees taken from property owners and developers for future infrastructure upgrades. However there are strict accounting and accountability rules to monitor the use and keeping of the funds by government.

EDC Auditor-Controller (A/C) Joe Harn notified then CAO Daly that “EDC was out of compliance with County Ordinance 13.020.20, and California Mitigation Fee Act (Government Code Section 66000-66008) districts (in EDC) that collect money and the collection of those developers’ fees needed to stop.”

A lawsuit against EDC (Dec 4, 2015 \$30 million) maintains the Mitigation Fees have been mis-allocated and the proper re-evaluation of the use and need of the fees every 5 years was not done. Therefore, plaintiffs there are demanding a refund of their fees. Former County Counsel Ciccozzi along with Daly ignored and argued against A/C Harn’s protests that the county was out of compliance and violating the law.

Some feel a worse-case scenario shows EDC paying out up to \$50 million in a settlement over the Mitigation Fee Act violations.

Many in El Dorado County are happy that Ciccozzi and Daly are gone. Now, they both work for Yuba County.

### ADOPTED SACRAMENTO SERVICE PLAN EFFECTIVE JULY 1ST

Marysville, Ca.

Following a public hearing that was held during a special night meeting, the Yuba-Sutter Transit Board of Directors adopted a new Sacramento Commuter and Midday Express service plan last night that will become effective on Tuesday, July 1, 2019. The new service plan features the addition of one new morning and one new afternoon Highway 70 schedules and the elimination of one afternoon Highway 99 schedule. In addition to a number of minor adjustments to account for the above additions and deletions, most of the Sacramento Commuter schedules will experience minor adjustments to reflect current travel times between Marysville/Yuba City and downtown Sacramento as well as within the downtown area.

In addition to approving the new Sacramento service plan, the Board also authorized in a separate action the funding of these improvements with Low Carbon Transit Operations Program (LCTOP) revenue from the State of California greenhouse gas reduction (Cap & Trade) program. As a result, implementation of the related service changes is being delayed until July 1st when these funds become available for expenditure.

## Food and Farm News

### CVP to issue its first water forecast

With the Sierra snowpack swollen to far above average, three members of Congress have urged the U.S. Bureau of Reclamation to factor in this month's storms and maximize its projected water deliveries for irrigation in the San Joaquin Valley. In a letter to the bureau, the legislators say the snowfall should help the Central Valley Project provide more certainty on water supplies. The first forecast of CVP supplies is expected this week.

### Scale categorizes strength of atmospheric rivers

A new scale to rank "atmospheric river" storms could help water managers plan for the rain and snow the storms bring. The state Department of Water Resources says it has partnered with researchers to develop the scale. It ranks storms on a scale of 1 to 5, with 1 being mostly beneficial and category-5 storms

primarily hazardous. DWR says atmospheric-river storms provide most of the state's water supply--but also cause most of its floods.

### Beekeepers report theft of colonies

With almond bloom progressing in the Central Valley, beekeepers have placed colonies in orchards to pollinate the crop. But demand for bees may be close to outstripping supply--and that has contributed to thefts of bee colonies. Beekeepers in both the Sacramento and San Joaquin valleys have reported losing hives. A sheriff's deputy who investigates bee thefts says beekeepers and farmers must work

closely together to prevent bees from being stolen.

### Pistachio consumption poised to set record

People around the world will eat more pistachios than ever before, according to the U.S. Department of Agriculture. Record production in both the United States and Turkey will offset a crop failure in Iran, leading to higher available supplies. Those three nations produce the bulk of the world pistachio crop, with smaller production coming from Syria and the European Union. California farms produce virtually all U.S.-grown pistachios.

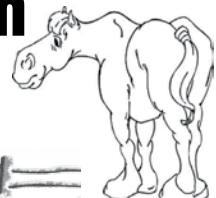

## Corruption Cause of Oroville Dam Disaster?

Officials of the Oroville Dam, the Sacramento Bee reports, “stole equipment, cooked financial books to conceal wrongdoing, destroyed evidence and fostered a toxic culture of sexual and racial harassment that included slurs and nooses hung where a black worker would find them.”

Female Department of Water Resources employees suffered “similar derogatory treatment,” a lawsuit recently filed in Sacramento also charges. The case includes declarations from UC Davis sociology professor Kimberlee Shauman and Cal State Sacramento management professor Amy Mickel, who contend that “a toxic workplace culture could have factored into the spillway failure.” Californians have good cause to place the blame elsewhere.

Oroville Dam was constructed in 1968 and remains the nation’s highest dam. On February 7, 2017, the dam’s concrete spillway failed, launching fears of a complete dam failure, and forcing the evacuation of 188,000 people. Government engineers knew for decades that the alternate earthen spillway was unreliable but failed to reinforce it with concrete. As Rep. John Garamendi (D-CA) famously put it, the dirt spillway “worked fine until it had to be used, in which case it didn’t work so well.”

Governor Jerry Brown

told reporters he was unaware of warnings about the emergency spillway and added, “I’m glad we found out about it.” As Brown explained, “We live in a world of risk. Stuff happens and we respond.” As it happens, one of the government’s first moves was to dam up the flow of information on safety issues.

Governor Brown and state water bureaucrats blocked access to the dam’s design specifications, federal inspection reports, technical documents, and other crucial information. Much of that emerged in Independent Forensic Team Report: Oroville Dam Spillway Incident, a 584-page report that chalks up the disaster to “a complex interaction of relatively common physical, human, organizational, and industry factors, starting with the design of the project and continuing until the incident.”

On page 59 of this document, readers learn that the principal designer for both Oroville spillways “was hired directly from a university post-graduate program, with prior engineering employment experience limited to one or two summers.” And the designer had “no prior professional experience designing spillways” and “no instruction on spillway design” in college coursework. The forensic team “finds it striking that such an inexperienced engineer was given the

responsibility of designing the spillways of what is still the tallest dam in the US.”

Whether or not they live near the dam, California taxpayers may find it striking that this massive, detailed report fails to name this non-engineer. A longtime DWR employee denied that there was any such person, which Californians might take as confirmation that there was.

Though obviously unqualified and incompetent, this person’s political connections were doubtless strong. That’s the simplest explanation why the incompetent grad student got the job and why the expert team keeps the identity a secret. Taxpayers statewide have good cause to regard the report as part of the ongoing cover-up of nepotism, faulty design, and improper maintenance.

Now comes a lawsuit blaming the spillway failure on a “toxic workplace culture” of racism and sexism. If Californians see this lawsuit as part of the coverup, it would be hard to blame them. Californians might also recall the response of Gov. Jerry Brown when he was informed of lingering safety risks on the new \$6.5 billion span of the San Francisco-Oakland Bay Bridge, built with cheap Chinese steel.

As Brown told reporters, “I mean, look, shit happens.”

## YWA Celebrates Grants to First Responders

Marysville, Ca.

A dozen local first responder agencies received funding to purchase specialized equipment and training to assist with rescue and safety services with the help of Yuba Water Agency's unique new program launched in 2018.

The Bill Shaw Rescue and Training Grant program has provided grants for up to \$5,000 annually for the one-time cost of specialized equipment and training to public agencies that provide first responder services for employees and people recreating near the agency's New Bullards Bar Reservoir, New Colgate Powerhouse and surrounding areas.

The Yuba Water Agency Board of Directors unanimously voted to increase the value of the grant to up to \$10,000 per applicant annually.

"These first responder agencies provide valuable first aid services to some of the most remote areas in

Yuba County, including areas near Yuba Water Agency's facilities and New Bullards Bar," said Yuba Water Agency Chairman Brent Haste. "We are so grateful for their quick, emergency response capability, and are happy to help them do it better with this program."

The grant program, which was created in January, 2018, was the idea of, and is named after Bill Shaw, an employee who made a heroic recovery from a potentially life-threatening injury, and is extremely grateful for the emergency first responders who helped save him. Shaw, who is also a volunteer fire chief, gave a presentation to agency directors at today's board of directors meeting, describing how the program has benefited the different recipients and the pride he takes in this unique grant program.

"It was crucial that the people who showed up to help me the day of the accident were well-trained and knew exactly how to deal with my injuries," said Shaw. "The costs for the equipment and training aren't cheap, so anytime Yuba Water Agency can step forward and help pay for training or buy new equipment as needed, it is a huge benefit."

"We were so fortunate to receive the \$5,000 Bill Shaw Grant last year," said Yuba County Mounted Sheriff's Posse Lieutenant Ric Teagarden. "We used the funding to upgrade our medical supplies and backpacks, and to continue training our members, so now all of them are educated in CPR and important rescue techniques."

All first responder agencies in Yuba County are eligible to apply for the grant program for up to \$10,000 each year. The grants must be connected to Yuba Water Agency's missions or operations to be eligible for funding.

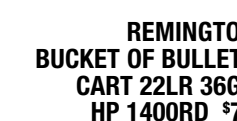

## Water Forecast Demonstrates System's Limitations

With the Sierra Nevada snowpack rising to nearly 150 percent of average, the California Farm Bureau Federation said it's understandable why some agricultural customers of the federal Central Valley Project would be disappointed by the initial CVP wa-

ter outlook. The project, operated by the U.S. Bureau of Reclamation, has told agricultural service contractors south of the Sacramento-San Joaquin Delta to expect 35 percent of contract supplies, and those north of the delta to expect 70 percent.

"California has been blessed with an abundant Sierra snowpack and that should be recognized in making an initial water allocation, so farmers can make their planting decisions," CFBF President Jamie Johansson said. "We hope the CVP will be able to increase its allocations as the spring continues. In above-average years such as this, we need to provide as much certainty about available supplies as early as possible to farmers and all other water users."

Johansson said the CVP likely needed to be conservative in its projections because of bio-

logical opinions for protected fish that require water to be reserved for fishery uses.

"We're hopeful that revised biological opinions can provide more flexibility in managing the system and encourage creative projects for improving fish populations," Johansson said.

"From our offices along the banks of the Sacramento River, I can look out and see a river swollen with runoff heading toward the ocean," he said. "In wet winters such as this, we need to be able to capture more of that runoff, both above and below ground, to shield people and the environment from future droughts and replenish our groundwater basins."

Johansson said Farm Bureau "will continue to advocate for balanced water policies that benefit our state's farms, cities and environment alike."
