

# Yuba Water Agency Reaches Significant Milestone in Relicensing

Marysville, Ca.

The Federal Energy Regulatory Commission this week issued the Final Environmental Impact Statement for relicensing the Yuba River Development Project, which is owned and operated by Yuba Water Agency. FERC has regulatory authority over most hydroelectric projects in the U.S.

This milestone represents FERC's final independent environmental analysis of the impacts associated with issuing a new license to operate Yuba Water's facilities for the next 40-50 years. Those facilities include Our House and Log Cabin diversion dams, New Colgate and Narrows 2 powerhouses, and New Bullards Bar Dam and Reservoir.

Through this environmental document, FERC staff largely supports Yuba Water Agency's proposed conditions (from the amended final license application) for the projects' future operation. For example, instream fisheries flows based on the Yuba Accord form the basis of the flow requirements proposed for the new license, with some small previously negotiated changes. Other key license conditions proposed include:

• Construction of a new

secondary spillway at New Bullards Bar Dam to enhance Yuba Water's ability to manage large storm flows, significantly reducing flood risk for the communities of Yuba and Sutter counties and enhancing dam safety

- Construction of a new tailwater depression system at New Colgate Powerhouse, to enhance power generation capability
   Enhancement of existing
- recreational facilities around
  New Bullards Bar Reservoir
  and at Our House Dam

   Development of new
- Development of new plans to plant riparian vegetation and to place large woody material along the lower Yuba River to benefit fish and wildlife

This is a major milestone in the relicensing process for the agency. Next steps include working with the State Water Resources Control Board on compliance with the Clean Water Act, and FERC completing consultation with the National Marine Fisheries Service regarding the Yuba River's fish species. Once these two major processes are finalized, FERC can issue a new operating license to Yuba Water Agency, which may differ from this document. This process may take several years to complete.

"This has been a time-

consuming, highly-technical and expensive process," said Curt Aikens, Yuba Water Agency general manager. "But now, it seems as if all the time, effort and money expended to fulfill the requirements of the relicensing process are paying off. We feel that this final environmental statement sets us on a successful relicensing path for the long-term operation of this incredible asset that provides so much benefit for the people of Yuba County."

Yuba Waters' facilities benefit the people of Yuba County. Collectively, these facilities generate 400 MW of clean renewable hydropower for homes and businesses throughout California, supply water for nearly 80,000 acres of productive Yuba County farmland, reduce the risk of flooding for residents in Yuba and Sutter counties, and offer numerous recreational amenities including boating, fishing, camping and swimming.

The environmental impact statement is available for public review on FERC's website, as well as the Yuba Water Agency website.

# Terrorists and Foreign Aid

Those graduating from high school this year were not alive when Al Qaeda terrorists bombed the USS Cole in Aden, Yemen on October 12, 2000. Nor have students been told the truth by government schools and the main stream media that Muslims have been on a terror rampage since the Munich, Germany Summer Olympics in 1972.

In 2017, a call for assistance for a young suicidal naval veteran was a reminder that the damage on the USS Cole was not limited to 17 fatalities and 40 injured. The young man in crisis once stood guard in the ship for hours among his dead shipmates until the scene could be processed. Seventeen years later he was still struggling to survive the experience.

Four killed that day were in their early thirties while 13 of the dead were just 19-24 years old. Family members suffer to this day and search for any morsel of comfort from the lingering investigation and court proceedings.

So, President Trump's mention that on January 1, 2019 the US military killed Jamal al-Badawi, the Yemeni terrorist accused of leading the attack, was bitter-sweet relief for those grieving their loss.

Trump's tweet read, "Our GREAT MILITARY has delivered justice for the heroes lost and wounded in the cowardly attack on the USS Cole. We have just killed the leader of that attack, Jamal al-Badawi."

The ship had been refueling in the Yemeni Port of Aden when attacked. A small boat carrying C4 explosives and two suicide bombers rammed the port side of the destroyer creating a huge gash. Al Qaeda leader Osama Bin Laden celebrated the attack which occurred just one year prior to the September 11, 2001 multi-faceted terrorist strike on the US

On Wednesday January 9 2019 at approximately 1:30 p.m., the Yuba County Sheriff's Department along with the CDC Fugitive Apprehension Team located and subsequently arrested wanted parolee and mail theft suspect Damien Cooper at a home in the 1700 block of 10th Avenue in Olivehurst. Cooper

initially hid in the attic of the home, but was talked into surrendering. He was taken into custody without further incident just before 3:30 p.m.



# FISHIN' TALK

We are told steelhead are in the system. These ocean going rainbow trout have been taken in the Feather and Yuba Rivers on various lures and bait. We advise checking with regulations for closures, bait restrictions and other info including catch and release and/or barbless hooks.

I have fished for steelhead both in the Yuba and Feather Rivers in the past and have accidentally caught them when salmon fishing or catfish fishing in the Feather River. Some favorites are spinners and lures along with night crawlers, salmon eggs. Roe is also a good choice when allowed.

The biggest mistake anglers make when steelhead fishing is to wait too long for water clarity after a storm. Water clarity is extremely important for success, but cloudy water is when you want to fish and continue as the water clears. Color is also a big item no matter what you are using at the end of your line. I have had success on natural colored salmon eggs when nothing else would work. Also sometimes changing lure color will get some action.


Steelhead always

move close to shore when storms are around. They will also move in that direction when boats run the rivers. As the storms pass and the water clears you will find them more in the deeper water towards the middle of the rivers. Early morning seems to be the best time for these fish and this brings to mind another story. The biggest steelhead I have ever caught happened early in the morning. We were anchored up at the mouth of the Yuba, sitting in Feather River water. We were after salmon but I decided to toss out a large spinner. My boys both were fishing with a flatfish and sardine

and watched that beautiful steelhead break water and dance on its tail as the early morning sunlight created brightness from the fish and the water spraying into the air each time he iumped.

I brought the fish to the boat and Ted netted him ... a beautiful five pound steelhead. We caught salmon that morning but the conversation was about that fish dancing on top of the water so beautiful and colorful in the early morning sunlight.

Closing thought: "Get out the tackle boxes. check them out and clean up your gear. Good fishing will be here before you know it."








As I traveled to the Territorial Dispatch last week to bang out the weekly column, I tuned into Tom Sullivan's radio talk show to possibly gather some info that I could pass on to the readership. In the budget I will present to you, we will try to do more to speed the deportation of illegal aliens who are arrested for crimes, to better identify illegal aliens in the workplace as recommended by the commission headed by former Congresswoman Barbara Jordan. We are a nation of immigrants. But we are also a nation of laws. It is wrong and ultimately selfdefeating for a nation of immigrants to permit the kind of abuse of our immigration laws we have seen in recent years, and we must do more to stop it."

Here are portions of the transcript of President Trump's address on January 8th. Sounds to me like what President Bill said 24 years ago. You decide!

President Trump: "Every day, Customs and **Border Protection agents**  encounter thousands of illegal immigrants trying to enter our country. We are out of space to hold them, and we have no way to promptly return them back home to their country. America proudly welcomes millions of lawful immigrants who enrich our society and contribute to our nation, but all Americans are hurt by uncontrolled illegal migration. It strains public re-

sources and drives down jobs and wages. Among those hardest hit are African-Americans and Hispanic-Americans. Our southern border is a pipeline for vast quantities of illegal drugs including meth, heroin, cocaine, and fentanyl, Every week, 300 of our citizens are killed by heroin alone. Ninety percent of which floods across from our southern border. More Americans will die from drugs this year than were killed in the entire Vietnam War. In the last two years, ICE officers made 266,000 arrests of aliens with criminal records including those charged or convicted of 100,000 assaults, 30,000 sex crimes, and 4,000 violent killings. Over the years, thousands of Americans have been brutally killed by those who illegally entered our country and thousands more lives will be lost if we don't act right now.

This is a humanitarian crisis. A crisis of the heart, and a crisis of the soul. Last month, 20,000 migrant children were illegally brought into the United States, a dramatic increase. These children are used as human pawns by vicious coyotes and ruthless gangs. One in three women are sexually assaulted on the dangerous trek up through Mexico. Women and children are the biggest victims, by far, of our broken system.

This is the tragic reality of illegal immigration on our southern border. This is the cycle of human suffering that I am determined to end. My administration has presented Congress with a detailed proposal to secure the border and stop the criminal gangs, drug smugglers, and human traffickers. It's a tremendous problem. Our plan also contains an urgent request for humanitarian assistance and medical support. Furthermore, we have asked Congress to close border security loopholes so that illegal immigrant children can be safely and humanely returned back home.

overall approach to border security, law enforcement professionals have requested \$5.7 billion for a physical barrier. At the request of Democrats it will be a steel barrier rather than a concrete wall. This barrier is absolutely critical to border security. It's also what our professionals at the border want and need. This is just common

The border wall would very quickly pay for itself. The cost of illegal drugs exceeds \$500 billion a year. Vastly more than the \$5.7 billion we have requested from Congress. The wall will also be paid for indirectly by the great new trade deal we have made with Mexico.

Some have suggested a barrier is immoral. Then why do wealthy politicians build walls, fences, and gates around their homes? They don't build walls because they hate the people on the outside but because they love the people on the inside. The only thing that is immoral is the politicians to do nothing and continue to allow more innocent people to be so horribly victimized.

To those who refuse to compromise in the name of border security, I would ask, imagine if it was your child, your husband, or your wife whose life was so cruelly shattered and totally broken. To every member of Congress: pass a bill that ends this crisis. To every citizen, call Congress, and tell them to finally, after all of these decades, secure our border."

Sure sounds a lot like President Bill.

in the bombing and charged him with 50 counts of terrorismrelated offenses, including the murder of American citizens and U.S. military personnel.

In April 2003, Pakistani officials arrested suspected USS Cole attack planner Walid bin Attash.

Yemeni authorities held Badawi until April 2003 when he escaped. In March 2004 he was recaptured but fled again in February 2006. The FBI offered a reward of \$5 million for information leading to his capture. The January 1 strike killed him while driving alone east of the Yemeni capital of San'a.

Five men accused in Yemeni court in July 2004 were al-Badawi. Maamoun Msouh, Fahd al-Quso, Ali Mohamed Saleh and Murad al-Sirouri. Abd Al-Nashiri, mastermind of the attack, was to be tried in absentia since he was detained at Guantanamo Bay. The judge also named the two suicide bombers for the first time, Ibrahim al-Thawr and Abdullah al-Misawa. Al-Nashiri was sentenced by a Yemeni court to death though still in American custody.

On July 16, 2004, family members of the sailors killed filed a lawsuit against Sudan for more than \$100 million, alleging the Sudanese government provided support that enabled the al Qaeda attack. On March 14, 2007 US District Judge Doumar found Sudan liable for the USS Cole attacks and ordered Sudan to pay \$8 million to the families.

In 2010, fifteen iniured sailors and three surviving spouses filed a federal lawsuit making similar claims against the Sudanese government. The plaintiffs accused the Republic of Sudan of funding, training and giving additional support to al Qaeda. They sought assets in Sudanese banks to compensate for the injuries and deaths.

0n March 30, 2012, the US District Court issued a final judgment awarding \$314,705,896 in compensatory and punitive damages to the plaintiffs. On September 23, 2015, the 2nd US Circuit Court of Appeals denied the Sudanese government's appeal and ordered Sudanese bank assets to be turned over to family members.




# **Dog Bite Incident Update**
