

Covillaud's Escheman Era

In the 1950s - 60s, California schools were tops in the nation. Today, California is a habitual underperformer, way below the national average, a bottom feeder of the industry. How the mighty have fallen.

Politicians and union raconteurs say it's all about the money. Government schools need more money and better facilities they say. And, schools are faced with poor children, addict parents, absentee fathers and non-English speaking households to overcome. Good teachers, but lousy parents they say.

In 1997, Doug Escheman, became principal of Mary Covillaud Elementary School founded in 1858. Located in downtown Marysville, Escheman discovered the K-5 school performing horribly. In math and reading, only 1 of 7 students functioned at grade level.

Even in 1999 on the state Academic Performance Index (API), of all state government schools, 10 being the highest, Covillaud ranked a 2. Teachers said it's due to all these incompetent kids, parents and poverty. However, when compared with schools of the same demographics, Covillaud still ranked 2. Covillaud scored 536 on the API when good would be 800.

Talk of the school was full of justifications for failure. Poor kids, pathetic parents, pitiful performance. What would you do if you were principal?

An old paperback, "No Excuses – Lessons from 21 High Performance High Poverty Schools," sits on the corner of Escheman's desk. It's been there for years.

Contrary to state and district policy Escheman moved Spanish-speaking students from segregated classrooms to learn with other children. Today, more than 45% of his students are Latino with about 37% white, 7.4% multi-ethnic and 5.6% Black.

Yes, there is American-style poverty, some homeless kids and a transient population. The school distributes \$15-30 thousand in clothes to students each year. However, the school is now rich with family-building, student-encouraging extra-curricular activities. Covillaud students are now succeeding.

Covillaud's mission statement today is "All learners will learn." In other words, no child will be left behind, for real, not rhetoric. Twice each day, for 25 minutes, teachers divert from their planned curriculum to focus on where each student is not thriving. Those weak spots are corrected. Those on task receive enrichment instruction.

Utility Times **Are Changing**

PG and E once was popular around Yuba-Sutter Counties. Most people knew the local manager. The company was very involved in the community similar to Recology (Waste Management Company) today. Then, like other large corporations they reorganized how they did business and became more aloof from

Though the state has a glut of oil, natural gas and hydropower, utility rates went way up rather than down. State global warming regulations added to the pay-more-for-less utility world. Today, some surveys show PG and E rates 60% higher than the national average.

Then PG and E got into social engineering. In November 2008 there was a measure on the ballot to create an amendment to the State Constitution stating that marriage is a union between a man and a woman. It passed with 52.24% of vote. Earlier in May of that year a majority of Supreme Court Justices had ruled that same-sex marriage was a constitutionally-protected right in California.

California first explicitly defined marriage in 1977. The Cali-



Strawberry Valley First Snow 2019

Strawberry Valley, Ca. Strawberry Valley in northern Yuba County is 3,750' above sea level. It has an annual rainfall between 80 and 86 inches and annual snowfall of 94". On Sunday January 20, 2019 they received their first snowfall of the year, 4" of snow, and year-to-date 39.76" of rainfall.

Three and a half weeks earlier On Jan. 3, California Dept. of Water Resources conducted its first snow survey of 2019 at Phillips Station, near Lake Tahoe. The survey recorded 25.5 inches of snow depth and a snow water equivalent of 9 inches, about 80 percent of average for the site. Water Resources conducts five snow surveys each winter - near the first of January, February, March, April and May - all at Phillips Station. California began 2019 with lower-thanaverage snowpack measurements — just 67 percent of the year-to-date average.

"On average, the snowpack supplies about 30 percent of California's water needs as it melts in the spring and early summer," said Michael Ander-



son, a climatologist with Water Resources. "The greater the snowpack water content, the greater the likelihood California's reservoirs will receive ample runoff as the snowpack melts to meet the state's water demand in the summer and fall."

So far this year, as of January 28th, Strawberry Valley has received 9" more rain than the same time period in 2018. California's weather is very unpredictable, you may have a drought one year and above average rain fall the following

year.

Though many consider the worst of California's drought to be in the past, forecasters warn that the Central Valley will need several averageto-wet years to fully recover. "We have not fully recovered from the drought in terms of groundwater recharge," Borgioli said. "Some areas of the Valley have experienced 5 to 6 feet of subsidence."

Next snow survey is early February.



FISHIN' TALK

My son Ted and I ventured up to Hammon Grove and left the Pickup at the last parking area. We dropped down to the Yuba River, along a marked trail, to investigate the condition of the Yuba River in regards to steelhead fishing. The water was up bit and was running on the murky side. This area would be a good bet for trout or steelhead. Both swim in this river. The rainbow trout is considered to be a steelhead when it reached 16 inches. In addition, both wild and planted fish are here. The wild fish are protected and cannot be taken at any time, but must be released immediately. You can tell a wild fish from a hatchery fish by the small fin on the fishes back near the tail. If the small membrane is clipped and therefore does not exist it is a hatchery fish. By the same token fish with the fin intact are wild and must be released. At the end of the last parking lot are signs explaining the rules and regulations, including barbless hooks and no bait allowed along with sections of the Yuba River which have different regula-

Driving into Hammond Grove past the neat barbeque and seeing Dry Creek and what was left of the concrete swimming pool wall brought back many memories at the park long before Yuba County decided to clean it up and make it a day use park. I can recall the swimming parties, the picnics and the beer busts which took place back in the 40-s and 50s. It was not unusual to see large crowds of people, most of them party goers, but a few were fishing.

I have fished Dry Creek over the years past and have had success catching a variety of fish, including catfish, smallmouth bass, northern pike, and all varieties of pan fish

such as crappie, bluegill, and sun perch and so on. In fact, back in the 40's the stream had so many catfish which ran in schools you could see them in the clear water swimming in the current, traveling from one deep hole to another. It was a beautiful sight to see.

Upstream from Hammon Grove there were several pools which ran up to ten feet deep. This was always the place to go to catch catfish for supper. However, over the years, including the floods in 1950, 1955, 1986 and 2005 the deep pools in Dry Creek gradually filled in and changed the natural flow of the stream.







Covillaud's Escheman Era

Escheman says his school is now a Professional Learning Community (PLC). The late education guru Richard DuFour stated that initiating and sustaining a PLC "requires the school staff to focus on learning rather than teaching, work collaboratively on matters related to learning, and hold itself accountable for the kind of results that fuel continual improvement."

That's Mary Covillaud today. What counts is what is learned, not what a school district says is taught. Teachers understand what students are to know at each grade level and then are expected to get them there.

with top schools but did not submit an application for state recognition. Covillaud was noted as a California Distinguished School in 2006. Between 1999 and today scores have continued to rise.

In 2018-19, Covillaud was recognized as one of only four schools north of Sacramento to be a Distinguished School and scored the highest of the four. Covillaud is also an Honor Role School meaning it is among the top 25% of all schools in the state.

Escheman says that incorporating weekly Character First training beginning in 1999 helped students focus, behave and learn. Discipline issues are minimal with only 2 students suspended so far this vear.

stress fractures in its newest old building.

On November 4, 2008 district voters agreed to borrow \$47 million to construct new buildings throughout the district. Although classrooms, gyms and playgrounds were installed in school after school, Covillaud was ignored.

In fact, you will find no 2018-19 Distinguished School banner in the District boardroom or a news release or proclamation celebrating the extraordinary accomplishment of the teachers and support personnel of Covillaud.

The Escheman era is nearly over. The guestion is how long will it take for the school to resemble the rest of the underperforming district when he retires. In the meantime, parents count your blessings with the Covillaud School staff.

Local USDA offices to reopen this week

Despite the partial

government shutdown, the U.S. Department of Agriculture says it will reopen local offices to help farmers process loan, tax and other documents. The action affects 32 Farm Service Agency offices in California. A dozen California offices had reopened last week for limited services. The rest will reopen Thursday. The USDA also extended a ing to presentations at deadline for farmers affected by retaliatory tariffs to apply for aid.

Cling-peach farmers diversify to compete

Subsidized imports from China continue to encroach on markets California canned for peaches, leading what a grower group called the state's smallest cling-peach crop in modern history. The U.S. imposed higher tariffs on Chinese canned peaches last year, but the California Canning Peach Association says that led to a spike in import volume, as buyers rushed to beat the tariff increase. Peach growers have been removing trees and diversifying crops to stay in business.

Studies show grazing, other tools can slow fire threat

Livestock grazing, prescribed burns and other land-management tools could reduce wildfire risks and bring other benefits, accorda "rangeland summit" meeting. Experts gathered in Stockton to discuss the role of livestock grazing in preventing wildfire. A University of California land-management specialist said her studies find that regular grazing, combined with other treatments, proved effective in managing potential wildfire fuels.

Wildlife authorities battle nutria infestation

Close to 400 nutria have been trapped in California since the invasive rodent entered the state last year. Most have been found in Merced County, with multiple nutria also trapped in San Joaquin and Stanislaus counties. Nutria can destroy crops and other vegetation, and can cause flooding by burrowing into levees. State wildlife officials say they're optimistic about chances for eradicating the pests, and say they've had good cooperation from affected landowners.

> A drug addict OD's and gives up the ghost, Sally gets raped and a child is abused. George is still sitting behind his oval desk, Do you think he's worried about our risks?



President Trump's Proposal on the Table!

Our local daily paper hasn't given hardly any space in their reporting of President Trump's nationwide speech this recent Saturday, January 12th, on his efforts to end the government shutdown and solve the humanitarian crisis on the southern border.

Here, in part, unedited, are vital parts of his speech:

"Just a short time ago, I had the honor of presiding over the swearing in of five new great American citizens. It was a beautiful ceremony and a moving reminder of our nation's proud history of welcoming legal immigrants from all over the world into our national family. I told them that the beauty and majesty of citizenship is that it draws no distinctions of race or class or faith or gender or background. All Americans whether first generation or tenth generation are bound together in love and loyalty, friendship and affection. We're all equal. We are one team and one people proudly saluting one great American flag.

We believe in a safe and lawful system of immigration, one that upholds our laws, our traditions and our most cherished values. Unfortunately, our immigration system has been badly broken for a very long time. Over the decades many presidents and many lawmakers have come and gone, and no real progress has been made on immigration. We are now living with the consequences -- and they are tragic -- brought about by decades of political stalemate, partisan gridlock, and national neglect.

There is a humanitarian and security crisis on our southern border that requires urgent action. Thousands of children are being exploited by ruthless "coyotes" and vicious cartels and gangs. One in three women is sexually assaulted on the dangerous journey north. In fact, many loving mothers give their young daughters birth control pills for the long journey up to the United States because they know they may be raped or sexually accosted or assaulted. Nearly 50 migrants a day are being referred for urgent medical care. Vast quantities of lethal narcotics are flooding through our border and into our communities, including meth, cocaine, heroin and fentanyl.

Drugs kill 78,000 Americans a year and cost our society in excess of \$700 billion. Heroin alone kills 300 Americans a week; 90 percent of which comes across our southern border.

Illegal immigration reduces wages and strains public services. The lack of border control provides a gateway, and a very wide and open gateway, for criminals and gang members to enter the United States, including

the criminal aliens who

murdered a brave California police officer only a day after Christmas. I've gotten to know and love angel moms, dads and family who lost loved ones to people illegally in our country. (Writer's note: **Numerous Angel Moms** recently waited in Nancy Pelosi's office lounge... but she wouldn't come out to see them)

I want this to end; it's got to end now. These are not talking points. These are the heartbreaking realities that are hurting innocent, precious human beings every single day on both sides of the border. As a candidate for president, I promised I would fix this crisis, and I intend to keep that promise one way or the other. Our immigration system should be the subject of pride, not a source of shame, as it is all over the world.

tem should be the envy of the world, not a symbol of disunity and dysfunction. The good news is these problems can all be solved, but only if we have the political courage to do what is just and what is right. Both sides in Washington must simply come together, listen to each other, put down their armor, build trust, reach across the aisle and find solutions.

Our immigration sys-

It is time to reclaim our future from the extreme voices who fear compromise and demand open borders, which means drugs pouring in, human trafficking and a lot of crime. That is why I am here today, to break the logjam and provide Congress with a path forward to end the government shutdown and solve the crisis on the southern

border. The radical left can never control our borders. I will never let it happen. Walls are not immoral. In fact, they are the opposite of immoral, because they will save many lives and stop drugs from pouring into our country. Our plan includes the following: \$800 million in urgent humanitarian assistance; \$805 million for drug detection technology to help secure our ports of entry. An additional 2,750 border agents and law enforcement professionals, 75 new immigration judge teams to reduce the court backlog of - believe it or not - almost 900,000 cases. However, the whole concept of having lengthy trials, for anyone who sets one foot in our country unlawfully, must be changed by Congress.

This includes a new system to allow Central American minors to apply for asylum in their home countries, and reform to promote family reunification for unaccompanied children, thousands of whom wind up on our border doorstep. To physically secure our border, the plan includes \$5.7 billion for a strategic deployment of physical barriers, or a

wall. This is not a 2,000 mile concrete structure from sea to sea. These are steel barriers in high priority locations.

Much of the border is already protected by natural barriers, such as mountains and water. We already have many miles of barrier, including 115 miles that we are currently building or under contract. It will be done quickly. Our request will add another 230 miles this year in the areas our border agents most urgently need.

A steel barrier will help us stop illegal immigration, while safely directing commerce to our lawful ports of entry. Many of these security ideas have been proposed by Democrats themselves, and all of them have been supported by Democrats in the past, including a physical barrier wall or fence.

Furthermore, in order to build the trust and goodwill necessary to begin real immigration reform. there are two more elements to my plan. Number one is three years of legislative relief for 700,000 DACA recipients brought here unlawfully by their parents at a young age many years ago. This extension will give them access to work permits, social security numbers, and protection from deportation, most importantly.

Secondly, our proposal provides a three-year extension of temporary protected status or TPS. This means that 300,000 immigrants whose protected status is facing expiration will now have three more vears of certainty, so that Congress can work on a larger immigration deal, which everybody wants -- Republicans and Democrats. And our farmers and vineyards won't be affected because lawful and regulated entry into our country will be easy and consistent. That is our plan. Border security, DACA, TPS, and many other things -- straightforward, fair, reasonable, and common sense, with lots of compromise.

This plan solves the immediate crisis -- and it is a horrible crisis. It is a humanitarian crisis like we rarely see in our country. And it provides humanitarian relief, delivers real border security and immediately reopens our federal government.

Whatever we do. I can promise you this: I will never forget that my first duty and ultimate loyalty is to you, the American people. Any reforms we make to our immigration system will be designed to improve your lives, make your communities safer, and make our nation more prosperous and secure for generations to come.

Thank you, and God bless America. Thank you."

Cannabis Delivery in California Headed Toward Legal Battle

In 2016, many California police chiefs and sheriffs opposed to legalized recreational marijuana use were placated by a provision in Proposition 64 that said local governments would have the right to block recreational sales.

The Ballotpedia overview of Proposition 64 reflected the conventional wisdom at the time it passed: "Local governments were also allowed to completely ban the sale of marijuana from their jurisdictions." The text of the ballot measure stated: "Allows local regulation and taxation of marijuana."

And as CalWatchdog has reported, 80 percent of local governments have declined to authorize the opening of local pot stores.

But last week, the state Office of Administrative Law approved rules crafted by the state Bureau of Cannabis Control that say marijuana sales by delivery services can operate in any community – even if local governments object.

This led to an immediate backlash – and strong hints that the rules will lead to a court fight.

"This decision puts the public safety needs of communities across the state at risk," Carolyn Coleman, executive director of the League of California Cities, said in a statement.

"We are deeply concerned with the adoption of the new cannabis regulations, which allow for the delivery of cannabis anywhere in the state. We are already having trouble enforcing a new and complex industry, and this allowance will only make enforcement even more difficult," California Police Chiefs Association President David Swing told the

Sacramento Bee.
Marijuana industry
officials disputed the

idea that the deliveranywhere ruling went against the spirit of Proposition 64 or its language. They said the ruling reflected the will of Californians, who approved the measure 57 percent to 43 percent – a 2 million vote cushion.

But even some supporters of Proposition 64 appeared unsure if the cannabis bureau's ruling squared with what the ballot measure said. Assemblyman Ron Bonta, D-Oakland, told the Associated Press that he thought only medicinal marijuana deliveries should be allowed. Bonta thinks clarifying new legislation may be in order.

Even with such legislation, lawsuits over the state regulations appear inevitable. California has decades of history of courts being asked to interpret poorly or vaguely written ballot measures approved by voters.





fornia State Legislature passed a law declaring that marriage is a "personal relation arising out of a civil contract between a man and a woman."

In 2000, voters passed ballot initiative Proposition 22 with a margin of 61%, formally defining marriage in California as between a man and a woman. Proposition 22 was a statutory change via the initiative process, not a constitutional change.

Then in 2004, San Francisco Mayor (now Governor) Gavin Newsom performed same-sex marriages in his city, which were subsequently judicially annulled. This case, and some others, eventually led to the decision announced on May 15, 2008 of the California Supreme Court, which by a 4-3 vote reversed Proposition 22. So, in the campaign

against the traditional belief of what marriage was PG and E spent \$250,000 of ratepayers' money to defeat Proposition 8. The utility monopoly supported same sex marriage.

Let's say that was a blow to PG and E's stellar image for some Californians. Then, September 9, 2010, a natural gas pipeline exploded in San Bruno, CA leveling 35 homes, killing 8 and injuring more than 50. A federal jury found the company guilty of obstructing justice by lying to regulators about its

pipeline-testing policy. PG&E was also accused of collaborating with a top state regulator (California Public Utility Commission) to find a judge who would be friendly to the company.

Since then, there have been dozens of horrific fires, hundreds of deaths, hundreds of thousands of acres burned, tens of thousands of structures destroyed, and hundreds of thousands of people displaced. Early indication is that PG and E is at fault. Meantime, customers are hit with high rates, then higher rates to absorb the damage settlements and finally the cost of evacuating and in many cases losing homes and loved ones.

In other utility news **Governor Newsom wants** to tax drinking water to clean-up some tainted water in a few areas around the state. But Jon Coupal of the Howard Jarvis Taxpayer Association said he thinks improvements for water systems shouldn't be addressed with a new tax when the state is sitting on a \$14.8 billion budget surplus.

Speaking of water and taxes, the ballot initiative banned by the board of Yuba County Water Agency was rejected because they say it would have amounted to an unlawful tax on about 100 farmers making millions off selling water. The initiative would have shared some

of the revenue collected off Agency water and power sales with all of Yuba County citizens.

Most Yuba County voters wouldn't agree that a few people "own the water" since those making millions didn't produce the water to sell. The farmers / water pumpers along with Agency leaders manipulated control and sales benefits to favor a few. Voters would believe that they indeed are being deprived of their rightful benefit (are being taxed) for corporate welfare parlayed to farmers.

Yuba County voters made the decision over 50-years back to borrow money for Bullards Bar Dam and guaranteed payment of the bonds.

The Agency is rewriting history by downplaying the election to permit the sale of bonds and minimizing the annual transfer of \$400,000 or more in property taxes (the people's assets) for 50 years to operate the Agency. The hindsight contrived argument that there was no risk with the bonds since PG and E would get the hydropower and make the payments is foolish.

PG and E nearly went bankrupt once and probably will now due to negligence and mismanagement. Thankfully, Yuba County dodged a financial bullet by PG and E paying off the bonds in 2016.



The literary arts are high on Yuba Sutter Arts' list of priorities. Yuba Sutter Arts is once again inviting high school students to be a part of its annual Poetry Out Loud competition. Poetry Out Loud was created in 2006 by former California Poet Laureate, Dana Gioia during his term as head of the National Endowment of the Arts and Yuba Sutter Arts has been involved since almost the beginning.

All currently enrolled students in grades 9-12 are eligible. The program is as simple as students selecting a poem from the online list, memorizing it and then reciting it at the competition. Poems must be selected from the Poetry Out Loud online list of 1,000 poems at www.poetryoutloud.org. Only versions of poems from the website are eligible for use in the contest. Students are sometimes additionally motivated by teachers who offer extra credit for their participation or they accept Poetry Out Loud participation in lieu of an essay assignment.

The Sutter County competition will held on Tuesday February 5th and the Yuba County competition will take place on Thursday February 7th. Competitions will be held at the Burrows Theater, 630 E Street in Marysville starting at 6pm with pizza for all. The two county champions will go on to the state finals at the Capitol in Sacramento on March 10th and 11th.

Our first-place winners for each county will receive \$150, second place winners will receive \$75 and third place winners, \$50 each. The California State winner will receive \$200 and an all-expense paid trip to Washington, D.C. in April to compete at the National Finals for college scholarship funds.

This year's local spokesperson for Poetry Out Loud is nationally




renowned poet, Marcelo Hernandez Castillo, who lives in Marysville. Marcelo is visiting classrooms to talk about the Poetry Out Loud program from a very personal perspective. He knows several of the contemporary poets whose works are listed in the Poetry Out Loud anthology. Marcelo is also one of Yuba Sutter Arts' teaching artists for the Jump StArts program in Yuba and Sutter County schools for at risk youth.

Poetry Out Loud judging is based on Accuracy. Physical Presence, Voice and Articulation, Dramatic Appropriateness, Level of Complexity, Evidence of Understanding and Overall Performance. Students may not use props or wear costumes during their recitations.

Another special friend of Yuba Sutter Arts and an Actor's Equity member for over 40 years, Gary S. Martinez, will be available on January 31 and February 1 and 2 to provide coaching for students who might like to "up their game" and chances of winning.
