52nd Annual Constitution Day Parade



Nevada City, Ca. Highlights of this Sept 8th & 9th weekend include a parade, Revolutionary War Living History at Pioneer Park, the Gold Country Duck Race on Deer Creek, and a free outdoor big band concert in the downtown historic district.

Nevada City's Constitution Day Parade, starts at 2 p.m. on Sunday, has been a local tradition since 1967 and is reported to be the oldest and largest Constitution observance in western America.

The parade through the downtown historic district includes marching bands, floats, antique autos, equestrians, politicians and the perennial crowd favorites the Famous Marching Presidents of Nevada City, a humorous but reverent group that portrays each U.S. president.

REVOLUTIONARY WAR DAYS!

The Delaware Regiment of the Brigade of the American Revolution will be offering living history demonstrations of Revolutionary War soldiers drilling and firing, drilling of kids with mock muskets, music by the California Consolidated Drum Band, and colonial life living history. Flag raising to music and reading of the Declaration of Independence will be at 10am each day, and activities conclude at 5pm on Saturday and 12pm on Sunday.

Caltrans Black Hole for Your Taxes

Prior to passage of Senate Bill 1, the road tax and motor vehicle fee increase, while the state doubled in population there has been a forty-year legislative resistance to spending money to maintain or add roadways and bridges in California.

The objective was to make citizens so miserable sitting in stalled traffic on freeways and dodging potholes that commuters would beg to turn-in their fossil-fuel cars in exasperation. (LA is now number one nationally in gridlock time and the state 49th poorest in road quality.)

The socialist options - well, there is no intelligent alternative offered to citizens. Luxury- priced inefficient electric cars, unworkable bus systems, and bicycling or riding a horse are choices to get back and forth to school, work, appointments and getting supplies for the family.

There never has been a shortage of money to maintain and expand what once was considered the premier road system in the country. If you heard about a shortage that is a lie.

Democrats squandered road funds on foolish social programs and government employee union demands. Meanwhile, there are many new trails, save a beetle research grants and inefficient bus and lite rail systems in the rural north state.

Who would have dreamed bureaucrats could have made the Department of Motor Vehicles (DMV) even worse, a socialist-model fiasco to waste your time and money. One DMV official advised a complaining Yuba-Sutter resident to "Just set aside a couple days and wait your turn."

State Political Controversies

Possibly the most incompetent managed entity in the state is our government. So, why would government employees continue to support their retirement funds being directed by the blundering corrupt people at CalPERS? Where is the revolution?

Maybe, employees are hoping that the lowly taxpayers will get stuck paying all these pensions regardless of CalPERS and its supporting jurisdictions going broke. Or maybe they just feel stuck with a system that came along with a career choice.

An investment consultant recently justified CalPERS losing \$500 million when selling off almost 80% of its \$2 billion forestland portfolio saying it was not "a panicked move."

Andrew Junkin of Wilshire Consulting says, "Forestland, real estate, and infrastructure make up the three components of the CalPERS \$37.5 billion real assets program, but unlike returns for real estate and infrastructure over the last few years, forestland investments have been a money loser for the system.

With all the politically correct socially sensitive types on the CalPERS investment committee it's amazing that they would invest in timber in the first place. Environmentalists who manipulate state decision-making hate the timber industry and have sued it into oblivion.

Junkin acknowledged that CalPERS's timing was "poor," buying the forestland before a financial crash, but that "you can't know in advance that the market's going to collapse." That sounds like the Marysville City Council's excuse after burying the residents \$17 million in debt by buying 5 acres of property overlooking Ellis Lake.

Too bad government employees can't take their money out of CalPERS, but that's the problem. The money really is not there and does not belong to them. Once retired, they just get checks until they die. And cities, counties etc. have not fully funded the pensions because they don't have the money to cover their commitments to employee unions. Oh, the unions control CalPERS as well.

Essentially, employee unions have open access to the wallets of taxpayers. They get what they want from politicians, manage or mismanage the pension fund and demand what they wish from vested jurisdictions like Yuba-Sutter Counties and their cities when CalPERS falls short of funds.

In other state news, the chair of the California LGBT (Lesbian, Gay, Bi-Sexual, Transgender and now Q for questioning) Caucus recently introduced a bill to outlaw Christians and others with a Biblical view of sexuality from helping people with unwanted same-sex desires or gender identity confusion. It passed the Senate.

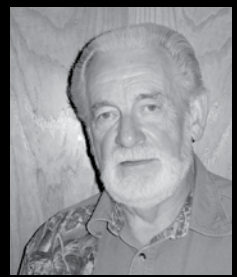
Our students participate in College Teams which provides an opportunity for our eighth graders to establish mentor roles and leadership skills as they participate in monthly planned activities to support school collaboration.

FISHIN' TALK

Everyone has been enjoying the cooler weather which includes the fish that swim in local low level reservoirs. Some bodies of water have the trout back on the bite which includes Collins Lake near Browns Valley. In regards to the cooler weather...we contacted our weather source and he advised to expect the cooling trend to stay with us until around Labor Day, and then expects warmer conditions. We could have temperatures close to three digits in September and into October.

We have reports of kokanee salmon being taken at Lake Tahoe with limits available. In addition, the fish are running larger than normal with one fish reported to be a 20 incher. This is huge compared to the usual size of land locked kokanee salmon which range from 12 to 14 inches.

We remind all who fish and those who do not about the free fishing day coming up on September 1st. The Department of Fish and Wildlife (DFW) allow several days a year when you do not need a license to fish. So if you have a friend or relative who is curious about fishing but does not want the expense of a license, this would be the way to go.

The DFW planted trout last week in Butte Creek, Upper Susan River, Halsey Forebay, North Fork of the Feather River and Deer Creek. Halsey Forebay is located in Placer County. The Feather River was planted near Lake Al-

manor. The Susan River is located in Lassen County near the town of Susanville.

Salmon can be found all over up and down the Sacramento and Feather Rivers. As they move up river there will be hot spots. The fish will be in a certain area one day and gone the next as they head up to spawn. Salmon are different from Striped Bass. The stripers come up, spawn and then return to the ocean. Salmon come up to spawn and then they die so there is no returning fish to bend your pole. Both these fish can travel miles a day until they reach the area where they were born. Here they will spawn and stay around to protect the eggs, then as stated above will die.

This is the time of year when the Kokanee salmon start to change color as they prepare for the annual spawn. These land locked salmon will swim up a stream or river which flows into the lake or res-

ervoir to lay their eggs. Both male and female fish leave the waters of the lakes and reservoirs; enter the streams, never to return to the deep water from which they came. As with their cousins the King Salmon, they also will die after the spawn.

Closing thought: "The greatest remedy for anger is delay."

a car. There was much bureaucracy to survive and then all the money was paid in advance. So it was in those days in Communist nations. Lots of questioning, long waits, little money and pay in advance.

As the Soviets tell the joke, the auto purchaser puts down his money, signs the papers and the bureaucrat then says, "OK, your car will be ready in ten years." The excited new owner asks "Morning or afternoon?"

The bureaucrat then says, "Well ten years from now, what difference does it make?" The car buyer answered, "The plumber is coming in the morning." So goes the "golden state."

State Senator Moorlach wrote Bill X1-9 to make Caltrans operate more like other states, able to contract out up to 50% of architectural and engineering services (It's a 10% limit now). Caltrans administration costs are 5 times more

and road repairs 2.5 times more than other states. The engineers' union defeated the bill.

A 2016 study for the American Council of Engineering Companies found that contracting out highway construction is a huge savings. The cost for one year of employing a government design team member was \$349,734, compared to just \$262,866 for a private firm. Potential savings: \$86,868 per employee. So if 500 new positions are filled at Caltrans, hiring private contractors would save \$43.4 million a year. And combining this study with the 3,500 in "overstaffing" found by the Legislative Analyst's Office in May 2014 and that's \$1.22 billion wasted.

And who can forget the state auditors' list of abuses at Caltrans that included one employee playing golf for 55 days, and his supervisors approved his time sheets.

Now, Gov. Brown is using your increased road taxes for pay raises (road designers, planner and project managers.) A two-year agreement with Professional Engineers in California Government

(PECG) includes general wage increases of 4.5 percent immediately and another 4 percent July 2019.

In addition, the engineers with 20-years of experience and up are in line for a series of extra longevity raises to keep them around.

The proposed longevity increases are 2 percent for engineers with 20 years of experience or more as of July 1, 2018; 3 percent for engineers with 21 years of experience or more as of July 1, 2019; 4 percent for engineers with 22 years of experience or more as of July 1, 2020; and 5.5 percent for engineers with 23 years of experience or more as of July 1, 2021

These changes will cost \$93 million in the current budget year, and \$171 million next year. An overstaffed Caltrans is now understaffed according to Gov. Brown.

If this all sounds too much to handle the options are move out of state or vote to repeal the increased road and DMV costs. Vote Yes on Proposition 6 on November 6 to repeal.

Predicting the Stock Market

The movement of stocks is everything but a science. Technical analysts point to charts and graphs claiming the history of stock movements illustrated as patterns will forecast what a stock may do in the future. Based not on fundamentals such as how a company is doing, but relying more on a keen eye for comparing what stocks may have done in the past, they believe this will forecast what will happen in the future. This historical analysis may not only predict a particular company's stock movement but may also be applied to a group of stocks or perhaps even a particular geographical market.

So say the technocrats.

What I call the "Macro" guys don't care about charts but rather what is going on in the world of money and politics and basically anything that could affect the planet and the people living on it. These folks just say "As goes the world so goes the markets". Of course some of these analysts took it in the shorts when Trump got elected thinking if the Donald won, the world and hence the markets would come to an abrupt end. Well the only thing that ended was the markets "go nowhere" bias and it screamed upwards almost nonstop since the election.

Still other analysts peruse over a company's

financials and predict how business will be and hence draw that conclusion out to the price of its stock.

Certain stock gurus might look towards the future as to what industries or geographical areas might be possibly coming into a cyclical hot streak and which might be falling out of favor in the eyes of the wholesale investor.

Other analysts might look at the amount of money flowing in or out of a sector or geographical region and some eyeball what the Federal Reserve is doing and then draw their conclusions from there.

Computer programs are written to forecast stock movements and are often used by some as their crystal ball.

Then there is "high frequency" trading, which some call technically cheating. High frequency trading is rumored to front run stock orders electronically using massive computers, basically seeing orders in milliseconds mid-stream. Then based on some mathematical quant's algorithm, go into hyper drive and cut in line sort of speak, hoping to catch a few fraction of a penny's worth of profit by gaming the system. It's all part of the fact-versus-rumor mill of course.

Who really know what goes on in the trading rooms of the huge conglomerate money firms?

Some might even chalk up stock decisions based on the month, the cycle of the moon, an alignment of celestial bodies or even numbers on a wooden cube (yes I personally saw this method used once).

No matter what the method or the math, the truth is markets do not react scientifically nor predictably. The day to

day movements are only the sum of all the players and their perception of whether it is a good day to buy stocks or sell them. Being an extremely large group of course, much like a herd of animals, they can meander peacefully one day and stampede in all out fear the next.

So goes the mentality of the herd. Predicting what they will do and where they will go is impossible, and only when it happens will we know the outcome in hindsight. As to market foresight however, it's the holy grail of stock prognosticators, and so far, nobody has found it.

Bail Reform Will Make Criminal Justice System Works

Says Former Chair of Board of Prison Terms

Senate Bill 10 (Hertzberg), a bill to eliminate the current money bail system, passed both houses of the Legislature and is on its way to the Governor's desk for his consideration. Senator Jim Nielsen (R-Tehama), who served as Chair of the Board of Prison Terms, issued the following statement:

"This is a stay-of-out jail card.

"The current bail system serves as an incentive for those accused of a crime to appear before a judge. Without a bail system and the fear of being tracked down by a bail bondsman, what is the motivation for anyone to appear in court? And what standard will be used to determine whether the accused is a flight risk?

"This measure, if signed into law, will result in a worse system where victims and their loved ones will not get the justice they deserve.

"Criminals will thumb their noses and dismiss court orders. With our criminal justice system already weakened by AB 109, Proposition 47 and Proposition 57, this bill will further deteriorate our public safety.

"With parole supervision virtually eliminated, bail agents are the only boots-on-the-ground supervision for most convicted felons.

"Under realignment reform, burglars receive nothing but a notice to appear, with little to no consequences if they do not show up in court.

"The effect is no justice, and criminals are free to continue victimization."

Gallagher Joins Petition

to Stop the State Water Grab

Assemblyman Gallagher (R- Yuba City) is joining state and federal bipartisan legislators, valley farmers, and North State Farm Bureaus in an effort to stop the State Water Resources Control Board from cutting water supplies to agriculture.

"This dangerous "Water Grab", that could cripple the farming economy, is possible because of the unaccountable and un-elected bureaucrats and their radical policies that do not take people into account, and is why we are seeing our water infrastructure crumbling. If they can take water in Stanislaus, Merced, and Tuolumne, they're going to do it to us in the North State. We need to be together and we need to be united," Gallagher stated at a rally on Monday.

The fight over this watershed is the first of a two-

part proposal. Later this year, the board will release a companion proposal to redirect portions of the Sacramento River watershed's supply to benefit fish and other environmental purposes. The two proposals could mean historic changes in how water is parceled out in a state that has faced many water management challenges.

After mounting pressure highlighted by a rally on the steps of the Sacramento Capitol building on Monday, the board has decided to postpone their decision. However, if approved, this proposal will not only lead to farmland being taken out of production, but it could also negatively impact local and rural economies and the industries that support them.

In an effort to permanently stop this decision, a petition campaign is underway to tell the water board to protect the water supply for families, communities and farms over environmental needs.

have had incidents of vandalism one of which occurred this past week of August 11-August 18 in which someone broke in to the kiosk on the property and stole tools and staples which were utilized in the operation of the Market and the Snack Shack. We have also had the dish soap used to wash dishes for the Snack Shack sprayed on the deck and stairs of the same on another occasion. Our pump house doors were left open and the hot water tank drained in another past incident. We have had to chain the doors up as a consequence.

It does not matter so much who did these things or what was stolen. The crux of the matter is that someone lacks integrity and respect for the community as they have no idea what their actions cause. They fail to realize that the Market is there for the use of the WHOLE community, and as such, fail to see the responsibility that YFACA has undertaken in operating the Market. Their actions demonstrate a lack of community re-

sponsibility.

With the above said, we are asking you in the community who can understand what such responsibility entails to help us in having the incidents described end. We are asking that when passing by the Grove in your travels on Marysville Road in Dobbins to keep an eye out for suspicious behavior which we believe occurs at night. If you happen to notice suspicious behavior, inform the Sheriff's Department. The Sheriff's Department has already been alerted about this latest and past incidents and check on the Grove on their regular drive-bys in the area.

Finally, if anyone knows WHO has been committing these actions, PLEASE inform them to quit their actions. YFACA is not out to prosecute anyone. We just want the incidents to cease.

Fleeing the Flock?

August 1, 2018, Judge Kimberly Mueller, United States District Court for the Eastern District of California, denied two motions filed by Citizens for Fair Representation (aka State of Jefferson) against California Secretary of State Alex Padilla.

While the State of Jefferson movement remains in limbo, the State of New California movement is actively proceeding forward in compliance with Article IV, Section 3, of the United States Constitution, which states: "New States may be admitted by the Congress into this Union, but no new State shall be formed or erected within the Jurisdiction of any other State, nor any State be formed by the Junction of two or more States, or Parts of States, without the consent of the Legislatures of the States concerned as well as of the Congress."

Founded by former State of Jefferson supporters, "New California is a new state in development by egregiously aggrieved Californians exercising our Constitutional right to form a new state separate from the tyranny and lawlessness

of the State of California."

After being informed two of SOJ's latest motions were denied August 1 and seeing nothing publicly reported, Paul Preston, president of the New California State movement, wrote an article, "Jefferson Fail: New California State Only Option to Become 51st State: Jefferson 3-Judge Panel Thrown Out," which he emailed to New California supporters at 7:25 a.m. August 18 and posted to New California State's website www.newcalifornia.state.com. I shared the article on Facebook. In response, Richard Power, an attorney working with the New California state movement, posted the following comment:

...there were two orders. The first denied the plaintiffs' motion for a 3-judge court. The second denied the plaintiffs' request for a stay. There has been no dismissal yet although I think the judge is warming up to that and probably just hasn't had the time to draft the ruling. The Jefferson leaders are just trying to collect money, which has basically been the whole idea all along.

Without going into a lengthy legal explanation, the 3-judge court motion was denied because the complaint does not allege facts sufficient to show malapportionment. The complaint is just a bunch of nonsense cobbled together and thrown out there as an excuse to fleece the flock.

Fleeing the flock is exactly what some of us who were part of the State of Jefferson (SOJ) movement suspected when we broke away from SOJ. Rather than welcome help and any opportunity to free us all from California's lawlessness and tyranny, SOJ's unelected, self-appointed leaders outrageously disparaged and fought against the New California State movement. If freedom and representation are SOJ's goals as they claim, why do they fight the only movement adhering to the Constitution to get us all there?

At 12:05 p.m., August 18, 2018, SOJ (admin@soj.net) sent another fundraising letter. There was NO mention of the judge denying their motions for a three-judge panel and for a stay.

State Political Controversies

Assemblyman Evan Low's AB 2943 declares "advertising, offering to engage in, or engaging in sexual orientation change efforts with an individual" as illegal under state's consumer fraud law. It must pass the Assembly by August 31.

Dave Bryan, pastor of Church of Glad Tidings in Yuba City published the following statement concerning AB 2943 in defense of the US Constitution and the 1st Amendment to the US Bill of Rights:

"As an ordained Christian minister of the Gospel of Jesus Christ, I stand with all other true Americans in defending the First Amendment liberties granted by the US Constitution and Bill of Rights as the Supreme Law of these United States; guaranteeing that 'Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.'"

"Furthermore, we will stand with any and all American citizens in the defense of this fundamental American right to express our wide and varied beliefs without State control or censorship, so long as these sundry religious

expressions are not commonly deemed to be detrimental to the well-being of the community or to specific individuals within the community.

"We are always and forever committed to the defense and preservation of these ideals."

"While this affidavit applies widely to all matters of governmental control over religion, of particular interest just now is the anti-American, anti-Christian AB 2943 recently passed by 25 of the 26 democrat Senators prohibiting the church to counsel anybody of any age regarding sexual iden-

tity disorders or gender confusion. This is both unconstitutional and unconscionable for genuine authentic Christian leaders, and demands a response from freedom loving Americans."

"We will not comply with the unconstitutional and unconscionable California AB 2943 that clearly violates the long-held American values of freedom of speech and freedom of religion; but will instead resist this attempted breach of Constitutional liberty in every way and by all means possible, without compromise or reprieve."

Alpha earns, two out of five, Bone Setting Monkeys. Subtitles abound in this film, as well as long scenes of walking. There are some nice action scenes and the writing is weak, with lots of missed opportunities to build and delve into a fresh new world with beautiful vistas and almost compelling situations. How does one know how to set a broken bone and not light a fire in this world? A bit more time on the story board to improve the flow of the film would have helped tremendously. There are some truly beautiful shots that are impressive to see on the big screen.

Walnuts Hold Top Crop Position in Yuba County; Prunes Rebound

Marysville, Ca. The increased value of walnuts and a rebounding prune harvest led the way to an 8 percent increase in Yuba County crop values during 2017 over the previous year, according to the just-released Crop Report from the county's Agricultural Department.

The gross value of Yuba County's agricultural production for 2017 is estimated to have climbed to just over \$231.7 million. The estimate for crops during 2016 was just under \$215 million, in a year that saw significant crop failures for prunes.

"Walnuts continue to be the strongest crop product for Yuba County, with about a \$74 million value in 2017," said Yuba County Ag Commissioner Stephen Scheer. "Our region enjoys a very strong and supportive collection of farms and ranches that work hard throughout each year, in an industry that sets the pace for Yuba County's economy."

Despite a slight dip, rice maintained its position as Yuba County's number two crop, with a value of \$37 million. Prunes saw the most dramatic increase; jumping from a value of about \$25 million in 2016 to

\$33.6 million in 2017. Peaches rounded out the top four crops with nearly \$23 million in value.


Among some of the ranching product, milk values increased by nearly \$2 million between 2016 and 2017,

while the price for cattle and calves dropped by a little more than \$1.4 million.

Water board holds hearing on river proposal

Farmers, elected officials and environmental representatives overflowed a Sacramento hearing room Tuesday to comment on plans to redirect water in Central California rivers. The State Water Resources Control Board proposes to dedicate more water to fishery restoration. Farmers and other Central Valley residents

say the board proposal would not help fish but would punish people--a point they made at a rally at the state Capitol Monday.
Controversial "waters" rule returns in California
A disputed federal rule governing "waters of the United States" has come back to life in California and 25 other states. The rule would expand federal agencies' jurisdic-

tion over both water and land. A judge in South Carolina sided with environmental groups in partially reinstating the rule. On Tuesday, groups led by the American Farm Bureau asked the court to stay its ruling, pending appeal.
Study shows how agriculture boosts regional economy
One of every five jobs in Northeastern California can be linked to agriculture, according to a new study by California State University, Chico. The university's Agricultural Research Institute says farm and ranch production adds more than \$4.7 billion in economic activity in the 13-county region. The top crops grown in the northeastern region include almonds, walnuts and rice.

Malakoff Diggins State Historic Park CELEBRATES FRENCH HERITAGE

On Saturday, September 8, 2018, from 11 am-4:30 pm, the Friends of North Bloomfield & Malakoff Diggins and California State Parks, 23579 North Bloomfield Rd., Nevada County, California, will jointly commemorate the French heritage of the park in a delightful small-town festival. Cost: \$5 Day-use fee. Food and beverages will be available for purchase at the event. You may bring a picnic blanket, re-usable beverage container, beret (optional).

Attractions include French-themed music performed by Nevada County favorites Beau-coup Chapeaux, a reprise of the enchanting

original marionette play, "How Malakoff Got its Name" by the Theatre of AWE, a guided tour of North Bloomfield's French heritage, including the historic cemetery, locally sourced picnic-style food, beer, and wine, and a raffle with a grand prize of a week's stay in a small villa on the French Riviera (Villa La Grisette, in Vence, Donated by Dr. Claudine Chalmers).

Research has revealed that the French influence at Malakoff Diggins State Historic Park was widespread. Entrepreneurs designed massive water systems and hydraulic ventures, opened hotels and businesses, and planted gardens.



They dominated the local scene at the Park for 15 years, laying the groundwork to the nation's biggest hydraulic operation of the day, the North Bloomfield Gravel Mining Company, which was commonly called the French Company for years. The Malakoff Mine be-

came so large that it was the defendant in the famous federal lawsuit that handed down the Sawyer Decision (1884), the renowned injunction against the laissez-faire practice of polluting waterways.

Malakoff's French Connection II Festival commemorates those French and French-Canadian pioneers responsible for much of the early technological and cultural developments at the Park in a festive, lively gathering open to the public.

Malakoff Diggins State Historic Park is located 26 miles northeast of Nevada City, nestled in the western foothills of the Sierra Nevada. Within the Park's roughly 3,200 acres of forested hills, lakes, dramatic cliffs, and historic buildings lies the exciting and significant story of the nation's largest hydraulic gold mining operation and the nation's first environmental regulation.

Today the Park is of-

ten characterized as a place of peace, quiet, and solitude, an ironically drastic shift from the destruction and devastation that created it. Popular activities

include historic town tours, hikes through scenic diggings, mountain biking, camping, fishing, and photography.

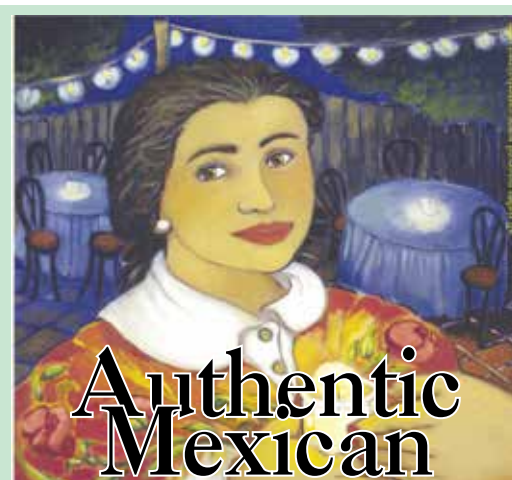
