## Picnic Time at Empire Mine 123 Years Young

The first Miners Picnic was held on June 5, 1895. Hosted by the Mine Workers Protective League, the event helped raise money for miners' widows and orphans, as well as injured and out-of-work miners. It was such a significant event in those early years, local businesses and mines closed for the day so everyone could attend. Today the event is hosted by Empire Mine Park Association (EMPA) to celebrate local gold-mine history.

"Okay, maybe businesses don't close today," event chair Steve Sanchez said, "but for many local and out-of-town visitors, the Miners Picnic remains one of Nevada County's annual highlights. Each year we try to keep its old-time character, while we find new ways to make it special, fresh and fun."

New for 2018 will be a beer garden near the Clubhouse. "We've not had this for a number of years," Sanchez added, "but on a warm August afternoon, what's more refreshing than a cold beer in a shady

garden?" Besides beer, visitors may purchase food, snacks and treats from local vendors, including Lazy Dog Ice Cream and Cornish pasties (a favorite miners' lunch). Miners Picnic is one of the few times a year the public may also bring their own food, blankets and chairs, and picnic on the stately grounds inside the Park.

A nail-biting mine rescue reenactment is scheduled for noon in the Mine Yard, and everyone's encouraged to cheer on the old-time rescue vehicles racing to save the injured miners. World-renowned Izzi Tooinsky is scheduled to perform his juggling-and-history show on the Clubhouse stage at 1:15 p.m., followed by local band Midnight Acoustic who will be making their debut appearance at the mine. "There's an impressive array of entertainment," Sanchez added, "including magic, Dixieland jazz, a barber shop quartet and more. We even have a group of donkeys and their mini-horse friend all

dressed up to go prospecting. They're a big hit with everyone, especially the children." There's also the traditional Cakewalk, plus raffle prizes and a silent auction with a tempting assortment of items that includes a ride to school on a fire truck." To add to the history, Empire Cottage, the old Clubhouse, the Blacksmith Shop and Gift Shop are scheduled to be open. Visitors will also appreciate the vintage cars on display. "It's an action-packed day," Sanchez emphasized, "and it's best to arrive early, as visitors won't want to miss a thing."

The 123rd Miners Picnic takes place at Empire Mine State Historic Park on Saturday, August 25th, with special activities from 11:00 a.m. to 4:00 p.m. Parking's free – and everyone's invited. Phone (530) 273-8522 or visit <http://www.empiremine.org> for further details.

year-old William Austin Simpson of Danville was arrested for 11360(a)H&S/Transport of Marijuana to sell, 11359H&S/Possession with intent to sell, and violation of probation. 26-year-old Samantha Ragsdale of Santa Cruz was arrested for 11351H&S/Possession of a Controlled Substance for Sale

## Measure K's Dirty Secret

Yuba County officials have been paying hundreds of thousands of tax dollars for marketing firms to convince citizens by phone and mailer surveys to pay more taxes.

However, the solicitors neglected to ask this question. County employees make 2-3 times more than you do and will retire collecting most of that pay for the rest of their lives. Would you support paying more taxes for that to continue?

In fact, the November 6, 2018 ballot argument for the Measure K sales tax increase never mentions the financial tsunami of employee spiking pension and health costs. The very dysfunction driving the county into insolvency is suspiciously missing.

In 2015, Stanford University's Pension Tracker found every Yuba County household owed \$14,490 each if the pension debt was spread equally to pay for county retirees that year.

The number of government employees along with their pay, pensions and health benefits are out of control and officials at every level of the national bureaucracy have lost their voice. Unions have them by the short hairs.

Steven Greenhut writes, "This is a state where police sergeants routinely earn total compensation packages in the \$250,000 to \$350,000 range and retire at age 50 with 90 percent or more of their final years' pay. Many University of California employees earn more than \$1 million a year and median firefighter compensation tops \$175,000. State employees earn medical packages that would be the envy of royalty everywhere. Then there are those myriad pension-spiking gimmicks (such as allowing managers to earn special pay for 'management' duties)." By the way, many executive employees pay nothing into their pension plans. They hit the lottery without even buying a ticket or driving to the store.

At a California Public Employees' Retirement System (CalPERS) hearing where city officials from across the state came to

The Woodson Bridge area, located on the Sacramento River, has been a good spot for salmon as well as at Verona. Fish have also been caught on the Feather River both above and below the rapids near Yuba City.

We have reports of striped bass being caught in the Delta, with most fish being on the small size. Large Mouth Black Bass are also being taken here with fish ranging up to 6 pounds.

The Mackinaw Lake Trout at Lake Tahoe are being taken with some up to 15 pounds. Kokanee are also cooperating with anglers with fish up to 3 pounds. However, smoke is a problem.

The trout at Collins Lake are once again off the bite. The warmer water has bass, crappie and catfish cooperating.

Trout fishing at Boca Reservoir has been good early in the morning and late in the evening. We were told fishing during the daytime is a waste of time.

Shore fishing at

Donner Lake has improved for trout after the Department of Fish and Wildlife planted a bunch of catchable trout there.

We have a report of king salmon in Lake Oroville. Anglers have been coming in with limits of fish. Find what depth they are hanging out in and bingo.

All of you out there who fish for salmon are reminded of the one fish limit this year.

Reports tell us Folsom Lake is holding its water. Expect the reservoir to be about the

same until after Labor Day which will bring shallower water as the reservoir drops.

Rainbow and brown trout are being caught at Lake Almanor at this time. Trolling is the best bet and fish finders are a necessity to locate the fish. Both these species get big in Almanor and it is not unusual to catch them in the 6 to 10 pound range at different times of the year.

Closing thought: "Yard by Yard, life's awful hard, but inch by inch, it's a cinch."

describe their plight one representative expressed concerns about bankruptcy, and another noted that in 10 years pension costs will consume 94 cents of every payroll dollar in his city. Maybe it's time for each household to get a 5 gallon can of asphalt patch to fill cracks in front of their residence.

Did some public employees ever imagine they would retire as millionaires? LA Deputy Police Chief Earl Paysinger retired after 33 years of service cashing out with \$1,473,823.20. LA Assistant Fire Chief Emile Mack (33 years) was paid \$1,457,638.62 in 2016 to stay home. Statewide there were nearly 700 retirees collecting more than a half a million. That year, there were more than 8.6 million state pension records found by Transparent California. And, nearly 62,000 retirees were collecting 6 figure incomes.

In 1999, there was a pay and pension increase frenzy retroactive to the start of employment as local governments caved in to union pressure. The legislators also passed a union-backed law (SB 400) raising the pension multiplier to 3% (times the number of years of service) that "CalPERS promised wouldn't cost taxpayers a dime."

It didn't cost a dime but rather billions of dollars. Yuba County taxpayers do not recall being asked for their opinions via survey prior to the Supervisors' vote on the pay and pension increases.

The entire government

pay and pension debacle can be traced to politicians and unions. The citizens have been shafted by unions promising to elect politicians and by politicians promising to reward union pay contracts. It works beautifully for government workers and politicians. However, like British Prime Minister Margaret Thatcher liked to say, "Socialism is great until you run out of other people's money."

Usually when a marketing campaign is fear-based like the Measure K effort you should be suspect. Proponents are hiding something, in this

case the real cause. An honest Measure K would have pitched a sales tax for higher pay, pensions and health costs that few of those paying the bills enjoy. The answer would have been no.

However, with most people being fairly ignorant of ballot measures when voting and with government people bullying and silencing the business community there are good odds for passing Measure K. If it does fail, Supervisors will use more tax dollars for another campaign at the next election cycle.

## United Way "Cash for Food" Drive Totals

Local food closets serving community members in need and the Yuba-Sutter Food Bank will benefit from a highly successful first-time Yuba-Sutter-Colusa United Way "Cash for Food" drive held locally this summer.

Traditionally, outlets providing food to individuals and families in the three-county area hits a low point in inventory each summer. In years past, the local United Way has held a traditional food drive which last year raised 35,000

in food.

This year, a new program was launched, designed to collect cash donations so that the local food closets and food bank could purchase the nutritious foods they need to fill in gaps in their inventories.

So, thanks to 93 individuals and business donors in Yuba, Sutter and Colusa Counties, the drive topped its goal and brought in \$15,541! The largest single donation being \$5105 from the Grocery Outlet store's annual "Independence

from Hunger" drive in July. Other large donations came from the Peach Bowl Lions Club, Yuba County employees, Colusa Casino Resort and employees of Sierra Central Credit Union.

100% of the funds will go to 11 local food closets in Yuba-Sutter and Colusa counties and to the Yuba-Sutter Food Bank to provide as much as 81,000 pounds of food to people in need. Y-S-C United Way covered all of the costs of running the drive.

## Senate Republicans Split Over Welfare Reform

*Excerpts from Washington Examiner.*

Senate Republicans are battling over whether a bill reauthorizing the nation's food stamp program should boost work requirements for recipients.

The Senate-passed farm bill reauthorizes agriculture and nutrition assistance programs for five years. But the legislation does not include House-passed changes to the Supplemental Nutrition Assistance Program, otherwise known as food stamps, that would broaden work requirements and make it more difficult for states to waive them.

Senate Majority Whip John Cornyn, R-Texas, on Thursday called on negotiators working on a House-Senate compromise to include the work requirements in the final version, going against Senate Agriculture Committee Chairman Pat Roberts, R-Kansas.

"I think having the work provisions is really important," Cornyn told reporters Thursday. "Able-bodied people, people who can't work, can train, can do community service. People who can't should be exempted from that. I think the House got that right."

## George Soros Kicked out of Hungary, Pumps 3 MILLION into New York Times

A press release got past us (Unbelievably... being so political) a couple of months ago on June 15th when a New York Times announcement will probably mean more hard left leaning from their reporting and editorial desks. It came from "yournewsline.com" at the New York Times.

It reads... Billionaire (actually Multi-Mega Billionaire) George Soros plans on making the New York Times an even louder mouthpiece for his globalist propaganda by buying up another \$3 million in shares.

Even though Soros already owns a large share of the Times, his latest purchase will see his influence infiltrate every inch of the newsroom.

Rt.com reports: According to a filing to the US Securities and Exchange Commission (SEC) in May, the shares are worth \$3,046,000.

According to the same filing, Soros also invested money in Tribune Media Company and in Time Warner Inc.

Soros Fund Management is the company that Soros uses to spread his wealth around. Soros Fund Management actively invests in stocks, bonds, commodities, currencies and, as the New York Times reported recently, the Triple Crown-winning racehorse Justify.

Soros' latest purchase marks the first time in over a decade that the billionaire has sunk money into the New York Times. In 2007, Soros bought \$470,000 worth of shares in the newspaper.

Dan Gainor, vice president of business and culture at the conservative Media Research Center, told the Washington Free Beacon that it would be "naive" to disconnect Soros' investment from

his views.

"Soros has long had influence or given direct funding to a wide range of journalism operations from NPR to ProPublica," Gainor said. "This is still a big step to be buying a \$3 million stake in the top liberal outlet in America."

After throwing more than \$10.5 million into Hillary Clinton's failed election bid in 2016, Soros has also made no bones about his desire to see President Donald Trump—who he recently called the "ultimate narcissist"—impeached and removed from office. Trump's victory reportedly cost Soros almost a billion dollars on the market.

Since Trump's election, Soros has taken to sponsoring leftist candidates in district attorney races across the country, in a bid to reshape the American justice system in his own progressive image. After donating \$50 million to the American Civil Liberties Union in 2014, he has spent over \$9 million funding candidates in 14 cities. In San Diego alone, he spent \$1.5 million propping up Democrat Genevieve Jones-Wright's unsuccessful campaign.

Soros' Open Society Foundations project began in 1979. The organization now enjoys an annual budget of over \$940 MILLION and operates in over 100 countries across the globe, with 26 national and regional foundations and offices.

Soros was accused of meddling in British politics when it emerged last February that he had donated almost \$700,000 to the pro-EU lobby group, Best for Britain...against BRITAIN...that won!

In April, Judicial Watch released a report detailing how the Obama administration, in concert with Soros, spent at least \$9 million of US taxpayers' money to fund a political reform campaign in Albania.

Soros is a business-

man and "shouldn't be receiving taxpayer support to advance his radical left agenda to undermine freedom here at home and abroad," Judicial Watch President Tom Fitton said in a statement.

The billionaire's image as a human rights campaigner and philanthropist has not been well-received in his native Hungary. The country's Prime Minister Viktor Orban has been an outspoken critic of Soros and his Non-Government Organization (NGO), accusing the billionaire of meddling in Hungary's internal political affairs by funding opposition groups. In May, the Open Society Foundations announced that it would end operations in Hungary, claiming to be the victim of a "repressive political and legal environment."

In February, Orban's Fidesz party submitted a bill to parliament called the 'Stop Soros Act,' which would curb immigration and would also affect foreign-funded NGOs. The bill says that all NGOs that "support illegal immigration" need to be registered, while any NGO that gets money from abroad must pay a 25-percent tax.

Before dabbling in American politics, George Soros made a fortune 'shorting' Great Britain's pound sterling, which resulted in the currency's collapse in 1992. In his native Hungary, Soros has been accused of tampering in internal affairs and pushing pro-immigration policies to destabilize Europe.

What is Yuba City Plan to Provide Police to Walton Area of Yuba City?

Yuba City council candidate Dave Shaw is the only candidate I know who is ready to push hard to bring Police Service to the Walton area. This is a valid area of Incorporated Yuba City since 2001. The results of annexation vote is over and done by two months already. Not a word officially about how Yuba City will meet its obligation to the Walton area. It seems as if Council Member Stan Cleveland and John Buckland are forgetting there a great many voters in the Walton area. Those Walton area voters will make their choice crystal clear on November 6 who they expect to deliver on the city promise of Police service for Walton residents.

letter to the board, Sheriff Durfor advised he would be retiring and the end of August, approximately 4 months prior to the end of his final term.

As mandated by Government Code Section 25304, the Board of Supervisors must fill the upcoming Sheriff-Coroner vacancy with an appointee to fulfill the remainder of the office's term. At the recommendation of Sheriff Durfor and in consultation with County Administrator Robert Bendorf and the Yuba County Counsel's Office, it was recommended to the board in

Agenda Item 720/2018 that they appoint Sheriff-Elect Wendell Anderson to fill the remaining term upon Sheriff Durfor's retirement.

The Board of Supervisors approved the recommendation of staff and voted to appoint Sheriff-Coroner Elect Wendell Anderson to assume command as Yuba County Sheriff-Coroner on September 1, 2018 and until the official beginning of his elected term January 7, 2019.

## Yuba Water Agency Over \$110,000 in Grants

Marysville, Ca.

Yuba Water Agency this week granted more than \$110,000 for design work on the Marysville Ring Levee, new equipment for local fire departments and law enforcement, and to support a local duck egg salvage program.

These grants support Yuba Water Agency's missions and objectives by funding the following equipment and services:

### Design work for the Marysville Ring Levee project for the City of Marysville - \$91,000

This grant will cover the costs of the design work the Marysville Levee Commission needs to keep the Marysville Ring Levee project construction on schedule.

The U.S. Army Corps of Engineers, the lead agency on the project, requires the relocation of pipes that run through the levee near the City of Marysville's 17th Street pump station, which is a drainage facility that is used when it rains.

USACE has agreed that the drainage facility is a project cost, but do not have the resources to perform the design and requested that the city provide a design that meets its requirements.

This grant supports Yuba Water Agency's mission of flood risk reduction by funding critical work on the ring levee necessary to continue on the next phase of construction. When the ring levee is complete, Marysville is expected to have the highest level of flood protection for any urban area in California.

### AEDs for Smartsville Fire Protection District - \$5,000

This grant will fund three automated external defibrillators for the Smartsville Fire Protection District as a part

of the Bill Shaw Rescue Equipment and Training Grant Program.

An AED is a portable device that delivers an electric shock through the chest to the heart and can potentially stop an irregular heartbeat and allow a normal rhythm to resume following sudden cardiac arrest.

The Smartsville Fire Protection District serves 67 square miles in the south-east region of Yuba County and provides services to areas around the Yuba River and Yuba Water Agency's Narrows 2 Powerhouse.

### Swift water rescue equipment for the Marysville Fire Department - \$5,000

This grant will cover the costs of four dry-suits, water shoes and water rescue throw bags for the Marysville Fire Department as a part of the Bill Shaw Rescue Equipment and Training Grant Program, and will be utilized in all conditions during rescues.

The dry suits and supplemental equipment will provide warmth and the ability to add layers of clothing to decrease heat loss. They will also allow for increased buoyancy and provide isolated protection from contaminants that can be encountered in waterways and flood rescue situations.

The Marysville Fire Department serves the City of Marysville, District 10 and the Hallwood Community Services District, providing services to approximately 15,000 residents. The department additionally provides swift water and flood rescue services for Yuba County.

The Bill Shaw Rescue Equipment and Training Grant Program is designed for first responder agencies in Yuba County and will cover the

one-time costs of up to \$5,000 per applicant annually, associated with the purchase of rescue equipment or specialized personnel training.

### Radio to aid in search efforts for the Yuba County Sheriff's Office - \$4,430

This grant will help the Yuba County Sheriff's Office purchase a mid-power radio, including programming and installation, for the sheriff's posse's new mobile command post.

The new radio will be used to aid in callouts to search for lost and injured people when the mobile command post is deployed.

The Yuba County Sheriff's Posse assists in wildland searches on forestland, and in river bottoms and remote waterways, such as the watershed around Yuba Water Agency's New Colgate Powerhouse.

### Support for District 10 Wild Duck Egg Salvage Program - \$5,000

This grant supports District 10's Wild Duck Egg Salvage Program and continued efforts to safely rescue wild duck eggs in Yuba County.

The \$5,000 contribution will help the program continue its work in collecting and preserving duck eggs laid in crop fields, protecting them from the heavy machinery used to mow the fields prior to harvest.

Once the eggs are collected, they are transported to a hatchery to be monitored and incubated, and are eventually released back into the wild after they have been banded.

Yuba Water Agency is able to contribute to programs like this because of the benefits the water provides for rice cultivation and waterfowl using the flooded rice fields.

Senator Nielsen Responds to Wildfires, DMV wait times

Over the past several days, I have once again seen the strength and resilience of the residents of the North State who have faced relentless and unprecedented wildfires that have destroyed homes and led to the tragic loss of life of residents and first responders. I have witnessed firsthand the Herculean efforts of the first responders, and the compassion and outpouring of support from businesses, neighbors, and volunteers, doing what

they can to help. There are far too many to name, but I want to give thanks for all of those who, in ways both big and small, will get us through this difficult time. We must develop and implement a long-term plan to diminish our fire risk and support the strongest fire-fighting efforts possible. We must strengthen our forest management policies surrounding these increasingly overlapping rural/urban areas and reduce the overgrowth and vegetation that provide fuel for these massive fires. I will continue to support the residents

of Senate District 4, and the surrounding counties, with hopes and prayers that these fires will end with no more loss of property or lives. I also hope that, as the fires are extinguished, we will see relief from the smoke that has blanketed our

communities and results in unhealthy conditions for all. The road to recovery throughout the state is going to be long and arduous, but I pledge to be part of positive, productive efforts to move forward.

## DMV Must Address Service Issues

Over the past several weeks, residents throughout Senate District 4 have called to express their increasing anger and frustration over long wait times at offices of the California Department of Motor Vehicles. The simplest tasks are now taking up to several hours to accomplish. DMV officials have blamed the federal REAL ID Act for much of the problem. REAL ID requires an upgraded form of identification for people wanting to travel on an aircraft and to access certain federal facilities starting in October 2020. DMV was given millions of dollars specifically to prepare equipment and train staff. In the 2017-18 budget, an extra \$23 million was given to DMV to hire new employees and extend office hours. In response to the complaints, my Republican colleagues requested an audit of the DMV to determine how the agency is utilizing the millions of dollars it has received. In a Joint Legislative Audit Committee meeting DMV Director Jean Shiimoto responded by saying an audit would be a “strain on resources,” and she instead requested millions more to continue to implement the program. Sadly, the committee decided, by one vote, not to approve doing an audit and to move forward with the funding request. We just can’t keep throwing millions of dollars at issues without figuring out how to resolve the underlying bureaucratic problems. I have turned my attention to Senate Bill 76, which I co-authored with Senator Patricia Bates. SB 76 would give a 90-day extension for residents to renew driver’s licenses expiring this year and to register out-of-state vehicles. We cannot accept that the most basic services of a government agency can be so expensive, time consuming, and difficult to provide.

## SHERIFF CANDIDATE UNVEILS STUDENT SHIELD PROGRAM

One of my very first critical incidents as a law enforcement professional was the Lindhurst High School shooting in 1992. I have carried that incident with me over my 26-year career in law enforcement career. It's an honor to be in a position have the ability to effect REAL change by protecting our students while they accomplish one of the most basic endowments afforded to them --- getting an education.

Safeguarding our schools from students that present a clear and present danger to their campus and mentally unstable individuals who enter the campus with the intent to harm students, is a complex issue.

This issue involves behavioral health, access to weapons, school and home environments, family/support systems, bullying and more. To get to the root of the problem, schools need more funding to employ a larger number of counseling staff and identify potential threats in advance and intervene early. Many times, schools must choose between funding for counseling staff, security or programs.

It's vital that schools have the funding for counseling professionals to collect information from multiple sources so that students can be assessed on their risk for harming others. Students who exhibit signs that they could present a threat to themselves or other students would undergo an intervention program designed to mitigate any real or perceived threat.

## As Sutter County Sheriff, I will:

- Work with School Superintendents throughout Sutter County to advocate for greater funding for school counseling staff and develop a comprehensive intervention program. Working together, we can apply for grants to fund these additional positions.

- Work with area Superintendents, veterans and retired law enforcement officers to create a volunteer program at every school campus in Sutter County. Veterans and retired Law Enforcement Professionals would submit to a psychiatric evaluation and undergo training to provide an extra layer of protection at school sites throughout Sutter County.

- All Sheriff's Deputies will undergo campus tours at every school site in Sutter County to ensure that our deputies possess a comprehensive understanding of each campus layout so that if there is an incident, they can plan the most effective entry to neutralize or eliminate the threat.

- Secure local and government funding to purchase barricade equipment for teachers and students to barricade classrooms, providing a greater degree of protection to students and school staff.

Sutter County residents deserve a pro-active Sheriff who prioritizes protecting our children and families. If you want to see real change inside the Sutter County Sheriff's Office, it needs to come from the outside. I'd be honored to earn your vote on November 6th.

Parents and government have nurtured generations of takers and tire dumpers. Now, this is what we get.

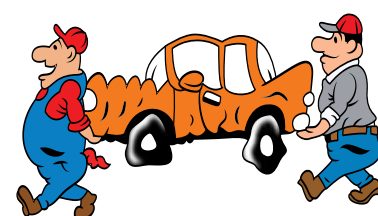

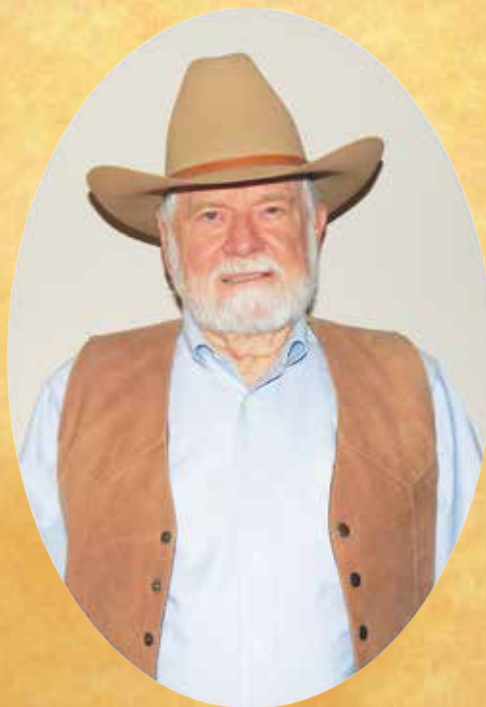
