# Yuba Co. Board Puts Sales Tax on the Ballot

Marysville, Ca. – On Thursday, August 9, 2018 at 9:00 a.m. the Yuba County Board of Supervisors unanimously voted to put a 1% sales tax increase on the November 6th ballot. There were approximately 40 people in attendance, mostly county staff and employees. Two residents from Yuba County were the only ones that spoke besides county officials. 5th District Supervisor Candidate Alton Wright spoke and Gretchen Flohr from Oregon House.

Candidate Wright said, "There have been too many missteps made by the County. Voters don't know what to believe and are now pushed into an uncomfortable corner. The Safety Tax is an unacceptable bandaid." While Gretchen Flohr's concerns that not enough of the proposed tax was going to fire departments.

Robert Bendorf Yuba County Administrator commented on Friday, "Thursday's unanimous vote by the Board of Supervisors means voters in the unincorporated parts of Yuba County will have the opportunity to have their voices heard in November on supporting public safety and essential services. Voters will have a chance to establish local control of funding for public safety and essential services; funding that would not be controlled by the state."

## Mistler Begins Write-In Campaign

John Mistler ran for Yuba County Supervisor 5th District and came in 14 votes short in the primary. He has begun the Write-In process to win in November.

Mistler said," I didn't even know that you could do a "Write-In" campaign until some residents of Brownsville contacted me. They were concerned that they did not care politically for either candidate and did not have a good choice in a candidate for November. While a write in means more work and is harder to win; the fact I was only 14 votes short and I still have three months to talk one-on-one with the

voters I had a better than normal chance to win. I want to be very clear that I got into the race because the incumbent Fletcher broke the law when he, as a representative of the people, denied the people the right to vote. I think all citizens should take that seriously and I will do whatever I can to bring honest representation to Yuba County. Now if we can only agree to get candidates nights in the 5th district and get Fletcher to attend, to date he has not allowed the voters access to ask direct ques-

The Yuba County Board of Supervisors passed a resolution that will put a sales tax in-

crease on the November ballot. While I do not agree with the tax increase, I do agree with putting it on the ballot. Randy Fletcher should have been consistent and allowed the people to vote on the initiative that he illegally stopped. He wants us to vote on a tax increase but not to vote on sharing profits from water sales."

A "Write-in" campaign is very similar to regular campaign except that instead of drawing a line to connect two dots you must write in the candidate's name, that is considered to be the hard part. In this case it would be Mistler.

# Politicians Skirt Law to Skim from Taxpayers

The Howard Jarvis Taxpayers Association (HJTA) filed a lawsuit against the County of Los Angeles for "gross misconduct" when it "illegally spent" close to \$1 million in taxpayer funds on political advertising. The lawsuit seeks reimbursement to the County Treasury and civil penalties.

County officials funded a campaign consultant and political advertising to push Measure H, a sales tax increase that was on the ballot in March 2017. The English and Spanish radio and television commercials touted homeless programs that Measure H would make possible. The spots used the tag line, "Measure H, Real Help, Lasting Change, Vote March 7," but never mentioning about a tax increase to accomplish the feat.

California law allows public funds to provide voters impartial information regarding the pros and cons of a proposed ballot measure, but it forbids government to "'take sides" in elections or give an unfair advantage to one of several competing factions." (Stanson v. Mott (1976) 17 Cal.3d 206, 217.)

The lawsuit also alleges that the County failed to identify itself as the sponsor of its advertising, and failed to file required campaign disclosures and expenditure reports

Government Code Section 8314 says, "It is unlawful for any elected state or local officer, including any state or local appointee, employee, or consultant, to use or permit others to use public resources for a campaign activity, or personal or other purposes which are not authorized by law."

The law is based on the principle that it would be unfair and undemocratic for officials to use taxpayers' money for self-serving political campaigns. However, California officials up and down the state are doing just that, with little fear of being pursued by prosecutors or the state Fair Political Practices Commission (FPPC).

### Obama's IRS at Fault

Last week, U.S. District Judge Michael R. Barrett approved a \$3.5 million settlement on behalf of more than 100 Tea Party Chapters and other groups against the Internal Revenue Service (IRS). Hundreds of Tea Party and other conservative organizations had been targeted, harassed, investigated and stonewalled when applying for tax exempt status.

The government's intimidation successfully curbed the growing influence of the libertarian and conservative movement that advocated for a smaller government, reducing spending and the national debt, fewer regulations and opposing tax increases. Though many candidates were elected with Tea Party help, President Obama's use of government agencies to trouble private citizens was successful in preventing the activists from derailing his campaign for a second term.

The Tea Party movement began following Barack Obama's first presidential inauguration (in January 2009) when his administration announced plans to give financial aid to bankrupt homeowners. That was a tipping point for many passive people to take action.

Though not an official political party, the Tea Party had impact as hundreds of thousands of citizens grew tired of their political party's impotence and became activists. The movement's name refers to the Boston Tea Party of December 16, 1773, an act of rebellion and protest in the launch of the American Revolution. The 1773 event demonstrated against taxation by the British government without political representation for the American colonists.

Historically, requests for IRS 501(C)3 and 501(C)4 recognition were swiftly determined in a few months based upon answers to standard questions to confirm the entity's tax exempt purpose. However, that changed when Senator Barack Obama became president.

In May 2013, the media began reporting that the IRS flagged Tea Party and other conservative groups for review of their applications for tax-exempt status during and prior to the 2012 election. This led to both political and public condemnation of the agency, and triggered multiple investigations. President Obama said the first he knew of the controversy was by reading it in the media. This is the same response he offered for the shameful Fast and Furious and Benghazi corruption.

Some groups were asked for members' names, their affiliations, and donor lists, which are usually a violation of IRS policy. Groups were also asked for details about family members and about their postings on social networking sites. Names of past and future speakers were demanded. Once one set of questions were answered, another list would arrive in the mail.

The Yuba-Sutter Tea Party Patriots was one of the chapters

### Politicians Skirt Law to Skim from Taxpayers

Yuba County Administrator Robert Bendorf and five supervisors have authorized the use of hundreds of thousands of dollars to do exactly what Los Angeles County did – use the taxpayer's money to convince voters to give wealthy officials more funds.

HJTA complained to

the FPPC that LA County should have filed a campaign finance report, but the FPPC refused to act. The county gave TBWB Strategies, a San Francisco consulting firm, a \$1 million contract to work on Measure H. So. HJTA filed a lawsuit to challenge the TBWB contract's legality.

Tax increase measures are a rich cash trough for public relations firms to feed from. Boards and councils are basically copycats willing to all go over the cliff together holding hands. The law and ethics are no hindrance. Officials see no conflict in using the voters' tax dollars to snooker them.

LA County is also promoting a parcel tax to take more funds to address a deplorable water system that has been ignored for decades. The "parcel tax" on the November ballot will assess 2.5 cents per square foot of "improvements that cannot be permeated by rainwater," such as driveways. It will lift an estimated \$300 million in annual revenue from property owners.

The county will pay a "hired gun" \$2 million for "public outreach and education." The California Taxpayers Association says that an "educational video aired during the (supervisors') meeting touted the measure as one that would result in 'better quality of life for everyone in L.A..' and ended with the statement: 'Now let's do this, before the opportunity dries up.' "

Sounds like a slanted presentation and biased approach in violation of the law.

Proposition 6 will also

be on the November ballot to repeal SB1, the Gas Tax and DMV Fee increase passed by the legislators. The state is now illegally using taxpayer dollars to convince voters to keep the tax. Senator Ling Ling Chang is challenging the use of Caltrans signage at construction sites celebrating the taxes and fees in light of the citizens' repeal effort.

Government employees, unions and those benefitting by more road construction are opposing repeal of SB1. The same government employees, their family members and unions will vote for Yuba County's sales tax.

Yuba County has more than 1,000 employees, plus their families all voting for a bigger handful from the voters' pockets. That's the danger of a massive government that can basically vote to take whatever it wants when it wants it. Federal, state, county and city employees now are in control.

The word up north is about a huge plant of rainbow trout. The Department of Fish and Wildlife last week dumped 12,000 pounds of trout into Davis Lake. Now that is a bunch of fish and we wonder who knows who. At any rate the plant should be a winner for anglers in that area. Other areas which also received planted trout were Donner Lake, Grace Lake, Gold Lake and Deer Creek.

The trout are on the move at Collins Lake. These fish have been scarce for the last couple of months, but now are being caught in the deep portion of the reservoir with some big trout being reported. This more than likely means near the dam, which has the deepest water on the lake. We are told power bait and lures have been productive.

Stampede Reservoir is brim full of kokanee salmon. Anglers are having great success here and a bunch of people are boasting limits. Reports tell us a few cutthroat trout have also been taken. Best bet is to troll down to 75 or 80 feet.

The weather at Lake Almanor is hot, really hot. This has slowed down the bite in this reservoir located at Chester. However, current weather temperatures have dropped which should bring back the bite until another heat wave hits this popular lake due to show up next week.

kokanee salmon are still hitting at Stampede Reservoir but have moved into deeper water down around 80 feet. This

We are reminded of the advantage of a light wind when trolling. The light wind creates a ripple effect on the surface of the water, which in turn improves the bite.





### Resigns in protest of edited GJ report

The 2017/2018 17 member Sutter County Grand Jury resigned in protest of their report being edited. After a year of investigating Sutter County government the report was presented for publication. When it came back to the Grand Jury it had been edited and no longer reflected the final report. It is believed to reflect badly on the Sutter County District Attorney and the Sutter County County Counsel. It is rumored that the County Counsel had told the Grand Jury that if the report was released the county would not defend them against any libel suits. Because the Grand Jury is sworn to secrecy until the report is signed and released hard facts are not able to be obtained.

No members of the 2017/2018 Grand Jury were present for the swearing in of the 2018/2019 Grand Jury. Rebecca (Beckie) Jennings, President of the Sutter County Grand Jurors' Association pressured the Sutter County Board of Supervisors to write to the State Attorney Generals' office in an attempt to get hard facts and investigate what got us to this point.

Dear Attorney General Becerra:

I am writing regarding the Sutter County Civil Grand Jury's 2017/18 report, and to request your assistance to ensure the proper processes and laws were followed in the Grand Jury's decision not to make their report public.

In late June, advising Judge Brian Aronson announced that the report would not be published. To date, no reason has been given as to why the Grand Jury elected not to publish their report.

It is my understanding that all members of the 2017/18 Sutter County Grand Jury resigned shortly before their term was to expire. It is also my understanding that the Board of Supervisors and some Sutter County department heads received a preliminary repo1i, but were instructed to keep the contents confidential, since the Grand Jury elected not to publish.

The Grand Jury operated with an approximate budget of \$47K. During their investigation, pursuant to Penal Code §926, they received an additional \$10K for outside counsel from attorney Charles Poulus. Late in the term, Judge Brian Aronson took over as the supervising judge.

Grand juries serve an important watchdog function using public resources, and the report not being publicly released, along with the entire Grand Jury's resignation raises many questions. It is in the public interest to ensure that there was no improper influence of the decision to not publish the report or make redactions. The Sutter County Grand Jury has published a report every year since 2001, and if a report is not published, the community deserves to know the circumstances that lead to this decision and whether or not the legal process was followed accordingly.

Specifically, the following questions should be addressed and answered publicly:

- 1. Why was the 2017/18 Sutter County Grand Jury Report not published?
- 2. Did the supervising Judge require redactions? If so, did the required redactions comply with Penal Code §929?
- 3. What if any communications (written or oral) were made by outside parties to the grand jury prior to its decision to not publish the report? Were any of these communications unlawful or improper?
- 4. Was a preliminary report distributed to affected Sutter County agencies pursuant to Penal Code §933.05(f)? If so, is it required for this preliminary report to be made available to the public?

I appreciate any assistance the Depai1ment of Justice (DOJ) can offer to address these questions. I look forward to hearing from you regarding what actions may be available and appropriate for the DOJ to verify the Grand Jury process followed appropriate procedures and was free from improper influence. If you require further information or have any questions please contact my office at (916) 319-2003.

## **Rural Broadband Update**

This week, U.S. Secretary of Agriculture Sonny Perdue announced that the U.S. Department of Agriculture (USDA) is accepting comments on the implementation of the e-Connectivity Pilot Program created in the omnibus spending measure that was signed into law on March 23, 2018. The omnibus package appropriated \$600 million for the pilot program within the Rural Utilities Service to finance broadband deployment projects in underserved rural areas.

Rural communities with a population of 20,000 or less with an internet speed of 10 megabits per second or slower will qualify for assistance from the pilot program. Comments for the program's implementation are due on September 10, 2018.

In addition, the USDA announced it will invest \$97 million in 12 projects across 11 states that will increase internet service for underserved or unserved rural areas. The states impacted by the program would include

Arizona, lowa, Idaho, Maryland, Minnesota, Missouri, Nevada, Oklahoma, South Dakota, Wisconsin and Wyoming. The \$97 million will come from the Telecommunications frastructure Loan Program and the Community Connect Grant Program at the USDA. Rural California will not benefit from this round of investment, but the USDA reiterated that such investments are the key to rural prosperity and a priority for the agency under the Trump Administration.

Due to the resignation of the 17 Grand Jurists, and the subsequent absence of a Grand Jury report for the 2017/2018 Grand Jury term, questions have surfaced that need to be addressed. Our Grand Jury Association is comprised of former Forepersons and previous Grand Jury members; we strongly fear the Grand Jury process has failed.

There are many checks and balances in the system to protect and guard against inappropriate managing of this process. There are several areas where it appears this year's Grand Jury may have not been allowed to be independent as prescribed by law.

We are hearing many strong allegations surrounding the 2017/2018 Grand Jury, one of the allegations is that they were threatened they would be sued for libel and told they would not be protected by County Counsel if they released the report.

In *People v Superior Court (1973 Grand Jury) (Santa Barbara County)* (1975) 13 Cal. 3d 430 states: The grand jury is a judicial body, an instrumentality of the court. However, subject to the court's general supervision, the grand jury has full independence of action when performing its watchdog functions and the court has no authority to impose its own views on the grand jury or suppress a report simply because it considers it ill-advised, insufficiently documented, or even libelous.

#### We made an inquiry of County Administration office to confirm two things: 1. Does the county have a policy in place to guide County Councel in the evo

1. Does the county have a policy in place to guide County Counsel in the event County Counsel needs to recuse themselves when they believe they have a conflict? We have been told there are no such policies. In our research into other counties we have found if lead County Counsel has a conflict in most counties the grand jury advisory role is assigned to another attorney in the County Counsel office and the jury is protected by the client attorney privilege.

**2.** We also checked to see if our County Board of Supervisors was consulted in this decision

# Free Waste Tire Disposal Coupons Available

Yuba and Sutter Counties, Ca.

Beginning July 1st, the Regional Waste Management Authority has a new allotment of coupons available for the free disposal of residentially-generated waste tires — even if you participated in the program that ended June 30th. Yuba and Sutter County residents can now request a coupon for the free drop-off of up to 20 residentially-generated passenger car and light

truck tires per household (rims up to 17 inches in diameter – no truck or tractor tires).

The free tire disposal coupons are issued on a first come, first served basis while supplies last. They will expire 30 days from the date issued and a valid coupon must be presented when the waste tires are delivered to the drop-off location. Tires do not need to be removed from the rims.

Call the Regional Waste

Management Authority during weekday business hours at (530) 634-6890 to request a coupon or for more information on the program. Please be prepared when you call to provide the number of tires that you have for disposal. This program is for residential use only - no businesses - as commercially generated waste tires are not eligible for this program.

If hauling more than nine tires at one time, the Local Enforcement Agency conditions on the reverse side of the coupon must be completed. This program is funded by a grant from the Department of Resources Recycling and Recovery (CalRecycle).

and we were told they were not. The attorney general in the decision listed below explains the protection counties are required to provide to the grand jury.

#### Indemnification/defense for defamation suits 81 Ops.Cal.Atty.Gen. 199 (1998)

A county must indemnify (pay a settlement or judgment) and pay for the defense of grand jurors sued for defamation for statements made within a final report that is within the jury's jurisdiction. Jurors are considered to be county employees for this purpose.

The decision does not say support can be withdrawn due to concerns of liable. It does however state, the only time a county can withdraw legal counsel is if the jury went outside their jurisdiction. For example a jury decided to investigate an agency outside of their own county.

Grand Jurys provide an important watch dog function which has been built into our state constitution in order to help protect and proclaim the importance of the Civil Grand Jury process. California is currently the only state in the United States with a functioning civil grand jury system. Grand juries were established throughout California during the early years of statehood. As constituted today, the Grand Jury is a part of the Judicial Branch of government, an arm of the Court.

It is very disturbing that the **entire** 2017/2018 Civil Grand Jurors resigned 4 days prior to the end of their term and made the decision to not release a final report. It raises the question, "What could have possibly happened that this jury felt they had no other recourse but to resign and not release a final report?"

Our citizens have a right to know whether or not our Grand Jury system was compromised and to discover if there was in fact improper pressure placed on the jury to redact information from their report or too not publish their findings. We know they produced a report because it was delivered to various department heads as well as the Board of Supervisors, City Officials and Elected Officials as stated in a letter from the Honorable Judge Heckman. "On June 14, 2018 you were mailed a preliminary copy of the 2017-2018 Grand Jury Report section(s) that pertains to your department. After those copies were mailed, the Grand Jury elected to not publish an authorized final report. Therefore, there is no report to respond to." The penal code that explains this process states: The grand jury must give the relevant parts of the report to the official or entity it investigated two business days in advance of the report's public release and after its approval by the judge. (PC §933.05(f)).

The date stamped as received by the county on the letter from the courts show the letter was received by the county on July 9th twenty-seven days after they had received their copy of the unauthorized report. Why?

Judge Heckman goes onto say, "Please be advised that any physical or electronic copies of the preliminary report continue to be confidential unless it is ultimately included in an authorized final report. Los Angeles Times v. Superior Court (2003) 114Cal. App.4th247." The Sutter County Grand Jurors' Association has been involved in training and educating on the Civil Grand Jury process since 2011. We were honored to have the opportunity to meet the 2017/2018 Civil Grand Jury and to provide additional training on such topics as how to conduct a proper investigation as well as congeniality and committee formation. During our training for the 2017/2018 Sutter County Civil Grand we found these jury members to be dedicated, intelligent and civically minded. The question we should be asking is why after working 365 days the entire Grand Jury would resign without releasing their report allowing their efforts to go for naught.

We respectfully request the Sutter County Board of Supervisors look into the allegations surrounding the legal advice provided or not provided by County Counsel to the 2017/2018 Grand Jury and report the findings to the citizens of Sutter County.

We further request, as a board that is responsible for the governance of our county, that you draft a letter to the Department of Justice (DOJ) addressed to the Attorney General requesting their office conduct a thorough investigation into this matter.





Wildfires damage crops, rangeland In areas of Northern

California burned by wildfires, farmers and ranchers continue to assess the impact of flames and smoke on crops and rangeland. In the area of the Mendocino Complex fires, farmers say they're aware of some damage to vineyards and pear orchards in Lake County, and aren't certain whether smoke might affect ripening winegrapes. Mendocino County ranchers say fires have scorched timber and rangeland, and some livestock remains unaccounted-for.

#### Salvaged trees help fund restoration projects

Trees that burned in a fire a year ago are being salvaged in an operation in Northeast California--with proceeds from timber sales used to help pay for ecological-restoration work. The Modoc National Forest says dead-standing trees that burned during the Parker 2 Fire are being milled, providing more than 3 million board-feet of timber. Forest officials say the project will improve safety for road travel and recreation, while helping the local economy.

#### **Peach production** accelerates in California, nation

Peach harvest across the country is in full swing, and California farmers say they're seeing more competition in the market this year. That's because peach orchards in Georgia and South Carolina have recovered after frost reduced their harvests a year ago. Cold weather this year in the Central Valley took a toll on some early peach varieties, but

growers say harvests of midseason peaches have returned to typical levels. California leads the nation in peach production.

that was targeted with the intimidation and interrogation noted above. Their nonprofit status was eventually improperly and arbitrarily rejected by the Lois Lerner nonprofit department of the IRS. They also were assessed and paid thousands of dollars in corporate fees eventually putting them out of business.

Former local Tea Party secretary Ruth Criddle said that members also had their personal income taxes audited. They felt like they were under assault by one of the nation's most powerful agencies.

Another target for trouble was a conservative voter organization founded by Catherine Englebrecht called True the Vote. It was active

primarily in Texas.

Engelbrecht she and her husband and their business, Engelbrecht Manufacturing, were investigated by the Federal Bureau of Investigation (FBI), the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF), and the Occupational Safety and Health Administration (OSHA). Englebrecht stated that she was targeted because she "worked against voter fraud."

On May 21, 2013, her organization filed a lawsuit in the District Columbia against the IRS over claims that the agency delayed the determination process for its application for 501(c)3 tax-exempt status, claiming, "We've been waiting for three

years to receive a decision from the IRS about our tax exempt status. After answering hundreds of questions and producing thousands of documents, we're done waiting. The IRS does not have the power to pocket veto our application. Federal law empowers groups like True the Vote to force a decision in court - which is precisely what we aim to do."

IRS leader Lois Lerner and Commissioner John Koskinen were not cooperative with Congressional committees investigating the wrong doing and now have nice retirements courtesy of those they abused.



#### The power of astute observation.

Teaching baseball is one of my favorite things to do. Not that I am world's first and foremost baseball player and expert, far from it. But based on my history of parent feedback and stellar win-loss records every year I was a head coach, I can comfortably say I convey America's favorite game to my players in a manner that is both effective and enjoyable.

I think one's ability to teach something to another requires a host of talents and empathies, while leaving other attributes hidden in a drawer somewhere.

Indeed some of the best instructors and teachers were not the best do'ers per se, but they had a keen eye and ear for what was needed to be taught and knew how to teach it.

My knack for baseball and indeed many things is based on a sharp observational eye. In other words no matter what the sport, I watch it in detail and over a long period of time. As I familiarize myself with the game, certain nuances and reoccurring patterns will usually develop and finding solutions to any negative events or occurrences is the next step.

For instance, in baseball after years of playing and many more years of observation, I discovered that 90% of the strikes made were because the bat was passing UNDER the ball. Very few strikes were above the ball. I noticed many players would also dip their body when pitched to or not hit the ball very far because of a deficient hip turn.

Solutions to these problems were developed and exercises and drills were invented to address the various issues. That experienced coaches and often minor league or college players who taught baseball produced players that still did these things was perplexing. Often I found the most experienced baseball player/coaches often had sons who played but were not very good.

I thought "how could an experienced such player or coach have a son that himself had the same trouble with these common problems I had seen"?

What was the deficiency in transferring their vast knowledge to the children?

Once I moved to high school baseball, I observed similar deficiencies in coaches. A favorite of mine was watching year after year and team after team practice endless double play drills. Counting the hours spent on double plays however did not equate to the two or three double plays (if they were

lucky) turned during a sea-

son all the while making the most basic of mistakes in other areas.

Those hours spent on probability double plays would be better spent on the basics. Seldom did teams have these basics nailed down pat. A reoccurring problem

was that of reoccurring problems. A team would make the same mistake game after game yet no drill was ever practiced nor the problem addressed. The coach would sometimes get mad at the players for making the same mistake, and under my breath I would mutter "If he knew it he wouldn't do it". Simply put, if a player doesn't know something or repeatedly makes the same mistake, it's not the players fault, it's the coaches.

They say a war is won before the first bullet is fired and game is won before it begins. That seemed to ring true as I have heard several coaches tell their players before a game "nobody expects you to win so go out there and show em".

My gosh, talk about programming the mind before a game.

In conclusion, observation is tantamount to what you think you know. Some of the time what we think we know is proven wrong by observation. And if it is so proven, change your methodology and change your thinking. I know little of the game of soccer but

I have watched it a few times. I have already noted what seems like flaws in this game by young players and although I never played it, know little of its rules or how it's played, I bet anyone a dime on a dollar I could coach this sport and given equal teams and a year or two of experience, I could muster up wins against just about any seasoned coach. Some may call me crazy and too optimistic but in my opinion, observing closely is the key to many successes in areas where one might have the most experience.

This is the power of astute observation.
