Yuba County Will Put Sales Tax on Ballot

At the Board of Supervisors meeting Monday July 23 at 7:00 in the evening, the Yuba County Board of Supervisors voted unanimously to place a one-cent sales tax on the November ballot. This was the first hearing of the ordinance. The second and final hearing will be August 9, 2018 at 9:00 a.m., that is a Thursday, at the Board of Supervisors Chamber.

After months of county officials gathering feedback from residents about their priorities for Yuba County, the Board of Supervisors on Monday evening voted unanimously to place a Public Safety and Essential Services Protection Measure on the November 6 ballot for voter consideration.

If enacted, the measure would help Yuba County overcome underfunded state mandates by generating locally-controlled funds for essential services. These include main-

taining fire protection services and emergency response times, improving the ability to react and contain wildland fires, maintaining 24-hour sheriff's patrols, and attracting and retaining jobs and businesses to Yuba County. No funding could be taken by the State. The tax would be a general sales tax increase requiring a 50% + 1 vote to pass. There are no legal requirements that would guarantee that the tax would be used for the stated needs. Only a "Special Tax" requiring a 2/3rds vote can make that guarantee.

"Yuba County is handling over eight thousand 911 calls for fires and medical emergencies each year, sometimes with only two emergency dispatchers," said County Administrator Robert Bendorf. "In other cases, some fire districts rely exclusively on volunteers and a patchwork of funding including relying on thrift store sales. Locally-controlled fund-

ing will help districts do more to ensure that every call gets a timely response."


The measure, if approved by voters, would enact a onecent sales tax for unincorporated Yuba County essential services. The measure contains strict accountability provisions, including independent citizens' oversight and audits.

"With an average of only five sheriff's deputies patrolling 664 square miles across Yuba County at any given time, and only one patrolling all of the foothills, it's impossible to quickly respond to emergency calls," said Sheriff Steve Durfor. "This measure would help maintain 24-hour sheriff's patrol and address response times that can currently take up to 50 minutes."

Kudos to YCOE Superintendent

Yuba County Superintendent of Schools Francisco Reveles did the taxpayers a big favor by closing a government-run child care operation in Plumas Lake that routinely lost \$150,000 or more annually for 12 years. If the center were a private business with such losses it would have closed its doors in the first 1-2 years.

However, by utilizing the deep pockets of Yuba Co taxpayers Plumas Lake residents received childcare courtesy of \$2 million or more of benevolence from their neighbors to keep the center afloat.

These losses do not include the initial monies invested to develop the facility.

In a capitalist economy, a business closing its doors is called creative destruction. It's the natural pruning of poorly run businesses, noncompetitive operations and obsolete services or products. When allowed to occur creative destruction ushers in new products or services at competitive pricing.

In the private sector when a failing product or business is "saved" by government's crony capitalism and bail-outs, the taxpayers lose big. Interference in a struggling economy prolonged the Great Depression. Most remember Presidents Bush and Obama claiming banks and auto makers were "too big to fail." That's 100% wrong. Other businesses would have purchased the struggling enterprises without costing taxpayers a dime.

The constitution does not authorize government to take money from citizens to favor certain private enterprises. However, politi-More on Page 3

Surprise – Sales Tax Increase on Ballot

Yuba County will vote this November on whether sales taxes should be raised 1% from 7.25% to 8.25% on purchases over the next decade to raise \$4.3 million annually. It will take 50% plus 1 more vote to pass. Regardless of promises there are no legal restrictions on where the money is spent.

County Administrator Robert Bendorf each year tells why the county is in trouble. He basically says "Revenues are up, but so is the cost of doing business." That euphemism "cost of doing business" means the county can't afford the escalating unfunded pension liability and health care costs.

The problem is fairly simple. Most in the private sector set aside their own money for retirement. (Few employers pay into employee's retirement.) When people retire they begin collecting a sum each month from an IRA, 401K, savings, sell property etc. There is no guarantee how much they earned from investments. Whatever they have earned they begin enjoying – a lot or a little.

Government retirement is quite different. Each pay period a small percentage of pay is contributed to the state retirement fund CalP-ERS by the employee and also the employer (taxpayers). Then the employee is promised a designated benefit (a percentage times the number of years worked.) So, if a person worked 30 years at 3% rate then they would get 90% (30 yrs X 3%) of their highest pay year for the rest of their life. It is a guarantee regardless of how much money they paid in or how well the investments fared.

However, county supervisors have made promises to unions that they cannot afford to keep. It is called an unfunded liability. So, CalP-ERS contacts the county to let them know how much the fund lacks to pay all of their retired county employees. Then that extra money must be sent to cover the shortage.

Let's look at the predicament for just one job, sheriff. When Sheriff Durfor retires at the end of August there will be three retired Yuba County Sheriffs living, Gary Tindel, Virginia Black and Durfor. Since their retirement funds are not set aside in an account for them to draw from, here's how it works.

This Month In Your Garden

We are going into August which usually is still a hot month, though it is the month that will usher in our fall season and will typically bring temporary, but welcome, breaks in the steady heat that our summers bring. Early signs of fall become noticeable as deciduous trees prepare to lose their leaves and subtle fall colors begin to be noticed. Though hot, August is a month showing a change in the weather.

For many people August becomes a time for upkeep. Deep watering still is needed, especially for trees and larger shrubs that have been planted this season. They still have lots of new foliage that needs the moisture and are depending on a newly developing root systems to supply that moisture. This should be done one or two times a week during the dry season until the tree is about three years old, and gradually taper off the frequency of watering. A vegetable garden requires a quite a bit of attention considering that the ripening fruit needs to be harvested routinely to keep new veggies to keep coming on. Watching carefully for unwanted insects is needed. Pumpkins growing in the garden can be fun for the kids, but be sure to prop them

up so that they don't sit in a small puddle of water causing that spot to rot. It can make it un-worthy of becoming a Jack-o-lan-

Do you have any citrus trees? This period as we approach fall is a good opportunity to ready any citrus for the winter, since they are not very "cold hardy". They should have dark green leaves, If the leaves are pale or yellow with darker veins in them they need to be fertilized with citrus food and some extra iron.' This will help insure that they will more easily go safely through the winter months as long as they have protection around them, as well. Since the fruit on them ripens in late fall to early winter, keeping them from exposure to the very cold nights protects the fruit,

-This is the proper time for the last feeding of rhododendrons, camellias and azaleas. They will set buds from this feeding to bloom beautifully in the spring, after which they should be fertilized every 30 days for thee times. Be sure you use an acid fertilizer specifically for rhododendrons, azaleas, and camellias, otherwise referred to as RAC fertilizer.

Crape myrtle bushes and trees are very vibrant as trees. They thrive on the hot weather. They are available in several different colors. The flowers, in their fluffy bunches, can sometimes be encouraged to bloom again by cutting off the spent flowers rather than letting it form a bunch of small round seeds. The first set of flowers will be the the most lovely, as is the case in many plants. I feel that I'm a bit behind on timing this year, though, since we are in early July as I am typing this and I have seen gorgeous crape myrtles in many places. But, they do like the hot weather and we have had lots of that, so enjoy them whrerever and whenever you see them! Rose of Sharon are much like the crape myrtles in that they don't seem to mind the heat and bloom during the

hottest part of the year.

Perennials can be plant-

blooming bushes, or grown

ed now, not necessarily for the flowers that they might produce now, but for those you will be able to enjoy next spring. Perennials are very rewarding – you plant them and enjoy summer bloom, they die back during the winter months and emerge again in the spring, frequently multiplying their numbers. Just don't mistake them for weeds in the spring and spray them or dig them up until you know what they are. A marker of some kind can be used to prevent that happening. It is nice to have some colorful things that will come back by themselves, not requiring lots of care and then will provide some color. Some suggestions could include Shasta Daisy, Lavender, Cone Flower, Coreopsis, Achillea, and Rubeckia. You will find many others with a visit to the nursery.

As the heat of August reminds us that summer is still in charge, Just start looking for those subtle signs of fall.

It seems a bit distant with some of the heat we have had this summer. But it won't be long before we are enjoying the waning summer as it takes us into the fall.

They just keep biting. The kokanee salmon that live in Bullard's Bar Reservoir are still what you might call outstanding in regard to a huge bite still underway. Limits of salmon are a sure thing with fish up to 15 inches. Best bet to get the fishes attention, is to troll with flashers in front of a spoon or spinner tipped with corn. We are told to avoid the dam area and when small kokanee salmon are caught it is best to go find the bigger fish. It appears the smaller fish are schooled up together and the big-Upper and Lower Salmger salmon are schooled up also together. on Lake, Upper Spencer Lake. TEHAMA COUNTY:

Salmon fishing on the Feather River has been slow so far into the opening, but anglers are catching stripers on bait from Yuba City on up to Gridley. Those who have been successful with the salmon are scoring with plugs and spinners.

A check with the Department of Fish and Game's planting program coordinator revealed that a bunch of rainbow and brook trout have been planted at various locations. See below for fish plants in the Northern part of the state. BUTTE COUNTY: Butte Creek; EL

We hear from Eagle Lake near Susanville. The Eagle Lake trout are cooperating and are being caught trolling and still fishing with night crawlers. Trollers are having success pulling needlefish or Thomas buoyant lures in red or gold.

Lake Berryessa fishing has been slow and the new fire in that area has not helped along with the hot weather and water surface temperatures in the 90's. However, some fish are being caught at night.



cians after swearing to defend the Constitution then properly ignore it.

Why didn't the county school board vote to close the childcare operation long ago? The board had no authority to vote to close the school. However, they could have refused to approve the annual YCOE budget unless the school was closed but the odds of that happening were slim to none.

Prior to Reveles and under School Superintendent Scotia Holmes Sanchez the losses were questioned by some board members but the center continued. That's why the Reveles move is so bold and refreshing.

California public schools up through high school are tuition-free. In fact, if parents of students are not property owners (pay no property taxes) they have little or no financial stake in their child's education. It's an entitlement. Owners of property, even those with no children or children long out of the home, are forced to pay for schools.

In this unique case the Plumas Lake Center charged tuition but still ran \$150,000 plus each

year in the red. Reveles said that tuition would need to go up 100% just to break even. The center's costs that make it uncompetitive with the private sector include higher salaries, vacation and health benefits and mandatory employer contributions to state and federal defined benefit retirement systems.

There are some lessons here. Government has priced itself out of competing with the private sector when providing a similar service and charging for those services. Government has become unaffordable. Also, it is nearly impossible to hold government financially accountable.

There is no profit and loss plumb line. There is no accountability when it comes to productivity. When government runs short of funds it finagles a way to take more from the citizens or the general fund, just like Yuba County Office of Education (YCOE) did for 12 years.

Even the business department at YCOE was not particularly nervous about subsidizing a project running at a huge deficit. That's a standard operating approach in government funding. You get money and you spend money. When you run out then you take more from some other department or from the citizens. There is no assessment of relevance, being effective, costs versus outcomes, etc. There is no reason or incentive to do so in government. That's why reform is nearly impossible to achieve.

In 1803 the British created a civil service position in which a man was required to stand on the cliffs of Dover with a spyglass. He was to watch for an invasion and ring a bell if the army of Napoleon Bonaparte was approaching. It was a strategic idea at the time, but the position was not eliminated until 1945 long after the world added telephones, radios, radar, television, submarines and planes.

It took the British government 142 years to render the spyglass unnecessary and drop a civil service position. Thankfully, it took Superintendent Reveles just a few years at the helm to give the childcare center a decent burial.



NYWD Board's Bad Behavior

I am not simply opining about NYWD's behavior, there is evidence that backs up what I am saying here, (please see our website) through either documents, press releases, photographs, and/or videos that can be downloaded. Viewing NYWD board meeting videos is illuminating - of particular interest is the meeting in June (Minutes 10 and 33-45). NYWD Policy towards

the Public is codified in their agenda (download any NYWD agenda at: https://www.nywd.org/ meetings). We will be uploading all agendas to our website to ensure they are not tampered with at: https://oregonhousedobbins.wixsite.com/water/ about:

- 1. AGENDIZED ITEMS opportunity for public comment on agendized items will be provided only at the time they are addressed by the board.
- UNAGENDIZED ITEMS - Opportunity for public comment on any other items of interest within the jurisdiction of the Board will be provided only during the "PUBLIC INPUT" item agendized below specifically for this purpose.
- 3. TIME LIMITATIONS -Public comments will be limited to 3 minutes per speaker and 10 minutes for all speakers combined for the agenda item. (This means only three people ever get to speak and that one person cannot take the whole 10 minutes - even if they represent the public.)
- **PUBLIC** INPUT:However, no action may be taken by the Board on topics or matters presented during this PUBLIC INPUT agenda item
 - G. DIRECTORS INPUT:

.....The Board cannot take action on any matter not on the agenda and will refrain from entering into discussion that would constitute action, direction or policy, until the matter is placed on the agenda of a properly publicized and convened Board meeting. Consideration of agenda items for the next meeting. Items must be requested in accordance with the District's POLICY FOR AGENDIZING ITEMS FOR BOARD MEETINGS. In this above-copied language which is repeated

in every agenda and read aloud at every meeting the Board makes it clear that they will not answer any questions nor have any discussions with the public at all. Our repeated requests for meetings regarding irrigation water and to have irrigation water agendized have been ignored and unaddressed since March. NYWD has insulated themselves from any accountability to its customers, its taxpayers, and its constituents.

During the April, May, and June 2018 board meetings, the public was reprimanded multiple times, cut off as they were attempting to speak, and told that they are NOT ALLOWED to ask questions and are restricted to comments only. As one example of the behavior of the NYWD, at the June 21 board meeting, an expensive consultant (North Star) hired by NYWD to do work they should themselves be doing (writing for grants) gave a "presentation". When I attempted to ask a question of the rep, Don Forguson reprimanded me - as if I were a child - telling me that the rep was ONLY speaking to the board and that the

public would ONLY be allowed to speak at the end of the presentation. When the rep was done, the board tried to immediately go to a vote on a resolution regarding hiring this engineering firm to work on grants without allowing the public any participation at all. This resolution was not an agenda item, which was a violation of the Brown Act of 1953 ("Each item of business to be transacted or discussed, including items to be discussed in closed session, must be the subject of a brief general description [in the agenda] which generally need not exceed 20 words). (NYWD agendas and the Brown Act can be downloaded from our website).

With public intervention, I was finally allowed to speak, and I asked one question regarding oversight of grant monies, to which the General Manager, Jeff Maupin, turned to Board Member, Don Forguson, and intoned "This is public comment, not questions". Blindly obedient to the hired general manager, the elected board member, dutifully informed me that I was not allowed to ask questions, but to only comment. The board then voted on the resolution to allow the General Manager complete control of over potential grant fundswith no oversight from the board. Video of this meeting clearly shows the public attempting to intervene in the board's intention to vote on a resolution about which the public had not been allowed to comment or question and which was not on the agenda (see https://youtube/orH5gh7-

Governor Signs Gallagher Legislation to Help Fire Victims

Sacramento, Ca. Governor Brown has signed Assemblyman James Gallagher's (R-Yuba City) legislation written in response to the 2017 wildfires and Oroville Dam crisis. AB 3078 expands the crime of looting to include when the conduct occurs during an evacuation order, and AB 3122 clarifies the property tax deferral process for individuals affected by natural disasters.

The fires, and resulting mudslides, forced many to evacuate on short notice, leaving their homes unprotected from looters and burglary. In the aftermath of the evacuations, there were numerous reports of residents returning to their property where valuable and irreplaceable items were stolen. While there is already an enhanced penalty for burglaries committed during a state of emergency, there is no enhanced penalty when burglaries are committed during an evacuation order. AB 3078 will close this loophole.

"During the 2017 Oroville Dam incident and last year's wildfires, residents were ordered to leave their homes under mandatory evacuations. During this hectic time, homes and businesses were left unprotected. AB 3078 ensures that people who take advantage of communities when they are most vulnerable face higher penalties," said Gallagher.

Gallagher's other bill, AB 3122, clarifies the property tax deferral process for individuals impacted by disasters. In the months following the wildfires, many individuals applied for property tax reassessment and deferral. However, victims were unaware that their deferral claim would be invalid if damage to their property was less than \$10,000. AB 3122 allows anyone impacted by a natural disaster to apply for relief, without the risk of penalties if they end up not qualifying.

"AB 3122 will ensure that people who are already facing a tough situation are not put in a position where they have to choose between applying for relief and paying penalties if they don't qualify, or not applying at all," said Gallagher.

How about those big marijuana raids in the foothills two weeks ago? They sure brought smiles to the residents of merit and crocodile tears to the illegal growers and their supporter and candidate for Fifth District Supervisor Alton Wright. Early in 2018, Supervisor Fletcher contacted State Assemblyman James Gallagher and State Senator Jim Nielsen seeking assistance from the State of California. He followed this up with an anti-illegal marijuana rally on the steps of the State Capitol and a meeting with State Officials to develop a plan of action. The result was the marijuana raids on July 12th and 13th 2018. These raids were under the jurisdiction and coordination of the Yuba County Sheriff's Office, but now included assistance from numerous State agencies, including the National Guard. Assemblyman Gallagher summed up Randy's efforts when he thanked him "for helping to find a

Voters' Rights Denied Again by Lou Binninger

Silicon Valley billionaire Tim Draper has been trying to divide California, first into 6 and recently into 3 new states. He sees the state as ungovernable.

His Cal 3 initiative qualified for the November 2018 ballot by gathering ample signatures from registered voters. However, the California Supreme Court blocked the initiative from the ballot.

The ruling came after Cal 3 opponents argued that breaking up the state would be a "revision" of the state constitution that requires support by two-thirds of the California Legislature before it can go to voters.

Supreme Court Justices reversed legal precedent that allowed even legally questionable initiatives of the voters to be on the ballot. The thought was that if the measure passed Constitutional challenges could then be addressed.

Draper said, "Whether you agree or not with this initiative, this is not the way democracies are supposed to work. This kind of corruption is what happens in third world countries." So much for a people-driven government, we now have a top down ruling class.

State of Jefferson movement leader Mark Baird said, "The California Supreme Court has ruled that Cal 3 would cause too much disruption! The arrogance of the ruling oligarchy of California defies liberty and defies description. Obviously the California Supreme Court has never read the Constitution of the state it is supposed to serve." (An oligarchy is a small group of people having control of a country, organization, or institution.)

Baird does not support the Cal 3 idea, but endorses the people's Constitutional right to decide the future of Cal 3 and the state. Baird offers an applicable portion of the state's founding document in his statement:

Article 2, Section 1, California Constitution: 'All political power is inherent in the people. Government is instituted for their protection, security, and benefit, and they have the Right to alter or reform it when public good may require."

Baird's statement continues, "Liberty is for everyone and the California Supreme Court has struck a blow for tyranny and oligarchy by denying Constitutional Liberty to the voters of California. Are you the masters of the government which was created to protect your freedom? Or are you the slaves and servants to those who think you too stupid to know what is right and good?"

"This is proof that California is broken beyond repair. We need to start over. We need a Constitutional Republic with far smaller districts, where state representatives are afraid of the voters where government is restricted to its proper role."

Blocking the people's right to direct their affairs has been popular lately. The Yuba County Water Agency "Seven" blocked an initiative from the ballot to revise how agency revenues are spent. Surprise - Sales Tax **Increase on Ballot**

Taxpayers guarantee an agreed upon amount to 3 retired sheriffs and also pay Sheriff – Elect Wendell Anderson. Taxpayers are paying four sheriffs while one works.

Let's look at some

quesstimates on how the

money works out. Gary Tindel retired from Yuba County in 1999 and collected \$58,539.52 2017. He then retired in 2011 from Marin County and collected an additional \$42,587.95 in 2017. Virginia Black retired in 2006 and received \$134,624.16 in 2017. Let's guess Sher-Durfor's retirement pay at 181,620 annually. And, let's say Anderson starts out at \$185,000 not counting benefits (another \$50,000 plus).... a guess.

This all means that Yuba County (and Marin Co for Tindel) taxpayers are paying \$417,371 annually for three retirees and then when adding Anderson it brings the total to \$602,371 commitment for one sheriff working.

This promise to government employees seems too good to be true. You work and the taxpayers promise to pay you for working plus sustain you in retirement for as long as you live at up to 90% of your top earnings year.

Meanwhile, government employees get automatic raises based on agreements not merit. It's like participation trophies in soccer. So, the entire Yuba County payroll of \$70,951,286 in 2016 automatically grows with no additional employees.

This pay and retirement system is unfair to citizens and is unsustainable. This is what finance investigators call a Ponzi scheme named after Italian swindler and con artist Charles Ponzi. Ponzi promised people that if they gave him their money to invest he would provide 50% return on investment in 45 days

and 100% in 90 days.

However, Ponzi was not investing people's money. He simply paid returns to the first investors off contributions from later investors. The whole scheme lasted just over a year before it collapsed and he was arrested.

Who in their right mind would trust a con man with promises like that? If you had your entire retirement nest egg to invest would you give it to a government agency to invest? DMV now takes all day just to issue a new driver's license.

Finally, let's look at Yuba Co 2016 salary compari-

sons, government versus private sector. Median pay and benefits for fulltime county workers were \$83,108 versus \$37,103 for nongovernment. More than 200 county workers are making between \$100,000 each \$300,000. In 2016, the total county employee payroll costs every resident \$960 each. There is 1 full or part-time county employee for every 73 residents.

Government is way too big and expensive for Yuba County folks to afford. That's the problem.

Leverage

The term leverage in financial circles means investing money (or wagering some might say) partially using someone else's money for part of the investment funds.

Suppose an investor or company wants to invest in a security or investable endeavor and puts up \$100 to and receives \$100 worth of value in a stock or other security. There is no leverage in this example. The investor put up \$100 and got a \$100 worth of value. The investment could be a share of stock. an interest in a business or property, or whatever might be available.

Now imagine the same investor or company puts up \$100 but wants to receive \$1,000 worth of value. In essence, \$900 of the "investment" must be covered by someone else. Think buying a house. You put up a down payment and take a loan for the rest. This is in essence a type of leverage. You received more in value than you put up in cash. Leverage is available to

investors through what is called "margin accounts", where the brokerage firm you have your account with may allow you to borrow funds from them to increase the amount of your investment.

There are various example of leverage throughout the financial community. An investment company might borrow money to invest in another company, a bond fund might use leverage to increase its amount of bonds it buys to increase the amount of interest it receives, or an investor like Joe Smith of Main Street USA might want to buy more of an investment then he has money for. In all cases, someone else besides the initial investing entity is loaning money to that entity.

Leverage is used to hopefully increase returns. An example might be an investor believes stock ABC might increase in value and he only has enough money for 100 shares but he wants to buy 1000. Let's then assume the shares cost a buck a share. The investor puts up \$100. His brokerage firm may elect to loan him the money to make the 1000 share purchase, which means the firm is loaning an amount to buy the remaining 900 shares the investor doesn't have money for.

In this case that amounts to \$900 which is 900 shares at a buck a share. If the transaction is completed, the investor owns 1000 shares but owes the firm the money for the other 900 shares, which would be \$900.

Now suppose the stock doubles in value. The original 1000 shares cost \$1,000 but now are worth \$2,000. Since the investor only put up \$100 and he owes \$900, his profit, once he paid back the \$900 would be \$1,000. That's a 1000% gain or a \$1,000 on a \$100 bet. Not too shabby.

This is the enticement of leverage and the big boys know it all too well. Leverage on a humungous scale can contribute to some sizeable gains with a lot of zeros on the end but knife edge of leverage is two sided.

Suppose our \$100 investor who borrowed the other \$900 saw his shares

drop 10% after he bought them. 10% of the \$1000 share value is \$100. That's all the investor has in game. In that case the mere 10% drop in share price wipes him out.

Ouch. So goes the good, bad and ugly of using leverage.

One only has to look back at the near financial collapse of the entire global system in 2008/09 to see just how leverage can ratchet up the losses in a hurry with nowhere to run should the underlying asset fall rapidly. Hence the trepidation of world central banks when moving markets. Even small moves can cause huge problems. Knowing full well the tool of leverage is used on a grand scale by financial institutions everywhere, monetary authorities are well aware of the damage leverage can cause when used on a massive scale.

When individual investors use leverage it can wipe out their portfolio in a hurry. When global financial institutions use it, it has possibility of wiping out not only individual investors but world banking systems as well.

Beekeepers say they're satisfied with rules requiring imported honey to bear clear labels showing its country of origin. Avocados withstand heat wave

A severe Southern California heat wave earlier in July damaged avocados near the end of their season, and growers say they're evaluating whether the heat

might affect next year's crop, too. Young avocados for next season's harvest had reached the size of olives or walnuts when the heat wave hit. University of California farm advisors say farmers will watch heatstressed trees carefully in hopes that new growth regenerates.

Study examines purchases of convenience foods

Americans' food choices often boil down to availability of time and resources, and that extends to "convenience foods" such as restaurant meals and ready-toeat foods. For example, federal study says households with children purchase more fast food and less food from fullservice restaurants. As household income rises, people tend to eat out more, and households where all adults are employed purchased much more food from full-service restaurants.
