# **Yuba County Raid**

# **Several Violations Stemming From MJ Cultivation**



On July 12, 2018, Yuba County Sheriff's Office (YCSO) along with several other allied agencies executed warrants at 17 different locations in Yuba County. This focused operation involved environmental and water violations stemming from illegal marijuana cultivation. As a result of this investigation, 6,534 marijuana plants were eradicated, 1000 lbs of processed marijuana, 40 lbs of processed Butane Honey oil, 2 vehicles, 1000 in cash, a rifle and a Butane Honey Oil Lab was seized. Numerous water board and environmental violations

were found at these different sites. This was a cooperative effort with the California National Guard Counterdrug task force, California Water board, California Department of Fish and Wildlife, Calaveras County Sheriff's Department, The Highway patrol, Narcotic Enforcement Team and Yuba County Probation.

# Stephan Duckels Will Assume Assessor Duties

In a letter to the to the Yuba County Board of Supervisors, dated June 26, 2018, retiring County Assessor, Bruce Stottlemeyer, stated, "As you are well aware, I am retiring effective at the end of the day on July 3, 2018. It is my recommendation that your board appoint Stephan Duckels as assessor for the remainder of my unexpired term of office, as soon as reasonably possible. Stephan won the primary election on June 5.2018 with more than 50% of the vote, thus avoiding a runoff election in November 2018. It is clear that the public is supportive of Mr. Duckels and I believe that Stephan is fully capable of serving successfully in the capacity as appointed assessor until he is officially sworn into office in January 2019, as elected assessor."

The County Administrator, Robert Bendorf, directed Assistant Assessor Kimberly Heish to discharge the duties of the Assessor from July 4, 2018 through August 12, 2018; and appoint Stephan Duckels, Assessor-Elect, as Yuba County Assessor effective August 13, 2018 through December 31, 2018, completing the remainder of the current Assessor's term in office.

Government officials investigated by the Sutter County Grand Jury (GJ) have manipulated and intimidated the jury using its confidentiality pledge to hide damning information about those same officials. Sutter County Public Information Officer Chuck Smith maintains the county has nothing to do with the jury except to fund its work.

Smith says the jury's independence is maintained because it is commissioned to look into various agencies and departments of government. Obviously, the 2017-2018 GJ was not independent of county influence and control. The jury is independent as long as county officials approve of their document's contents.

So, then who in the county has the right to suppress and silence this GJ that represents Sutter County people? When government figures have something to hide, are unethical or criminal, can they remove the report from the public's view? That is what happened.

When you think of the most powerful appointed or elected local officials it may be the County Administrator, Superior Court Judges, District Attorney, Sheriff and County Counsel. The Department of Transportation is the beneficiary of the President's fourth quarter salary of \$100,000. The announcement came one day after introducing his plan to rebuild America's crumbling infrastructure.

The White House announced a proposal to spend \$21 billion on infrastructure in fiscal year 2019, which is the start of a campaign to devote \$200 billion to infrastructure over the next 10 years.

The spending on federal programs would lead to an investment of \$1.5 trillion on roads, bridges, waterways and railways, the White House says.

#### **Dwarfed citrus trees** show potential benefits

The threat of a fatal plant disease has renewed interest in efforts to develop dwarfed

citrus trees. University California specialists have been studying the smaller trees at a research station in the Central Valley. If successful, the dwarfed citrus trees could be grown under protective screening, which would keep out insects that can carry the plant disease known HLB. Researchers started new studies this spring on the dwarfed trees' water efficiency.

#### Food prices have become less volatile

Food price volatility in the United States has stabilized in recent decades, according to a report from the U.S. Department of Agriculture. The study says prices for both food and housing have "enjoyed relative stability" since the 1990s, increasing between 2 percent and 5 percent most years. Food price inflation was lower than average the past two years, due to decreased commodity prices and other factors.

#### Project aids marketing of moringa products

It's a green that grows on trees, and University of California researchers say they hope moringa shoots can become a successful crop for small-scale farmers in the Central Valley. UC specialists say moringa shoots can be added to salads, soups and other foods, and that other parts of the tree--such as its flowers and pods--are also edible. A UC Cooperative Extension project supports farmers in marketing moringa products to new buyers.

The kokanee bite at Bullards Bar continues but the results of fish are larger than last week. The landlocked salmon being caught range from 14 to 15 inches. The spotted bass population, especially the larger fish, have gone deep. boat and recreational traffic has been heavy creating a problem for fishing. Smaller bass are being caught up in the arms of the reservoir.

If you are in the mood for a good catfish feed we suggest fishing at Collins Lake. Most of the trout have gone down to deep water, but the

catfish are still in shallow water and are cooperating with fish being caught in the three to seven pound range, Bass are still available as well as crappie with some crappie being caught up to three pounds.

A check with Englebright Reservoir up above Browns Valley tells us the fishing has picked up a bit but is nothing to brag about at this time.

The bass bite at Lake Oroville has been reported to still be on the good side but success is only had by fishing early and late in the day using top water lures.

Reports tell us fish are available at Lake Almanor by trolling slow and deep using lures and night crawlers. Some bass are being taken fishing deep with plastic lures. The river above the lake was planted last week with catchable trout.

After the big fire around Lake Berryessa all roads are now open and anglers are catching bass all over the lake. Boat ramps are open.

Marysville, Ca.


The Marysville City's consultant continues to make progress on completing the Ellis Lake Study. Staff recently met representatives from the State Water Quality Board ('Board') to discuss the water quality study and, specifically, to seek assistance and clarity on the level of permitting required to address Ellis Lake's water quality issues. Based on the feedback from Board staff, the City is pursuing technical assistance and guidance from the Corps of Engineers to determine agency authority. This additional task has required adding more time to the project schedule.

Ellis Lake Seasonal Changes:


Ellis Lake is prone to poor water quality and odor due to seasonal changes in temperature. especially during the summer months. When lake temperatures rise above a consistent 60 degrees, water quality becomes stressed increasing algae content, diminishing water quality and emitting a strong

odor from the lake. Staff is in the process of adjusting the lake conditions by implementing various treatment measures. It's possible these measures will need to be implemented a few times during the summer months due to the high temperatures and heat.

# Yuba County Probation Team: **Safety and Opportunities**

The Yuba County team dedicated to balancing public safety with a strong belief in an individual's ability to change wants the community to gain a better understanding of what their jobs actually entail.

National Pretrial, Probation, and Parole Services Week, running July 15-21, is set aside as a time to reflect on how the vital work done by agencies such as Yuba County's probation officers and juvenile corrections officers impact those who live here. "Our officers work with

adults and juveniles in the community and in custody to provide them with opportunities for success," said Yuba County Probation Chief Jim Arnold. "This approach includes providing programs and paths of intervention and rehabilitation, enforcing accountability to the Court's directives and with the offenders to address harm done to victims."

Over the past year, the Yuba County Juvenile Probation Unit took in 298 young offenders. During that period, the probation team supervised 66 youth out of custody, seven juveniles were included in a placement program, and numerous youths were also included in a juvenile offender work program. Overall, the probation team completed 228 reports, in accordance with court requests and legal mandates.

Arnold said the community may not be aware that his department also provides four Probation and School Success (PASS) officers to local schools, as part of its charge to supervise youths and to be a resource to each campus. Additionally, his team works with the Tri-County Rehabilitation Juvenile Facility and Camp Singer programs to oversee the safety, care, and custodial status of an average of 24 youths per day in Juvenile Hall and an average of 17 youths per day in the Camp Singer. The Juvenile Probation Unit works with various community programs on a daily basis to provide local youths with the services they need for future success.

The Adult Probation Supervision Unit had an equally busy year, with continued expansion and collaboration in the services provided through community partners and at the Yuba County Probation Day Reporting Center (DRC). Adult clients can find helpful classes at the DRC that include GED/high school diploma programs, anger management, the Courage to Change curriculum and an outpatient drug and alcohol substance abuse treatment program.

The Adult Supervision Unit supervised 780 individuals over the past year. These include felony and misdemeanor probationers, some offenders released from state prison commitments on Post-Release Community Supervision (PRCS), those sentenced to local prison commitments released on Mandatory Supervision, those undergoing intensive substance abuse treatment under Proposition 36, Drug Court clients and others under courtesy supervision.

Some of those supervised were referred to the DRC to have access services offered there. The Probation Department also contracts with two mental health counselors to help clients begin the rehabilitation process through counseling.

Yuba County Superior Court recently saw an increased presence from

Yuba County Probation's Adult Court Investigations Unit during sentencing hearings, plea entries and arraignments. In the past year at these arraignments, Pre-Trial Release officers completed 499 assessments of incarcerated individuals and provided recommendations for their detention status. This process allows the Court to have a brief investigation to assess the potential danger and flight risk of each detained individual.

The Court Investigations Unit completed a total of 932 reports in the past year addressing various mandates such as sentencing, restitution, and bail. The completion of these reports requires a great deal of knowledge of penal law mandates and requirements.



**Comprehensive Needs Assessment** 



When DWR and Kiewit Construction reached the November 1st construction deadline last year, the announced Department it would be conducting a 'Comprehensive Needs Assessment' of the Oroville Dam complex. The purpose of this

assessment was said to identify long-term operational and infrastructure changes that are needed in order to improve safety. Some of the questions

to be answered in this review include: Is a second spillway needed? Is a larger low level outlet needed? Is the 'green spot' a problem? Do the headworks and gates need repairs?

At first, there was no mention of public involvement in this process. But Senator Jim Nielsen and I insisted that the community be represented and have a seat at the table as these critical decisions are being made.

To DWR's credit, they

have worked with us to set up a process where local stakeholders can have a voice. The newly formed ad-hoc group is made up of several key individuals we have been working with since the February 2017 evacuation, including Supervisor Bill Connelly, Sheriff Kory Honea, and Rune Storesund with the UC Berkeley Center for Catastrophic Risk Management.

Starting next week, our local ad-hoc group will begin quarterly meetings with DWR and an Independent Review Board (IRB). These five IRB members are national experts not

eliminating the minimum wage and rolling back age restrictions to operate equipment to 16 years of age. Unions have forced the young people in need of soft occupational skills out of job opportunities.

Unions pressure politicians to increase the minimum wage thereby pricing young, unskilled, inexperienced people out of the job market. Replacing them are "immigrants", taking the jobs of black, white and Hispanic American youngsters. The job-getting advantage that the inexperienced could have against more skilled older workers is a willingness to work for less. The minimum wage removes that edge.

The Center for Immigration Studies (CIS) found that as the number of U.S. teens with summer jobs has dropped significantly, employment of immigrants has doubled.

"Immigrants, legal and illegal, are crowding out U.S. - born teenagers from the labor market," according to the director of research at CIS, and demographer Karen Zeigler. That could be reversed if the minimum wage were eliminated.

Key findings showed the current low rate of teen employment at 41 percent versus 48 percent in the labor force in the summer of 2007 before the Great Recession, 61 percent in 2000, and 64 percent in 1994. In the 10 states with the largest share of immigrant workers, just 36 percent of U.S. - born teens was in the summer labor force.

For young people in the 1960's jobs in the Sacramento Valley were plentiful. Operating tractors, bobtail trucks and forklifts were mastered by 16 years-olds. Today, teens are treated like sissies. No wonder they prefer getting high to being put on pause.

Camarota says, "Researchers have identified several reasons why working as a teenager creates so many shortand long-term benefits. Holding a job as a teenager seems to instill the habits and values that are helpful in finding or retaining gainful employment later in life. This may include showing up on time, following a supervisor's directions, completing tasks, dealing politely with customers, and working hard. Learning good work habits and values seems to become much less likely without holding a job at a young age. Once a person who has little or no work experience reaches full adulthood, learning these skills seems to become more difficult. Other factors also may explain the benefits of early employment. Teenagers may gain social contacts on one job that provide them the opportunity to find their next job as their career develops. In some cases, teenagers may even acquire specific skills that make them more employable, such as basic auto repair or learning to be a shortorder cook. Whatever the reason for the benefits of teenage employment, they are large and longlasting."

# **Sheriff Candidate wants more Deputies & Safer Communities**

The County of Sutter continues to struggle with the same budgetary issues facing almost all of California's 58 counties. Sutter County Sheriff's Office has received grant funding from the US Department of Justice "Community Oriented Policing Services (COPS)" in the amount of \$340,000 for front line law enforcement with an additional \$100,000 to be used in the jail. This funding was not budgeted into the 2017-2018 Recommended Budget and it was noted that "The Sheriff has not yet determined how these funds will be used". COPS grant funding of this nature cannot be used to supplant current County Public Safety funding and thereby does not reduce the General Fund allocation to the Public Safety Fund.

More grant funding is available from the US Department of Justice. In 2017 DOJ awarded \$3,196,132 in funding to California law enforcement departments under the Cops Hiring Program. This federal program has \$98 million dollars in funding available to put more officers on the streets. US Department of Justice also awarded \$3.5 million in Community Policing Development Grants as well as money for Anti Methamphetamine and Anti Heroin Enforcement programs.

Ballistic vests are required to be replaced every five years which creates an ongoing cost to departments across the nation. Every deputy/officer is measured and fitted with a vest that should not be passed on to someone else for use and in no case should be used beyond the 5 year lifespan of the vest. The Bulletproof Vest Partnership (BVP), created by the Bulletproof Vest Partnership Grant Act of 1998, is a unique U.S. Department of Justice initiative designed to provide these critical resources to state and local law enforcement. The program provides funding for new vest purchases for new deputies as well as replacing those vests that have reached the end of their serviceable life.

The California Office of Traffic Safety awards millions in grants every year for Alcohol Impaired Driving, Distracted Driving, Drug-Impaired Driving, Motorcycle Safety, Occupant Protection, Pedestrian and Bicycle Safety and Police Traffic Services.

The USDA even has grant funding available through the Community Facilities Direct Loan and Grant Program. These funds can be used for public safety services such as fire departments, police stations, prisons, police vehicles, fire trucks, public works vehicles or equipment.

Why hasn't Sutter County accessed more of these available funds? Is it because there is no one in the department with grant writing abilities? Perhaps because grants require detailed applications and the ability to handle complex budgets as well as grant reporting.

As an experienced grant writer who has obtained more than \$1 million dollars in grant funding for local law enforcement, I pledge to seek out grant opportunities to augment the Sutter County General Fund, better equip our Deputies and Correctional Officers and put more deputies on our streets to ensure a safer Sutter County for our families and businesses.
