## Nevada City Classic Bike Race

***A Beloved Father's Day Tradition Since 1961  
... and a New Tradition in 2018***

Nevada City, Ca.  
2018 marks the 58th anniversary of the Nevada City Cycling Classic, the second oldest continuously running bicycle race in the country. 2018 also marks year two of the revitalization of this iconic Nevada City event.  
For only the second time in history, the Nevada City Classic will be moved from the traditional Father's Day date to the weekend of June 23-24, 2018. The date change allows the Chamber of Commerce to address a number of issues that were identified as factors to dwindling community support and engagement as well as falling race participation

numbers.  
Not only has the date been changed, but the course for 2018 will go back to the original that was designed by event founder Charlie Allert in 1961. Instead of riders going all the way to the bottom of Broad St., they will turn left onto N. Pine St., cross Commercial St. and proceed past the Courthouse and the relocated start/finish at N. Pine & Church streets before merging back to the course most people are familiar with at York & N. Pine streets.  
2018 will continue to build on changes from 2017. The 2nd Annual Nevada City Mile run-

ning race that takes place on the same route as the bike race will be on Sunday as well. Saturday evening June 23rd will include an expanded edition of the 2nd annual Broad Street Sprints: standing start, straight line, four riders at-a-time, head-to-head all-out battle up Broad St. This event will be combined with a brewfest type event and free live music immediately after the sprints finish...right on Broad St.  
The Nevada City Chamber of Commerce is looking forward to Nevada City and the surrounding communities coming out to this all-inclusive, family-friendly event weekend.

## Initiative to Split California Qualifies



An initiative that would divide California into three separate states qualified Tuesday to appear on the ballot in November's general election.  
Californians will vote whether to separate into three states: California, Northern California and Southern California — subject to approval by US Congress.  
The proposal by venture capitalist, Tim Draper to break up California in a campaign called "Cal 3," received more than 402,468 valid signatures — surpassing the amount required by state law.  
California Secretary of State Alex Padilla will certify the initiative as qualified for the November 6th ballot on June 28.

## Illegals and Family Separation

A recent example is the coordinated contrived media uproar over illegal children supposedly "forcefully separated from their parents at the border." The entire story is a crock of crap.

Ariel Cuellar Guizar will face thirty-one years in prison for charges relating to his activities as a human trafficker. He was found guilty of trafficking, pimping women out to prostitution, and the rape of a fifteen-year-old girl. Guizar will also be registered as a sex offender for life. (ABC 7, July 20, 2017)  
Pasqual Mendez, 24, of Morganton, was given a prison term of 12 to 19 years for felony human trafficking of a child, assault on a female, interfering with emergency communication and statutory rape of a child less than 15 years of age (News Herald, May 23, 2017)  
On April 27, 2002, Ronald da Silva was standing with a friend in his driveway when he was shot and killed by an illegal alien who had been previously deported. The illegal alien was sentenced to 21 years in prison but will be released in 2020.  
Tessa Tranchant, 16, was killed on March 30, 2007 in Virginia Beach, Virginia. Tessa and her friend, Ali Kunhardt, were at a stoplight when Alfredo Ramos, an illegal alien from Mexico, was intoxicated and speeding, rear-ending their car. Ramos had numerous prior convictions, but due to Virginia Beach's sanctuary policies, he was never detained. He was charged with two counts of involuntary manslaughter and sentenced to 40-years in prison.  
Sarah Root, 21, from Omaha, Nebraska was killed on Janu-

funds are legally restricted to emergency services. The rest of the budget is fungible or exchangeable. Other emergency service funds can be transferred from law enforcement for others.

That's how we got into this predicament. Supervisors used the sheriff's budget elsewhere while relying on the Immigration and Customs Enforcement (ICE) monies to fund the sheriff's department. Supervisors have overcommitted to the salaries and pensions of more than 1,000 employees thereby shorting the sheriff's budget.

The county has little concern for saving costs. A recent 6"x11" two-sided multicolor glossy mailer warning about wildfires went to every household, business and post office box holder in the county, probably in excess of 30,000 pieces. Many people received 2 or more copies. The Marysville Post Office was littered in wasted mailers.

Why would people living in Marysville, Plumas

Lake, Edgewater, Olivehurst and Wheatland housing tracts be served a notice that they are required by law to create 100 ft. of defensible space around the house to survive a wildfire? Most residential homes are separated by 15-30 feet and have never been threatened by wildfire. Do the hill residents get the flood warnings that valley people receive? That's crazy. Why this waste?

What business in the private sector would send mailers to people that have no need of the information or product? Would Yuba County pitch bikinis to Eskimos?

Many in government couldn't care less about saving money. Decision-makers do not seek the best price for the same or better product. There is no accountability or conscience.

In fact, the entire system encourages waste and cronyism. As an administrator if you don't spend your budget it is reduced the following year. "Good" bureaucrats

grow bureaucracies, not become more efficient and shrink the department.

That's why President Trump's move to drain the swamp is mocked, despised and hated. It's even fashionable by some local so-called conservative politicians to praise Trump but do just the opposite. While federal employment is shrinking, county and state government is growing. We have a socialist Kommifornia because Republicans act just like liberals.

Some are saying that last week's sales tax road show in Wheatland should have been properly noticed as a public meeting according to the Brown Act. There was a quorum of Supervisors present and it was a government organized event. With a county office of attorneys how could that have been missed? The name of the game now is Crappie at Collins Lake. The fish are on the move and are striking anything that shines in the water along with jigs and worms. One of my favorite crappie lures is a jig or small spinner with white color.

A spot check at local reservoirs resulted in the following report: FOLSOM LAKE is almost full and the lake is also full of skiers and wave runners. Anglers are around early in the morning with some good results catching fish on the north shore using plastic lures. BULLARDS RESERVOIR is still on the bite for kokanee but action has slowed down at this time. ENGLEBRIGHT RESERVIOR has a few anglers out on the water but the action has been slow. CAMP FAR WEST RESERVOIR fishing has slowed down. Spotted bass which are being caught range between one and a half pounds up to around two pounds. LAKE OROVILLE king salmon have decided to slow down a bit and the bite has done the same. Bass are being caught casting to shore and retrieving your lure back to the boat. However, the bass bite is on again off again with one day being successful and the next day getting skunked. The fishing at SCOTT'S FLAT RESERVOIR has really slowed down at this time.

Trout have been planted all over the state with the following local

waters receiving catchable trout: BUTTE COUNTY: Big Butte Creek; EL DORADO COUNTY: Echo Lake and Stumpy Meadows Reservoir; NEVADA COUNTY: Donner Lake Park, Coldstream Park and Prosser Reservoir; PLUMAS COUNTY: North Fork of the Feather River, Antelope Reservoir,

Snake Lake and Lake Almanor; SIERRA COUNTY: South Fork of the Yuba River at Downieville; TEHAMA COUNTY: South Fork of Battle Creek and Deer Creek.

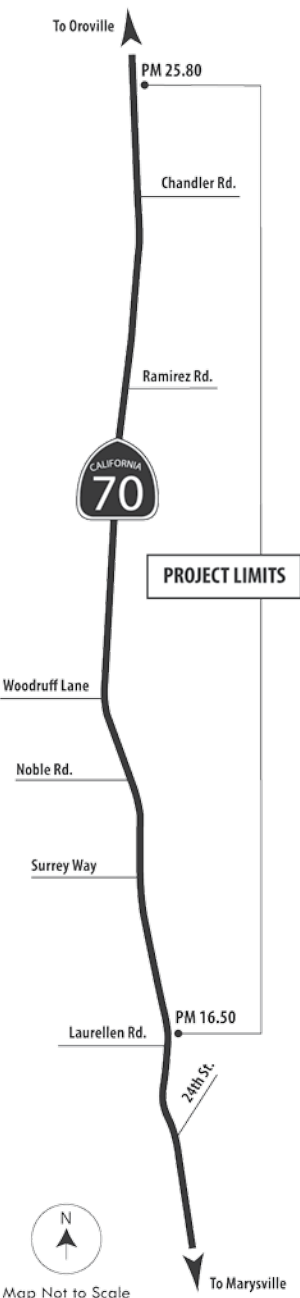

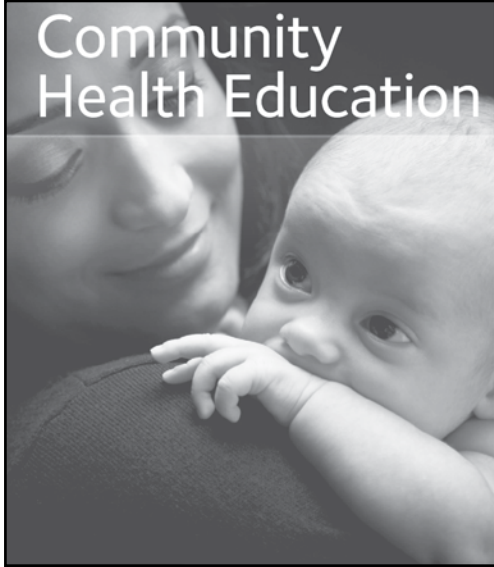

## What is ONEROUS is North Yuba Water District

It seems as though the quote of losses on both the Forbestown Ditch and the Oregon House/Dobbins Irrigation Canal are stagnant. The 60% loss on the Oregon House/Dobbins Irrigation Canal has been quoted as 60% since the late 80's.

The NYWD received a loan from the Yuba County Water Agency in the mid 1990's to gunnite a very leaky portion of the ditch. Since then, NYWD received two grants from the California Department of Food and Agriculture with the cooperation of the Yuba County Agricultural Commissioner(Dennis Pooler) at the time, to gunnite two sections of the irrigation canal due to invasion of hydrilla(a noxious weed) introduced into the ditch.

The major change under the new manager regime is that there has not been any ditch tenders to maintain the ditch. In years past, two seasonal workers full time job was to maintain the ditch. Also, NYWD had a foreman who was very dedicated to maintenance and repairing leaks. He left the district because of conflicts with the current Manager.

Before 1992 when NYWD attorney, Alan Lily was instrumental in perfecting our pre 1914 water right on Dry Creek which is for irrigation and fire protection purposes for Oregon House and Dobbins. NYWD had only 3700 acre feet of water, which is stored in Little

Grass Valley Reservoir, to serve both the domestic customers and the irrigation customers. Never was there a problem delivering irrigation water to Oregon House and Dobbins. Also, there were many years NYWD did not use its' full allotment. Now in addition to the 3700 acre feet, NYWD has the full flow of Dry Creek from April 1st to October 15th, minus 4.0CFS for fish flows, plus an additional 15,500 acre feet stored in Little Grass Valley Reservoir.

What is ONEROUS is that after the 2005 Agreement with South Feather, the NYWD acquired a pre 1914 water right on Oreleve Creek which supplies the Water Treatment plant with sufficient water in late Fall, throughout the Winter months.

Also ONEROUS is that after the 2005 Agreement with South Feather, the NYWD also acquired an additional 15,500 acre feet of water to serve its customers.

During the ONEROUS Prop 218 water rate increase that was rejected by over 51% of the customers in both the domestic and irrigation service area, the quotes used for the leakage on the Forbestown Ditch were over 60% not the current quote of 30%. Really, lets' get our losses right.

The Irrigation customers of Dobbins and Oregon House are being told that there is no water and the ONEROUS 2005 Agreement with those

folks at South Feather are the reasons why irrigation was not turned on. South Feather has agreed to work with us again, like in 2016 when we needed more conveyance room in the Forbestown Ditch.

As further background, the Yuba County Water Agency's Yuba River Development Plan written in the late 1950's, the Bookman Edmonstons Feasibility Study and the most recent Kennedy Jenks Feasibility Study all clearly demonstrate that the Oregon House/ Dobbins communities are best suited to receive irrigation water because of the rich soils and Mediterranean climate for growing agricultural products. These Feasibility Studies clearly demonstrate that the additional 15,500 acre feet can be used to serve the 119 current customers and the over 1500 annexed customers who pay taxes and get no service of water.

It would be onerous if the State Water Resource Control Board would not see NYWD using their water for beneficial use to its irrigation customers and in fact denying their customers service. And it is the mandate of that agency to do so.

## YC Obligation to Walton Area of Yuba City for Police Service

Yuba City council member John Buckland stated an obligation to the area of Yuba City referred to as the Walton area. That obligation is to bring Yuba City police services to this area. And he said “eighteen years is too long”. He refers to their annexation into Yuba City in Yr 2000. He stated if the annexation of the “Key Hole” area failed Yuba City would still be obligated and need to renegotiate the master tax exchange agreement. (MTEA)

The city officials and county officials in Yr 2000 agreed that police would only begin service in the Walton area if a target level of 82% of the parcels in the combined area of Walton and “Key Hole” area were annexed into Yuba City. Was that made clear to new city residents annexed into Yuba City? So Yuba City tried to annex the “Key Hole” area in 2003 and failed by a 2/3 vote against. The

sheriff continued law enforcement for the Walton area. And CHP handled traffic enforcement. Yuba City officials then left the Walton area of Yuba City hanging out to dry for another 12 years. Finally in 2016 they began another attempt to annex the “Key Hole” area. Not knowing how badly they were beaten in 2003. Pretty amazing arrogance to assume the “Key Hole” area would just roll over like a dog doing tricks and agree to be annexed. YC council was told at the time in 2016 to just change the MTEA and save a lot of time and money. YC taxpayers pay the entire cost of an annexation attempt. “Key Hole” residents do not pay a single dime.

Two years into this annexation effort by Yuba City has so far shown a majority of residents still do not want to be annexed. But the vote counting is being finished at this time. So

anything could happen. At least now the Walton residents who want YC Police dept service can hope that it might happen soon. Without a change in the MTEA they might have to wait for another annexation attempt. Any future annexation will be over my dead body.

### NYWD Claims Not Supported

In early April 2018, North Yuba Water District irrigation customers received a letter authored by Jeff Maupin, General Manager, North Yuba Water District (NYWD), informing the customers that irrigation water would not be released this year. This notice was received less than two weeks prior to the annual date of the release of irrigation waters (April 15) into the Oregon House-Dobbins Water Canal. Irrigation customers were outraged and have attended all NYWD board meetings in an attempt to get answers as to why irrigation water is not being released.

Requests by the public for the board to place the issue of withholding irrigation water on the agenda have been ignored by this board and general manager. The decision to withhold water this year was a unilateral decision by Jeff Maupin and was not voted on by the board. This is allowed during a period of water shortage; however, 2018 is not one of those years.

Reasons given thus far by NYWD to refuse delivery of irrigation water:

1. Shortage of Water – Data do not support this. Water over the Taco Bell bridge is approximately 30-40 CFS and was approximately 80 CFS one month ago. “We had a slow start to the water year, but several late spring storms greatly improved conditions and have left us in a good position heading into the summer,” said Scott Matyac,

water resources manager for the Yuba County Water Agency (Appeal Democrat 06/14/2018). “Along the Yuba River, New Bullards Bar Reservoir was at 94 percent of its capacity as of Wednesday, or 111 percent of its historical average for the date. Englebright Lake was at 95 percent of its capacity, or 99 percent of its historical average. The snowpack was much less this year compared to last, **but the late storms provided significant reservoir inflow, so we have plenty of water in storage at this time,**” he said..... reservoir storage is good this year and the agency's member units can expect full deliveries.

2. NYWD is Working on the Ditch – No, the agency is not working on the ditch. It is now two months since water should have been released. No work has been done, no engineering plans for repairs have been prepared, no contractor has been hired, and no operator has been hired to operate the excavator NYWD purchased. NYWD, however, is planning to spend another \$17K to buy a trailer for the excavator sitting idle.

3. Unhappy Customers - NYWD states that water would not reach the last customers on the 03 line and NYWD would then have unhappy customers ([https://docs.wixstatic.com/ugd/ce9012\\_e5e8bce755bc49d5ba734f3450039bf6.pdf](https://docs.wixstatic.com/ugd/ce9012_e5e8bce755bc49d5ba734f3450039bf6.pdf)). They therefore, decided to withhold water from all customers. Were

the customers at the end of the 02 and 03 line surveyed for their opinions? I am on the 03 line and I definitely was not interviewed, and I would definitely not vote to withhold water from everyone just because I would not personally receive any water.

Throughout my 25+-year career as a professional biologist, I have worked with numerous irrigation and water districts. Not once have I ever personally witnessed shutting down a water source for any significant length of time, let alone an entire irrigation season. When asked about this approach to water, BVID stated that they “work on their earthen ditches during the off season (October through April) and the line is never shut down for more than a day or two at most”. The data do not support the claims of NYWD – WHAT IS REALLY GOING ON? Where is our water going? Where is the money gained through power generation and taxes going if not for personnel and maintenance? Why is the board sitting mutely by and allowing a General Manager – who they oversee and who works for this community - to run the show unchecked? Why was the public not brought into this decision-making process? What are they NOT telling us? Why is there no transparency and accountability? We need answers and the Oregon House-Dobbins Water Association will continue to work for this community to get those answers and to get our water released.

We get lots of calls after a fire, but by then, it may be too late.

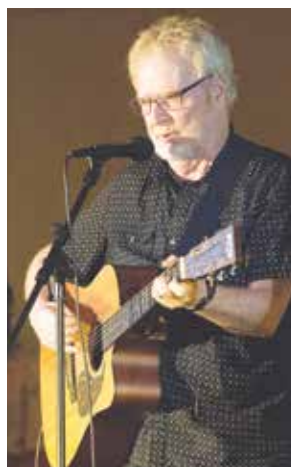

## A "State of the Arts in Yuba-Sutter" Convening at Yuba Sutter Arts

### Community Discussion on Preparing a Cultural Plan and Annual General Membership Meeting

Marysville, Ca. Yuba Sutter Arts will host its first "State of the Arts" convening on Wednesday, June 27 at 6pm. The purpose of the meeting is to discuss all aspects of the arts and culture in Sutter and Yuba Counties and to begin development of a "cultural plan." The public is encouraged to attend this free event in the Burrows Theater at Yuba Sutter Arts, 630 E Street in Marysville. Refreshments will be served.

Following a brief meeting during which the Yuba Sutter Arts Board of Directors will elect its new slate of officers, David Read, Executive Director, will make a presentation about recent Arts Council accomplishments and future plans and then open up a discussion that will begin the process of creating a community-wide, comprehensive and detailed cultural plan for Sutter and Yuba Counties.

A cultural plan is based on a broadly defined understanding of culture with integrated goals compiled through community consultation. Cultural assets include facilities and/or organizations involved in the programming, production, presentation, and/or exhibition of cultural disciplines—such as

music, dance, theater, literature, visual arts, and history museums and historical societies as well as schools at all grade levels including pre-school. These facilities can be used as a launching point for a broader cultural plan. In the past two decades, cultural facilities have been seen by artists, arts organizations, government officials, urban planners, and communities as key anchors to the revitalization of distressed communities.

Two years ago, the California Arts Council began a Cultural District project encouraging communities to celebrate their heritage, their people, places and traditions and events. Nearby Nevada County has achieved Cultural District status which has opened the door for additional and increased funding. Yuba Sutter Arts will work with all local stakeholders in the year ahead to identify and recognize the breadth and diversity

of our cultural assets. As the designated State-Local Partner for Sutter and Yuba Counties, Yuba Sutter Arts is in a unique position to lead the efforts to build on the solid foundation that exists in our schools and our well-established local arts and cultural organizations. California's economy is steeped in the arts with one in ten jobs being part of the creative economy with benefits to the state in billions of dollars. Yuba and Sutter Counties should also look at their economies in terms of the potential economic benefits of the arts with the understanding that much work still needs to be done.

Yuba Sutter Arts will continue to support the success and growth of our community by promoting cultural vibrancy and community involvement, access, equity and diversity and arts education.

ary 31, 2016. Her SUV was rear-ended by Edwin Mejia, an illegal alien from Honduras, who was street racing. Sarah had just graduated from Bellevue University with a 4.0 GPA the day before the incident.

Omaha is in Douglas County, Nebraska which has sanctuary policies that impede local law enforcement's ability to cooperate with immigration officers. Mejia was charged with motor vehicular homicide but posted bond to get out of jail and was released. He is still on the run.

Igor Zubko, an illegal alien from Russia, killed Shayley Estes on July 24, 2015 in Phoenix, Arizona. Shayley obtained an order of protection against Zubko just 10-days before her murder, but he entered her home and fatally shot her. Zubko entered the U.S. legally, but overstayed his visa and remained here illegally. He is in custody with first-degree murder charges.

Roberto Galo, an unlicensed driver from Honduras who entered the U.S. illegally but earned temporary protective status (TPS), killed Drew Rosenberg, a second-year law student, on November 16, 2010 in San Francisco. Rosenberg was riding his motorcycle when Galo ran over him three times with his car. Galo was convicted of vehicular manslaughter and sentenced to 6 months in jail. US Immigration refused to deport him and he was released after serving only 43 days. Thanks to the Rosenberg family's activism, Galo was finally deported on April 4, 2013.

Apolinar Altamirano, an illegal alien from Mexico, murdered Grant Ronnebeck on January 22, 2015 in Mesa, Arizona. Ronnebeck was shot over a pack of cigarettes while he was working at a convenience store. Altamirano killed Ronnebeck while out on bond from a previous conviction while ICE (Immigration and Customs Enforcement) determined

whether he should be deported.

These egregious crimes would never be committed by illegals if the borders were closed. Yes, it's true. Thousands have experienced "family separation."

## Food and Farm News

### Market uncertainty follows trade tensions

Trade disputes between the United States and some of its partners have led to market uncertainty for California agricultural exporters. China placed new tariffs on farm products earlier this spring, in a disagreement about steel and aluminum trade. Exporters of California nuts, for example, say Chinese buyers have postponed purchasing decisions as a result. Canada, Mexico and the European Union say they also plan new tariffs on products including farm goods.

### Farm exporters visit Japan

A dozen California-based companies are among those exploring agricultural export opportunities in Japan this week. The U.S. Department of Agriculture organized the trade mission, which also includes representatives of state agriculture departments. Japan represents the fourth-largest market for California farm exports. California companies participating in the trade mission sell rice, nuts, fruit drinks, dairy foods, prunes and other products.

### Potential for larger timber harvest encourages foresters

With millions of dead trees remaining in California forests, people in the timber business say they're encouraged by a plan to increase logging on national-forest land. The California Forestry Association says the timber target announced by the U.S. Forest Service could be the highest in 20 years. With continued dry weather and California wildfires becoming more destructive, forestry leaders say it's crucial to reduce the fuel load in national forests.

### Pest moves from city to country

It's been a pest in urban areas of California for more than a decade, and the brown marmorated stinkbug has started to move into agricultural zones. University of experts say the stinkbug began causing damage in orchards and vineyards last year, and more impact has been seen this year. The bugs feed on a variety of plants. The brown marmorated stinkbug has become established in 16 counties and has been trapped in 18 more.
