civic generosity of Mary and her family to allow their land to be used to build Sites Reservoir so that millions of Californians can have safe and reliable drinking water."

"Throughout my lifetime, I have found achieving good policies and actions to be rewarding. But this honor really highlights my many years of work in water, agriculture and women in agriculture," said Mary Wells.

Mary also served on the Tehama-Colusa Canal Authority Board for 20 years with a focus on resolving the Red Bluff Diversion Dam fish passage and reinitiating Sites Reservoir.

As one of the founding direc-

tors of Northern California Water Association (NCWA), from 1992 to 2007, she served as Secretary/Treasurer to the Board and held the office of Chairman from 2001 to 2007. Last year, NCWA celebrated its 25th year with a generational testimonial video honoring its founding directors.

"Sites Reservoir is very important to me. Water storage is critical to future generations, and we as a family are willing to make the sacrifice to give up our family land to build Sites," said Mary Wells.

"I am so honored, and I thank Senator Jim Nielsen for this recognition and his work for California."

## Education Tyrants

Thousands of students around the country were hustled by second amendment foes to walk-out of school last week to memorialize the deaths of 17 students in a Florida shooting. However, the rallies were tainted by anti-gun ownership propaganda and acts of violence by those supposedly there protesting violence.

Rocklin High School history teacher Julianne Benzel was placed on administrative leave for discussing the merits of the upcoming protest 2-days prior to the event. The question she posed to students was too much for liberal government schools. She asked whether students with strong views about other important causes like abortion should also be permitted to leave class to protest.

Out of more than 120 students two complained along with one parent that she would prompt a discussion of the merits of releasing students to protest. The shame is that most students were clueless that they were pawns in a political war over the future of the Constitution itself. Last week's student protests likely will leave them less safe than they were before if liberals get their way.

Amy Wax, a University of Pennsylvania tenured law professor specializing in Social Welfare Law and Policy has been disciplined following statements she made about the lack of black student achievement in her required first year course. She now will only be allowed to teach electives after complaints from some teachers and black students.

Penn Law Dean Theodore Ruger said Wax spoke "disparagingly and inaccurately" when she claimed that "rarely, rarely" had she seen a black student finish in the top half of her class. However, in an article in the Daily Pennsylvanian about the petition to discipline her, Wax said plainly that "student performance is a matter of fact, not opinion. It is what it is."

The professor's original remarks came in an interview she gave in September 2017 with Brown University professor Glenn Loury titled, "The Downside to Social Uplift."

"Here's a very inconvenient fact, Glenn, I don't think I've ever seen a black student graduate in the top quarter of the class, and rarely, rarely, in the top half," Wax said in the video, which discussed affirmative action policies. "I can think of one or two students who scored in the top half of my required first-year course."

Although Wax's specialty is Social Welfare Law she is forbidden to cite statistics on student achievement that question affirmative action policies. She could probably give stats on the lack of whites or Asians in the NBA with no backlash.

Before her video remarks were attacked, an August commentary written by Wax and another academic stirred controversy for advocating a return to a "bourgeois" era in American society.

"All cultures are not equal. Or at least they are not equal in pre-

## State Fire Mismanagement



It has been very cold out there this week with snow dropping down to 4000 feet. However, the trout have finally been on the bite at Collins Lake above Browns Valley with some nice trout being taken with some fish being turned in up to seven pounds. Best bet, according to our source, is to troll shallow or bank fish on the beach or near the dam.

Snow is still around at Lake Almanor but boats doing the fast troll are picking up some fish at the north end of the lake. This source advised rainbow and brown were taken but the fishing at this reservoir has been tough. In addition, they expect more snow and/or rain in the upcoming week.

Mackinaw and rainbow trout are hitting at Donner Lake. The snow is down to the water and most success is fishing from shore. The ramps have been plowed.

If you want to catch a mackinaw lake trout we suggest you head up to Lake Tahoe. At this time limits are common. Best bet is to leave the boat home and charter a boat from one of the marinas. We are told the fish are hitting all over the lake.

If you plan on going up to stampede Reservoir any time soon we advise you to change your plans. The area is snowed in with some water available for bank fishing by snow mobile.

We hear from Bullard's Bar Reservoir. Lots of bass being caught but most are small. Expect

things to improve later on when the rains stop.

We advise holding off on fishing Camp Far West at this time. The water temperature three days ago was below 50 degrees.



## Interest Rates Gas Pedal of Economy

Interest rates are said to be the gas pedal of the economy. Interest rates are set by our central bank called the Federal Reserve here in the United States and other countries have their interest rates set by their central banks. This is one kind of what is called monetary stimulus which means altering the money supply in circulation. You could call it the gas pedal the Fed pushes up and down in the hopes of steering (some say manipulating) the economy.

As interest rates drop, borrowing is easier and therefore credit flows increase for consumer credit (margin debt, credit cards, home and auto loans to name few), business borrowing (corporate bonds and lines of credit), banking and financial institutions (acquisition, mergers and finance), and the bond market in general (the feeding trough of business and governments). All this money from low rates goose upwards.

Low interest rates are thought to be one of the main elixirs for an ailing economy. Recessions, depressions and in recent times, stock market sell offs have all been addressed by central bankers lowering rates.

Conversely if the economy overheats which means inflation would rear its ugly head in an unacceptable rate, the Feds would consider raising rates, lifting off on the proverbial gas pedal of monetary stimulus.

Many analysts argue this is far from a perfect science and one could argue just by the fact we continue to have economic tsunamis from time to time (depressions, recessions, banking crisis) that either the gas pedal doesn’t work so well or the Feds aren’t very good at using it. My vote goes to checking the “all of the above” box.

The inherent problem with interest rate manipulation is it takes a while to work its magic. Sort of like steering the Titanic. Goose the engine and the ship is so big it takes a while to get going. Go too fast or fail to see an iceberg far enough ahead and you can’t turn or stop it in time to avoid a crash. So goes the mechanism of interest rates. There is a bit of a guessing game mixed with a crystal ball type of reality that means a wheel is only as good as those steering it. That’s not to say the Fed doesn’t know what it’s doing. It literally has thousands of economists peering into the blackness of prognostication all hoping their general consensus of what’s ahead is correct.

But the lag in the gearing of interest rate manipulation is a fact and that lag

is what I call the missing link in using it successfully. The scale by which interest rates work their magic (or poison at it may be) is tremendous. Small movements up or down in rates and the amount of money that is affected is beyond comprehension. Literally trillions of leveraged dollars in the global economy gear up or down depending on the direction of the move. The more debt there is, the more the effect and Lord knows we have a lot of debt both domestically and globally.

Think of the Feds task in fictional terms of waking a cyclops. Don’t shake hard enough and he won’t get up. Shake him too hard and he’s likely to throw a fit and tear the hell out of the surroundings. Yes, it’s an odd analogy but you get the point: one has to be VERY careful when messing with interest rates.

There are those who argue against the very idea of manipulating interest rates in any way. After all, interest rates are said to be the price of money, and the argument goes that the price should be determined by those using it and not by some arbitrary small group of ‘experts’.

Much like going to a grocery store. Would you rather decide yourself what to buy and how much you pay or would you rather have that determined by someone else?

Whatever the belief, the fact remains right now and since its inception in 1913, the Federal Reserve determines interest rates here in the U.S. Another fact is rates have been at or near historic lows for 8 years. This means the gas

pedal has been pressed to the proverbial floor for an unprecedented amount of time. Some argue the pedal is not working and some argue its working just fine. I guess it all depends on where one sits. It could be argued the super wealthy seem to think we are cruising along just fine while others are wondering when they’ll see some movement.

Whatever the view is from your seat, my real concern is whether we’ll hit anything along the way.

## Sheep ranchers report strong lamb market

Easter remains the biggest time for American lamb consumption, but the holiday doesn’t have much influence into when California ranchers market their lambs. Most California-grown lambs are born in the fall and marketed after Easter, with many being sold directly to restaurants and other customers. Both ranchers and marketers report strong demand for California lamb this year.

## Projects aim to benefit honeybees

Research to improve honeybee health includes a multi-year project at the University of California, San Diego. Scientists have been testing a way to immunize bees against

a fungus known as Nosema. If successful, the researchers say, the tests could lead to a new way to treat honeybee fungal diseases. Meanwhile, the U.S. Department of Agriculture announced an international project to seek new controls for a honeybee parasite called varroa mite.

## Rat problems emerge in orchards

It seems to be a good year for rats in California orchards and fields, according to a University of California specialist--and that means farmers have been taking extra control measures to protect crops. UC farm advisors say they’ve spotted roof rats in Central Valley orchards. In rural settings, the rats

often burrow into the ground, then climb trees at night. Farmers have used bait stations tied to tree limbs as a control method.

## Imports of apparel, textiles set record

The expanding U.S. economy boosted demand for clothing, which led to record apparel and textile imports. The U.S. Department of Agriculture reports growth in athletic and leisure wear has increased demand for synthetic fibers, so synthetics accounted for half of the import total. Cotton products made up more than 40 percent of the imports. The report says overall cotton consumption in the U.S. remained virtually unchanged last year.

Who Runs Sutter County?

Several months ago the Sutter County Supervisors voted unanimously to immediately enforce its "No Camping" ordinance. However, county CAO, Scott Mitnick, apparently decided that the supervisors did not have the authority to order him to proceed with the enforcement. As a result, he

instructed Sutter County employees not to enforce the ordinance and to allow the continued pollution and destruction along the Feather River. The fact that Scott Mitnick has a home and family in Ventura County may explain why he has no regard for the health and safety of Sutter County

residents or the devastation of one of its most treasured natural resources. However, it does not explain why he believes he has the authority to disregard the unanimous decision of elected Sutter County Supervisors. Mike Johnston Sutter County, Ca.

“YC Taxpayers Fleeced by County Fire Area”

Yuba City Taxpayers are being fleeced by a county fire service area named CSA-G since 2001. The total amount now could be roughly \$2 million dollars. The latest year available is 2015 when Chief Daley estimated his unrecovered costs of fire service to CSA-G was about \$126,000. Based on a very rough projection that would produce the \$2M from now back to 2001. What happened is simple! In 2001 Yuba City managers and Council approved a merger with Walton Fire Department in their discussions with Sutter County and the Walton Fire district. What is the current plan for solving this problem? Yuba City Council and senior staff think they can annex their way out of this subsidy of a Sutter County Fire Service area. So they just whine about the problem at council meetings where annexation is an agenda item. In early 2015 then

Mayor Buckland said that 'the “Keyhole” area near Yuba City was getting fire service from Yuba City. And YC was paying for it'. It turns out to be only partly true. It is not free service to the “Key Hole” area but it definitely is subsidized service. Meaning that only 88% of fire service costs to that area are covered by taxes turned over by Sutter County. The Walton Merger agreement provided for property taxes to be turned over to the city on a “pro rata” basis. So if annexation of the “Key Hole” area occurs there will be no increase in fire department funds. Just a change in the boundary of the city limits. But most of the subsidy will remain a problem even if the “Key Hole” area is annexed during the June 5 vote. Not even YC Fire Chief Daley knows how much of the subsidy problem will reduce since it requires a tedious analysis to forecast this. The “Key

Hole” area is one square mile while the total CSA-G is nearly 18 square miles. If any YC taxpayer is not pleased to be paying for county residents subsidy of fire service they should contact their city council. Darin Gale is the public affairs person to call at Cell 953.6886 So what is the bottom line here? In my view YC management should take the initiative to renegotiate the Walton merger agreement. Even if it means undoing the Walton Merger and rolling it back to a county responsibility. It will be an extremely long time before YC grows 18 square miles. “Key Hole” residents may request a “Vote by Mail” ballot well in advance so it can be mailed to them. ## YCWA and Cordua Resolve Lawsuits

Marysville, Ca.

Yuba County Water Agency and Cordua Irrigation District are beginning a new chapter in the story of their relationship, having moved to one of collaboration and partnership, with the finalization of a recent settlement agreement.

Both entities today exchanged settlement checks, resolving several long-standing disagreements, including two lawsuits.

"Just as important as resolving old disputes, this settlement agreement provides a foundation for future cooperation and collaboration between YCWA and Cordua," said YCWA Chairman Brent Hastey.

The procedures specified in the settlement agreement will expedite YCWA's approval of Cordua's 2018 water transfer program, resulting in significant Cordua efficiencies and cost savings, while maintaining

measures to avoid adverse impacts to other water users.

"Yuba County is fortunate to have a nearly 100-year-old irrigation district in Cordua and an entity like YCWA managing the water and power resources for its citizens," said Charley Mathews Jr., Cordua Irrigation District board member. "When water is involved, there are always situations where disagreements arise, but the professional courtesy exhibited by both sides moved what was a disagreement into a better understanding of the value of a long-term relationship going forward. The winners in the end are the citizens of Yuba County."

The lawsuits and disputes between YCWA and Cordua that this agreement resolves include:

1. A lawsuit against YCWA seeking approximately \$4.5 million in damages for a dispute

dating back to 2015, in which YCWA did not approve a Cordua proposed groundwater substitution-based water transfer and sale.

2. A lawsuit against Cordua claiming California Environmental Quality Act and Brown Act violations relating to Cordua's 2016 approval of a CEQA addendum for its groundwater substitution transfers to State Water Project contractors for 2016 through 2024.

3. A YCWA and Cordua dispute over the price owed by Cordua to YCWA for Yuba River Development Project water delivered in 2016.

Under the agreement, the lawsuits are dismissed and YCWA paid Cordua \$675,000 to resolve the 2015 transfer request lawsuit, and Cordua paid YCWA \$60,000 to resolve the 2016 project base supply billing dispute.

## \$40 Billion Rural Broadband Proposal

Last week, Senate Democrats pushed their proposal for a \$40 billion investment of federal funds in rural broadband deployment projects. Democrats call for a "Roosevelt Plan" that will bring internet to every American in the United States, including rural areas that are less profitable for the private sector.

The \$40 billion investment will be allocated using the following principles:

1. Provide Direct Federal Support for a Universal Internet Grant Program to Close the 'Last Mile' Gap. 1. Focus on those areas that need adequate, affordable high-speed internet the most.
2. Upgrade existing infrastructure where reasonable.
3. Leverage competition to make sure federal resources are used most efficiently.
4. Use Tax-Payer Resources Responsibly.
5. Tackle the Tribal Broadband Gap.
6. Create Accurate Maps of Areas that Lack Adequate Internet Access.
7. Deliver Internet Speeds Needed to Compete in the 21st Century.
8. Upgrade the Nation's Critical Safety Infrastructure.

The Democrats' proposal matches Federal Communications Commission (FCC) reports that estimate it will cost \$40 billion to bring broadband to 98 percent of the country. This approach would not only invest directly in broadband deployment projects, but will include investments in broadband mapping data to help providers pinpoint the most underserved areas.

# State Fire Mismanagement

standing it.” Whether it is ruining the timber industry, insane forest management and even ‘stand and watch’ fighting of forest fires, whoever will write the biggest check wins the argument.

Then, the San Diego Tribune brings up the fact that Cal Fire’s use of state prisoners or ‘slave labor’ to fight forest fires has allowed employed firefighters to cash in on exorbitant salaries.

Of course, prisoners love fire camp duty. It is better than prison life. They are out and about and learn marketable skills. They make more money than being “inside.” Pay is \$2 a day plus \$1 an hour, and meals and hygiene supplies are superior.

Well, let’s not get stuck at those ne’er-do-wells are getting a great deal. This chump-change-earning chain gang is toiling side by side with firefighters collecting enough on a strike team to return home and order a new car. And, state officials say using prison labor saves their budget \$100 million a year. Firefighter union leaders are

drooling.

The medium compensation for Cal Fire firefighters is \$148,000 and the typical battalion chief is getting \$15,800 per month. However, the ranks of Cal Fire workers are loaded with those earning in the \$200,000 - \$300,000 range.

According to Robert Fellner of the Nevada Policy Research Institute, when you add up the entry level average pay (\$27,713) for 1,500 seasonal workers (9 months) including their “other pay” (\$15,676), and overtime (\$11,410) and pensions (\$26,848), they’re compensation is at \$81,647.

In late 2017, Cal Fire employees were set for a wage increase, ranging from 8.5 percent for the \$189,600 per year battalion chiefs to 22.3 % for low-ranking firefighter/paramedics. However, the complicated formulas determining firefighter pay masks from the casual observer what is truly paid out in the end.

And this formula does not include retirement pension liabilities (promised but not budgeted)

that the taxpayers are on the hook for. However, if you think this pay is high, Cal Fire employees are paupers compared to city and county firefighters.

California Policy Center shows the average compensation package for county firefighters is above \$196,000 and for city firefighters is above \$198,000, which is more than \$50,000 a year in average total compensation above those at Cal Fire.

Some argue that state firefighters have a tougher job than the locals, since they are focused on wildfires when only 8 percent of local calls are fire responses. Most city and county call-outs are for medical assistance.

So, city and county firefighter higher pay is not attributable to more dangerous work than state firefighters nor is it reflective of free market supply and demand. There are hundreds applying for each job opening. Actually, many will do the job for no pay. Nationwide, 70% of firefighters are volunteers. It is at 30% in California.

The high pay is linked to political clout. Although the fire unions have leverage at the state level they have to compete with special interests and many other unions wanting a bigger slice of the budget.

Firefighter union intimidation has greater impact at the local level on council members and supervisors that depend on union endorsements and contributions to get elected. Candidates are fearful of being tabbed anti-public safety. Firefighter and law enforcement unions have less competition for local dollars.

Cal Fire said they only had around 680 firefighters on the Cascade Fire that should have had 3,000. If firefighters were paid based upon supply and demand rather than union muscle there could be more experienced personnel to save life and property and prisoners could receive better pay as well. However, this is Kalifornia.
