# **Dann Spear** 1955-2018 "no regrets."



Marysville, Ca. – Dann C. Spear, 63 years old, a 40 year resident of Yuba County, passed away unexpectedly surrounded by family on February 22nd, 2018 following a short illness.

Dann was born to William C. "Doc" and Margie Spear in Ventura, California in 1954. He is survived by his wife Roberta, his two sons Carson and Brandon, his daughters in law Erin and Cotie, his mother, Margie Burnett and her husband John Burnett, his sister Darla Pumphrey (Wayne) and many other family members.

He grew up around horses and livestock, and worked at the family business at the Ojai Valley Inn Riding Stables and Matalija Ranch in his youth. He graduated from Nordhoff H.S. in 1972, and while attending Cal Poly S.L.O. he competed in college Rodeo and went on to compete successfully in Professional Rodeo in the Team Roping Event.

He married the love of his life Roberta Eskew Spear in 1974. After attending Cal Poly they moved back to Ojai where Dann began working in the construction industry. After two years they realized their dream of owning a small ranch and moved to Marysville. CA where Dann continued to compete in Professional Rodeo and continued his construction career. Dann worked in the Public Works department of Sutter County for 30 years where he loved helping the people of Sutter County. Dann also had a strong faith and love for the Lord in a quiet way and always treated people like family. He was known for being fair, honest, kind and had an amazing sense of humor with a smile on his face.

Dann and Roberta had two sons, Carson and Brandon Spear. As a family they were involved in 4-H, little league, and High School Rodeo. They were avid fans of Wheatland Pirates football where they never missed a game, and were able to watch Carson's team make the playoffs for the first time in history in 1996 and Brandon's team in 1998 won the only section championship Wheatland has ever won in football. Dann's boys grew up to become a Captain in the Army and Iraq War Veteran and a Sergeant in the Yuba County Sheriff's Department. Dann dearly loved his daughters in law Erin who is an Estate Planning Attorney at Guth & Changaris and Cotie who is the Nursing Administrator for Yuba County Corrections.

While raising his family, Dann founded the Museum of the Forgotten Warriors in 1983. Dann had always been interested in Military history, and after meeting several WW2 Flying Tigers Veterans it inspired the start of his Military memorabilia collecting. Dann's collection and passion for telling Veterans' stories continued to grow each year into what the Museum is today.

Dann always said the Museum is not about war, it's about people, and he was interested in everyone's story.

# Whiteaker Served With **Recall Papers**

Sutter County 4th District Supervisor Jim Whiteaker was served with a Notice of Intention to Recall on Sunday February 25.

Recall proponents believe Whiteaker's history of improper behavior with Yuba City High School students including accusations going back as far as 1996 make him unfit to serve as county supervisor. He was elected to that position in November, 2002 and is employed as a physical education teacher at the school.

So far, two lawsuits have been filed on behalf of students against Whiteaker and Yuba City Unified School District. After the latest incident in January school trustees placed the teacher on administrative leave and initiated termination actions against him.

A second teacher was thought to have been disciplined regarding the latest Whiteaker incident, but the administration said it did not place another teacher on leave. Whether a lesser form of disciplinary action was utilized is unknown.

The second teacher was accused of refusing to report a student's accusation of abuse against Whiteaker to the administration. If true, it is a crime punishable by a fine and incarceration. Teachers at the high school received emails from the administration instructing them not to discuss developments with the Whiteaker case.

Recall proponents now have 7-days to file the original Notice of Intention along with an affidavit of the time and manner of service with Sutter County Elections Clerk Donna Johnston.

Then, Supervisor Whiteaker has 7-days to respond to the Notice with an answer of not more than 200 words. If a response is forthcoming then Johnston has 7-days to legally inform one of the recall signatories.

Once petitions are drafted and approved by the Clerk then recall proponents have 90-days to submit enough valid signatures of registered voters from the 4th District to qualify the recall for the ballot. At least 25% of the registered voters in the 4th District will have to sign the petition. The exact number has yet to be determined from Clerk Johnston.

end impunity for athletes and other privileged perpetrators of sexual assault and violence against women," said Stanford Law School Professor Michele Dauber, the leader of the recall campaign. Dauber has received death threats for her recall efforts.

If Persky loses, it will be the first time a California judge has been removed by a recall election in 85 years.

The recall campaign was sparked by the Brock Turner case Brock Turner, a 20-year-old student and elite swimmer at Stanford University, served only three months for sexual assault due to Judge Persky's light sentence and a state law aimed at reducing jail overcrowding.

Following Turner's release on September 2, 2016 he returned to his hometown in Ohio. California law requires Turner to register as a sex offender for the rest of his life.

Turner sexually assaulted an unconscious woman and was convicted of three felony sex offenses, including assault with intent to commit rape. The victim, still anonymous and not a Stanford student, was found half-naked behind a dumpster.

She attended a fraternity party with her sister earlier that night The victim woke-up with no memory of events and learned the details of her assault from the media. Two bicyclists pulled Turner off of the victim.

Judge Persky sentenced Turner to six months in county jail with three years of probation. Persky ignored the statutory minimum sen-



**FISHIN TALK by Boots Johnson** Dan "Boots" Johnson has fished and hunted in California for 73 years. Anyone with questions or comments can




We checked on the stream conditions in the high country. This includes rivers, creeks and streams. We found conditions now are a month ahead of schedule which means by the time the season opens the end of April we will be dealing with summer conditions with low water and all the rest which comes with not much snow for runoff and rain on the slim side.

While on the subject of trout fishing in the high country it reminds me when I was introduced to stream fishing as a lad of only seven years old. I had a good teacher and my Dad had me catching limits of rainbow trout in my first year on a trout stream.

Back then we used a double hook setup. You could buy the leaders with the two loops, one for each hook. My Dad taught me how to fly fish and to use the double hook setup with natural colored salmon eggs. The eggs were flesh in color and had a strong smell about them. We would fly fish from first light to around 9 A.M. and then switch to the eggs.

I remember the first time I was shown how to use the double setup with only one egg and a fly or jig on the bottom. I was told this was a way to tempt the fish and I caught many trout with this method. Dad always told me that trout sometimes are not on the bite and a double offering sometimes will catch fish.

Dan had a special spinner he kept in his creel. It was a copper/stainless combination blade with three red beads and a treble hook. I will never forget the day we were returning to camp, came upon the pool which completely changed the direction of the creek. Dad motioned to me to be quiet and he sneaked up about six or seven feet from the water and cast that spin-



ner. He got no results so he tied an egg hook about 12 to 14 inches below the spinner, attaching the leader to the treble hook. On his second cast with that setup he set the hook on what turned out to be a beautiful rainbow trout which measured on the de-liar scale at 18 ¾ inches. I learned an important lesson from my Dad that morning. Use your imagination with presentation and when he released that beauty back into the water it started my positive thinking about catch and release, which I have been doing for the last 74 years.

Closing thought: "Distance does not separate people, silence does."

# **Dresses for Africa**



Grass Vallev. Ca. Soroptimists of Grass Valley (SIGV) was joined over one hundred by area women in producing handmade dresses for young girls in Uganda, Africa. It has been found that sex-traffickers are discouraged from kidnapping young girls in vulnerable countries or any area when they see the girls dressed in a garment that someone has lovingly sewn for them. It signifies that someone watches over and cares for them according to news reports.

This project was the brainchild of "Hope For International", Women dedicated to empowering and educating women. One activity of the group is creating simple dresses for the "Dress A Girl Around The World" (DAG) project. The Soroptimists International, one of the world's largest women's organizations, service with clubs in almost every country across the globe, has in California adopted the "Dress A Girl" campaign as a major project. The local club headed by Judy East and Jenni Johnson, co-presidents, appointed member Lynn Mehren Costa to organize a local movement to gather materials, make patterns, to make sewing kits and make dresses to be taken to Uganda by local volunteers.

This past Fall, Soroptimist of Grass Valley gathered over four hundred dresses sewn by people who answered a public call to sew to protect children from kidnapping. Three hundred dresses were taken to Central Uganda and handed out to young girls in three different villages by Lynn Costa and volunteers from local churches.

The success of this venture has encouraged the women's service club to continue their endeavors to dress girls in sex trafficking danger zones. Two more events are schedule sewing to ready materials and to make more dresses at an old fashion sewing bee on two Saturdays in March, the 10th and the 24th, from 1 PM to 5 PM at Twin Cities Church. The church is located at 11726 Rough and Ready Hwy, Grass Valley. The public is invited to join in the effort to produce a batch of dresses which will be sent to several non-profits with connections in parts of the world where girls and women in need are being served. For those interested in helping who may have extra pieces of 100% cotton fabric (even scraps) they can drop supplies off from 4-6 PM at Twin Cities church. Many volunteers will continue to sew the year round and can use any and all materials donated, states Lynn Costa.

Mrs. Costa added that being in the group who visited three villages in Uganda to deliver the dresses was a highlight of her life, not to be forgotten. The villagers were most grateful for the clothes and even asked her to teach them to sew, she said.

She added that both Soroptimist International and the "Dress a Girl" campaign appreciate how so many women in Nevada County, and elsewhere, stepped forward to donate materials and then cut, trim and sew the first 400 dresses. Costa also thanks Twin Cities Church for allowing the use of their facility for the sewing events and for helping to distribute dresses while on the church's Uganda Missions trip.

After enough recall signatures are submitted and certified by the Clerk then the Board of Supervisors has 14-days to order the Clerk to set a date for an election. If the Board does not act then the Clerk shall do so.

A ballot question would ask whether Supervisor Whiteaker should be recalled. The ballot would also include candidates interested in replacing Whiteaker should he lose the election.

If the recall qualifies for the ballot it has an historic Whiteaker family twist.

Supervisor Whiteaker's father and 20-year incum-

bent Sheriff Roy Whiteaker was upset by Yuba City Police Captain Art Brandwood in the 1990 Sutter County Sheriff's race. However, after less than 90-days in office Sheriff Brandwood was served with recall papers by defeated Sheriff Whiteaker's shocked and disgruntled supporters.

Their complaint was that Sheriff Brandwood was cracking down on issuing concealed weapons permits. Brandwood argued that Sutter County had issued the highest number of gun permits per capita in the state (one permit for every 48 Sutter County residents). LA

County Sheriff issued one weapons permit for every 24,216 residents that year.

Brandwood turned back the recall by capturing 59% of the vote and served two four-yearterms before retiring.

In other Yuba City High School personnel actions Varsity Basketball Coach Mamo Rafiq was fired last week. Rafiq had been the head coach since May 2013. He was not a teacher and can be terminated at will. The reason for his dismissal is unknown, but he had been the target of complaints from parents and others at the school.

Rafiq had been exonerated in 2016 after being placed on leave due to accusations of mismanaging school athletic funds. He was reinstated in September 2016 following an audit costing an estimated \$27,000. Auditors criticized the district's training and policies regarding handling of student funds.

# **Food and Farm News**

#### Farmers work to protect crops from freeze damage

Cold overnight temperatures across much of California come at a time when some crops will be vulnerable to freeze damage. For example, Central Valley almond trees are in bloom, so farmers have been irrigating orchards in hopes of raising temperatures enough to stave off damage. It's a similar story in citrus groves, where concern focuses on the blossoms for next year's crop. On the Central Coast, new growth on strawberry plants could be affected.

# CVP announces initial water allocation

Reclamation, which operates the CVP, said Tuesday it expects to deliver 20 percent of contract supplies to its farm customers south of the Sacramento-San Joaquin Delta, and 30 percent to customers of its Friant unit. The bureau said the current situation underscores the need for more storage to capture water in wet winters.

# California Farm Bureau seeks immigration solution

As Congress discusses immigration reform, the California Farm Bureau Federation says any solution must recognize the current immigrant employees on whom farms and ranches depend. California Farm Bureau President Jamie Johansson says legislation currently before Congress "just wouldn't work" for the state's farms and ranches. He says CFBF and other organizations will press for a more practical and flexible agriculturalvisa program.

#### Californian wins national Collegiate Discussion Meet

A Fresno State University student has won a national contest aimed at simulating discussion of agricultural issues at a committee meeting. Tim Truax, an agricultural education major from Turlock, won the national Collegiate **Discussion Meet sponsored** by the American Farm Bureau Federation. In the final round of the competition, Truax and other college students discussed trade policy. He competed in a field of 59 contestants from around the country.

## This Month In Your Garden

March is usually a favorite month for gardeners - the cold weather is behind us and the hot weather hasn't made its debut yet. The first day of spring officially happens on March 20. Spring is a beautiful time of the year with beautiful weather for all kinds of pleasant activities, gardening being a favorite for many. Other noteworthy days in March are on March 11 we start Daylight Saving Time, and on the 17th it is St. Patrick's Day. Palm Sunday and Good Friday follow. An eventful month, and getting out in the garden can add more pleasure and activity.

Vegetable gardens and flower gardens are high on the list of things to do for many. Select a spot with lots of sunlight for your vegetable garden, and some intermittent shade as the sun moves across the area is alright. The soil will probably need to be spaded or roto-tilled to loosen it. If you have heavy clay soil, it will likely take several rounds of turning the soil and adding compost to lighten it and make it more porous. Try to use organic soil additives that will build your soil rather than chemical products that tend to deplete the soil of needed nutrients. The decomposition of organic matter such as crushed leaves and grass clippings can be interspersed into heavy clay soil to help lighten it as well as create spaces to help with drainage which is a problem with very dense clay. Many of our customers in the foothills are very familiar with the clay soil, and maintain a compost pile - an effective way to always have soil additive ready when you need it. A compost pile is not espework well and will breakdown trimmings into compost. It is not a fast process, but it is still a good way to dispose of trimmings and weeds, and make good use of them.

It is important to keep weeds and brush under control - they both grow rapidly and can be an invasive problem. Control can be accomplished in several different ways, some of them can be quite labor intensive - such as pulling them by hand. They can be controlled mechanically and they can be sprayed with an herbicide. Because we had so much warm weather in February, I doubt that pre-emergent can be used effectively now to deter the weeds - most of them have likely sprouted already. With pre-emergent, one must be careful not to apply it where you planted flower seeds for spring color - it is not fussy about what it works its magic on! Congratulations to anyone who had the foresight to use it early enough to be effective. A combination of all those things seem to work for most people, depending on the areas to be done, the kind of weeds, etc. All methods require that some caution be used in order not to harm something else in the process.

With the weather warming and plants eager to grow, it is also time to fertilize just about everything to give them all a good start. An all purpose fertilizer is fine for most plants, but try to use the proper fertilizer on those things that need it, such as citrus food and acid based fertilizer. I have a few words of caution, though. should you have any plant that has buds that should open several weeks later than your date of fertilizing,

the plant to start putting on vigorous new growth that could push the unopened buds off. Just wait until it has finished blooming, and fertilize it then. It is natural for spring blooming plants to put out new growth following their bloom period This caution refers to those plants that bloom only once a year in the spring. Sometimes, for instance, some rhododendrons are later blooming. Enjoy all of their beautiful blooms, and fertilize them after they have finished. Another cautionary statement on rhodies - be sure to break off the flower trusses left following the petals falling, to reduce seed formation which will reduce next year's bloom.

We are not the only ones happy to see spring. slugs, snails, earwigs, aphids all welcome the warmer weather. Aphids multiply exponentially and ants farm them by moving them from one place to another because they like the sticky honeydew that they leave behind. Aphids can be controlled by hosing the off frequently, and there are insecticides that will control them for longer time. Controlling the ants helps to control the aphids.

This an excellent time to plant most anything – ground covers, lawns, annuals, etc. Perennials can also be dug and divided and possibly shared with other gardener friends. They can become well established more easily in the cooler spring temperatures and thus, withstand the heat of the summer. Enjoy the beauty of the spring season.

Crazy Trends

With the market continuing to hit new highs almost daily, investors are wondering just how high it can go and when might we see a correction. We saw one nasty one a few weeks back but memories are short and so it may be off to the races again.

Obviously at some point the markets will again give back some of what it has gained but the question is when and by how much it will correct by.

Markets never go straight up forever obviously but looking at the last year or so and indeed since 2009 the trajectory has been mostly straight up and that in itself can be unnerving to some.

There is an old saying that "markets can stay irrational longer than you can stay liquid" which is to say a markets future direction is an enigma to all with no exceptions. Markets can stay flat, rise or fall longer than expected and by how much is anyone's guess. Rule nothing out and you will be less surprised when crazy trends continue farther than expected.

No one can say what markets will do and when they will do it but like the proverbial approaching train, something is going to happen at some point that will likely be a tad unpleasant for the average mom and pop investor. Although preparing for the uncertain is certainly difficult, there are things one can do to at least prepare for what most agree is bound to happen at some point and that is an unwelcomed correction to the downside. For those investors finding their nerves being tested by the relentless upward direction of recent markets, looking at gains and not wanting to see those gains disappear, the usual steps to take is lightening up on stock holdings and moving a higher percentage to cash or cash equivalents.

certain in the investing arena, many areas are regarded as offering some sort of protection when markets catch a cold and some asset classes may even rise when the general market sells off.

Knowing what rises and falls when other things fall and rise may require the knowledge of a financial professional but can also be learned by those willing to spend some time gaining investment knowledge and comparing historical data.

This type of education can be learned by reviewing some of the fine investing resources available in print by many qualified and knowledgeable professionals. One may also search the web for all the material one would want on markets and investing.

Should an investment professional not be used however and the investor doesn't want to spend the time to learn the ins and outs of market dynamics, although not an ideal situation, simply moving a higher percentage of the portfolio into cash will take some of the ups and downs out of play. The more cash one holds, the less the portfolio balances will move up or down.

Gains are great and rising markets tend to manufacturer them but keeping those gains is yet another hurdle investors must overcome. Too many investors gained much in the infamously rising tsunamis that were the dot-com and housing boom only to see those gains evaporate when those markets returned to normal by correcting quite horrendously.

### **"Key Hole" Residents Vote June 5 on Annexation** by Bob Renton

The vote is finally coming to the residents near Yuba City often called the "Key Hole" area.

Yuba City council authorized a ballot that will appear as part of the June 5. 2018 primary election.

This was approved Feb 20 and authorized another \$40K of YC taxpayer money for County Elections costs and public outreach.

If the annexation is successful the new YC residents within the annexed area will have some wonderful new privileges. They will get to see their taxes go to pay for unfunded pension liabilities for city employees. That liability has risen to \$71 million dollars from only \$59 Million a year ago. A 20% increase in spite of the YC reserve funds used to pay down some of the debt. By the way the previous \$59 Million debt was an increase of 19% from its prior year. The city finance director has called the demands made by Cal

Pers on the YC budget as "unsustainable". The poor performance of Cal Pers is a big part of the problem. Still, Yuba City taxpayers are obligated to guarantee any pension fund shortfall. A fair question to ask is this: Who guarantees your Keogh plan for your retirement if the investments produce less than you need to retire? Does Yuba City guarantee your retirement? Yet you get to

guarantee theirs. Another new privilege of YC residents if annexed is required ownership of a permit from Yuba City for your burglar alarm. In a grand gesture they are waiving the \$42 cost of just the first permit. But not the requirement that your alarm must be connected to a monitoring service. Cost another \$30 per month! You still need to pay \$42 every 3 years for the next permit. The city requirements covering permits are mind boggling. NO requirements at

all for alarms for residents outside city limits. No permits needed.

Oh, let us not forget the new privilege of paying for a city business license if you operate from your home. And pay a tax on the gross income of that business. No net profit? Too bad! You will pay a tax on the gross income anyhow. This will include a person owning several houses for rent in the city. But you say there is not much net profit from the rental units because it mostly goes out in expenses. Again, so sorry! You will pay a tax on the gross rents received. Yuba City is entitled by ordinance to demand your tax payment on the gross income.

Residents may request an "absentee" ballot well in advance so it can be mailed to them. You then vote in the comfort of your own home. Perfectly legal. Feel free to contact BobRenton91@GMail.com



tence of two years. The victim said Turner received essentially "one month for each felony."

Dan Turner, Brock Turner's father, wrote a letter to the judge during sentencing. The father wrote, "His life will never be the one that he dreamed about and worked so hard to achieve...That is a steep price to pay for 20 minutes of action out of his 20 plus years of life." The letter and Persky's actions provoked anger among those believing judges and authority figures are lenient on sexual assault when it involves connected people.

Prosecutors asked that Brock Turner be sentenced to six years in prison for the January 2015 assault. The minimum sentence for his crimes was 2 years and he could have faced a maximum of 14 years. Turner was presumptively not eligible for probation

Judge Persky found that the case was "unusual" and justified sentencing Turner to probation instead of prison based primarily on the fact that Turner was an elite athlete at a top university and that alcohol was involved. He noted that a harsher punishment would have had a "severe impact" on him. The judge had to make a special exception to hand out such a light punishment.

In June 2016, at least ten prospective jurors refused to serve in a misdemeanor trial for possession of stolen property where Persky was presiding, citing the judge's sentencing of Turner. The following week, Santa Clara County **District Attorney Jeff Rosen** filed a peremptory motion for recusal in a case where Persky was to preside over the criminal trial of a sur-

gical nurse. The nurse was charged with sexual battery for allegedly touching the genitals of a patient under sedation. In August 2016, Persky requested to be transferred from criminal to civil court, citing unwanted scrutiny and attention stemming from his ruling in the Turner case.

The recall has pitted the government system of justice (judges, public defenders and the bar association that support Persky) against citizens and victims.

In 2002, Persky, a Santa Clara County deputy district attorney lost a close race for Superior Court Judge to another deputy district attorney Ron Del Pozzo. Persky then was appointed the following year by Governor Gray Davis to the Superior Court.


