## NCSA Hall of Fame 2018 “Local Hall of Fame/Scholarship Recipients”

The Veteran's Memorial Building will be host to the 48th Annual Northern California Sports Association “Hall of Fame/Scholarship” Dinner on Saturday, March 17th. The evening highlights the induction of 8 new members into this 2018 Hall of Fame, along with six college-bound students who will receive scholarships totaling \$15,000.

Heading the list of those originally from this area are Russ Goodman, Salvador Balderama, and the late “Beaver” Swanson. GOODMAN excelled at football and basketball at Yuba City High School in the 60's, and played on a football scholarship for Stanford under Bill Walsh, John Ralston, and Dick Vermeil. Russ also played Rugby with both Stanford and then UCLA while pursuing his master's degree. He was an original founder of the Santa Monica Rugby Club.

SALVADOR BALDERAMA was one of the best shortstops to come out of Yuba City High. Salvador was the team captain and MVP of the Yuba City High, Yuba College, and University of Davis baseball teams. He was also All-Conference at all three levels and after UC Davis signed as a charter member of the Kansas City Royals Baseball Academy. He was Rookie of the Year and leading hitter with the Yuba Sutter Twins when he played in the old Placer Nevada League.

“BEAVER” SWANSON arguably might be the best athlete ever out of Wheatland High School in the early 60's. A High School All-American in football, he was All-Conference and All-State in football, basketball, and baseball. He signed with the Cincinnati Reds and became their leading hitter in AAA, then was traded to the Montreal Expos and played in the Major

Leagues with the Expos. Beaver passed away last year, so his daughters and grandsons will be traveling from Montana and Houston to accept his Hall of Fame plaque.

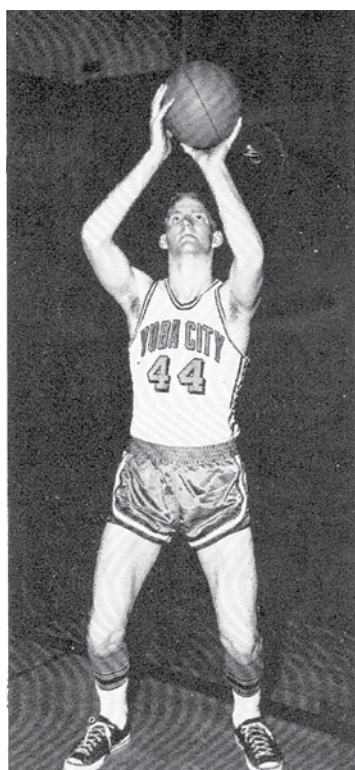
Among other inductees, RYAN ROBISON, for years the principal at Sutter High School, excelled in football and track. He attended Trinity High School, Shasta JC, and Chico State University. He was all-conference in football and track/field, and set records with his javelin throws in track and field. Ryan has spent 35 years coaching and has received numerous awards in administrative positions within the school systems.

RUSS CRITCHFIELD has coached the men's basketball team at Butte College for the past 20 years. Excelling at basketball at Salinas High School Russ played collegiately at UC Berkeley. He played professionally with the 1969 ABA Champion Oakland Oaks and has coached over 40 years. Russ is a member of the B Berkeley and the PAC-12 Hall of Fames.

JOHN PERRY played baseball at Willows High, Butte College, and Chico State where he was the team captain and MVP at each school. He has received all-conference honors and awards both as a player and coach. Teaching at Willows High School for 34 years he also coached the football and baseball teams and was NSCIF Baseball Coach of the Year in 1969.

RAY BALLOCK played football at Pitt State College, but is best known for his outstanding coaching career at Orland High School from the late 50's until the mid-1980's.

Ray's football teams were some of the best, highlighted by being selected as the #1 team in Superior California

in 1961. He has coached Optimist All-Star games and led the Trojans to 3 straight Westside League championships with a 27-game winning streak. Ray's track teams won 4 Westside League championships under his guidance.

This year's team honors go to the 1959 AUBURN LITTLE LEAGUE TEAM. In their 3rd year of existence they played in the final championship game in Williamsport, PA. After an incredible run of 13 victories to make it to the finals, they lost to the Michigan All-Stars in that final game. Most of those original players will be in attendance at Saturdays dinner.

## Money to Burn and Poor Vision

Marysville City Council, buried in millions of dollars in debt, decided last week to pay a consultant \$12,000 to conduct a one-day retreat and have dinner with the mayor and city manager. It must be nice having all that money lying around, all courtesy of the taxpayers.

In the past, these annual events to set goals and brainstorm were led by the city manager or a local leader. Former city manager Walter Munchheimer conducted the last one but neither the council nor our \$100,000 a year City Clerk could locate a copy for review. Guess it wasn't that memorable. At least it didn't cost \$12,000.

Neither could the highpoints of a council gathering led by former Yuba County Superintendent of Schools Ric Teagarden be recalled. Teagarden annually guided his board trustees through such a meeting and provided attendees with cold drinks, sandwiches and coffee. Back then, administrators had the skills to lead and that's what you paid them for. Maybe the refreshments cost a hundred.

The Council also agreed to hire another consultant for \$22,400 to find a new fire chief for their one station department.

## “Homeless” Nonsense

The tension over what to do with the “homeless” aka vagrants, addicts, hustlers and mentally ill has nothing to do with loving and helping people who have lost their way. The federal judge ruling that towns and counties must provide one more location for squatters is a liberal potentate not someone that bases a ruling on law.

These renegade jurists are creating a back door to socialism by exempting criminals and rebels from obeying the law. Responsible hard-working citizens have their earnings forcefully taken to provide cash aid, food, and housing to those that reject rehabilitation and the values of their abused benefactors.

Legal activists like California Rural Legal Assistance attorney Ilene Jacobs, threaten the finances of taxpayers but are unlikely to take a “victim” into their own home for reformation. Jacobs declined the opportunity to put her home where her mouth was in the late 80's when offered a personal challenge as she threatened to sue the Salvation Army to get federal funds for her “victims.”

Most communities have a multitude of resources - rescue missions, clean and sober homes, drug and alcohol rehabs, shelters, church food pantries and work programs. However, if troubled people refuse existing opportunities then loony judges force the jurisdiction to provide another resource at taxpayers' expense. This is asinine and should be rejected by community boards and councils.

Look at what happened in Orange County. About 1,000 campers were evicted from along the Santa Ana River after a 10-year legal battle. The negotiated resettlement reached by U.S. Judge David O. Carter, social justice attorneys and the county forced the county to pay for almost 500 motel rooms for the former campers. Those rooms will never be the same.

Attorneys claimed campers had a “civil right” to squat on non private property. Now, where will the nonconforming campers go to squat and sue? Is anyone asking about the squatter's civil responsibility to behave?

The victorious “model citizens” forgot to clean-up after themselves in Orange County (OC) so Public Works (OCPW) spent three months on the detail. OCPW reported that in the first month workers removed 5,279 pounds of human waste, 404 tons of garbage and 13,950 used needles.

Health officials declared the area so toxic that the top 3 inches of two miles of bike trail along the river from Santa Ana to Anaheim needed to be removed and burned. The county will use asphalt slurry to seal all bike paths along the river's edge.

Allowing this lawbreaking and the resulting health crisis is

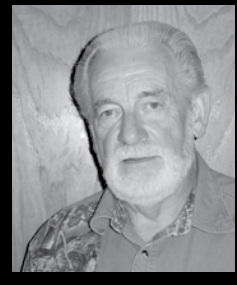

The recent storms and colder weather has changed many areas for fishing. The Sacramento River is running at 55 degrees at the time of this writing. Striped Bass are not on the bite and the sturgeon are also not cooperating. We need some warmer weather for the striper bite to take off. Water temperature in the Feather River is about the same with cold water.

We recommend a phone call in advance to any trip to the high country. Snow has closed some roads and made boat ramps inaccessible in some lakes and reservoirs. In addition, the big snowfall last week has actually closed some waters even from shore. If you have a snowmobile and warm clothing you will be able to reach that favorite high elevation lake or reservoir.

We hear from Bullard's Bar Reservoir. The recent cold spell has really slowed down the bass bite. The boats on Collins Lake are few and far between and the lake is full of recently released rainbow trout. Englebright Reservoir is putting out some trout with trollers doing the best at this time. One thing about Englebright is it is an on again, off again situation. Some days produce limits, other days the fish are off

the bite. Up Tahoe way the mackinaw lake trout are hungry but the weather is very cold with snow on the ground right down next to the water. Lake Almanor has also had its share of snow with over 18 inches of snow falling last week. Boat ramps should be plowed by this time. Expect cold water conditions.

Our weather source advises to enjoy the sun and the warmer weather this week. By mid-week we are told the rains will return to the Sacramento Valley and more than likely snow to the Sierra Nevada Mountains.

# Food and Farm News

## Agricultural exporters watch metal-import dispute

Farmers have a lot on the line in discussions about potential U.S. tariffs on imported steel and aluminum, according to an analysis by the American Farm Bureau Federation. If the U.S. imposes the tariffs and steel-producing nations retaliate, farmers worry agricultural products could be affected. The analysis says about one-third of California farm exports go to aluminum-producing countries, and nearly 45 percent go to steel-pro-

ducing countries.

## Farmers and ranchers visit state legislators

More than 150 farmers and ranchers from around California gathered in Sacramento Tuesday to visit legislators and discuss pertinent issues during the annual California Farm Bureau Federation Leaders Conference. Farm Bureau President Jamie Johansson told the group their voices are needed to reinforce issues important to rural California. The farmers and ranchers then conducted dozens of legislative visits at the

state Capitol.

## Collaborative salmon projects show promise

Cooperative projects to benefit salmon are proving helpful in recovering fish, according to participants in the projects. Farmers, researchers, agencies and organizations report positive results from ecosystem improvements that address challenges salmon face. The numerous projects include efforts to grow food for salmon in flooded rice fields and to create salmon refuges by lowering large tree trunks and root wads into the Sacramento River.

## Research promises to boost water efficiency

Saying their work could lead to increases in agricultural water efficiency, scientists announced Tuesday they have been able to regulate a plant protein that controls photosynthesis. The team, including researchers from the University of California, Berkeley, says increasing the protein in plants allows them to grow more efficiently, and thrive on 25 percent less water. Researchers say the plants used less water without "significantly sacrificing" yield.



Couldn't the council use the same network to call for a chief without dishing out \$22,400? How about contacting retired captains and battalion chiefs in this community and nearby that may be interested? At least they wouldn't leave before they run out of business cards.

The city council appears to have little interest in the soccer field complex in Riverfront Park. A nonprofit soccer group took over maintenance of the fields from the city years ago and raises money to care for the fields.

The complex is utilized by thousands of children and their families. Thousands of visitors each year travel here to compete in tournaments. That all adds up to purchases of shoes, clothing, hotels rooms, food and fuel from local retailers.

Last year's flooding damaged the entire river lowlands for which the city received federal monies for repairs and clean-up. Little if any funds went toward repairing the biggest sports complex in the two counties. Like the closed boat ramp that was ignored

for years it seems like the city council has little vision for upgrading the valuable soccer complex to become an even bigger asset to the community.

If the complex were improved more tournaments could be hosted bringing more young athletes and their families to town. Currently, the local soccer program has more than 20 traveling teams competing around the state.

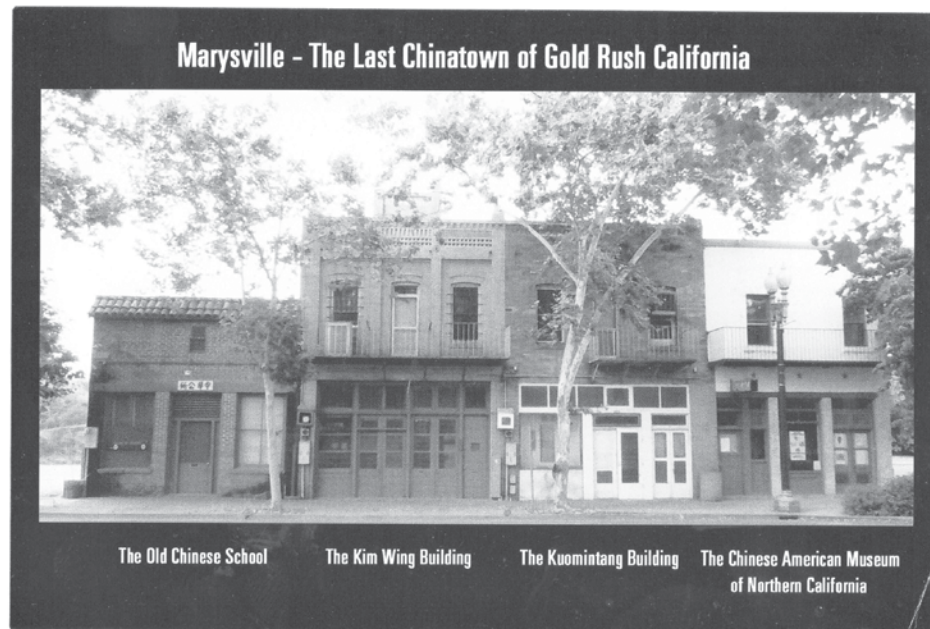

posed to indicate when a stock may be topping out and about ready to change direction to the downside and the climax bottom is supposed to indicate (note the words "supposed to") when a security or index is bottoming out and ready to change direction to the upside.

### "Climax" pattern

Certain analysts and theorists look at patterns on charts and graphs and believe they tell a story as to what may lie ahead on the particular security or market they may be looking at. Many theories and methods are then derived that try and predict where the price of the asset may go to next. The various theories are then usually named and some are widely followed and believed and some are not. This analysts takes the charting theories with a grain of salt but I do believe many at least have some sort of merit that I might find useful.

One chart theory I find useful is a pattern commonly known as a "climax" pattern. This pattern has two uses which are helpful to indicate potential bottoms and tops of price movements in stocks and indexes. Stocks refer to individual company stocks like an Apple, IBM or General Motors issues, all of which are individual companies, and indexes refer to the various markets like the Dow, the NASDAQ or any other investment vehicle that holds a multitude of stocks, bonds or other security. The point here is the climax pattern can apply to a individual security or a group of securities. Although there are no fool proof prognosticators of market direction, the climax pattern has two uses and they can be illustrated by their two names, a "climax bottom" and a "climax top".

The theory goes like this: suppose a stock or market has had a sustained rally upwards and an investor wants to know when to "get while the getting is good" and sell out before the stock falls back down. In other words, when might the rally be exhausting itself and the time is near to take some profits before a possible price fall takes it all back.

The climax part of the moniker says if the price action is mostly one direction but then exhibits wild swings with significant ups and downs of a high percentage compared to its usual degree of price swings, it might be indicating a climax pattern. An example of this would be a stock that climbs from 20 - 40 with daily highs and lows of a buck or two but generally grinds upwards until such a time where the stock swings wildly up and down 3 or 4 bucks but generally goes nowhere over time. The summary of this price action is the stock is experiencing wider than normal highs and lows over a short period of time and is generally stalling out while bouncing wildly. The same would hold true in either direction. If the extended price action had been up, and it starts bouncing wildly it would be a climax top. If the direction had been an extended erosion in price (falling prices over time) its price would stop falling and start bouncing wildly. This price action might be viewed as a

possible climax bottom, indicating the fall might be coming to an end.

We don't have to look far for an example of a possible climax event. On February 9th of this year, the Dow had experienced several days of heart-stopping actions falling from a high of 26,616 weeks early and culminated the week with a 1300 point decline. That Friday the Dow had been down over 500 points early on with an intraday high up 500 points and closing with a 300 point gain. These wild intraday swings of nearly 1000 points in total give an excellent of example of what climax believers look for. The Dow may have substantiated the climax theory in the following days as the direction the next week was mostly in the upwards directions. Was the wild Friday a climax bottom? It certainly appeared so in hindsight.

Keep in mind no one can predict market direction with 100% certainty but depending on what theories an analyst might give weight to could at least give some indication at least to that particular analyst to invest accordingly.

The slew of chart theories are almost endless and its up to each investor to determine whether a particular method works for him or her. The climax theory of price action is just one of many. An NBC Bay Area Investigative Unit surveyed 153 blocks of downtown San Francisco in search of trash, needles, and feces. The effort revealed trash littered across every block. Forty-one blocks were littered with 100 needles and 96 blocks had 300 piles of feces.

"If you do get stuck with these disposed needles you can get HIV, Hepatitis C, Hepatitis B, and a variety of other viral diseases," said Dr. Lee

Riley, an infectious disease expert at University of California, Berkeley. Riley explains that once fecal matter dries, it can become airborne, releasing potentially dangerous viruses, such as the rotavirus. "If you happen to inhale that, it can also go into your intestine," he said. The results can prove fatal, especially in children. Hepatitis A is also spread by human feces.

Riley, author of the book 'Slum Health,' believes areas of San Francisco are filthier than many developing countries. Poor does not have to equal gross polluter. It takes a twisted thinker to excrete where you eat.

Mohammed Nuru, Director of San Francisco Public Works, says cleaning human feces, trash, and needles from the city's sidewalks costs his department about \$30 million each year. A single pile of human feces

takes at least 30 minutes for one of his staffers to clean. "The steamer has to come. He has to park the steamer. He's got to come out with his steamer, disinfect, steam clean, roll up and go."

Other infectious disease outbreaks are starting in homeless camps. They include new strains of tuberculosis that emerged in Northern California; a deadly new strain of streptococcus that killed three street people in Anchorage; and a shigella food borne illness that causes bloody diarrhea, began in Portland.

The government kabuki dance around "the homeless" purposely ignores the liberal welfare state that created the problem and the resulting homeless industry in the first place. Now, a delusional judge rules that taxpayers must accommodate the waste.

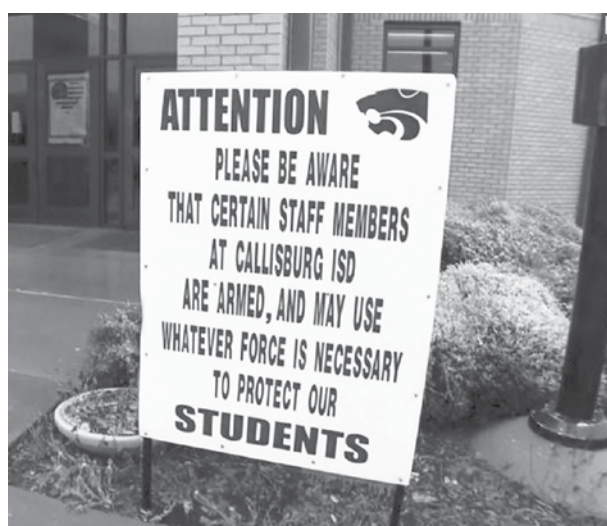
After her story, there was total silence from the usual gun control "blabbering" from a couple in the group...as well as no comment from Shifty.

city manager. What happened to a cake and ice cream. Or meet her while working. I can think of a lot of places that money could better spent in our town

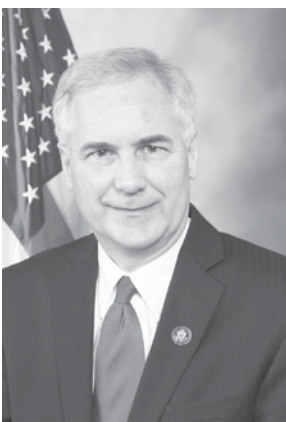

## Tariffs: Turning Abundance Into Scarcity

by Congressman Tom McClintock



Frederic Bastiat, the great 19th Century economist, posed a simple question we need to think about carefully as we consider tariffs and trade wars.

What is better: abundance or scarcity? The answer might seem self-evident, yet protectionists throughout history can't seem to grasp it.

If a dollar can only buy one widget from Pittsburg, but two from Ontario, the path to abundant widgets for America is obviously through Canada. If we slapped a dollar tariff on Canadian widgets to "level the playing field," then we have just cut our own country's available supply per dollar by half. It's a perfect way to create scarcity from abundance.

Similarly, by imposing a tariff on Canadian steel (by far our biggest foreign supplier), the price of steel for Americans rises, and with it, the price of everything from cans to cars.

To the protectionists, this is a small price to pay for "saving" American steel jobs. Yet, as Bastiat reminds us, the unseen is just as important as the seen. We see the American steel jobs preserved by ridding them of international competition. What we don't see as clearly are the jobs soon to disappear in every American industry that uses steel, as demand for their products declines in response to higher prices.

I have worked with Clint when he was a law clerk while I was Assistant DA of Sutter County, and took part in his training to become a lawyer and specifically a Prosecutor. I have followed his career since then and believe he has the appropriate qualifications to serve Yuba County as its Chief Law Enforcement Officer.

Clint's experience working as a Law Clerk in the Sutter County DA's office and as an attorney for a federal judge in the State of Alaska gave him

Every producer in a society is also a consumer. No consumer benefits from higher prices and no producer benefits from scarcer materials.

This has been the consistent experience of every nation that has succumbed to the sophistries of protectionism. Thomas Jefferson thought that high tariffs could fund the government and promote domestic manufacturing. The result was a devastating recession that nearly destroyed our fledgling economy. Herbert Hoover responded to the recession of 1929 with the Smoot-Hawley Tariff Act. It didn't end well.

All trade is the exchange of goods, and both parties must benefit if the trade is to happen. If I pay you a dollar for a cup of coffee, I'm telling you that your coffee is worth more to me than my dollar, and you're telling me that my dollar is worth more to you than your coffee. We both take away something of greater value than we had.

Now suppose someone slaps a dollar tariff on that cup of coffee. I end up buying less coffee, or less of other products to afford the higher price, or sTrue, some governments subsidize their exports, undercutting their unsubsidized domestic competitors. But how does it harm our overall economy if other countries are willing to help pay for the stuff we buy? As Milton Friedman observed, that's simply foreign aid to American factories and consumers, paid for by the unfortunate taxpayers in the exporting countries. Thank you.

We will lose some of the 140,000 American jobs that produce steel. But the other 6.5 million Americans who manufac-

ture products using steel can make more of their products, causing their producers to hire more workers and to pay them more. Jobs disappear in the steel mills, but reappear as better jobs in industries that can now obtain more steel at lower prices.

Writing 150 years ago, Bastiat asked the question we still hear today "What shall we do in case of war, if we have placed ourselves at the mercy of Great Britain for iron and coal?" He answered, "This sort of dependence which results from exchange... is a reciprocal dependence. We cannot depend on the foreigner unless the foreigner depends on us." If war clouds should gather between Canada and the United States, we may face the prospect of losing cheap Canadian steel, but Canada would face the loss of cheap American resources and products that their steel exports buy. Trade reduces the risk of war because it increases the value of peace.

Bastiat noted how much we invest in ports and harbors, railroads and highways, all for the sole purpose of surmounting the obstacles that nature has placed in our ability to trade. What sense does it make to erect artificial barriers to replace the natural barriers we have overcome?

By that same token President Trump has set the stage for rapid economic expansion by reducing the tax and regulatory burdens that were crushing our economy, and the economy is responding. What sense does it make to replace the taxes and regulations we have shed with new ones?

## Supports Curry

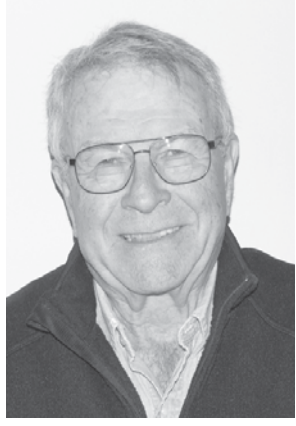

## Feather River Tea Party Patriots Guest Speaker Candidate for Governor Travis Allen

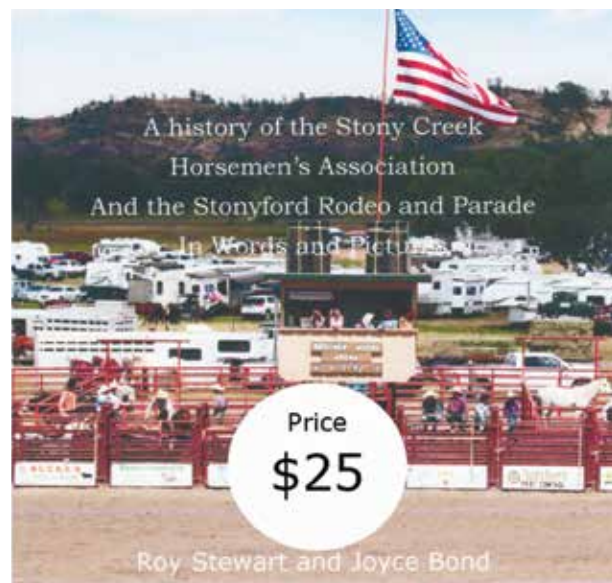

# YCWA Grant to Sheriff's Posse

Marysville, Ca. The Yuba County Mounted Sheriff's Posse will be able to enhance its search and rescue capability in Yuba County's mountainous regions and waterways with the help of a grant from Yuba County Water Agency.

A \$5,000 grant, approved today by YCWA as a part of the Bill Shaw Rescue Equipment and Training Grant Program, will help the Sheriff's Posse buy a new, contemporary, multi-unit waterproof medical first aid pack for use when searching near waterways and during wet conditions. It will also pay for upgrades to volunteers' first aid packs, to include new state-of-the-art tourniquets, among other improvements.

"The Mounted Sheriff's Posse provides valuable first aid services to some of the most remote areas in Yuba County, including YCWA's New Bullards Bar Reservoir and New Colgate Powerhouse," said YCWA Chairman Brent Hastey. "We are so grateful for their quick, emergency response capability, and are happy to help them do it even better with this new equipment."

Established in 1946, the YCMSP supports the Yuba County Sheriff's Office and California Office of Emergency Services in all types of search and rescue missions throughout Yuba County.

"This generous grant will help us work toward providing the best equipment and training for a rapid response to our emergency calls in the foothills and throughout Yuba County," said Henry Souza, Yuba County Sher-

iff's Posse captain. This is the first agency to benefit from YCWA's Bill Shaw Rescue Equipment and Training Grant Program, which was created in January, 2018. These grants are designed for first responder agencies in Yuba County and will cover the one-time costs of up to \$5,000 per applicant annually, associated

with the purchase of rescue equipment or specialized personnel training. Grant funding requests must be connected to YCWA's missions of flood risk reduction, water supply reliability, hydropower generation, groundwater management, fisheries enhancement and recreation in and around New Bullards Bar.

## Area African-American Pioneers - 1848-1900

### THE ADDIE TAYLOR SAGA

Although it was generally believed that slavery was banned in California by the Compromise of 1850, one can only research the newspapers during that time period to find items describing slaves for sale, cases involving enslavement or advertisements offering rewards for runaways such as the one that appeared in 1852 in the San Francisco Herald.

In this advertisement a \$100 reward was offered for a "runaway from Mrs. Elizabeth Ware in the month of October, 1850, from Marysville". A description of Hagar was given along with the fact that she had changed her name to Mary. The reward was increased to \$150

if she was located in any other county "with her delivery in the hands of the sheriff of San Francisco".

In another example, some slaveholders hid their slaves in remote areas such as the case of Addie Taylor who worked as a shepherd in the Yuba County community of Hansonville, which was first settled in 1851 by James H. Hanson, from whom the town was named.

Although it is unknown when Taylor first arrived, Hansonville, located 28 miles from Marysville, once boasted a population of a thousand residents. A quartz ledge was found in 1851 and, in addition, a number of miners worked along the Honcut Creek.

Serving this thriving community were seven stores—each with a bar; eight hotels, a bowling alley and a private school, which was established in 1853. A permanent school house was built in 1864 and was also used by the Methodists for religious services.

Hansonville would eventually endure a major fire and flood along with the loss of many established stamp mills. By 1860, the last store remaining closed down. It appears that prior to this time, the life of enslaved Addie Taylor took on an amazing turn of events—thanks to a man named Robert Anthony.

### THE RESCUE

According to research, Anthony came to Sacramento from St. Louis, Missouri between 1849-1852, traveling by ox team with his owner. Anthony worked in the mines for two years in order to pay for his freedom. It is said he worked by day for his master and by night for himself.

With the money he saved, Anthony was able to eventually purchase two quartz mills and is credited as owning the first quartz mill in California. Both of his mills were located at Horncutt (Honcut) between Yuba and Dry Creek. One mill was worked by horses, the other by water.

Anthony later moved

his mills to Browns Valley, which was once the scene of the most extensive quartz mining operations in Yuba County. While working at the mills, he learned about Taylor and her enslavement in Hansonville. As the story goes, one day Anthony drove by wagon where Taylor lived and asked her if she did not wish her freedom. "Yes," was her reply and Anthony then requested Taylor to get into his wagon and they drove to Colusa, where he was now a resident. It appears that a mine tunnel had earlier collapsed and crippled him so that Anthony was no longer involved with the quartz mills.

Many years later, Delilah Beasley, author of the "Negro Trail Blazers of California" interviewed Anthony at a "poor" farm in Marysville. Regarding his life after the rescue, Anthony remarked that he and Taylor were married and the marriage was witnessed by Allen Pinkard and Thomas Scott, both natives of Colusa.

Sadly, he added that "he had an only son, who worked on one of the Hearst papers, but who had forgotten his old father".

The April edition will include the history of the Sweet Vengeance Mine and the lives of its miners.

Gun ownership and the complex laws surrounding the use of firearms is a significant topic around the nation. The 2017 Pew Research reported forty-two percent of American households currently own a gun and twenty two percent of women personally own a firearm.
