## No Criminal Charges Filed Against Police Chief



Marysville, Ca. – In a press release on February 26, 2018 the Yuba County District Attorney's Office stated that they have completed a review of the Yuba County Sheriff's Office reports related to the criminal investigation of former Marysville Police Chief Aaron Easton. Based on the investigative facts and the applicable California law,

no criminal charges will be filed related to his alleged actions in February of 2008.

In April of 2016 the Sacramento County Sheriff's Office notified Yuba College of a possible sexual assault occurring in 2008 against a female cadet attending the Yuba College. Police Academy, and that the assailant was possibly an Academy instructor. On May 10, 2016, the Yuba College Police Department referred the matter to the Yuba County Sheriff's Office after it was determined that the suspect was Aaron Easton, who in 2008 was employed by the Sheriff's Office as a patrol deputy, and that the alleged assault occurred in the county jurisdiction while Easton was on duty.

The victim of the alleged

crime was at the time a cadet in the Yuba College Police Academy. Easton was employed as a full time patrol deputy with the Yuba County Sheriff's Office and employed part-time as a physical training instructor at the Academy. The crime was allegedly committed during the early morning hours inside a YCSO patrol car while the cadet was accompanying Easton on a law enforcement "ride along". Academy cadets were encouraged but not required to complete such "ride alongs" as an adjunct to their training.

The final decision stated, based on a review of the totality of the admissible evidence, the allegation was determined to be credible and, more likely than not, to have occurred. However, the unanimous opinion of the reviewing prosecutors was that the admissible evidence was insufficient for a criminal jury to unanimously agree, beyond a reasonable doubt, that Aaron Easton had committed the alleged crime.

## Sexual Abuse Cover-ups No Game

United States Olympic Committee (USOC) Chief Executive Scott Blackmun has resigned following accusations that the committee knew about former team doctor Larry Nassar's sexual abuse of hundreds of female gymnasts and other athletes, years before it acted.

"For 31 months, I heard nothing," gold medal gymnast Aly Raisman, 23, told the Wall Street Journal. "I find it hard to believe after all this time that the USOC is genuinely concerned about anything other than the scrutiny it's now facing."

Former Olympic gymnasts, including Raisman and McKayla Maroney, won't participate in the U.S. Olympic Committee's investigation into the Nassar scandal, saying they don't trust the body to conduct a thorough and independent inquiry. The gymnasts are among 150 women formally accusing Nassar of sexually abusing them.

Nassar was arrested in November 2016 and last year pleaded guilty to state sexual-abuse and federal child-pornography charges. Nassar, who is now serving a 60-year sentence in

## Yuba-Sutter Political Notes

Many citizens and politicians relegate the Constitution and the convictions of the founders to the future of phone books and rotary phones. However, the nation-builders were literate, intelligent with some considered genius and they had backbones.

Far different than leaders today, they did not view "constituents" as sheep to be sheared.

The following quote is from the 1801 Inaugural Address of Thomas Jefferson. "With all these blessings, what more is necessary to make us a happy and prosperous people? Still one thing more fellow citizens – a wise and frugal government which shall restrain men from injuring one another, shall leave them otherwise free to regulate their own pursuits of industry and improvement, and shall not take from the mouth of labor the bread it has earned...."

Government today would not be described as "wise and frugal." Politicians have mastered the fine art of thievery to lift the bread from the mouths of workers and make them feel that the taking is good and necessary.

The founding fathers launched the fastest growing industrial power and most successful country in history from scratch when today high-priced bureaucrats cannot even manage without hiring expensive consultants and incurring massive debt. Most of the elected know little about the Constitution and others treat it like a buffet. The result is a quasi-socialist government going broke while freedoms are routinely removed.

Yuba County Supervisors, already needing repeated bailouts from the Yuba County Water Agency spent \$30,000 for a firm to do an opinion survey of 556 voters on how to acquire more money. Before this survey to raise sales taxes they secured a consultant to cure homelessness.

Now, the City of Marysville lists on its March 6 Consent Agenda an item to pay a consultant \$12,000 to conduct a retreat for councilmembers. They aren't even willing to have an open discussion about the expenditure with the community.

Retreats usually teach participants how to get along and set some goals. Doesn't City Manager Marti Brown have the skills to do this? It's so easy to spend someone else's money.

Did Mayor Samayoa recently write that the city needed to work on a General Plan? More consultants? Didn't the city spend a couple hundred thousand for Bounce Back "experts"

U.S. citizens must present

a valid passport book when entering the United States by air. U.S. citizens entering the United States from Canada, Mexico, the Caribbean and Bermuda at land borders and sea ports of entry must present a passport book, passport card, or other travel documents approved by the U.S. government.

To help our customers who may not be able to visit our office during our normal business hours, additional services such as certified copies of Birth, Death and Marriage Certificates, Fictitious Business

Name Statements, Passport photos, issuance of Marriage Licenses and performing Marriage Ceremonies (by appointment only) will be available on this Saturday.

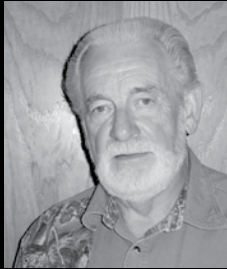

Things changed dramatically last week when the rain came, the snow fell and the wind blew throughout the Valley floor, the foothills and the Sierra Nevada Mountains. The heavy storm, which has changed the minds of many in regard to drought or water shortages, reminded me of past Februaries which dumped rain and snow in the North State. In fact some years were flood years in February, including 1986. This past week just goes to show us that Mother Nature is very unpredictable. In fact, our weather source says the rains will return next week with precipitation continuing off and on into April.

We hear from the DFW (Department of Fish and Wildlife) in Sacramento. They predict another small run of king salmon in the Sacramento River this year. This also includes the Feather, Bear, American and Yuba rivers which flow into the Sacramento River. We were told the returning salmon will be so low that the state is considering reducing limits, closing endangered areas and placing different dates and/or times anglers can fish for salmon.

The drought has been blamed for part of the problem which reduced

flows of all rivers in Northern California. The drop in returning fish will also have an effect on ocean fishing, both commercial and sports fishing this year. Regulations are due out in the next couple of weeks and at that time we will see what the decisions are and how it will affect our areas of water.

A while back this column discussed the outlawing of lead in fishing lures and equipment. Well folks, it has happened in Sacramento. Assembly bill 2787, introduced by Assemblyman Bill Quirk, who by the way lives in the Bay Area, if passed will add to the rules and regulations so many anglers find unfair, complicated and downright wrong. This is another reason persons

who used to fish have quit. The number of fishing licensed sold today is one half as many as in the past and we expect more to just throw in the towel and give it up.

This is a sad and unhappy situation and if you wish to voice your opinion on the latest slam against us who fish you can call Assemblyman Bill Quirk at (916) 319-2020 or fax him at (916) 319-2120. ## Samson

Starring: Jackson Rathbone, Billy Zane, and Taylor James. Rated: PG-13, Runtime: 110 minutes.

Samson, a Hebrew Nazirite rises up to break the power that the Philistines have over his nation. Samson sets about the task by marrying a Philistine girl and killing thirty soldiers to use their clothes to settle a bet that he lost to deception. His wife is killed and he falls in love with Delilah, the prince's wife, and tells her the secret of his great strength. This leads to his blinding and capture and also to his opportunity to finally overthrow the Philistines.

The flow of the film is forced and the acting is not the greatest. The effects are not very good either. The lion killing scene and the fight scenes could have used more choreography. With the small budget they used to make this, it is not a terrible film just not up to industry standards for theater released films.

Samson, Earns two out of five, Gate Stealing Monkeys. Not the best film out but certainly not the worst either. I liked parts of it and found it entertaining enough to not think about getting my money back. It was closer to the source material than big budget films such as, Noah and The Hobbit, so it has that going for it. Wait for the release to video and Netflix before you see it. Not quite worth the trip to see on the big screen. It would not be a bad film to have on the shelf, just don't pay too much for it.

with One Eyed Reilly in Concert



Marysville, Ca. – So what's your favorite Irish song? "When Irish Eyes are Smiling," "My Wild Irish Rose," "Patriot Game" or maybe "Danny Boy?" Join Yuba Sutter Arts for a St. Patrick's Day warm up concert on Friday March 9th at 7pm. Sacramento based One Eyed Reilly will appear locally for the first time and is the first concert in this year's Yuba Sutter Arts' World Music series.

One Eyed Reilly is a Celtic/Americana rock band that blends dynamic original songs with modern Celtic rock, Americana, and energetic, innovative versions of traditional Irish and Scottish classics. One Eyed Reilly's original songs draw upon wide-ranging musical influences from The Clancy Brothers, The Chieftains, and The Dubliners, to Flogging Molly and The Pubcrawlers. They infuse their live performances with occasional unexpected nuggets ranging from Bob Dylan to John Prine to Tom Waits to Wilco or Old Crow Medicine Show. Ultimately, this genre-bending free-for-all sets the perfect foundation for a really good time.

One Eyed Reilly formed shortly after St. Patrick's Day 2012, but the members have been honing their musician-ship for

many years leading to this fortunate convergence. Lead singer and rhythm guitarist Rick Meagher comes from an Americana singer/songwriter background, but with a father who is 100% Irish and a grandmother born in County Cork, One Eyed Reilly is the natural culmination of his musical journey. Classically-trained violinist St. John Fraser brings his considerable size and talent to bear with his ridiculously inventive and creative fiddle playing — mixing multiple styles and techniques in a red-bearded, frenzied attack. Nick Carvajal cements the rhythm section together with his unique and innovative percussive techniques that will have you stomping your feet! The band is rounded out by Aaron Hendel on bass and electric guitar and Tim Kurteff-Schatz on drums/percussion. Together it all adds up to a beer-drinking, foot-stomping, hand-clapping celebration that will have you hoisting a pint and bellowing "Sláinte" That's Irish Gaelic for "Good Health!"

And just as a reminder, Saint Patrick's Day, or the Feast of Saint Patrick is a cultural and religious celebration held on March 17th, the traditional death date of Saint Pat-

rick (c. AD 385–461), the foremost patron saint of Ireland. According to tradition, Patrick converted the pagan Irish to Christianity. Patrick's efforts against the pagans were eventually turned into an allegory in which he drove the "snakes" out of Ireland. In fact, Ireland never had any snakes. St. Patrick's Day, while not a legal holiday in the United States, is nonetheless widely recognized and observed throughout the country as a celebration of Irish and Irish-American culture. Celebrations include prominent displays of the color green, religious observances and numerous parades. It has been celebrated in North America since the late 18th century.

The cost to attend is only \$20 general admission or \$15 for seniors, military and students. There will be a no host bar. The concert will take place on Friday March 9th at 7pm at The Burrows Theater at Yuba Sutter Arts, 630 E Street in Marysville. There is plenty of free street parking and in the parking lots at Umpqua Bank and Bank of America directly adjacent to the theater. Come out for what promises to be a fun evening.

federal prison, was sentenced earlier this year by two Michigan judges to terms of up to 175 years and up to 125 years in state prison.

Victims are now filing lawsuits against the USOC and others, alleging that the organization failed to protect athletes and lied about when it learned of the Nassar allegations.

Former USOC board member Edward Williams says the investigation is too narrowly focused. The probe should be expanded to include “the climate within the USOC in July 2015, as well as in the years leading up to the July 2015 disclosures, which permitted the abuse to occur.”

Aly Raisman said, “This investigation needs to be bigger than Nassar. There have been countless allegations of abuse for years and years. Anything other than a full investigation just isn’t good enough.”

Why are sexual abuse complaints against adults often ignored, minimized or scuttled altogether? It protect “important” people, schools or organizations.

It is no wonder young people lose respect for teachers, administrators and a judicial system they thought would protect them. Women who graduated from Yuba City High say they made complaints against Physical Education teacher Jim Whiteaker as far back as 1996. Some reports indicate “appropriate action taken” but don’t describe the action, nor were the victims informed. Whiteaker remained at work.

US female athletes have turned their attention from a pervert doctor to a perverted governing system that wanted to save face by ignoring victimized young women and hoping they would remain silent.

Athletes didn’t get

counseling, an apology, anything. In fact, the ladies risked reputation, relationships, occupations and being shamed to come forward. To take on the full force of the USOC and the national exposure is no game.

For ladies to begin the case against Whiteaker, the Teacher’s Union and Yuba City Unified School District, let’s say it’s not for the faint-hearted. The union has plenty of tenured bad apples and more money than all the students’ families put together.

The life of a crime victim is tormenting. Being a juvenile target of sexual abuse is nearly impossible to overcome. For a young person, taking a stand against the adult perpetrator and facing a judicial system that is confusing and overwhelming causes many victims to just walk away.

Yuba City Unified, like the USOC, needs to do its own broader investigation on reporting of abuse as well as the morally permissive culture it has fostered.

### Extent of freeze losses remains to be determined

They know their crops have suffered damage from several days of freezing temperatures, but almond farmers say the extent of losses from the cold weather likely won’t be known for months. The freeze of the past week occurred throughout the Central Valley as almond trees bloomed. Farmers say that means some of the blossoms won’t create nuts. But the full impact may not be known until harvest time this summer, and observers say it may vary greatly from orchard to orchard.

### Farmers, farm employees seek immigration reform

Pursuing the goal of a flexible, practical agricultural immigration program, California farmers and employees have traveled to Washington, D.C., this week to meet with members of Congress. The California Farm Bureau Federation, which sponsored the trip, says it aims to emphasize the importance of partnerships between farmers and employees. Farm organizations have been advocating with Congress for a workable solution for people who want to enter the U.S. to fill agricultural

jobs.

### Agriculture secretary visits Southern California

For the second time this month, U.S. Agriculture Secretary Sonny Perdue is scheduled to speak to the Commodity Classic agricultural conference in Anaheim on both Wednesday and Thursday. His visit also includes a meeting with U.S. Forest Service rangers and employees, and a tour of parts of the Angeles National Forest damaged by the Creek Fire last December. Perdue visited Central California two weeks ago.

### Organic berry sales trend upward

Americans show a growing demand for organic berries, according to an analysis by the American Farm Bureau Federation. Citing data from both government and private sources, Farm Bureau economists say sales of organic produce generally have continued to increase—but sales for strawberries and blueberries in particular have trended upward. The analysis says sales of domestically grown and imported organic berries have shown sharp increases.

### Has bitcoin and crypto currencies bit the dust?

From its meteoric rise of close to 2000% in 2017 to a roller coaster ride which lopped off half its value a week or two back, this analyst is tempted to spout the words “I told you so” but I won’t.

My last media coverage of crypto did contain the quote ‘its wild price swings should at least be cause for concern for those investors thinking this is as safe as it gets. The price charts certainly are likely saying something quite different, at least to this analyst’.

So I didn’t exactly predict it was going to crash but you get the gist of the last article and its veiled buyer beware flavor.

From the perceived currency that “couldn’t be shot down’ to the basement of heartbreak hotel for the most recent buyers of Bit, you have at least take notice of what’s transpiring in the crypto market just recently.

Obviously the blood bath that is the selloff is no cause for joy jumping, indeed some investors took a nasty haircut on the roller coaster of bit, but other things that are transpiring causes more concern from this analyst and probably should for you as well.

For crypto to act as currency of sorts, one quality it must have is to maintaining some sort semblance of value, meaning a 20 fold annual increase in price is anything but.

Maintaining a store of value means no wild ups and downs in price, so if it skyrockets in price, it’s as disturbing as a market bust because for every winner there is a loser in the world of money.

With such volatility in the crypto market, and not knowing how long a crypto will maintain its value and by how much, the serious boys in the banking business are saying “no mas” at least for now, to accepting crypto for charges or payments.

JPMorgan Chase & Co., Citigroup and Bank of America Corp. all announced they are no longer allowing purchases of Bitcoin and other cryptos on their credit cards. We can imagine they fear if someone gets burned on a crypto purchase, they might well take it out on

the credit card company and not pay their bill. Valid concern.

The Chinese and Indian government meanwhile went after crypto trading sites and we can assume they won’t be the last government to do so. All in all, cryptocurrencies have to overcome at least some obstacles in order for this analyst and others to consider it a viable alternate to gold and other currencies. Firstly, the price has to stop bouncing around like the proverbial ping pong ball. Currencies must maintain a store of value, and I might add at least a somewhat stable price!

Secondly governments are known to be very jealous of competing forms of payment. Remember it is illegal to refuse the mighty U.S. dollar for all debts, public and private. Should Bitcoin or some other facsimile of become more widely regarded as a serious threat to the greenback they have the means to stop its access by simply shutting down the apps and websites where they are traded. Ditto for all the other countries in the world should they decide so.

Right now the roll out for crypto is running into growing pains. With the

mania like run up in price and now the subsequent crash or at least major setback, and with anxious governments breathing down its back, I think investor may want to consider letting the dust settle and see how this all pans out before committing large sums of money into cyber space. Caveat emptor as they say which means buyer beware.

If you live in the city, you surely want to get to know your City Council members. However, it is just as important to know your County Supervisor, who oversees the substantially largest local government budget.

Local government services are provided by counties, cities, and special districts. Counties, which augment and compliment services provided by cities and special districts, provide services to everyone, whether they live in an incorporated city or in unincorporated rural areas.

Sutter County has an annual budget that exceeds \$300 million, overseen by the Board of Supervisors. That's 300 million reasons to know your County Supervisor.

As one of those supervisors, I've learned firsthand many people who live in the city aren't aware how much their lives are

impacted by our decisions. Your input is critical, because of the size of the budget and the number of programs that impact you and your family

Here are just a few examples of services provided by the County that impact everyone, regardless of your address:

- Operation of the County Jail.
- Operation of Juvenile Hall.
- Criminal prosecution and other services by the District Attorney
- Probation Department services.
- County Coroner services.
- Public Defender services.
- Bailiff services for Sutter County courts.
- Veterans services, including operation of a Veteran's Hall.
- Emergency Management coordination and training.
- Behavioral Health Services, including mental health and drug addiction counseling, education, and early intervention.
- Public Health programs, such as monitoring, reporting, and containing of infectious diseases; vaccinations, and healthy lifestyle education.
- Public assistance programs, including supplemental nutrition, elder care, and children's services such as foster care and child protection.
- Environmental Health, which conducts inspections for sanitary conditions at restaurants, other businesses and recreational facilities.

- The Agricultural Department, which makes sure you get a gallon of gasoline when you pay for a gallon of gasoline, inspects bee colonies for strength and health, protects crops from pests, and provides continuing education for best pest control practices.
- An array of library services, including children's programs and English literacy.
- The Community Memorial Museum of Sutter County.
- Property value assessments.
- Elections for County, City, special district, school district, state, and federal offices, and for ballot measures and propositions.
- Recording of legal documents such as marriage licenses, property transfers, death certificates.

It is the job of the County Board of Supervisors to ensure these programs and services are economical and effective.

Those of us who govern need to know what is important to you. We have to pay attention to how we budget and how you feel about the services provided. We really care about your opinion. I encourage you to reach out to your County Supervisor—everybody has one—to convey your views on any issue, pro or con. After all, it is your money.

Education - The Forgotten One

Yuba County has a high school dropout rate of approximately 18%.

While better than some counties, it's still a sad state of affairs.

Young adults, without our most basic of educational achievement, a high school diploma, face a mountain of challenges, especially if they live in the remote, rural corners of our county. They have difficulty in securing employment, auto loans and credit. They can also face psychological and emo-

tional issues due to a lack of confidence or feeling left behind.

Without a car, and living remotely, they are isolated. They might pull together a junker car, but it's probably not registered and it's uninsured. They often rely on small, local odd jobs to piecemeal together a paltry income. They don't have the luxuries of a computer or regular WiFi. They become another statistic in Yuba County's increasing poverty situation - In 2016, 17% of the

county was living below poverty and in 2017, this figure climbed to about 22%, an approximate 30% increase.

Many young people know that if they could complete a GED program it will help them climb out of the hole they're in. Unfortunately, many don't have easy access to enter a program at Yuba College, nor do they have an online opportunity to complete a program. They are stuck in a tough situation, that if not resolved, can sometimes lead them into serious trouble.

While we should always focus on keeping kids in school (In 2016, a little over 7% of Yuba County students didn't finish 9th grade), we cannot ignore those that got away. We need to bring GED programs into the rural areas. Utilizing existing public spaces and equipping them with computers and an occasional visiting instructor could help tremendously. Perhaps the county could transform a couple of old school buses into a mobile GED classrooms to bring success directly into the rural, remote communities. We have to rethink how we serve up education, especially for these young men and women who feel forgotten.

## Legislative Republicans Demand New Water Storage

Sacramento, Ca.

On February 21, 2018 Republican members of the California Legislature delivered a wagon-load of petitions to the California Water Commission calling for the immediate approval of funding for Sites and Temperance Flat reservoirs. The more than 4,000 petitions were signed by Californians from all corners of the state in response to recent reports that the commission is blocking the construction of badly needed surface water storage, even as another drought is looming.

"Four years ago, California voters overwhelmingly approved a \$7 billion water bond on the promise of new surface storage projects," said Assembly Republican Leader Brian Dahle (Bieber). "Our government has made a habit of selling the voters a false bill

of goods. It is long past time that our government starts keeping its promises."

In 2014, Californians approved Proposition 1, a water bond that included \$2.7 billion for investments in new reservoirs. The proposition tasked the California Water Commission with allocating the storage funding. Recently, the commission issued a report that could jeopardize the funding for important storage projects like Sites Reservoir and Temperance Flat.

"The lack of urgency from bureaucrats at the water commission is putting Californians' livelihoods in danger," said Assemblyman Frank Bigelow (R-O'Neals) in a recent Sacramento Bee op-ed. "If we are hit with another drought, the commission will be responsible."

If built, Temperance Flat Reservoir could hold 423 billion gallons of water northeast of Fresno. Sites Reservoir could hold 586 billion gallons in Colusa County.

already? When is the city actually going to make improvements after getting its added 1% sales tax or an extra \$1.5 million a year?

Did the council forget its slogan "We can't lose one more cop" for the sales tax increase measure as they now spend the money wherever they please? Even after raising money for the police the council then borrowed more money to finance new police cruisers.

For those planning to reside in Marysville for the next two decades much of your taxes will go to pay-off B Street property bonds, employee pensions and police car debt. If residents managed their affairs like the city does they would go broke and maybe to jail.

Sutter County Deputy District Attorney Clint Curry announced he will campaign to replace retiring Yuba County District Attorney Pat McGrath. McGrath and Sheriff Steve Durfor have endorsed Curry. Curry has worked for 8 years prosecuting cases for Sutter County.

Clint's father James Curry after serving in Vietnam 1963-1966, served as a Yuba County probation officer, attorney and then Superior Court Judge from 1997-2010. Clint also served in the Army, studied for a year in seminary and then completed UC Davis School of Law in 2007.

Clint and his wife Meredith founded the nonprofit Restoration Railroad to assist human trafficking victims and raise awareness about the problem. The effort led to a more active enforcement to protect children and arrest predators.

The Sutter County Citizens Advisory Committee on Homelessness met for the second time Monday, March 5. The Committee was commissioned by the Supervisors to identify a location for a homeless shelter, not whether or not to build one. No county leader has a solution on homelessness but they are sure the community needs to own a shelter.

However, no one has been able to answer the question of once a shelter is built then what is to be done with the homeless population remaining? If there is no plan of action then why spend a million dollars for a shelter and leave

the rest of the vagrants to ignore existing resources and the law?

"Unclaimed debris," as Sutter County Administrator Scott Mitnick calls it, is mounting in both Yuba and Feather

River bottoms waiting for high water to take it to San Francisco. Like the local crows and pigeons the homeless are returning to their roosts and even developing new haunts.
