Whiteaker Termination Proceeds

Tuesday, February 13, 2018, at 3pm Yuba City Unified School District board members will again consider assault charges brought against physical education teacher and former coach Jim Whiteaker.

Last week, local attorney Michael Trezza filed a claim for \$500,000 in damages with the district alleging that Jim Whiteaker engaged in sexual misconduct with female students.

The current victim indicates she was in her physical education class on January 16 when Whiteaker "approached her without her knowledge and grabbed her buttocks." Whiteaker said, "I've been teaching for 26 years; I've never had to face any allegations like this in the past. I don't believe I should be terminated on these conditions."

Whiteaker says that he mistook students playing around for them fighting and intervened. He denies grabbing the girl's buttocks.

Others at the school say Whiteaker has a reputation for edgy behavior and for being a bully. A former school employee reported Whiteaker's improper contact with female students to former principal Martin Ramirez numerous times along with former Athletic Director Joel Seaman and nothing was done.

A former student and current district employee indicated Whiteaker touched her breast in 1997 and on another occasion did not intervene as a male student held her against the wall and "gave her a hickey." She said Whiteaker laughed. A student aid in his physical education class she did not report either incident. She said she was humiliated and indicated Whiteaker was known among students as a "perv" and a "creep."

The Trezza claim tells of another student and her mother reporting to school authorities and to police in October 2014 that Whiteaker videotaped the 15-year-old girl while she was participating in his physical education class. Whiteaker allegedly filmed the girl's buttocks and her body from the waist down, and admitted doing so when confronted by the girl and her mother.

The mother was refused a copy of the police report since the officer did not fully investigate the incident choosing instead to file an information report. Yuba City Police told the mother that they do not have to provide copies of information reports to the public. However, the district did give a copy of their file to the mother.

Gabe Foster expressed alarm at the previous board meeting that in his wife's 1998 case, an investigation was done, a district report filed, but there was no description of any action taken for Whiteaker touching his wife's breasts on two separate occasions when she was a senior.

The Trezza claim states that despite "red flags" from teachers, parents and students, the district failed to take action against Whiteaker or thoroughly investigate reports of inappropriate behavior.

The current victim says when she reported her incident to another physical education teacher he refused to report it since he did not see it. The claim describes the teacher saying that men Whiteaker's age "like to play around like that." Trezza argues that the teacher violated the law by not reporting the incident.

Other victims have contacted this paper or other noted victims but have yet to provide the details of their stories.

Snowpack Below Average Despite Gains

Despite moderate January precipitation in the Sierra Nevada after an historically dry December, today's Department of Water Resources (DWR) manual snow survey east of Sacramento found little snow-pack there, two months into what is typically California's wettest three months.

Measurements at Phillips Station revealed a snow water equivalent (SWE) of 2.6 inches, 14 percent of the early-February average at Phillips as measured there since 1964. SWE is the depth of water that theoretically would result if the entire snowpack melted instantaneously.


"California experiences the most variable weather in the nation," said DWR Director Karla Nemeth. "It's vital that water conservation efforts remain consistent regardless of the year's precipitation."

More telling than a survey at a single location like Phillips are DWR's electronic readings today from 103 stations scattered throughout the Sierra. Measurements indicate the SWE of the northern Sierra snowpack is 4.6 inches, 27

percent of the multi-decade average for today's date. The central and southern Sierra readings are 5.8 inches (30 percent of average) and 3.8 inches (25 percent of average) respectively. Statewide, the snowpack's SWE is 4.9 inches, or 27 percent of the Feb. 1 average.

"The snow survey today shows water content far below average for this time of year," said Frank Gehrke, chief of the California Cooperative Snow Surveys Program who conducted today's survey at Phillips. "Today's measurements indicate an anemic snowpack to date, but there is still the possibility of a wet February and March."

On average, the snowpack supplies about 30 percent of California's water needs as it melts in the spring and early summer. The greater the snowpack water content, the greater the likelihood California's reservoirs will receive ample runoff as the snowpack melts to meet the state's water demand in the summer and fall.

Collins Lake near Browns Valley will be planting their spring caged trout starting on February 12th. Fish have been taken in the last week with limits expected any time now. If it is bass you are after we recommend fishing near the dam. This area has been producing nice bass the last week or so.

We have reports of sturgeon showing up in the Sacramento River. The hot spots on the river are Knights Landing and Verona. These two areas usually produce fish on a regular basis but once the word gets out the boats show up in large numbers. Let's face the facts.....there not enough sturgeon in comparison to the number of boats in the river.

The spotted bass at Bullard's Bar Reservoir are now in the pre-spawning mode. Records have been broken in this lake three years during this time of year. Expect lots of activity, but the chance for a big fish is at Bullard's.

Striped bass are still moving into the north side of the Delta which means the spring run is about to happen. Best bet on the

is cut bait or pile worms. In Suisun Bay area just about any type of bait is producing some sturgeon. We suggest a combination of baits be offered for the big boys. We advise you check

before you head up in the high country. Things should be clearing up now after the recent storms, but some reservoirs, including Stampede, Lake Tahoe and Jackson Meadows, were either snowed in or adverse weather made it difficult to fish this past week.



"Melt Up"

In recent months, undoubtedly due to the seemingly relentless rise in stocks, the term "melt up" has appeared in many a financial commentary. Indeed the term appeared years ago by prognosticators who predicted the trillions of dollars created by global central bankers to facilitate the myriad of bailouts required (arguably) to stabilize the world markets after the 2008/9 crisis would eventually find its way into the stock market, driving prices to previously unheard of levels.

With the widely followed Dow Jones Industrial Average (DJIA) soaring from the mid 6,000's where it stood during the 08' banking crisis to over 25,000 where it stands this week, an argument could be made this close to quadrupling of the DJIA could be nothing else but the proverbial "melt-up".

From Investorwords. com, the melt up is defined as:

"A dramatic upturn of certain stocks ocinvescurring when tors unexpectedly purthese stocks and drive their price up without any specific reason, logic or improvement in economic conditions. A melt up reflects a mass mentality where it appears that investors do not want to miss out on making a possible profit. This is usually followed by a meltdown".

Obviously the melt up portion of the equation is quite an enjoyable ride experience by most investors as they see portfolio values rising almost daily. What could be simpler right?

Such increases in stock valuations and their subsequent effect on in-

vestor perception of their new worth could also lead to the often touted "wealth effect". This wealth effect is based on the belief that with rising stock portfolios come rising optimism on behalf of investors and they will subsequently spend more, boosting asset prices even farther as companies reap the rewards of such spending. And around and around we go, upwards and onwards to the carefree life resembling the "Roaring 20's", a period in U.S. history that is said to be one of lavish spending brought on by the relentless rise in their markets between 1920 and 1929. During that time the nation's wealth reportedly more than doubled, only to fall victim to the great stock market crash of 1929.

Of course, the wealth effect is thought to kick in reverse when the opposite happens, mainly the stock market melts down. Such a thing happened in 1929 and has happened at various other times in history, not the least of which being our own crisis in 2008/09, when consumer spending fell off the proverbial cliff, to put it

This is not to say, as Investorwords.com puts it that "this is usually followed by a meltdown" is cause for concern.

After all, this is an opinion only, and as we know, no one, no matter who it is, can predict market direction, no way, no how. Obviously markets rise and fall as a matter of fact and historically speaking, but who's to say this market can't quadruple again before correcting, if it corrects at all?

Most analysts and investor alike would likely concur a market fall is in the cards, but when and by how much is an unknown fact to all. Should a minor correction or corrections happen along the way, such corrections are viewed by some as a healthy and normal pattern of markets in gen-

The fact remains al-

though manias, boom and bust cycles and "irrational exuberance" as Fed Chief Alan Greenspan once quipped in response to the dot com run up, may appear as excessive to some, markets don't follow scrips nor give a hoot about what anybody thinks might happen.

I have always said markets will reflect reality eventually but their day to day movements are only the perception of all the millions of investors in it on any given day. That said, the term melt up is only a term made up by some to describe what they perceive as an irrational movement over a given time period.

As in all debates however, there are others on the opposite side of the analytic spectrum that might say the drastic movements in the markets are only a sign of a healthy and booming economy. Although the rise in the market is indeed remarkable, there is no absolute law of markets that say it can't continue, and by how long, nobody really knows.

As in all things however and as the Boy Scouts say, hope for the best but prepare for the worst. That way, no matter what happens, at least you have a chance at not becoming another in a long line of investors who just hoped for the best, and did nothing

Sierra snowpack remains low

The Sierra Nevada snowpack has improved ever-so slightly in January, according to automatic sensors, but manual surveyors who visit the Sierra Thursday will still find far-below-average levels. Sensor readings show the statewide snowpack at about 30 percent of average, up from about one-quarter of average at the start of the month. But most aboveground reservoirs remain at or above average storage levels, due to the wet winter a year ago.

Processing tomato acreage to increase

More tomatoes may be produced on California farms this year, according to a preliminary government estimate. The report savs processors plan to contract with farmers to grow 12 million tons of tomatoes for use in sauce, ketchup and other products. That would be up 4 percent from last year's contract volumes. Processing-tomato acreage had dropped to low levels a year ago, as processors sought to balance supply and demand.

Direct purchasing may affect produce buying patterns

People who shop directly with farmers at roadside stands or farmers markets tend to spend more money on fruits and vegetables: That's the finding of a U.S. Department of Agriculture study. Analyzing data from shopper surveys, USDA concluded that Americans shop at direct-to-customer outlets relatively infrequently, and that encouraging people to shop at farmers markets and other direct outlets could increase overall fruit and vegetable purchases.

Area African-American Pioneers – 1848-1900 by Carol Withington

In 2011, a data base of over 520 pages listing the names of California pioneers of African descent was published by Guy Washington, program manager of the National Park Service of the Pacific West Region. In addition, an index of African American pioneer locations in California was also made available. This valuable information was gathered due to the National Underground Railroad Network to Freedom Act of 1998, which directed the National Park Service "to facilitate an international effort to commemorate and interpret the Underground Railroad and to locate and preserve sites associated with this theme of American history".

Information was gathered from a multitude of sources such as newspapers, cemeteries, the Federal census and city directories. One of the comprehensive most works utilized was from the book authored by Delilah L. Beasley whose extensive research was compiled in the 1919 publication of the Negro Trail Blazers of Califor-Another resource

Over the following months, a series involving the lives of area African-American pioneers will be presented in order to honor those over 200 residents who chose Marysville and surrounding communities as a place to settle and begin life anew.

WESTWARD MOVEMENT

When gold was discovered at Sutter's Mill in 1848, among the huge migration of people who headed to California were African-Americans Fritz Vosburg and James Monroe Breeden who appear to be the first to arrive in Marysville followed by over two dozen pioneers who are listed as "49ers", according to Delilah Beasley.

Among those identified are: William Bailey, Texana, Major and Charles Breeden: Samuel Brown, Robert Chandler, James and Mary Churchill, Sandy Clark,


Rounding out the area African-American 49ers include: George Symes, Sarah Thompson and her husband; Bill Vaughn and Mrs. Carpenter Williams.

According to research, many of these pioneers were primarily from the southern states with the majority from Virginia. Missouri, Kentucky and Tennessee--in that order. Others arrived from the southern states of Florida, Mississippi, North Louisiana, Carolina, Maryland and Texas.

The remaining states include: represented Connecticut, Massachusetts, New York, Pennsylvania, Illinois, Michigan and Ohio. Two arrived from Washington D.C. and a few from as far as Denmark, England and Jamaica. Unfortunately, records do not sometimes record the state of origin or the arrival year to California of some of the African-Americans.

Those who arrived in 1849 and the early 1850s found Marysville a bustling distribution center for the northern mines. It was also one of the largest cities in California with a variety of businesses and trades to accommodate its residents as well as the miners during their excursions to replenish supplies. All appeared to be welcome. One saloon even placed a sign in the window encouraging all customers "with no regard to distinction or color".

Some African-Americans were eventually able to purchase freedom for themselves or send money for family members to come to the area. However, there were others that were sent back into Southern slavery by their owners or remained slaves while in California such as Addie Taylor who will be among those highlighted in the next part of this series.
