# **Non-Profits Recognized**

For efforts during wild fires of October

On Friday February 16, 2018 the California State Legislature publicly recognized the people and organizations that made immeasurable contributions during and after the devastating wild fires of October 2017. That included the leaders in each of the counties of

Nevada, Butte, Lake, Yuba, and Sonoma along with the state firefighters.

In addition to the government leaders of each county the legislature recognized the non-profit organizations of the Foothill Lions in Yuba County, Feather Falls Grange in Butte County and Yankee Hill Fire Safe Council of Nevada County.

The resolutions were presented to each of the organizations by Senator Jim Nielsen and Assemblyman James Gallagher on the floor of the Senate. The resolutions recognized the damage to property and lives during an unprecedented fire storm driven by winds up to 70 miles per hour. The resolutions also recognized the successful efforts of the non-profits to raise money for those affected by the fires, gather needed supplies, food and clothing and help in the information to begin rebuilding . The Foothill Lions Club is located on the edge of the fire line and was helpful as an immediate gathering location. Within days it became a central location for FEMA to gather information that those affected would need to move forward.

Learn the Sales Tax Shuffle

In 2014, the City of Marysville initiated a campaign to raise the sales tax rate to 8.5% for 10 years. It failed by 75 votes. The council, unable to service debt on a lame decision to speculate on property, blamed the shortage of funds on police and fire. City Hall launched a second identical tax measure in 2016 which passed on June 4 by 209 votes.

Both pitches promised the funds though not legally restricted would be used for police and fire. That was a lie. A citizens committee was to keep the council honest.

As soon as funds began to flow raises were given to employees, not restricted to emergency services. The other day City Manager Marti Brown in an interview with radio personality John Black mentioned that maybe some of the funds could go to parks. Yes, parks are terrible, but the money wasn't for that.

Opponents of the sales tax increase argued that as personnel and council members come and go the new cash flow will be just that, and have nothing to do with police and fire. We are already there in Marysville. People are forgetting the emergency services tax lullaby.

Now, the Yuba County Supervisors just spent \$30,000 of taxpayers' money for a survey of 556 voters to convince citizens to raise sales taxes by 1%. It's for police and fire they say.

Howard Jarvis Taxpayers Association says, "Local governments also frequently hire expensive consultants (at taxpayer expense) to tell them the best way to pass a sales tax. These consultants sometimes advise local officials not to publicize the sales tax election to the entire community, but to target only their supporters. This means running a stealth election, communicating only with known tax supporters."

**Faces of The Internment** 

On February 19, 1942 President Roosevelt ordered Japanese Ameriinternment cans to camps. The U.S. government then began relocating Japanese-Americans living in coastal Pacific areas to internment camps in remote areas of several states. This came 10 weeks after the surprise attack on Pearl Harbor in Hawaii.

Of the 127,000 Japanese-Americans, mostly U.S. citizens, 112,000 lived on the West Coast and about 80,000 were second generation U.S. citizens

Walter Williams says "Americans should be proud of the tremendous gains made since emancipation. Black Americans, as a group, have made the greatest gains, over some of the highest hurdles, in a shorter span of time than any other racial group in mankind's history."

Williams says that "if American black income is totaled and thought of us as a separate nation along with its own gross domestic product, black Americans would rank among the world's 20 richest nations."

Then there are key national leaders. Colin Powell directed the world's most powerful military and Barack Obama the nation. Clarence Thomas is a world-class Supreme Court jurist. Ben Carson is a renowned neuro-surgeon. Blacks routinely are picked for the President's cabinet, sundry legislative seats and to be mayors of our largest cities.

A few black Americans are among the world's richest and most famous personalities. There is a multitude of black millionaires.

Black intellectual, educator and author Thomas Sowell and Williams both contend that neither former slave nor slave owner would have dreamed that such changes and advances were possible in 150 years. It is a tribute to the Constitution and Americans that worked and fought to make the needed changes to conform the nation to the grand document. It should not be



This time of year we are always discussing the fish which move up river to spawn. This includes salmon, steelhead, striped bass, shad and others. These runs certainly get one heck of a lot of anglers excited but there are fish which live here year round in the waters of the foothills and valleys of Northern California.

Catfish swim in all waters in the North State, as well as in the South, and are good fighters and excellent food fare. In fact, many folks prefer a catfish fillet for dinner over other fish.

A long time ago my Grandfather and Uncle would go out into the Sutter Buttes and bring home a half dozen or so dead jack rabbits. (Jack rabbits were so common back then it was easy to see a hundred or more in a single morning). After field dressing the animals and both ingredients and carcass are left out in the sun for a week or so, they were placed in a gunny sack, along with several large rocks, and thrown into local ditches, streams and bypasses. After several days we would go fishing for catfish close by the chum. Some very large fish were caught with this method, which by the way is illegal now.

Stink baits have been used for catfish for a long time. This concoction used to be home made and everyone had his or her own recipe. Nowadays you can purchase all different kinds of catfish bait at the local sporting goods store, but some of us still prefer our own mixture and we all know good catfish bait must stink. Another reason to make your own bait is no one has it.

We highly recommend if you decide to make your own catfish bait that you do it away from the house and never mix up a concoction in the kitchen. In fact, the containers you use should be ones that will not be used for anything else. Most stink baits have a base of melted cheese mixed with some kind of meat and spices. Garlic is a favorite. I know of several



anglers who used to poke holes in canned dog food and drop it in the water. Again, I believe this is illegal today.

Finally, the bait must be of the consistency to melt away underwater which will get the smell to the fish and draw them to the area. Baits can be placed inside cheesecloth or dip a sponge into the mess. The other important thing to consider of the bait must stay on the hook.

# **Food and Farm News**

### Agriculture secretary visits California

U.S. Agriculture Secretary Sonny Perdue visits farms in the Central Valley Wednesday during the second day of a three-day visit to California. Perdue has scheduled visits to two fruit packinghouses, a dairy, an almond processing plant and other facilities. On Tuesday, the secretary conducted a town hall meeting at the World Ag Expo in Tulare, during which he answered questions about farm policy, research priorities and other topics.

Unusual winter weather affects crops

Warm, dry winter weather affects operations on California farms and ranches. Farmers say warmer-than-average temperatures in recent weeks have pushed crops ahead of a typical schedule--and may leave some crops vulnerable to frost when colder weather resumes. The lack of rain in the Central Valley has encouraged some farmers to irrigate trees and vines earlier than they typically would.

### State continues to lead in vegetable production

Heavy rains in California last spring contributed to reduced vegetable



production in California, according to an annual report issued Tuesday by the U.S. Department of Agriculture. The report showed total vegetable production in the state down 11 percent, compared to the previous year--though harvests of crops such as cauliflower, sweet corn and romaine lettuce increased. California accounted for 57 percent of the nation's vegetable production last year.





### (Continued from Page 1) Learn the Sales Tax Shuffle

"Since it is illegal for local officials to use public resources (including public tax funds) to urge a vote for or against a ballot measure, consultants frequently counsel sales tax supporters on the best way to wage 'information' or 'education' campaigns. This often means putting up signs or sending out material stating all the 'good things' a sales tax would do, but stopping just short of telling people how to vote. These tactics sometimes occur even before a tax is officially placed on the ballot."

Cities and counties use scare tactics explaining this is the only alternative to save law enforcement and fire. They use "It's only" campaigns. "It's only a few cents a day or a few dollars a month more for police and fire." They make it sound trivial. However,

many people will pay more than \$1,000 in additional taxes a year. The poor of the county will be hit the hardest.

The truth that won't be told is that supervisors misspent funds designated for emergency services, overpromised on salary and pensions and now want a bigger bucket to bail- out a leaking boat.

This is a budgetary shell game. A sales tax measure is put on the ballot to fund a politically popular purpose (emergency services), and if the tax passes, it would enable local government to free up money from the general fund that can then be spent on the pet projects or programs of local politicians.

The Appeal Democrat will support the tax increase since the paper owes the county for getting their legal advertising. Businesses needing

a favor from the county will contribute campaign funds as will employee unions that want their pensions funded by taxpayers.

Sacramento employee unions paid for Measure U, the half-cent sales tax voters approved in 2012 to "restore public safety services." The union will likely fund the tax renewal campaign as well.

The League of California Cities reported this month that pension costs are expected to jump by at least 50% by 2024-25. It is unsustainable. Rather than stopping the insanity the league is advising all cities or in this case counties to launch local tax measures.

Since unions have money-and-vote-hungry politicians by the short hairs they both will get exactly what they want with taxpayers once again getting screwed.

Sell Good News Buy Bad

Truth sometimes is stranger than fiction. A week back or so I penned an article called the "Melt Up' which detailed the great run up in stocks and how rare it was to see such a sustained rally. Also detailed in that article was the caveat that "this is usually followed by a meltdown". No sooner did the article hit the wires did the market start to crater and in a big way. From the high of 26,616 on the Dow January 26th of this year, last week saw wild gyrations almost daily. It culminated with a handle gripping 1,175 drop on February 5th. It has been down 1579 mid-day so I guess it could have been worse.

We can make an educated guess as to why the "downalanche" (a coined phrase of mine) started but the cause touted by some was that the Federal Reserve would raise interest rates after an economic positive unemployment number came out from the Bureau of Labor Statistics.

Why good economic news causes a stock market selloff seems to be the new norm in the last decade or so is the perplexing question. Not so perplexing however say many analysts.

With the Federal Re-

logical conclusion would be the markets will fall and investors are acting preemptively to this belief.

It's indeed counterintuitive to think good economic statistics would trigger sell offs but the proof is in the proverbial pudding. A good unemployment number hit the wires the day the selloff began and when another bit of good news hit February 8th (jobless claims at a four year low) the market started down hard again.

In my opinion, this type of "sell the good news, buy the bad" where market direction is now more influenced by Fed monetary policy then economic fundamentals sets a dangerous precedent and a confusing picture to the average investor. The question now becomes: do you buy stocks when the economy shows signs of weakness because you believe Fed will rescue it or do you buy stocks when the economy shows signs of improvement which seems more logical?

According to the most recent market action, the former seems to hold true. But considering the logic of all of it and how we arrived at this point, who's to say one day the market's reaction to economic news will once again revert back to a saner evaluation of economic fundamentals?

Which is to say: wouldn't it make more sense to buy stocks when the economy is improving and remove the Fed from the picture all together? That would mean the Fed would have to back off trying to alter market direction and let the free market reign once again. Doesn't that seem to make more sense?

This analyst thinks so.

It all revolves around the elixir the Fed administers when it comes to monetary stimulus, which is to say how they respond to stock market falls or economic news. Historically the Feds drop interest rates to goose an economy (or rescue one) and increase rates to cool off an economy that's running too hot.

# Live or Die **Animal Disaster Planning**

Part Two by Carol J. Donaldson

Initially you are on your own during an evacuation. It will be you, your family and friends evacuating your animals. It takes time for emergency personnel to get into place and get the call centers up and running. If you are on your own don't hesitate to contact your local Office of Emergency Services call center or 911 in your county if you need assistance in removing your animals. In turn they will contact the Sheriff's posse, Animal Control and the local animal disaster groups. Many agencies, rescue organizations work together to bring animals out of the disaster area or provide them food and water.

There are several excellent websites: www. ready.gov/animals; www. humanesociety.org/issues/animal\_rescue/tip/ pet; check FEMA's website: Yuba County Office Of Emergency Services; and the County of Sutter has an Emergency Operations Plan (very extensive). Research and put together your emergency kits and

plans. Yuba County and Sutter County sites suggest if you have to leave your pet, Do Not Leave Them Tied Up. If confined in house, leave toilet seat up and toilet lid off. They have to have access to water. Make sure they have plenty. Leave a note posted to door or window with what type of pets, your contact information and your veterinarian's contact information.

It can be a decade or more between disasters, so don't let compliancy settle in - at least a couple of times a year practice your evacuation drill, update with trusted neighbors, friends or family your evacuation plans; keep crates in good shape and reachable and keep copies of important records (vet, micro chip, photos, etc) up to-date.

A pet escaping during the evacuation process is heartbreaking. In his excitement or fear if he is not contained, he will leap out of the vehicle and run. Collars with ID and micro chipping can save you heartbreak, if the animal

be returned to you. Notify news stations. many run stories of lost pets during crisis situations. Make flyers with your pet's photo, put them up in the area he was lost; advertise and check craigslist and other web sites. If you don't find him keep posting and checking as 6 months to a year later he may appear in an ad. Check with animal rescue groups. Send photos and description to all the local veterinarians. Check with all of the animal shelters in your county as well as surrounding counties, if someone finds him and takes him out of the area they may turn him in to a neighboring shelter.

You only have one life, your animal only has one life - don't wait until the last minute to evacuate. Have a workable plan.

and blocked all refugees for 120 days while the administration assessed its security process. After legal challenges, the administration issued a revised order in March. and in June the U.S. Supreme Court decided a version of the ban could go into effect.

Immigration: The DOJ resumed the criminal prosecution of first-time illegal border crossers after it had been stopped by the Obama administration.

**Government reform:** Trump signed an executive order in January to expedite environmental reviews of infrastructure projects, to jumpstart industry spending and investment.

Manufacturing regulations: Trump signed an executive order in January reducing regulations on manufacturers.

**Regulatory** reform: Trump set up task forces in every agency to remove "job killing regulations" and increase "economic opportunity." The Trump administration is on track to finish the first phase of its regulatory reform program with \$645 million in net annual regulatory savings, according to an analysis by the American Action Forum (AAF). By comparison, during President Obama's years in office, more than 22,700 regulations were imposed on Americans at a cost to American consumers, businesses and workers of more than \$120 billion each year. AAF called Trump's order reducing regulation and regulatory controlling costs "one of the most significant developments in regulatory policy in decades," noting it was the first time in U.S. history that the executive branch has established a regulatory budget.

expanded deportation priorities, signing an executive order in January that includes people who "have committed acts that constitute a chargeable criminal offense,' which could include anyone who entered the country illegally, leading to a significant increase in arrests.

**Government reform:** Trump signed an executive order Jan. 23, 2017 placing a hiring freeze on federal employees.

**Regulatory** reform: Shortly after his inauguration, President Trump signed an executive order mandating that for every new regulation, two regulations must be revoked In practice, the administration has exceeded that mark, rescinding or delaying more than 860 regulations, or 22 regulations for every new one implemented.

Abortion: In January, Trump signed an order reinstating the Mexico City Policy, which defunded the International Planned Parenthood Federation and other organizations that promote foreign abortions.

President's salary: President Trump, as promised during his election campaign, has donated his salary.

Technology: After his election, Trump met with top tech leaders, including Mark Zuckerberg of Facebook, Bill Gates of Microsoft and Jeff Bezos of Amazon. According to Gates, it was "a good conversation about innovation, how it can help in health, education, the impact of foreign aid and energy, and a wide-ranging conversation about power of innovation." That's just one-third of his first month's workload...and he's got the rest of the year to go... and he just got started!



As I unloaded my tractors for display on Monday afternoon, I saw a young man polishing a piece of farm equipment. I walked over and complimented him on his work. He happened to be from Northern Michigan. I wished him a good visit to California. He responded in awe about our weather, soils, and variety of crops. A detail that has caused me much thought was he belonged to a tractor club Jim Escheman and I joined so we could do the Big Mac Bridge Drive in September in Michigan!

Practically next door was a local dealer that I have had great respect for many years.

Beeler Tractor had some of their equipment on display. The dealership


had its roots with Howard R "Buck "Beeler.

History is not a series of dates or places, but also people and their machines who generate the woof and warp of who we become as a culture. The long time businesses that grow in our towns and cities have special people involved. Those that possess hearts of stone do not last. Those who have hearts of blood and compassion for their fellow man survive. Those businesses that place value given above money gained move on into the future.

I did not know Buck, but over the years I used their service and parts department. I particularly became a good friend of a young East Indian man in the parts department who brought his family to my farm. I sold a hard to find tire to one of their mechanics for a John Deere BO. I just learned the tractor came from a farm in Colusa was sold by the dealer in Colusa.



Buck created a culture of quality and service in his business which is verified by a review of files of letters expressing their appreciation. The letters came from a wide area to local. The handwritten letter from Susanville to the emergency repair immediately done for the Linda County Water District. Mr. Beeler's attitude of " Get them going "is still there today. Why else would a company have so many long term employees for



35 years and one who is still at the site? When the clouds were dark and the fruit was ripe, Beeler would be there.

Many of the N series tractors were sold by the network established by Harry Ferguson. After that split with Ford, the main sale sites occurred through the car dealers. Following that in our area partnerships formed and companies were established. Preceding Ford tractor dealers in this area were E M Barth and C P H. E M Barth was located on 14th St. in Marysville and that business was purchased by Buck in 1961.

A Grand Opening for the present site on Onstott occurred on February 18, 1967.

Buck was a Navy Veteran of WWII and at one time was a PGE employee. He was active in community service and was a member of the local Rotarian Club. He enjoyed playing dominos at Peach Tree and passed there. He was a somewhat young man when he was called. Buck was not a rich man but he was known for helping local farmers as best he could. He would make good deals, give discounts and accept delayed payments. He was one of the first in our area to use two way radios on his service trucks. He was survived by his wife Edith who carried on the business. The present leadership of Beeler Tractor evolved from a network of past employees. Ford tractors opened the Dearborn equipment to make equipment for the three-point hitch. Ford bought Newholland and later Versatile. As Beeler Tractor evolved, so has the array of equipment. They presently have a wide selection of agricultural products. Buck Beeler, was a man with a great heart and one of several who helped the Yuba Sutter Basin become a world

class food producer. What we leave is more important than what we take.


