Yuba County Deputies Receive Top Honors The Gold Medal of Valor

On Wednesday December 6, 2017, Steve Durfor, the Yuba County Sheriff had a special awards ceremony. Three deputies, Sgt. Brandon Spears, Deputy Nathan Byrom and Deputy Andrew Thomas were presented with special commendations for exemplary performance in their efforts related to the illegal cultivation of Marijuana.

Three deputies, Phillip Bronson, Andrew Everhart, and Daniel Harris were presented with the Gold Medal of Valor.

The Gold Medal of Valor is the highest decoration for bravery exhibited by public safety officers in

the United States, comparable to the military's Medal of Honor. Previously there were only two recipients of the Gold Medal of Valor in Yuba County, Yuba County Sheriff's Deputy Brian E. Meilbeck was awarded posthumously Sergeant Kenny Smith. Smith still works with search and rescue.

The incident happened on August 1, 2017. Two deputies Phillip Bronson and Andrew Everhart responded to a Marijuana in Oregon House. Upon arrival the two deputies responding pursued a suspect, matching the description they were given, into a mobile home.

As they were clearing the home they were met with gunfire, both were hit twice, and returned gunfire. While unknown at the time it was believed that they hit the suspect. Both deputies were laying wounded in the mobile home. A third officer. Daniel Harris, had been watching the back of the home. He entered the home twice and pulled the two deputies to safety.

The two deputies were flown to Sutter Roseville related disturbance call where they underwent extensive surgery.

"Honor Legion". It came about after a retired NYPD Officer who was traveling through Northern Ca. on vacation during the time of the incident, heard of the officers shooting and responded to the hospital, where he introduced himself to Sheriff Durfor. They later signed the flag and asked Sheriff Durfor to present it to the three involved in the shooting. The Sheriff is sending a photo of the deputies and the flag to NYPD Honor Legion at their request. The NYPD Honor Legion will post the picture in their Honor Legion Display as well as publishing an article about the incident.

No More Taxes

Yuba County Administrative Officer Robert Bendorf and the Supervisors have crafted a county government to their liking. The problem is the citizens can't afford it. County officials this week are debating not how to cut back but how they can lift more of your money. Their eyes are bigger than their bank ac-

Americans are world-famous for living above their means. Most have only a month's worth of savings for emergencies.

The difference between counties and families is that families run low on money, cut costs or go bankrupt. Counties just take more from taxpayers and they are good at it. The Howard Jarvis Taxpayers Association has a phrase for how jurisdictions make a tax increase palatable, 'Bait and Switch.' For example in 1996, Yuba County pitched a Transit Occupancy Tax to develop tourism. Once passed, the money was absorbed into the general fund.

Marysville's recent fear campaign claimed that police and fire would not be able to properly respond to 911 calls if citizens didn't increase sales taxes to 8.5%. Since the law prevented the council from campaigning for a tax increase or using tax dollars to do so they colluded with developer David Lanza to fund a propaganda effort to deceive voters. It worked. Lanza then was awarded a marijuana dispensary permit by the city.

Once the new tax flow began, the Marysville City Council gave raises to employees including the City Manager. Remember the money was to maintain proper police and fire services. Then the council added more than \$640,000 in debt to lease 19 new po-

Casino Breaks Trust

Yuba County Supervisors received a letter from the Colusa Indian Community Council - Cachil Dehe Band of Wintun Indians. The Colusa Casino group is asking Supervisors why Butte County's Enterprise Rancheria is allowed to ignore agreements made in 2002 in order to build a casino in South Yuba County.

The Wintun Tribe followed the law to establish a casino on their reservation near Colusa. They have been protesting the Butte County Tribe's illegal reservationshopping to locate a casino in Yuba County rather than in Butte. They're asking why we all don't play by the same rules.

The Cachil Dehe people have a point. Enterprise Rancheria agreed to a Memorandum of Understanding (MOU) crafted by former Supervisors Mary Jane Griego and Don Schrader, but Enterprise has not complied with it. The need for compliance was triggered by the tribe breaking ground. The tribe made an initial payment to the county and the City of Marysville but then nothing else.

The tragedy is that Griego and Schrader's MOU included no cost of living adjustment in the event the casino took years to build. The flawed MOU, now 17 years old, has cost Yuba County taxpayers hundreds of thousands of dollars in lost revenue.

In the past, Supervisor Andy Vasquez and former Supervisor Roger Abe asked the board to revise the MOU to properly reimburse taxpayers in current dollars for costs expended. Their request was rejected by former Supervisors Griego, Nicoletti and Stocker.

Enterprise Rancheria has violated the MOU by not

Preet Didbal Makes History as New Yuba City Mayor

First Sikh Woman Mayor Calls It An Honor to Lead Her **Community, and Serve as Role Model for Young Women**

The Yuba City City Council swore in Vice Mayor Preet Didbal as Mayor on Tuesday, December 5, 2017.

Didbal was elected to her first term as a City Councilwoman 2014 after eight years serving on the Yuba City Planning Commission and two years on Sutter County Planning Commission. Beating the odds, breaking both cultural, and gender barriers, she is the first Sikh American woman to become Mayor in the United States.

"I'm incredibly humbled by and grateful for the responsibility our community has invested in me," she said. "This is such an honor and incredibly exciting, for me and even more so for my family. It is truly the manifestation of the American dream."

Mayor Didbal was born and raised in this community, after her parents immigrated from India to Yuba City in 1968. The daughter of farm laborers, Preet worked alongside her parents in the peach and prune orchards and on the graveyard shift at a cannery during the summer. She became the first in her family to attend college, pursue a master's degree, and follow a path to leadership in local government, culminating in her election to the Yuba City City Council.

"I lost my dad several years ago, but this was something we had talked about before he passed away,"

YCWA Grants \$10,000 **Levee Maintenance**

The Yuba County Water Agency Board of Directors approved a grant to Reclamation District 817 to fund vegetation removal along areas of the Dry Creek and Bear River levees.

RD 817 is responsible for the maintenance of

the levees that provide protection for agricultural properties in the unincorporated area of the county, west of the City of Wheatland and in a portion of the area north

With the months quickly proaching, construction and maintenance on levees throughout Yuba County is critical. This grant will provide up to \$10,000 for mechanical vegetation clearing along several reaches of levees that have become overgrown with blackberry bramble and wild rose, making it difficult for routine levee and drainage culvert inspec-

"This is a great opportunity for us to help improve and sustain levees, and reduce flood risk for the people who live and work in Yuba County," said YCWA Board Director Gary Bradford. "This grant will allow RD 817 to more efficiently operate and maintain the levees within its jurisdiction."

Previously, RD 817 burned the levees to suppress vegetation, but this practice has become difficult due to air quality and endangered species regulations. The vegetation has grown beyond the point where animal grazing or herbicide spraying can work effectively.

Once the levees have been mechanically cleared, RD 817 will resume grazing and spraying programs to control vegetation and maintain them according to current standards.

Christmas it iust around the corner and will be here before you know it. Now is the time to give serious thought to those who fish in your family or close friends. Just about anyone who enjoys the sport of fishing would appreciate a gift for their favorite sport. If you want to do this and do not know what to give try a gift certificate or card from a store that specializes in fishing equipment.


As we reported last week the sturgeon fishing on the Delta is out of sight with fish of all sizes being taken on the Sacramento Delta and at Suisun Bay. Striped bass are also on the bite and can be found at both ends of the Delta. If the Delta is too far for you to travel we recommend the Sacramento River for sturgeon. Hot spots are still in the vicinity of Knights Landing and Verona. Successful anglers are using a combination of bait on their hooks including night crawlers, eel and other baits along with roe.

The cold weather at Lake Tahoe has reduced the number of boats on the lake. This light pressure has increased the bite for brown and rainbow trout as well as mackinaw lake trout. These fish are being caught in shallow water with the trolling speed reduced due to the cold water.

The Department of Fish and Wildlife dumped a bunch of trout into Folsom Lake last week as well as Fuller Lake and Englebright Reservoir. We received reports of some of the trout in the plants being in the 12 to 14 inch range.

Resident Striped Bass are once again being taken on the Feather River along with some fresh stripers showing Some anglers are hooking up with fish at Mosquito Beach just south of the Fifth Street Bridge at Yuba City. The fish are hitting on cut bait and plugs.



"The Thin Blue Line Flag is a symbol used by law enforcement to symbolize the relationship of law enforcement in the community as the protectors of fellow civilians from criminal elements. Each stripe on the emblem represents certain respective figures: the blue centre line represents law enforcement, the top black stripe represents the public whilst the bottom represents the criminals. The idea behind the graphic is that law en-



forcement (the blue line) is what stands between the violence and victimization by criminals of the would-be victims of crime.

Proponents of the symbol assert that the identifier is intended to show support for police. In the wake of controversies over police shootings, the Thin Blue Line Flag has become popular among law enforcement personnel, their families and supporters."



The Public Safety Officer Medal of Valor, which intentionally resembles the military's Medal of Honor, is a gilt, blue-enameled, five-pointed, upside-down star (i.e. one arm points downwards), with each arm formed by a letter "V" (for Valor), surrounded by a wreath of laurel. The central disc bears the obverse of the Great Seal of the United States. The reverse bears the legend "FOR EXTRAORDINARY VALOR ABOVE AND BEYOND THE CALL OF DUTY", with the name of the recipient engraved at the center. The medal is suspended on a gilt disc bearing a letter "V" surrounded by a wreath of laurels, which is in turn suspended on a neck ribbon, blue with white and red edge stripes (the national colors of the USA) and a gold center stripe (symbolizing honor).

When the ribbon alone is worn, it carries a miniature gold gilt disc bearing a letter "V" surrounded by a wreath of laurels. There is also a lapel pin, which is the miniature of the medal without suspension.

A Yuba County Icon is Reborn



I first visited Yuba County's Oregon Creek Covered Bridge in 1992. I was impressed by its rough beauty and the fact that it was built in 1860. That would make it the oldest covered bridge in California. By the way, covered bridges were built in order to protect the wooden bridge roadbeds from the elements.

What I was not impressed by, however, was the fact its 100 foot length looked like it was about to collapse into the creek bed. I recall not being able to find enough courage to drive across it.

In January of 2017 I again visited the bridge. I found that over the past 25 years the bridge's condition had gotten far worse. Auto traffic was banned and both ends of the bridge were blocked by huge concrete barriers. After taking some nice photos I left, rather depressed. I felt that it was even more likely that its bulk would soon fall into the creek bed.


A few weeks ago I posted some of those photos on a Facebook page called Yuba-Sutter History 101. I got a good reaction to them. One was from a woman who stated that she discovered that the bridge had been torn down this summer. I was appalled that a historic bridge had apparently

been destroyed. But shortly thereafter others who posted advised me that the bridge had been torn down, but then reconstructed in new

condition. In addition to being very happy that a local historic icon had been reconditioned, I was very surprised that this was the first I had heard of this major restoration. There was not one thing about it on the internet and I could find nothing in our local media that had even mentioned it.

So last week I visited it and the included photograph is the result. It has been beautifully reconstructed. And, yes, this time I did drive across it. The bridge is located about 3 miles north of North San Juan on Hwy 49. It's easy to find by taking the right turn at the Oregon Creek

Day Use Area. This bridge is also known as the Freeman's

Crossing Bridge. A uniqueness of the handmade original bridge's history is that it was reinstalled backwards. In 1883 it was washed 150 feet downstream when a dam broke. As it washed downstream, it turned end to end. A team of oxen was used to tow the bridge back into place. However, they reinstalled the bridge backwards.

There are several covered bridges in our area besides the Oregon Creek Covered Bridge in Yuba County. There is the Bridgeport Covered Bridge (1862) in Nevada County. There are two in Butte County; the Honey Run Covered Bridge

(1894) and the Oregon City Covered Bridge (1984). They are all well worth the drive to visit them.

It's nice to know that some government agencies and some private organizations have made efforts to preserve, and sometimes reconstruct, these very visible relics of our past.

The restoration of the Oregon Creek Covered Bridge will guarantee a great reminder of our history for those who visit the Oregon Creek Day Use Area. With its new, reinforced bridge foundation I don't see it falling into the creek bed any time soon.

lice cars. Remember, the new tax flow was to pay for police needs not borrow more and spend the tax increase elsewhere.

The truth is that Marysville had financial problems because the council created \$17 million in debt to invest in 5 acres of lakefront property on Ellis Lake. There was no problem with police and fire funding until they botched the city budget.

No one would support a new tax for a land purchase boondoggle. The better strategy was to scare the hell out of senior citizens and mothers with young children, then utilize the new tax flow to boost the general fund to cover more than \$600,000 in annual property payments.

Yuba County officials say there is not enough money for Law Enforcement (LE) and Fire (F). That's impossible. LE and F are the only constitutionally mandated expenses for government. County officials should redeploy funds from other uses and departments back to LE and F. The county is living way above its means. Take a look at recent history.

In the 1990's, prior to former Sheriff Gary Tindel remodeling and expanding the jail to take in immigration detainees the Yuba County Sheriff's Office (YCSO) budget was maintained by the general fund. However, once millions (currently \$6 million annually) of federal dollars flowed to YCSO for housing immigration inmates, supervisors began diverting tax dollars once destined for YCSO.

There was so much money that county officials gave employees

raises retroactive to the date of hire. The bonuses not only added more than \$1000 a month in pay to some workers but it spiked pension payments for the rest of their lives.

Then as the housing boom blessed Yuba County with massive revenues etc., Supervisors voted to double their salaries and benefits to more than \$80,000 each. Within 1-2 years of that decision the housing crash and recession occurred. Revenues dipped severely but it was much worse than it needed to be due to reckless payroll spending and unwise county budget decisions affecting YCSO. Add to this misman-

agement impossibly high pension and health benefits. They are unsustainable and much higher than what local citizens have for themselves. That is wrong.

Finally, there too many administrators earning too much money for Yuba County folks. Here is a sampling of 2016 salaries for non-public safety employees. The County Administrator was paid

\$277,207; Dep County Administrator \$169,853; Health Officer \$261,373; Community Development Director (Dir) \$239,989; Dir of Public Works \$213,567; County Counsel \$239,960; Health and Human Service (HHS) Dir \$227.475: Dir Child Support Services \$206,893; Dep Dir HHS \$190,204; another Dep Dir HHS \$185,110; HHS Program Manager \$154,100; another HHS Program Manager \$146,154; Dep Dir Child Support Services \$145,678; Chief Information Officer \$185,352. There are 1,013 county employees with 689 considered fulltime / year around in 2016 according to Transparent California.

The median household income in Yuba County is \$48,739 which means a lot of little people funding a lot of big shots.

The county has money for consultants, homeless camps, \$3,000 a month for 14 Forward lunches, and much more. Yuba County's 73,000 residents are already the highest-taxed people in a nation of 323 million.

It's time to govern differently not tax more.

Dividends

Dividends are payments by companies to shareholders. They are at the discretion of the company and can be changed usually at any time in a variety of ways including to increase, reduce or eliminate them.

Companies may utilize dividends to entice people to buy their shares and hold on to those shares for the payments. Some companies pay dividends and others do not. Some companies never paid them, some used to and some may even start to pay them in the future. The point being made here is companies can do whatever the heck they want as long as they don't break the law. And fooling around with dividends is usually a common occurrence.

An obvious observation to make is in order to pay out money, the company first has to have it. And therein lies the caution. Like any other entity needing cash for whatever reason, a company short on cash could still pay out a dividend or a series of dividends by borrowing the money to do so. But having to borrow money only to turn around and pay it out might not seem like a prudent financial decision and in many case it isn't.

When an investor buys a stock for its dividend and that dividend is increased, it makes for a happy investor. Usually it also makes for more investors buying the stock. When a dividend is cut, the reverse might be true and the stock may fall as investors head for the exits once the payments go away.

How can you tell if a company can afford its dividend or is living on borrowed time (literally) in order not to spook investors by reducing or cutting its dividend?

There are a variety of indications but unless you are on the Board of Directors making that decision, an investor can only make an educated guess based on the public information about the company's financials.

Without getting too complicated, your question is: does the company have the cash to pay out its dividend and for

how long? If not, when will it cut or eliminate its dividend in the future?

A lot of it boils down to what is called "free cash flow". One obvious question is if a company pays out five million in dividends, does it have the cash after paying its bills to pay the inves-

Another question would be even if the company is making enough in profit to pay, is the company banking that profit when dividend time comes around.

It can all boil down to it free cash flow. Is there enough cash left over after all expenses to pay out the dividends promised and is the cash received in time to pay the dividend when it's due. The other issues are can the company continue to make enough money to continue to pay its current dividend over the long haul or will it eventually have to cut or eliminate it because profits and the receipt of such profits eventually fail to meet the obligation?

The ability to pay dividends hinges many events but the first question investors can ask is the basic one: can it afford to? A good place to look for that answer starts with its cash flow. An old saying in business is "cash flow kills", and when it comes to dividends, those words couldn't be

Farmers assess damage from **Ventura County fire**

The Thomas Fire in Ventura County is burning in an area known for its production of citrus fruit and avocados, but it's too early yet for authorities to estimate agricultural damage from the fire. The grower group California Citrus Mutual and a local farm advisor say the fire appears to have affected Ventura County groves, but the extent of damage isn't known. In the Central Valley, cold temperatures this week have not harmed citrus fruit so far.

Tax-reform measures show mixed impact

With federal tax reform headed to a House-Senate conference committee, California farmers and ranchers say they may not gain as much from the package as they had hoped. Although many parts of the bills would help farmers and ranchers, California Farm Bureau Federation analysts say other provisions could be problematic. For example, they say, elimination of a federal deduction for state and local taxes would put California farmers at a disadvantage.

Farm Bureau holds 99th Annual Meeting

The California Farm Bureau Federation will elect new officers when it finishes its 99th Annual Meeting in Garden Grove Wednesday. In his annual address, retiring Farm Bureau President Paul Wenger said consistent, long-term and unified advocacy will be needed to secure the future of California farms and ranches. Delegates to the meeting will set Farm Bureau policy. The meeting also features recognition of county Farm Bureaus.

UC reports progress in psyllid fight

In a discovery that

could help citrus growers fight a dangerous pest, University of California scientists say they have identified the sex pheromone of the Asian citrus psyllid. The psyllid can spread a plant disease that kills citrus trees, and has been found in Southern and Central California. Pest experts say the development holds promise for both preventing the spread of the psyllid and aiding in its control.

NYWD Pays Off Loan from YCWA

The November 30th 2017 North Yuba Water District Board meeting began with a report by the Financial Manager Heidi Naether that the District had \$2,000,000 cash in the bank. By the end of the meeting, the Board had voted to allow General Manager Jeff Maupin to spend up to \$2,000,000.

Among other items, Manager Maupin was authorized to pay back a \$399,000 loan to the Yuba County Water Agency. Not only will this save some large interest costs, it will also help to establish the Water District's creditworthiness.

Manager Maupin was also authorized to purchase a fleet of new vehicles to replace and augment the current fleet, which has reached the end of its useful lifetime.

This will also include a brand new tractor/backhoe loader with attachments. This piece of equipment will make the ongoing maintenance of the District's pipes and ditches far more productive than is currently pos-

Also included was some much needed rewiring upgrades to the treatment plant. As one Director pointed out, water and electricity do not mix well.

The meeting was adjourned by Director Donnie Forguson.

All in all, these actions by the Water District Board will go a long way to improving the District's ability to provide a reliable source of water for both its domestic and irrigation users.

"E Street Reconstruction – Williams"

The above title introduces one of the most needed public roads projects in Colusa County: E STREET RECONSTRUC-TION - WILLIAMS. I am preemptively announcing this project to inform the public and to make an unveiled suggestion to the Colusa County Transportation Commission, the agency responsible for road reconstruction.

For years the Williams City Council has made requests of the Transportation Commission to undertake road reconstruction in Williams and recently the Council has expressed it's consternation with the long absence of any Commission reconstruction projects. I written several have times over the past couple of years addressing the Commission's apparent inattention to some of the worse conditioned. most heavily used, and deteriorating roads in the Commission's iurisdiction; those in Williams.

You may have noted the recent road repairs throughout completed the City including in front of the Fire Station, the McDonalds pothole, Sixth Street. The City of Williams is committed to fixing our streets and these recent, small street repairs (not reconstruction) are within the City's fiscal capacity. On the other hand, the large reconstruction projects needed for Husted Road, E Street, and Seventh Street each cost millions of dollars, take years to program. months to reconstruct.

and are beyond the City's fiscal capacity. where the Transportation Commission comes in.

Large scale road reconstruction projects with multi-million dollar price tags are the responsibility of the Transportation Commission and are the reason the State created local transportation commissions. State law (Transportation Development Act of 1971, Government Code section 29535) established this Commission and gave it the responsibility for planning and funding major reconstruction for all roads in Colusa County - county and cit-

The E Street Reconstruction project is a natural candidate for the Transportation Commis-

All of this has brought the City Council to its current discussions about our streets and our membership in Transportation Commission. If Williams cannot get its roads reconstructed as a member of the Transportation Commission, what if the City were not a member and became its own Commission? In its aspiration to get these roads fixed. the Council has formed a Subcommittee to look into these questions.

This Subcommittee's task is not necessarily to investigate forming our own commission, but to explore the regulations, laws, and funding needed to get our roads fixed. Already produced from the Subcommittee's

work has been: raising attention to our poor roads, propounding that our local County Supervisor be appointed to the Transportation Commission, revealing unmet transportation needs, informing our local state legislative representatives - Senator Nielsen Assemblywoman Aguiar-Curry - of these critical local concerns, and educating the public.

It is unfortunate that

the City has to consider leaving the County Transportation Commission. There are about nineteen transportation commissions throughout California administering multi-million dollar road reconstruction projects, as has the Colusa County **Transportation** Witness Commission. the Transportation Commission's recent work on such large scale projects Marguerite Street, Maxwell sidewalks, and Arbuckle road paving.

The City would prefer to work with the Transportation Commission to accomplish our needed road reconstruction projects. The question remains; why is the Transportation Commission reluctant to undertake a project in Williams?

Hopefully, the Colusa Transportation County Commission will set aside their reluctance and move ahead, soon, and start the project titled ...and you heard it here first...E STREET RECONSTRUC-TION - WILLIAMS.

Safety Regulations Needed

I am writing to express my concern about a dangerous condition I experienced while driving on Highway 45 in Colusa County in October.

On October 18, 2017 I was driving from Princeton toward Colusa. The agricultural harvest Walnuts was underway and I noticed near the highway large clouds of dust being generated by Vann Brothers Farms. I reduced my speed to about 40 MPH when I was engulfed by a blanket of dust that reduced visibility to zero. I immediately began further breaking but discovered a large commercial truck stopped in the highway without blinkers on. I suspect the driver of this "big rig" could not see to drive either. The collision occurred with my speed at about 35 MPH. I

was the only injured party and was taken to Rideout Regional Medical Center. where after a six hour wait in the Emergency Department was discharged to my home.

In the weeks that have followed the incident I have discovered that the California Highway Patrol maintains no iurisdiction over agricultural caused impaired visibility on the highways. Brothers Farms, and other similar farming operations, are not required to post "flaggers" or other warning precautions when their actions are causing driving conditions to rise to high risk conditions.

All who drive in this region of California have experienced similar driving conditions, and may have been in similar accidents or experienced

"close calls" while driving. Their leader was Ammon Bundy, who participated in the 2014 Bundy standoff at his father's Nevada ranch." A jury found all Oregon standoff defendants not guilty of federal conspiracy and gun charges. The "armed militants"

were American citizens exercising their First and Second Amendment rights to protest government tyranny after the government sent Oregon ranchers Dwight Hammond, Jr., 73, and his son Steven Hammond, 46, back to prison after they were released. (The Hammonds had lit

CFBF President Stresses Need for Long-Term, Unified Action

Securing the future of California agriculture will require consistent, longterm and unified efforts, California Farm Bureau Federation President Paul Wenger said today. Wenger spoke during his annual address at the 99th CFBF Annual Meeting in Garden Grove.

Instant communication as represented by smartphone technology, Wenger said, can lure people into thinking that public policies affecting farms and ranches could

resolved quickly through social media, for example.

But the most effective way to sway public policy, he said, "is long-term, consistent, working with individuals, taking them on tours on farms, supporting them politically, getting them out and educating them about agriculture. It's not fast, it's not easy, but those who work the hardest the longest and invest the most are probably going to be

successful.'

To influence the debate in a largely urbanized state such as California, Wenger said, working means with government officials, political candidates and elected leaders who may have little if any background in agriculture.

"We have to get out of our comfort zone and start dealing with some people we normally don't deal with," he said, adding that he is proud of Farm Bureau's work in that regard.

After eight years as president, Wenger has served his maximum term in office, and urged Farm Bureau and other agricultural organizations to work together for the greater good of farmers and ranchers.

"I appreciate the opportunity to work with all of you here. I do love this organization and everybody that's out here," Wenger said. "We have got to continue to work together."

adopting and complying with building codes, fire and safety codes, water quality standards, and food safety and public health standards. The tribe has not obtained a National Pollutant Discharge Elimination System permit or implemented storm water mitigation measures.

Building plans were to be presented to the State Reclamation Board for review. No safeguards have been developed to prevent air pollution. A Clean Water Act permit has not been issued. Finally, there is no plan to curb noise pollution during construction.

Though not mentioned in the Colusa Tribe's letter, \$565,000 is past due to the Yuba County Sheriff's Department to provide services to the Tribe. That is in 2002 dollars. It would have been \$786.783 in today's dollars, but for Griego and Schrader's miscue.

However, San Diego Supervisors found that if the county prevails in court it still cannot force a Tribe to pay money owed to the county. It's like trying to force Venezuela to pay back a loan.

opponents Casino warned Supervisors about this predicament but were ignored. Opponents repeatedly voted against this project and off-reservation casinos in general. Supervisors Bill Simmons, Griego and Al Amaro were euphoric with the scent of a new casino. They hurried a 3-2 vote with Hal Stocker and Don Schrader opposing. This was just prior to incoming Supervisor Dan Logue replacing Amaro. They knew Logue would oppose the casino and stop the project.

The Colusa Tribe's letter also reminds Supervisors that the legality of the Department of Interior's decision to permit land on Forty Mile Road to be a tribal casino is the subject of litigation in the Ninth Circuit Court of Appeals. And, Governor Brown's agreement with the Interior's decision is under review by the California Supreme Court.

If the Appeals Court rules against the Department of Interior or the Supreme Court finds against the Governor then the entire project could be stopped.

The Colusa Tribe's understanding of Yuba County's MOU is no surprise for local opponents of the casino. What is disappointing is that opponents' fears have come to fruition - that the County is impotent to enforce the MOU against a trust-breaking Enterprise Rancheria.

County bureaucrats have not held Enterprise accountable. The taxpayers' take is that government got them into this and government should get them out. Of course, the citizens will pick-up the tab for the mess.
