Karen Rosser Honored with Tad Lucas Award

Karin Allred Rosser, Miss Rodeo Utah from the Ogden, Utah, will be honored this week during the National Heritage Museum's annual Rodeo Hall of Fame Weekend in Oklahoma City for her western heritage work. The Tad Lucas Heritage Award is named for Tad Lucas, who was known as 'Rodeo's First Lady'.

Yuba-Sutter Chamber of Commerce commented, "We can be extremely proud to have Cotton and Karin Rosser as part of our community family and congratulate Karin on this well deserved honor. She is certainly 'Rodeo's First Lady' in our hearts.

Cotton Rosser and Karin, are the owners of Cotton's Cowboy Corral in Marysville, California, as well as, "one of the most successful stock contracting firms in professional rodeo," the Flying U Rodeo Company, which is the oldest rodeo company in the world and the major supplier of rodeo stock in the United States.

In 1995, Cotton Rosser was inducted into the Pro Rodeo Hall of Fame in Colorado Springs, Colorado. In 2007, the Flying U Rodeo Company published a book called Million Dollar Memories: Fifty Years with Cotton Rosser and the Flying U in commemoration of Rosser's career. And in 2009, he was inducted into the National Cowboy and Western Heritage Museum Rodeo Hall of Fame in Oklahoma City, Oklahoma.

As a roper, he competed alongside the likes of Gene Autry and rode with Casey Tibbs and Jim Shoulders-Cotton received the Jim Shoulders Lifetime Achievement Award at the Heroes & Legends ceremony in Las Vegas.

Homicide and Arson Arrest

Marysville, Ca. - Early morning November 17th, Yuba County Sheriff Detectives arrested 78 year old Ronald Allen Dainauskus of Marysville for Homicide and Arson following an investigation overnight into the death of a Marysville woman. The deceased victim was located in a burned RV at a mobile home park located in the 3700 block of Highway 20 northeast of Marysville just after 8pm Thursday night 11/16/17. The victim's identity is being withheld pending the notification of next-of-kin.

The Yuba County Dispatch Center received a 911 hang-up call from the mobile home park in the 3700 block of Hwy 20 outside of Marysville at approximately 8pm and while dispatching deputies to respond, CHP dispatch also received a 911 call from the same phone number advising of a deceased female located in a motorhome at that location. Upon deputies' arrival to the mobile home park, the RV was found on fire. Once the fire was extinguished, the body of a deceased female was located inside.

It was determined during preliminary examination of the burned motorhome and the body located within it, that the female was likely deceased or gravely injured prior to the fire. The investigation further revealed that the initial 911 calls were believed to have been made by Ronald Dainauskus who was no longer at the scene.

Shortly after the discovery of the fire and body, Deputies

searching the area located suspect Dainauskus walking near Browns Valley. He was detained and later interviewed by detectives, then subsequently arrested for 187 PC/Homicide and 451PC/ Arson and booked into the Yuba County Jail. During the investigation detectives learned that Dainauskus and the victim were neighbors in the small mobile home park where the suspect was a longtime resident. It is believed that the two were associated with one another and at this time we are not aware of any history of problems or hostility between the two. Yuba County Sheriff's Office has no prior arrest history with Dainauskus. Official cause of death for the victim is pending autopsy at this time.

Yuba County Bans Commercial Cannabis

Marysville, Ca. – Yuba County has banned all Commercial Cannabis grows in the unincorporated areas of the county. The ban will become effective in 30 days.

Yuba County Board of Supervisors adopted the ordinance relating to commercial cannabis activities. Supervisors Vasquez, Fletcher and Bradford voted to adopt the ordinance. Supervisor Lofton was absent and Supervisor Leahy abstained. Supervisor Leahy said his concern was

that it is not clear whether the ban will stop the transportation of cannabis from outside of the county. Since the City of Marysville has OK'd Medical Marijuana Dispensary's this could be an issue. Supervisor Bradford asked County Counsel to clarify the transportation issue. She replied that she would review the law and get back to him.

Yuba County residents, Buck Weckman and Karen Liggett thanked the board for adopting the ordinance but; Lee Boutt was very concerned that the board was taking away his right to Medical Marijuana. At the end of the discussion Community Development and Services Director Kevin Mallen said that the ordinance did not affect the Medical Marijuana rights under California Proposition 64.

It is likely that the board may make adjustments to the ordinance after the State of California comes out with regulations on January 1, 2018.

Suspects Arrested for Elder Abuse

of Former Marysville City Council Member and His Wife

Marysville, Ca. – In early November Marysville PD began an investigation into alleged elder abuse of a former Marysville City Council member and his wife. Thomas Hickman and his mother, Heather Deuel were being paid by the victims to provide in home house care. Through preliminary investigation it was revealed that Thomas Hickman

and Heather Deuel were embezzling several thousands of dollars from the victims, and not providing proper care.

On Wednesday, November 15th at approximately 4:46 p.m., Marysville Police Officers went to the victim's residence on the 1100 block of Swezy Street in Marysville to conduct a welfare check. Thomas Hickman and

Heather Deuel were both at the residence and were interviewed regarding this case. Based on the investigation, Thomas Hickman and Heather Deuel were arrested for elder abuse, embezzlement, criminal threats, and for being under the influence of a controlled substance.

Marysville Notes

Marysville City Administrator Walter Munchheimer is leaving soon. It appeared all was well with the city as he received his raise after voters agreed to an 8.5% sales tax. Then, boom, he resigned. Maybe he'll return to Florida where there are no state income taxes. California's top rate is 13.3% and the Florida's sales tax is 6%, not Marysville's 8.5%.

There hasn't been talk of Marysville's infamous Bounce Back plan for months. Remember how indignant Bounce Back committee members became when the entire plan was challenged? Did the city spend \$100,000, \$200,000, or more? Did the consultant ever get the work done? No matter. There's more money where that came from.

Maybe the committee would like to return for a reunion.

Most people thought the city council, after going against voters to permit two marijuana dispensaries for medical uses, would expand sales for recreational use as well. As of January 1, recreational cannabis gets the green light in California.

However, council members McKenzie, Pedigo and Whitmore said no to recreational sales. Remember, cannabis users for medical purposes already had home delivery in Marysville without dispensaries. However, the city wanted the tax revenues from cannabis outlets.

After cannabis people greased Mayor Samayoa's palm with \$10,000 along with some ordinance and zoning massages, these dispensaries may finally be Marysville legal. The odd thing is we knew who would win the dispensary lottery ahead of time. Is that how it's supposed to work?

A Colorado Springs Gazette editorial ("Five Years Later, Colorado

Sees Toll of Pot Legalization") takes the euphoria out of the benefits of legalizing cannabis. The writer refers to the story of legalization as an "embarrassing cautionary tale."

"Visitors to Colorado remark about a new agricultural smell, the

wafting odor of pot as they drive near warehouse grow operations along Denver freeways. Residential neighborhoods throughout Colorado Springs reek of marijuana, as producers fill rental homes with plants.

Five years of retail pot coincide with five years of a homelessness growth rate that ranks among the highest rates in the country. Directors of homeless shelters, and people who live on the streets, tell us homeless substance abusers migrate here for easy access to pot.

Five years of Big Marijuana ushered in a doubling in the number of drivers involved in fatal crashes who tested positive for marijuana, based on research by the pro-legalization Denver Post.



FISHIN' TALK

This is the time of year to expect the sturgeon to show in local rivers when the rains come and the water rises and turns the familiar brown color. The sturgeon are currently being caught in the north delta area along with striped bass.

The water level of the Feather River has kept many anglers off, but the steelhead fishing should be picking up at this time. The Yuba City boat Ramp is currently closed due to the low water conditions. Best bet is to fish above the Outlet. Bait and lure preferences are Glo Bugs, night crawlers and roe.

The trout bite has improved at Collins Lake. Expect some big rainbows to be caught in the coming months in this reservoir.

The warm weather up at Lake Almanor has really slowed down the trout bite. Expect conditions to improve when the weather turns colder and the mirror like surface of the reservoir gets more ripples and slight movement.

Those anglers who carry a side arm while in the woods fishing are advised that the Sutter County Sheriff's office has announced changes in concealed weapons permits. The department now allows more than three weapons on the permit. However we recommend checking with them to make sure you qualify for any other firearms as we understand there are some restrictions in regard to caliber.

Up Camp Far West Reservoir way the lake has filled considerably which


has slowed the bass bite. The docks will be left in this body of water for the rest of the year.

Englebright Reservoir has been relatively quiet with a few bass being caught. As usual night crawlers work best in this lake.

If you plan on going to Scotts Flat Reservoir we recommend fishing either


along the Cascade shore or near the inlet for bass. Smallmouth bass are hitting inflated night crawlers. The fish range up to two pounds.





DJIA Loves Trump

With the Dow Jones Industrial Average (DJIA) racing to new highs almost daily, one has to ask, what is driving this market?

Certainly there are enough Donald Trump haters to cast a dim light on anything financial, where even many are doubting the civilized world itself will survive if Trump continues as President. But one cannot deny that the DJIA has loved this President, as evident by the rally that has been in place since he was elected.

With the DJIA making news headlines with every milestone it passes, the news might entice some investors to review their statements and then call their advisors to see why they haven't doubled their money in light of this almost relentless rally.

Although the DJIA is the most talked about index in the media, it encompasses only 30 stocks of the thousands that are out there in the various marketplaces.

The question some may ask: is the Dow a realistic representation of the market in general and the economy.

On the latter, I have always said the market will reflect reality eventually but its day to day movements are only the sum of the perceptions of all the players in it at any given time. For example, late in the housing boom cycle after Bear Sterns collapsed two funds tied

proverbial first domino to fall in the real estate blow up), the reality was the housing crisis was already in its early stages of implosion. That was the reality. The perception however was that real estate never falls in value and any set back would be temporary. Housing stocks therefore continued to climb as the housing market was beginning its historic collapse. The perception that all was ok drove these stocks ever higher even though in reality the real estate market had already turned.

That being said, the perception at least up until now, is the economy is strong and the stock market is justified in roaring upwards.

The market did however

eventually reflect that re-

ality when all the indexes

worldwide eventually cra-

tered miserably.

Certain things however might not add up and be confirming of the apparent strength of in the market meaning not all assets are firing on all cylinders.

If the economy is galloping forward in strength, one might expect the commodities and energy sectors to be in high demand and therefore screaming upwards as well.

Such in not the case, at least in the proportions the Dow has climbed. Indeed some energy and commodities have languished badly and or gone nowhere. (Yahoo.com). Since booming economies need energy and commodities, why have we not seen these asset classes go up

Additionally the Dow index is very limited in what is has in it. Remember it only has 30 stocks out of thousands and only seven stocks make up almost half of the index weighting (42%- Forbes.com) Some have even specu-


Matthew Yglesias of Slate.com goes so far as to call the DJIA a "nonsensical index" due to how it is purposely constructed to favor more positive results.

Indeed just the fact that the DJIA contains only 30 stocks might be enough to convince the investing public to better observe how the market in general is performing by looking at a variety of indicators and markets. Indeed many of those indicators are positive.

But because most investors hold a variety of assets in their portfolio which include assets that might move in opposite of a rising market, and because there are stocks in many areas that have actually gone nowhere or even fallen in the midst of this rally, its likely few portfolios have seen proportional increases their value that the DJIA has. Additionally because fixed income investments (bonds and preferred stocks to name a few) may have moved opposite of the rally, some portfolios may actually have lost

It was formerly known as Armistice Day, and was originally set as a U.S. legal holiday to honor the end of World War I, which officially took place on November 11, 1918. In legislation that was passed in 1938, November 11 was "dedicated to the cause of world peace and to be hereafter celebrated and known as 'Armistice Day." As such, this new legal holiday honored World War I veterans.

In 1954, after having been through both World War II and the Korean War, the 83rd U.S. Congress -- at the urging of the veterans service organizations -- amended the Act

of 1938 by striking out the word "Armistice" and inserting the word "Veterans." With the approval of this legislation on June 1, 1954, Nov. 11 became a day to honor American

veterans of all wars.

In 1968, the Uniforms Holiday Bill ensured threeday weekends for federal employees by celebrating four national holidays on Mondays: Washington's Birthday, Memorial Day, Veterans Day, and Columbus Day. Under this bill, Veterans Day was moved to the last Monday of October. Many states did not agree with this decision and continued to celebrate the holiday on its original date. The first Veterans Day under the new law was observed with much confusion on Oct. 25,

1971.

Finally on September 20, 1975, President Gerald R. Ford signed a law which returned the annual observance of Veterans Day to its original date of Nov. 11, beginning in 1978. Since then, the Veterans Day holiday has been ob-

served on Nov. 11.

Please take time to remember those gave their all, because a veteran is someone who, at one point in his or her life, wrote a blank check made payable 'To My Country' for an amount "up to and including their life." The Alliance was also a sponsor of Proposition 98, a statewide ballot measure that intended to stop eminent domain abuse and we were vocal supporters of the State Legislature's decision to abolish local redevelopment agencies (RDA), relatively unknown local public agencies that used eminent domain and over \$5 billion dollars in taxpayer money for dubious development projects, many of which failed.

After the State Legislature and Governor abolished RDAs, the number of eminent domain abuse cases declined significantly and today, this power is largely limited to public projects. The public's distain for this police power has never been greater. It has become so closely associated with public corruption, corporate welfare and wasteful spending that few politicians will utter the

As a consequence, the Alliance is shuttering its doors, figuratively speaking. As we had fewer and fewer battles to wage, it became evident that we achieved what we sought to do - expose a corruptive power so that private property could once again

Will eminent domain abuse return? Absolutely! The redevelopment lobby may have experienced a setback, but they are still thriving and their campaign dollars will certainly persuade future legislators to return California to its darkest days.

While the Alliance's time has come and gone, we are pleased that the Pacific Legal Foundation will continue the fight. To all our friends and supporters, we enjoyed being part of this noble cause. Thank you for sharing our journey.

Research solidifies health benefits of nuts

Eating nuts on a regular basis reduces risk of heart disease, according to a study published this week by the American College of Cardiology. The study found that people who ate five or more servings of nuts a week had a 14 percent lower risk of cardiovascular disease and a 20 percent lower risk of coronary heart disease, compared to people who didn't eat nuts. The research tracked consumption of walnuts, tree nuts and peanuts.

UC Riverside reports progress on ethanol

A process that closes the gap between different types of ethanol production has been developed at the University of California, Riverside. Engineers say they've found a way to make ethanol more economically from non-food plants such as grasses, rice straw and wood chips. The UCR team found a fermentation process that releases sugars from such biomass products more readily, and ferments the sugars into ethanol.

Study charts history of prepackaged salad

It took almost 200 years to create the variety of prepackaged salads on the market today, according to University of California researchers. They traced the history of prepackaged salad to a French professor's discovery in 1820 about how to maintain fruit freshness. Since prepackaged salads were introduced in

the late 1980s, they have grown to dominate the market. Americans now buy twice as many prepackaged salads as whole heads of lettuce.

Tomato canneries, milk and ice cream plants, wineries and other facilities are all considered foodprocessing plants - and California has more of them than any other state. The U.S. Department of Agriculture says California has more than 5,500 foodprocessing plants. The report cites the state's favorable climate for growing a variety of crops, its ports and its large metropolitan areas for attracting foodprocessing facilities.
