The Airport and the Homeless

Sutter County continues to alter its 'homeless' agenda as citizens react to the extraordinary expenditure of tax dollars and the administration's poor judgement. This Tuesday, November 7, 3P.M., Supervisors will entertain yet another strategy to 'Win the War on Homelessness.'

The current 'crisis' developed as local government began refusing to enforce laws on vagrancy, panhandling, being drunk in public, squatting on private and public land, possessing stolen property etc. As a result, illegal camps grew along both Yuba and Feather Rivers with lawbreakers doing hundreds of thousands of dollars in damage and establishing their own set of norms and values.

In Yuba County, a tipping point occurred in March 2016 when Greg Kelley, 62, an often incarcerated man who struggled for years with substance abuse, was clubbed to death and buried near the Simpson Lane camp. It was an act of street justice after he was accused by river bottom 'neighbors' of raping a female camper. The rape victim is a longtime heroin addict, also often incarcerated who refused many rehab opportunities for the outdoors.

Gilbert Wilden, 56, pled guilty to voluntary manslaughter. Wilden's longtime partner Beverly Brown (not

Your Troubles are Spelled UNION

As a Californian, where ever you notice troubles like increasing regulations, lousy schools, the highest taxes in the nation, wasteful government, Third World road and dam maintenance, services insolvency, or a corrupt state pension program, you have government employee unions to thank.

They own the politicians, and their hefty union dues literally control who gets elected and what measures and propositions pass. They are bullies and they are corrupt. Recently, they muscled any non-union workers off the Oroville Spillway project.

Your 12 cents per gallon increase on fuel as of November 1 and continuing for the next ten years, the additional DMV fees and the 72 cents per gallon spike starting on January 1, 2020 will pay overcompensated government employees who deliver their steep union dues to elect Democrat politicians.

Last year, Senator John Moorlach (R-Costa Mesa), the only CPA in California's state legislature, released a report on CalTrans which he summarized in the article "7-Step Fix for 'Mismanaged' Caltrans." A few highlights reveal why the state's billions are wasted.

In May 2014, the Legislative Analyst Office determined that CalTrans was overstaffed by 3,500 architects and engineers, costing over \$500 million per year. In America, an average state transportation agency outsources over 50% of its work. CalTrans outsources only 10%.

Arizona and Florida outsource more than 80%. The unions benefit from California's 'white collar welfare' keeping the payroll all union and with inflated numbers of employees whether they are needed or not. Little outsourcing means more union laborers and higher costs.

Therefore, the unions oppose any outsourcing. Outsourcing exposes their shameful wastefulness and they lose the dues and therefore the power to control. Moorlach found that 54% of CalTrans staff is at or near retirement age, so a hiring freeze would reduce staff merely through attrition, without requiring layoffs. However, the unions and therefore the politicians say "No way!"

Check Before You Burn

The Feather River Air Quality Management District is the local agency tasked with managing air quality programs for Yuba and Sutter counties to reduce public health impacts from pollutants. One pollutant of concern is fine particulate matter, especially in the autumn during the intensive fall burn season and in winter while residents are warming their homes with wood burning stoves and fireplaces. Exposure to fine particulate matter (PM2.5) can cause irritation of the eyes, nose and throat, coughing, chest tightness and shortness of breath, reduced lung function, asthma attacks, heart attacks, and premature death. People with heart or lung diseases, older adults, and children are most likely to be affected.

Wood heating voluntary Spotlight program begins November 1st.

During the late fall and winter time (November 1st to February 28th) the District issues a recommended action for operation of

wood burning devices, known as the Stoplight: Check Before You Burn Program. Wood burning devices such as fireplaces and wood stoves can generate PM2.5 both inside and outside the home. If the air is forecasted to be unhealthy, the recommended action may be that residents with alternative forms of heat forego burning in their wood stove or fireplace. The recommended action will be posted on the District's website by 3:00 pm for the following day. Recommended actions will also be sent along with air quality forecasts. Check the webpage https://www.fraqmd.org/ stoplight-check-beforeyou-burn-program more information.

Agricultural Burn Program The intensive fall burn

season is the short window to time between harvesting the rice fields and the rainy season. Rice fields with invasive species or disease can get a permit and be placed on a list to burn as part of their Best Management

Practices. The District balances the economic and public health impacts of the program as directed in the Health and Safety Code by the State of California, and authorizes Agricultural burning when conditions are optimal to minimize public impact from the smoke.

According to Whitney Brimm Deforest, the UC Davis Rice Advisor "Burning helps to reduce the severity of invasive species and diseases for the following rice season. Economic impacts of these pests are high, severely reducing rice yields. There are limited ways that farmers can treat these pests, and burning straw in the fall is one of the few nonchemical options."

Residents can check current air quality levels and sign up to receive daily air quality forecasts at www.airnow.gov. The AIRNow service is directly linked to the monitor in Yuba City and current conditions. For more information please contact us at 530-634-7659 or visit http://www.fraqmd.org.

We are on the way up to Lake Tahoe. If weather permits we will be fishing in the vicinity of the South Shore, probably chartering a boat from one of the marinas. It will take a mighty big mackinaw lake trout to top the big black drum I caught the first of October out of the Gulf of Mexico off the Galveston coast. He was oversized according to the laws and was released. To tell you the truth, after a picture, I would probably let him go anyway.

The Department of Fish and Game are scaling down their trout plants, but the Northern part of the state received trout last week in Collins Lake, Fuller Lake, Icehouse Reservoir and Union Valley Reservoir.

Our weather source tells us to expect light showers followed by a week of dry weather. He also advises the high elevation storm which was talked about on the news media will not come until mid-November.

We have reports of some large striped bass being taken all over the state with some fish in excess of 20 pounds. Planting those small rainbow trout never fails to bring on the big stripers. As far as that goes they also love to

feast on the small salmon which are planted in the Feather River every year.

We hear from Clear Lake that the bass are finally starting to get active. The bite has improved so much that local guides are putting lots of fish onto client's rods, but the fish tend to be on the small size. Hopefully the big boys will also start cooperating.

The bass bite at Lake

Oroville is still producing fish as the water level continues to drop. The bass are active at this time feeding on small minnows

and other water creatures Bucks Lake, above Oroville, has closed the marina for the year. We hear boats are few and far between on this reservoir.

Marysville Police Solve 6 Cases \$54,000 in Stolen Property

On November 1, 2017 at about 1:30pm Marysville Police Department served a search warrant on a residence in the 4300 block of College Way in Olivehurst, California.

During the search of the residence and property, Marysville Police discovered a substantial amount of stolen property from various cases from the cities of Marysville, Yuba City, Rancho Cordova and unincorporated Yuba County.

Police Marysville recovered more than \$12,500 in miscellaneous hand tools, power tools, a welding cart, and tool boxes that had been stolen from a burglary at Brandon Brown Handyman Services in Yuba City. Officers also recovered a stolen GMC truck and Yamaha Raptor fourwheeler that were stolen out of Yuba City.

Marysville Police recovered a Bobcat attachment taken from a job site in the Edgewater area of Yuba County, valued at \$5,000, and a pair of Bobcat attachments taken from a trailer in East Marysville, valued at \$2,500.

As the investigation continued, Marysville Police discovered \$1,000 worth of fencing materials and approximately \$5,900 in tools on the property that had been stolen from the suspect's employer in Rancho Cordova. The tools included a welder, cordless drills, a roto hammer, jack hammer, and more.

Marysville Police also recovered several other

Bobcat attachments, a stolen motorcycle license plate, and a roadway sign demarcating the County of Yuba County.

Owners for the previously stolen property arrived on scene and delightedly identified their recovered property. All told, the Marysville Police recovered over \$54,000 in stolen property, as a result of this investigation.

Marysville Police later went to the Yuba County Jail and arrested 40 year old Richard Townsend, of the 4300 block of College Way in Olivehurst on two counts of auto theft and four counts of possession of stolen property. Townsend was already in custody on un-related matters.







The Airport and the Homeless

the rape victim) testified that Kelley held a machete to her neck and threatened to kill her along with many others dwelling in the river bottom hovels. It's just another sunny day in the neighborhood. Numerous

enclaves were then cleared-out by Yuba County authorities. The '14 Forward' government settlement was created with 20 Tuff Sheds as an option for the illegal squatters. However, those evicted are now returning to their preferred habitation or new roosts like behind the Marysville Cemetery.

Sutter County's initial multi-million dollar proposal to site the variety of homeless personalities (60, 90, 200, Who knows how many?) along Garden Highway is intriguing. Why there, with the obvious destructive impact on the airport, sheriff's training center / range / posse arena, the Twin Cities Rod and Gun range and the Peach Bowl Little League operation?

Though the proposal would spend millions it was called a '2-year Temporary Plan.' What? The problem would be resolved in 24 months? No one believes that.

The fact is that county officials do not care about the homeless nor the entities affected along Garden Highway. It is a task to address, maybe just a painin-the-ass, maybe just politics. In fact, County Administrator Scott Mitnick can't even remember where he is. He routinely refers to Sutter County as Ventura County where his home and family are. That's where his heart is. That's normal and expected, but it would be nice to have an administrator that considered Sutter County home, where the problems were not just academic, but personal.

Beneath the homeless shuck and jive Mitnick and County Counsel Jean Jordan are working to close the 170-acre airport in order to develop it. County supervisors and bureaucrats have for years violated Federal Aviation Administration (FAA) rules including financially mismanaging the airport. The operation has been deprived of millions of rental dollars due it for structures encroaching on airport acreage.

Mitnick and Jordan think the airport is a poor use of county land. Maybe or maybe not, but is it their decision to make? Who sets policy for the county? Where are the Supervisors on this? Shouldn't the Supervisors conduct public meetings to debate the airport's future rather than use an underhanded approach like we need to

house 60 homeless? Jordan has been exploring ways to accuse the nonprofit pilots group (Sutter Buttes Regional Aviation Association), who manages the facility, of transporting drugs in and out of the county. The initial plan to launch a camp for transients at the airport would violate FAA rules eliminating federal funding and possibly trigger an action against the airport. Both contrived controversies could have ended the airport operation delighting Mitnick, Jordan and Assessor Todd Retzloff.

The so-called homeless are looking more like political pawns, particularly when there is no nation on earth that offers more hand-outs, more food more rehabs, more shelters and more jobs than this country. However, you cannot force people to conform to living standards and rules they left behind.

The problem here is not those we now euphemistically refer to as homeless They have been with us since the beginning. The problem is that government is incompetent when it comes to delivering charity and shouldn't be in the business. And, government manipulates and deceives the public.

Yuba and Sutter County taxpayers would be thrilled if each jurisdiction would simply provide law enforcement, fire service and maintain the infrastructure. The private sector can do the rest.

PG&E Offers Assistance in Hauling Away Wood

In Wildfire Counties

San Francisco, Ca. In an effort to support communities recovering from the October 2017 Northern California wildfires, Pacific Gas and Electric Company (PG&E) is offering its customers assistance in cutting down and hauling away larger wood from their property at no cost. Customers can now request wood removal for qualifying hazard trees PG&E cuts down near its power lines to help ensure public safety and protect its electric and gas infra-

This is an opt-in program and customers' trees must qualify for the service. PG&E expects to cut down as many as 25,000 hazard trees in the fire-impacted areas throughout its service

structure.

"Safety is our top priority for everyone at PG&E every day, and that's why we're working to remove

hazard trees around our power lines. We know that the wood will pile up,

increasing the fuel around homeowners' properties. This no-cost assistance is one of the ways we are helping our communities recover as quickly as possible," said Kevin Dasso, PG&E vice president of asset management.

Wildfire Wood Management Program

The Wildfire Wood Management Program is designed to assist customers in recovery by removing large wood. In order to qualify:

- Wood must be easily accessible by equipment or machinery
- · Be larger than four inches in diameter and six feet long
- And, wood must be within 50 feet of a permanent structure or have the ability to impede traffic, roll into roads, road drainage structures or water-

courses

Customers who would like to opt-in can call 1-800-743-5000 to schedule an inspection

This opt-in program is only available for trees PG&E contract tree crews cut down. PG&E expects to have the wood removal program work completed within three months.

PG&E contractors will haul away and dispose of the wood. The wood being removed from fire-impacted areas is generally not commercially viable. PG&E's contractors will determine any potential end-uses.

Wood and debris that is less than four inches in diameter does not qualify for this program. As with its normal practice, PG&E will clean up debris it cuts either by chipping or lopping and spreading according to forestry bestmanagement practices.

Food and Farm News

Ranchers assess wildfire toll on

animals, land Ranchers who had animals and pastureland in the Northern California wildfire zone continue to tally the impact of the fires. It's not yet known how many animals died in the October fires. For animals that survived, feed will be a concern because of scorched pastures. Ranchers will have to provide hay for their livestock. In addition, ranchers will need to replace fences burned by the fires.

Cotton farmers expect high-quality crop

Improved water supplies have led to larger cotton plantings in the Central Valley this year. Acreage grew by more

than one-third, compared to a year ago. Farmers say they hope for dry weather during cotton harvest, to ensure crop quality. California farms have a reputation for producing high-quality cotton. A government crop report shows the California cotton harvest about 30 percent complete, with nearly all of the crop rated in "excellent" condition.

Social media has become a bigger factor for agritourism operations. The University of California agritourism coordinator says travelers do everything on mobile devices, and expect to find farm sites on social media. For example, the Apple Hill **Growers Association east** of Sacramento created an app listing its members' operations. Irritated with Cal-Trans

So I went to a Live Oak 99 Streetscape ad-hoc meeting and became irritated. First off we are trying to secure businesses along the 99 corridor in the City of Live Oak. Caltrans has been a big bag of NO HELP. They do not appear to care whether the current business owners survive the highway modifications. All through the process, it has been like pulling teeth to get them to make simple changes. First they stated that they will not be able to allow angle parking. Then they came back with reverse angle parking. The problem is that nowhere in California, or elsewhere to my knowledge, is there a reverse angle parking on a highway system. We were told that it is safer yet has never been tried on a busy highway. Now, there is a location on Solana Beach (Southern California) where they started to put in reverse angle parking on a highway but was changed to drive in angle parking last

for these particular Caltrans people and the city, we asked if we could increase the parallel parking size from 11 feet. Cal-trans and the city responded with a one paragraph negative answer which stated that it was impossible to increase the 11 foot dimension. Here is the dishonest point. The actual size of the parallel parking space is 12 feet not 11, PER THEIR OWN PLAN. This example is the 4th time where Caltrans and the city have used deception in their own figures just to force

You ask yourself, why are we in favor of drive in angle parking vs reverse angle parking? Well this is a busy highway and most residents of the city want the new expansion to slow down the 99 corridor to 25 miles per hour. Cal-trans states that they want this to happen too but will not allow signage for 25 mph until a study is done AFTER the project. They will not order a study before the start of the project. All plans have stated 35 mph and this is unacceptable to the business interests. Vehicles stopping and backing into a parking place at 35 miles per hour will create a hazard for which most people will avoid by not using Live Oaks businesses. Businesses who have been in Live Oak for many years will be forced to shutter.

We, the ad-hoc com-

mittee, have asked for Cal-trans to create a real life (field) demonstration of reverse angle parking on high 99 to ascertain it's safety. Cal-trans has refused this and has used every trick, during meeting, to not address this hazard, nor are they willing to do the exact same thing they did in Solana Beach Highway last year. Please spread the word that Cal-trans is hurting families in Live Oak and the City of Live Oak (City Hall) is gladly helping them do it. Hopefully we can get the Gridley Harold, The appeal Democrat, KCRA and any other News agency to look into

this travesty.

My Experience with the Fire

"You will face many defeats in your life, but never let your self be defeated" Maya Angelou

I woke at 4 AM in Rough and Ready for some inexplicable reason. Smelling smoke I turned on the lights. There were no lights. Opening my little trailer door I saw my neighbors yard ablaze with the wind pushing the flames, sparks, and embers into our yard. I could hear the loud popping of trees exploding perhaps propane tanks.

My Red Cross flashlight sits in a wall plug and comes on when the power goes out. That little item possibly saved my life, as I was able to locate my purse, car keys, and little dog. Thankfully I saw my 94 year old landlady in her car heading out the drive. Following her out we drove thru dense smoke, unable to see, we knew the road well enough to get to the main road. There large trees were fully ablaze, brush was burning, the fire was jumping the road.

As we joined our neighbors driving out the fire trucks were coming in, we had no advance notice, we did have defensible space but nothing was stopping that wind swept fire. Many of us gathered across the street from the Rough & Ready fire dept. shocked, cold, and barely clothed. The fire dept. let us use their facilities, charge our cell phones & made us coffee. Thank you all for making us feel at home in your house. The folks at the little R&R Chapel had no power but fired up a camp-stove for food, coffee, and tea. Thanks so much to the fellow there who gave me his slippers!

Thankfully there was no loss of human life. Our homes did not make it sadly I lost my little dog, booger and bunny Foo-Foo. Rest in peace little friends.

I have so many people to thank. The folks at Salvation Army, who listened to my story, let me cry, calmed me down and gave me food and toiletries. My many generous friends and family who took me in, gathered clothes, offered support. The folks at Diego's who fed me wonderful pumpkin soup. The kind lady at the Family Resource Center who gave me \$20. A local merchant gave me a blanket. My friend who set up a Go Fund me page under the heading "Grateful to be Alive"

And I am, extremely

grateful. So many are facing such loss right now. With all the divisiveness in our world today these tragedies bring us together in our common humanity.

For those of us who live in fire prone areas I strongly suggest you invest in a safe deposit box for your valuable papers. It's not that expensive. Also please acquaint yourself with Nevada County's Fire safe Council. This thoughtful committed group fer valuable advice and have trained personal to individually visit your home and assess your fire readiness they can be reached at areyou-

firesafe.com
And please use common sense. Refrain from lighting your burn piles, clean your roof before you begin using your wood stove, do not build campfire or smoke in the woods. We are not out of fire season yet. Let us be spared any further disas-

ters.
Thanks again to our brave fire fighters, Red Cross, Salvation Army, FEMA, and the many kind generous folks in our community.



Work at Oroville Dam Far from Complete

With most of the work on the Oroville Dam Spillway complete, North State's Legislators - Senator Jim Nielsen (R-Tehama) and Assemblymember James Gallagher (R-Yuba City) — thank the dedicated men and women who have worked around the clock to repair the Spillway and ask the state to clean up the sediment buildup that resulted from this crisis. They issued the following state-

"The men and women from Kiewit Construction and the sub-contractors on site have accomplished a monumental task. Speaking on behalf of all of our constituents living downstream of the Oroville Dam complex, we say thank you to the Kiewit team for their tireless efforts.

"We want to be clear that although today's accomplishment is worthy of recognition, the work is far from complete. It's not enough to fix the spillways and move on. The impacts of this crisis have not been mitigated. Perhaps the most glaring impact not yet addressed is the massive sediment and debris buildup in the Feather River. The newly formed sediment buildups impact not only recreation, but also the channel capacity of the river and habitat for migrating salmon and other species.

"It is encouraging to hear that DWR is considering long-term infrastructure and operational changes to improve public safety and flood control. However, our community deserves a seat at the table as these plans are being discussed and plans are developed. We strongly advise against keeping the public in the dark as these discussions are taking place.

"Lastly, we agree wholeheartedly that a comprehensive needs assessment is necessary. However, this robust inspection work should be conducted completely independent of DWR and the other regulatory agencies that were responsible for the inspection work leading up to the collapse of the Oroville Dam spillways."

Take Action Against Distraction

SACRAMENTO, Calif. - Driver distractions have always presented challenges to roadway safety. Over the years, it has increasingly become a more serious problem as in-vehicle technology has expanded. To discourage this dangerous habit, the California Highway Patrol (CHP) is launching the statewide Adult Distracted Drivers campaign in partnership with the California Office of Traffic Safety (OTS).

The yearlong campaign, funded by a grant, will combine education and enforcement to combat distracted driving. The focus of the education component is to help people understand anything that diverts a driver's eyes or attention from the roadway, even for a second or two, can result in tragedy.

"For your safety and for the well-being of those around you, keep your eyes on the road and not on your phone," CHP Acting Commissioner Warren Stanley said. "Nothing on that phone is worth endangering a life."

The CHP reminds motorists that it is illegal to use a cell phone while driving unless it is hands-free. The more technology a car has, the more distractions it may present to the driver. Multitasking increases the risk a driver will injure or kill themselves, their passengers, pedestrians, bicyclists, or people in other vehicles.

With this grant, the CHP will complete a minimum of 100 distracted driving enforcement operations and at least 600 traffic safety presentations statewide by the end of September 2018.

"Our goal with this grant is to further educate the public about the hazards associated with distracted driving and ultimately stop the potentially deadly behavior," Acting Commissioner Stanley added.

Funding for this program was provided by a grant from OTS through the National Highway Traffic Safety Administration.



They passed the environmental laws causing California housing to cost 2.5 times more than comparable sizes and locations in other states. The median home value in America is \$202,700. The median home value in California is \$509,600.

When union-backed politicians talk about needing more 'affordable housing' they are talking about unions constructing government housing projects where the funding is forcefully removed from taxpayers and the units are provided at nearly no cost to the 'less fortunate.' That is socialism.

Commission's recommendation and designated as a historical landmark, the Dr. W.C. Jones Memorial Hospital, now the Swan Levine House. Originally built in 1867 by the Faheys, owners of

the Allison Ranch Mine, the property was later sold in the 1870's to a prominent financial tycoon and investor, William Campbell. The building was later sold in 1905-1906 to Dr. John Taylor Jones of Grass Valley for use as Nevada County's first private hospital. The hospiple. Dr. Jones installed the County's first x-ray equipment, and the hospital served more than twenty patients with a staff of five. Following Dr. Jones' death, his brother, Dr. Carl Jones, took over the hospital in 1917 and went on to promote the advancement of medical technologies and public nursing, including development of the Jones-Painter splint for broken pelvises.

Dr. Carl Jones and Idaho Maryland Mine owner Errol MacBoyle founded the nonprofit organization that

Formerly the Swan Levine House. eventually became Sierra Nevada Memorial Hospital. The Dr. W.C. Jones Memo-Hospital remained open as a private hospital until 1968, when it was purchased by the Geist family, who used the facility to raise funds to restore the Nevada Theater in Nevada City. Howard Levine, Grass Valley's current mayor, and his wife Peggy Swan Levine, purchased the house in 1975, and the Swan Levine House now serves as a teaching studio, a classroom for Sierra College students and a

bed and breakfast inn. The Jones Hospital will be added to the Commission's interactive map and e-guide.




