## Retired Attorney Stanley Coolidge,

**longtime Loma Rica Resident, among Cascade Fire Victims** 



Stanley A. Coolidge, Jr., (78) a former attorney for 40 years in the Yuba-Sutter area, was listed among the victims who died in the Cascade Fire in Loma Rica. Coolidge's home was located on the 11800 block of Loma Rica Road near Pizza Round Up. Also caught in the blaze with him, was his fiancée, Roseann Marie Hannah (53), of Grass Valley. Of the four deaths which occurred during the fire in Yuba County, all of them were within a ½ of a mile of this area.

Born in San Francisco, Coolidge had been a resident of Loma Rica for 50 years. He was a graduate of the University of California, Berkeley with both his Bachelor Degree and Law Degree. He was a former Yuba County Sheriff's Reserve Officer in the Foothills during the early 1970's and his partner, Don Brown, was killed in the line of duty in the foothills while answering a call on November 21, 1974.

Coolidge also served on the Beckwourth Frontier Days committee and played Steven J. Field in reenactment events which took place during the celebration. He was a member of the Yuba-Sutter Bar Association, the Yuba City Noon Rotary Club, served as Judge Pro Tem and was a former national officer in The Americans Motorcycle Club which is active throughout the United States and raises funds for Children's Cancer. Coolidge enjoyed staging puppet shows through the club for young children and sometimes did so for sick children as well.

Among his most noted litigation as an attorney was representing Yuba City High School Bus Crash Victims when a charter bus carrying members of the Yuba City High School Choir were killed during a tragic crash on May 21, 1976. He, along with his former law partner, Lyle Gisi, also represented victims of the 1987 Linda Flood which years later resulted in a positive result for hundreds of families.

Coolidge was the father of Stephen Coolidge, who preceded him in death; Karen Lockhart, of Yuba City; and Andrew Coolidge, of Chico; and was the grandfather of ten grandchildren. He was married to Constance Coolidge for over 40 years before the couple separated in 1997.



His fiancée, Roseann Marie Hannah, leaves behind two adult twin boys, Jeffrey and Jordan Hannah of Grass Valley. More than anything in the world Coolidge loved to ride his Harley Davidson Motorcycle. He was very active in The Americans Motorcycle Club, (TAMC), for 30 years and owned a Harley up until his death.

TAMC member Frenchy remembers Stan as,

knew Stan Coolidge for over 30 years. He was one of the finest, caring and compassionate men I have known. From his extensive knowledge as a lawyer, Reserve Deputy in Yuba County, Superior Court Judge, make believe Chinese language expert. He was a man liked by most he met. A serious and yet funny man who I will miss forever along with his fiancée Roseann, may they both rest forever in God's loving arms.

Coolidge's house sat halfway up Johnson's Peak (a small mountain) next to Paynes Peak mountain, across Loma Rica Road by Pizza Round Up. The entirety of Johnson's Peak suffered extreme fire damage barely leaving behind any trees or brush which was not completely burned.

While last details of the couple are unknown, it was evident through limited family conversations with the couple prior to their deaths, that the fire came upon the home almost instantly and engulfed the entire residence while they were still inside. The remains of Coolidge and Hannah were recovered onsite by the Chico State Anthropology Department Team and Yuba County Sheriff's Department. The Sheriff's Department listed the couple as confirmed fire fatalities on October 18, 2017, nine days after the event and the date of death is October 9, 2017.

# Sutter Co Broke and Binge Spending

Sutter County is essentially broke owing \$150 million dollars to the California Public Employees Retirement System (CalPERS). This debt is owed for Sutter County employee pensions.

However, long before the court is petitioned for

bankruptcy protection taxpayers will experience 'services insolvency.' That is a phrase now used to describe a county, city or agency unable to provide the public services it was created for. The reason is that most all tax monies will be consumed with paying down debt, government salaries and pensions.

Roads, parks, and infrastructure will deteriorate due

to funding shortages while government office hours are cut. Police and fire will be reduced creating higher risk for emergency responders and skimpy protection for citizens.

County Administrative Officer (CAO) Scott Mitnick recently revised employee schedules causing some offices to close during the week and others to run with fewer staff. His justification was to benefit employees and save money. No mention was made of the inconvenience to those the government serves.

Tuesday, October 24th, at 3pm, Supervisors will decide whether to commit millions more in tax dollars each year to 150-400 'homeless' people, out of over 97,000 Sutter County residents. CAO Mitnick says the number is less than 1% of the population. The number is actually four-tenths of 1%.

There are currently hundreds of agency and nongovernment organizations and programs to help needy people along with numerous funding streams. There are jobs available.

This population is resistant to reformation and assimilation. Of course, there are a few exceptions, but why is government involved at all other than enforcing the law? It is lousy at helping people.

Since 1956 the Twin Cities Rescue Mission (TCRM) with no taxpayer money has housed 40-50 people a night and serves 100-150 meals each day. The mission directs people to jobs and all the local services. TCRM's annual budget is \$80-100 thousand with three employees plus many volunteers.

Government funding streams encourage addiction, laziness, and resistance to assimilation with no ac-

## Time to Say "Hell No"

Yuba and Sutter Counties get two new sheriffs as of January 1, 2018. Sheriffs are the highest law enforcement officials in the county and therefore are the key individuals to uphold the Constitution. With the remaining influence of lawless and repressive Obama bureaucrats and now tyrannical legislators in Sacramento the new sheriffs may have a time of it.

On July 22, 2013, El Dorado County Sheriff John D'Agostini stripped agents of the U.S. Forest Service of their law-enforcement powers in his county. More than 50 citizen complaints about forest service employees harassing them and issuing citations while they visited National Forests led to the sheriff's decision. Some of the issues involved 'right to carry.'

McGeorge School of Law professor John Myers was asked if D'Agostini could tell federal law enforcement to stand down. Myers said, "It looks to me as though the sheriff can do this."

This isn't the first time D'Agostini protected the rights of his constituents. In January 2013 the sheriff informed Vice President Joe Biden that he would uphold the Constitution over any gun ownership restrictions the Obama Administration would contrive.

Now, D'Agostini has spoken about the passage of the Sanctuary State Law (SB54) limiting law enforcement working with Federal Immigration and Customs Enforcement (ICE) officials when an illegal alien is encountered. D'Agostini sees the new state restrictions as coddling criminals. He isn't having it.

SB 54 stops law enforcement from asking people

### Farmers work to evaluate effect of wildfires

Withfirefightersworking to contain the severe wildfires in Northern California, farmers and ranchers are beginning to assess the impact on their crops, livestock, land and buildings. Most say it will take some time to gauge the complete impact. Grape growers say that although some vineyards have burned, others have come through the fires with little or no damage. One farmer says vines singed by fire should recover, once they're pruned this winter.

### **Survey reveals** ongoing farm employee shortages

Chronic problems in finding and hiring qualified people continue on California farms and ranches, according to a survey

released Tuesday by the California Farm Bureau Federation. The informal survey showed more than half of responding farmers have experienced employee shortages this year. The figure was higher among farmers who employ people on a seasonal basis: Nearly 70 percent have seen shortages, despite higher wages and other actions.

### New law will encourage purchase of Californiagrown food

State agencies and institutions that buy food would be encouraged to buy California-grown products, under legislation signed by Governor Brown. The measure by Assembly Member Anna Caballero of Salinas will require state agencies buying agricultural products to purchase

from California, as long as the quality is equal and the price is within 5 percent of the lowest bid. School districts will have to buy California-grown if the price is

## FISHIN' TALK

We hear from our weather source who has predicted an early winter this year with more warm days to come before the leaves fall and we wake up with frost on the pumpkin. He advises to expect much cooler weather this winter and not as much participation as we experienced in the Sacramento Valley and foothills last year, with heavy snow in the sierras.

The waters of local reservoirs, along with the higher elevation lakes have dropped in temperature. This annual fall event will bring the trout up from the cooler depths into the shallower areas. As stated in the past, look for some lunkers caught as the fish gorge themselves in preparation for the upcoming winter months. If you go, we suggest fishing close to the banks where the most food lives, such as crawdads, minnows and water insects.

I recall a great fishing experience this time of year several years ago while fishing Lake Oroville. The big brown trout were cruising in shallow water looking for their morning meal and it was not necessary to use lead line or downriggers, but just to troll below the surface close to shore. Two nice browns were on the stringer long before the sun hit the water.

While we are talking about the chance for big fish this time of year we must mention the big mackinaw lake trout being taken at this time at South Lake Tahoe. The usual size is from three to seven pounds, but when the big boys start to get

active it is not uncommon to nail one between 10 and 15 pounds.

Collins Lake has reopened since their evacuation from the fires in that area. The resort is back in full swing and is looking for a good fall trout bite with their scheduled plant

of 1800 to 2000 trout which were planted last week. Weekly trout plants are planned throughout the winter months ahead.


















### **Horizontal Integration**

It is said businesses are either in a state of expansion or contraction. When the state of stagnation exists, the state of contraction is usually argued.

Small business might expand by selling more stuff and/or getting more customers. Although this is the first type of expansion one might think of for businesses both small and large, very large corporate conglomerates have other ways of expanding that might not be as feasible to a small mom and pop store in some retail mall somewhere.

The two types of expansion that comes to my mind from my economic class many years ago are commonly referred to as horizontal integration and vertical integration.

Horizontal integration may sound like a fancy word but think of it as acquisition of companies in the same business. For a shoe company that makes athletic shoes, it might buy another shoe company that makes shoes as well. The types of shoes made might be the same or different but shoes are the key concept here.

Horizontal integration means a company just buys other companies in the same business, thereby decreasing the total number of companies in that particular business that exist and in the process getting larger by the merger.

Examples of horizontal integration are many and varied. Horizontal integration usually means two companies become one with one of the companies being the buyer and one being the "acquired" company.

If the merging of the two companies into one larger company threatens competition and limits consumer choices in a monopolistic way, the government can stop the sale under the guise of preventing a monopoly by the merged company.

Companies look to horizontal expansion to garner more market share or move into a similar market they might not be currently in. The main reason for doing this is obviously to eventually make more profit.

John D. Rockefeller used horizontal integration when he bought up many of his competitors and subsequently dominated and controlled the oil industry with his company Standard Oil which today is known as Chev-

Vertical integration is also done by acquisition and to improve profits but it accomplishes this in quite a different way.

A company doesn't buy another company that makes the same product but instead it buys the companies that it buys from, uses their services or sells to. Andrew Carnegie was known for his vertical integration strategy when his steel company Carnegie Steel Corporation bought up the companies that serviced his company both above and below him. Think transportation companies that moved his steel and companies that made the equipment he used to make the steel. Other vertical integration moves might include buying the chain of stores that sells your product so you keep end and then buying the trucks that move your

product so you pay yourself for shipping therefore reducing expenses below

There are many examples of both vertical and horizontal integration happening frequently in the board rooms of large corporations.

Companies buying similar companies that make similar products are practicing horizontal integration by expanding market presence and product variety. Companies buying companies that service it like shipping companies or perhaps buy the companies that make the stuff they use to make THEIR stuff are examples of vertical integration.

Although horizontal integration is fairly easily identified and therefore news making when authorities step in to block a merger, vertical integration, where a company buys an unrelated company that just services it, is much more difficult to prevent due to the case that the monopoly is not obvious or even related in the true sense of the word.

Think of it this way: the number one shoe company buys the number two company.

Pretty easy to see how that might make a monopoly.

Now consider the same shoe company buying the company that makes it's rubber or sells the shoes it makes. That one is hard to argue as creating a monopoly. For this reason, vertical integrations are usually much easier to accomplish by companies looking to reduce the extra profit on that costs and increase profits without being accused or refused due to the defini-

## **Yuba Sutter Animal Evacuation Shelter**



One of the hallmarks of the Yuba Sutter area is the attention that is paid to the care of animals evacuated in the face of a disaster. The Cascade Fire evacuation is no exception. The Yuba Sutter Domestic Animal Disaster Assistance (YS-DADA) group once again operated a shelter for all the evacuated animals along with the Sutter County Sheriff's Posse.

The shelter was opened at the Yuba Sutter Fairgrounds before 7:00 a.m. on Monday morning for all pets and livestock. Since the fairgrounds has no facilities for horses, all horses were housed at the Sutter Sheriff's Posse Arena.

At first, the horses were tied up all around the arena. The Sheriff's Posse put out the word that they needed panels

to make corrals and the donations started to pour in. On Monday, the focus was on taking care of all the animals who evacuated with their owners. In the meantime, the Sutter and Yuba Sheriff's Posses began to go into the affected area as soon as they were allowed began to evacuate animals that had to be left behind when their owners evacuated.



Some animals that appeared to be safe were not evacuated, but the Sheriff's Posses made sure that they had water and food. Any animals that were evacuated by the Sheriff's Posses have been matched up with an owner except for 4 large, mostly white goats and 1 horse. If anyone is missing animals that meet these intentionally vague descriptions, you can go to the Loma Rica/Browns Valley Emergency Fa-

cebook page for more information. In addition, some of the livestock and horses belong to people whose houses were lost. They are being notified that their animals will be taken care of for the foreseeable future while they get their own living situation settled.





## **Property Tax Adjustments** for Wildfire Properties

Property Tax Adjustments Available for Taxable Real and/ or Taxable Personal Property Damaged by the October 2017 Wildfires

Property owners impacted by the October 2017 wildfires, by having more than \$10,000 in damage to taxable real and/or personal property, are eligible for a temporary reduction of their property tax assessment and may be eligible for a deferral of the first installment of their 2017-2018 property tax bill.

The Yuba County Assessor's Office is encouraging all property owners of fire damaged property to notify the assessor's

office. You will be asked to provide the property address, the type of damage (i.e. house destroyed, outbuilding damaged, orchard damaged, etc.), and your contact information so that tax relief can be granted as prescribed by law. The assessor's office will be conducting an independent field canvas and will be reviewing fire reports in an attempt to identify all damaged property qualifying for relief. Properties having locked gates and otherwise compromised access may be missed if the assessor's office is not contacted. Assessed values are

## **Fires Do Not Wipe Out Grandfathered Uses on a Property**

**Helpful example:** 

Property in Loma Rica has a home and barn. Fire completely destroys home and barn, damages well head and burns up controls to the pressure dose septic system. Yuba County is not requiring permits for people to repair the damage to their well head or controls to the septic system, just let them know the work was done. This goes for setting up a service pole to restore power to the property as well. When you go to rebuild the house and barn, the structures will need to meet the current building codes (sprinklers inside home, except modular homes, fire resistant rated exterior construction materials, etc.), the home can reconnect to the repaired well and septic (just need to verify they are operational, do not need to be upgraded to current standards). In addition, people do not need to rebuild their home or barn in the exact location of what it is replacing, if it makes sense to move it to another location on their property (especially if it helps with fire safety) then they are free to move it.

or personal property. When real property is restored, repaired or reconstructed, and is similar in size and utility as the original property, the base value of the original property will be the new base value of the repaired or reconstructed property.

Qualifying owners of properties damaged in the October 2017 wildfires can also apply to defer payment of the December 10, 2017 first installment of their 2017-2018 property tax bill unless that bill is paid by their mortgage company through an impound account. Property tax deferral can be requested as part of the calamity reassessment claim. Deferral requests must be submitted no later than December 10, 2017. If the property qualifies, taxes will be deferred until 30 days following the receipt of a corrected bill that reflects the temporary reduction in value caused by the fires. Property tax deferral is provided only upon application. · Yes, you need an old-fashioned, corded landline phone, and make sure the ringer is turned on. Why? If the power goes out, your cordless landline phones won't work. Also, if the power goes out, and you use a cell phone booster to get service, it might not work either.

• If you have an elderly, or handicapped family member, consider registering another family member's phone number to also get their alerts. If your phone num-

ber or email address has recently changed, be safe and register again. • TIP: If you only reg-

ister your cell phone make sure you keep it charged, turned on during the night and not on "silent" mode.

## Cascade Fire, A Team Effort

With my 33 years of work experience with Cal Fire, I believe I can make an educated assessment on the actions taken by our first responders and follow up recovery efforts of the Cascade. Because of the very

high winds that Sunday night, and within an hour of the fire's start, the flames were threatening homes along Los Verieles, Loma Rica and Stonehedge Roads. In this short 60 minutes, the Yuba County Sheriff's Office, the CHP and Local and State Fire Agencies had many units on the ground helping to evacuate residents. Due to the continued fire threat and the many power lines, poles and transformers in the roadways the Sheriff's Office and other law enforcement maintained the necessary road closures until Friday night. Hats off to Sheriff Durfor and other mutual aid law

enforcement.

departments and Cal Fire had five days of hard long hours in containing and suppressing this fire. We will never know how many structures and lives were saved by their efforts. Due to the numerous fires in Northern California, fire equipment and personnel was in short supply, so the limited fire crews available had to work all the harder. Try working in hot weather wearing fire protective clothing and carrying a 50 pound pack on your back and you will gain additional apprecia-

An area that might go unnoticed is the support and recovery efforts by Yuba County Government. Led by Fifth District Supervisor Randy Fletcher and County Administrator Robert Bendorf, Yuba County established support services well before the fire was contained. Sycamore Ranch established as a refuge site for evacuees and their RVs, County road

crews were assisting with road blocks and clearing downed trees in the roadways, and Supervisor Fletcher maintained constant communication with Cal Fire on fire status. In addition, an informational Center was established at the Lion's Club in Loma Rica providing residents with recovery information Just this Tuesday morning Supervisor Fletcher made the motion to waive building permit fees associated with Cascade Fire losses and declare a Public Health Emergency in the fire area. These motions were unanimously approved by the entire Board of Supervisors, thus reducing costs to fire

victims. To me, it was evident that there was a team effort at all levels of Government.

## Survey Shows Chronic Employee Shortages on California Farms

Across California, farmers and ranchers face chronic problems in finding and hiring qualified and willing people to work in agriculture, according to a survey conducted by the California Farm Bureau Federation. The informal survey

of Farm Bureau members showed that more than half of responding farmers had experienced employee shortages during the past year. The figure was higher among farmers who need to hire employees on a seasonal basis—69 percent of those farmers reported experiencing shortages. The results are similar to a survey CFBF conducted in 2012.

"Despite all the efforts California farmers and ranchers have made to find and hire people to work on their operations, they still can't find enough willing and qualified employees," CFBF President Paul Wenger said. "Farmers have offered higher wages, benefits and more vear-round jobs. They have tried to mechanize operations where possible, and have even changed crops or left ground idle. But employee shortages persist."

When asked what ac-

tions they have taken in response to employee shortages, farmers participating in the survey most frequently cited increased wages, benefits and additional incentives. Farmers also reported they had used, attempted or investigated mechanization; reduced cultivation activities such as pruning trees and vines; and either planted fewer acres or left some crops unharvested.

Wenger said he expects farmers to continue offering higher wages and moving toward mechanization, but that the survey results underline the need for action by Congress to improve the existing agricultural immigration program.

"Only 3 percent of the farmers in our survey said they had used the existing H-2A agricultural immigration program," Wenger said. "Even though more farmers have tried it, H-2A remains too cumbersome for most. Farmers in California and elsewhere in the country need an improved system to allow people to enter the U.S. legally to work on farms and ranches."

Farmers have been forthright about their reliance on a largely immigrant workforce, he said, noting that efforts to hire U.S.-born employees on farms have remained unsuccessful. Wenger said Farm Bureau and other organizations would continue to work with Congress to create "a secure, flexible, market-based agricultural immigration program."

### Oroville Dam Survey Results Residents Say Spillway Crisis was 'Manmade and Preventable'

YUBA CITY - Today, Assemblymember **James** Gallagher (R-Yuba City) released the results of a survey his office distributed to collect feedback in the aftermath of the Oroville Dam spillway disaster. A full listing of survey

results can be found here.

Gallagher summarized the findings, "This first comprehensive survey of those affected by the Oroville Dam failure shows that we still have a lot of work to do. There is a strong distrust of DWR, people are frustrated by a lack of transparency, and they know this disaster could have been avoided," said Gallagher. "These results should serve as a wakeup call to state and federal agencies involved that they cannot simply fix the spillway and move on. The downstream impacts need to be addressed and long-term reforms are necessary. The status quo is no longer acceptable."

### **KEY SURVEY FINDINGS** A DEMAND FOR TRANSPARENCY

After intense pressure from local leaders, citizens groups and the news media, DWR publicly released some inspection reports, memos, correspondence and other critical documents. However, many of these documents have been heavily redacted by DWR in order to protect 'information that could be used for terrorist activity.'[i]

When asked about public safety, residents living downstream of Oroville Dam say they are more concerned with the operations and maintenance performed by DWR (84%) than they are of terrorists (3.6%). An overwhelming majority of residents (83.9%) say that all inspection and maintenance records should be made public.

DWR has attempted to open up lines of communication with the public by hosting a series of community meetings. However, more than twothirds (73.1%) of residents who attended these public meetings stated that the information provided and responses to questions

### **50-YEAR LICENSE** On February 11, 1957

the Federal Energy Regulatory Commission (FERC) issued DWR a 50-year license to construct and operate the Oroville Dam facilities. The original license expired on January 31, 2007.[ii] Since 2005, DWR has been working to secure a new 50-year license. The timing and terms of the license renewal has now been put into question following the February spillway crisis.

Nearly all residents (85.1%) living downstream of Oroville Dam say that DWR should not be issued a new 50-year license to operate the dam until the cause of the spillway collapse has been identified, operations at the dam have been modified to address safety concerns and downstream impacts are addressed.

In August, a coalition of downstream stakeholders urged FERC to delay the issuance of the new license until certain conditions are met and outstanding mitigation needs are dealt with.[iii]

### A PREVENTABLE CRISIS

FERC ordered the establishment of an independent Forensic Team to determine the root cause of the spillway incident. The Forensic Team is expected to release its final analysis in November 2017. Only about onethird (36.3%) of residents believe that Forensic Team will produce a fair and accurate assessment of what caused the spillway to collapse.

A preliminary memo released by the Forensic Team on September 5th stated that no comprehensive/independent review of original design and construction of the spillway was conducted since it was built decades ago. The Forensic Team stated that such a review would have 'connected the dots.'[iv]

It appears that the public is already convinced this disaster was the re-

preventable. A small number of residents (16.5%) believe the spillway crisis was largely caused by record rainfall.

### **MORE KEY FINDINGS**

Who should pay for repairs? Most (57.1%) say that water contractors benefiting and receiving water from Lake Oroville should finance the emergency and recovery efforts.

Level of financial loses? Nearly half (45.9%) of residents say they suffered financial losses as a result of the spillway failure and evacuation.

'Green Spot' concerns? Respondents believe that the question of the green spot, and whether it poses a threat to dam stability, has not been answered by DWR. Nearly half (45.3%) of residents ranked finding the cause of this wet spot as one of their top three issues they want addressed.

### **ABOUT THE SURVEY**

The Oroville Dam survev was conducted from August 28-September 30, 2017. Surveys were mailed to every residence in the evacuated areas where a registered voter resides. The survey was also available online. A total of 3,322 residents completed the survey. Results are being shared with the California Department of Water Resources, the Federal Energy Regulatory Commission and the State Water Contractors who finance the operations and maintenance of the Oroville Dam
