# Yuba County News

On September 16th, City Limits Showgirls, a Yuba County bar and strip club conducted a car wash fundraiser at their establishment on Hammonton-Smartsville Road in Linda. The proceeds of \$2565 were given to assist the families of Yuba County Sheriff Deputies Phillip Bronson and Andrew Everhart.

The two deputies were shot by a felon employed by an illegal marijuana operation when they responded for a request for service at the Rastafarian Church marijuana planting.

The car wash was planned for 11am-5pm with up to 15 topless ladies cleaning the cars. The event was extended an hour to cope with the large response from the community and those passing through town. The ladies then returned to work their shift from 8pm-3am.

Club manager Hal Meyer said they appreciate and support law enforcement whenever they can. Meyer was raised in Orange County and was an explorer for the sheriff's department as a young man. He said he has many fond memories of his work with the harbor patrol and credited a deputy for mentoring him.

When Meyer approached the ladies with the idea there was an immediate positive response, he

said. Leslie Carbah, information officer for the sheriff's department, said it was legal for Showgirls to have the event outdoors as long as there was a visual barrier.

The car wash was a complete success. However, car washes have been outlawed in Yuba County since the supervisors passed an ordinance forbidding them. An individual can wash his or her car, but cheerleaders, families seeking burial expenses and showgirls are not to be washing multiple cars in one spot. The person with a filthy car could have washed their own but cannot have it washed in a

group of cars. It sounds silly because it is.

Although Community Services Director Kevin Mallen did not respond with an explanation, maybe it depends on who you are as to whether the law is enforced. The code is an example of the lunacy of federal and state environmental 'wack jobs' who want to control our every move even when any positive outcome is unmeasurable. Of course, supervisors felt compelled to rubber stamp the loss of freedom and lame thinking.

Yuba County marijuana advocates are in a panic. They think Supervisor Randy Fletcher representing the Yuba County foothills may propose a State of Emergency at the Tuesday, September 26, 9 am board meeting. The agenda says nothing of the sort. However, the growers say they received information from a reliable source on the board.

There is a movement among rural northern counties to combine their efforts to solicit state and federal help. That takes more time and organization than a single board meeting. And the sheriff needs to make the declaration.

Siskiyou County Sheriff Jon Lopey and his County Supervisors declared a State of Emergency along with State Senator Ted Gaines requesting help from the National Guard. A brother and

sister attempted to bribe Lopey with a million dollars to allow their marijuana business to continue without interference.

Chi Meng Yang, 31, of Montague, and his sister, Gaosheng Laitinen, 36, made a payment to Lopey of \$10,500 when the FBI arrested them. Hundreds of Hmong have moved into the area buying up parcels from a failed development and are growing mariiuana.

Yuba and Siskiyou Counties have this in common. Thousands of people are growing illegally and have no intention of registering with the state on January 1. Even strong marijuana advocates like candidate for Governor Gavin Newsome see that we have become a lawless state.

This weekend, foothill resident Buck Weckman who advocates soliciting more enforcement help and money for the Yuba County Sheriff's Department and code enforcement was threatened by a grower accusing Weckman of causing the removal of the grower's plants in the middle of the night.

Weckman recently noted 'the grow' in this paper as an illegal planting. Just like thieves steal walnuts and watermelons, they also steal mature crops of marijuana. That's why the plantings and million dollar harvests are guarded with gunmen.

On July 16, 2017 Michial Too of Browns Valley sent a picture to the Territorial Dispatch of a bear in a garbage can that had been roaming the area of Township and Peoria Road in Browns Valley.

Steve Duckels lives on the Duckels Ranch which is in the general vicinity of where the bear was roaming. Steve said that the bear in the picture with the garbage can is not the same one they saw four

years ago. His wife's, Christine, first encounter was a couple of years ago when she heard the dogs barking; fearing that a cow had gotten out she went out to investigate. When she went to the fence she saw tan colored fur and knew immediately it was not a cow. She says she didn't stick around because her first thought was a mountain lion. Later her curiosity got the better of her and she went back out. Approaching the fence she realized to her surprise that it was a BEAR! Making noise and moving around had no affect on the bear. She decided to take some pictures because she didn't think anyone would believe her.

Christine called Fish and Game to report the sighting and was basically told to get used to it, because bears are moving down through the foothills.

It was determined to be a juvenile Cinnamon Black Bear.

If you ever considered attending a Sutter County Supervisor meeting the Tuesday September 26 gathering at 3pm might be interesting. The Health and Welfare Committee, Supervisors Sullenger and Flores, met last week to discuss raising supervisor pay 61.7% along with travel compensation. The concern of citizens was that the change might be voted-in with the consent agenda on September 26 like the 35% retirement increase was in 2004. As this edition went to print the word was that the item may be pulled from the agenda.

The board will also discuss a new camping ordinance addressing the lawless homeless population. "Sutter County is faced with a growing dynamic of persons who are homeless occupying, camping on, and utilizing public and private spaces for their residence," according to County Counsel Jean Jordan. Along with illegal camping homeless crime is rampant in both counties.

The amended ordinance prohibits squatting on properties Jordan describes above which is occurring now with no enforcement. More than one law enforcement official has stated that "we cannot arrest our way out of this problem." This is a "straw man" argument since we have been arresting people for domestic and gang violence, drug dealing and sex with children throughout history and there is still plenty of deviant behavior in the community. Should we stop arresting those perpetrators as well?

It's also been said that County Administrator Scott Mitnick instructed law enforcement to stop arresting homeless people trespassing on private and public property. Maybe we should begin paying the perpetrators to obey the law like the City of Sacramento is paying violent gang members to not kill?

We essentially have been paying street people and others through one of 127 various 'anti-poverty' hand-outs since the 1960s. The conclusion of the Sutter Co Board and Welfare Service professionals is that we haven't been paying them enough. However, have any of these 'leaders' personally worked with a homeless person to see them converted to getting off the dole, taking care of themselves and serving others?

The government has a habit of experimenting with funds extracted from the citizens.

The new ordinance authorizes the development of a permitted homeless camp along Second Street, Yuba City, next to the Sutter County Airport, the Sheriff's Training Center and Shooting Range,

# Lake Oroville Spillways Construction Updates

The Department of Water Resources (DWR) provided an update on construction work on the Lake Oroville Spillways Emergency Recovery Project.

Continued Construction on the Main Spillway

• DWR remains focused on meeting its primary objective of repairing and reconstructing the main spillway by November 1 to handle flows of 100,000 cubic feet per second (cfs).

• Work will continue well past November on both the main spillway and emergency spillway. The state's contract with Kiewit Infrastructure West is currently until January 2019.

• This year, 730 feet of main spillway leading to the radial gates will be patched, reinforced and left in place. It will be removed and re-

constructed with structural concrete in 2018.

• There are 42 days left until November 1: o Placement of reinforced, structural concrete is 30 percent complete. By November 1 there will be 1,220 feet of spillway chute with structural concrete – 870 feet on the upper chute of the spillway and 350 on the lower chute of the spillway.

o The 1,050-foot middle section of the spillway chute, including filling in the two scour holes, is now 50 percent complete, with approximately 170,000 cubic yards of roller compacted concrete placed. This year, there will be an estimated 350,000 cubic yards of RCC placed. In 2018, this middle section will be completed to final design with structural concrete. o On September 17, crews placed 3,143 cubic yards of roller compacted concrete on the middle section of the spillway chute, a record amount for a single 12-hour shift.

o Crews have installed 1,725 slab anchors to date in the structural concrete sections – nearly 60 percent of what is needed for 2017.

#### Construction at the Emergency Spillway

• DWR continues to make progress at the emergency spillway, and is on schedule to complete construction of the secant pile wall, or cut-off wall, in December 2017 or January 2018.

• Crews have completed 22 percent of the secant pile wall.







The proposed 200 person outdoor homeless camp with parking and a 6,000 square foot facility will remove the Sheriff's Posse Arena according to unhappy posse members and will affect other activities near the airport, as well. Joe Borzelleri, president of the Sutter Buttes **Regional Aviation Associa**tion (SBRAA), a nonprofit that operates the airport sent an alert to association members.

"I strongly believe that this is not compatible with the airport environment. Recently, there have been aircraft and vehicle breakins and property stolen. I am very concerned for the safety of aircraft operations and the security of the airport. If an incident should occur, it would make the airport and the county look very bad. I do not think the county realizes the liability involved with having people camping on airport property." "I would like to have

as many SBRAA members and people that are Sutter County residents, call and email the Sutter County Board of Supervisors. Once this "homeless camp" is in place, it would be nearly impossible to make it go away. It does not align with our Airport Layout Plan," writes Borzelleri.

Jordon's ordinance notes an "unknown financial impact," however the Supervisor's agenda item asks the board to authorize using up to \$500,000 of CDBG (Community Development Block Grant) funds to construct the homeless camp.

Sutter County officials have a reputation of withholding the facts until they can make a stealth move to avoid scrutiny. Leaks to citizens have created a dust-up in county offices to discover the source. Maybe an honest, open approach should be utilized and there would be no need for a purge.

Also on the agenda is the possible placement of a commercial cannabis business license tax on the June 5, 2017 ballot.

#### **Rice harvest gains** momentum

It's a race against time and weather in California rice fields, as farmers work to harvest their crops before the onset of autumn rains. That prospect is more urgent than usual this year, because spring storms delayed rice planting. Hot summer weather helped the crop catch up a bit, but may also reduce yields from rice fields. The rice harvest will build momentum to a peak in early to mid-October.

#### **Prune harvest shows** significant recovery

In California prune orchards, farmers report a much-improved The California crop. Dried Plum Board says the harvest is winding

down, with volumes recovering from weatherrelated challenges that cut production in recent years. The 2017 prune crop, at 105,000 tons, would be roughly twice what farmers harvested last year. California farms produce virtually all U.S.-grown prunes and about 40 percent of the world supply.

#### Experts study how wild bees affect pollination

Wild bees can help managed honeybees be more efficient at crop pollination, according to a University of California researcher. A UC Davis professor and team compared orchards that had wild bees with orchards that didn't. They found the presence of wild bees helped hon-

eybees to pollinate more flowers, leading to an improved crop set. They say that's because native bees encourage honeybees to move more among rows of trees.

#### Kern becomes nation's top agricultural county

The United States has a new No. 1 agricultural county, in terms of value of crops and commodities. Kern County reported its crop production for 2016 at more than \$7.1 billion. It surpassed the previous top farm county, Tulare County, which reported its crop values Tuesday at nearly \$6.4 billion. Top commodities in Kern County include grapes, almonds, citrus fruit, pistachios and milk.

# **Bad Year for Prunes** in Sutter County

Devastated By Rain And High Winds, Prune Losses Contribute To Overall Drop In 2016 Sutter County Crop Values

A tough year for prunes led to a 4.4% percent drop in Sutter County's crop values from 2015 to 2016, according to Sutter County Agricultural Commissioner Lisa Herbert.

sors on Tuesday, reporting agricultural production at \$514 million, down 4.4 percent from the \$544 million reported in 2015.

Rice remains the top ranking crop in 2016 with a total value of \$127 million. Though still in a drought, water allocations increased in 2016 attributing to a rise in acreage by 27 percent. The total value of walnuts increased 53% in 2016 due to higher acreage and

vields, rising to \$118 million after crashing to \$77 million in 2015.

Prunes were hit the hardest by inclement weather in March. The prune crop was devastated, leading to a 54% loss in production and 55% loss of total value. At a total production value of \$24 million for 2016, prunes dropped from third to seventh place after a total production value of \$54 million in 2015, Her-

#### bert said.

Processing peaches (\$56 million), nursery products (\$35 million) and processing tomatoes (\$34 million), and almonds (\$31 million) rounded out the top crops.

### Wendell Anderson Will Run For Yuba County Sheriff in 2018 Endorsed by Sheriff Durfor



Yuba County Sheriff, Steve Durfor, announced last week that he will not seek re-election next year and has endorsed Lieutenant Wendell Anderson for Yuba County Sheriff/ Coroner in 2018. Anderson is a lifelong Yuba County resident and 21-year veteran of the Yuba County Sheriff's Department.

"I thank the people of Yuba County for allowing me to serve them," said Durfor. "I would not make this transition if I didn't feel I was leaving our community in strong hands. I've seen Wendell's work on numerous projects and high-profile cases. I've seen his determination. I've seen his passion and commitment to this office time and time again over the two decades we've served together. I fully endorse him as your next Yuba County Sheriff."

Anderson, 48, currently holds the rank of Lieuten-

ant and is Chief of the Detective Bureau, managing 6 detectives and administrative staff. Anderson also serves as Yuba County's SWAT Commander. He is the current President of Yuba County's Management/Supervisor Association and has held that position for the past several years.

"Over 20 years in Yuba County law enforcement, I've worked everything from the patrol beat in Olivehurst and Linda, to resident Hill Sergeant in the foothills," said Anderson. "I know the landscape, the people and the challenges of Yuba County firsthand."

Anderson is a graduate of Lindhurst High School and a graduate of the Yuba College Police Academy, where he now serves as an instructor. He earned an AS in Criminal Justice at Yuba College and has received specialized training during his Law Enforcement career. He is a graduate of the Sherman Block Leadership Institute, management and leadership development courses and other advanced training.

If elected, Anderson's priorities will be to fill vacant deputy positions, increase rural patrols and marijuana abatement, and lower the amount of mandatory overtime current deputies work.

"All this takes money we don't currently have," said Anderson. "My plan is to begin tackling this well before I take office. He has been involved in youth sports for decades, serving as a North Yuba Little League coach and board member, competitive softball coach, and as a volunteer football and softball coach for Marysville High School for many years.

Wendell and Tammy have been married for 26 years. They have two children, Mikayla, 19, a college student, and Zachary, 23, who currently serves in the US Air Force.


After a brief welcome and introduction by Fifth **District Supervisor Randv** Fletcher, General Manger Curt Aikens took over.
