## Yuba County Board of Supervisors Meeting

At the September 26th meeting of the Yuba County Board of Supervisors, under the "Public Communications " portion of the Agenda, Buck Weckman, long time opponent of the marijuana industry, took the opportunity to update the Board of Supervisors on recent illegal activities related to the growing of marijuana in the foothills.

He stated that he really had no problem with the marijuana plant itself; it is the criminal human element that is associated with the growing and distribution of this illegal drug.

He first pointed out that on September 12 there was a daylight shooting and burglary in Browns Valley. The two suspects were arrested on the same day and a search of their home in Olivehurst revealed an illegal marijuana grow and a Butane Honey Oil Lab. Weckman also related a disturbing Email he had recently received through his Yuba County FACT (Families Against Cannabis Trafficking) Web Site. He said he could not give the man's name because it would endanger his life. The unidentified man and his wife live in a Yuba County area

where even Law Enforcement will not go alone. According to the email, four trucks had recently pulled up to a ten foot gate just past his home and several men got out with many guns waiting to gain entrance. This man knew several marijuana grows were behind this gate. The man also stated: "I fear for my kids lives".

Finally Weckman recounted a recent CHP Code Three pursuit through Brownsville and Challenge, resulting in a felony arrest in front of 10013 La Porte Road in Challenge. The person claimed to be a Sureno Gang Member and associated with the house at that location. At the arrest site and within view from La Porte Road was a marijuana grow. One of the plants was over ten feet tall. Weckman provided the Board of Supervisors with a photograph of this grow site. A Google satellite photograph of the site was also given to the Supervisors which showed a Yuba County Road Department Building and Road Equipment storage area right next door. Weckman pointed out that this situation could result into another shooting similar to the shooting of our Sheriff's Deputies in Oregon House. He further stated he liked the work the Road Crews were doing on New York House Road and it would be a shame if some of the work crew got shot as innocent bystanders during a marijuana theft.

Following Mr. Weckman at the podium was Heidi Lepp, the reverend, founder and CEO of the Rastafarian Church in the 9000 block of Marysville Rd., Oregon House, The Reverend Lepp said they use cannabis as a sacrament in their religion. She stated to the Board that she was willing to

All a helper needs to do to help a poverty girl in threat of being kidnapped by a human trafficker is to make one or more small girl's dresses which demonstrate to traffickers that the girls are being watched and looked over.

The Soroptimist of Grass Valley who are heading this movement locally will send a dress pattern and requirements to seamstresses willing to make a dress to save a life via email so they can join dozens of area women making 200 dresses for little girls in Uganda. The finished dresses will be taken to the children's village by club members Lynn Costa and Judy East.

It is possible interested helpers may have remnants around a home sewing space they can use and this dress, which may save



a life and can be made in the time spent on one TV show.

The requirements include all cotton material and the use of bias tape, and elastic As Soroptimist humorously explain to their helpers, it needs extra strength so the children can wash them in a stream beating them clean on rocks, says Lynn Costa, project chairman.

Let the women's club know if you can make one dress or more on your own or join in an old-fashioned sewing event on Sat. Oct 21st. at 1 PM or Nov. 4th at 1 PM until 5 PM at Twin Cities Church on Rough and Ready Road in Grass Valley. Other locations will be announced later according to Costa.

If a seamstress will make one at home SIGV will send instructions and a pattern to you and when done, you can mail the dress to Soroptimist International at their PO Box. "Let's make our area proud and make 200 dresses for 'girls around the world", adds Costa.

## **Fatal Accident in Frenchtown Area Yuba County** Driver Faces Murder Charges

Oregon House, Ca. On September, 25, 2017, at approximately 8:25 p.m. , CHP received reports of a vehicle colon Frenchtown lision Road near Frenchtown Dobbins Road in the unincorporated Frenchtown area of Yuba County. Yuba County Fire Services and units from the Yuba County Sheriff's Department also responded to the scene. Arriving units discovered a solo vehicle rollover collision and three injured vehicle occupants. The right front passenger

Timothy Aaron Rorie 25 was declared deceased at the scene. Michael Wayne Gordy 53 and rear passenger Valorie Lynn Christensen 43 were transported by Bi-County Ambulance to **Rideout Emergency Room** for major injuries. Investigators determined that Mr. Gordy in a Ford attempted to negotiate a left hand turn in the roadway at a very high rate of speed, but veered off of the right edge of the roadway. The Ford overturned several times and also struck a wooden power pole, severing the pole completely. before coming to a rest approximately 100 yards from the point where the vehicle left the roadway. Alcohol use is suspected on the part of Mr. Gordy, as he was arrested for DUI.

Mr. Gordy was released from Rideout Hospital and booked into Yuba County Jail on September 28th at 12:45 pm. He was booked for 23153(a) VC - Felony DUI, 23153(b) VC - Felony DUI .08% or greater, causing injury/death and 187(a) PC – murder.

#### To Discuss Stop Light at Highway 99 and Oswald Road

**Caltrans, Sutter County Meet** 

Caltrans District 3 Director Amarjeet S. Benipal said Caltrans would commence a traffic count study in connection with preparing plans and a cost estimate for a traffic light at the intersection of Highway 99 and Oswald Road.

The Director made the statement Thursday afternoon at a meeting requested by Board Chair Jim Whiteaker to discuss possible changes at the intersection where increasing numbers of trucks are entering and exiting Highway 99. Residents from surrounding neighborhoods have complained to Sutter County about the growth in the number of commercial trucking operations in the vicinity. Mr. Benipal and Deputy Director Andrew Brandt met with Whiteaker. Assistant County Administrative Officer Steve Smith, and Joseph Brennan, a representative from Assemblyman James Gallagher's office. Some residents from the neighborhood and some representatives of the local trucking industry were present for a portion of the meeting and spoke to Mr. Benipal about their concerns.

Mr. Benipal said a traffic signal could cost as much as \$3 million, and part of the cost would be shared by the County. He discussed various funding options.

Chair Whiteaker said a traffic light or some other modification to the intersection is one part of a potential solution for challenges raised by the growth of commercial trucking operations south of Yuba City. A Commercial Trucking Ad Hoc Committee of Board members Ron Sullenger and Dan Flores has been appointed to make recommendations to the full Board of Supervisors.

"No matter what other solutions we find to balance the legitimate concerns of the residential neighborhoods and the commercial trucking operators who provide many jobs and are integral to our economy, we have to address the safety issue at the intersection of Highway 99 and Oswald Road first," Chair Whiteaker said. "This was a good meeting. Caltrans is very sensitive to the conditions and is prepared to assist us in dealing with this safety concern."

Sutter County will also be examining improvements to other portions of Oswald Road itself.

At its October 10 meeting, Supervisors will be considering a 45-day moratorium on new commercial trucking operations as the County searches for ways to mitigate issues raised by residential neighbors.

cold temperatures might be stunted by those cold temperatures. They withstand the very cold temperatures but may not develop and flourish until the warmer spring temperatures. All of the color and pretty foliage could have been enjoyed all winter long by earlier planting. This same message applies to other things as well, such as a winter vegetable garden, and ground covers. They do best with this early warm soil to help them become established. Plant root vegetables such as beets, turnips, carrots and radishes from seed now. Edible peas are cool weather plants, as well as sweet peas that bloom with the lovely fragrant flowers in early spring, and they all can be planted now. If you are planning a winter vegetable garden, it is time to get it done. I know some folks were anxious and have their gardens all planted by now.

The best time to plant California native plants is in the fall when they are going dormant. They then become established naturally by Mother Nature during the cooling of the warm soil. They can be more difficult to get started in the spring since most of them are quite drought tolerant and they are easily ruined by over watering them as

## **Food and Farm News**

Tomato harvest may fall short of estimates

Spring rains and summer heat have combined to reduce the California tomato harvest. Farmers say the wet spring delayed planting, and hot summer temperatures brought stress to tomato plants. As a result, a growers group expects the harvest of processing tomatoes will be 1 million tons smaller than estimated by a government survey. California farms grow most of the nation's processing tomatoes, which are used for sauce, ketchup and other products.

## California leads in organic agriculture

More than 1 million acres of California farmland have now been certified for organic production, according to an annual government report. It says California continues to lead the nation in the number of certified-organic farms, acreage and value of organic sales. The state saw increases in the amount of organic cropland and grazing land during 2016, and sales of organic products from California represented nearly 40 percent of the national total.

Research aims at heattolerant broccoli

Most of the broccoli grown in the U.S. comes from coastal areas of California, because broccoli thrives in cool weather. Plant researchers want to expand the areas where broccoli can grow, by breeding plants that tolerate higher temperatures. U.S. Department of Agriculture scientists in South Carolina say they have identified genetic markers that help broccoli resist heat. They're growing trial plantings of heat-tolerant broccoli in Southeastern states.

Survey shows small rise in food prices

A seasonal survey of retail food prices shows a slight increase compared to a year ago. The American Farm Bureau Federation says its fall market basket survey of 16 retail food items showed prices up about 3 percent. Bacon, chicken breasts, orange juice and flour were among the items showing higher average prices. The survey found lower prices for bagged salad, ground chuck, eggs and potatoes.

## An Eighth of a Teaspoon Kills a Bear bird and can move up the food chain when dead

poisons and insecticides. Unwelcome bugs, animals, and humans who wish to partake of the crop are the enemy to growers. Gabriel says one of the more gnarly chemicals repeatedly discovered is Carbofuran. Carbofuran, an extremely toxic pesticide that's effectively banned in the United States, is a favorite product among many growers and Mexican drug cartels. Gabriel says it is at 60 to 70 percent of illegal grow-sites he visits, often mixed in bottles that have no warning label.

"An eighth of a teaspoon would kill a 300 pound black bear," says Gabriel. Farmers in Malaysia discovered 18 cows dead from Carbofuran in 2010. In 2009, it was used to poison lions in Kenya. The chemical is also highly toxic to fish, and is believed to be one of the main contributors to the reduction of salmon populations in the northwest.

Will it take a couple dead youngsters that were out for a hike and partook of some grow-site's baited fruit to get politicians on their soap boxes? When reasoning and pleading fail, someone's dead kid is always good fodder for remedial action.

While some local politicians cash-in playing 'cat and mouse' on marijuana growing, Carbofuran residues could become Yuba County's own little Love Canal. Because of its long soil half-life (from a few days up to 60 days) Carbofuran has a high potential for groundwater contamination and has been detected in surface water.

This highly restricted chemical is responsible for the deaths of millions of birds and wildlife since its introduction in 1967. The pellets often resemble plant seeds commonly eaten by birds and are often applied on newly cultivated soil. One highly toxic granule can kill a small birds are eaten by predatory species. It can also be obtained as a liquid.

China is manufacturing and then exporting Carbofuran all over the world. It can be obtained online. If delivery is difficult in the US bringing it through Mexico is a popular option where another illegal Chinese killer, the superopiate Fentanyl or China White is finding its way here.

While food-producing farmers are harassed and fined over the location of portable toilets, tissues, shade structures, drinking water, their monthly spray reports and the posting of notices, thousands of pot growers are slinging killer chemicals with no consequences, all for the sake of profit and a buzz.

It's actually no surprise at all. It's always easier to snatch some good citizen's freedom than pursue his abuser.

Day of the Dead is a day of celebration and remembrance of loved ones who have passed. Because it is celebrated at roughly the same time of year as Halloween and the two share some common roots, Day of the Dead is sometimes referred to as the "Mexican Halloween", however, the focus of the two holidays is guite different. Day of the Dead is in some ways more similar to the American observation of Memorial Day. As celebrated today, Day of the Dead is essentially a family time, a time of reunion for both the living and the dead.

#### Honoring Our Vets

War Veterans have put their life on the line and the saying goes "All gave some and some gave all".

The quintessential act of giving one's life for their country is an act of the utmost valor and selflessness.

Although all of us sleep, rise and live under the blanket of freedom provided by such men and women, we have often forgotten them once the guns are holstered and the uniforms are hung in some dusty closet somewhere.

What remains among us are the very men and women who wore those uniforms and shouldered the task of our protection.

In our personal lives, we pass vets daily, some of whom we will never know of their service. My 92 year old father is a WW2 vet, yet never volunteers that information unless asked. Other veterans work among us, or recreate with us, wait tables for us or do the myriad of jobs around us, never asking for anything but what is earned.

Still others hang out in alleys or on street corners, in homeless shelters or mental institutions, much of their plight likely caused by the horror they've seen or by the simple fact that they were little more than teens when integrated into the most sophisticated and largest military in the world, both in mechanism and regimen.

For a myriad of reasons, both obvious and others not so obvious, some vets have difficulty in adjusting to societal norms and therefore not living what some might call normal lives.

Some vets are homeless, institutionalized or living on the outer margins of society. At times it may seem the same government that called them into service has now forgotten many of their needs. Luckily we are fortunate to have those who care enough to reach out and try to help in whatever way they can.

"Welcome Home Vets" and the "Stand Down" organizations are two such entities.

Welcome Home Vets provide support and transitional services to vets and their families. This may include mental health therapy, assistance in navigating the various veteran support systems, and increasing public awareness.

The Stand Down Organization's main focus is helping homeless vets by providing a broad range of basic services and items such as food, clothing, medical, dental, legal help, mental health assistance, job counseling and basic companionship when needed.

The local chapters of both recently held one of their many events to raise funds for providing these support services. The annual Welcome

Home Vets motorcycle rally and BBQ was held on September 16, 2017 and the Stand Down event date is October 6th and 7th at the Nevada County Fairgrounds. At this two day event, veterans can access clothes and other basic necessities including medical, dental, 12 step addiction counseling, PTSD counseling and referrals, job counseling and other assistance.

Colusa County Cameos — Stonyford by Carol Withington

Stonyford is located in a mountain plateau at an elevation of approximately 1200 feet above sea level. The community was originally known as Smithville after pioneer John L. Smith.

Smith, a native of Illinois, traveled to California in 1863, where he settled on the banks of Stony Creek. He soon after erected a hotel, livery stable, blacksmith shop, a lumber mill and grist mill operated by Ernest Seidel, Smith's son-inlaw.

The town retained the name of Smithville until 1890 when a "so-called" promoter by the name of H. C. Stillwell literally moved the existing town to its present site and changed the name to Stonyford. According to research, Stillwell laid out the new town and paid the expenses of the relocation of the buildings. Some were moved as they stood; others were torn down and rebuilt.

It must have been quite an undertaking. For example, the old Smithville Hotel and a store, operated by W. J. King and Ragain were moved and torn apart. A horse then pulled the buildings after they had been placed on rollers. it is said that business was continued at the store as usual while the moving process was underway. Unfortunately, the Smithville Hotel burned down two years later.

Other businesses involved were two saloons with George Howard and Silas Tatum proprietors; two stores, a restaurant, a livery, a feed stable and a blacksmith shop which was operated by P. D. O'Connor.

Stillwell also reportedly spent \$20,000 to build a flour mill. It took an additional \$8,000 for the construction of a ditch to bring water power to the mill. However, the investment proved profitable. A "brisk" market in Colusa and the large amount of wheat raised in the area kept the mill busy almost continuously.

A Post Office was established in 1891 with Henry Engraham serving as postmaster. Residents in the area were given twice a week delivery service with mail brought to Stonyford by stage.

At one time, Stonyford became a tourist stop as people came to spend time at the several hot springs that "dotted" the hills above the town. Among the destinations were Cook Springs, Wilbur Springs and Fouts Springs.

According to old photographs now housed at the Stonyford Museum, the community once sported planked sidewalks, a large hotel and a variety of stores. However, the hot springs later were out of vogue and a fire destroyed the hotel and other buildings.

The Stonyford Cemetery was first used as far back as 1862, when a man named Smith was buried there. Other pioneers in this cemetery include Daniel Smith, who passed away in 1868 and John Martin Smith, the son of John L., who died in 1883 at the age of 30 just seven years before the town named after his father was changed to Stonyford.

The former hamlet of Leesville will be featured in November.
