The beautiful Draft Horses, "The Gentle Giants", are at the 2017 Draft Horse Classic. Majestic Draft Horse performances, breath-taking competitions, and seeing a Draft Horse "up-close" – it's all part of the Annual Draft Horse Classic and Harvest Fair at the Nevada County Fairgrounds in Grass Valley. Featuring six different performances by the Draft Horses, this event has become the premier Draft

Horse show in the western United States. The Classic spotlights a variety of horses, teams, and performances; featuring everything from farm wagons, carriages, and driving competitions to dancing horses and racing mules. The stars of the show are the horses, and with more than 120 horses stabled on the grounds, the Classic offers a unique chance to observe them in a multitude of settings. Happening all four days at the Fairgrounds during the Draft Horse Classic, September 21 – 24, is the Harvest Fair at the Nevada County Fairgrounds in Grass Valley.

## 2nd Annual Civil War Days - Marysville "Battle of the Feather River"



Marysville's second annual Civil War reenactment will take place on Saturday and Sunday, September 23 and 24, 2017 at River Front Park. Cannon and musket fire will echo from two daily battles (12 noon and 3 PM on Saturday and 11 AM and 2 PM on Sunday). The site is open to the public from 9AM to 5 PM Saturday and 9AM to 4 PM Sunday, with a \$10 admission charge at the gate (school children 18 and under are free). In addition to witnessing the 19th century

clash of arms, guests will visit Confederate, Union and Civilian camps, to talk with the soldiers and civilians and learn about life during America's greatest conflict. They may even encounter blue- or grey-coated pickets along the trails or behind the trees between the camps and the battlefield. They will watch battles which feature special effects and reconstruct the sights and sounds of Civil War fighting, with authentic Civil War tactics and weapons.

Soon to be a Marysville tradition, the event is hosted by the Reenactors of the American Civil War, Focus on Marysville and the Mary Aaron Historical Museum. The RACW, a Northern California non-profit organization, is comprised of several Union and Confederate infantry, artillery and cavalry units, as well as a large civilian contingent. RACW members are dedicated living historians recreating the daily experiences of both soldiers and civilians during the Civil War.

## William Regan, Local Civil War Veteran

How did a decorated Civil War veteran make his way to Browns Valley and Long Bar to live out the rest of his life after the war? Born in Inchigeelagh, Ireland in 1840 William Regan immigrat-

ed to America with his parents around the age of 9 along with older sister Hannah and three younger siblings. Apparently, the family lived somewhere in the Midwest. Listing his occu-

pation as a teamster, he enlisted at age 21 into Company D Massachusetts 28th Infantry as a Private on December 13, 1861. The 28th was the second Irish

## Sutter Co Sup Pay Increase 61.7%

Sutter County Administrator Scott Mitnick who was hired by supervisors in spite of a 'thumbs down' evaluation by a panel of local professionals is doing his bosses a solid. He is recommending they vote themselves a 61.7% 'adjustment' to their salaries.

The Health and Welfare Committee comprised of Supervisors Ron Sullenger and Dan Flores will consider Mitnick's 'adjustment' on September 19 and then it goes to the full board for a vote on September 26.

According to Transparentcalifornia.com, in 2016 Sullenger collected Base Pay of \$34,470.90, 'Other Pay' of \$3,895.68 and nontaxable Benefits of \$23652.09 for total compensation of \$62,018.67. Flores received \$34,470.90, 'Other Pay' of \$1767.36 and nontaxable Benefits of \$26,722.38 for a take of \$62,960.64. Mitnick wants to bump the \$34,470.90 figure to \$53,952 which will of course spike the taxpayers' commitment to supervisor pensions.

Using the 2016 figures for the two supervisors with Mitnick's 'adjustment' Sullenger would have collected \$81,499.77 and Flores \$82,441.74 that year.

Mitnick also argues that the suffering supervisors in 2011 were forced to actually start paying the 'Employee Share' (6.6%) of their CalPERS pension payment and that "equated to a 6.6% salary reduction." Only a socialist entitlement mentality can get a reduced salary by funding your own pension. By that logic buying your own cup of coffee would be a salary reduction as well.

For those in the private sector who don't believe politicians deserve any pension and who pay 100% of their own pension

## Davis-Bacon – Windfall of Racism

If you wonder why government takes more and more taxes and accomplishes less while spending more, we are paying a penalty for racist thinking and racist law-making.

In 1927, Congressman Robert Bacon, a Long Island, New York Republican, was irate because an Alabama contractor using all black workers was the low bidder to build the Veterans' Bureau Hospital in Bacon's district.

Racist Robert Bacon was determined to pass legislation to keep minorities out of the construction trade. Prior to what we now know as the Davis-Bacon Act, the construction industry provided wonderful opportunities to blacks, especially in the South. In at least six southern cities, more than 80 percent of unskilled construction workers were black. Blacks also were a disproportionate number of unskilled workers in the North. They also comprised a sizable portion of the skilled labor force in both parts of the country.

Nobel Prize winning economist Milton Friedman says that in a competitive free market the only leverage lower skilled workers (or workers discriminated against) have over more talented or favored ones is by working for less, harder and longer. That was the case after slavery.

Millions of hard working blacks were looking to enter new occupations and would work for less pay. Competition benefits the project owner and in the case of government, the taxpayer. However government, prevailed upon by private agendas, could not long stand competition and the free market.

This glut of unskilled black labor existed while most of the major construction unions excluded blacks, and blacks faced widespread discrimination in occupational licensing and vocational training. The white unions felt threatened by competition from blacks, and favored any attempt to restrict it. So unions went to government to pass laws against competition.

In 1927, when Bacon first introduced his legislation, he inserted into the Congressional Record the following statement by 34 professors concerning immigration legislation:

"We urge the extension of the quota system to all countries of North and South America from which we have substantial immigration and in which the population is not predominantly of the white race. ... Only by this method can that large proportion of our population which is descended from the colonists ... have their proper racial representation."

In 1931, after 13 previous attempts, the Davis-Bacon Act passed with debate making reference to "unattached migratory workmen," "itinerant labor," "cheap, imported labor," "cheap bootleg labor" and "labor lured from distant places" for "competition with white labor throughout the country."

The Act created a 'prevailing wage' or what amounted to

The cold water being released from the Oroville Dam is attracting bunches of salmon as they journey up the Sacramento, hit the cold water from the Feather River and make a right turn. Fish are being reports being caught from Verona all the way to the Outlet, with the best fishing being at the end of their journey. Salmon are fresh, full of energy and are bright in color. There is no need to travel down to the ocean, but just catch your salmon here. Roe is doing an excellent job at this time with flatfish with a wrap coming in second. If you fish the Sacramento River we suggest you do it below Verona and good luck.  
Has your favorite stream, lake or reservoir had a plant of trout from the Department of Fish and Wildlife lately? Well folks, there are many bodies of water which have not been touched with catchable trout for years. If you follow the schedule of the destinations of DFW trucks you will find they usually end up in the same waters dumping trout. Why is this? Good question, but facts are

facts and we are trying to find out why there are so many areas which are not planted. One thing we have discovered is the number of planted trout had diminished considerably over the past five or six years. This is on record as showing the number of fish in 2012 at almost 12 million, has continued down and in 2106 to just over 7 million. What does this mean for the number of planted trout in 2017?

Hundreds of protesters showed up at the UC Berkeley event; nine people were arrested, four were carrying weapons. Reports are that the police said the crowds swelled to about 1,000 people. There was a feeling that Shapiro's speech, "Say No to Campus Thuggery", went well although he was only allowed to fill half of the auditorium.

## Food and Farm News

### Showers dampen raisin crops

Late-summer thunderstorms that passed through California have farmers checking their crops for potential impact. In Fresno County, farmers say raisins laid in vineyards to dry got caught in the rain. Farmers hope for breezes and warmer temperatures to help the raisins avoid damage and finish drying. It will take farmers a couple of weeks to assess the full effects of the storm.

### Plant nurseries adjust to new trends

Changing trends affect California plant nurseries, which are working to adapt. Nursery operators say people appear to be devoting more of their leisure time to technology and less to gardening, and a number of independent retail nurseries have closed. The drought brought more attention to water-efficient and native plants. Nurseries say customers have shown more interest in raising homegrown produce, and in smaller plants for container or balcony gardens.

### UC tests new methods to assure cow comfort

Keeping cows cool while saving energy and water: Those are the twin goals of a University of California research project. Specialists at UC Davis have been testing two ways to help dairy cows during hot weather. One involves use of cooling mats; the other uses fabric ducting to blow cool air. Researchers say each method could be more efficient than current techniques, but they plan more tests next summer.

### Estimate shows a slightly smaller walnut crop

The California walnut crop could be the second-largest ever, according to a government estimate. The U.S. Department of Agriculture predicts California farmers will harvest 650,000 tons of walnuts this year, down about 5 percent from last year's record crop. The report says record rains this past winter left some walnut orchards saturated for weeks, and summertime heat had forced growers to protect walnuts from sunburn.

the union wage that had to be paid on all federal projects and eventually applied to most state projects as well. Minorities forced by government to pay union wages removed the advantage they had to compete with union contractors. Small minority companies could do the job as well and cheaper, but lacked the sophisticated equipment, office staff to complete government paperwork and skilled workers to pay union wages and remain competitive.

Just like another union strong-arm tactic, the minimum wage, Davis-Bacon put unskilled people out of work. Blacks immediately suffered from the union pay-offs to government. On the Hoover Dam construction in 1932, of around 4,100 workers no more than 30 were black.

Like slavery, The Dred Scott Supreme Court decision (pro-slavery), abortion clinics targeting minority neighborhoods, anti-black Jim Crow laws, and school segregation, the Davis – Bacon Act was another means to institutionalize discrimination against black and then all lesser skilled workers.

The Davis-Bacon Act today imposes tremendous economic and social costs. A 2011 Heritage Foundation study estimated that Davis-Bacon would add almost \$11 billion to that year's construction costs. In the 1990s it was estimated that repealing the Act would create an estimated 31,000 new construction jobs, most of which would go to members of minority groups.

When you wonder why there is little money for roads, bridges, dams, schools, any government improvements, Davis – Bacon is adding 1/3 or more to the costs on every project.

Now, California Democrat legislators and their unions are using Assembly Bill 1250 to take further control over government work. AB1250 would forbid counties to outsource or contract-out tasks even though it saves money and time to do so. This bill would cause an immediate expansion of government, union members and related costs. Once counties lose their freedom, cities are next.

# William Regan, Local Civil War Veteran

regiment organized in Massachusetts and was mustered in for three years at Camp Cameron, Cambridge and mustered out at Boston, December 19, 1864. Those three years were described by one Civil War researcher as “horrendous” for this company. They left the state in January, 1862 and for two months were stationed at Fort Columbus, New York Harbor. They then embarked to Hilton Head, South Carolina where they were assigned to General Sherman's expeditionary corps and performed” various services” until June 1 when their real action began with an attack on Fort Johnson near Secessionville. Battles of the second Bull Run , Chantilly, South Mountain, and Antietam followed in rapid succession. At the battle of Fredericksburg in December during a “gallant advance” the regiment was nearly cut in two by enemy fire. On January 1, 1863 William was promoted to Corporal. Heavy

losses were incurred at the battle of Gettysburg where he was taken prisoner July 2, 1863. It is unknown when he was released from Gettysburg but fighting was nearly constant from July through December. They rested in winter quarters until May and then fought battles through August 14, 1864 where William was wounded at Charles City Cross Roads, Virginia. Battles continued into December when William mustered out. Statistics for this regiment indicate for the 4 years of the war 235 enlisted men were killed and an additional 136 died of disease or accident. 15 officers were killed. Older sister, Hannah at some point had made her way to California, possibly with family members and in 1871 at the age of 29 she married Thomas Gorman. It is unknown when William came to California, whether it was before or after his sister's marriage but we know by age 40 he

was living in Browns Valley. We know through family lore that he was plagued by a limp for the rest of his life, a result of his war injury. From ages 40 to 60 he worked as a farmer in Long Bar raising olive trees. It probably became difficult to continue doing the hard farming work so sometime around 1900 he retained “pension attorneys” Longshaw and Pollard to help him secure a pension. Pensions were determined by rank and severity of injury so it is probable he received around \$30 dollars monthly. Though he worked hard the rest of his life and did not become rich, surely his life was more peaceful than the tumult of the horrific war years. He remained single and died on February 15, 1917. He is buried in the Gorman/Sperbeck family plot next to sister Hannah. William Regan was the oldest remaining Civil War veteran in Browns Valley when he died.

### Investing, One Size Does Not Fit All

There are many reasons to invest and they include saving for retirement, saving for the kids education, providing income now or in the future and passing along the estate to the heirs among others.

Although the term “investing” applies to all these reasons, the methods to accomplish each goal might be different. Considerations depending on why one is investing could involve preferences such as an all growth strategy (aimed solely at increasing the balance and might contain a higher degree of risk), a conservative strategy (that puts conserving principal first and foremost before gains), a target strategy for college funds (structured for moving from risk investments to more conservative holdings as college age approaches), an income strategy later in life, an immediate income strategy, or a tax minimizing strategy for trusts or non-IRA type accounts.

As shown above, in investing, not one size fits all. One of the most critical areas of discovery between clients and financial advisors is to get to know your client and find out exactly why they are investing.

For many, a conservative approach that attempts to conserve principal first and foremost before attempting to grow the portfolio is adequate. For others, particular situations require specific strategies and these strategies can be quite different in their construction. I have reviewed literally thousands of portfolios over the years both managed by the client or an advisor and the similarities between portfolio holdings despite different individual situations has been somewhat disturbing.

It's almost as if there is a standard belief that holding a basket of stocks and/or funds mixed with some bond funds fits all situations. In my opinion, this structure may be good for some but definitely should not be used in all situations. In fact, I could think of half a dozen strategies one could implement depending on a particular situation.

The net worth of the individual, their age, how many kids they have, their level of perceived risk and what exactly they need from the investment all have a bearing on what strategy should be considered. Most investors might think their first and foremost desire is to make money but in truth, there is much more to investing than that one consideration.

What to hold, how much to hold, when to hold and what not to hold are all considerations for the client and his professional. Certain investments might be purchased that yield income now or in the future or both, while other investments might have a tendency to garner gains yet might also contain higher risk. Certain investments might have tax advantages such as deferral or lower rates while other strategies may have no tax implications at all.

If you are invested or are considering investing, you likely have a goal in the back of your mind somewhere. Distilling that thought into a concise and definable intention and then writing it down will go a long way in finding a strategy that best fits that need. I have always said you can't hit the target unless you know what you're aiming for. Once you know exactly why you are investing, the next step is implementing a plan which encompasses that goal and all its considerations. These considerations might include taxation, length of investment time, desired income stream, safety and timeframe, growth potential and other preferences and needs.

# Suspect Shoots Self During Altercation, Two Arrested

Marysville, Ca. On September 10, 2017 at about 6:01 pm the Marysville Police Department, received a 911 call in reference to an adult male being shot in the face in the 900 block of 7th Street Marysville. Officers arrived on scene and contacted an adult male; they learned at that time the bullet had actually traveled through the victim's shoulder and neck. The victim was transported to the Rideout Hospital for treatment and has since been released.

During the course of the investigation, Marysville Police Department Detectives learned that three subjects arrived in a vehicle and an altercation ensued. During the altercation, a male subject whom arrived in the vehicle, fired a small caliber handgun at the victim. Investigators learned that the male suspect also sustained a self-inflicted gunshot wound to his right bicep after the bullet exited the victim's neck. Marysville Police were able to identify the three suspects involved.

In the late afternoon of 09-11-2017, Marysville Police Detectives contacted and questioned all three suspects. As a result, 21 year old Jevaun Silas Coleman of the 1200 block of E.22nd Street, Marysville and 23 year old Adrianna Baker of the 1200 block of E.22nd Street, Marysville were arrested. Nicole Hedrick, Age 27, 1300 block of Hobart Drive, Marysville is pending criminal charges.

Through this investigation, Jevaun Coleman was identified as the shooter and both Adrianna Baker and Nicole Hedrick were identified as accessories to the shooting.

Jevaun Coleman was taken to Rideout Hospital and treated for his self-inflicted gunshot wound.

Jevaun Coleman was transported to the Yuba County jail where he was booked for attempted murder. Adrianna Baker was booked for being an accessory to attempted murder. Charges for accessory to attempted murder are being filed against Hedrick.

# Two Arrested After Residential Burglary and Assault with a Firearm in Browns Valley

Two arrested after residential burglary and assault with a firearm in Browns Valley

On September 12, 2017 at approximately 2:23pm, Yuba County Sheriff Deputies arrested Richard Nix age 36 of Olivehurst for Assault with a Firearm, Burglary, and Felon in Possession of Firearms and Ammo; and David Peterson age 18 of Marysville for Burglary; following a burglary that had occurred in the 5000 block of Marysville Rd in Browns Valley just after 2pm.

Nix's charges are being amended with the new marijuana offences added portion of the investigation was turned over to Net 5; and both he and Peterson were also charged with 211 PC/Robbery and 182PC/Criminal conspiracy in addition to Burglary
