

Another big catfish has been caught. This time the fish was huge and we will call it the "Big One". We don't have much detail, but the big cat was caught at Rollins Lake, was caught at night and weighed in at 27 pounds according to the Long Ravine Marina. The lucky angler is unknown at this time.

Salmon are being caught at the Barge Hole on the Sacramento River, but most of the fish are Jacks and the ratio per boat is less than one per angler, while action on the Feather is strong at the Outlet Hole if you want to put up with crowds of shore anglers and tons of boats. Salmon have been taken downstream, but the Outlet Hole is the hot spot this week.


Kokanee Salmon are on a biting frenzy just about in all reservoirs in the Northern Part of the state. Reports tell us Whiskeytown Reservoir and Stampede Reservoir is producing easy limits at this time.

It's official. The big spotted bass, which was weighed in at eleven pounds four ounces and was caught last February by angler Nick Dulleck at Bullard's Bar Reservoir was recognized as the all-tackle world recordholder by the International Game Fish Association. The bass, in addition to weighing over eleven pounds measured 24 1/2 inches long and had a girth of 20 34 inches. Now this is definitely the "Big One". Congratulations to

Autumn is close by and we think about all the high elevation trout streams which are running low, are crystal clear and have some of the best trout fishing of the year. To be successful one must be extremely quiet and if you wade we highly recom-

mend doing so upstream. I love to fly fish and this time of year is a good time to go this way. It is not as important what fly is used, but mainly the presentation. By this I mean gently so as not to make a big splash. In addition, red worms fished on the bottom of the stream and drifting downstream is a good idea for spin anglers. The secret to fall trout fishing in the high country is to be aware of the quiet clear water and avoid any chance of spooking the fish.

Closing thought: Our hearts go out to the folks in Houston and now in Florida. God Bless.



French Organist, Christophe Mantoux, to Perform in Yuba City

Yuba Sutter Arts is proud to announce a community organ concert in collaboration with Marian Metson and First Lutheran Church in Yuba City. The featured organist will be internationally renowned

musician, Christophe Mantoux, Professor of Organ at the Regional Conservatory of Music in Paris where he teaches students from all over the world.

The concert will be on Tuesday, September 19 at 7:30pm at First Lutheran Church, 850 Cooper Avenue in Yuba City. The concert is Free, but donations will be accepted for the upkeep of the organ.

Marian Metson, coordinator of the upcoming concert series, was the organist at First Lutheran from 1994-2010. During her tenure at the Church, there was a successful concert series that included top organists from around the country. Due to a generous anonymous gift, she has been asked by the church to reinstate the series.


"We were able to collaborate with Chico State where the organ builder had built his first instrument and attract some of the finest organists available," said Marian. "So now we have an opportunity for our community to once again hear a world class organist playing on a world class instrument right here in Yuba City," she added.

The First Lutheran organ was built by Munetaka Yokota, who went on to build organs at universities

in Sweden and in Rochester and Ithaca, New York. Yokota is revered in esoteric organ circles. The organ is one of the finest church organs built in an historic style in Northern California. While not a copy, the organ is identical in appearance and in voicing to the seventeenth century North German Baroque instruments Bach would have known. Its crispness, clarity and balance are exceptional.

Christophe Mantoux's career as a concert organist has taken him to more than twenty-five countries in Europe, South America, South Korea, Japan, Canada, China and the United States. He has played some of the world's most prestigious instruments including many of the great organs of Europe and the U.S. including the Fisk organ at Stanford University. He recently held a weeklong teaching residency and presented a concert at Yale University. His recordings include a CD featuring the music of Johann Sebastian Bach on a new organ built in the "Bach" style, by Dominque Thomas in Strasbourg, France.



Winegrape harvest accelerates

Quantity may be a bit lower but quality remains high for the California winegrape crop. Winegrapes are reaching maturity in vineyards across California. The consensus among farmers and wine executives is that yields will be slightly below average, but quality has been excellent. Farmers say cool, wet days during bloom appear to have reduced grape production. Growers have also been checking the impact of late-summer heat on their crops.

Pear growers report improved crops

Reports have been positive from California pear orchards, where farmers are wrapping up harvest. Pear growers describe both the size and the quality of their crops as much improved from last year. Hot weather brought smaller-sized fruit and sunburn in a few cases, but for the most part pears have done well this season. About two-thirds of California-grown pears will be canned, with most of the rest sold as fresh fruit.

Estimate shows impact of citrus tree disease

As citrus growers in Florida struggle with a devastating tree disease, California has for the first time in decades passed Florida in total citrus production. A

government report shows California farmers sold nearly 4 million tons of citrus in the latest marketing year, compared to 3.5 million tons from Florida. The tree disease HLB has cut Florida citrus production. In California, the disease has been limited to backyard trees, so far.

Farmers explore the possibilities of pitahaya

A fruiting cactus known

as pitahaya grows well in the mild climate of Southern California, and more farmers appear to be taking interest in growing the fruit. University of California specialists say the pitahaya fruit--sometimes marketed as "dragon fruit" -- has become popular in Asia and the Middle East. They say the cacti can also make excellent landscape plants, and that pitahaya thrives in regions that produce avocados.

Walnuts Still Yuba County's Top Crop; others hobbled by low prices

Marysville, Ca. – California's extended drought that carried into the 2016 harvest season played a significant role in reducing Yuba County crop gross values by nine percent.

Yuba County Agricultural Commissioner Stephen

Scheer said drought conditions and lower prices for many crops resulted in a gross crop value of \$214.9 million, a significant drop from 2015's estimated value of \$231.8 million.

"The extended drought and lower prices continue to

pose significant challenges for producers," Scheer said. "The decrease in value is primarily due to the prune crop loss and lower pricing for many of our top commodities."

While some of the county's agricultural totals suffered from lagging prices, other crops such as walnuts. kiwis.

timber, and almonds benefitted from notable increases in value. Farming acreage devoted to walnut trees increased, helping that crop jump from \$52.7 million in 2015 to \$65.9 million in 2016.

By contrast, rice – the county's number two crop – dropped in value by more than \$6 million. Prunes expe-

lion in value due to lower prices and decreased yields.

The Reality and The Politics of DACA

The Trump decision to eliminate DACA will not lead to massive deportations of so-called Dreamers; in fact it is likely to have little effect at all. The 800,000 DACA immigrants were in this country before DACA was enacted in 2012; they are likely to be here long after it ends, if it does end.

That's because the reality of immigration policy is much different than the hysteria that often surrounds it. Despite President Trump's harsh talk about immigration, the fact is that deportations under Trump are down from the final year of deportations under President Obama. But you would hardly know that from the fear mongering that surrounds Trump's immigration policy.

According to the Washington Post, 61,370 illegal alien criminals were deported between January and June 2017; that is down from the 70,603 criminal deported between January and June 2016, the last year of the Obama Administration. The rate of overall deportations is also down from 2016. Part of the reason for this is that the job of Immigration and Customs Enforcement has been made much tougher under Trump by the sanctuary cities efforts. And a slowing of illegal border crossings under Trump has reduced the illegal immigrant population in America. So there are simply less people to deport.

It will take much greater effort by Trump for him to even reach the deportation levels of America's presidential deporter in That would be chief. President Obama; it is a little known factoid but the Obama Administration deported more illegal aliens than any administration in American history, more than 2.5 million.

The Dreamers are, by definition, young people who have stayed in school or have a job and have stayed clear of any involvement with the law. They were already here;

DACA did not open the floodgates of illegal immigration; it simply provided two years with renewal protection from deportation for law abiding undocumented immigrants. Little about their status is likely to change once DACA expires, and under the Trump order that will not be until 2020 anyway

So why all the hysteria over the Trump action? The answer is that Democrats think immigration is fabulous political issue for them, and enhances the national demographic trend that is already in the Democrats' direction. Polling shows that the

public as a whole favors some sort of legalization of law abiding immigrants. Non Defense Spending

Politicians are always promising to create jobs for their communities. But where do these mythical "good jobs" come from? Like many others in our community, I graduated UC Davis in the middle of the 2008 financial crisis. I cobbled together four part-time jobs to pay the bills, but I feared that I'd have to pack up my life in boxes and sleep in my car. What prevented me from becoming homeless was the job that I got as a lab technician funded by the National Institutes of

Health (NIH). When I joined the lab, there were 15 people who were employed from NIH grants. Many of us were not your typical "scientist." Jane had never studied science before she started working in the lab, but she grew to love it and was a great supervisor to me. I myself was daunted by the idea of working in the ivory tower of "Science." But as I grew into

my position I realized that

jobs in scientific research

are not reserved for a se-

lect few academics. These federally funded laboratory jobs are accessible to all kinds of amazing and hard-working people in our community.

When Congress cut NIH funding, several people in my lab had to be let go. Jane was let go just when she was expecting a promotion. She had grown up in Yuba County, but had to move to Southern California to find work.

My lab was not the only one affected by the funding cut. UC Davis hires thousands of local people from all over the valley using federal non-defense spending including 22,000 professional and support staff - nearly double the 12,000 academic jobs at the university. When federal non-defense spending is cut, many of these support jobs disappear and money and jobs leave Yuba County.

The jobs created by non-defense funding are not out of reach or reserved for a select few. They are good jobs that I truly believe any of us in

the community can do. If we want to provide more of these jobs, we need to tell Congress to increase nondefense spending before the deadline at the end of the month. Federal nondefense funding doesn't just push health research forward and keep America on the cutting edge of innovation. Non-defense funding boosts the local economy in our communities by providing good, accessible jobs that allow our residents to prosper.

Siskiyou Sheriff Requests to Declare **Emergency On Illegal Cannabis**

Siskiyou County The Siskiyou Daily News reports that Siskiyou County Sheriff, Jon Lopey, has requested the County Board of Supervisors declare a local emergency due to illegal cannabis cultivation.

A proposal to declare a local emergency in Siskiyou County due to the proliferation of illegal cannabis cultivation sparked a much wider discussion at the Siskiyou County Board of Supervisors meeting on Tuesday.

Many members of the Hmong community expressed their opposition to the proposed proclamation, and a number of

residents in areas with large numbers of cannabis cultivation sites spoke in favor of it.

Sheriff Jon Lopey explained that it was hoped that the proclamation would help the county leverage resources from the state and federal governments in order to respond to what he estimated to be approximately 2,000 illicit cannabis cultivation sites spread around the county.

Lopey also clarified that the emergency proclamation does not target any specific community, but ultimately is an attempt to respond to illegal activity that has proven to be beyond the county's capabil-

ity to address.

The board's discussion came at the end of the public comment period, and each supervisor expressed support for the proclamation, calling attention to the impacts of illegal cultivation, from illegal pesticide use to the increased risk of fire from cooking outdoors.

Taken to a vote, the board unanimously supported the proclamation of a local emergency declaration.

"Good Reason" Carry Requirement Unconstitutional Decision from July 24, 2017

Springfield, VA . — Gun Owners of America (GOA) is celebrating a landmark victory for the Second Amendment in a case that was decided by a three-judge panel of the D.C. Circuit Court of Appeals, which ruled that D.C.'s "good reason" requirement for concealed carry permits is unconstitutional.

GOA submitted an amicus brief in Wrenn v. D.C., arguing against the "good reason" justification for the permitting process in Washington, D.C.

Said the court: "[The law-abiding citizen's right to bear common arms must enable the typical citizen to

carry a gun." The court's decision represents a stunning rebuff to the District's historical animus toward Second Amendment rights.

Washington's current permitting system is extremely restrictive. In fact, living or working in a high crime area is not a sufficient reason by itself to get permission for a carry permit.

"Americans everywhere - even those living in our nation's capital - should be able to defend themselves with a firearm," said GOA Executive Director Erich Pratt. "GOA is happy to see the Court recognize the right to keep and bear arms and deal a blow to Washington's draconian carry laws."

Washington's restrictive gun laws also affect those travelling into D.C., as Pratt points out.

"These restrictive carry laws do nothing to stop criminals, but they do leave law-abiding citizens defenseless, as shown in the tragic congressional shooting last month," Pratt continued. "We hope Congress will soon pass concealed carry reciprocity so that honest Americans can carry their firearms across the country, as well as in the District of Columbia."

The Battle of Feather River is Coming



Civil War Days are coming on September 23rd and 24th. Be sure to come for the Battle of the Feather River and allow plenty of time to stroll through the camp. Here is a glimpse of life in the camps continued.

Artillery: Considered the King of the battlefield, the cannons and their crews of this era achieved new levels of accuracy and lethality. The men of the artillery demonstrate the loading, aiming and firing procedures for cannon under their charge. Visitors will examine the different type of cannons and learn about the advantages and disadvantages of those various types along with the differing kind of ammunition used. .Learn how the artillery was used in battle and how it was organized, how many men comprised each battery, how many horses were required and the extent of the support staffs required to keep a battery in the field

Medical: Field hospitals of the Civil War era did the best they could. But shortages of supplies and huge numbers of casualties combined for crude care at a time when the importance of sanitation was only beginning to be understood.

The regimental surgeon will explain to you the nature of the most common wounds and the most expedient forms of treatments. He will also show-off various surgical and examination instruments used in the field. And since more men died from disease than from battle, you gain knowledge about the most common drugs used to treat soldiers. Because not all medical personnel were actual doctors, you will see how the training of various individuals that tended the wounded.

Commissary: Keeping the troops fed and supplied was a major problem during the war and the skill of the company cook often made a big difference in the quality of a soldier's life.

The cook will explain the many types of foods issued to the troops; those supplied by the army and those collected through foraging. Officers ate differently from enlisted men and the sick were often prepared special meals when conditions allowed. While much of the food consumed by the Union and Confederate armies was the same there were some differences. Getting supplies to the men in the field was often the biggest obstacle facing the armies. You will gain a better understanding of how the food and supplies reached the men in the field, whether by wagon, ship or train.

Civilians: Not everyone who participated or suffered during the war was a soldier. Many civilians went following Union soldiers south, while many southern civilians suffered heavily as the war raged across their family farms and

through small towns. You will hear about the plight of many southerners and how the "Yankee invaders" ruined their ability to make a living. Some civilians traveled with the armies, working in a number of noncombat jobs.

Politics: It is often said the Civil War pitted: brother against brother". That men followed their conscious and staked their lives on what they believed. As you move throughout the encampment you will hear why men are fighting, whether it be for the Confederacy or the Union. What motivated them and what pressures may have come to bear when making their decision to take up arms?

While a modern visitor may think of the Civil War purely in terms of preserving or ending slavery, they may be surprised to learn men fought for other reasons that many soldiers in the north were ambivalent about slavery and even opposed the Emancipation Proclamation while many in the south had no stake at all in the preservation of that "peculiar institution".

Civil War Days is a local public event sponsored by FOCUS Marysville and Mary Aaron Museum. Join your neighbors on Sept. 23rd and 24th Camps open at 9:00am with two battles daily. Come travel back in time to the 1860's and relive an exciting part of our shared past.

How Marijuana Bills Could Shape California's Legal Weed Industry

Excerpts from the Lost Coast Outpost by Ryan Burns

State lawmakers are scrambling to develop regulations for California's legal weed industry before Jan. 1, 2018, when it finally becomes legal for adults to buy marijuana without the cover of a doctor's recommendation. Regarding that mad scramble, representative in California Senate, Mike McGuire, offered an analogy: "We are building the plane while it's being flown."

The Legislature now has until Sept. 15 to pass bills in the current legislative session, and Gov. Jerry Brown has until Oct. 15 to sign them into law or veto them into oblivion.

"The new rules and regulations that will be required of cannabis

businesses next year are going to be a big change for the industry," Wood told the Outpost. "We are working to do everything we can to make this transition period as easy as possible."

Here's a look at how the current batch of bills from our local lawmakers

may impact the industry. With legitimacy comes taxation. (Or is it vice versa?) Starting Jan. 1, all licensed cultivators in California will have to pay the tax man for their harvested ganja. How much? Per voterapproved Proposition 64 (aka The Control, Regulate and Tax Adult Use of Marijuana Act, or AUMA), the state will levy a tax of \$9.25 per ounce of harvested buds bound

for the commercial mar-

ket The rate for leaves, meanwhile, will be \$2.75 per ounce, and consumers will pay a 15 percent

tax on retail purchases.

When Prop. 64 became law, many growers expressed concern about having to pay taxes at the time of harvest before the product has been sold. To address these concerns, Wood introduced a bill, coauthored by McGuire, to allow growers to pay their taxes through a licensed distributor, meaning they won't have to pay the tax man until after they've been paid for their product. (Technically, the distributor would pay the tax, just like retailers are responsible for paying the sales tax they collect.)

Do women make better VP's? It's a tough question to answer and certainly a hotly debated one. Although the majority of company CEO's are male, there are a number of women steering the rudders of large and small companies alike, and although we can't know for sure how a private company is doing, public companies whose stock shares are available to retail investors have to publish their financials every quarter and by looking at these financials, we can discern whether the woman CEO is measuring up or even surpassing her male counterpart.

According to a 2016 survey by Fortune, only about 4% of Fortune 500 company CEO's are women and that number actually decreased that year. For those doing the math, it means a paltry 21 companies Fortune 500 companies were commandeered by women in 2016, down from 24 two years before. 2017 however is witness to a new record of women run companies with 29. The caveat being with women making up 50% of the population, only about 6% of notable companies are run by them.

Of the women heading up or used to head up these companies, some notable names and companies appear on the list, some with glowing results and some not so favorable.

Meg Whitman, former CEO of Hewlett Packard, GM's Mary Barra, Pepico's Indra Nooyi, Ginni Rometty of IBM, and Merissa Mayer of Yahoo are but a few of the wellknown companies with women who held CEO positions. Lockheed, Xerox and Avon also can be added to this list. There are more of course.

The obvious question is do women perform any differently than men when it comes to calling the shots of such behemoths. The sample set is obviously limited with such a low percentage of female CEO's but since all numbers can be crunched in some manner, we can at least draw some hints as to how well women have performed in the past when heading up large companies.

Investigating women's intuition and judgement on handling money, a gender investor comparison study in the year 2000 by Terrance Odean of UC Berkeley and Brad Barber of UC California entitled "Boys will be Boys: Gender Overconfidence and Common Stock Investment" deter-

mined that women investors outperform men by 1.44% annually. Extrapolating out on that study, Kristin Orman of Wealthy Retirement compared the performance of S&P 500 companies after women CEO's replaced male counterparts and found the companies went on to outperform the broader markets by an average of 104% based on their stock price. The women run companies saw a price increase cumulatively rise 170% while the market increased only 67% during the same measuring period. Although the obvious observation is the sample size is very small, the results do spawn some Are women better

questions. managers than men? Why aren't more women in the top positions at large public companies? Are the results of the few studies undertaken conclusive? Why do the statistics we currently have available to date seem to indicate women are indeed superior CEO's based on stock price performance? Is stock price performance the only indicator of a successful manager and is it a valid indicator of a

company's success?

In time the answers to these questions will become clearer as the number of women who are put into CEO positions increase and the passage of time and greater sample size allows for better statistics to yield better conclusions. One thing is certain however: The number of women in top positions is woefully disproportional to the number of women in the general population. That certainty leads us to the obvious and most important question: why?
