

## Ronald Ybarra and Michael Alexander Cases

On August 7, 2017 parolee Ronald Ybarra was arrested and booked by a Yuba City Police Officer. Police were called to a disturbance, a fight between two men, at the Bridge Street Taco Bell. One of those involved was Ybarra.

A struggle ensued between the cop and Ybarra as the larger Ybarra was wrestled

to the ground. Ybarra was charged with resisting arrest and violating parole.

The interesting but now common aspect of the incident is that a by-stander was using a phone to video the event. The 10-second clip was posted on social media which is more than enough time for Facebook 'criminolo-

gists' to assess blame. Most did incorrectly.

Many viewers immediately trashed the cop for hitting Ybarra. However, retired Marysville Police Chief Jack Simpson, rebuked the cop critics on Facebook saying it was a righteous takedown.

Many citizens may think policing works this way. The

officer invites you to jail and you can decline. If you decline, then the officer apologizes for any inconvenience he caused and excuses himself to get on to more important business.

What is even more disturbing is that those observing do not assist the cop but remain morally neutral and detached until the victor is determined. Then, the observers' next move is to triumphantly post their prize, the 10-second thriller right after they upload the photo of the cupcakes they baked.

Yuba City police are frustrated with the Sutter County District Attorney's office for not prosecuting Ybarra and releasing him. Police are convinced the officer's own video along with witnesses at the scene completely justify his actions.

Did Ybarra and the officer get justice or social media 'justice?' Why bother with a jury when we can count-up the 'Likes' and comments on Facebook?

On January 23, 2013 Leola "Dodie" Shreves, 94, was found beaten to death in her Yuba City home on Park Avenue. Her neighbor Michael Patrick Alexander, then 20, was eventually arrested and charged with first-degree murder, torture, aggravated mayhem, first-degree burglary and attempted first-degree robbery.

Yuba City police believe Alexander broke into Shreves' home some time on the night of Jan. 18, 2013 setting off a violent struggle that led to the woman's death. The graphic criminal complaint indicates that Shreves was tortured and dismembered. "The defendant did unlaw-

fully deprive a human being of a member of her body, or disable, disfigure or render it useless, or did cut or disable the tongue, or put out an eye, or slit the nose, ear or lip," the complaint reads.

Yuba City police detectives said that Alexander confessed to the killing on January 25, 2013 telling them how the victim denied him money. Sometimes "angry Mike" takes over, the accused said.

Former District Attorney (DA) Carl Adams discussed the death penalty as a possibility as did Judge Brian Aronson at the time. The case was then passed onto Assistant DA Jana McClung when Adams resigned and then eventually to newly elected DA Amanda Hopper.

Hopper dropped charges in August 2016 for lack of any physical evidence connecting Alexander to the scene. Alexander remained in custody until the dismissal of the case.

Now, in a lawsuit filed against Sutter County, Alexander says he was tricked into confessing. Investigators disagree, believing Alexander could be prosecuted. Would it have been appropriate to consult with outside prosecutors to evaluate or help pursue the case? And why wait more than 3-years to dismiss?

The relationship between prosecutors, judges and law enforcement is sensitive and often laden with frustration and tension. However, the public benefits when they can achieve a degree of harmony to efficiently process cases.

High profile incidents lost, not prosecuted or dropped test that relationship.

A 15-year-old walking out of Marysville with a gun and ammo today would surely light-up the local dispatch center. Times have surely changed.

In the late sixties and early seventies Marysville residents were tiring of a tattered downtown and voted to demolish blocks of historic brick buildings. The area around 1st, 2nd and 3rd streets and B, C, D and E were loaded with bars, cheap rooms

**"The Stock Rental Income Strategy"**

There are a variety of strategies for investing and many of these strategies don't just entail buying a bunch of stock and funds and then waiting for the market to go up to make money. Some investors want retirement safety while others want explosive growth. One of the more common requests I get is the desire for a structured and dependable income. Although this may be accomplished through an income annuity or similar product, some investors shun annuities because of their possible time commitment some products may have as well as potential early withdrawal penalties. There are however other ways to accomplish the need for income. One such strategy is what I call the "The Stock Rental Income Strategy".

The portfolio is structured holding about 20 or so large stocks that are scheduled to pay dividends. Dividends are payments by companies to shareholders. The companies held are not just any companies but the largest of the large with an emphasis not only on size but on dividend history, financial strength, product lineup and other factors. Companies that have been around a long time, sell products that many people use and are familiar with a long history

of rewarding shareholders are sought out and then reviewed also for financial strength and strength of product.

Once selected, the aim is to hold these stocks as a basket with each paying dividends which would yield a variety of checks throughout the year. If all the companies continue to pay their dividends, a steady stream of checks is hoped for.

The work for the client and advisor does not stop there however. Both parties then sit down and discuss how the portfolio should be viewed as to how its balance may move and how advisor and client should regard those moves. This means we review what the name "stock rental portfolio" means and why it was named such.

The idea of this portfolio sprouted from discussions with many investors who had rental properties and from an idea a portion of my own holdings gave me.

When I meet a client who has rental property, when queried with they liked about owning such rental property, they usually responded "the rent checks that come every month". When asked if they minded if their rental property dropped in value by 5% or so, the response also was, a common one: "not if I get the rent checks".

Since this mindset gave the property owner some sort of peace of mind, if a portfolio could be constructed in a similar fashion (furnishing dependable income checks every so often) and the investor could adopt the same mindset with this portfolio (not minding a possible reduction in over value), as long as the checks arrived the client would

be happy.

Although there are many facets in setting up such a portfolio as the "Rental Stock Portfolio" the strategy may be an option for those looking for income yet wish not to worry so much about moving balances. As with any portfolio based in the markets, there are risks and they are as follows:

Our weather source, who has been predicting the weather for the past 70 years, tells us this heat wave has happened before. He recalls extremely hot weather back in the 40's, the 70's and so on. He advises to hang in there and watch for an early fall as it approaches. Furthermore, he tells us to expect much cooler weather into September. We shall see and are looking forward to fall and better fishing.

The run of salmon is happening and we have reports of some being caught on the Feather River at this time. Several phone calls and a couple emails tell us not to expect fishing on the Sacramento to be all that great. My son Ted took the red boat out, dropped into the Feather River at the Yuba City Boat Ramp and got skunked, but did see a nice 19 pound salmon taken by another boat near him and his buddies.

As far as trout go the fish are hanging out in the deepest part of lakes and Reservoirs due to the three did get weather. As things cool off we can

expect the fish to come up from the depths a bit. Reports tell us trout fishing is slow at this time unless you fish at first light or close to dusk.

Keep in mind of the extremely hot weather we are sharing at this time and stay out of the heat from 1100 A.M. until 600 P.M. and don't forget the hat and the sun screen. Be sure to drink lots of water and avoid the beer and alcohol.

We advise to be extra cautious on the Feather River. Sandbars and shallow areas are all over the

place and some are only under the water in a foot or so. If you decide to go after salmon with a prop just be aware of the danger out there and the changes in the river.

The kokanee have finally gotten active at Lake Tahoe. They are being caught both at the North Shore and South Shore of the lake.

and prostitutes, plus a few great restaurants. And, then there was the Red Carpet Bookstore which provided ‘adult’ entertainment (porn films and magazines) before the Internet came about. The city council paid businesses in the target area tens of thousands of dollars each to leave. However, the ‘uptown’ Red Carpet Bookstore located out of the demozone also had to go because the council considered it ‘immoral’ or if not that, then seedy. Times have changed. Today, porn can be accessed for free on city library computers. And last week, two Marysville Planning Commissioners, David Hobbs and Beverly Hayes opposed a use permit for the River City Phoenix Medical Marijuana Dispensary on ‘moral grounds.’ Seven commissioners voted for the dispensary. This is the dispensary that funneled \$10,000 to Mayor Ricky Samayoa, \$5000 of which came right before the dispensary’s appeal hearing. River City Phoenix was disqualified for a permit for having a felon on their board of directors. A felon on the board was

a no-no. However, it was nothing a new squeaky clean board member and taking care of the mayor couldn’t mend. Marysville codes are like the Groucho Marx quip, “These are my principles, and if you don’t like them...well, I have others.” There is a code buffet. If you are favored then we’ll find a package to fit your business. Kind of like The ‘Lite’ Church, just 7 Commandments, you pick’em. Even folks annoyed by the smell of marijuana think that is no comparison to the stench at City Hall. Changing codes, altering zoning, redefining the definition of a park, violating the Brown Act, favoritism and bias, and pay-to-play, the dispensary Kabuki Dance is something to behold. The council probably celebrated with cake and punch when the Mc Donald’s restaurant remodel at 4th and E Streets eliminated the outdoor playground. That kids’ area was too close to the anointed dispensary and therefore standing in the way of progress, selling ‘bud.’ ‘Thank God those damn kids are gone so we won’t have to change the ordinance again.’ Or

did someone pay-off Mc Donald’s? Marysville government is allergic to kids. Years ago when youth advocates suggested using a windfall of recreational cash from Yuba County for a skate park, Mayor Bill Harris was concerned a park would draw a lot of kids to town. Don’t want that to happen. Today, we have the amphitheater for concerts in Yuba County where alcohol, drugs and weed are consumed and now we will have two pot vendors in the city. Yes, times have changed.

**Storms hit Texas crops**

The many impacts of Tropical Storm Harvey include damage to crops in southeastern Texas--including the cotton crop. American Farm Bureau market analysts say crop conditions "are likely to deteriorate" as a result of the storm. Texas leads the nation in cotton production, representing more than 40 percent of the U.S. crop. California ranks fifth, at about 5 percent, with most of its crop rated in excellent condition at last report.

**Report indicates smaller tomato harvest**

A new estimate shows the California tomato harvest coming in a little smaller than originally expected, and a little later than last year. The government report tracks pro-

cessing tomatoes--those used for ketchup, salsa and other products. The report says the tomato crop will be about two and a half percent smaller than first estimated. Spring rains, and summer heat, have affected the crop, with shipments running 22 percent slower than last year.

**Research focuses on strawberry improvements**

They need to deliver high-quality fruit year-round, and strawberry farmers also need to protect their crops from disease in the soil. New research projects aim to improve strawberry plants and the soil in which they grow. The University of California, Davis, will concentrate on disease-resistant plants, while UC Santa

Cruz focuses on how to combat soil-borne pathogens. California produces 91 percent of U.S.-grown strawberries, according to a new crop report.

**Study links avocado consumption, improved cognition**

Older adults who ate avocados showed increased memory, attention levels and processing speed, according to a new study. Scientists at Tufts University in Massachusetts say the improved cognition among study participants appears to be linked to a pigment within avocados called lutein. People in the study who ate avocados as part of a controlled diet had more lutein in their systems, and performed better in cognition tests.

## Two Sides to Every Story

I appreciate Mr. Mistler graciously allowing me to comment concerning the unverified allegations flying about me and the Sutter County District Attorney's Office. In so doing, I caution against jumping to conclusions. I encourage each reader to take the time to allow the facts to come out in the manner proscribed by law. I remind each reader that there are always two sides to every story.

I cannot compromise my ethical duty of confidentiality. I will not discuss personnel matters. The members of this community are no doubt aware that as a department head, I cannot violate the privacy rights of my employees, nor would I want to. The natural result is that you, the citizens, cannot know the facts at this time.

There are several facts that I can speak to and I want the members of this community to know. Leading an office is difficult. Traversing the myriad rules and regulations of county government is complicated. Being proud of the people serving in the Sutter County District Attorney's Office, however, is easy. I am privileged to work with men and women who are motivated, diligent, hard-working, and most of all, ethical. These are the standards that I expect of myself and of my staff.

When I presented the idea of a proactive sex

sting to my staff in the fall of 2015, I knew that I was asking a lot of them. I received an overwhelmingly positive response. DA employees have routinely volunteered for extra duties to support that operation. All of us, investigators, secretaries, and attorneys, put in an incredible amount of time and effort in the sting operation. And while making those arrests was a significant accomplishment, it was not the end for those cases. I learned early in my career that even the best arrest in the world does not amount to anything if the case is not adjudicated properly. We are still working these cases. The operation will not be completed until each case is closed. We are committed to ensuring justice in each case.

The Sutter County District Attorney's Office is unlike the Sheriff's Office and Yuba City Police Department. They respond to calls for assistance, investigate crimes and make arrests based upon probable cause. The Sutter County District Attorney's Office's duty is to "do justice." We are mainly a law office with the duty to prosecute violators of crime. To assist in this responsibility, we have an investigations unit and we also oversee the Victim's Services Program for our county. As the department head, it is my responsibility to budget the resources that our county supervisors have

approved, allowing us to accomplish our mission. Allocating these resources in line with our overriding mission requires hard choices.

Our children are our most precious gifts; they are a "heritage of the Lord." I am proud to be a mother of five children. They are my motivation to serve this community to the best of my ability. It is shameful that my children have been included in the allegations and rumors being tossed about. When did having a large family become a politically divisive issue in our community of strong values and fundamental rights? At what point does this society draw the line between right and wrong? It is vital that we educate ourselves about political issues, that we care about public safety, that we are vocal about liberty, and that we fight for democracy. It is foolish to make judgments without knowing the truth. Jesus cautioned against this very thing when He said, "Judge not, that ye be not judged."

George Bernard Shaw wisely urged, "Beware of false knowledge. It is more dangerous than ignorance." Truth. Integrity. Justice. These are easy words to throw out but they are more than that to prosecutors. These are the necessary tools of this job. These are the principles that we fight for.

The reproductive success of giant sequoias demands only that each tree produce just one maturing offspring over its lifespan of several thousand years." ### Emboldens Criminal Behavior

Killer of Sacramento Sheriff's Deputy had Lengthy Record and Was Wanted by Federal Authorities

According to authorities, Thomas Daniel Littlecloud fired multiple shots at officers who knocked on the front door and walls of a motel room in their search for a different parolee's room. Littlecloud struck and injured two CHP officers before he attempted to exit through the back balcony. Using a high powered assault rifle, he shot Sacramento Sheriff Deputy Robert "Bob" French, who died on the way to the hospital.

"Convicted criminals like Thomas Littlecloud should not have been allowed out on our streets," said former Chair of the Board of Parole Hearings Senator Jim Nielsen (R-Tehama). "State laws, court decisions and initiatives have turned the criminal justice system inside out."

Senator Nielsen added, "The lack of meaningful

penalties has emboldened career criminals like Littlecloud. This individual has been apprehended with firearms on multiple occasions."

Since the passage of Assembly Bill 109 and Propositions 36, 47 and 57, criminals like Littlecloud now face diminished to no consequences for their continued criminality.

Senator Nielsen and others have made many attempts to strengthen laws to protect police officers and the public.

The Democrat-controlled Legislature denied passage of his proposals to support public safety. Earlier this year, Senator Nielsen introduced Senate Bill 652 to change current law to require that felons with firearms would return to state prison if they had been previously convicted of a violent felony. Even this modest change was rejected in committee.

Unfortunately, the weakening of the state's criminal justice system

allowed for the release of convicted felons like cop-killer Littlecloud whose criminal record spans 14 years.

"Littlecloud's wide-ranging criminal behavior speaks for itself. Legislative acts, court decisions and initiatives facilitated this behavior," Senator Nielsen added.

## Court Makes It Easier for Local Government to Raise Taxes, Assessments & Fees

### on Homeowners

Court Makes it Easier for Local Government to Raise Taxes, Assessments & Fees on Homeowners

In a 5-2 decision, the California Supreme Court ruled that tax, assessment and fee increases proposed by citizens require only a simple majority vote, and that the stricter two-thirds vote requirement imposed by Proposition 218 only applies to government entities, not citizen initiatives.

"The court decision, if allowed to stand, will

mean higher housing costs as local governments partner with special interest groups to inflict more taxes, fees and assessments on homeowners," Senator Jim Nielsen (R-Tehama) said. "It should be harder to impose taxes on citizens, not easier."

The court case, California Cannabis Coalition v. City of Upland, was centered on a local initiative that would have repealed existing city ordinances in order to legalize and tax medical marijuana dis-

pensaries.

As one of the original proponents of Proposition 13 to protect homeowners from ever-increasing property taxes, Senator Nielsen condemned the high courts' decision.

"In passing Proposition 218, the voters imposed restraint on government from all local taxes, not just some. The majority on the Supreme Court was being creative in their interpretation of Proposition 218."

## The Battle of Feather River is Coming



Civil War Days are coming on September 23rd and 24th. Be sure to come for the Battle of the Feather River and allow plenty of time to stroll through the camp. Here is a glimpse of life in the camps.

**Infantry:** This is the backbone of any army and comprises the largest portion of an army. In short, the infantryman is a foot-soldier. He carries his weapon and gear with him as he marches from battle to battle. Equipment of the soldier will include his musket, bayonet, cartridge and cap box. You will also see the firing procedure and manual of arms used by the soldiers when operating muzzle-loading rifles. You will learn the different pieces of a soldier's uniform and how the differing insignias are read to indicate branch of service (infantry), regiment, company and more. You can learn the organization of the armies, north and south: what a regiment, a company and a brigade is: how many men and commanded by whom.

Equipment of the infantry camp; including how the soldiers slept, the kind of tents and how the quarters differed from enlisted man to officers. You can inspect

the regimental colors carried by the units and learn of their importance and background.

And of course the men that composed the armies. What were they're different ranks and duties that came with rank. Understand a little why did these men join up and what were they fighting for or against. Learn what the average soldier did to pass the seemingly endless boredom of camp and hear some of the popular songs of the time.

**Music:** Music was as important to the Civil War soldier as it is to modern soldiers. You can hear songs and stores common throughout the army camps, both north and south. You can hear and perhaps join-in the singing of tunes both poignant and humorous, of victory and defeat.

**Calvary:** These troops are mounted on horseback and are the fastest moving component of the army. Though able to put up a good fight, the cavalry was used mainly to search for the enemy and in-turn keep enemy scouts away and unable to detect their army's true location.

Equipment of the cavalryman. You will learn how the pistols, saber and

carbine rifle of the cavalry allowed them to fight hard yet move fast. You will see how the soldier and his horse worked together and the unique pieces of gear carried by the trooper's mount. Learn how the uniform of this branch of the army carries from the others ranging from the style of footwear to the yellow trim of the tunic and trousers. Hear about the tactics of the cavalry and how they varied from the other branches. Troopers could fight while still on horseback but mostly dismounted and fought on foot. Learn how the weapons issued to these men reflected this style of fighting. Hear where these fighting men came from and why Confederate cavalry was considered superior to Union troopers throughout much of the war.

Civil War Days is a local public event sponsored by FOCUS on Marysville and Mary Aaron Museum. Join your neighbors on Sept. 23rd and 24th. Camps open at 9:00am with two battles daily. Come travel back in time to the 1860's and relive an exciting part of our shared past.

# The 1955 Flood of Yuba City

The rain seemed to be a forever thing.....day after day; week after week it came down, heavy at times, but constantly there day and night. After the first couple of weeks people started to think about not days, not weeks but months of constant rain.

The rivers rose and kept rising. The levee patrols were on the job day and night. The radios were on whenever possible to hear a report of conditions with levees which surround Marysville and lie next to Yuba City. People began to worry with lots of folks

driving over the bridges to see for themselves what was happening.

After the rains came down and the rivers rising for a good part of a month the Marysville Authorities decided to evacuate the City of Marysville. Many evacuees came to Yuba City, including all new automobiles as well as used ones which were placed at the Yuba-Sutter Fairgrounds.

Both the Yuba and Feather Rivers had water lapping at the top of the levees and there were hot spots reported about boils in the levees and

seepage here and there. Yuba City residents stayed home. A call went out for volunteers to help at both the Marysville and Yuba City levees. An emergency office was set up in a store on Second Street in Yuba City and another on D Street in Marysville.

I decided to volunteer along with my Brother in Law and a best friend. We drove to the headquarters on Second Street in Yuba City around 7 p.m. on December 24th and they advised us to go to Marysville and report to the office there. On our arrival we were told to go to the D Street Bridge. Upon arrival a man, who seemed to be in command, told us to go down the levee upstream a couple of hundred yards and help with a levee problem at that location. The three of us jogged up and found a couple dozen men frantically throwing sand bags into the water. It was dark by then but we could see the swirl of water. We got in the chain line at the bottom of the dry side of the levee and could see the dirty water seeping out of the levee. Progress was not possible due to the fact that the sand bags thrown into the water were washed downstream from the swift current. At this point it was decided to build a dike on the opposite side of the river at the base of the levee and attempt to build a wall of sand bags to stop the levee from failing.

Lumber was needed as well as nails. It was decided to get what was needed from Union Lumber on B Street, so some of the guys took a flat-bed truck, broke into the lumber yard and returned with the lumber to start the wall. People were sawing boards by hand when a man appeared wearing an orange hard hat and yelled, “I have a chain saw, can I help?” It was believed that man saved the levee and the City of Marysville due to the speed the lumber was cut and the wall

was complete. As the sand bags were placed against the wooded structure and as the wall of bags got higher and higher the levee seepage slowed and at that time we knew the idea was working. We had stopped the levee from falling apart even though the seepage continued.

There were cheers and handshakes and back slapping when the wall was complete. However, within a minute or two word came down from the D Street Bridge that all men were needed immediately.

The river water had seeped under the approach to the D Street Bridge and there was fear the bridge itself would collapse from all the debris the raging water stored on the up-river side. A crane was brought in and made its way up and down the bridge picking up logs and junk and placing it on the downside of the river.

Suddenly there was a roar and water came rushing out of the asphalt roadway just below the bridge entrance. A gaping hole appeared with asphalt being thrown around like toys and the mighty Yuba River created a spout of water straight up in the air which would make Old Faithful in Yellowstone National Park look small in comparison. Sandbags thrown into the gaping hole in the pavement simply shot back at the workers.

As the water rushed down D Street someone in the crowd of soaking wet men decided to place a huge tarp over the hole. This feat was extremely difficult due to the pressure of the water as it shot straight up in the night air. We formed a human chain around the tarp and managed to keep most of it in place. Men were being washed away, falling and fighting the pressure of the water. Finally, with enough men holding down the tarp another bunch of workers began a chain of

bodies to hand the sandbags from the trucks to the site.

Once during the building of the “chimney” one side of the sandbags began to shift. I was on that side and felt the bags move. People were yelling to get out of the area and to get away from the section which was giving away. Men and machines were running and driving away in a mad rush as the wall stopped moving and police whistles were hear above the commotion. We heard yells of “It stopped! Come back! It stopped!”

Everyone returned and we completed the walls around the hole in the pavement. As soon as the water inside the new levee of sandbags, making a complete circle around the hole stabilized, we all knew we had once again stopped the Yuba River from flooding Marysville. People were yelling and laughing, slapping each other on the back and some men were actually hugging each other.

Most of us had returned to the top of the levee when the word came down via a sailor with a walkie talkie that the levee had broken at the Nut Tree on Garden Highway in Yuba City. All of us from Yuba City immediately headed home. Driving thought Marysville and across the 10th Street Bridge was strange due to the city being dark and uninhabited.

By the time I got a few things together and my wife also had the car packed we headed

north towards Gridley. As I turned onto Plumas Street a block away from Colusa Highway we could hear the screams coming from the gas stations as people fought for gasoline. Then the roar coming from down south along with the yelling and noises of crunching sounds filled our ears as we made our exit north on Live Oak Highway.

Over 30 people lost their lives that Christmas Eve night back in 1955. The wall of water which hit south Yuba City was 18 feet high and houses were ripped from their foundations with some hanging off of railroad levees and others on top of each other. People were rescued hanging onto tree tops. Some managed to spend the night on the roof of a house. I find it amazing that more human life was not lost that night.

There is a City Park located in South Yuba City off of Garden Highway. It is named Blackburn Talley Park in honor and in memory of Undersheriff Blackburn and Sutter County Deputy Talley who lost their lives racing through the night warning people to wake up and get out of the area. Their patrol car was located near the Park after the waters receded and was covered with river bottom silt, sand and debris. Rescuers had to cut open the roof of the patrol car to remove their bodies.

We cannot ever allow this disaster to happen again.

A man is fired for not disclosing a preexisting condition and following the disgruntled employee handbook sets out to rob a vault. Enlisting the help of his family and a few morally upright neighbors a tale of Southern charm and dedication unfolds.

There is some fine acting in this film. Daniel Craig (The latest James Bond.) and Adam Driver (Kyro Ren from the new Star Wars series.) are great with Southern accents. The story moves along at a slow pace that is off putting at first, but grows on you over time.

Logan Lucky, earns four out of five, Explosive Device Catching Monkeys. This is a fun film worth a trip to see in the big movie house. The Game of Thrones reference is worth the price of admission alone. It is more subtle than most heist movies and while a tad quirky at times it has nice character and plot development.

To enhance security at the Rideout Regional Medical Center, the Department of Security will introduce a new Fast-Pass visitor identification system.

The FAST-PASS visitor identification system will be used for a quick, welcoming reception by our security staff and greeters when visitors arrive at the Main Lobby of Rideout Regional Medical Center or the Rideout Emergency Department.

All visitors will have their Photo ID (such as a driver's license, or identification card) scanned and will have a picture taken. This quick process takes less than a minute and will print out a temporary paper badge containing the visitor's picture, destination, and date.
