### Yuba Co. Pot Chaos Life Threatening

A turkey hunter chasing a wounded bird was confronted by men with long guns and informed that if he crossed onto their property again he would not fare well. The property is at 10874 Marysville Road, Dobbins and owned by BBNR LLC, Lance Bates, Adam Bates, Mary Bates and Scott Bates.

What would cause someone to be so inhospitable to a hunter just trying to retrieve his game? They were protecting a major marijuana growing operation on 429 acres once known as the Middlebrook Ranch. (See Google photo here) Confirmation that the plants were marijuana was made by conversations with those who had access to the property.

Since 1996 and the passage of Proposition 215, The Compassionate Use Act, allowing the use of medical cannabis, counties and cities have wrestled with ordinances to comply with the new law. Yuba County has tried a couple different approaches. The latest forbids any outdoor growing.

However, hundreds and possibly thousands of marijuana entrepreneurs are ignoring the ordinance, permits, fees, and their neighbors in Yuba Co. In fact, Buck Weckman, who founded Yuba County FACT (Families against Cannabis Trafficking) 5 years ago, says the problem of illegal pot growing has increased and become even more dangerous particularly for hill residents.

The shooting of two Yuba County sheriff deputies, Phillip Bronson and Andrew Everhart last week by an armed felon with warrants employed by the Rastafarian Church may have been a tipping point for many hill citizens. 'Church' leaders Heidi Grossman and Eddy Lepp have been in an ongoing legal scrap with the county over their illegal pot operation in Oregon House.


In spite of Grossman's history of crass and profanity laced threats posted on the Internet against the sheriff's department, on August 1st she called for help protecting her illegal marijuana from an irate employee. Deputies were fired upon after entering a home where the resident denied the presence of the perpetrator.

The irony of law enforcement put in harms way by a hateful lawless citizen to protect her illegal operation and then deputies being deceived and led into a death trap by a second citizen is disgusting in its lack of respect for authority and for fellow human beings.

Yuba County hill residents are angry and fearful at what they perceive as the inability of the government to protect life and property. The founding fathers believed the role of government was to protect from foreign invaders and from those in our midst who would infringe upon our liberty.

Government has taken on many roles like handing out condoms, welfare, cautioning about hot weather, taxing everything and restricting what we eat and drink, none of which are in the constitution. If the county cannot protect the life and property of Yuba Co residents it has lost its mandate to govern.

Yuba County is using 4-code enforcement officers to respond to all kinds of complaints. There currently are 700 open cases 10% of which are marijuana complaints. Kevin Mallen, Director of Community Services, was surprised at how few calls they get for

marijuana grow issues, but citizens say that many people now are afraid to complain or don't see any results.

Mallen said that normally 2 of the 4 code enforcers are assigned to the marijuana complaints but lately all four have been focused mainly on the homeless problem. Even though marijuana farms are protected with armed security people, code enforcement officers go out with only body armor and a pen and paper. Many residents believe the marijuana grows are a law enforcement problem and we need to declare a state of emergency and ask for federal intervention.

Mallen said grows on private property are more cumbersome to address versus grows on public property like the recent Bullard Bar Dam eradication of 3,500 plant and 500 lbs. of refuse. The private property dilemma seems to be whether the illegal grows are going to be considered a matter for criminal versus code enforcement. It is complicated, cumbersome and ineffective.

People violating codes and/or laws are afforded due process. However, the neighbors of these marijuana businesses want law-breakers cleared out and the problem solved. Good people are growing weary and may choose to relocate rather than wait for government to do its job.

### Union Goes for Nail in County Coffin

Though politicians created the pension and health care crisis in California they all fault someone else. It's like the 40-year smoker who has lung cancer and now blames the tobacco company and society for not warning him.

There is even a term for the evolving condition of cities and counties, service insolvency. That is where the jurisdiction is still paying bills, payroll, pensions and health but that's it. There is little or nothing left for services.

As a city manager was once said, California cities have become pension providers that offer a few public services on the side. It's a corrupted system when local governments exist to do little more than pay the people employed there.

Wherever unions have dominate, industries crum-

ble under the weight of health and pension benefits. Before the bail-out General Motors had become a health and welfare business, no longer a competitive car company. Everyone remembers the pastry icon Hostess Twinkies, once a victim of Bakers Union greed. The nonunion private sector bought the brand and heavenly recipe out of bankruptcy and the tasty treat returned to the shelves.

Not surprisingly, the union-dominated Legislature has been of little help to local officials dealing with such fiscal troubles. The state pension systems have run up unfunded liabilities, or debts, ranging from \$374 billion to \$1 trillion (depending on the financial assumptions one makes). Regardless, legislators

### Two Deputies Shot In Oregon House

Deputies Condition Upgraded to Good

Marysville, Ca.

On the morning of August 1, 2017 the Yuba County Sheriff's Department received a call about the Rastafarian Church in the 9000 block of Marysville Rd., Oregon House. The complainant Sugarleaf Rastafarian Church leader Heidi Lepp said she received a call from church members who live on the marijuana farm saying a newly arrived worker had become erratic, was ripping up plants and holding a gun. Lepp said she called the sheriff's office and told the men on the farm to leave immediately. Upon arrival the two deputies responding pursued a suspect, matching the description they were given, into a mobile home. As they were clearing the home they were met with gunfire, both were hit twice, and returned gunfire. While unknown at the time it was believed that they hit the suspect. The two deputies, Phillip Bronson, 14 years with Yuba County Sheriff's Office (YCSO) and Andrew Everhart, 10 years with (YCSO), were dragged to safety by a third deputy, Daniel Harris, 22 years with (YCSO), who had been watching the back of the home. Harris called for officer down and backup. The two deputies were flown to Sutter Roseville where they underwent extensive surgery.

Multiple Yuba County Deputies, SWAT team members, Detectives, and Hostage Negotiators responded to the scene, along with many neighboring law enforcement officers and other first responders. Nearby residences were evacuated, a perimeter was established, and attempts to communicate with the barricaded suspect were initiated. Just before 2pm, SWAT personnel deployed diversionary devices into the home followed by tear-gas deployment, and then entered into the residence. Once inside, SWAT members located the suspect and determined the suspect was deceased and had suffered multiple gunshot wounds.

The suspect was later identified as Mark Anthony Sanchez, 33, originally of Gilroy, Ca. It is believed that Sanchez was living and working as a caretaker at the marijuana garden. Sanchez was a previously convicted felon that had served time in California State Prison for multiple violent felonies including carjacking and assault with a deadly weapon, as well as burglary and possession of stolen property. It was also discovered that Sanchez had two active warrants out of Gilroy for Robbery and Disturbing the Peace at the time of his death.

An autopsy was completed the morning of August 3 and the official cause of death was listed as "multiple gunshot wounds". Official manner of death is pending conclusion of the shooting investigation, however it was determined that the suspect was struck multiple times by return gunfire from the two injured deputies. It is not conclusive at this time whether the fatal shot was self inflicted or the return fire from the deputies.

The two wounded deputies are still recovering and their condition has been upgraded from Fair to Good

### **Last Chance for Spillway Claims**

The Oroville Mercury Register is reporting there are only a handful claims relating to the Oroville Dam Spillways disaster. Risa Johnson told Agenda 21 Radio in an interview July 29, 2017, residents who feel they were harmed have until August 11, 2017 to file a claim. Residents who are considering a law suit at a later date must according to California law file a claim within the 6 month time frame prescribed by the state.

Residents have until Aug. 11, six months from the declaration of a state emergency, to file in order to be eligible to receive compensation for their losses from the government. form can be completed online or mailed in and costs \$25 to process. Several affected cities and counties have also filed claims of their own, including the city of Oroasked for ville, which about \$1 million.

Residents forced to flee their homes and drop work in February because of the Oroville Dam emergency should file a claim with the state government soon in order to have a chance at getting reimbursed.

Residents can file up to Aug. 11, six months from the declaration of a state emergency when than more 188,000 residents downstream were forced to evacuate for fear of spillway collapse Feb. 12. The form can be completed online or mailed in. There is a \$25 processing fee, though residents who are incarcerated, have a monthly income lower than the poverty line, or are receiving federal assistance such as food stamps or supplemental security income may apply for a fee waiver. The form also states the filing fee will likely be waived if the claim is accepted.

A check with all the activity down in the bay area, specifically around the Golden Gate, in regards to salmon fishing is true. Our source advised it appeared like every boat and angler from the western United States had appeared for the outstanding salmon bite. He further stated the wait time to launch his boat was over two hours and taking it out was not much faster.

Meanwhile, outside the Golder Gate still has salmon everywhere with all anglers putting fish in their boats. Limits of fish were the ticket last week from San Francisco, Sausalito, Berkeley and Emeryville. In fact, as our report stated, boats were limiting out and returning early. Average size was 12 to 25 pounds.

We hear from Lake Tahoe. The big Mackinaw lake trout are being caught at this time. Reports tell us some of the fish caught are in the 15 to 18 pound range. Now that is a huge trout by anyone's standards!

### **Bears Finish Season Strong**



Place draftguards beneath doors to ensure that all doors to the outside close tightly. Do not keep doors or unscreened windows open. especially if people are sleeping. Evacuate any room with a live bat and close the door".

Farm bill session to be held in Modesto

As part of its work to shape new federal farm legislation, the House Agriculture Committee will hold a listening session in Modesto this week. The Saturday session will gather comments from farmers, ranchers and other interested people. Congress plans to write a new farm bill next year, authorizing programs on conservation, research, nutrition and other aspects of agricultural and food policy.

### Proponents write new water bond measures

Drought remains on Californians' minds de-

pening Ceremonies Friday at Noon spite this season's wet winter, and as many as four new bond proposals address continuing efforts to improve the state's water system. Two of the proposals have been created in the state Legislature. The other two would need to qualify via signature drives. Each aims for the 2018 statewide ballot, and could build on the Proposition 1 water bond voters passed in 2014.

### Tomato harvest picks up speed

They've faced challenges this season, and farmers who grow processing tomatoes say their harvest has gotten off to a slow but good start. Spring rains delayed tomato planting, then heat waves during the growing season further affected the crop. Farmers say their harvests have been starting later than they did last year. California leads the nation in production of processing tomatoes, which go into salsa, ketchup and other products.

### Rice agreement opens new markets

The promise of new markets in China encourages California rice farmers. A trade agreement allows American rice to enter China, and California farmers say they may be uniquely suited to fit the market. For one thing, California is much closer to China than other rice-growing regions of the U.S. In addition, California farms specialize in growing high-quality, mediumgrain rice that could fill a market niche in China.

In May, I received a notice in my AT&T bill that mandated I would have to allow an AT&T technician to install new network equipment on my premises or, if I didn't allow them to do so, my phone service "may" be disconnected. Since there are no other landline providers in our area, which is very rural, this gives us no choice but to accept their changes to our residential service agreement and the notice comes across as a definite threat to our security and well-being that such a monopoly can achieve. There was also no explanation as to the purpose of the new network equipment and how it would benefit AT&T customers.

When I read the Territorial's July 26th article titled "AT&T Is Stealing Our Landlines", I began to wonder if there was connection between the notice in my bill and AT&T's desire to get rid of their landline service

in our areas. I called the

Federal Communications Commission (FCC) and registered a complaint. They forwarded my complaint to the California Public Utilities Commission, where Mr. Rvan Yamamoto, in the Division of Safety & Enforcement, responded by calling me. He asked several questions and requested a copy of the AT&T notice, which I sent. I also called AT&T and asked if their proposed updated equipment included improved cell phone service in our area. They said no. However, I do believe that it is AT&T's long-range intent to abandon its landlines in our areas and turn the telephone poles into cell towers. If so, such cell service must be deter-

mined to be 100% reliable in all areas before landlines will be abandoned. There are thousands of vulnerable residents in the foothills that rely on landline phone service, especially in the case of

emergencies. Many cell

phones do not function

well up here. So what happens in an emergency if the phone doesn't work? Those with cell phones have to drive all over town or down the hill in order to find a spot where they can get a signal. Who has time to do that if someone is having a heart attack or their house is on fire?

There are laws in this country that are intended to protect the people from such high-handed conglomerates like AT&T that can monopolize our phone service to the peril of its customers. Please encourage the CPUC to investigate thoroughly AT&T's actions before it is too late! Write or call:



have avoided meaningful pension reform. They owe their soul to the unions. This has forced local governments to cut back services or raise taxes to meet their ever-increasing payments to California's pension funds.

Now, union legislators have introduced Assembly Bill 1250 to gain complete control over local government. AB1250 would essentially stop county governments from outsourcing services (financial, economic, accounting, engineering, legal, etc.), which is a strategic way for counties to survive these

The legislation originally also applied to cities, but was dialed back. It now applies to all 58 counties except for San Francisco (which is exempt because it also is a city) and the authors plan to exempt Santa Clara County because of a hospital contract. Cities

this move is successful.

The bill is sponsored by the Service Employees International Union (SEIU) and authored by Assemblyman Reginald Byron Jones-Sawyer, a Los Angeles Democrat who previously was an SEIU vice president. It's a brazen blitz to force county governments to spike the size of their full-time, unionized workforce. Ultimately, the bill sees county governments as employment agencies rather than service providers.

The bill removes the autonomy of local citizens and their supervisors to make the appropriate decisions regarding the financial benefits of outsourcing. Counties were not intended to provide cushy employment-tograve benefits but were created to serve the citizens. Does anyone recall those days?

An analysis for the counties by the Oakland law firm Jarvis Fay Doporto & Gibson conclud-

ed that the latest version of the bill "will substantially increase the cost for delivery of county services and substantially decrease delivery of county services - including critical public health and safety services." Counties will be forced to pare back services "to offset increased pension and benefit costs." Small and rural communities in particular like Yuba-Sutter will face service

reductions. Although government outsourcing tasks to private companies usually saves huge sums of money while providing a more effective service this bill makes it nearly impossible with all the new rules and paperwork. Also, many companies may choose not to do government work due to the nonsense created to shut private enterprises out.





"Karen and Jim are an integral part of our Fair's agriculture community," said Rea Callender, Fairgrounds CEO. "They have dedicated countless hours to youth and Nevada County agriculture, and we are grateful for their service."

# Colusa County Cameos by Carol Withington



#### **COLUSA**

The early beginnings of the community of Colusa can be traced back to the mid 1840s. According to research, Dr. Robert Semple of Benicia stopped briefly at the Rancheria of the Colusi Indians during a return trip. It is said that Dr. Semple was so impressed with the beauty of the area along with its fertile soil that he inquired as to who owned the land. He was told it was John Bidwell, who obtained it under a Mexican Grant.

When his brother Colonel Charles Semple arrived in California in 1849, Dr. Semple informed him about the Rancheria. The Colonel soon after located Bidwell and the purchase was made.

In the early 1850s,, Colonel Semple, accompanied with a small group, arrived to the area by steamboat. It appears they miscalculated their landing and ended up seven miles past the Rancheria. Realizing their mistake, they moved on down the river where they eventually built a "crude" hotel, surveyed the streets and a new town was born.

Witnessing this event was William Semple Green, the 17-year-old nephew of the Colonel, who would later become one of the most prominent citizens of the area.

During this time, both the county and town were named Colusi, derived from the name of the Coru Indian tribe who lived along the Sacramento River during the 1840s. Some sources relate that the Coru Indians came to be known as the "Colus" by the French explorers because of a "twisted" pronunciation. Whatever the case may be, both the county and town names were changed to Colusa in 1854 by an act of the

California Legislature. Monroeville was the first county seat, but in November of 1853, it was moved to Colusi. That same year, the first official jail and courtroom were built on Market Street. A hall of records, a town hall and county hospital would later be added in the years to come.

Due to its location on the Sacramento Pacific Railroad, the town of Colusa began to flourish. In 1861, a post office was established with J. Hop Woods, owner of the Colusa Drug Store, serving as postmaster. Although Colusa was

largely dependent on its grain fields and fruit orchards and other agriculture, the community also boasted of a Canning, Drying and Packing Company along with a foundry and machine shop which manufactured plows, wagons, buggies, traction engines and agricultural implements.

Other businesses included a marble works, two cigar factories and a flour mill. In addition, the Colusa County Bank was considered "one of the most prosperous and soundly conducted interior banks" in California. Incorporated in 1886,

Colusa embraced all the major businesses needed for its community. There were general merchandise and clothing stores, drug stores, books and stationery stores, along with jewelry and millinery businesses. Hotels and restaurants were also among the many establishments.

In addition, physicians, dentists, attorneys and building contractors were all available to meet the needs of the citizenry. There was also a grammar school, a high school and a parochial school of the Catholic Church. Other churches included the M.E. Church South, the Christian and the Presbyterian.

The Colusa Gas Company incorporated March 5, 1886, supplied the town with its first illumination on March 31. The capacity of the works was said to be sufficient enough for a town of 10,000 inhabitants.

The community also included the Daily and Weekly Sun, the Herald weekly and the Gazette daily newspapers. However, it was the Colusa Sun which come into the forefront over the years. Thanks to William Semple Green, its editor and publisher, this newspaper was the "voice of Colusa County" for over forty years. Green, also known as the "father of irrigation" in California was self-educated. However, he became an author of the history of Colusa County as well as the entire state.

Green was also a United States Surveyor during President Cleveland's administration. even considered him a "hero" of the county-quite a compliment for one of the founders of the town of Colusa who first arrived on a steamboat at the age of 17.
