# The 18th Annual Marysville Peach Festival

The City of Marysville will once again welcome more than 25,000 locals and visitors as the historic town hosts the 18th Annual Marysville Peach Festival, July 14 and 15 this summer. Admission -- and parking -- for this blocks-long street fair is free.

Marysville, once the third largest city in California when it was the gateway to the gold fields, enjoyed a second Gold Rush a century later when it produced half of all the canned peaches in the world. The golden fruit is still grown in its many varieties, by local family farms and larger companies alike.

What began as a small street event in 1999, is now a two-day festival known around and beyond California, featuring ever more inventive ways for visitors to savor the flavor of the luscious fruit. Fresh peaches, peach ice cream, cobblers and pies, shakes and smoothies, candies, sodas, peach-basted barbecue are just a few of the foods that will be offered. Other vendors will be displaying non-edible peach products, and there will be a variety of peachy games, rides and children's amusements.

Live entertainment on the Festival Stage at 6th and D Streets will include performances by

Guilty Again, The Ray Allen Band, and Tijuana Taxi. The seventh annual Tasty Treat Challenge at St. John's, 8th and D Streets, will showcase pies, pastries and preserves with entry fees for competitors going to benefit the local community food and clothing program Loaves & Britches.

Returning to the festival this year, the Miss Peach Festival All Natural "inner beauty" pageant.

Also scheduled: a peaches and pancake breakfast and 5K Run/Walk, on Saturday morning.

# Homeless Woes Worsen

A town hall meeting last week in Sutter County Supervisor Matt Conant's district attracted some angry constituents. Homeless people living along the river are vandalizing businesses on Burns Drive and causing havoc in the Shanghai Bend subdivision. Conant's constituents came and left frustrated and confused about what is being done.

County Administrator Scott Mitnick was there, but his mind was in Thousand Oaks, Ventura County, where he resides. He repeatedly inserted 'Thousand Oaks' when referring to Yuba City / Sutter County. Mitnick joins a growing number of county and city administrators and employees that are good enough to get the job here but too good to live here. It's getting old.

Mitnick instructed the sheriff's department to not cite or arrest

the homeless but shew them into the river bottoms until he comesup with a plan. One lady interviewed by KCRA News said she had been residing in her camp along the river for 7 years. She said she liked living down there.

It's amazing when people feel entitled to live wherever they wish even when the property doesn't belong to them. There are limits though. Yuba County District Attorney Pat McGrath sent a lady to prison that moved her family into a fully furnished Olivehurst home while the owner was away. A 'meth' perspective convinced the inmate that if she claimed the house then it was hers. McGrath didn't see it that way.

Hundreds of thousands of Sutter County dollars have already been spent for hotel rooms to cure homelessness and cleaning-up the river bottom area only to have it trashed once again. Neither Sutter nor Yuba County leaders have discovered how to get these 'victims' to pick-up after themselves.

Mitnick, consultants and the supervisors will jump off the same cliff Yuba County did, but of course they will spend more money and kick it up a notch. Rumors are flying about sacrificing the newly renovated Sutter County Sheriffs Training Center along the airport to add yet another shelter.

How many shelters will it take until social service workers do their miracle to empty them? Since we have been funding these county departments for more than a hundred years just what have they been up to until now?

# The Pension Heist

Yuba-Sutter and its cities are going broke from pension and health care debt while the general funds are depleted to bail-out a corrupt, flawed and horribly managed California Public Employees Retirement System (CalPERS). CalSTRS for teachers has the same terminal condition.

Yuba County Administrator Robert Bendorf's latest suggestion to add a 1% sales tax for an employee benefit bail-out is like the SF Giants correcting their lousy play by raising ticket prices. The state pension system is an insult and a rip-off to private sector workers and other taxpayers paying for it.

Citizens are sick of being shafted by self-dealing politicians who run short of money for infrastructure and public services and then dump the responsibility back on the citizens. When local government employees make \$100,000 to over \$400,000 annually, continue to get most of it in retirement, and then suggest raising taxes with a straight face there is a seared conscience.

Both counties' supervisors provided fantastic increases in wages and employee benefits when they were rolling in money due to the construction boom and the dot.com bubble in the early 2000's. Yuba County Supervisors were so euphoric they nearly doubled their own pay/benefits to \$80,000 annually. They took credit for the boom, but blamed others for the eventual bust.

Yuba County not only increased employee pay but did so retroactive to the date of hire spiking some long-time employee income by thousands a month. Of course, those increases carried on into guaranteed pensions.

Sutter County Supervisors raised the pension percentage from 2% to 2.7% in August 2004. In 2001, there was a \$28,707,894 surplus in the county's retirement fund. Today, there is a debt of \$150 million according to Auditor-Controller Nathan Black.

If CalPERS earns 3.25 percent on investments using 2015 figures every Yuba County household owes \$14,490 each to pay-off the pension debt. However, CalPERS earned just 2.4 percent in 2014-15 and 0.6 percent in 2015-16. If the system is not earning more than 7.5% all jurisdictions must make supplemental payments to the fund. Taxpayers were lied to, deceived and defrauded by local and state politicians.

Yuba County is in poorer shape than other local jurisdictions. Sutter County owes \$7493 per household, Yuba City \$9676 and Marysville \$9113.

When thinking about CalPERS being trusted with the publics' pension money versus the private sector think about the alphabet soup of government agencies. Which one is well-managed?

# **Former Yuba City Bears Player Charged**

Yuba City, Ca. Yuba Sutter Community Baseball has just been informed of the allegations regarding former Yuba City Bears pitcher, Tyler Minton. As an organization, we have a 'notolerance' policy against

The allegation and charge of rape stems from an incident in February. Twenty-year old Tyler Minton has been released on his own recognizance and is not scheduled for his first court appearance until August 2nd.

allegations such as this.

"It is a major disappointment to me personally, and my two daughters who think the world of Ty. It is very hard to

comprehend that he would do something like this; but none of us were there to witness the crime. We as an organization just recently became aware of this as it surfaced in the community. At that point in time, he had already been released from the team. If the allegations are true, our heart goes out to the family. Either way, multiple reputations have been damaged." says VP/GM Michael Mink.

"I have never had any issues or concerns with Mr. Minton. It's troubling all the way around; if it finds to be true, it's a terrible situation -- and if it isn't -- someone's reputation has been ruined."

says Bears Head Coach, Jeramy Gillen.

As we are aware, this incident occurred in February of 2017, and because there was no information or charges pressed, Minton was signed to play for the Bears.

Minton was released from the Yuba City Bears on June 22 following an arm injury, and officially pulled off of the roster. During the game against the Lincoln Potters, he went 0.1 with 5 runs, 5 earned runs, 2 hits, 3

walks, and 0 strikeouts. We would like to reiterate that the Yuba City Bears Baseball Club and Yuba Sutter Community Baseball have a 'no-tolerance' policy on matters such as this, had we known about these prior allegations, the actions that we took with this player would have been drastically different.

Our thoughts are with the victims of these allegations.

# FISHIN' TALK

We had several inquiries the past couple of weeks about fishing in the local rivers. One question, asked by two new neighbors to our areas pertained to what is available to fish for when the runs, such as striper, shad and the upcoming opening of salmon season on July 16th end. The first phone call

last week was about the end of the striper run. I advised there were what we call resident striped bass in the Feather River year round. All an angler needs to do is find where they hang out. We also talked about small mouth bass and advised these fish can be found in parts of the river which give them cover and security. You will find them in deep holes, in debris along the banks, such as fallen trees and old tree stumps under the water and in quiet areas under cut banks where the current slows down or where then can swim from cover and grab food as it passes

The second message came into my email basket and was asking about catfish. I advised that catfish make their homes in all the local rivers. The channel cat is the most abundant but there are other species as well, such as the bullhead and so on. Feeder streams or ditches usually will hold catfish as well as the feisty crappie. These fish, along with the bass will find food and still water in any water which flows into any river.

Another local fish which stays in the river system year round is the Sacramento Pike or also known as a Squawfish. These fish are scavengers and feed off the bottom of the rivers. They also feed on fish eggs, also called roe and according to studies by the California Department of Fish and Wildlife they eat a tremendous amount of striped bass and salmon eggs which includes sturgeon roe. The Department says we should kill those we catch. The only problem with this rule is striped bass, catfish and other species also feed on fish eggs. In fact, we have been catching trout in streams on salmon eggs and steelhead on roe (which is another species of the trout familv which move into river each year) for as long as I can remember.

The Shad run also brings in these ocean

fish and usually happens around the last of April or into May. I was taught that when the cottonwood puffs fall from the trees and can be seen floating on the surface of the water this means the shad are here or about to come on strong.

It is important to advise new people in the Yuba Sutter area who fish just how lucky we are to have so many rivers, streams, lakes and reservoirs available for catching fish and to tell them where to go, what kind of bait to use and what species of fish are in the water. After all, strength comes in numbers. We need all the support we can get when it comes to new fishing regulations we do not agree with or consider ridiculous.

Closing thought: "If you know you can do better.....then do better."

# Long Bar (Part 3)

Browns Valley, Ca.

As life continued into the 1860's on the wild North banks of the Yuba River, people were born, got married, made their fortune or not, and eventually died as Jacob Hoss did, never making it back home. People were now able to cross the river from

Long Bar to Kennebec Bar on the South side on a ferry which had been built in 1850. A Post Office had opened on April18, 1854. Originally known as the Dry Creek Post Office it became the Long Bar Post Office on April 9, 1858 and was discontinued on June 22, 1864. Sometime in

the early 1850's a grammar school was established though the original location is uncertain. By 1879 the school had 17 children in the district, 14 of which attended the school. A male teacher earned \$82 yearly and a female earned \$67.

Hydraulic mining was looked to as a solution for finding gold as it was becoming ever more elusive. Five miles of ditches brought water from Dry Creek to Long Bar since to mine hydraulically depended on a steady supply of water. No restrictions on water use existed. It was viewed as akin to air, anyone could use as much of it as he liked. Miners and investors gave little thought as to what was happening downstream when massive streams of water shot through giant hoses at hills and riverbanks deposited silt, gravel, and even whole trees downstream.

Miners, worried about the increasing difficulty of making a living finding gold, had short fuses and riled easily. The headline of the Marysville Appeal for December 11, 1860 says "Murder In A Dance Hall". Dutch John was knifed to death at Long Bar, "he died quickly, his only weapon his fists". The article expressed puzzlement at the behavior of Long Bar residents, that " they allowed the perpetrator (Everett) to escape was very strange and discreditable. A very small exertion of manliness would have sufficed to prevent his escape." Sheriff Middleton of Butte County arrested Everett three days later in Chico. He was brought to Oroville for the murder of Hungarian John (some confusion on nationality!), on to Marysville and finally to proceedings at Long Bar. He was described as" young and prepossessing in appearance and looks but little like a man who would perpetrate so dreadful a deed."

Justice was swift; he was

sentenced to die. Possibly the towns, farms and ranches, and mining bars would have survived the hydraulic debris longer if it had not been for the massive storms of 1861-1862. Beginning in mid December it rained for 43 days. What is now called an atmospheric river was followed by a modern day pineapple express. 100 Chinese miners drowned at Long Bar and Owsley's Bar. Nearly all the bridges on the Yuba were swept away, thousands of head of livestock were lost. houses and towns broken up and sent tumbling down river. Both Marysville and Yuba City flood ed. William Brewer writing in the Scientific American describes a great sheet of brown rippling water extending from the Coast Range to the Sierras. Called a megaflood, the muddy silt filled water remained in Sacramento, Marysville, and Yuba City up to three months. Thousands of people lost their lives in the Central Valley. Interestingly, few Native Americans died. The Indians living along the banks of the rivers moved to higher ground a week before the rain began after warning the "whites" that water was coming as "high as the trees".



Too late for change?

When is it too late to change and when is it time

Change is part of the universe and there are many things we are capable of changing.

First to mind might be to change clothes, our hairstyle or diet. Next could be a change in attitude or the proverbial changing of our mindset. The list is endless of the things we can change and the same would go for the things we cannot ad infinitum.

The important changes in our lives are sometimes easy and sometimes difficult but the hardest part of change is realizing the need to.

Sometimes small corrections in direction or speed might do the trick when negotiating the roads, waterways or skyways if piloting a vehicle of some sort. Changes that address addictions can make for a happier and healthier life. Changes in lifestyle, career, residency or peer groups may make for better outcomes in the long run. Again the list is endless as are the positives from making such change.

Realizing there is need for change is step one. Regardless of what you think you need, like, require or are addicted to, taking a step backwards and being honest with yourself and your particular situation is required in order to change.

Unfortunately there are things in life that cannot be undone as that is the way the world works. Some things are permanent. You just can't go back and undo them.

But I am of the belief, no matter whether it's financial, personal, medical or what have you, the willingness to change does yield some kind of result, even if it's just the improving the self-respect of the individual making that change.

Regardless of whether it's early, right on time or even very late, the saying "it's never too late to change" may be a concept we should grasp tightly and never let go.

It brings to mind something I heard once somewhere: "God, grant me the serenity to accept the things I cannot change, the courage to change the things I can, and the wisdom to know the difference" (Reinhold Niebuhr (1892-1971).

Being a financial columnist, I will sum this up by saying it is never too late to change investing strategies. And it goes without saying, the longer the wait to make a change, the more money you will likely lose.



# Homeless Woes Worsen

The Second Street area in Yuba City is already in chaos between the homeless running amuck along the levee and the controversy with the airport being out of compliance with the FAA (Federal Aviation Administration). Twin Cities Rod and Gun Club is now paying \$338 / month versus \$10 annually for its range to help the county follow FAA rules. All the while, the club faces ongoing vandalism and members report illegally parked recreational vehicles now residing adjacent to them and the airport.

How will this all turn out? George Mason University Economics Professor Walter Williams says whatever is subsidized will grow and whatever is taxed will shrink. Poster cities for this approach are San Francisco (SF) and Los Angeles (LA) where the spending on the homeless has spiked along with the street people population.

SF spent \$241 million in 2015-16, \$275 million in 2016-17 and \$305 million in 2017-18 to 'conquer' homelessness. But in 2016 the liberal San Francisco Chronicle ran a front page editorial declaring the city's efforts a failure.

The number of SF

homeless on an average night was estimated at about 7,500 in January 2015. By late 2016, city officials' estimate was up to about 10,000, with some homeless advocates saying the number was closer to 12,000. The Chronicle's editorial took the side of those who argue that these numbers were on the low side.

LA budgeted \$100 million for 2015-16 and \$138 million in 2016-17. In 2016, voters approved \$1.2 billion in bonds to build houses for homeless. However, in spite of the generosity with the public's money, the average number of those homeless on any night according to city tracking has gone up by nearly two-thirds. In 2015, the average number was 21,338. In 2016, it was 28,464. In 2017, so far the number has grown by 18 percent to 34,189.

For those Yuba-Sutter law-abiding citizens who pay for services, they see their community overrun while law enforcement stands down. No longer can you walk, fish, or bike the river. The region has been surrendered to people packing weapons and under the influence of drugs, drink, and demons. Meanwhile, most of the city and county aristocrats carry-on comfortably away from the fray.

And taxpayers, as well as the workers contributing toward their pensions, have a right to ask if the \$20 million settlement even comes close to compensating them for their loss which appears

to be at least \$30 million more."

It is clear that Villalobos and his co-conspirators' self-dealing hand-in-thetill government way fits into the widely-held image of insiders dishonestly taking care of themselves at the expense of the general public.

Since the late 1960s when government employees unionized, all pay and benefits negotiations have occurred out of public sight with no one representing the taxpayer Politicians and unions continue to take care of each other leaving the tab with the citizens.

At some point taxpayers not only must say "No,

# Sierra snowmelt appears to have peaked

Even though there's plenty of snow in the Sierra and plenty of warm weather ahead, state officials say they believe the annual snowmelt has peaked, and should now decline. Central Valley farmers and other landowners have coped with flooding that resulted from the record-setting June heat wave. A state floodoperations specialist says the June heat caused snowmelt runoff to peak, and that any future peaks

should be smaller.

After a slow start caused by late-season rain that delayed planting, Salinas Valley vegetable farmers say the 2017 growing season has recovered. Prices rose this spring for lettuce, broccoli, spinach and other vegetables, but have now settled back to levels similar to a year ago. To improve efficiency and maintain their production for the long term, Salinas Valley farmers say they're employing automated planting machines and other new technology.

# Fruit, vegetable consumption improves

Americans continue to eat more fruits and vegetables, though consumption remains below what the government recommends in its dietary guidelines. A U.S. Agriculture Department report compared food trends from 1970 and

2014. It found that fruit and vegetable consumption has increased during that period. But Americans eat only about two-thirds of the recommended amount of vegetables, and less than half the recommended fruit

### State's field-crop acreage increases

Slightly more field-crop acreage has been planted in California this year, according to government estimates. A new report shows field-crop acreage up about 2 percent in California, though acreage declined slightly nationwide. The report estimates California farmers have planted more corn, cotton, barley, sunflowers and potatoes this year, but they decreased acreage of rice, wheat and oats.

# **Blessed to be Born** in the United States



Following a trip to a third world country I again realized how blessed I am to be born in the United States. I saw many good people working very hard and living in conditions that we would find less than acceptable. Most of the persons involved in the tractor culture are vets, very patriotic, and give the Pledge of Allegiance and include the phrase "Under God" with great passion.

Many of them are the kind of people you would be willing to spend the night in a foxhole with great trust.

When it comes to the Fourth of July celebration it is done so in ways most cannot even imagine. The included picture is just such an occasion. At the throttle is the engineer Jess Gilbertson of Knights Landing assisted by two skilled firemen from Paso Robles. The awesome Best 110 can be seen at the fabulous California Agricultural Museum in Woodland. The tractors came out able to burn wood, straw, or fuel oil thanks the genius of Dan Best. The basic process for the "Fireworks Display" is to shut down the oil input and switch to wood. Build the fire grate with a large supply of charcoal. Throw sawdust over the coals and let it cook for awhile. A loading device such as a Baker Fan is belted up and the throttle is pushed to wide open. The smoke

stack draft draws in the



fuel, burns quickly, and the cool air coming in draws the saw dust out the stack. A glorious display in the summer night creates a memory to never be forgotten

The creative mind of Dan Best generated many patents. The upright boiler had many advantages including the ability to go up and down grades maintaining constant pressure. Boiler construction allowed for higher pressures providing more power. Use of fuel oil dramatically reduced the supply problem and was copied by the railroads of the time. Moving the chaff from the back of the harvester to the boiler by use of a conveyor device was inspirational. Using injectors that were modified to enhance the water supply was addressed by Best. The quality of the machines and the improvements opened vistas to other industries besides agricultural endeavors.


Being a man of vision, Dan Best knew the days of steam would not last. The ground compression of the giants, the water and fuel supply, and the cost of the machines were only affordable to large operations were all limiting. Improvements in the internal combustion engine, techniques in reducing gasoline costs, and Rudolf Diesel thoughts and the use of tracks in logging in Maine had the potential to cause dramatic changes

A visit to the California Agricultural Museum in Woodland, the Bolt Museum in Oroville and the purchase of the book "Making Tracks" by Ed and Sue Claessen, Beavers Pond Press is highly recommended.
