# Yuba County Borrowing to Pay Debt

A family in financial crisis with multiple credit cards maxed out at 18%-24% often "saves money" by consolidating all cards on a lower rate credit plan. Did they reduce their debt load? Of course, but did they change their ways? Don't jump to any conclusions.

This scenario is analogous to the Yuba County Water Agency (YCWA) recently approving a 6.6 million dollar loan to save Yuba County money on their annual debt payment to CalPERS (California Public Employee Retirement System).

"Yuba County is fortunate to have a collaborative relationship with the Yuba County Water Agency that allows us to achieve unique solutions," said County Administrator Robert Bendorf. "This short term loan helps us achieve substantial savings and protect funding for ongoing vital services."

"It is great to see government agencies working together," said YCWA Board Chairman Brent Hastey. "This loan will benefit the County, YCWA, and the people of Yuba County."

It's not what these two Bendorf / Hastey quotes say it's what they don't say. These 'compatible' agencies with this collaborative relationship are led by two boards of essentially the same people. YCWA has two additional members elected by the public. So, basically the five Yuba County Supervisors petition themselves as YCWA directors for a loan which they then approve as YCWA directors. It's nice to get along with yourself but bad juju for future bad ideas.

The YCWA used to say their money was utilized for flood control, water resources and hydroelectric power. However, since YCWA now has the deep financial pocket in the county, will they now become a slush fund to bail other Yuba County agencies and cities out? Marysville would like some help and what about Wheatland? Maybe the supervisors / directors don't have such warm feelings toward these folks.

Robert Bendorf did not create CalPERS but as county administrator has conformed to the employee union - CalPERS gig, even taking part in giving huge retroactive raises to long-term employees back to their date of hire when Yuba County had some extra cash.

Bendorf's comment that the savings will protect funding for vital services is telling. All agencies and districts have been told how much extra money into the future they have to contribute to CalP-ERS. So, taxpayer funds are not going to traditional infrastructure maintenance and will begin cutting into law enforcement, the primary reason for taxation.

What is hypocritical is to be told that Yuba Co leaders are saving the taxpayers money when they created the problem to begin with. This is like the meth addict stealing his partner's stash, and then helping him look for it all night.

Cities and counties have been told by CalPERS to prepare to double contributions over the next 5 years. In May, Joe Lopez, Modesto's acting city manager, said the city eventually could not afford its CalPERS bill, which will nearly double over the next eight years.

Last month, Chico Councilman and financial planner Randall Stone said CalPERS would eventually collapse as the benefits it paid out exceeded the money it collected. The grim assessment comes from a report showing the city's CalPERS bill increasing about \$370,000 in 2018-19, \$803,000 in 2019-20 and nearly \$2 million in 2020-21.

Umbrella Sky Comes to Marysville Yuba Sutter Arts Mounts Major Art Installation

So what are those 100 umbrellas doing floating over the central courtyard at Yuba Sutter Arts? In a practical sense, they provide shade from the intense summer sun, but there's a lot more to the presence of the umbrellas than a simple utilitarian function. Most importantly, when you see them they will make you smile!

The original Umbrella Sky Project began in 2011 as a part of an annual art festival in Águeda, Portugal. Each year, during the hot summer months, a handful of the city's narrow streets gain colorful umbrella canopies that provide shade for the pedestrians passing through. The numerous parasols help cool the roadways in a creative and cost-effective way, and the sea of umbrellas forms a unique pattern overhead as well as changing shadows on the roadway below.

"We first heard about the

Umbrella Sky concept in an article in a recent issue of Sactown magazine titled, 'Why Not Here'," said David Read, Yuba Sutter Arts Executive Director. "We said, 'why not?' and started planning our installation which came together in about three weeks," he added.

There is an aesthetic to the colors and the shapes of the umbrellas and the geometric shadows they cast on the ground. Even the slightest breeze causes the umbrellas to shift and realign themselves turning them into "dancing umbrellas." Five different color umbrellas were used, each about 40" in diameter. They are suspended on a wire grid system about ten feet off the ground.

In Águeda, these pop-up shade structures have become an annual summertime installation and they have developed a cult following around the world. Creators

of the Umbrella Sky Project have also launched offshoots of this work in other cities including a few in the United States, where they have added to the streetscape by stringing multicolored balloons over urban alleyways. The polka-dot shadows that shine down onto the street below add more color to people's lives in everyday settings.

Umbrella Sky will be on display through at least September. There is no admission to view the installation or any of the Yuba Sutter Arts exhibits. Hours are Wednesday through Saturday from 11-4 or at other times by appointment. Yuba Sutter Arts is located at 624 E Street in Marysville. Plenty of free parking is available on the streets adjacent to the theatre and at the Umpqua Bank and Bank of America parking lots directly across the street. Come support art in the community and enjoy this unique project.

# Appeal of Marysville Planning CUP Denied

ville Municipal Code Title 18, Zoning, regarding upholding the laws of the State of California and the United States, Sections specifically 18.67.060. 18.08.070, and 18.67.120 and possibly other code sections, and consider recommendation to the City Council.

The vote by the Planning Commission was 4 to 1 against eliminating or changing the ordinance, thereby upholding State Law, Federal Law and Marysville Municipal Code. Two commissioners were absent and the lone vote to eliminate was Michael Paine.

On July 18th the Marysville City Council met to hear Mr. Weckmans appeal. There were approx. 70 people in attendance, six people spoke in favor of the appeal and there was no opposition. Mr. Weckman made a presentation to the City Council showing that the setbacks from Ellis Lake Park and the Cargil Building did not meet Marysville's own ordinance. When Councilman Pedigo asked the city planner if he had

checked the distance for the setback he replied, "No that was done by my predecessor, but I stand by them". The issue of a setback

the dispensary from deals with the presence of children. It was suggested by Mayor Samayoa they require the dispensary to be closed when the Kiwanis had their Children's Fishing Derby. This suggestion shows that the council knew what they were doing was wrong. Councilwoman McKenzie made the point that there are always children around the park. The Mayor responded, "There are always children walking around everywhere."

The appeal was denied on a 3-2 vote with councilmen Simmons, Pedigo and Mayor Samayoa voting to deny.

Following the Appeal Hearing Buck Weckman made the following statement:

"A majority of the Marysville City Council are morally corrupt and inept. By approving and granting a Conditional Use Permit for a Marijuana Dispensary at this location they continue Marysville City's downward spiral into becoming another Oakland. By voting to approve the CUP, Marysville Mayor Samoyoa, and Councilmen Simmons and Pedigo violated their own City Municipal Code Section 18.67.120. At best their action is an Infraction of the Law. The Police Chief Aaron Easton is charged with the duty of enforcing City Laws, where is he on this issue? Does City Ordinances only apply to Business signs and the little people?"

# FISHIN' TALK

The hot weather has driven the trout population down deep in most reservoirs and lakes. Trolling for them in the summer months usually means downriggers or lead line. The downrigger will place your offering exactly where you spot fish on your finder, while the lead line has

Many anglers fish water that does not hold fish and they also depend on that blip which shows them a fish. There are certain areas of reservoirs which hold fish and other areas which are bare. That expensive fish finder will tell you where the most likely spots hold fish which is usually where there is drop offs, underwater canyons and an uneven bottom. Trout and bass will go deep this time of year but will also cruise the shallows at night for food. If you hit the water before first light we suggest two lines in the water, one down deep and the other

near the surface. I have had fishing friends, who spend a bunch of time on the water, who put their boat on the trailer as soon as the sun hits the water. They consider trolling during the morning hours when the lake or reservoir has the sun on its surface to be a waste of time.

If you plan on fishing the bottom of a lake or reservoir we recommend using power bait or an inflated night crawler along with whatever else you have on your hook. Both the power bait and the inflated worm will keep your

baits off the bottom which will have your offering floating above the grasses which grow in just about all lakes and reservoirs.

Trolling with flashers and a night crawler cannot be beat for fishing in lakes and reservoirs, but one must not forget lures and spoons or try removing the flashers or ford fenders for a different drag and presentation. If trolling in a straight line does not produce any strikes we recommend zig zagging

or trolling in a figure eight pattern. Also a sudden stop of your boat and then to continue may produce a strike due to the flashers falling which will attract a fishes attention.

Another way to catch lake trout this time of year is to jig with jigs or a night crawler. This is done on the bottom of the reservoir and is especially productive for brown trout.

Closing thought: "Do what is right, not what is easy."



### **Medical Discounts**

On a recent visit to the local hospital near my home to get a rather involved medical test, I compared the cost of paying cash to paying by insurance. I told them due to my type of insurance I would pay cash and get a receipt to submit to the company. This is regarded by the hospital as what it is: a cash payment collected at time of visit. The cost was \$1,780.00. If I had paid by insurance, the cost that would have been billed to the insurance company would have been \$2,620.00.

This works out to a difference of \$840.00 or an almost one third higher price. One then asks the question: what is it about getting paid by an insurance company versus cash that requires the hospital to charge a third more.

Having to wait for payment might be one reason but even a extremely high usury rate assumptions, the opportunity cost (the use of the money I paid up front versus waiting for the insurance company to pay) certainly amounts to but a few dollars. Assuming an unheard rate of return based on current interest rates of 10%, which the hospital likely gets nowhere close to that return, and

assuming a liberal 90 day pay period for an insurance company, the loss incurred by waiting for insurance company to costs the hospital less than \$100.00.

What other costs does the hospital incur when dealing with an insurance company which could amount to \$740.00?

The question does boggle the mind, at least mine. Since shipping and handling (actually processing and handling- pun intended) is the only major cost I can imagine that is incurred in dealing with an insurance company, just how involved and costly is that entire process. Apparently very.

The required paperwork is detailed. The submittal process exacting and the kickback rate significant. Since the old adage is an insurance companies secret mission is to "keep the money as long as they can", you can imagine there are many landmines in the paper trail awaiting an inexperience clerical worker in crossing all the "T's and dotting all the "I"s.

Even experienced clerical managers can make mistakes on the pile of forms required during a claim submittal. Resubmissions can be required and every box left unchecked or incorrectly checked means a longer wait until the reimbursement check arrives.

Of course, should legal issues arise that requires the services of a lawyer to recoup a denied claim or loss, the hospital will pay that out of its pocket as well. That cost is therefore assumed by the hospital as a reoccurrence at a presumed rate and is then built into the insurance rate as well.

Sit over a cup of coffee for a spell and the possibilities of what problems could arise when transmitting and transacting complicated medical procedures can occupy ones mind for hours. I know, it did it. and I basically gave up after compiling quite a list of things that could go wrong when dealing with a profit driven insurance conglomerate and trying to get them to cut the hospital a check. Never mind the government requirements heaped on the poor processing souls when dealing with a Obamacare, Medicare, Medi-Cal or other government entity.

After an hour or two of listing all the pitfalls and requirements that does and could befall processing hospital or Doctor, I'm actually

surprised that a 30% surcharge covers it. And that's one reason your medical costs are skyrocketing.

### State of Jefferson and **Equal Representation**

So what is going on with the State of Jefferson? Let me give you a little history lesson first. In 1964, the Supreme Court case known as Reynolds v Sims ruled that equal representation of counties in the state legislatures was unconstitutional. This ruling unlawfully amended the Constitution of each and every state. Rather than allowing each county to have equal representation in the state legislature, the Supreme Court ruled that political subdivisions known as Senatorial Districts must be created.

### Lawsuit Filed Over Attempt to Stop Recall

Sacramento, Ca. On July 20th, the **Howard Jarvis Taxpayers** Association (HJTA) filed a lawsuit to stop the Legislature's unconstitutional efforts to undermine the voter-led recall of State Senator Josh Newman. "The Legislature has

pulled out all the stops to silence the voice of taxpayers and undermine the people's right to a fair and democratic process," stated HJTA President Jon Coupal. "You can't justify changing the rules midway through, which is why we believe we'll prevail in asking the court to step in and right this wrong."

For months, the Howard Jarvis Taxpayers Association has been working with concerned taxpayers who seek to recall Senator Josh Newman over his vote to impose over \$5 billion in new annual taxes on cars and gasoline. On July 7, the Secretary of State reported that 87,884 signatures had been collected—far and above the 63,593 signatures needed to qualify the recall for a vote.

In an underhanded attempt to protect Newman, the Legislature scrambled to pass Senate Bill 96, a gut-andamend bill that would deny voters in Senate District 29 their due process by unnecessarily extending the state's recall approval process. Joining with four of

the recall petitioners, HJTA filed the lawsuit to issue a stay on the implementation of SB 96 and compel the Secretary of State to certify the recall petitions.

HJTA is a non-profit organization dedicated to protecting the interests of taxpayers in the Legislature and at the ballot box. Earlier this year, **HJTA formed Californians** Against Car and Gas Tax Hikes, a Committee to Recall Josh Newman, Sponsored and Funded by No New Taxes, a Project of the Howard Jarvis Taxpayers Association, in order to aid SD 29 residents in their effort to recall Newman.

### AT&T is Stealing Our Landlines

The public paid for America's sturdy, reliable and essential copperline landline infrastructure through rates and tax-subsidized incentive programs. But AT&T wants to eliminate copperline service. Most Californians don't know this. "Dependable" is not in vogue, and AT&T no longer wants to service this system. It claims it must make way for new technology, and that this service is no longer essential or economical for them to continue, despite AT&T's huge profit last year.

Tell that to Californians who live in rural areas, are older, have medical devices, are disabled, or are low income. They rely on this service. "Traditional landline phone service remains the backbone and only reliable two-way communication mode," says the Rural County Representatives of California.

Many states have allowed AT&T and other companies to disconnect, despite opposition by the public and organizations like AARP. Illinois just approved landline elimination. Michigan did so in 2014. Last year, California Assemblymember Low sponsored AB 2395 to disconnect copperline landlines by 2020, but vocal opposition, including from rural counties, stopped it.

The California Alliance of Retired Persons says: "AB2395 would leave California consumers without essential public

safety protections. Voiceover-Internet-Protocol (VoIP) services do not provide line power during an electrical outage. ... The FCC's rules have serious gaps: batteries must only provide a minimum of eight hours (24 hours after 2019); it is up to customers, not the provider, to purchase the battery at their own expense; and notification need only be at the point of sale." AT&T is trying sev-

eral work-arounds. The

first is FCC WC Docket No. 17-84. The FCC will likely preempt "wayward" states that want to retain copperline for their residents and adopt measures to speed up destruction of the copperline system. AT&T's second move was to send notices to AT&T customers this month, notifying them that they agree to any and all changes to their telephone service and the installation of any and all equipment on their premises that AT&T wants to do, including installing equipment that uses electrical power. "If you do not allow AT&T to install the new network equipment at your premises, your telephone service may be disconnected ... " Any customer who doesn't accept the terms must call AT&T to cancel their service." This becomes effective July 1.

Yet, the CPUC and TURN told me last week that AT&T has not been approved to abandon copperline.

AT&T plans to use broadband over powerline — a dangerous system that puts the microwave signal directly on powerlines, where it travels along all wiring and onto household wiring It broadcasts microwave radiation everywhere and cannot be blocked. It was vehemently opposed by physicians in Austria and Switzerland when it was mandated there for Smart Meter communication, saying it would cause widespread health problems.

AT&T is also pushing Senate Bill 649, which effectively turns most utility poles in a community into cell towers. Cities and counties have to approve them, even in residential neighborhoods. SB 649 has been approved by the Senate and now faces the Assembly.

The Mendocino County Board of Supervisors said last year, "Don't take away the most reliable way to reach 911 in an emergency. 911 dispatch centers automatically know our location when we call from home. Our home phone lines will keep working for weeks if there is a power outage. Wireless signals can be unreliable when we need our phones the most. Don't let vulnerable people be left without

reliable phone service." In power outages and in disasters, copperline landlines are a lifeline.

### YCWA Board Approves Over \$6.6 Million Loan to Yuba County

The Yuba County Water Agency Board of Directors on July 18 approved a loan to the County of Yuba for its required payment to the California Public Employees' Retirement System, in the amount of approximately \$6.7 million.

Yuba County has two options to pay the unfunded liability portion of PERS over the next year; either all at once or by making monthly payments. Paying the lump-sum up front will save the County close to \$180,000 in interest payments that would otherwise accrue over the fiscal

YCWA and Yuba County have a special, long-term financial partnership that started with the County providing money that was needed to establish YCWA. Additionally, 2008, in YCWA and Yuba County

partnered in \$78 million

worth of bond sales to pay for the local share of levee improvements. These bonds were refinanced in 2016, and that process shows the County's financial stability and good credit rating.

"Yuba County is fortunate to have a collaborative relationship with the Yuba County Water Agency that allows us to achieve unique solutions," said County Administrator Robert Bendorf. "This short term loan helps us achieve substantial savings and protect funding for ongoing vital services." YCWA currently has

more than \$40 million in reserves invested with the Yuba County Treasury. One of the major purposes of these reserves is to have the necessary funds on hand to construct project improvements when the

new Federal Energy Regu-

latory Commission license is issued. The Treasurer-Tax Collector actively helps manage YCWA's funds and investments in accordance with the law.

Since YCWA's FERC license is not likely to be issued within the next year, and the County has budgeted and agreed to repay the loan within one year, the Agency is able to provide these resources without any reduction in earnings or conflict with future expenditures. The Yuba County Board of Supervisors will have the opportunity to accept the loan agreement at its July 25 meeting.

"It is great to see government agencies working together," said YCWA Board Chairman Brent Hastey. "This loan will benefit the County, YCWA, and the people of Yuba County

# **Trash to Treasure**

Rosie was restored several years ago with a rebuilt engine, new tires and an auto body paint job. She has appeared in several parades and Tractor Shows. The Farmall A has been driven by some of my family members in the Hisken Family Tractor Day. She has been on display at county fairs.

Quite a few years ago as we started our equestrian facility we had to develop a way of dealing with dust. A used water truck seemed to hold promise. It did not take long to discover if you spent under\$50,000 you were buying a truck that would need constant attention. Just to get mechanic to come to Oregon House to look at the problem would be expensive. I did not think a water trailer would do the job. My next door neighbor in Truckee had a tank he did not want and a I had a trailer to haul my backhoe. We put out heads together and came up with a design. It worked, but not well. After three or four years of evolution I had a unit that worked well, was low cost, and did double duty as a fire

control aide. Our long time effort working with young people and horses has been wonderful. One of our little girls has now grown up, has children, and is a rated Dressage Instructor. She asked me to build her a water trailer and I did. I colored coordinated to an 8N Ford tractor I had previously sold her.

She put it on Facebook and I quickly got a call for another request from the soon to be the new owner of Rosie.

Loften review Craigslist and I noticed an old fruit pallet trailer in Yuba City on George Washington that was free for hauling away. I asked Matt Brugman to load it on my trailer with his forklift as he lived just around the corner on Franklin. The trailer and tank were heavily rusted, had old truck tires and wheels from the 40's that are difficult to get, and the wheels and hubs on the rear of the unit were gone and not available.

Walt Keller, a good friend, of Brownsville is an excellent welder and fabricator. He cut the trailer in two, removed the old axels and installed mobile home axels, and welded the trailer back together.

I bought a good quality pump from Clark and Sons and North State Tire

up a fire hose and nozzle available.

We wire wheeled and did some blasting in paint prep and painted the trailer and applied a logo with the barn colored theme.

The Farmall A was manufactured from 1939 to 1947. This model was followed by the Super A which was an improved version. The A is powered by an International Harvester engine of 1.9 L. It was claimed to produce 13hp but was tested at 16.32 at the Drawbar and 16.24 hp at the Belt. The weight range depending on options was 2,400 to 3,450 pounds. They were manufactured in Chicago and Louisville and sold for approximately \$750. The transmission is a four speed.

The A was produced to compete with the very successful Allis Model B. It was a tractor that was used on small farms and

performed a number of tasks living up to the term "Farmall". The Farmall design was created by the engineers at IH in the early 1920's which made a tremendous impact on future manufacturing The multiple tasks that could be performed put many manufacturers out of business such as the Fordson Model F. The concept lives on today and is seen in many tractors. So now Rosie will be working at a beautiful equestrian facility getting many looks and turning heads as she is parked in at the loading spot next to a major road doing dust control and standing by for a fire. The new owner is not dragging hoses by the hour and is grinning with a much more pleasurable task and the neighbors

are jealous. Gee, trash to treasures sure is fun!

what a time bomb this is," Stone told the Chico Enterprise-Record. "You should be screaming with your hair on fire from the rooftops."

In May, the Bay Area News Group reported that three small East Bay towns - Pittsburg, Walnut Creek and Martinez - cut several agencies' budgets for 2017-18 to pay CalPERS bills. These cuts are before the large predicted CalPERS hikes.

In March, the Ventura County Star told how local cities there were staggered by the CalPERS hikes. Port Hueneme's (pop 21,732 in 2010) pension bill went from \$774,000 in 2014-15 to \$1.3 million in 2017-18 and will reach \$3.2 million in 2022-23 more than guadrupling over an eight-year span.

In Yuba County there is no hair on fire shouting from the roof top even though there is no way to fund the sheriff's department out of the budget if the immigration detainee jail contract is ended. Bendorf uses the euphemism "the cost of doing business is increasing." That's like calling a levee breach a high water moment.

Bendorf is promoting a 1% sales tax increase and now we are borrowing each year to cover the CalPERS payment. The county is in big trouble. When are leaders going to lead instead of whistling together before the train hits us?

# **Pets and Heat – A Deadly Combination** Part Two

It is the start of summer and already animals have died from the heat. As their caretakers we must do everything in our power to prevent this. Here are a few things to consider for the health of your pet during the summer months. We have already covered heat exhaustion/stroke in Part One. It is common sense to

walk or exercise your dog early in the day while it is still cool. I have seen dogs walked by their owner in the heat; the dog is trying desperately to get off the hot pavement (asphalt or cement) and the owner is totally indifferent to what his dog is telling him. Dogs can suffer 3rd degree burns on their pads from hot surfaces. If your dog sustains these injuries take him to the veterinarian for treatment. Pavement heat increases throughout the day and it is not unusual for it to reach temperatures of 143 degrees and greater (120 degrees is enough to cause burns). Even grass can reach 105 degrees in the sun. If you cannot walk barefoot on the surface neither can

early in the morning.

You frequently see many dogs riding in the back of pickups in the summer. Can you image how hot the metal must get. Not too mention the dog is baking surrounded by all that metal and asphalt with no protection from the sun. No access to water. If you have vinyl car seats, keep them covered as they can get very hot.

In this heat reconsider transporting or keeping an animal in a crate. There is very little airflow and not much room for the dog to move around.

You often see dogs running along side of bicycles, in this heat it can lead to heat exhaustion/stroke and injuries to their pads. Again only exercise in the cool of the day and provide plenty of water.

have to set You boundaries for your dog when playing as many dogs will not stop playing. There are those dogs who become obsessive chasing balls and Frisbees and will not stop until they are overheated and in trouble.

Do not throw sticks or balls far out into the river. The rivers are cold and

moving fast - a dog can be swept downstream.

Livestock should have shade and fresh water. They also suffer the effects of the heat.

There is a high rat population this year and people are placing bait out for rats - if your dog or cat eats one they could end up dying. If you believe your dog or cat has eaten a baited rat take your pet immediately to the veterinary hospital. There are different types of poisons - if you know who placed the bait, try to find out the name of the bait. This will allow the veterinarian to treat your animal with the protocol designed for that particular type of poison. This can be very expensive so dispose of dead rats before your dog or cat finds it.

Always carry fresh water and a bowl with you for your pet's needs during these hot days.

There are many different web sites that are dedicated to protecting your pet during the summer months. It is in your interest to learn all you can on how to make the summer a healthy one for your pet.


