### **First Sutter Buttes Tea Party Scholarship**

**Awarded to Oroville High School Student Greyson Reynolds**

At their June 19, 2017, meeting at the Church of Glad Tidings in Live Oak, the Sutter Buttes Tea Party Patriots awarded their First Annual Patriot Scholarship to Greyson Reynolds, a junior attending Oroville High School, for getting the Pledge of Allegiance reinstated at Oroville High School, a school that had not recited the pledge since the

Greyson first spoke to the Oroville High School principal and then wrote a letter to the school board proposing the Pledge of Allegiance be recited every morning. With no results, he circulated a petition. The only opposition to restoring the Pledge of Allegiance came from a few teachers, not from any student. Other students and some teachers helped circulate the petition. Enough signatures were gathered. The Pledge has been recited every day since February.

Before introducing Greyson and presenting the award to him, Tammie Rikard, a member of the Sutter Buttes Tea Party Executive Board and teacher of their

biannual Institute on the Constitution's U.S. Constitution Course, addressed from where controversy to the Pledge comes:

I pledge Allegiance to the Flag... What could be wrong with pledging allegiance to your own nation? The answer is globalism, and Common Core in our public schools is seeking to transform our youngest citizens into global citizens. It targets vulnerable children that are not yet convicted to our founding principles of individual liberty and unalienable God-given rights. Our Declaration of Independence states the absolute truth, that all men are created equal, and that we are endowed by our Creator with certain unalienable rights. Contrastively, our children are being taught to deny any individual liberty in favor of the collective through this idea of globalism. So the term global citizen is being ingrained into the minds of our youth. This term refers to a godless government state citizen that places the collective above individual liberty, not an individual created by God and God-given inalienable rights.

...and to the Republic for which it stands... There are many people who grew up saying the Pledge of Allegiance over and over and yet still believe we live under a democracy. They don't even know the form of our government is a republic.

...one nation under God... We have recognized from the original formation of this great nation that we are living under the greatest jurisdiction there is. That is God's jurisdiction. He reigns supreme over this land, and He is the ultimate ruler and king of kings.

...indivisible, with liberty and justice for all. Justice for all. Liberty and justice for all, not just the social justice warriors and snowflakes and intolerant left. It means justice and liberty for all. That means I can say the Pledge of Allegiance, and I can fly my flag of the United States proudly..."

It was Greyson's patriotism which inspired the Sutter Buttes Tea Party to create what will be an annual \$500 Sutter Buttes Tea Party Patriot Scholarship. His goal is to attend the U.S. Naval Academy, Annapolis, MD.

### Kate's Law Can Save Lives

On June 29, 2017 the House passed "Kate's Law" named after Kate Steinle, 32, who was shot in the back and killed in San Francisco on July 1, 2015 by illegal alien Juan Francisco Lopez Sanchez. Her killer had 7 previous felony convictions and was deported 5 times.

The new law assesses enhanced penalties on illegals convicted of crimes, deported and then caught re-entering the United States. The law passed 257-157 with one Republican voting no and 24 Democrats voting yes. It still must now pass the Senate which previously voted it

Prior to Steinle's killing, Lopez-Sanchez completed a nearly four-year federal prison sentence for illegally reentering the country. He then was turned over to San Francisco (SF) officials because of an outstanding warrant for a marijuana-related charge that was immediately dismissed. SF authorities released him, despite a request from federal immigration officials to keep him in custody because of his undocumented status, according to a wrongful-death lawsuit filed by Steinle's family.

Less than three months later, authorities say, Lopez-Sanchez stole a .40-caliber pistol from the unlocked car of a U.S. Bureau of Land Management ranger, and shot Steinle at Pier 14 along the Embarcadero.

Seven months before Steinle's death, on December 7, 2014, Casey Bissell, 25, of Placerville was stabbed to death by two illegal aliens outside a restaurant in San Francisco's Mission District. Bissell and friends were celebrating his admission to U.C. Berkeley. Bissell's grandmother is longtime Yuba City resident Dottie van Eckhardt.

Bissell was a straight-A student completing junior college who hoped to study Internation-



al Relations at Berkeley. He was working his way through school as a sous chef.

Bissell's attackers had been drinking before approaching and assaulting Bissell and friends outside the eatery. Andres Novelo, 27, was sentenced to 19 years to life, 6 months in county jail and pay restitution of \$5,000. His partner in the assault, Josue Chan-Perez was released with a misdemeanor and time served of 220 days in county jail. The Bissell family was shocked that Chan-Perez was released.

"The nature of the crime could not have been more serious." Judge Rochelle East said, calling the murderous attack tragic, senseless and unprovoked. She said Bissell was stabbed to death at 18th and Valencia Streets "for no discernible reason."

Steinle and Bissell join thousands of other victims of illegal alien crime sprees. According to Hans von Spakovsky, Senior Legal Fellow at the Heritage Foundation, the Government Accountability Office (GAO) released two reports in 2005 on criminal aliens who are in prison for committing crimes in the United States, and issued an updated report in 2011.

The first report found that criminal aliens, both legal and illegal, make up 27 percent of

School in 2005 and was admitted to the California State Bar later the same year.

Beyond her professional work, Abril has been a volunteer attorney at Veteran's Stand Down for many years.

### FISHIN' TALK

I talked about old fishing lures last week so have decided to add a few more to the list. Fred Arbogast invented more lures, two of which were also my favorites and continually caught black bass. The Hawaiian Wiggler no. 2 was one of my favorites in the green/red color. This lure was a medium running lure consisting of a lead head, a spinner with weed less ability and the famous hula skirt. Another lure which continually caught a stringer of bass was the Sputterflux. This lure cast like a bullet due to its weight and was a surface lure which, like its name, made a heck of a lot of noise as it was retrieved. This lure, as stated above was heavy and as soon as it hit the water the pole was held as high as possible and reeling as fast as one was able to get the lure on the surface. My favorite color on this one was frog, which was painted so the frog was seen from under the water. Attached to the lure was a white skirt. Like the hula popper, the sputterflux was a kick to fish with due to the ripples one could see as the bass came from all over the pond to check out what was on the surface causing a disturbance. The lures came with an extra hook for attaching to catch short striking fish. I never used one due to the bass always devouring the



tistics are not fully representative of crimes committed by illegal aliens. The report only reflects the criminal histories of aliens in prison. If there were a way to count all crimes committed by criminal aliens, the numbers would likely be higher since

prosecutors often drop criminal charges against an illegal alien if immigration authorities will deport the alien.

The GAO reports also highlight the fact that criminal aliens from Mexico disproportionately make up incarcerations and that most arrests are made in the three border states of California, Texas, and Arizona.

Enforcing immigration laws saves lives, protects citizens and may have prevented Kate and Casey's violent and senseless deaths.

# Colusa County Cameos

PRINCETON by Carol Withington



Colusa County was established in 1850 as one of the original 27 counties in California created by the first State Legislature.

Early settlers in the north end of the county included Dr. Almon Lull, a native of Vermont, and J.W. Pratt who arrived in the area in 1852. Both took up residence in 1853 near a settlement named Ket-tee, located 14 miles north of Colusa. During that year, Dr. Lull established the first ferry across the Sacramento River.

On November 2, 1855 a third-class post office was established and Ket-tee was renamed Princeton by Dr. Some accounts indicate that Dr. Lull had attended Princeton University, but there has never been substantial proof that claim. Soon after, Dr. Lull, along with Will S. Green, laid out the first road on the east side of the Sacramento River.

Robert Arnett was the first postmaster. Born in Tennessee in 1816, crossed Arnett plains to California in 1853. Upon his arrival. he settled in Princeton he continued his farming pursuits. In 1857, Arnett moved to Mendocino County whereby Henry Vansycle took over the duties of postmaster. Vansycle, credited as opening the first store in Princeton, continued as postmaster until 1862 when Dr. Lull took over the position.

Over the years, wheat became the major produce in the area. At one time, more wheat was shipped from Princeton than from any other point and became the "heart" of this prosperous agricultural region. Due to Princeton's location, there was also a daily stage route from Norman to Butte City. The ferry also afforded communication with the east side of the Sacramento River.

In addition, the community continue to grow and included such businesses as a general merchandise store, a large warehouse, lumberyard, a saddlery, two blacksmith shops, a saloon and a harness shop. There was also a meat market, the Princeton Hotel, and a steam operated flouring mill. Rounding out the community was an M.E. Church and a schoolhouse.

On May 5, 1873, the San Francisco Bulletin announced that "the Princeton, Colusa and Grand Island Telegraph Company has opened an office at Boggs' ranch and at Princeton today". "There is great rejoicing and jolly time over the event here", it stated.

In 1891, the community of Princeton was moved into Glenn County. During that time, the counties of Glenn and Colusa were split and Glenn County was created from the northern part of Colusa County. However, on July 5, 1893, Princeton was removed from Glenn County by an Act of the California Legislature and was once again in Colusa County due to a boundary line change. And although this situation occurred for only two years, it must have caused confusion for the residents of Princeton. However, in all probability, the hard-working citizens persevered.

The community of Colusa will be featured in August.

Note: Those who remember the late Wilson Dillard (journalist, editor, etc.) may recall the story he often told about an incident while he was attending a gathering. It appears each person was asked to stand and tell the audience which school he or she attended. Dillard simply answered "Princeton" when it was his turn. After all, he was a graduate of Princeton High School, wasn't he? I can still recall his smile.

I have always said the stock markets of the world will reflect reality eventually but that their day to day movements are only the result of the perception of all the millions of players in it on any given day and at any given moment.

For instance, while the housing market was starting to turn down in a big way in 2007, housing stocks were still going up, as most investors didn't see the coming crash and bought housing stocks right up until we were in the midst of the storm. The perception was that the real estate market was fine even though the statistics were starting to turn negative.

Housing stocks eventually reflected the reality of the bust and subsequently crashed and burned. One could draw the conclusion perception first kept housing stocks up then reality brought them down.

With that thought in mind, how do we know how much the markets of today are reflecting reality or just mirroring investor perception?

I like to parallel markets and economics with your personal finances except on a grander scale. By drawing certain comparisons to your daily financial challenges one might more correctly assess the macro economic picture in global stock markets and give us clues as to where we are actually headed.

Think of it this way. Imagine a neighbor who had new cars in his driveway and seemed to go on vacation every

#### **Heat wave impacts will** take time to assess

It will be weeks, if not months, before California farmers can fully assess the impacts of the recent heat wave that hit many parts of the state. Harvest time will tell the story for most crops. Growers of processing tomatoes. for example, anticipate possible reduced yields. One farm advisor noted a positive outcome of the extreme temperatures: It could help tomato-plant breeders refine their efforts to develop heattolerant varieties.

#### Sweet-corn harvest accelerates to meet holiday demand

If you plan on enjoying corn on the cob this Fourth of July, California farmers have you covered. Sweet-corn harvest is going full speed,

as retailers promote it ahead of the holiday. Some growers see sales volume quadruple during this time. Sweet corn is mostly harvested by hand and often at night when temperatures are lower. Once out of the field, the ears are kept cool so the kernels stay sweet and tender.

#### Food-price survey shows cookout cost drops slightly

Your Fourth of July cookout will cost less this year, according to an informal survey. The American Farm Bureau Federation checked the cost of hot dogs, cheeseburgers, pork spare ribs, potato salad, chocolate milk, watermelon and other cookout favorites, and found prices overall had dropped slightly from a year ago. Farm Bureau attributes the reduction mostly to lower on-farm prices for meat and dairy products.

#### **Report labels** California's rural roads as deficient, dangerous

California's rural roads rank among the worst in the U.S., according to a national report. The report finds California the third-worst in the nation for the condition of rural road - and that the rate of traffic fatalities on rural roads is the nation's second-highest. California Farm Bureau President Paul Wenger called for making transportation-system upgrades a priority, saying "the whole nation depends on rural California for food and farm products."

For some odd reason, there a mistaken belief by some property owners that firefighters are responsible for the State Responsibility Area (SRA) Fire Fee of \$117.33. Homeowners are required to pay the SRA Fire Fee annually to assist with fire mitigation around their homes and properties in our rural areas.

In fact, in June 2011, it was California lawmakers that approved the fee to avoid a budget cut for firefighting by the State Agency, CAL FIRE. As to whether the amount being levied is legally a fee or a tax is the subject of an ongoing debate and legal wrangling in the courts. If it is a fee, according to Proposition 26, which was passed in 2010, the law requires that any fee collected must be used directly for the benefit of those paying it.

Regardless of the legalities involved, it significantly contributes to the essential fire prevention work that must be done to keep people, property, and natural resources safer from wildfire. Not only in Nevada County, but throughout the State of California outside of city limits in State Responsibility Ar-

In order to help the people of Nevada County receive the benefits of the money raised by this fee, the Fire Safe Council of Nevada County, among other organizations, applies for grants to obtain funds to assist low-income seniors, the elderly, and the disabled. In addition to helping those who can't do the fire prevention work themselves, the Fire Safe Council also provides Defensible Space Advisory visits completely free to homeowners.

### Fourth of July Leftovers bv Lou Binninger

In Southern California street-side interviews most people could not answer basic questions about the origin of the July 4th holiday. What happened and in what year? From what nation was independence declared? Why? Their answers were wrong, way wrong.

There is much skepticism as to whether government schools even place significant value on informing students about the Declaration of Independence and the harrowing times encompassing the drafting and signing of our founding document. Some on the left would rather it be forgotten and discarded. Fortunately early Americans saw it differently.

After the adoption of the Declaration of Independence, the "Committee of Five"—Thomas Jefferson, John Adams, Benjamin Franklin, Roger Sherman and Robert R. Livingston—was charged with overseeing the reproduction of the approved text. This was completed at the shop of Philadelphia printer John Dunlap.

On July 5, Dunlap's copies were dispatched across the 13 colonies to newspapers, local offi-

cials and the commanders of the Continental troops. These now rare documents, known as "Dunlap predate the engrossed version signed by all the delegates. Of the hundreds thought to have been printed on the night of July 4, only 26 copies survive. Most are held in museum and library collections, but three are privately owned.

Dunlap's Broadside included the signatures of just 2 of the eventual 56 signers, John Hancock and Charles Thomson. The later Goddard Broadside printed by Mary Katherine Goddard in 1777 showed all the signatures.

In 1989, a Philadelphia man found an original Dunlap Broadside of the Declaration hidden in the back of a picture frame he bought at a flea market for \$4. One of the few surviving copies from Dunlap's official first printing it was in excellent condition and sold for \$8.1 million in 2000. A 26th known Dunlap Broadside emerged at the British National Archives in 2009, hidden for centuries in a box of papers captured from American colonists during the Revolutionary

Broadsides,"

0n July 9, 1776, when Dunlap's Broadside reached New York City it caused a riot. As hundreds of British naval ships occupied New York Harbor, revolutionary and military tensions were running high. George Washington, commander of the Continental forces in New York, read the document aloud in front of City Hall.

War.

raucous crowd cheered the inspiring words, and later that day tore down a nearby statue of King George III. The statue was then melted and turned into more than 42,000 musket balls to equip the American army.

Although the document arrived in New York City to be proclaimed. the New York (NY) delegation to the Second Continental Congress was the lone hold-out among the 13 colonies to give their agreement to the Declaration. NY representatives had yet to receive permission from the New York Provincial Congress. However, after the Broadside arrived and the resulting impact names of New Yorkers.

their own pamphlets. Some questioned how

American slaveholders in the Continental Congress could agree that "all men are created equal" and still own slaves.

William Whipple, of New Hampshire, a signer who fought in the war, freed his slave, Prince Whipple, because of his revolutionary ideals. He concluded that no man could fight for freedom while holding another in bondage.

In the postwar decades, other slaveholders also freed their slaves; from 1790 to 1810, the percentage of free blacks in the Upper South increased to 8.3 percent from less than one percent of the black population. All Northern states abolished slavery

by 1804. However, as other "slave states" applied to join the union, slavery continued to be bitterly contested. Abolitionist legislators wanted to reject admission of any states permitting the

practice. In the 19th century, the Declaration took on a special significance for the abolitionist movement. Abolitionists tended to interpret the Declaration of Independence as a theological as well as a political document.

For radical abolitionists like William Lloyd Garrison, the most important part of the Declaration was its assertion of the right of revolution. Garrison called for the destruction of the government under the Constitution, and the creation of a new state dedicated to the principles of the Declaration.

The march to legalize this dangerous drug really got underway during the Clinton years. The plan was orchestrated in 1996 and subsequently funded for 20 years by America's Drug Lord, George Soros. Working, in his words, as a team with Bill and Hillary, he crafted and helped fund the propaganda campaign that duped California voters into passing Prop 215, "The Compassionate Use Act." In reality, it had nothing to do with compassion. President Clinton could have, and should have, stopped its implementation. But then, Clintons were part of the "team".

Working together, Soros, Hillary and Harold Eckes, formed the Shadow Party. By using the IRS 527 loophole, they found a way to invest significant funds into organizations that backed their political purposes, without directly financing politicians. Multiply that by 1.3 million dropouts, and the annual cost is about \$500 billion. Add public sector costs for physical and mental health care, the justice system, traffic deaths at \$1.4 million each, homelessness, incarceration et al, and the economic cost is well over \$1 trillion a year ... for a preventable disease. Nothing in modern history compares in terms of death, destruction, pain, suffering and economic cost; and nothing offers a greater opportunity to save lives and tax dollars. Yet, it isn't even on the Republican radar.

Why not? Marijuana causes physical changes in the developing brain for anyone under 25. It causes psychotic breaks leading to horrific crimes and suicide, mental illness, addiction, suicide, birth defects, cancer, and traffic deaths. Over 50% of arrestees test positive for pot. It is a gateway to crime, homelessness, academic failure, lost productivity and other drugs. It is tied directly to the pandemic of 144 overdose deaths every day from heroin and opioids. But overdose isn't the only cause of death, nor the only adverse outcome. Today's nuclear powered pot is very dangerous and can be lethal.

As to the State's rights for "medical marijuana". I challenge anyone, including the President, to define what is meant by the term. Marijuana is a fat-soluble complex drug with somewhere between 500 and 750 chemicals and cannabinoids. The potency (i.e. THC content) today ranges from 25% (+/-) in smoked form, 50 to 80% in edibles and almost 100% in oils and waxes used for dabbing and vaping.

CBD (cannabidiol), often called "medical marijuana", is a non-psychoactive component that has medical benefits for some, but not all. Calling CBD "medical marijuana" is analogous to calling penicillin "medical moss". To allow states to call pot "medicine" and consumers "patients" so the federal government won't enforce the law is an outrage.

California doesn't want or need any more out-of-state drug dealers. What we do need is for the Republican Party to step up and support AG Sessions and enforce the law. If neither party is going to protect the people, it begs the question ..... why do we need government at all?



"With area rivers running high and swift, our Commission and valued Partners saw an opportunity to improve the safety of Sutter County's youngest residents during these warm summer months," said Michele Blake, Executive Director for the Sutter County Children & Families Commission. "We're here to make sure our community's youngest residents are not only meeting milestones, but are as safe as possible."

A total of ten life jackets will be available for loan at each location, 5 infant (up (30-50 lbs).

To ensure the longevity of the program the Partnership is relying on the honors system. "For the program to be successful, the borrowed life jackets must be returned at the end of each use." said Blake.

Sutter Deputy Sheriff's Association will monitor the life jackets, the sign boards where the jackets hang and will replace any damaged or missing life jackets. "Each life jacket is branded with 'Property of Sutter Deputy Sheriff's Association'" said Sutter Deputy Sheriff's Association President, Lester Eaton. "If we can help save the life of one child on the river this Summer, then we'll have accomplished our mission," said Eaton.

The signs were approved by the Sutter County Board of Supervisors in May and were installed through a partnership with Sutter County Public Works. The Commission hopes to add more Life Jacket Loaner Program locations next Spring.
