Pension Poison -How It Happened

Politicians and government unions have had an exciting incestuous affair since the day public workers were given the right to organize. Public employees are tapped for dues that are used to fund political campaigns and ballot propositions benefitting unions. Union members are pressured to vote the union way. Union leaders then have politicians by the short-hairs when salary negotiations come around.

These negotiations are done in secret with no one representing those who are stuck paying for the majority of the pensions, the taxpayers. Union members' retirement pay now is more than the gross income of over half the households in California. The affair is working.

The total public pension liability for all state, county and municipal governments is \$106,848 for every household in California, according to Stanford University's Pension Tracker. Even if pension managers at California Public Employees Retirement System (CalPERS) experience a miracle by earning a 7 percent annual return without any loss over the next 30 years (CalPERS gained 2.4 percent in 2014-15 and 0.6 percent in 2015-16) every household in California will still owe \$28,507.

Without any financial smoke and mirrors California has a politician-produced crisis of over 2 trillion dollars in unfunded pension debt. And up until June 25, 2012, legislators 'cooked the books' to hide their deviant doings. They allowed government entities to leave the unfunded pension debt off their balance sheets further deceiving taxpayers, slow-thinking board and council members and financial institutions that might be solicited for loans.

The pension problem has been growing due to legislative corruption, union greed and CalPERS mismanagement. The current crisis started in 1999 with Governor Gray "Experience money can't buy" Davis. Davis was elected in 1998 with more than \$5 million in campaign contributions from public employee unions. He would take good care of his donors.

Up until then, CalPERS and other pension funds had a major surplus bolstered by double digit profits in their investment port-

San Diego – A Model of Pension Reform

San Diego may be one of the most visited cities in California and certainly a most beautiful and entertaining place. However, in 2008 the New York Times called it 'Enron by the Sea' as it wrestled with bankruptcy caused by employee pension debt. Deals made between city leaders and powerful unions created a massive financial crisis for the eighth largest city in America.

Today, San Diego is the only jurisdiction in California that does not offer defined benefit pensions. The city succeeded with a proposition to change pension plans and overcame multiple lawsuits and union prophets of doom to switch to 401(k) investments for employees.

With San Diego heading for bankruptcy in 2005, voters took charge by electing Republican Jerry Sanders, former commander of San Diego's SWAT team, as Mayor. Despite being a former member of the police union, he stopped all pension spiking, and pushed the passage of Proposition B, which required all nonpolice employees hired after July 19, 2012 to receive a funded 401(k) contribution instead of the right to an unfunded defined benefit pension, the California Public Employees Retirement

Unions screamed that the city would suffer economically and would be unable to attract sufficient public employees and firefighters. The proposed combined wage and benefit compensation would be 30 percent below the average of the 17 cities in San Diego County that offer a CalPERS defined benefit program. Unions said the city would become a training ground for other fire departments nearby.

The fire department reported an increase in retention losses the first year but has returned to the typical annual turnover. The city gets several thousand applicants a year to join the fire department and has no problem filling other city job openings.

The University of San Diego's Index of Leading Economic Indicators says that since converting public pensions to the 401(k) system the local economy has expanded for 58 of the last 60 months. In April, the Index reached its highest level since February 2006. However, in spite of the city's pension woes the unions waged a four-year legal assault to turn back the voters' will in Proposition B to reform the lavish and unsustainable CalPERS plan.

Finally, on April 11, a three-judge panel ruled in favor of voters. The taxpayers of San Diego still must pay \$2.7 billion in unfunded pension liabilities for employees that joined the city

folio. However, unions wanted that surplus for bigger pensions and SB-400 was passed by democrats and signed by Davis to do just that.

SB-400 increased pension benefits for all levels of public employees based upon the false assumption that the stock market would continue to achieve record levels. The up to 35% in pension increases stoked the governor's upcoming bid for re-election. The democrat - controlled legislature and Davis had done the unions a solid. SB-400 was the largest issuance of non-voter approved debt in the state's history.

SB-400 made more than 200,000 civil servants eligible to retire at 55 — and in many cases collect more than half their highest salary for life. California Highway Patrol officers could retire at 50 and receive as much as 90% of their peak pay. Other police departments got this

benefit, as well.

Pension-spiking was the rage. Soon retiring employees were promoted to boost their retirement pay-out. The financial barn-door was ajar and public employees ransacked the place to get 'what was theirs.'

Proponents sold the measure in 1999 with the promise that it would impose no new costs on California taxpayers. They said the state employees' pension fund would grow fast enough to pay the bill in full. Were these optimists, fools or liars. maybe some of each?

When the law took

effect in 2000, CalPERS investment values collapsed with the bursting of the 'dot.com' bubble. Eight years later, the housing market crashed and the recession set in. All this combined with poor investment decisions by the corrupt and unaccountable CalPERS management led to citizens paying the highest taxes in the nation while

getting the poorest services.

When Yuba County Administrator Robert Bendorf offers a budget review lately he usually says "we are bringing in more money but the cost of doing business is going up." That means that the taxpayers are being screwed by rising pension and health benefits for county employees. Yuba City's finance director Robin Bertagna gave the most transparent and ominous comments recently to the council about the pension and cost debacle. health She basically said this problem will eventually consume the city coffers thus further crippling services. Auditor-Controller Nathan Black says that Sutter County's unfunded pension debt has risen to \$150 million.

Can anything be done? Yes, but most politicians lack the backbone to grasp the nettle.

As San Diego is on the mend financially other jurisdictions are embracing pension reform as well in order to survive. Jacksonville, Florida, began switching all new employees, including police, into 401(k)'s last year. Pennsylvania's Governor signed a bill to move all new state employees and teachers

into a similar plan. And Michigan's governor is expected to sign a bill to move new teachers into 401(k)s.



FISHIN' TALK

The business of fishing has gone out of sight. We have lures that talk, swim and shudder when a real fish approaches. We have baits that smell any odor you wish to extend to the end of your line. In fact, the next generation of lures....or should I call them "something to catch a fish on"...will probably be a way to entice the fish population we have, as of this time, because some have never been seen in the water.

Now, let us go back a ways...way back to the days...when good old lures were first invented. Take the hula popper (which by the way was a killer for small and large mouth bass). Then let us discuss the famous jitterbug. Wow, what a lure. It was invented by a guy who made his name famous. Of course that was Fred Arbogast. His prototype was placed on the market in the 1930's. This lure was deadly late in the evening and after dark. In fact the inventor of this lure suggested an angler use it after night fall. With the right retrieve and the right jerk it was deadly and of course it made its own noise and gurgle as it was pulled through the water. The jitterbug was a surface lure just like the hula popper. Then we have the lure which changed the way we fish and made us realize the value of sound in the water. I am referring to the famous Rat-L-Trap introduced by Bill Lewis back in the 1960's. This lure was a huge success and is still available today. Try one and see what you will put in your live well or on your stringer.

I could go on and on about some of the famous lures, some of which have disappeared and those which are still available. Keep in mind however that same lure today will be different, not only in what it is made of, but also what it will cost. One more thing to discuss before we go to the next subject. I am referring to the Mirror-Lure which was a fantastic lure in its own right. This lure, when used the way the manufacturer suggested, was so great at enticing fish to strike, that some

higher-ups in the world of fishing almost decided to outlaw the lure.

This is old news for some folks, but we decided to report on the release of almost a half million small steelhead into the American River. The little guys came from the Department of Fish and Wildlife's Nimbus fish hatchery which survived the drought and the high water problem the past two years.

The California Department of Fish and Wildlife (CDFW) encourages all Californians to give fishing a try for free on July 1 and Sept. 2.


All fishing regulations, such as bag and size limits, gear restrictions, report card requirements and fishing hours and stream closures, remain in effect. Every angler must have an appropriate report card if they are fishing for steelhead, sturgeon, spiny lobster or abalone anywhere in the state, or for salmon in the Smith and Klamath-Trinity river systems.

Anglers residing in urban areas also have opportunities to fish close to home. Some CDFW regions also offer Fishing in the City, a program that allows children to learn to fish in major metropolitan areas. The students are incoming juniors and seniors who applied and interviewed for the opportunity to learn about government careers. From 8:30 a.m. to 3 p.m. each weekday, they have spent nearly 100 hours at City Hall and at City facilities to learn all that encompasses a job in government and the path it takes to achieve such a career.


"We are honored to support our local students by demonstrating a career pathway in government," said Yuba City Councilmember Preet Didbal, who has been instrumental in building and running the program. The S@CH program is funded by a Northern California Science Technology. Research, Engineering, Arts and Math (STREAM) Grant through the Sutter County Superintendent of Schools Office. Yuba City Unified School District partnered with the City of Yuba City to provide a teacher and curriculum.

River Valley High School teacher Sandy Richmond administered the daily classes, which included tours of every City facility, from the Water Treatment Plant to a Yuba City Fire Station,; presentations by the majority of City department heads; and meetings with county officials and State Assemblyman James Gallagher. Each student also experienced three, three-hour job shadows with City employees in jobs ranging from our waste water treatment facility and animal services to finance and the city manager's office.

"This isn't your standard summer school. These students recognized an invaluable learning opportunity and volunteered their time to study up on what could be their future," Ewert said. "It was spark with every realiza-



gating is best done early in the day for maximum growth and health of your plants. Drip systems offer the careful use of water by delivering the water just to the targeted plant and not all the surrounding area, and is therefore a system that keeps weeds down as well. The problem we find with them is that they must be carefully monitored to be sure they are working properly and are not clogged. The use of mulch around and between plants help to keep the areas moist between watering. A really efficient system takes a bit of planning and altering as plants grow larger and require more water. Usually that is done by adding emitters when needed. Having it all on

Knowing how much water the emitters produce will let you accurately decide how long they should run to do a thorough job of watering.

calls about the advisability of planting a tree in the middle of the July heat, and it is obviously not the optimum time, but it can be done if you are going to be there to be sure that the tree will be watered adequately. It would need a deep watering about three times a week through the heat of the summer. Deep watering requires a basin around the base of the tree. It should be just deep enough that a very light stream of water can be left on for several hours without overflowing, insuring that the water is soaking in around and into the tree's roots. Another easy way is to accomplish this by using a piece of 2" plastic pipe that is long enough to reach the bottom of the planting hole and extend several inches above ground level. About three sets of four or five 1/2" holes need to be drilled in a vertical line in the lower end of the pipe to allow the water to drain. Put that pipe in vertically to the bottom of the hole as you put the planting mix in around the tree. Hang the hose into the pipe and turn the water on slowly, leaving it for several hours to deep water the tree. One added precaution to insure a good result is to add a capful of 'Superthrive' to the irrigation water the first time or two. Put some rocks into the bottom several inches of the pipe to help to keep mud

from clogging the pipe. For those folks in the foothills dealing with the rapid growth of wild blackberries, poison oak, poison ivy, and other bushy and woody unwanted growth, this is good time to spray them with a brush killer. It must be done while they are growing vigorously for the best result. Using a product labeled as "brush killer" will do a better job than a general herbicide like Remuda or Roundup. These pesky plants it might require more than one spraying. Do you like Monarch

butterflies? Most of us seem to, and there is a plant available that will attract them. Asclepias curassavia, a variety of milkweed. It is quite an attractive annual plant with vivid red or bright yellow clusters of small flowers. The Monarchs lay their eggs on the stems which then hatch into caterpillars. They then feed on the foliage of the plant for nourishment. Nature has more interesting, clever and amazing ways of doing things than any of us will ever know, but it is fun to watch when you see it.

Mower blades should be set at 2 " of height during the hottest months. It may not give as smooth a finish as a lower setting, but it will take less water to maintain a nice green lawn. The higher setting helps the longer grass to shade the ground beneath which helps to retain moisture, thus keeping the grass green with fewer waterings.

Fertilize your summer vegetables and annuals to keep them flowering and/or fruiting. Use B.T. on the big green worms that defoliate tomato Don't neglect plants. those pretty hanging baskets. They need thorough watering to keep them pretty and that tends to wash nutrient right out of the bottom of that basket. It is probably easiest to use a 3 or 4 month slow release fertilizer on them. Annuals that you may have planted for all the color they provide will bloom longer if you have the time to dead head them frequently, and give them a bit of fertilizer.

Enjoy the pleasures of summer.

After 9,000 Columns, I'm Still Watching California - Now From a New Perch

So here I am again, beginning the third incarnation of my running commentary on all things California, but particularly its politics.

Having written more than 9,000 Californiacentric columns over the last 36-plus years, first for the late Sacramento Union and then for 33 years for the Sacramento Bee, I and the column have moved to CALmatters.

Four times a week, I will conjure up about 500 words of observation about California politics, and also will travel throughout the state for longer articles about the challenging issues it faces in the coming years and decades.

Why CALmatters? The name really says it all: California matters, not only to Californians, but, because of its unique attributes, to the larger world.

CALmatters is a nonprofit organization founded on the principle that such uniqueness requires journalism that looks far beyond the daily churn of political maneuvering and delves deeply into its underlying issues.

That credo meshes completely with my own abiding interests in California's continuous economic, cultural, demo-

graphic evolutions and the difficult challenges - even dilemmas - they present to its political system.

One current conflict illustrates the syndrome.

California has evolved into a blue state whose overwhelmingly support Democratic Party politicians, giving them virtually total control over state government, and generally support the party's liberal goals, which require more spending.

At the same time, however, those voters have demonstrated repeatedly that they are somewhat averse to paying higher taxes themselves to pay for those goals, even as they embrace taxing others, such as smokers or the rich.

After years of ignoring the deterioration of California's vital roadway network, Gov. Jerry Brown and his fellow Democrats in the Legislature mustered the will, and the votes, to raise gas taxes and other auto-related fees to increase spending on transportation by more than \$5 billion a year.

Despite the demonstrated need, a subsequent poll revealed that most Californians dislike paying the new taxes and, in effect, endorse the Republican opposition, even though they almost never vote for Republicans.

It's entirely possible that voters will pass an initiative repealing the new road taxes, which would not only put the issue back at square one, but make it politically radioactive and thus even more intractable.

That sort of dichotomy - the clash between reality and politics - permeates California and explains why issues, such as the deterioration of roads and highways, often simmer for years, or even decades, without resolution.

One finds similar dynamics in countless other important matters, such as education, water and housing, whose outcomes will determine whether spectacular California's history will continue, or whether it, like ancient Rome or Detroit, will see its societal position crum-

They are the kinds of issues - those central to California's fate - on which this column has focused in years past and will continue to explore in the future, with a minimum of inside-the-Capitol gamesmanship, although some is inevitable, and a maximum of outside reality.

Their end game is delay. They want to delay the ultimate vote on ousting Newman for as long as possible, despite the constitutional guarantee to have the vote as quickly as possible — between 60 days and 180 days from the recall petitions having been certified.

Here's how they do it: First, they try to delay the petition review process by requiring the county Registrars of Voters to check the validity of every signature submitted. Normally, the registrars are permitted to check a random sample of the signatures, saving both time and money.

Second, and more disturbing, is the provision buried deep in the text that states, "Notwithstanding any other law, the Secretary of State shall not certify the sufficiency of the signatures [on the recall petitions] until the Legislative Joint Budget Committee has 30 days to review and comment on the estimate [of recall costs] submitted by the Department of Finance."

Here's the kicker. The Department of Finance is part of the governor's office and the bill does not require the governor's office to prepare that analysis under any time limit. Gov. Brown, who has already come out against the recall, can simply delay that report indefinitely, which, in turn, would hold up certification of the recall effort and the ultimate election.

Perhaps it should come as no surprise that those in power in Sacramento will stop at nothing to retain their power and influence, putting their own interests ahead of those of average Californians. But lawmakers who disrespect voters should be wary. Polls show that nearly 60 percent of Californians oppose the new gas tax. The higher taxes will kick in just before the beginning of next year's election season. Voters are very likely to remember who is responsible and choose to retire multiple representatives, not just a single senator, in the regularly scheduled 2018 election.



Why do you own the stocks you own

Investors usually tell me they hold a variety of assets which might include stocks, bonds and mutual fund in order to be diversified yet few can give me a specific reason for why they hold each investment. Somehow they believe holding a wide variety of assets is diversified, and while this is a partially true statement, the actual reason why this is true can be elusive.

Having clarity and focus in ones investing is tantamount to reaching financial goals. This means you have to be clear on why you own everything you own and how we reach that awareness is actually quite simple.

For instance, I own my

shotgun not as an invest-

ment but for protection. I am investing in my safety and the safety of my family in case some bad guys arrive at my house late at night. I own my garden to give me food and own my car for mobility. I own my house for my family and I to inhabit yet many investors think of a house as place to accumulate retirement savings or invest for growth. While this might be true to some extent, during 2008/09 we discovered that perhaps that wasn't such a good idea. Part of the reason for the housing bust was confusion on the part of investors on why we own our homes. Decades ago most people thought of home ownership as just that, a place to live. In the last decade however, the reason for owning a home morphed into an "investment" instead of a "necessity" and that's where the trouble may have started.

The reason for holding money in a bank has also changed over the decades. When I was growing up, the banks paid me six percent interest on my savings. My Dad told me to save my money in the bank for the interest payments much

like he did. Since banks now pay little interest, the reason for putting money in a savings account has changed. Now we put our money in a bank for safety, not for the interest. When investors complain to me they cannot make money in a savings account, I tell them that is not why we are there, at least it isn't at this particular point in time. We have savings accounts and similar bank products for safety, not to make money. If we want to make money, we obviously must look elsewhere.

Many people hold stocks for growth. I do not. I hold stocks for their potential income as I usually don't buy any stocks that don't pay me money (dividends) to hold them. With the income they pay me, I may get the growth regardless of whether the market goes up or down. If the market does go up, I might do even better. If the market goes down, any payments I might receive takes some of the sting out. Keep in mind, dividends are not guaranteed and, having stocks that pay dividends does not ensure profit or protect against loss

Some investors might hold gold and silver coins in a bank safe deposit box for peace of mind against a possible currency collapse while others might hold gold stocks for speculation on the gold price.

Commodity funds may help guard against rising grocery bills while holding some Cd's, Treasury bills or cash would tend to help preserve funds in a broad market sell off.

I could pay off my

home mortgage, I don't. I consider my mortgage as a way to help protect against inflation. (Inflation could allow me to pay off my mortgage with cheaper dollars) Others consider debt the devil's own and avoid it all costs.

By detailing the reason you hold each asset, it may help clarify your portfolio goals and even cause you to perhaps alter its contents. Once you detail and carefully consider why you hold what you do, or at least ask the question, your investing plan might become that much clearer. The thought process of truly knowing why you place money where you do will go a long way in helping you reach your goals and allow you to better allocate your money where it may offer the maximum possible return, the possibility for growth and protection while providing clarity to


