

# Autopsy Reveals Cause of Death Chocolate Milk from Brown Cows

There are some benefits to growing-up in Northern California. You realize that brown cows don't produce chocolate milk. This understanding is called agricultural literacy which some people have missed out on.

Whether government schools covered that topic or parents, it seems that 7% of more than a thousand people surveyed were fuzzy about the origin of chocolate milk. Seems logical but wrong – if white cows give white milk then brown cows offer chocolate milk

A 1990's Department of Agriculture study found that 1 in 5 adults did not know hamburgers were made with beef. And in 2011, researchers learned that more than half of the fourth, fifth, and sixth-grade students interviewed did not know pickles were cucumbers or that vegetables such as onions came from plants.

However, these ag or food literacy rates are not the same throughout the nation. Those living in rural areas and those having higher income and education levels know more about their food sources. Ag literate Yuba-Sutter youngsters can at a glance tell the difference between peach and prune trees and between walnut and almond orchards without fruit or nuts on display. They can also name row crops at a glance.

At one time, the big talk just before summer for students around here was where they were going to work. Many found jobs in orchards or the fields, canneries, construction, retail and restaurants, while some headed to Alaska for the fishing industry.

The thought of work was exciting. It was before the unions lobbied for laws limiting equipment operating to those 18 and older In one summer a 16-year-old could learn how to drive and maintain a tractor, operate a forklift and bobtail truck.

More importantly a multitude of soft skills were accumulated while having a great time and making money to buy a car. Teens paid with cash and most bought their own. They learned timeliness, diligence, determination, and team work. They experienced laboring under stress and pressure, how to get along with coworkers, following directions and they understood the value of a dollar.

Some were promoted and guaranteed a job for next summer while others were fired, both a great lesson. For Baby Boomers

# Aly Yeoman's Autopsy Reveals "Drowning" as Cause of Death

Sutter Co.

On March 30, 2017, at approximately 10:30 PM, Alycia (Aly) Leane Yeoman went missing. She was last seen driving westbound on Butte House Road from Romero Drive in Yuba City. Aly was in route to her home located in Gridley. Aly never made it home. On April 5, 2017, Aly's vehicle was found near the Feather River, just north of the Live Oak Recreation Park. Aly's cell phone was found on top of the levee, not too far from her vehicle.

An extensive search and investigation was initiated. A unified investigation team was

formed which included the following agencies; Gridley-Biggs Police Department, Butte County Sheriff's Office, Butte County District Attorney's Office, Yuba City Police Department, Sutter County District Attorney's Office, Sutter County Sheriff's Office, Federal Bureau of Investigation and the Office of Emergency Services. In addition, many citizens throughout the nation assisted in the search for Aly's safe return.

On May 7, 2017, the hope in finding Aly alive ended when her body was located in the Feather River, not too far from where her vehicle was found.



An autopsy was performed and the cause of death is listed as "drowning." The manner of death is undetermined.

# **Special Meeting of Marysville Planning Commission**

Marysville, Ca.

The seven-member Marysville Planning Commission serves as an advisory board to the Mayor and Marysville City Council. The Special Meeting of the Marysville Planning Commission on June 14, 2017 was scheduled to change the zoning requirements for the proposed Marijuana Dispensary's since they violated the city's existing zoning ordinance. The change would eliminate any compliance with state or federal law. Item: 6. Consider modification or elimination of statements in the Marysville Municipal Code Title 18, Zoning,

regarding upholding the laws of the State of California and the United States, specifically Sections 18.08.070, 18.67.060, and 18.67.120 and possibly other code sections, and consider recommendation to the City Council.

This was an attempt to make changes to the ordinance that would nullify the rescheduled future appeal of the City Council's decision, presented by Buck Weckman of FACT (Families Against Cannabis Trafficking)

The vote by the Planning Commission was 4 to 1 against eliminating the ordinance, there-

by upholding the state and federal law. 2 commissioners were absent and the lone vote to eliminate was Michael Paine.

After the meeting Buck Weckman made the following statement," The decision by the Marysville Planning Commission was a reminder to me that there are people of integrity and honor within City Hall. I need to thank and mention the good employees and staff more often. But this is just one round of the continuing battle against the corruption that comes with commercial marijuana."

Street property valued at \$1.5 million and the spiking unfunded employee pension and healthcare liabilities.

Munchheimer has an aversion to working with the county. He resigned rather than seek help from the county and save \$20,000 in a personnel search. He and the council did a disservice to the city by not asking the County Sheriff for a proposal to police the city. This is a classic example of going broke by maintaining outdated practices rather than saving a million a year in the policing budget. Stubbornly being stuck in the past is expensive. Munchheimer may have experience but pride comes before a fall.

The city violated the rights of Buck Weckman who submitted a timely appeal on the dispensaries. The city without explanation postponed the hearing.

Weckman's appeal will highlight the city violating its own codes to complete their marijuana outlet plan. Will the council have the courage to do what is right? Or, will Rich, Fuidge, Lane and

Bordsen double-talk them and the city get sued by Weckman? Of course, going to court would be a cash cow for the law firm. The city is rushing the ordinance change through thus avoiding Weckman's testimony since city hall knew he could not attend the council meeting.

Munchheimer's outdated ways have contributed to an eventual insolvency here. Spend up to \$15,000 for a small town website, incredible. Expand parks personnel when the city cannot afford its pensions is crazy? The parks need care, but by private industry. The council has an opportunity to look at outsourcing finance and community services positions and go to a 3-day a week city manager.

It's time for a change. Tuesday will speak loudly one way or the other.

# **Chocolate Milk** from Brown Cows

and Generation X, the summer job was a rite of passage.

Today, more and more teens are not working. Those that are working are most likely employed by July, according to data from the Bureau of Labor Statistics (BLS). In July of 2016, 43 percent of 16- to 19-year-olds were either working or looking for a job. That's 10 points lower than in July 2006. In 1988 and 1989, the July labor rate for teenagers nearly

hit 70 percent.

Whether its summer or year around, teens are dropping out of the workforce. They are finding other tasks to occupy their time. Some are attending classes to get ahead scholastically. In July of 2016, more than two in five 16- to 19-year-olds were enrolled in school during summer. That's four times as many as were enrolled in 1985, the BLS says. Almost a million students graduated

in 2009 having completed an advanced placement (AP) class, up 39 percent from four years earlier. Others not working may just be lazy.

Extra scholastic work and sports camps have their benefits but missing out on job experiences cannot be replaced by reading or hearing about them. College graduates with a spotty work history may make poorly adjusted workers and soon join the unemployed.

For some kids a job may save their life. In two Chicago jobs programs, arrests among participants for violent crime dropped by 42% for one and 33% for the other. The effect continued for at least a year after. Though the work programs could not show future employment or education benefits keeping people occupied for pay had a unique outcome in the city where shooting people is a pastime for some.

Rural and urban kids have differences, but having a job has been a rich learning experience for them in the past. Now, for many, going jobless until they need to support themselves should be interesting.

For one, you cannot ride your motorcycle or quad, in other words anything that is a motorized vehicle and not registered for highway use anywhere in the camping areas. All camping areas are designated as "restricted areas" and this covers just about everything except camping. No firearms area allowed which includes non-firing weapons such as bows and arrows. # Yuba Sutter Arts Awarded **California Arts Council**



#### **Spring weather affects** blueberry harvest

The cool, rainy spring complicated the California blueberry harvest. Farmers say spring weather delayed harvest by up to 10 days, causing California blueberries to be short on the market at a time of high demand. But reduced crops in other states helped California farmers win markets. Blueberry production in the state has grown the past decade, and marketers say demand for the California-grown crop continues to expand.

#### **Cherry harvest** increases

Volumes of Californiagrown cherries on the market have shown a sharp increase this year, according to a government estimate. The report savs California cherry farmers expected "the best crop in recent years" after several seasons of drought and low yields. The estimate pegged the California crop at 99,000 tons, up 65 percent from last year. Washington leads the nation in cherry production, and also expects a larger crop.

### **Grants benefit farm**to-school programs

Ten California-based farm-to-school programs will benefit from grants awarded this week by the U.S. Department of Agriculture. The Oakland Unified School District says it will use its grant to "dramatically increase" the amount of local food served in school meals. Other districts will start "farm to school action plans." A Fresno-based project will hold fruit-andvegetable taste-testing events for schoolchildren.

**Report notes 'supply** gap' in organic produce Demand for organic produce has been expanding faster than production, leading to a "supply gap" analysts believe could continue for several years. A report from the agricultural lender CoBank says it takes three to five years for farmers to transition crops to organic status. That can lead to a lag in fulfilling new demand for organic crops. The report says food companies and retailers have increased imports of organic produce to meet demand.

## **Access to Emergency Air** Ambulance Service at Risk

Sacramento, CA (June 12, 2017) - Today, members of California's network of emergency air medical providers are assessing how their ability to care for patients will be dramatically impacted if one of their primary sources of funding is not renewed by the California Legislature.

The Emergency Medical Air Transportation Act (EMATA) was established in 2010 to specifically fund emergency air ambulance services by placing

a \$4 fee on moving violations. The EMATA program sunsets on December 31, 2017, unless renewed by the Legislature. Legislation introduced by Assemblymember Jim Wood (D-Healdsburg) that would extend the sunset for this crucial fund is currently stalled in the Assembly.

The fee generates approximately \$8 million for California's emergency medical helicopter network, and allows the state to receive an additional \$8 million in matching funds from the federal government. Without this funding, air medical bases are at risk of closure.

"We recognize that the fees being tacked on to traffic tickets have become excessive, but without a funding source, we risk making these services, that are often the difference between life and death, available to only the wealthy and privileged," said Asm. Wood. "We must find a solution for this critical piece of our state's infrastructure."

A significant number of patients transported by emergency air medical services are only covered by California's Medi-Cal program. The reimbursement rates from Medi-Cal were last adjusted more than 20 years ago. Should the EMATA program be allowed to expire, critical funding that minimizes the gap between Medi-Cal reimbursement and the actual cost of services will be cut by more than half, which could result in reduction of services and even force the closure of

air medical bases. Reduction or elimination of air medical services will disproportionately impact rural areas that do not have immediate access to trauma centers and children's hospitals throughout the state - putting some of California's most vulnerable residents at

"In rural areas, emergency helicopters play a vital role in EMS and our ability to get the most critical patients to a hospital in time to save them. Traffic accidents, in places like the roads to Yosemite National Park, present a unique challenge to us, where we are a long way from a trauma center." said Bill Caldera, EMT-P and chief operations officer, Tuolumne County the Legislature to extend Ambulance Service. "A \$4 fee on moving violations

seems like a small price to continue paying to ensure we do not lose access to these lifesaving services."

Air ambulances also play a critical role in transferring patients from rural and community hospitals to receive trauma care or specialized treatment they may not have access to in their area.

"We strongly support the EMATA program as a way to fund air ambulance services. ## **Follow the Money**

Mayor Ricky may have inadvertently come up with a solution for Marysville's debt problem. Since he believes that the city council's job is to follow staff recommendations, we could save a bundle by dismantling the council and simply rely on staff. Let me set the stage.

Walter Muncheimer, retiring City Manager, recommended the council adopt a bid for \$20,000 to pay a headhunter company to fill several vacancies in the City's administration rather than go with a cheaper \$2,000 option available if they used existing Yuba County resources.

Muncheimer has made a series of recommendations and decisions that have already cost the city millions of dollars. You might say his recommendations are questionable at best.

Yet despite Muncheimer's dismal track record, Mayor Ricky voted to go with the more expensive \$20,000 option for a headhunter reasoning that "The council should not interfere with staff decisions."

All credit is due the four council members who voted against this recommendation, but Mayor Ricky raised a good point. If the council is just there to rubber stamp staff's decisions, do we really need a mayor or a city council? Just think of the savings we could realize from not having to pay their salaries or retirements!

Staff is not elected to serve the citizens of Marysville. They have no accountability to the voters for their decisions. We did elect a city council and we should expect that they represent the views of the voters, not staff.

Unfortunately the majority of the city council has acted irresponsibly by voting to allow two marijuana dispensaries licenses despite the wishes of the electorate. The process to push these dispensaries through has been tainted from the start and the stench grows stronger every day.

Just for the record, I have been a medical marijuana advocate for the past forty years. I do not object to the presence of a dispensary in Marysville and believe that two is better than one to avoid price gouging. However, I strongly object to the unfair methods used to award these licenses.

You know a process is corrupt when I (and many others) predicted exactly who would get the licenses months before the ap-

plications were available. Yet that didn't stop the city from accepting thousands of dollars from 15 or so applicants that had no chance of getting a license. The unfortunate truth is that the same two applicants would probably have won the licenses anyway but the methods used have forever clouded the outcome.

We have to ask why favorable treatment was given to the two finalists for the dispensary licenses. We already know that Mayor Ricky received thousands of dollars from one of the licensees that he failed to mention during his run for mayor last year, but what was done behind the scenes?

Allegations swirl about bribes, kick backs and campaign donations that were not reported surrounding these licenses, but we will never know for certain until a forensic auditor is hired to follow the money. I'm not singling out Mayor Ricky alone. David Lamon, Walter Muncheimer, and possibly others need to be

scrutinized as well. This needs to be a top priority when the new Grand Jury is seated in July.





# Long Bar (Part 2)

Browns Valley, Ca. Outside money from faraway investors began to fund mining activities. Henry Bleeker, H.B. Cartwright, and W.S. David Pierson who set up camp in 1849 at Long Bar sponsored men to work for them using the new methods. Gold mining was becoming more organized, more subject to the rules of business. Still, the grueling work of mining was done by men who were learning on the fly; men who had tilled land in Illinois, raised cattle in Chili, or wrote for newspapers in Boston; men who had never done this punishing work before or faced such loneliness and deprivation day after day. The dream of returning to their loved ones a rich man must have sustained many. According to the Marysville Appeal, a traveler to Marysville reported miners on the

river were making \$5 to

\$10 dollars a day, "He speaks in glowing terms of the country around and the cordiality shown him by the miners".

Though people of all nationalities and skin colors worked side by side at all the bars up and down the Yuba, their long held prejudices and discriminatory beliefs brought from home still ruled their actions. In July 1849 a resolution was passed at Long Bar that "a Negro could not hold his own claim." Chinese and American Indians also were held in low regard and had few rights.

By now 1000 people lived at "The Bar". Stores, saloons, hotels, bakeries, even laundries provided services miners, investors, and visitors. Crime increased as the population grew; men already under incredible stress had short fuses when challenged. In November 1850 as One beat a shop keeper described in the Marys- to death in Rough and

ville Appeal, W.E. Villey was charged with attempting to poison Captain Kirkpatrick, his son George, and Mr. Donato. All the victims recovered but motive is lost to the passage of time. Perpetrator and victims were all Long Bar residents. An increasing population brought confrontations between men over mining claims, thefts of equipment, or the favors of the rare woman. Solitary isolated men far from home and family were ill equipped to settle disputes peacefully. Around the end of 1850 disillusionment about the increasing scarcity of gold fueled murder, hangings, and rapes. According to "Gold Dust" by Donald Dale Jackson, British convicts exiled to Australia had made their way to San Francisco and up through the Northern mines wreaking havoc.

Ready as he pleaded for his life.

At first gold mining at Long Bar was thought to be a summertime activity but miners soon learned high rushing water from winter storms deposited new gold along the river banks. Miners moved swiftly to mine the new sites and mining became a year round job. By 1850-1851 previously worked claims were being worked and reworked, some for the third time.

It is unknown when Jacob Hoss arrived to mine for gold at Long Bar but it is known he was there approximately from 1853 to 1856. A letter to his son in January 1856 depicts the mining life in stark terms." Mining is not like when we first come here it is all chance if a man gets a claim that will pay wages. The country is overrun with men that are working 1 and 11/2 cent dirt and think they have good claims. The times in this country are pretty hard right now. Provisions are high, flour is \$6 per 100 pounds. A good cow and calf will bring a hundred dollars. Chickens bring 2\$ a pair. I am going to try my luck at mining once more and if I have none I am coming home pile or no pile if I live and have my health." Sadly, the next letter received by the son, Henry Hoss was dated November 1856 from No. 1 Sons of Temperance, Long Bar Division "my painful duty to inform you of the death of your father Jacob Hoss. He died on 5th of November last of no disease in particular but it seemed from the effect of old age and debility more than anything."

"He has finally gone to that House from which no traveler returns". The letter writer David Fairfields goes on to assure the family that Jacob had faithfully kept his pledge{ to abstain from alcohol) and was "much beloved and respected by not only the Brothers of the Order but by the community at large". The Order arranged the burial with the" usual ceremonies" he "was followed to the grave by a large procession of the citizen generally". It is assumed by family that Jacob is buried at Long Bar Cemetery but this is difficult to confirm. Only three headstones are visible, the remaining 26 are buried under 10-15 feet of river rock and debris shot down the canyon from high pressure streams of water from hydraulic mining.-
