## Dear Dog Owner

New Dog Licenses Sign at City Hall

Marysville City Government is trolling for ways to lift money from the pockets of citizens.

The City Council snookered residents in June 2016 to increase the sales tax rate to 8.5%. The added cash stream was to "save" police and fire. However, all city employees recently received raises. The council is using the money for whatever it wishes.

Next, businesses are being assessed up to \$75.00 for an annual fire inspection fee. Inspections had been suspended for years and there had been few commercial fires, but the council thought businesses should pay them another \$75.00. Business people and residents wonder what their various taxes actually cover.

Now, a letter addressed "Dear Dog Owner" says that "Marysville Municipal Code Chapter 8.12 requires that all dogs within the City of Marysville be licensed." It is unclear whether only dogs residing in the city trigger the license or canine visitors pay-up as well.

The annual fee is \$6 for altered dogs and \$24 for unaltered. The license is valid only as long as their rabies certificate is current. Of course, there is a late fee of \$10 for no compliance within 45-days of receiving the anonymous letter.

The boiler plate "Dear Dog Owner" letter closes with no name, just the "City of Marysville - Finance Department." And, the letter was not received by all dog owners. Residents are wondering whether this is one of those Nigerian email-style scams since the letter is void of names. Councilmembers were not aware of

## YCPD Conducts Successful Distracted Driving Effort

Yuba City, Ca.

During the month of April, motorists caught violating California's distracted-driving law received a clear message from law enforcement during the high-visibility enforcement campaign.

"Using a hand-held phone for calls, texting or apps while driving is something we all know is dangerous and wrong, but too many drivers are doing it anyway. So when we see it, we show zero tolerance," said Lt. James Runyen, Yuba City Police Department.

The Yuba City Police Department issued 71 citations to violators of California's distracted-driving law during the recent

enforcement period. The law provides that it is illegal to hold and use a cell phone while texting, calling or using the apps while driving. It must be affixed to the vehicle, may be operated in hands free mode using voice activation, or used with the motion of a single swipe or tap of the driver's finger.

"Distracted driving kills too many people for us to ignore the facts and pretend it's okay—it is never acceptable to text and drive," said Lt. Runyen. According to the latest data from the U.S. Department of Transportation's National Highway Traffic Safety Administration, 3,477 people were killed nationwide, and another 391,000 were in-

jured in motor vehicle crashes involving distracted drivers in 2015.

Offenders caught texting and driving will face tickets totaling at least \$162, and higher for a second violation. Though the high-visibility enforcement effort is over, law enforcement officers will continue watching for distracted drivers to make sure all motorists keep their eyes on the road and their hands on the wheel.

This campaign is funded by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.

## Samayoa's Agenda More Debt

Marysville Mayor Ricky Samayoa's glowing perspective of the city's rebuilding agenda in the May 13 Appeal Democrat was bold on objectives and coy on how it's possible. A look at the details is troubling.

The mayor loves the city. That's good. Let's assume residents in Marysville either like the city or are financially mired here. People don't run toward gritty towns full of vagrants.

Everyone wants better roads and parks, and a clean Ellis Lake. However, few people want speculative management that created the city's fiscal mess in the first place. They want a city that can pay its bills.

The mayor's first move when elected was to conclude that the city's B Street lakefront property didn't sell due to poor marketing. He convinced the council to re-bond the property which will cost residents around \$17million over 25 years. The 5-acres are valued at about \$1.5 million. His marketing insight has come up short.

Now, the city has the highest sales tax rate in the region. The mayor says those taxes have enabled the hiring of 3 police officers and 3 firefighters. He left out the fact that all city employees received raises. The tax increase continues for 10-years and can be used for anything.

Although the city has been basically bankrupt due to the B Street real estate speculation, the mayor's article mentions no funding source for the \$4-5 million for paving roads and improving parks. The council is actually discussing borrowing millions more indebting city residents again for 15-20 years. These bonds or loans plus interest would be repaid from SB1 (Gov. Brown's Road Tax) and Measure F (Marijuana Dispensary Taxes) monies.

The B Street property was purchased with borrowed money by city council members with no real estate experience. Their

# Dear Dog Owner

the finance department's move.

In the unincorporated areas of the county dog owners receive a personal letter regarding licensing where the owner and the dog(s) are referred to by name.

State law requires that cities only collect dog license fees in order to recoup costs related to city animal control services and Marysville's municipal code refers to the law. The City's code mentions the animal control officer position and describes the work of the officer.

However, the City does not have an animal control officer nor does it offer the typical services for animals. A Marysville

resident called the City asking whether it had an animal control officer and was told it did not. The citizen then asked who to call for animal control services? The City employee said to call Yuba County Animal Care Services (YCACS).

YCACS told the City resident that it does not provide regular animal care services within the City of Marysville. YCACS serves the unincorporated portions of the county.

The Yuba County Sheriff's website says that YCACS transports stray injured animals to veterinarians for emergency care; rescues animals from locked vehicles and

abusive or negligent conditions; provides assistance locating services for wild animal removal; impounds loose and stray animals; administers a rabies control program; helps citizens resolve nuisance problems such as complaints about barking dogs; investigates dog bite complaints; assists emergency response agencies; educates pet owners on the importance of spaying or neutering their cats and dogs; responds to animals in disaster situations and co-sponsors low-cost vaccination and spay / neuter programs.

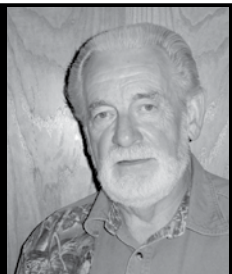
YCACS also provides a 24-hour-a-day response for injured animals, those involved in biting incidents and when there is a health or safety threat. YCACS also assists fire and law enforcement agencies in its jurisdiction.

Marysville people are wondering if the letter is for real and if so, what they are paying for when the City provides no animal care services.

# FISHIN' TALK

A lot of years ago salmon could be found in just about any ditch that could hold water when the fish migrated upriver to spawn. It was common to find salmon in ditches that fed the rice fields. In fact my cousin Dick and I used to see them when pheasant hunting in November, their dark backs out of the water in the early morning sunlight. Most or I should say just about all of the salmon found in these areas were beat up and dark skinned. In other words they were on the verge of dying, which is natural for salmon. They come up the rivers to spawn and once this task is done they pass on.

Once in a while we could run into a fairly clean fish stuck in a narrow irrigation ditch in the middle of an alfalfa field. Back then my cousin Dick and me, he was nine years old and I was twelve, would be instructed by our folks to find a good one and "catch" it for dinner. By catch my Uncle Ralph told us to go into the barn for a pitch fork. The farm grew alfalfa so there were several forks available.

The drainage ditches were narrow, about two feet across, so straddling one was no problem. The problem was to get the fish to slow down enough so one of us could use the pitch fork like a spear and bring the fish unto dry ground. We accomplished this by me straddling the ditch with

the pitchfork in hand and Dick getting past the fish and then wading down the ditch towards me. This caused the salmon to take off like a race car. It was difficult to hit the fish as it passed between my legs and we missed more than we hit and went back to the house empty handed.

When Dick or I, who ever had the fork, was successful we had our hands full. The salmon were fighters and it was a real job keeping the fish in that spot and finally tossing it on dry land. Back at the farmhouse my Aunt and Uncle, along with us kids helped cleaned the fish,

cut salmon steaks and chunks and Uncle Ralph smoked the rest.

Back in the 40's no one thought about breaking the law. Times were tough and it was a matter of feeding the family. We hunted and fished for most of our food and grew most of the vegetables.

In this day and age a person, even a boy would get into trouble fishing in the manner above. You might say it wasn't fishing, but just bringing food to the table.

Closing thought: "Sometimes the best therapy is a long drive and music."

## Bat with Rabies Confirmed in Yuba City

Yuba City, Ca. On Sunday, April 30, 2017 an injured bat was found on the east bank of the Feather River located south of the Sutter County Boat Ramp in Yuba City, California. Several concerned citizens attempted to render first aid to the bat. The animal later died and reported to the Sutter Animal Services Authority. The bat was collected by Sutter Animal Services Authority and was tested and confirmed as having rabies. In 2016, Sutter Animal Services Authority collected three bats with confirmed rabies from this area of the Feather River and several pets living in that area were quarantined as a safety precaution. ## WILLIAMS

The community of Williams, located ten miles southwest of Colusa, was originally named Central. On August 10, 1874, a post office was established in this area which included a stage stop from Sacramento enroute to the Oregon Road and was regarded at that time as the "center" of the valley.

However, in early 1876, William Henry Williams, a large landowner, gave the Northern Railway right of way through the community along with an interest in 200 acres of land. In so doing, Williams "induced" the officials to establish a railroad station at Central. Soon after, Williams began circulating maps showing the advantages of purchasing lots in the area. When the town was platted, it was named Williams in his honor.

Born in Maryland in 1828, Williams first arrived in California in 1850. Pursuing a variety of unsuccessful occupations over the first few years, he finally settled in Colusa County near the present site of Williams in 1854. Over time, Williams became a promoter of his sheep which he purchased from the east. In addition, he made extensive investments in surrounding land where, at one time, he had accumulated over 7,000 acres.

By the time the first

train arrived on June 23, 1877, the once "hastily-constructed" buildings in Williams had been replaced by "handsome" dwellings of substantial brick blocks, formed by clay which was located nearby. In fact, from large warehouses to churches and school-houses; from businesses to private homes--brick was the choice of construction.

As the community began to grow, it became a shipping point for grain. The Stovall-Wilcoxon Company built a large warehouse with a capacity of 15,000 tons near the tracks at the railroad station. In addition, Williams, the town founder, erected a fire-proof brick structure with a storage capacity of 10,000 tons.

Soon the bustling community included a variety of trades and professions along with a bank, an express office and post office, and a two-story brick schoolhouse, the "pride" of the citizenry. In addition, the community boasted of two general merchandise stores; a drug store; a tin shop; a paint shop; along with three blacksmiths shops and two livery stables.

There were also two hotels, a restaurant, a barber shop, a lumberyard, an ice house, a meat market, eight saloons, a flouring mill, two variety stores, and three

millinery and dress-making establishments.

The public halls, also constructed of brick, included an opera house and an Odd Fellows' Hall. In addition, the Catholic and Methodist churches served the community and outlying areas.

On August 18, 1887, a newspaper--the Williams Farmer--became indispensable to the farmers for weather forecasts and to the businessmen who watched the Stock Exchange. Over the years, Seymour H. Callen, editor and proprietor, used his newspaper as an "active agent" in the promotion of the local interests of the community of Williams.

Williams also benefited by the many mineral springs located in the foothills. In order to reach those areas, travelers first arrived in Williams by train followed by a stage ride that went once a week to the various destinations including the Bartlett, Alans' Cook's, Wilbur, Fouts, Hough and Sulfur Springs.

And like so many Colusa County communities, it took the foresight of one individual who saw the potential in settling in Williams as well as many others who envisioned the permanency that it would offer.

**CFMG Takeover at Yuba County Jail**

Yuba County Jail medical services have been put out to bid. The deadline for bids was 5 pm March 17. California Forensic Medical Group (CFMG) had job postings for all the clinic staff FOUR days prior to the bid deadline. The deadline was subsequently extended to March 31. The May 23 Board of Supervisors meeting will likely finalize the takeover.

CFMG, which has been involved in hundreds of lawsuits, has already metastasized to at least 27 counties in California, including Butte County and the very recently contracted Sutter County. Most of the current (Sutter) and future (Yuba) dis-

placed employees live in the Twin City area. These are also union jobs being lost.

The inmates receive very good single payer health care, despite the fact that the clinic is understaffed. All U.S. residents deserve this level of care. But jails and prisons, like public schools and the U.S. Postal Service, are starved of funds (look up the ridiculous mandate to prefund postal worker retirement 75 years in advance in just 10 years). This is the formula of the 0.1% (the corporate masters of the millionaire Congressman and Senators -- who, by the way, have Cadillac-tier health care at taxpayer expense):

Starve it, force failure, privatize it.

Contracting out public services is not the answer. Corporations are driven by profit, not quality. More money will leave our community, via profits, wages, etc. Shareholders demand a return on their investment, CEOs command exorbitant salaries and perks, and these are accomplished by cutting corners -- and quality. Never mind that they don't live here and have no personal investment in our inmates and community.

**Taxpayers Need Sanctuary from Foolishness**

Grandstanding California politicians seem intent on outdoing each other in finding new ways to appear to be resisting the policies of our new president. Efforts to ban cooperation by local agencies with the federal government on immigration issues include working to make California a "sanctuary state."

As prominent elected officials beat their chests in defiance of federal law, they ignore the fact that their actions could jeopardize the wellbeing of millions of Californians who depend on the hundreds of billions of dollars Washington provides our state, the majority of which goes to support vital services to our most vulnerable citizens.

While the governor and the majority of the members of the Legislature seem intent on putting California's share of federal dollars at risk — sort of like playing Russian roulette only the gun is aimed at the heads of taxpayers and the needy — there is an alternative. Assembly Bill 536 (by this column's coauthor Assemblywoman Melissa Melendez) would protect the billions of dollars California currently receives in federal funding.

Assembly Bill 536 allows counties to opt out of any state laws that may

result in a loss of federal funding. By electing not to implement a state law that jeopardizes funding, counties will then work directly with the federal government to receive the allocations to which they would otherwise be entitled.

While the majority of lawmakers may see themselves as heroically standing up for their principles, they don't speak for millions of California who depend on federal dollars to help them survive. And they do not speak for taxpayers who do not want to pay new taxes to make up for the mistakes of irresponsible politicians and their misguided laws.

This is not a trivial issue, although one might think so after listening to the Sacramento leadership. Approximately 40 percent of California's budget is allocated through the federal government. California receives \$368 billion in federal funding, or about \$9,500 for each Californian. The funding is most prominently used for welfare benefits and retirement pensions; however, the federal government spends money in various capacities in California — from infrastructure upkeep and maintenance, to assisting refugees.

Here are a few examples of what is at stake:

- California's Department of Health Care Services received almost \$54 billion from the federal government in order to provide health care services to millions of low-income and disabled Cali-

fornians each and every day.

- California's Department of Education receives almost \$12 billion from the federal government, which include K-12 and higher education.

- California's Department of Social Services, which is responsible for the oversight and administration of programs serving California's most vulnerable residents, receives \$7 billion from the federal government. Those programs include food stamps, child welfare and veteran services to state a few.

Average Californians are desperately in need of sanctuary. They are the ones in need of a "safe space" where they are protected from the frivolous yet dangerous actions of the self-aggrandizing political elite who are gladly putting the welfare of so many at risk. Lawmakers should pass Assembly Bill 536 and allow county boards of supervisors to spare their constituents from a disruption of federal benefits.

**Who Is Acting FBI Director Andrew McCabe**  
Excerpts from Daily News



McCabe, 49, began his career with the Federal Bureau of Investigation (FBI) in 1996. After 20 years with the FBI he was promoted, by Director James Comey, to deputy director in early 2016.

But McCabe's tenure as deputy director has

had its share of partisan strife; most notably in October when it came to light his Pediatrician wife, Jill McCabe, had landed a \$467,500 donation for her 2015 state Senate run from a PAC tied to Virginia governor and longtime Clinton ally Terry McAuliffe.

Jill McCabe wound up losing that election; but news of the donation last fall prompted outcry from Republicans, who pointed out her husband was later tasked with overseeing the FBI probe into Clinton's use of a private email server.

Mr. McCabe is also a long time friend of Hillary

Clinton campaign Chairman John Podesta. Mr. Podesta is a long-term associate of the Clintons and was President Bill Clinton's Chief of Staff from 1998 until 2001. Mr. Podesta also owns the Podesta Group with his brother Tony, a major lobbying firm and is the Chair of the Center for American Progress (CAP), a Washington DC-based think tank. Mr. Podesta is deeply involved in the Hillary e-mail scandal.

McCabe on Feb. 15 told White House chief of staff Reince Priebus a New York Times story detailing Trump campaign aides' alleged contacts with Russian officials prior to the election was not true, according to multiple reports; possibly violating Justice Department rules that govern contact between the White House and FBI officials.

McCabe became acting director after President Trump fired FBI Director Comey on May 10, 2017.

Aside from McCabe, possible names floated for the gig include former NYPD Commissioner Ray Kelly, Milwaukee County Sheriff David Clarke, New Jersey Gov. Chris Christie and Rep. Trey Gowdy (R-S.C.). This is the short list as of May 12 and will surely change by the time this is printed.

## CA Public Employee Unions Push Bill To Block Public From Negotiations

Democrats advanced legislation supported by public employee unions this week that would block the public from seeing collective bargaining negotiations between labor and government until they are complete.

Assembly Bill 1455, introduced by Assemblyman Raul Bocanegra (D-Pacoima), passed the State Assembly Judiciary Committee on a party line 8-3 vote.

According to the floor analysis, AB 1455 "[ex-empt]s from required disclosure under the California Public Records Act the records of local agencies related to collective bargaining if those records reveal a local agencies deliberative processes, impressions, evaluations, opinions, recommendations, meeting minutes, research, work products, theories, or strategy...".

If AB 1455 becomes law, it will end the last potential route for the public to know the details of negotiations and to have input into the negotiations themselves. Without public disclosure through the California Public Records Act, the first time

the public knows about the "deal" is when it is released for a final vote - when it is usually too late to change the terms.

Why would employee unions want to exclude the public from this process? Maybe it is because collective bargaining negotiations have seen drastic increases in total compensation to public workers, including benefits as well as salaries. It is this process that has created massive unfunded pension liabilities, as politicians (often elected with the help of the very unions with which they later negotiate) often reach deals that are much better for the unions than the taxpayers.

I am personally very familiar with this process, as I was involved in litigation about a year-and-a-half ago that prompted the unions to advance this legislation. The County of Orange had entered into collective bargaining negotiations with the Orange County Deputies Union. I filed a request, under the California Public Records Act, for any and all documents

in the possession of the county having to do with the negotiation. When the county indicated that it was going to comply with my request, the union filed a lawsuit against the County (naming me as an interested party) in Superior Court, trying to block the records from being released.

The county's counsel, as well as my own attorney, Craig Alexander, were very effective in the courtroom, and prevailed before Judge Craig Griffin, who ruled against the union. The judge cited the important role of public awareness in a democratic form of government. The documents were released to me, and revealed an outrageous compensation increase for deputies. But the delay caused by the court proceedings meant that the information had no time to reach the public.

The fact that this new legislation is sailing through the legislative process without nearly a peep from anyone in the media speaks volumes about how the mainstream media don't want to poke public labor unions in California.

plan was to flip the property to a developer. Their excuse when it didn't happen? They had good intentions gambling with the city's future.

So, the mayor is gambling again, this time presuming that the new gas and cannabis taxes will make the payments for the city to enjoy improvements now and pay later. Are we 100% sure we have these tax flows for 15-20 years? SB1 is a 10 - year gig.

Next, the mayor says that "The city has agreed to spend \$145,000 on improving water quality"

at Ellis Lake. There is no mention of a funding source. However, just prior to Public Services Director Dave Lamon leaving, it was discovered that Lamon ignored filing 12- Department of Water Resources quarterly reports triggering a \$3 million state fine. The city's attorneys retained at \$10,000 a month found a legal specialist to negotiate the fine with the state.

The state reduced the fine to \$288,000 and stipulated that half could be used on a city project agreed upon with the

state. So, there is still no found money to pay the \$288,000, half of which may go to lake improvements. Is there a plan to borrow the \$288,000, as well to pay the fine and clean-up the lake?

The council is also discussing leasing up to 19 new vehicles for city agencies. The city will pay an additional \$10,000 per vehicle over 5 years to lease versus purchasing outright.

With a \$636,875 annual B Street Property payment looming over the city for 25 years shouldn't the voters have a say in borrowing more money? They are the ones who are stuck with the debt after council members are long gone.

Has the mayor or council members ever heard of living within your means? The council is doing no favors by fixing up the city while incurring more debt.

His 6-year-old solar train has six batteries that are usually charged by a solar panel on the roof, but he can also plug it in and charge them with electricity.

Cowboy Ken designed the train over a period of 4 1/2 years before having it custom built in Belgium. It is made out of completely recyclable materials, and if he ever needs a new train, he will send it back to Belgium, and they will use the different parts to build a new one.

It is the only solar, battery-powered train that runs without being on a track in at least six Western states — California, Oregon, Washington, Ari-

### Flower sales peak for Mother's Day

With Mother's Day coming Sunday, California flower growers and shippers are hopping. For many, Mother's Day marks the busiest floral holiday of the year. Growers say they're shipping lilies, tulips, ranunculus, irises and foliage for spring bouquets. California produces more than three-quarters of domestically grown flowers. But imports have taken a large share of the U.S. market, so California growers urge buyers to seek out domestic blooms.

### Cherry harvest accelerates

A good start to their fast-moving harvest encourages California cherry growers. Cherries appear to have avoided serious problems from rainy spring weather, and farmers report a good-sized, high-quality crop. Harvest has been accelerating in the southern and central San Joaquin Valley and will soon move into northern districts. The California Cherry Board says it expects the state's overall crop to be larger. California cherry harvest will continue until mid-June.

### Shelters in river provide salmon habitat

Work has ended in what's considered a first-of-its-kind project to benefit chinook salmon in the Sacramento River. A Northern California farm partnered with state and federal agencies to place 25 salmon shelters in the river near Redding. Made of tree trunks and root wads bolted to boulders, the shelters allow juvenile salmon to avoid predators and fast-moving water. Experts will evaluate the shelters' effectiveness in helping salmon in the river.

# Industrial John Deere's They Weren't Always Green

World War I was a major influence on manufacturing in the world.

The business of agriculture was dramatically influenced as farmers were required to feed the masses well beyond feeding themselves and their neighbors. This production saw the development on new and constantly improved machines, seeds, fertilizers, irrigation and management of the farm. Government involvement with new regulations, price controls, production control of crops, and subsidies burst on the agricultural scene. WWI caused an over production of food and was influential in setting the stage for the Depression of the early 20's.

Some agricultural manufacturing companies survived and some did not. Those who did focused on quality and designing products that met the changing needs of the farmer as we switched from animal power to machine power remained in business.

New inventions with appropriate patents began to appear. Evolution of machines to improve production and profit became paramount for the farm.

As we came out of the Depression of the early 30's, a revival of optimism added vigor to our economy. Farmers slowly began to have capital to purchase new improved equipment.

Many manufacturers of ag equipment modified and began to produce machines for focused markets.

One such company was John Deere. Their inner circle of designers saw a market in the Industrial realm. They began to contemplate the modification of tractors for specialized use by industry. This article will present a brief overview of the John Deere L and M series. Following articles will present information on the A, B, and D.

The John Deere L began life as an experimental, the Model Y. The 62, the Unstyled L, the Styled L and followed by the LA. The L was manufactured from 1937 to 1946 and the LA from 1941 to 1946. The early Industrial was built from 1938 to 1941, and the late from 1942 to 1946. The engines that were used in the series were the Novo, Hercules and finally a John Deere designed vertical twin L head engine.

It was thought that if

anyone could drive a Ford Model A they could drive a John Deere L. The original had a Model A transmission (later a John Deere design), a foot controlled clutch, and individual rear brakes.

The Industrial version appeared earlier, but was not an official LI until 1941. Modifications included a lowered and wider stance. This was accomplished by a longer front axle, shorter vertical spindles, and spacers on the rear wheels. The final drives were rotated a quarter of a turn. The transmission was changed to include a highway gear for a faster speed when in transport to job sites. The gas tank size was made larger to increase engine run time.

The first official serial number was 50001. Approximately 1,000 were built. The LI was available in yellow, green, burnt orange, special yellow, special orange, and Tennessee Orange. Other colors could be applied upon customer request.

When WWII ended, a plethora of new products appeared on the American scene. This was certainly true in the tractor world. Greatly improved hydraulic systems came into use. The tight patent of the Ferguson Three Point disallowed it from being copied until 1952. Therefore, companies like John Deere continued to improve their lift systems and introduced what they called Touch O Matic. This lift was used on the newly introduced M in 1947. The M replaced the L. It was a higher horsepower, tractor that could pull two plow shares. The improved two cylinder engine could produce 14.65

hp on the drawbar and provide 18.3 brake hp. The Touch O Matic lift allowed for a front and mid mounted cultivator. It could also be used to lift the right or left unit independently.

The farmer could buy a M, MT (wide, narrow, tricycle), MC (crawler) or the MI. The MI as the LI aimed at the highway mowing market and about 1,000 were produced.

The MI was lowered by rotating the final drives and changing the front axle and spindles. This eight inch lowering was complemented by a slight off -set to reduce the possibility of turning over on hillsides. The operator sat in a padded seat with a back rest. Some of the features of the LI were also included. When viewing Ms you may see different front axles and hitches. The steering wheel is adjustable making the MI a pleasure to drive. A standard painting scheme featured yellow with black lettering.

Both LI and the MI are 5 star rated collectability on a scale on a scale of one to five.

The MI is a great little tractor, fun to drive, easy to get on and off, and gives the operator a special feeling of happiness when on a country drive
