Victims Lose on Liberal Crime **Policies**

Liberal legislators in California have been on a mission to overhaul the criminal justice system. This time, it is bail reform to benefit the accused and those convicted of crimes. Lawmakers say the bail system is unfair to those short of funds. However, new legislation displays no concern for those victimized by criminals.

Senate Bill 10 and Assembly Bill 42, if passed, would change the pre-trial process, largely doing away with the bail bond system. Instead, those charged with or convicted of "non-violent, non-serious felonies" (including residential burglary) and misdemeanors would be released on their promise to return for court appearances.

The proposals would also change the bail schedule, now based on the seriousness of the charges, to a new approach where judges must establish bail at the lowest amount possible to discourage the subject from being a flight risk.

Currently, if defendants or those convicted do not return to court, their bail would be forfeited whether costing them or the bail bond company. The new approach removes the financial penalty for a failure to appear, but there is more.

The legislation's new plan undermines the role of crime victims in the judicial process despite the passage by voters of the 2008 Crime Victims' Bill of Rights or Marsy's Law. This law ensures that victims would have, among other rights, the ability to have a voice in the criminal justice process.

Under Marsy's Law victims' rights are to be preserved by the court, district attorneys and law enforcement. Unfortunately, these entities have done poorly at honoring the law in some jurisdictions including Sutter County up until the departure of former District Attorney Carl Adams. Adams had a token Victim Services office and little passion for assisting victims.

Under the current system, the pre-trial release of someone charged with a crime takes place at an arraignment hearing. California's Constitution requires that victims be notified of public hearings, have a right to be present, and be able to make a statement to the judge. These rights not only ensure that victims are treated with respect, but also allow the victim to have input on potential conditions of release.

SB 10 and AB 42 would for misdemeanors and some felonies eliminate an arraignment hearing where victims have rights and could have a say before a judge. This would be replaced by an administrative process where an agency would make an evaluation and decision for release without need of bail and without input from victims.

Victims fearing for their safety would have no opportunity to argue for a high bail, a stay-away or restraining order, nothing. Unless the legislation is amended, it looks like a step back to the Dark Ages for victims.

Years of getting tough on crime using determinant sentences and the 1994 Three Strikes Law saw the prison population spike and crime rates fall. Incarcerated criminals do not victimize com-

Now, Three Strikes and determinant sentence reform have released thousands of prisoners. What has changed about these prisoners to benefit the community?

When politicians and groups like the American Civil Liberties Union argue for reducing sentences and bail they tout fairness to defendants and cost savings to the taxpayers for housing fewer inmates. However, they rarely explain that society pays a cost for being victimized. Costs per average incidence in 2008 dollars vary depending on the study, but it is expensive: murder \$8,982,907, sexual assault \$240,776, assault \$107,020, robbery \$42,310, arson \$21,103, vehicle theft \$10,772, stolen property \$7,974 etc. to vandalism at \$4,860.

When voters passed Proposition 47 it redefined many felonies as misdemeanors. If the crime loss was under \$950 (shoplifting, grand theft, receiving stolen property, forgery, fraud, writing a bad check and use of illegal drugs) it was now a misdemeanor. But, Prop 47 had some unintended consequences.

Semisi Sina, a 30-year-old meth addict, steals bicycles to support his habit. He skipped out on drug treatment 5 times in 12 months. He has 16 arrests and a reputation with the L.A. County Sheriff's Department" Los Angeles County Sheriff's Department. He says the new law made it easier for him to commit crimes.

Sina was thrilled when he first heard about Proposition 47. He said he didn't start stealing bicycles until the proposition raised the threshold for a felony theft to \$950.

"Proposition 47, it's cool," Sina said. "Like for me, I can go do a [commercial] burglary and know that if it's not over \$900, they'll just give me a ticket and let me go."

"I know it's up to me to change. I wasn't ready. I probably still am not. I'm not going to lie - I'm still not ready to quit," he said on a break from shoveling dirt at a sheriff's training facility in Whittier.

Incarceration may not change Sina, but there are fewer citizens losing bicycles when he's behind bars.

Striped bass are running strong in the Feather River at this time. Lots of fish being caught with some in the 20 to 40 pound range. The fish are hitting on cut bait, pile worms and minnows. A few sturgeons have also been caught in the Feather.

We expect Shad to be in local rivers any day now. These fish normally show up in the Sacramento River about now and the fish are expected to be in all rivers by the end of April.

Local river guide **Jimmy** Zanocco passed away on April 6th. Jimmy was one of the first guides in our area and he was an amazing man. We send our thoughts and our condolences to his family. Rest in Peace, Jimmy.

The Department of Fish and Wildlife have been busy preparing for the upcoming trout opener the last Saturday of April. So far plants have been placed in the Sacramento River and Mc-Cloud River in Siskiyou County; Kilarc Reservoir and the Sacramento River in Shasta County and the Susan River in Lassen County along with plants in the southern part of the

Reservoirs in the North State are beginning to clear up which means good fishing now into early summer. Our weather source has


As we stated earlier the ocean salmon count is low enough to force authorities to either close the season or restrict it to a shorter time frame. I personally have had

my share of close calls with rattlesnakes. The snakes are out now and will be in unusual areas due to the high water conditions. Rattlers are active from April to October with their living areas covering from the Pacific Ocean to the Nevada Dessert. These poisonous snakes will attempt to avoid you unless you try to pick them up or surprise them in any way and of course if you corner them. Be aware they could be found this year inside city limits and in subdivisions. If you get bitten, try to stay calm and get the victim to the nearest medical facility ASAP. 


Overflow parking is available at Rose Bar School for those coming from Marysville and Yuba City. The free parking shuttle will take you from the Rose Bar School to the festival location.

In Loving Memory Eleanor Mackensen 1934 – 2017

Born in Los Angeles on May 29, 1934, the only child of LeRoy and Wanda Starke, Eleanor grew up in Canoga Park CA, and moved with her folks to Sutter County at the end of WWII, joining Wanda's sisters, Ruth and Clara as individual orchard keepers on the County's fertile



land. Eleanor attended Brittan School and Sutter High School, attended Brigham Young College and was employed by the California Board of Nursing Examiners in Sacramento.

In 1954 she met 2nd Lt. Robert Mackensen of St. Louis County, a Mather AFB student officer. He fell for her, love at first sight, and they were married in Yuba City, and rushed back to St. Louis, where they soon had to part, she back to California, and he to RAF Station Sculthorpe in England's Norfolk County, where he had just been assigned to duty as navigator/bombardier on the US Air Force's first jet bomber, the nuclear-deterrent equipped B-45. Four months later, in England, on a particularly wonderful St. Patrick's Day, they were reunited. Eleanor and Bob enjoyed a three-year honeymoon in England, travelling—when they could—to the warmer places in Europe. Eleanor's talents blossomed. Her nail polish earned her the nickname 'Frosty', which still endures among our Sculthorpe friends. She sang in the Chapel choir, bowled, played duplicate bridge and was deeply involved in both the social and the charitable outreach of the Sculthorpe Officers Club.

They returned from England with their firstborn, Jim, to a small base in Florida, then on to Texas. They made the decision for Bob to pursue his Architectural profession (interrupted by Vietnam), and returned to California, where Bob enrolled in Cal Berkeley's Bachelor of Architecture program, with help from the Gl Bill and the dedicated support of Eleanor's work at the U.C. Admittance Office. All with time out for sons Kenneth and Eric, with our heartfelt thanks to a few very kind babysitters!

By the time Bob graduated, Wanda, Eleanor's wonderful, smart mom, had arranged for her son-in-law to be hired by a local Engineering/Architectural firm. Seems she was determined to not let her daughter escape again! She was so right! And son #4, Roger was born in Yuba City. Eleanor and Bob flourished right where they belonged... for 53 of their 63 married years. As their children matured and one by one moved out of that big, beautiful old Dutch Colonial house (sadly destroyed for a shopping center) where Orlin and Esther Harter raised their four boys, Eleanor branched out into the community. With a partner she opened a gift boutique in a historic house in Marysville and called it 'Eaglehill'. Later, with another partner and friend, she opened a small stenograph/secretarial service, and gave it the name, 'The Electric Secretary'.

She served her community in so many ways. From her many activities at First Lutheran Church and School where her boys attended grade school, to serving on Sutter County's Bicentennial Committee, to membership in Sutter County Republican Women, and in Rotary's 'Inner Wheel (she chaired both organizations at different times) to a lifetime of local choral work with all her friends in the Y/S Master Chorale, Oratorio Society and the Yuba College Symphony Chorus, finally to singing at the Berkshire Music Festival in the western Massachusetts town of Sheffield, who's first called minister, Jonathan Hubbard (Eleanor's 6-great-grandfather), arrived from Yale Divinity School in 1735 when much of the territory was still unexplored. He must have been a bit of an adventurer; because he went there on the promise they would build him a house if he brought the nails. His house and the church they built for him and his congregation still stand in Sheffield—the reason Eleanor and Bob participated in

that most enjoyable trip.

As patriotic as her husband (and all her sons have served our nation in various uniforms), Eleanor was appointed by the California Republican Party to represent our state at the 1980 Republican National Convention which nominated Governor Ronald Reagan to be our President. As a result, in the spring after his election, the California Delegation was invited to a reception-celebration the White House. Of course we attended!

Eleanor and Bob's four sons also flourished here: Jim, in Yuba City, a hereditary firefighter (maternal grandfather and great-grandfather, both Fire Chiefs in So.Cal.), now semi-retired, he remains 'on call' usually as P.I.O, with the U.S. Fire Service, together with his Interior-Designer wife, DeAnna and their family—Alex, Cassandra, Nicole & Kristina; Ken, doing control and administration with the excellent Kendall-Jackson Winery in Healdsburg, CA, and his son Rob; Eric, a math teacher at Sutter High School (Eleanor's alma mater), with his wife Kate, in a beautifully restored historic house in the oldest part of Yuba City with their three sons, Russell, Mark & Jeff; and Roger, in Sacramento, with his wife Karen, daughter Emily and son Peter. Karen is a caring teacher of kids in their early stages of learning, and he is in the State Capitol, working with the Republican Caucus, fighting a daunting battle with the political climate of California.

Heartfelt thanks—and love—to our caring children, relatives, friends and neighbors for all their kindnesses. With family members at her side, a dear only child, Eleanor rejoined her Mom and Dad on the morning of April 15. Mortuary visitation is on Friday, April 28, four until seven pm at Ullrey Chapel in Yuba City. Eleanor's Memorial Service is on Saturday, April 29, at three pm at First Lutheran, Cooper & Forbes, across from the Library, Yuba City.



Brexit

Brexit, a term coined a few years back, describes the U.K. process of its exit as a participating member of the European Union (E.U.). The E.U. is a partnership with 28 countries in the Euro area. It was established to help unify the economies and people of the member countries and allow them to operate more or less like one entity. 19 members use the common currency (Eurodollar). The union has a single parliament where certain rules are set that apply to all which include but are not limited to transport, economic regulation, consumer rights and the environment.

Being a voluntary union, a country could vote to leave at any time and the U.K. voted to do exactly that in June of 2016. The vote to leave caused a temporary downdraft in markets worldwide as uncertainty as to what it would actually mean drifted through the minds of global investors and big money players alike.

The clock has been ticking on the Brexit and now it's time for the U.K. to take the next step if this thing is really going to happen. There have been doubters that the U.K. would actually go through with it but now they find themselves at a spot where the proverbial rubber meets the

The actual mechanics

of how a county leaves the E.U. is detailed in a document named Article 50 of the original Treaty of Lisbon which was ratified in 2009 by all the E.U. states at the time. The timeframe spelled out is 24 months from the vote which would put the deadline on or about June of 2018, a date fast approaching for such a monumental move. An extension is possible but many expect if the Brexit does actually happen, it will be a done deal by summer of 2019.

Keep in mind this is the first undoing of an E.U. member. In other words, no one has ever left before. To grasp the magnitude of what lies ahead both in policy and paperwork, imagine California deciding to secede from Uncle Sam. The task is monumental on all fronts to be sure.

There are of course variations of exit that could be negotiated. A hard or soft exit would mean different things to different things, policies and people and any hybrid of possibility could be conjured up as regulators and government officials stumble along a path never before traveled. Immigration, import-exports, tariffs, taxes, treaties, security, stock and bond markets and their instruments

are all up for discussion just to name a few.

Since the whole process is uncharted territory for all involved, no can say how financial markets, economies and even the general welfare of the UK and surrounding countries will fare let alone the global financial markets.

The ramifications could easily encompass the entire civilized world in a number of ways, hopefully none of them catastrophically. Economically speaking, markets hate uncertainty and uncertainty abounds both during and after such an historical event. There is always an outside chance after looking at the task ahead, the Brexit could be negotiated into another breed of autonomy or cancelled all together but as it appears now, its full speed ahead.

County workers participating in the cleanup said they were astounded at the number of cigarette butts and filters that were picked up. According to the California Department of Public Health Tobacco Control Program, cigarette butts make up an amazing 34 percent of total litter collected in California.

Government Center organizers plan to set aside a couple of days each year to pick up trash around the building.



Allis Chalmers Model G

by Rod Hisken



Several of the major tractor manufacturers produced small tractors for the market of low acreage farms, gardeners, and light utility use. The Allis Chalmers Model G was produced to meet this requirement.

The pictured G was discovered on a farm near Sheridan California.

The Allis Chalmers corporation has its roots with Edward P. Allis and Fraser and Chalmers, a rock crushing company. Allis began manufacturing in the late 1800s and went bankrupt in 1873. Restarting the company he hired Edward Reynolds who developed the famous Reynolds -Corliss engine which dominated the power supply for flour mills, logging operations, and city electric needs.

These engines came in small versions to the nine monsters that powered the Manhattan Subway System. The big engines had cylinders up to 88 inches in diameter. Some produced 1,000 horsepower. The Manhattan Monsters required 1,000 pounds of coal a day. They had a reputation of lasting for years without need of repair.

1901 saw the incorporation of AC.

In 1912the Company began to experience serious financial needs. They reorganized under the direction of General Otto Falk who reduced the number of plants from six to two. Under resistance from others in the corporation, he started the movement into the farm equipment business and purchased Monarch in 1928. Monarch was producing track layer type machines. Acquisitions followed: 1929 La Cross Plow, 1930 Stearn Engine, 1931 Advance Rumley,1953 Buda, and Gleaner in 1955.

AC was noted for their products as being of excellent quality but they seemed to be behind the improvements that were occurring in the industry . Some lines met with mediocre sales. However, AC introduced many firsts in the industry.

Turbocharged sel Engines. 5.Live PTO 6.Dry type Air Cleaners 7.Power Steering 8.Positive Seal Idlers The Model U became famous when AC put high speed gears and promoted it at county fair race tracks . Barney Oldfield achieved an astounding 64.28 mph in 1931.

The Model B was a major catalyst to International Harvester to produce their Model A.

Early tractors were painted green and later units were Persian Orange.

In 1974 the company merged with Fiat and in 1985 they were purchased by Klockner Humbolt Deutschland and AG from Germany.

The Model G was built from 1948 to 1955. They were designed for the small acre farm, vegetable producers, and landscapers, A large array of equipment was produced to attach to the unique design. They were built in the Gadsden, Alabama plant. AC had hoped for greater numbers to be sold and production stopped at 29,976.The base tractor sold for about \$970. The little 62 Continental motor produced about ten horsepower. Weight of the G was around the 1,285 to 1,750 (lb) range. The three speed transmission option was a creeper gear which reduced speed to .08 mph.

Gs have been modified to diesel powered and electric.

Economy of operation is 7.46 horsepower hours per gallon The little G is popular with collectors because of its size and its unique configuration. Prices range from \$700 to \$10,000 depending on quality. The \$4,000 range is common for nice looking restorations. Many collectors like to have at least one G in their collection. Some just collect Gs

This Month In Your Garden by Cecilia M. Rice

May flowers", as they say, May should be an unusually pretty month that will put many people in the mood for gardening - seasoned and beginning gardeners. The weather is usually beautiful and so many plants have come to life with lovely green foliage and colorful blooming flowers. This year seems to me to be especially beautiful, almost as if the plants are celebrating the end of the drought which brought more rain and snow that we have seen in five years. May is usually not too hot, nor too cold - great gardening weather. Most of the colorful annuals that will give fast color such as marigolds, petunias, alyssum, lobelia, for sunny areas and pansies, begonias, and impatiens for the shady spots are now available and are easily planted from six packs. If you are not one of the impatient people who need instant gratification, they can be

planted from seeds. As the weather begins to warm in the spring, along come many insects that enjoy it as well. There are many insecticides for sale, some are "specific" and some are "all purpose" and one needs to check the label to be sure your needs are covered. Diatomaceous earth is an effective insect repellant for many crawling insects including, slugs, grasshoppers, fleas, centipedes, ants, cockroaches, earwigs and many others. It is quite inexpensive, easy to use and safe around pets and people. Mealy bugs seem to like citrus trees. If you notice small white dots on the limbs and in the crotches of the limbs, they are probably young mealy bugs. They grow slowly and look like a scale problem. They

stay flat and develop a white fuzzy coating that is difficult to penetrate unless a small amount of liquid soap or horticultural oil is added to the spray. When the bugs die spray them off with a strong stream of water.

As we work our way into May we frequently encounter some hot summerlike weather, so be ready. Check your irrigation systems and/or supplies. Drip systems should be turned on so that you can see where repairs are needed. Sprinklers should be checked to be sure they have not become plugged and that they work properly. It will be time to restore basins around any trees or plants that had been cut to allow for drainage during the winter. They will be needed for deep watering again for the summer season.

Roses are setting nice buds and some beginning to bloom as I type this, so they should be in their first beautiful spring show of the season by the time this is being read. Be sure to dead-head them and fertilize them regularly to keep them blooming. Spray them with a fungicide or Neem oil at the first sign of a fungus infection (Black Spot, Powdery Mildew or Rust) because they can

spread quickly and be difficult to conquer. Those first flowers are often large and beautiful. As the summer heat comes the size of the flowers usually become somewhat smaller, but still lovely.

Many people have asked if it is too late to plant a vegetable garden. It is not too late. Many people purposely wait - they feel more confident that they will avoid a late season freeze and that being a bit later is no problem since they will quickly catch up to the other gardens planted nearby.

Just a reminder – if you have camellias, keep the fallen flowers raked up. As they decompose they can harbor a fungus that can damage the plants. If you have rhododendrons that have bloomed, the flower truss should be snapped off at its base and discarded. If they are not removed the plant will spend energy making seeds and may not bloom the following year. It would be a shame to miss them.
