Pony Express Comes to Pioneer Day

Members of the National Pony Express Association, California Division, will be at Pioneer Day in Smartsville, April 29. Although specific details have not been finalized, their presentation may include horses and riders, a mochila (mail pouch), and stories of the brave, young messengers that risked their lives to bring speedy mail delivery to California.

In the late 1850s mail and news was brought to California by stage coach. By today's standards it was very slow, about three weeks from the Midwest to San Francisco. Sensing a business opportunity, Wm Russell, Alexander Majors, and Wm Waddell created the Central Overland California & Pike's Peak Express Company, to become widely known as the Pony Express. The new mail service was to be a fast and continuous relay of mounted carriers.

The 1,966 mile route from St. Joseph, Missouri to Sacramento followed existing wagon roads with the portion through California and Nevada along what is now Interstate 50. The riders were young, fearless, and light, not exceeding 125 pounds, mostly teen-age boys. Riders ran the horses hard for 5 - 10 miles with a fresh horse at the next station. There were about 80 riders and 400 horses needed. From Missouri to San Francisco, Pony Express

cutting the stage coach time approximately in half.

Mail was carried in a mochila, a specially designed pouch that draped over the saddle and was secured by the weight of the rider. In each of the mochila's four corners was a cantina to hold letters. The mochilas and the cantinas within them were locked and could be opened only by the mail officials at each station.

There are many stories about individual riders that illustrate the dangers and adventures of the Pony Express. My favorite is about Robert Haslam, known as "Pony Bob", who regularly rode from Friday's Station at Lake Tahoe to Buckland's Station near Fort Churchill, 75 miles to the east. On one occasion when Pony Bob reached Buckland's his relief rider was so frightened over an Indian threat that he refused to take the mail. Bob agreed to ride the additional distance east to Smith's Creek for a total distance of 190 miles. After a rest of nine hours Bob took the westbound mail where, at Cold Creek, he mail arrived in about 10 days, discovered that Indians had at (530) 701-2639.

killed the station keeper and had run off all the horses. On the ride back to Buckland's he was shot through the jaw with an Indian arrow, losing three teeth. His 380-mile round trip was the longest on record.

Most people don't know about the short duration of the Pony Express. On June 16, 1860, about 10 weeks after the Pony Express began operations, Congress authorized a bill to subsidize a transcontinental telegraph line between the Midwest and California. As the telegraph lines were constructed going west, news was received at the Pony Express station closest to the end of the telegraph wire and then carried on horseback to the Pacific Coast. By October, 1861 the line was completed to San Francisco and the Pony Express experiment was out of business. It had lasted only 19 months. In November, 1861 the remaining Pony Express letters were delivered.

At Pioneer Day on Saturday, April 29 you'll be able to see a mochila, how the riders changed horses, and hear stories of famous rides. In addition, Pioneer Day features mining tours, music on stage, tasty food, arts and crafts vendors, children's activities, and Timbuctoo Theater historic character presentations. Yuba-Sutter Political Notes

Marysville City Council is pondering another fee on businesses, \$75 to conduct an annual fire inspection. Some cities charge and others do not.

Rather than city hall positioning itself as the easiest place around to start and do business, council members continue to mimic other jurisdictions that seek any opportunity to lift more money from businesses and citizens.

Marysville already has a water rate 3-4 times higher than Yuba City, Linda or Olivehurst. Marysville requires a business license. Yuba County does not. City enterprises now lose customers who can save 1% tax shopping 5 minutes away in any direction just outside the city limits.

Mayor Samayoa is now advocating renewing the refuse contract with Recology with a rate increase since it includes another indirect tax on residents who pay the garbage bill. Marysville gets a tipping fee from Recology which could increase as the bills go up.

Citizens already pay taxes for police and fire, but funds have been flitted away through past and current city financial miscues. The city promoted the Measure C sales tax increase with a message of fear that fire and police may not be able to respond properly to emergency needs without a yes vote. Now that the additional sales taxes are flowing in, the council wants another \$75 per business?

It is too bad voters were misled in the Measure C publicity campaign.

Speaking of Recology, the company provides a good service and is the most generous of local monopolies including contributing to people running for office. Recently, city and county boards have been debating whether to renegotiate with Recology or open the agreement up for bid since it is renewal season (contract ends 9/30/19).

There appears to be competitors interested in bidding on the contracts. While Recology should have the advantage since they have an extensive local infrastructure what is the argument against going out to bid? If the same service could be provided at a lower cost don't elected officials owe that to the citizens who pay the bill?

Households and businesses are mandated by government to use the Recology service. They must pay Recology even if they disposed of refuse themselves.

How do elected officials know they are getting the best deal? Are they experts in garbage costs? They owe a bidding process to the citizens even if Recology is proven to be the best all-around option.

Consultants were obtained by Regional Waste Management Authority to do research and make a recommendation to the various jurisdictions. Sutter County Supervisor Matt Conant was the only vote to go out to bid on his board. When he asked if the consultants had ever done any work for Recology in the past it was like he hit a political wasp nest and never received an answer.

Why be offended if the firm had never worked with Recology and was completely independent and unbiased? Conant's take was that the rates here are high compared to surrounding communities. Looks like consumers will be kept in the dark.

The removal of illegal homeless camps that caused hundreds of thousands of dollars in damage is confusing. Who permitted the settlements to be established since they are now being un-established? If we can stop them now couldn't we have stopped them before? Was there a void in political will and leadership to grasp the nettle?

If the Yuba County Water Agency is going to pick-up the tab for political blunders (300 tons of garbage) in and near waterways, maybe the agency should have its own enforcement people to protect water and adjacent properties. It seems that the city and county jurisdictions themselves should pay for their negligence and reap what they sow. Is the Water Agency's bank account being used to bail out political blunders?

Does anyone remember if the county sought the blessing of nearby residents of west Marysville or the Rescue Mission next door to have the 14 Forward homeless camp installed? No permits, no variance, no hearings, no focus groups, no foot traffic or noise study, borrowing utility services from next door, amazing. If a citizen did a 14 Forward using Yuba County's approach there would be fines and incarceration.

The government creates 14 Forward with no rules while a booming volleyball training center 100 yards away was shut down by Marysville for installing temporary port-a-potties for big weekend tournaments and lacking parking lot stripes. At what hundred thousand dollar mark will this homeless camp become a stench to politicians?

Ryancare Defeat and CA Reps

Those getting free or heavily subsidized health services are thrilled with Obamacare. Others are furious, having lost their old policies and their physicians while seeing rates increased 30% to 100% along with huge deductibles. They see the "Affordable" Care Act for what it is -- a redistribution of wealth with lousy coverage.

After seven years jawing about "removing Obamacare root and branch" Paul Ryan and associates showed themselves to be the Democrat-Lite Party by pitching Ryancare rather than setting health care free from government interfer-

Ryanites were opposed by the more conservative House Freedom Caucus, most of whose three dozen members rejected Ryancare from the start. While the group does not publish its membership, there is a list online of declared participants and others believed to belong. Notably absent from the membership are California Congress members Doug LaMalfa along with Tom Mc Clintock who left the group in 2015. There are no known California Congress members in the caucus. That is a bad sign for conservatives.

Paul Ryan's and former Congress Speaker John Boehner's sidekick, California Congress member Kevin Mc Carthy, was a backer of Ryancare. Mc Carthy was positioned to take over for John Boehner until Mc Carthy trash-talked to the media about the Benghazi Investigation undermining the House committee's work and then was rumored to be in an affair with Congress member Renee Elmers (R- North Carolina). Ryan was elected Speaker as Mc Carthy stepped away.

Caucus members say they do not trust Ryan and indicate he does not listen to them. That is bad sign for Ryan. When a leader leads but no one is following, then he is just out for

Ryancare opponents didn't want to risk eliminating Obamacare in increments after promising their constituents it would be repealed. Even with President Trump's backing of the plan, Caucus members

consider Ryan a part of the Washington Swamp that needs draining. Maybe now they will get their opportunity.

The Caucus said the plan could be repealed outright and the Ryan people said it couldn't. Who do you believe? Heritage Foundation praised the move to reject the bill along with others like conservative Senator Tom Cotton and libertarian Senator Rand

Even if Obamacare were repealed the next question is what happens if Governor Brown keeps Covered California in place? Would Californians be able to escape California-style Obamacare? And, would the legislature block other insurance companies wanting to sell to citizens

A good time to re-evaluate

Many aspects make up the recipe to a profitable business and falling down in any one area could make the difference between success and failure. Although many specifics exist for each business, there are many common themes that can help insure you don't end up in the long line of failed businesses.

Offering a good product or service for a reasonable price obviously is way up there in things you should but other not so obvious exercises should be undertaken.

Tracking inventory and sales is a must. Having a solid accounting system will help avoid mistakes when reordering, paying bills and keeping in good graces with the tax man. A good computer system and software is regarded as an absolute necessity.

Watching overhead expenses means be frugal. New businesses should not overspend. What money you do spend should be spent on the basics with the minimum of unnecessary frills. That also means not committing to a large property lease or too long of a term. Start small is the order of the day. If you have a good product or service, it will likely sell no matter how large your presentation is or isn't.

Don't overstock. Stock costs money and new businesses usually have to pay up front for items due to a lack of established credit. Keep your stock to an ab-

solute minimum required to service your customers. You can always order more of what sells and you also will be stuck with less dead inventory.

Give great customer service. The reality is that in most cases new businesses just steal customers from other businesses. Keep this in mind. Give customers a reason to buy from you. That means you must be better than the current store he is buying from, either in quality, price, service or preferably all three.

Don't worry about profit too early in the game. You obviously need to make a profit but new businesses should first garner a customer base.

Watch cash flow. An old saying in business is "cash flow kills". Mismanaging cash flow kills more businesses than not. Have at least six months of operating cash and living expenses before starting to insure you can keep the doors open.

When planning your business, be conservative in your budget projections. Under estimating sales and profit rarely is fatal but being overly optimistic usually is.

Make a business plan entailing everything you can think of. List projected sales, expenses, inventory considerations, who does what, and all the "what ifs" you can think of. Have a contingent plan for anything that may happen, as usually anything that can happen will happen. Plan for all of it.

Don't over expand. You want sales to drive expansion, not expansion to necessitate sales. This means only expand when your overabundance of sales requires it. On the flip side, having to sell more because your large overhead is eating you alive is a recipe for disaster.

Build on strength. Don't go into areas you aren't familiar with to capture more sales. You will likely only

capture more expenses. Sell only what you know and don't try to sell too many different things or expand into too many different areas. The phrase "keep it simple stupid" comes to mind.

Don't underestimate vour customers. People with money didn't get that way throwing it away on frivolous or overpriced items. Most people know a good deal from a bad one. Treat them with respect and if they offer criticism take it. For every customer that tells you what they don't like, there are likely ten more that won't say anything and just not re-

Problems are a way of installing loyalty and are a natural occurrence in any business. But in the eves of a customer problems can make or break the relationship. Think about it: Anyone can take your money. It's the person that fixes a problem to the satisfaction of the customer who will be remembered. From that moment on the customer knows if he ever has a problem, you will fix it. Not so with many competitors lucky for you.


In conclusion, draw on people who have been there. Most are more than willing to give advice and help answer questions.

cellent source the salmon this year are in limited quantities. Ocean salmon fishing will be limited this year. The latest reports tell us Eureka and Crescent City will be closed this year. In addition, other areas on the Northern California Coast will be limited. The Pacific Fishery Management Council have stated the low Klamath River fall run kings counts are down to under 51,000. Expect a shorter season in Fort Bragg, which could end up with as short as 30 days. All this bad news is credited with five years of drought, which did not allow Juvenile salmon to make it to the ocean. Many died from lack of water or warm water

We hear from an ex-

temperature. Anyone who crosses a bridge over the Feather River can see it will be some time before the river is fishable. A check with the Department of Water Resources at Oroville tells us the high water will be a factor for some time as they release water in preparation for the spring run off as well as the repair of the main spillway and the emergency spillway. We were told this effort will be underway for months on a 24/7 schedule in order to fix, repair or replace everything needed for our safety and the stability of the dam.

As of this writing the water release at Shasta Dam is down which has made the Sacramento River fishable with sturgeon and striped bass being caught on a regular basis even though the river is still high and off color. Reports tell us anglers are having fair to good luck from Colusa all the way to Sacramento.

The mackinaw lake trout at Lake Tahoe have shifted their bite to the west shore and are hanging out down to 200 feet and more. The fish are averaging from three to six pounds.

Collins Lake added another 1800 pounds of trout to their waters last week. With the water starting to clear the fishing in this reservoir should improve considerably. Our sincere sympathy goes out to Kathy Hess' family. Her passing will be a blow to all who enjoyed her fishing reports and her expertise. God Bless.

Englebright Reservoir is planning to release their pen fed trout the end of March or the first part of April.

Lake Davis, near Portola, is still iced over and very dangerous at this time. It is highly recommended to stay off the ice due to the thinning taking place. It may look alright, but one person has already broken through and had to be rescued so it is best to stay away from this body of water until the ice melts.



Best Tractors

I am somewhat uncomfortable in writing this particular article because my knowledge is very limited on track layers and I feel such respect for C.L. Best. I am also aware that the development of the company is much more complicated than a straight line. Additionally, I have a responsibility to previous authors to not copy or be guilty of plagiarism in describing C.L. Leo Best. He was one of those rare individuals who changed the world with his strong work ethic, belief in metallurgy, passion for reducing friction, seeking innovators, and settling for nothing less than quality.

However, I feel an obligation to my readers to continue the exploration of knowledge into the world of Vintage Tractors.

I found it curious when I discovered the name B.F. Walton on a letter sent to the company in appreciation for their quality product dated 1887 and that C.Q. Rideout was on the Board of Directors of Best Manufacturing in 1893. This wonderment grew when I learned Dan Sr. lived for a while on his brothers farm near Yuba City and later owned a farm close to Marysville. It is truly fascinating to me that from these humble beginnings a corporation generated \$48 billion is sales by 2008!

Rather than quote others about Dan and Leo Best I will use two of my ten business beliefs to describe their passions.

- 1. There is no future in anything less than quality.
- 2. Be more concerned about the value you give than the money you get.

My first major experience with Best Tractors occurred when I was honored to be on the committee of the "Best Show on Tracks" in Woodland in 2008. The event was much more than another tractor show. While some say it was a once in a lifetime occurrence, my reflection back is that it was historic. There is probably no place on earth that such a celebration has the proximity of equipment than within 100 miles of Woodland. Three key people to me were Dan Best Jr. who donated his land to layout and host the activity at which about 12,000 people went through the gate on Saturday and approximately 1,000 tractors were on display. The motels in Woodland were booked full by January for the July event with reservations from all over the globe. Dan's hospitality and style were inspirational. Jess Gilbertson of Knights Landing served as a leader giving generously of his time, lost much income, and waded ahead through all the trials and tribulations in a stellar fashion. I was in awe of Doug Veerkamp of Placerville who provided men and equipment in an above and beyond fashion. Their efforts were models for a large number of volunteers who took a wheat field and did the harvest, baled the straw and removed it, did the underground, put in roads, the parking areas, and designed the layout for display and foot traffic in about two weeks.

How many times in your life will you see the largest number of Holt and Best tractors ever assembled and witness 50 mules pulling a harvester.

If you have an interest in Vintage Farm Equipment your library is not complete unless you have the book "Making Tracks" by Ed and Sue Claessen. I feel it is the most accurate and complete work on the life the C.L. Best and the Caterpillar Tractor Company. The Claessens claimed "Best lived up to his name".

The Best brothers, Sam and Dan Sr, were drawn to the west by the discovery of gold. Henry settled in



a portable grain cleaner to speed up the process in 1871. The natural evolution was to develop a larger horse powered combined harvester in 1885. The use of horses was a difficult task and was expensive to keep horses or mules for the year and to be used seasonally. In 1890, Dan Sr. acquired the rights to manufacture the Remington Steam Tractor. Realizing steam had a short future, he experimented with gasoline engines of the "Hit and Miss " type. Soon, the engines were well known around the world.

Steam tractors are heavy, cumbersome, caused fires, needed an active supply for burning and water, and caused heavy impaction of soils. Dan began thinking about other means to apply power to the ground.

He used his knowledge of engines and for a short period of time had an interest in "Horseless Carriages"

Mr. Best applied for a "Sidehill Harvester" patent in 1902, Harvesting was again improved by using an electric motor to power the unit for consistent rpm operation. Overall Dan Best Sr. filed for 41 patents ranging from washing machines to combined harvesters.

Holt and Best were engaged in a long expensive legal battle over patent infringement and is detailed in Making Tracks. Best sold to Holt about 2/3 of the assets of Best. Holt requested that Clarence Leo Best, the son who by this time was a rising star, join Holt. Leo was disappointed about the quality of the Holt Company and left in 1910.

During the legal battles, C.L. acquired the patent rights for the Lombard Steam Hauler which benefitted him greatly in a dispute from Holt.

In 1910 Leo formed the C.L. Best Traction Company. Capital was provided by some banks, farmers in Woodland, and a behind the scene effort from his Dad.

bonized steel, well supplied dealerships, follow-up visits with buyers, and strongly believed that quality products were more important than low price.

C.L. Developed the oscillating roller frame and rocker joints to develop adherence continually to the ground. He also provided an improved differential steering. The Best 30 featured the "Humpback" design where the drive axel was above the track line and is used on modern large crawlers.

The "Best Snow Special" gained much fame and opened doors to other business by clearing the snow from the road to the top of Pikes Peak. The company was renowned for being a success-

ful business and paid solid dividends when others were going under. The mark of Leo's passion for quality could be

seen in spending money in his factories for overhead fire systems. The company had fifty domestic and seven export outlets by 1924. Best bought Holt and formed Caterpillar Tractor

Company on May 14 1925. C.L. was Chairman of the Board from the beginning till his death in 1951. A family from humble beginnings helped to

change the face of the world. The big yellow "Cat" respected throughout the world. The Best 110 Steam Tractor pictured is a "monster"! The operator stands about 12' above the ground. You have to watch the arrow on the front

for steering as you cannot see the front wheel. The

steering is manual wheel type and has a tiller type steam assist. The steam assist has a slight delay and it takes a few turns to get used to it. The engine is oil fired. Dick Watson from Gridley is the operator. The

young lady is Alexandra Gilbertson of Knights Landing. Francesca Ehrk, a Counselor at Sutter High and is the leader of their vintage tractor club, are going for a memorable ride.



Food and Farm News

Local groundwater agencies take shape

With a June 30 deadline approaching, agencies around California are working to finalize formation of local groundwater sustainability agencies. Under state law, the local agencies will develop groundwater sustainability plans for basins classified as high or medium priority for management. County Farm Bureau leaders monitoring the process say they're striving to keep diverse groups working together as the process moves forward.

Flood damage in orchards to be assessed

The full impact of winter flooding on Central Valley orchards may not be known for months, according to University of California farm advisors. If trees have suffered damage from disease caused by waterlogged roots, the stress might not become apparent until the hot summer months. Orchard specialists advise farmers with flooded orchards to document the flooding and the condition of their trees, and file reports of losses with county agricultural commissioners.

Spinach demand increases

The popularity of packaged salads has fueled demand for organic spinach, with at least 40 percent of California acreage now grown organically. As they plant more, spin-

ach farmers look to crop breeders to develop varieties that resist a plant disease. The fungus reduces yields, and there's no organic product to attack it. That means farmers must vary their growing methods to avoid the fungus while breeders produce new, resistant spinach varieties.

It'll be California Ag Day at the Capitol in Sac-

ramento Wednesday, as farmers, ranchers, public officials and other people gather for an annual celebration of the state's bounty. Visitors will be able to sample California-grown food and farm products, see farm animals and learn about the variety of commodities grown in the state. Remarks on the House Floor by Congressman McClintock



Any discussion of the American Health Care Act needs first to consider where we will be without it. Obamacare is collapsing. More people are paying the steep tax penalty or claiming hardship exemptions than are choosing to buy Obamacare policies. In a third of the counties across America, there is only one provider to choose and soon we will see counties where there are no providers at all. Obamacare premiums soared an average of 25 percent last year, and we're warned this year will be worse.

I have strongly advocated that the House address this crisis in a single comprehensive bill that fully repeals Obamacare and replaces it with a healthy, competitive market.

Instead, we rely on the reconciliation process to bypass Democratic obstructionism in the Senate. This only allows us to repeal parts of Obamacare and enact only parts of a replacement. Finishing the job will require administrative actions and follow-up legislation requiring Senate Democrats to cooperate - something not very likely. So we need to ask if this bill alone is enough to produce a better healthcare system for the vast majority of people.

Its biggest defects are its failure to restore to consumers the freedom to shop across state lines and to fully free consumers from purchasing coverage they don't need and don't want. I fear that in states where insurance commissioners refuse to approve innovative replacement plans, consumers will be stuck in a market still governed by Obamacare man-

Critics cite the Congressional Budget Office estimate that "24 million Americans will lose their coverage." But this conclusion is based largely on the premise that unless people are forced to buy health insurance, they won't. In fact, people won't buy health insurance that's not a good value for them - and clearly Obamacare isn't. We envision a vigorous buyers' market where plans across the country compete to offer consumers better services at lower costs, tailored to their own needs and wants.

And this is the AHCA's biggest achievement: replacing coercion with choice for every American. It ends the individual mandate that forces Americans to buy products they don't want. It ends the employer mandate that has trapped many low-income workers in part-time jobs. It begins to restore consumers' freedom of choice -- the best guarantee of quality and value in any market. It allows Americans to meet more of their health-care needs with pre-tax dollars. It relieves the premium base of the enormous costs of pre-existing conditions by moving them to a blockgranted assigned risk

In making this transition, though, it's important to leave no one in the lurch. That's where we need to heed the CBO's warning.

The fact that many lowincome families could no longer afford basic health care is what produced When fully Obamacare. implemented, our reforms will correct the government mandates that trapped people in restricted markets that forced healthcare out of reach. But until then, the CBO warns that a 64-year old, for example, earning \$26,500 will see her out-of-pocket health costs balloon from \$1,700 to \$14,600 per year. This is neither morally defensible nor politically sustainable.

The Budget Committee adopted my motion on a bipartisan vote to ask the House to correct this inequity by adjusting the tax credits to assure that health plans are within the financial reach of every family. I want to thank the leadership for responding to this motion by creating architecture in the bill to shift an additional \$75 billion for this purpose.

pro-growth As our economic reforms cause incomes to rise and our health care reforms bring costs down, families will earn more and pay less for their health care, and reliance on these tax credits will recede. But we need a bridge from the present to the future, and we simply can't get there without addressing the bill's initial impact on older, low-income Americans.

It is also important that we assure stability in the Medicaid system as we transition to flexible staterun programs that correct the inequities of Obamacare that have pushed the elderly, blind and disabled to the back of the Medicaid line. This bill does so.

I wish it did everything necessary to restore an optimal health insurance market. But it moves us toward that goal, and even as a stand-alone measure, I am confident it will ultimately create a market in most states that will produce better services. greater choices and lower costs for the vast majority of Americans.

All That Water and No Place To Put It

Water System "Out of Whack"

After the federal Central Valley Project reported it expects to deliver only 65 percent of contract water supplies to its agricultural water contractors south of the Sacramento-San Joaquin Delta, California Farm Bureau Federation President Paul Wenger said the announcement shows how operation of the state's water system remains in need of an overhaul. "In the alternate uni-

verse of California water, we can have floods, full reservoirs and a huge snowpack and still not have full water supplies.

It boggles the mind,"

Wenger said.

"Operation of our water system remains out of whack. We need to continue efforts to improve and expand the system," he said. "In Congress, passage of the Water Infrastructure Improvements for the Nation Act last year marked an important step in addressing the system's inadequacies. Congress must now follow through with measures such as Rep. David Valadao's Gaining Responsibility on Water Act, which would offer longerterm ability to store and

move water."

Wenger said farmers and ranchers will also press Congress to modernize endangered-species laws, "to balance the goals of environmental restoration with the ability to provide the resources needed to grow food and farm products."

At the state level, he said, California must move as quickly as possible to invest money from the Proposition 1 water bond into storage projects that provide the state with more ability to store water in wet winters such as this.

"Improved storage capacity, both above and below ground, is crucial to California's longterm ability to withstand droughts, protect against floods and gain the flexibility needed to allow people and the environment to thrive," Wenger
