## Spillway Evacuation Feedback

*“They told us to run, but not where”*

On March 14th the public was invited to a feedback session dealing with what went right and what went wrong with the mandatory evacuation. The meeting was videoed and is playing on the Sutter County YouTube page. The recorded experiences, concerns and suggestions will be given to the Department of Water Resources (DWR) for their review and the local governments will use this information to put together an emergency evacuation plan. It was suggested that the plan be reviewed and updated every 5 years.

The Veterans Hall in Yuba

City was standing room only as the public turned out to tell their elected officials how they felt about the mandatory evacuation. The general mood at the meeting was that they, the public, had been let down and there was no plan. The most repeated concern was the lack of communication and bad information, followed by traffic control for the evacuation. The example was given that Hwy 20 from Marysville to Grass Valley should have used both lanes east bound and the Highway Patrol should have been keeping traffic moving instead of stranded vehicles left as sitting ducks if the flood came. It was also brought up that

there did not seem to be any consideration for the disabled and those in "Care Facilities" as transportation was a huge problem.

There were very strong feelings that (DWR) knew of the problem with the spillway in 2005 and did not react. That the amount of rain received was not the problem; but poor maintenance on the spillway was. The other concern with DWR was the quick reduction in river flows that caused the river banks to collapse creating loss of property and debris downstream. There was loud applause when one speaker demanded accountability from our government.

## Yuba-Sutter Political Notes

The laws and regulations regarding who can possess, grow, sell and consume marijuana continue to be confusing and costly to local government. Laws vary from jurisdiction to jurisdiction, county to state and state to federal.

Yuba County's convoluted marijuana ordinance and its enforcement have angered landlords and medical marijuana consumers. Landlords and the county have spent tens of thousands of dollars litigating the regulations with the court ruling for property owners. Private sector attorneys would have been canned for the same poor legal work done by county lawyers.

Meanwhile, contrary to voters' wishes Marysville (Yuba County seat) officials have authorized two marijuana dispensaries. The process was rife with favoritism, Brown Act violations, a \$5,000 dispensary pay-off to Mayor Samayoa and thousands more from a dispensary backer to benefit the council's quest to pass a sales tax increase.

In November 2016, voters statewide legalized recreational use of marijuana. Entrepreneurs and dispensary operators are dreaming about truckloads of cash. They are scrambling to posture themselves to corner the market on production, distribution and sales. The group includes local farmers as well.

At least one supervisor in Yuba - Sutter has received money and another supervisor promised money to lead the way in adopting an ordinance permitting outdoor grows of marijuana. A 700-page ordinance to this end was drafted by Los Angeles attorney Jeffrey Lake on behalf of marijuana vendors and submitted to both Boards of Supervisors for adoption.

Ordinance sponsors are expecting quick action by the boards. The question is whether any supervisor will actually read the door stop before voting on it.

A group of Marysville residents known as the 'Turn Around Team' will address the Marysville Council Tuesday 3/21/17. Their list of grievances describes incompetence, malfeasance and corruption. The citizens are asking for the resignation of Mayor Ricky Samayoa and City Manager Walter Munchheimer.

## Whiteaker Cries Foul

Sutter County Supervisor Jim Whiteaker complained that in a recent Territorial Dispatch article his vote and motive for voting to keep the county jail medical staff versus contracting with California Forensics Medical Group (CFMG) were misrepresented.

The vote to go with CFMG was 3-2 with Whiteaker and Larry Munger wanting to maintain the status quo while Dan Flores, Mat Conant and Ron Sullenger chose to contract out. The article suggested Board Chairman Whiteaker's vote was deceptive since it was the understanding of a number of board members that there was consensus to go with CFMG and they expected a unanimous decision.

The thinking was that Whiteaker knew the vote would favor CFMG, he was really for it, but did not want to lose face with county employees and voted for them. However, Whiteaker argues that the characterization was totally false.

Whiteaker maintained that he never forms an opinion on agenda topics prior to hearing the arguments at the meeting. And, he denied ever saying or insinuating that CFMG had his vote or would be the choice of the board. He insisted that the current medical staff is equally educated and skilled as CFMG employees.

Essentially, Whiteaker and Munger's vote says that the current jail medical operation is the same or superior to the CFMG proposal. The two supervisors are literate, so it is hard to believe they came to this conclusion based on facts.

According to documents and 2/28/17 board meeting testimony CFMG would provide 24-hour medical service versus the current 18-hour staffing. CFMG would handle all medical management, drug purchases, hiring, firing, health insurance and retirement. CFMG guarantees levels of staffing with employees who are more highly educated and accredited than county workers. This should reduce liability and costs to taxpayers.

When a county employee misses work, if no one is available to fill-in, jail medical runs short-staffed, risking disaster. Several inmates have died in the last few years. It takes months and often a year for the county to recruit and hire new employees to replace those who retire or leave.

CFMG would provide jail medical services at a lower cost. It would eliminate lifelong employee pension commitments by the county. And, inmate deaths along with the \$800,000 payout to survivors should be reduced with a high level of care.

The Whiteaker / Munger vote makes more sense in the context that it is easier for politicians and bureaucrats to have their impacted wisdom teeth extracted without painkillers than to privatize and shrink government. It is contrary to their nature whether their politi-

Sam Leach, a right-handed pitcher and outfielder from Seattle, Washington is a strong member of the division 1 University of Northern Colorado program. Graduating from Nathan Hale High School, Leach was an All-State player ranked as the 15th overall OF in the state of Washington. At UNC, he stands as one of the top freshman arms in a great recruiting class put together by an outstanding staff out in Colorado.

## Coach Correa on Daddario...

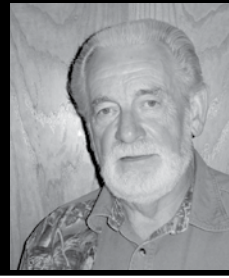

We launched the red boat at Boyd's Pump last Friday morning hoping for a chance of a striper dinner prior to the reported release of water from the Oroville spillway. We fished off and on down to Star Bend with only a couple of shakers. The water conditions were high and murky with the temperature in the fifties. Curiosity got the best of us so we went up river past the rapids (which were not a rapid) through the Jesus Hole and up a bit. The surprise was the conditions of the river bottoms. The Jesus Hole was back to normal at over thirty feet deep, but the river changed on the curve on the way down river just before the rapids. We observed a wall of sand on the right side which was next to the water and had to be at least six or seven feet high. In addition, trees were down, some with roots exposed as we traveled down river to star bend, some with broken off trunks. Expect new snags and hazards when the water drops back to normal.

## Colusa County Cameos

Welcome to a new series regarding neighboring Colusa County. Over the ensuing months, the communities of Arbuckle, College City, Williams, Maxwell, Princeton and Colusa will be featured. Also included will be the histories of Sites, Stonyford, Leeville, Grand Island and Grimes.

Along this journey, readers will meet the many interesting pioneers who played major roles in the formation of these early settlements. So let's begin with the founder of Arbuckle--a man of great foresight.

## TACITUS RYLAND ARBUCKLE

Born in Lexington, Missouri on March 6, 1834, Tacitus Ryland Arbuckle was the second of seven children born to parents, the Rev. Cyrus and Diana Evans Arbuckle. He remained with his family until the age of 15 when he moved to Arkansas, living with some uncles until the news of the gold discovery in California reached him four years later.

Traveling westward by the southern route while driving an ox-team, it took Tacitus six months before his final arrival to California. His first stop was mining on the Russian River; but he also tried stints at raising cattle, working as a butcher, and mining in the silver fields in Virginia City, Nevada until he finally settled down.

On June 9, 1855, Tacitus married Amanda Melvina Tinker in Napa County. The couple then purchased a stock ranch in Mendocino County where they remained until 1866. During that year, Tacitus purchased land in Colusa County, where, at one time, he accumulated an interest in over 7,000 acres.

When in 1875, Tacitus learned that the railroad was coming north; he offered some of his land for a depot. By July 4, 1876 the first railroad entered Arbuckle just two months after the depot was built. In addition, Tacitus encouraged others by giving away lots and furnishing nails to anyone who would build on them. Thus, the town of Arbuckle was duly laid out and surveyed in 1875.

The first building was erected by William Dalbrow and John C. Ward, a Confederate Civil War veteran, who also opened a harness shop and, with his carpentry skills, was instrumental in constructing many of the buildings in Arbuckle and surrounding areas.

Tacitus also built a large livery stable, a dance hall, and a public meeting hall with Post Office, where he served as postmaster. And by 1877, a new school district was formed with Annie Linton as the first teacher

from the Old Oregon Trail schoolhouse. All seem to be going well for Tacitus and his growing family of fourteen until December 19, 1878, when fire destroyed all of his buildings. With no insurance, Tacitus faced financial difficulties and was never able to recover his losses.

It is said that one day he "packed up his coon dogs and family" and moved to a ranch located in Scott Valley, Siskiyou County. Here Tacitus remained until he died of a brain tumor on July 7, 1899, at the age of 65 where he was buried on the hillside above his ranch a "glimpse away"

that he often traveled as he pioneered the West.

A Historical Marker erected in 1978 by Sam Brannan, Chapter, No. 1004, E Clampus Vitus aptly describes the "legendary Arbuckle (who) founded the town, deeded the lots, furnished the nails, and helped build the first houses in what has since become the City of Arbuckle.

The community of College City will be featured in April and will include the history of the Pierce Christian College along with its founder, Andrew Pierce.

# An Enviro Attempt to Block Oroville Dam Repairs

During the first part of this month, there have been environmental concerns over fish that are trapped in pools which then alerted two federal agencies, namely, the National Oceanic Atmospheric Administration (NOAA) and the National Marine Fisheries Service (NMFS), which sent a letter to the Federal Energy Regulatory Commission (FERC) requesting that the repair on the Oroville Dam be scaled back in order to protect threatened fish.

Yes, it's the same old song being sung by enviro politicians who now place even fish above the safety of the people who live below the tallest dam in America. After 100,000 plus people were already evacuated last month and are now living in harms way since returning to their homes, fish are still a greater concern than repairing a damaged dam in a timely manner over the safety and welfare of the people? What next, will floral and fauna be added to the fish list?

Consequently this prompted water associations and farming organizations to send a letter asking the U.S. Commerce Secretary Wilbur Ross to relax the regulatory rules to allow the dam repairs to be conducted in an ex-

pedient manner. So now even a dam repair that threatens up to 200,000 people lies in the balance while regulators debate the pros and cons of a few "poor" fish that need a home?

However, further assessing the situation, there was no mention of the thousands of fish that were purposely eradicated beginning in 2008 with a program that began when the Fish and Wildlife agency chose to save "threatened" frogs and toads over a harmless trout that swam in numerous streams and lakes in the Sierra Nevada Mountains. How was that done? It was accomplished through electrocution and by poisoning the water. Why? A million acres were designated for Mr. toad and Ms. frog. Yet, how "scientific" was the study and did the Fish and Wildlife agency listen to the hundreds of people who went to the hearings that said NO to the plan?

The event which included a talk by U.S. Representative Tom McClintock, who referred to the lackluster study as "junk science." But getting back to the Oroville dam issue, the NOAA isn't quite as credible and lilly white as we would hope it to be. Back in September of 2010, the NOAA had a paper shredding party which took place before the U.S. Commerce Secretary Gary Locke decided to go on a "fishing expedition" while exposing the federal agency which was having a field day with the spoils of Asset Forfeiture which also included proceeds from the sale of seized fish and vessels. It was to pay for "expenses" directly with regard to NOAA investigations and related to civil or criminal enforcement proceedings. But lets not forget the fines and the mega slush fund which came under great scrutiny from the Inspector General. In addition, the review of the NOAA agency and law enforcement cases went as far back as back as 2001

As Locke put it, "The problems identified by the Inspector General are unacceptable and were allowed to persist for too long and will end on my watch. We are taking the steps needed to make fisheries enforcement accountable and transparent." With that said, I would hope that under the new leadership within some of these federal agencies and with our current President, that higher standards and credibility will be brought back into the fold, but when one already sees what is transpiring with the latest letter writing campaign and the NOAA along with their sister agency the NMFS, I am already getting nervous.

In summary, the grand expansion of many of the U.S. federal agencies, along with their web of power, fuels the likelihood of continued, and extreme bias, while at the same time, major corruption in these numerous agencies has yet to have been fully flushed out.



## Premier Mushrooms Inc. Awards Grants to Colusa Non-profits

Six Colusa County non-profit groups were named as the 2016 Premier Mushroom Inc. Grant recipients. Representatives from the groups accepted the awards on March 1 during the 6th annual Grant Awards Breakfast hosted by Premier Mushrooms Inc. CEO John Ashbaugh.

The awardees which included the Studio ABC, Arbuckle-College City Fire District, Safe Haven Drop-In Center, Colusa County Resource Conservation District, Colusa County Free Library and the Colusa County Food Basket Association received grants of \$250 each.

Every Colusa County-based non-profit group is eligible to apply for the grants.

Ashbaugh commented that he and the mushroom farm are pleased to be a part of the Colusa County community. "We believe it is important for businesses here to give back to our community," he said adding that the grant program is one way that Premier can do that. "We are very appreciative the Colusa County Chamber of Commerce, Colusa Farmers Market, Market Street Grill and the Farm to Fork Dinner committee for their efforts in helping this be a successful project," he said.

This year's grant recipient brought a variety of projects for consideration.

Safe Haven Drop-In Center's award will provide funding for the Center's continued effort to bring awareness around mental health and reduce stigma within the community through various outreach efforts. spent on the basics with the minimum of unnecessary frills. That also means not committing to a large property lease or too long of a term. Start small is the order of the day. If you have a good product or service, it will likely sell no matter how large your presentation is or isn't.

Don't overstock. Stock costs money and new businesses usually have to pay up front for items due to a lack of established credit. Keep your stock to an absolute minimum required to service your customers. You can always order more of what sells and you also will be stuck with less dead inventory.

Give great customer service. The reality is that in most cases new businesses just steal customers from other businesses. Keep this in mind. Give customers a reason to buy from you. That means you must be better than the current store he is buying from, either in quality, price, service or preferably all three.

Don't worry about profit too early in the game. You obviously need to make a profit but new businesses should first garner a customer base.

Watch cash flow. An old saying in business is "cash flow kills". Mismanaging cash flow kills more businesses than not. Have at least six months of

operating cash and living expenses before starting to insure you can keep the doors open.

When planning your business, be conservative in your budget projections. Under estimating sales and profit rarely is fatal but being overly optimistic usually is.

Make a business plan entailing everything you can think of. List projected sales, expenses, inventory considerations, who does what, and all the "what ifs" you can think of. Have a contingent plan for anything that may happen, as usually anything that can happen will happen. Plan for all of it.

Don't over expand. You want sales to drive expansion, not expansion to necessitate sales. This means only expand when your overabundance of sales requires it. On the flip side, having to sell more because your large overhead is eating you alive is a recipe for disaster.

Build on strength. Don't go into areas you aren't familiar with to capture more sales. You will likely only capture more expenses. Sell only what you know and don't try to sell too many different things or expand into too many different areas. The phrase "keep it simple stupid" comes to mind.

Don't underestimate your customers. People with money didn't get that way throwing it away on frivolous or overpriced items. Most people know a good deal from a bad one. Treat them with respect and if they offer criticism take it. For every customer that tells you what they don't like, there are likely ten more that won't say anything and just not return.

Problems are a way of installing loyalty and are a natural occurrence in any business. But in the eyes of a customer problems can make or break the relationship. Think about it: Anyone can take your money. It's the person that fixes a problem to the satisfaction of the customer who will be remembered. From that moment on the customer knows if he ever has a problem, you will fix it. Not so with many competitors lucky for you.

In conclusion, draw on people who have been there. Most are more than willing to give advice and help answer questions.

## Yuba City Cannot Afford the "Key Hole" Annexation

The LAFCo commission can save Yuba City a lot of money. Your commission can deny this vote and squash this annexation right now. Yuba City was recently advised their revenue will not keep up with their rising expenses. These projections go out to 2023 and they show that YC will be underwater and steadily burning reserves out to 2023. By that time YC will be underwater by \$2.4 Million. This projection does not even include the impact of their poor portfolio performance last year. That alone will cost YC another \$500K per year. The city manager recently admitted directly to city council that the next several years will be challenging regarding the budget.

So my question to the commission is how can Yuba City annex a money losing area that will cost them \$300K per year. On top of that it will cost YC \$1.1 Million in startup costs for hiring police and

establishing a substation. This estimate is directly from the city manager in Feb of 2016.

The key costs are rapidly rising health care costs and Cal Pers changes requiring more and more of the budget for city employees already retired. YC is headed to a situation where these costs will not allow improvement in services such as police protection. The Cal Pers impact on the budget for this 2017 year is expected in July. Cal Pers is changing their discount rate and their portfolio performance was awful in the latest year. This means the city unfunded pension liability will grow from the current \$59 million. My calculations show that the YC unfunded pension liability will grow by about \$17 Million by the end of the year. So the \$59 Million debt will grow to about \$76 Million. This has been checked by a CPA familiar with Sutter County accounting. That is a 30% increase. The

budget of Yuba City cannot keep up with these increasing demands.

Some may argue that the budget will be actually be positive since several employee positions have not been filled. If YC is counting on that they should not be budgeting those positions in the first place. A follow on question is "Do we really need these employees?" YC management needs to clearly justify these positions. Or they should admit that YC residents are currently being under served due to inadequate staffing. If overtime is their method of coping that can only be done safely for a short time.

Save hard working Yuba City taxpayers a lot of money that would be wasted. We are confident that the annexation would be defeated by a vote anyway. The LAFCo commission should reject the vote resolution in April.

## Medical Marijuana Gardens

If you can see it or smell it, it is not a legal grow

The cultivation of medical marijuana in unincorporated Sutter County is regulated in a manner designed to balance the needs of medical patients and their caregivers with the health, safety, and welfare of its residents and businesses.

Only registered grows are legal--all others subject to abatement!

The outdoor cultivation of marijuana is not permitted

- Cultivation of marijuana within 1000 feet of a school, school evacuation site, church, park, county-licensed child care center, or a youth-oriented facility is not permitted
- Cultivation of marijuana inside residences and on vacant lots (i.e. premises without a permitted residential use) is not permitted
- The indoor cultivation of marijuana is limited to no more than eighty (80) square feet
- The structure must be detached and meet all building code requirements unless it is a pre-fabricated greenhouse which is no larger than 80 square feet and meets the requirements of the ordinance
- Prior to cultivation, an annual registration must be obtained from the Development Services Department and the site must be inspected for compliance with the ordinance
- A registration fee of \$140 and an inspection fee of \$180 must be paid

## Forbestown Ditch Breach Repaired

Brownsville, CA  
Repairs to the breached area of the Forbestown Ditch were completed March 13th.

The breach originally occurred February 7, when a portion of the mountain side supporting the Forbestown Ditch washed out approximately a 200-foot section of the Ditch. This was the second breach in the Ditch in two months. No disruption in service occurred during either breach because water runoff remained high and the treatment pond remained near capacity.

"This second breach took longer to fix because the mountainside was so

saturated and it simply wasn't safe to start work," said Jeff Maupin, NYWD Manager. "Luckily mother nature finally dried things out enough last week to make the repairs."

An automated call went to NYWD customers today with news of the finished repair.

"Another big thanks to our customers who again showed great patience and support during this breach," said Maupin. "We deal with the reality that the Forbestown Ditch is an open ditch, exposed to the environment and subject to complications. The long-term goal is to pipe the ditch, which will make

it much less susceptible to a breach."

In late December, the newly sworn-in NYWD Board of Directors voted to pursue a \$500,000 State grant to begin planning and engineering to pipe the Forbestown Ditch. Moving to a piped Ditch would lower the possibility of a breach like the one experienced last week. A piped Ditch would also save a significant amount of water lost from seepage and evaporation, increase the amount of water available for customers and eliminate a vast majority of dirt, trash and contamination from entering the treatment pond.

## Yuba-Sutter Political Notes

Recently, Public Services Director David Lamon suddenly retired after the city was notified he failed to file 4 years of State Water Resources quarterly reports. The state's initial fine of \$3 million was negotiated down to \$288,000.

Lamon also neglected to act on a \$1.8 million grant for street and drainage upgrades near 12th and J Streets. Yuba County loaned \$700,000 to the cash poor city believing the contract had been let and construction soon to begin. The project was never started. The principal, interest and a \$7,000 administration fee came due and were repaid to the county. The neighborhood continues to flood whenever it rains.

In 2016, City Council members were unanimous in their desire to raise sales taxes to 8.5%. They put Measure C on the June ballot after a similar effort failed the year before.

It is illegal for the city council to spend tax dollars for a campaign against city residents that oppose such measures. So, the city made an arrangement with a potential beneficiary of marijuana dispensaries David Lanza to fund the publicity campaign.

Literature and advertising stated the new taxes were to save police and fire departments and make city infrastructure repairs. Recently, all city employees and department heads were given raises from the increased sales tax revenues.

According to Howard Jarvis Taxpayers Association raising salaries and making pension payments are standard moves by politicians using bait and switch sales tax increase measures. The campaigns extort votes by fear promising poor 911 responses should the measure fail.

The 'Turn Around Team' believes the public has also been misled by the city's Bounce Back plan funded with an estimated \$200,000. It was portrayed by Munchheimer and Samayoa as an 'economic turn-around strategy.' The complainants contend it was nothing more than a zoning review.

The protest document notes a dozen reasons why the city leadership should step aside.

## YCWA Approves Loan to Reclamation District 2103

The Yuba County Water Agency has approved a loan to Reclamation District 2103 for up to \$200,000 to help cover the costs of necessary levee repairs on the Bear River.

During the February storms, a critical section of channel bank, located on the north side of the Bear River Levee, approximately a quarter mile east of Highway 65, eroded due to high river flows. YCWA's loan will cover 90 percent of the repair work, completed several weeks ago.

"One of YCWA's fundamental missions is to improve public safety for the people of Yuba County," said YCWA Board Chairman Brent Hastey. "We work closely with the local Reclamation Districts to ensure the integrity of the levees to reduce our local flood risk."

RD 2103 oversees 9.8 miles of levee and is responsible for the maintenance and operation of the Dry Creek levee, Bear River levee and the San Joaquin drainage canal, which provide protection to the City of Wheatland and surrounding agricultural lands.

"RD 2103 closely monitors levees during high water events," said Tom Engler, RD 2103 district engineer. "With limited financial resources it is really helpful to have a funding partner like YCWA to help us respond to these critical areas before they get worse or cause significant damage."

44 truckloads of crushed rock were delivered to shore up the banks from continued erosion, but further damage occurred on the levee roads as a result

of the heavy trucks used to assist in the repair efforts.

YCWA's loan will cover 90 percent of the total costs for the project – approximately \$60,000 for the initial erosion work, \$48,000 to re-rock the damaged road and hydro-seed for additional erosion protection, and approximately \$80,000 for post-project environmental permitting and potential mitigation. Initial erosion repair work was completed under emergency authority on Feb. 15, and the road repairs and hydro-seeding were completed March 3 during a break in the stormy weather.

RD 2103 has submitted for reimbursement through the California Office of Emergency Services, and is continuing to pursue state and federal funding to offset the costs.

## Food and Farm News

### Weather affects vegetable harvests

Warm weather in the desert and rainy weather on the coast could conspire to disrupt supplies of fresh vegetables this spring. Farmers along the Central California coast say their vegetable planting has been slowed by winter storms. At the same time, warm temperatures in desert growing regions has meant an early end to harvests there. Vegetable marketers say supplies and prices could be affected for a while, until coastal harvests hit full stride.

### Forest problems continue

The wet winter hasn't solved problems facing California forests. Experts told a California Farm Bureau conference that tree mortality, bark beetle infestations and overgrown landscapes continue to threaten the Sierra Nevada. The U.S. Forest Service estimates more than 100 million trees have died since 2010. The service's regional forester said it has cleared about 280,000 trees, mainly in areas where people could be harmed.

### Projects may apply for water bond money

Applications opened Tuesday for bond money to help build new water storage projects in California. The California Water Commission will decide what projects qualify for money from the Proposition 1 water bond voters approved in 2014. The bond will invest in the public benefits of water projects, including ecosystem improvements, water quality, flood control and recreation. Backers of individual projects will pay the remaining costs.

### Recycled rice husks create sturdy boards

Using rice husks to make particleboard renders the board termite-resistant--and students at the University of California, Riverside, say that, in turn, will benefit people in the Philippines. Working under the title Husk-to-Home, engineering students have figured out how to create the particle board, and have earned a federal grant to build relief shelters from it. The shelters will benefit people in a Philippine region recovering from an earthquake and a typhoon.
