# 137th Bok Kai Parade, The Year of the Rooster

The Bok Kai parade's rich history is believed to have started as far back as the 1850s. Always held on the weekend closest to the second day of the second month of the Lunar calendar it is the longest continually held parade in California. The parade honors Bok Eye, the Chinese Water God, who protects Marysville from flooding.

The event brings in thousands of visitors from the local community as well as San Francisco, Seattle, Oregon, and even Hong Kong. The parade features community organizations, schools, businesses, traditional Chinese lion dancers, lots of fire crackers and the famous 175 foot long golden dragon named "Hong Wan Lung." Dragons play a big part in the Chinese culture as well as in the Bok Kai parade's history.

The Bok Kai event will take place on March 4th and 5th. The parade starts at 11:00 a.m. on March 4th 2017 at the



corner of 6th and D Street. The parade will last approximately 2 1/2 hours.

The 2017 Bok Kai Grand Marshal is John Young.

The 2017 Bok Kai Hostess is Stacy Suen. Stacy was born and raised in Yuba City the daughter of Dr. Ron L.C. and Lucy Suen. She has an older sister, Stephanie Suen, who was the 2012 Bok Kai hostess. # Oregon Peak Lookout Volunteers Celebrate 25 Years

Recently a luncheon was held at the Alcouffe Community Center in Oregon House honoring the volunteers that staff the Oregon Peak Lookout. Oregon Peak is located on Oregon Ridge between the town of Dobbins and Bullards Bar Reservoir. The volunteers, known as V.I.Ps (Volunteers In Prevention), first started staffing the lookout in 1992, when the California Department of Forestry stopped funding paid Lookouts. At that time Guy Wolf and Greg Crompton, representatives from the former Lake Francis Grange, approached Cal Fire with the idea of staffing the lookout with volunteers from the Dobbins and Oregon House area. Approval was given and the Oregon Peak Lookout became the pilot model for this type of program. Many Lookouts from throughout the State of California followed their lead. Over the years Oregon Peak and other Lookouts have been credited with numerous first reports of wild-land fires. The latest luncheon was attended by over 50 volunteers and Cal Fire personnel. The volunteers were recognized for their service; some with just one year of duty, but there was others with 5, 10 and even

# Janet Nguyen Shushed, Dissed, Removed by Sentate

Republican State Senator Janet Nguyen of Garden Grove found she was the wrong minority (Vietnamese), the wrong party and had the wrong position on the Vietnam War to address the Senate on Thursday 2/23/17. If she were Black, Mexican, homosexual, from a Muslim country, or a democrat and opposed to the war she was good to go. She wasn't, so she was silenced.

Nguyen stood to inform the Senate of the Vietnamese view of the late Senator Tom Hayden. "Today I recognize in memory the millions of Vietnamese and hundreds of thousands of Vietnamese refugees who died in seeking freedom and democracy. On Tuesday, you had an opportunity to honor Senator Tom Hayden. With all due respect, I would like to offer this historical perspective....." At that point Nguyen was interrupted and her microphone silenced by Sen. Ricardo Lara (D-Bell Gardens), presiding over the Senate, who then gave the floor to Sen. Bill Monning (D-Carmel). Monning repeatedly exhorted Nguyen that she was out of order.

Though Senate leadership knew she planned to address the body and the subject matter, she was forcibly removed by security as she kept speaking. On the Senate floor Minority Leader Jean Fuller (R-Bakersfield), Joel Anderson (R-San Diego) and Jeff Stone (R-Temecula) each expressed their indignation at the prejudicial action taken against Nguyen.

However, Senator Jim Nielsen (R) representing Yuba-Sutter and seated just behind Nguyen, appeared confused and detached. He did not stand to support her nor did he attempt to intervene to protest her removal. Even a stunned Democrat Tony Mendoza (D-Artesia) arose to question the strong-arm tactics to shut down the

CHY Timber has been a supporter of the Volunteer Lookout program for many years; much of their land surrounds the Lookout and is in the immediate area. The service provided by these volunteers generally goes unseen, but is appreciated by those with knowledge of the program.

# Pedestrian Access Around Colgate Powerhouse Closed

The steel walkway around the Colgate Powerhouse that provides access to the Yuba River in Dobbins, CA remains closed to the public.

As a result of the continuous heavy storms, high flows have deposited floating debris on and around the walkway and may have damaged it.

The Yuba County Water Agency has closed the area to pedestrian access until maintenance crews are able to clear the debris and check for any damage.

voice of the Vietnamese people.

Though some liberal senators carped that Nguyen violated parliamentary procedure, the real issue was her topic. Nguyen noted Senator Hayden's national leadership in opposing the Vietnam War and his encouragement of the communists. Vietnamese believe Hayden's work contributed to the torture, loss of life and suffering of their people.

Nguyen's district has the largest population of Vietnamese in the nation, around 500,000. As the Senate adjourned in memory of Hayden (died 1/23/16) lauding his liberal politics, service to the country and his intellect, Nguyen left the Senate chambers and delayed presentation of her perspective in deference to Hayden's family attending the session. The Nguyen take-down occurred two days later.

After the communist takeover of South Vietnam, Nguyen's parents were repeatedly caught in attempts to leave the country and incarcerated. South Vietnamese and Hmong were being executed, placed in re-education (concentration) camps and starved. The communists were barbaric, executing resisters, torturing and burying people alive, raping, cutting open those who were pregnant and smashing infants on rocks. Nguyen's uncle was also killed.

Finally, her father and brother succeeded in escaping. Later, the mother and the two daughters left. Janet was 5 years of age at the time. They fled Vietnam by small boat. Millions of Vietnamese risked their lives in ramshackle flotillas adrift at sea. Thousands were shot, drowned or died of exposure.

Nguyen knows every Vietnamese that escaped has a story to tell like hers. She was their voice on the Senate floor that day to tell the other perspective of Hayden's life.

However, like Stephen stoned to death for telling the truth about Jesus, Nguyen's anti-communist and anti-subversive voice could not be tolerated. The Senate chambers and college campuses are similar, speech is permitted to those with accepted beliefs.

A recent example is when homosexual activist Senator Mark Leno (D-San Francisco) was allowed to speak in May 2016 against a resolution honoring former President Ronald Reagan for advancing the public good. Leno was critical of Reagan's cuts to AIDS research funding, ranted at length against Reagan, and said he would not support the resolution according to writer Katy Grimes.

Other dead or retired conservative officials recognized by the Senate have been the brunt of derogatory but permitted remarks of liberals, as well. Liberals speak freely. Nguyen is the latest victim of suppressing the truth and free speech of conservatives.

#### A Slight Miscalculation

The dam took a bit more than four years to complete. The area had been suffering from floods for many years and the primary reason for the dam was to control flooding and provide water during dry periods.

Most residents of the area had been very supportive of the dam. They felt that it would be a great asset to the region.

There had been some opposition to the construction of the dam. There had been lawsuits filed due to concerns regarding the geologic and seismic conditions of the area. Other opposition to the dam was because it would ruin a wild and scenic river and destroy a trout and wildlife habitat. In spite of this the lawsuits were dismissed. They had delayed, but not cancelled, the construction of the dam.

By that Saturday morn-

#### ing in June the 305 foot, earth fill dam had been filling at the rate of four feet per day. It was almost full and had filled much faster than anticipated due to a very wet winter and spring.

Leaking at the dam's toe was noticed at 7:45 AM. Then a hole was noticed 40 feet up from the dam's base at 10:30 AM. The hole was growing and was leaking 15 cubic feet per second. By 11 AM emergency and construction crews had arrived at the dam to try to plug the hole. At 11:30 two bulldozers were pulled into the hole with their drivers barely able to run to safety.

At 11:57 the hole had grown upward and toward the right side of the dam near the spillway. Then the entire dam fell away. 80 billion gallons of water were released into the valley.

Over the next two days the flood swept through five small and medium sized towns in its 90 mile swath through the area.

Damaged were 65 canal systems, 427,000 acres of cropland, 250 businesses, 350 farm buildings, and 4,000 homes.

Thousands of livestock drowned and eleven people died.

So did this occur in a poor, backward country a hundred years ago?

No, this occurred on June 5, 1976 in the state of Idaho.

The initial 30 foot wave of water spread out and took out the towns of Sugar City, Rexburg, Idaho Falls, Firth and Blackfoot.

The Teton Dam, built by the U.S. Bureau of Reclamation, was located on the Teton River and cost \$80 million dollars to build.

Why had the dam failed? It was determined the dam had been poorly designed and that internal erosion had occurred due to inadequately sealed rock joints. This article is simply food for thought. We need to make sure that money is applied sufficiently to our infrastructure. Recent local events have highlighted that need. Oroville Dam's embankment has been safe for 49 years but the spillway needs work.

Oh, by the way, on March 12, 1928 an even worse dam break happened near Castaic. California. The St. Francis dam broke and carried everything away from Castaic to the Pacific Ocean near Ventura; a distance of 54 More than 450 miles. people were killed.

All of us who fish wish for a chance to catch the big fish which will be the topic of conversation for years to come. To many of us it does not matter if it swims in salt or fresh water or clean or dirty water. To others it must be a "big one" caught in their favorite fishing hole or a backwoods trout stream and to some anglers their wish is in the ocean or a huge reservoir. To some the feat must be accomplished in the presence of others for bragging rights.

No matter where it might happen it will be the thrill of a lifetime. I have been fortunate to have caught large fish in just about all of the above mentioned waters. But the one that sticks in my mind is that large brown trout caught the opening weekend of trout season many years ago. Bill and I were fishing in high, fast murky water in the middle of the Feather River canyon. He decided to go down stream so I went up stream. I spotted the current on the opposite side of the river feeding a large pool directly in front of me. The distance

that big streamer fly right where the white water was as it churned into the pool. My first cast was right on the money and I stripped line off the

reel like crazy to keep up with the fast water. Finally my line slowed down as it moved across the pool I felt a jerk and set the hook. I was standing on top of the big boulter and as I retrieved my line I could see the fish in the early morning light.

As I brought the fish towards me and it began swimming on top of the water I could see is was a small rainbow when suddenly the water exploded and the fish disappeared. My fly rod doubled over and I let out a hoot so loud Bill turned, saw what was going on and began walking back towards me.

I was running two pound leader and was worried about a breakage as the fly line zipped across the water and back again. Then the fish decided to head down stream and I had a heck of a time holding him so he would not strip my spool. I had two problems. One was the fast water and the other was the size of the fish.

After what seemed like a lot longer than a couple minutes I carefully laid the big fish on the sand

bar below, jumped down and grabbed the trout. Just before I had the fish in my grasp the little rainbow came out of the bigger fish's mouth. As I sat there with a big grin on my face I marveled at the size of the brown trout. My deliar scale measured him at 16 <sup>3</sup>/<sub>4</sub> inches. The brown was spectacular in colors and was covered in black spots with orange running off his body into the fins and gills.

That was an amazing morning and it was not that the brown was large for the area, but because I had caught not one fish but two at the same time on the same fly. Needless to say, Bill and I talked about that day for years and it was a great tale to tell around the campfire to those who had not heard the story.

To this day I marvel how the small eight inch rainbow trout managed to swallow my two inch streamer fly.

all the money will stay in each county.

2. Property values will no longer be measured by only the price of ones property but a formula will be used to determine the net income of every person in the State of Jefferson, and if that income for a family of three or four is small, then the amount of property tax for that family will be reduced.

3. International Building Codes will be thrown out.

4. Code Enforcement and anonymous complaints will be eliminated.

Supervisors as well as CEO's and all the rest of the bureaucrats will have to swear an oath to uphold the U.S. Constitution.


7. A Constitutional Commission will oversee the governing body of the counties to make sure that the administrators are representing the people and not themselves or the state.

# **Food and Farm News**

#### Storms bring impacts to farms, ranches

Farmers and ranchers continue to assess the impact of storms that surged through California during the Presidents' Day weekend. A number of orchards and vineyards in Northern and Central California remain flooded as a result of this and earlier storms. Trees and vines could be vulnerable to root disease if floodwaters don't drain soon enough. The storms arrived during almond pollination season, but farmers say they remain hopeful weather in coming days will reduce any problems.

#### Farmers move dairy cows in advance of rising water

Several dairy farmers along the Tuolumne and San Joaquin rivers had to relocate their cows, because of rising water in the rivers. Dairy organizations had gathered farmers earlier, preparing them for the possibility of flooding. On beef cattle ranches, heavy rains washed out some privately maintained roads, making it hard for ranchers to reach their animals, and muddy pastures have limited ranchers' ability to reach herds on horseback.

#### Water, markets influence planting plans

Grain and hay fields that have flooded could ultimately suffer reduced yields. Farmers of other field crops will find their planting delayed. Thousands of acres were left unplanted in previous years during the multi-year drought. With more water likely to be available now, farmers say market prices will be a bigger determining factor in what they choose to grow. Prices have been weak for many field crops, forcing farmers to calculate what crops might turn at least a small profit.

### Second Amendment

#### Today for Money Matters I yield my time to my son Kyle, who has written this article in defense of the second amendment. M. Cuniberti

One of the most controversial issues today is the topic of gun control. The issue takes into consideration the safety and wellbeing of every American. Because of more and more shootings, it is important that Americans have the right to protect themselves by being able to carry a concealed weapon. Among the many topics surrounding gun control is the discussion of the right to carry a concealed weapon. A "concealed" weapon is defined as one that is kept hidden on one's person, or under one's control (Legal).

The argument for carrying a weapon is a valid one, due to the facts concerning the well-being of an American. The US homicide rate in 2014 was 4.5 per 100,000 ("FBI"). The rate keeps on increasing as the years go on. For instance, 2015 reveals a 3.9 percent increase in the estimated number of violent crimes which means that more crimes are being committed and the safety of American citizens are more at stake as the year's progress. As the rates of crimes increase, the time for an officer to come to the rescue remains the Meanwhile. the same. average response time for an officer to arrive is seven minutes ("Average"). Seven minutes can seem like an eternity if you are the one experiencing

a crime against you. With many criminals armed with knives, guns or other weapons, the average victim is little match for the experienced criminal and by the time police arrive, the crime and your life could well be over. Not only has the crime rate increased; there also has been an alarming increase in public shootings, ranging from schools to night clubs. Many times these shootings lead to multiple deaths and injuries before the authorities arrive, assess the situation, and stop the perpetrator. There were 372 mass shootings in the US in 2015, killing 475 people and wounding 1,870, according to the Mass Shooting Tracker ("Guns"). There were 64 school shootings in 2015, according to a dedicated campaign group set up in the wake of the Sandy Hook Elementary School massacre in Connecticut in 2012 ("Guns"). In many cases, there were no weapons carried by the victims nor did any of the victims have immediate access to one. Most of the assailants were unopposed until police arrived on the scene with their weapons. Had a gun been accessible to any persons on scene to confront and challenge the gunman, the victim count may have been lower. Simply put, the ability to shoot back presents a gunman with a threat to be dealt with, which would consume time and draw attention and fire away from unarmed persons.

Having the ability to carry a concealed weapon on one's person or hidden

crazed gunman or criminal blasting away uncontested. Carrying a personal firearm would also help prevent crimes against an individual and those in their immediate vicinity such as family members or workmates. Peace of mind is another benefit of a personal firearm. For persons who work at night, carry valuables, or work in dangerous neighborhoods or perform jobs that could subject one to harm, carrying a gun would provide the safety and security necessary to complete the work day.

The statistics in favor of personal possession of firearms is convincing. According to GOA (gun owners of America), "law abiding citizens use guns to defend themselves from criminals as many as 2.5 million times every year." Firearms are used more than 80 times more often to protect the lives of honest citizens then to take lives." These statements prove that officers cannot protect people all the time. Americans need to take situations regarding their safety into their own hands. The carry of a concealed weapon provides that safety. Not only can the police not guarantee Americans safety; they also are incapable of perusing and catching the correct criminal. "Armed citizens kill more crooks than do the police. Citizens shoot and kill at least twice as many criminals as police do every year. And readers of Newsweek learned that "only 2 percent of civilian shootings involved an innocent person mistakenly identified as a criminal.



### **Fletcher's Brownsville Meeting**

I told a few people I would report on supervisor Fletcher's command visit to a meeting of the Yuba Feather Community Services in Brownsville on January 10th. So here goes.

Fletcher, himself, had been dropping tidbits here and there, that he had worked a deal that would greatly benefit our poor community center, but he gave no details.

Therefore, Fletcher was duly invited to a meeting, to clear up all the confusion in the community and stop all the second guessing.

At the meeting, he started squeamishly in an uncertain tone, by saying he was only trying to help the community, and that, if his idea didn't pan out, he would drop it.

After a half hour or more of around the bush stuff, it seemed the crux of the matter was as follows: He tried to work a deal whereby a private and unspecified party would erect a "cell tower" on the property occupied by the community center; and, in so doing, the party

would pay for a lease on a small piece of land, thereby helping out the community center with a regular source of income.





## Farmers Monitor Storms' Impact on Crops, Water Supplies

Strong storms during the Presidents' Day holiday weekend flooded farm fields, caused several dairy farms to relocate their animals and brought other impacts on California farms and ranches. The storms also added more water to an already overtaxed system, and led to renewed calls to modernize the system.

"In the long term, the surge of storms should bring an improved water outlook," California Farm Bureau Federation President Paul Wenger said, "but it has definitely brought worries to farmers and ranchers whose land is inundated or whose crops may be at risk. We remain hopeful that weather in coming days will minimize any problems."

Wenger noted that many reservoirs have filled and have had to release water, which underlines the need to enhance California's water storage capacity.

"Believe it or not, there are people who think we don't need more water storage, and that we should even tear down many of the facilities we now have," he said. "These activists don't care how many people suffer from devastating floods in winters like this. They don't care how many people suffer from water shortages during droughts."

Wenger said California must move as quickly as possible to allocate money from the 2014 water bond, Proposition 1, to create more storage both aboveground and underground.

"Environmentalists

say we can solve water problems by conserving more water and storing more underground. But we're not able to conserve most of the water flowing through the system now-we have had to let it go. And moving water into the ground takes time. You can't replenish groundwater if you don't have aboveground reservoirs and canals to hold and move water to where it can effectively filter underground," Wenger said.

Farm Bureau said farmers of a number of crops and commodities will be assessing the impact from the weekend storms, including:

 Almonds — The storms hit just as almond trees were blooming. Bees that pollinate almond blossoms don't fly in the rain and prefer temperatures higher than 55 degrees. In addition, a number of almond trees were blown down by strong winds during the weekend. But farmers said the tree losses weren't as bad as feared, and expressed hope pollination would still be successful.

• Berries—The rains delayed strawberry harvest along the Central and Southern California coast. Production may be temporarily reduced as farmers wait for waterlogged fields to dry and discard raindamaged berries.

• Dairy farms—Several dairy farms located near the Tuolumne and San Joaquin rivers needed to move their animals to higher ground as river levels rose. Other farmers are watching river levels

carefully and preparing to move their animals if needed.

• Field crops—Fallplanted grain crops that have germinated could take on too much water, which could ultimately reduce yields. Hay fields have also flooded. Soggy or flooded fields will delay planting for a number of crops.

• Grapes—Vineyards in various grape-growing regions have been flooded. Farmers say that could leave vines vulnerable to root-rot damage if they remain flooded for too long.

• Vegetables — Rains and muddy fields slowed vegetable harvest in Southern California and delayed planting in the Salinas Valley. Rain generally benefited vegetable crops in the Imperial Valley.

• Walnuts — Flooded orchards that remain waterlogged for too long could be vulnerable to root diseases that can kill trees.

 Miscellaneous Heavy rains in foothill regions have washed out privately maintained roads, making it hard for cattle ranchers to reach their animals, and muddy pastures limit ranchers' ability to reach herds on horseback. Pear orchards in Lake County have been flooded. Citrus fruit harvest was temporarily delayed. The storms brought large amounts of rain to Santa Barbara County farmers who have remained in severe drought. One farmer there reported losing about half an acre of avocado trees to a mudslide.
