Sexually Violent Predator Hearing Update

Marysville, Ca.

The State of California Department of State Hospitals is recommending residential placement for 63 year old Eldridge Lindsey Chaney Jr., a Sexually Violent Predator, at the proposed address of 645 Ellis Rd in Marysville (District 10), Yuba County, California. On December 1, 2016 pursuant to Welfare and Institutions Code 6608.5, Yuba County Sheriff's Department and District Attorney's Office were informed by the State of California Department of State Hospitals of Mr. Chaney's court



ordered release and proposed relocation to Yuba County from the Coalinga State Hospital in Fresno County, Ca.

A hearing for Eldridge Chaney Jr's placement in Yuba County was scheduled for January 6, 2017 before the Honorable Lydia M. Villareal in Monterey County Superior Court in Salinas, Ca. Chaney was appointed a new attorney, who needed time to prepare. The new hearing is scheduled for February 10, 2017.

Yuba County Sheriff Durfor and District Attorney Patrick McGrath will travel to Monterey County to represent Yuba County and its objection to the placement.

Legislation Introduced to Limit Locations of Predators

Sacramento, Ca.

Assemblyman James Gallagher (R- Yuba City) introduced AB 255, the Protect our Communities Act, which would limit the placement of Sexually Violent Predators to counties where they have residential, familial, or employment connections when they are conditionally released. The Department of State Hospitals (DSH) is currently in the process of placing two convicted violent sexual predators in Northern California where they have no community ties.

"These offenders pose a serious risk to our community, and rural counties shouldn't be the dumping ground for offenders

from other areas of the state," said Gallagher.

"We are a small town where children roam freely. We cannot afford to have convicted sexually violent predators live among our families," said Senator Jim Nielsen (R-Gerber), a co-author of the bill.

"My community is rightfully concerned that a designated Sexually Violent Predator from Santa Clara, with no ties to our area, could be placed in Lincoln in close proximity to minors," added Assemblyman Kevin Kiley (R-Roseville), another co-author of AB 255. "This dangerous and arbitrary decision makes clear that the legal process relating

to these most deviant of offenders is broken. Our bill will fix the most glaring problems and provide much needed safeguards for fairness and public safety."

Specifically, AB 255 would require a court to consider where the offender was living prior to being arrested when determining their county of domicile, which will be the preference when determining county of placement. If placement in the county of domicile is not possible, the bill would require the court to place the individual in a county where they have familial, residential, or employment connections.

Lamon Leaves Msvl and Many Problems

Marysville City Services Director Dave Lamon's sudden departure on Friday, February 3, ends nearly 20 years with the city and completed a family legacy of public service. Lamon was born and raised in Marysville.



Lamon's father Grady was a general contractor and civic leader who served on the Marysville City Council. His Uncle John Lamon was a Fremont-Rideout Hospital board member for many years and Uncle Henry Lamon was a Yuba City Council Member. The three brothers operated Lamon Construction.

Dave Lamon's last noteworthy project was the messy and controversial task of taking the city from being a no marijuana dispensary zone to welcoming two dispensaries.

The process has been laden with charges of favoritism, violations of the Brown Act, and the city council's practice of crony capitalism, changing the ordinance and zoning to benefit the Lanza Family.

As in any departure, Lamon leaves unfinished business. In spite of being a city for 167 years Marysville still has a stretch of J Street with no curbs and gutters and the 12th and J Streets neighborhood experiences severe flooding during storms.

On November 5, 2015, Lamon obtained a California Department of Housing and Community Development (HCD) grant for \$1.8 million to upgrade drainage, add curbs/gutters, and repave around 12th and J. In addition, there was money for code enforcement and planning studies.

In order to fulfill the grant Marysville needed \$700,000 for cash flow and asked Yuba County for a loan. An August 26, 2016 memo from Yuba County Administrator Robert Bendorf asking supervisors to approve the loan states that "The project design and bidding has been completed and construction should be completed near the end of 2016." Repayment of the loan was to come from the State HCD grant funds.

However, not only has the project not been completed but council members do not believe the bidding ever took place.

Sutter Co Com Services Director Arrested

Sutter County Community Services Director Danelle Stylos, 60, was arrested on Feb 1, 2017 by District Attorney Investigators for making false statements, providing false information, perjury and voter fraud. She was booked into Sutter County jail and released on \$25,000 bail.



Sutter County Supervisors called an emergency closed session February 2 to discuss the matter with Stylos. An attorney spoke for Stylos. Supervisors voted 5-0 to place Stylos on administrative leave with pay. Her arraignment is set for March 6.

Stylos once served as Planning Manager for Sutter County before returning to be the Community Services Director. She receives pay and benefits of \$196,805.72 according to Transparent California's 2015 records.

She is responsible to oversee Animal Services, Certified Unified Program Agency (CUPA), Environmental Health, Fire Services, GIS Data Download, Planning and Building Services, Public

Lamon Leaves Msvl and Many Problems

Water continues to approach the porches of residences during storms.

The Bendorf memo stated the \$700,000 plus 1% per annum interest and 1% in administration fees was to be repaid on February 28, 2017. If the city does not repay the funds the county can take the money out of the city's property tax apportionment which the county processes.

Another set-back is that the state fined Marysville \$3 million for not filing 4 years of quarterly waste water reports. That duty fell under both Lamon's and

City Manager Walter Munchheimer's job responsibilities. Lawyers under contract with the city for \$10,000 / month have advised paying a negotiated reduction of the fine to \$288,000.

This loss is a blow to those residents who voted to raise their sales taxes to 8.5% for ten years to cover costs for past council financial blunders. Citizens continue to pay more as city hall cannot do its job.

Meanwhile, Munchheimer and department heads are asking for 7% raises. The State Controller lists Munchheimer's compensation

at \$133,674 (\$106,701 plus \$26,793 in retirement and health benefits.)

Denis Cook is expected to fill-in for a few months until a replacement is found for Lamon. Cook formerly served as Director of Community Development for Yuba City.

There has been no discussion of asking the county to assist with these duties even though the county's community services department is located a few blocks away.

Lamon has moved out of the area.

Works, General Fees and the Planning Commission.

A May 1, 2012 article in the Oakdale Leader "Oakdale Battles \$ Woes," refers to Stylos' work for the City of Oakdale. The article describes the troubled financial state of the city saying "Interim City Manager Gregory Wellman has made no secret that the City of Oakdale has money problems and cites a lack of financial oversight and historically poor business habits as the cause."

Oakdale Leader reporter Richard Paloma writes, "The unauthorized payments have resulted in over \$325,000

made without city manager knowledge or prior council approval. Oakdale Leader research showed most recently a payment for \$113,000 made to Environmental Science Associates was approved by former Community Development & Services Director Danelle Stylos and issued by Finance Director Albert Avila without having the contract being signed off by the council or Wellman." Stylos' office financials were said to be in disarray.

Interim manager Wellman was brought in as a "fixer" to save Oakdale in financial and ethical free-fall. The public works director was fired

and Stylos resigned to take her current Sutter County position. Wellman said he did not regret her resignation.

The District Attorney's office has yet to complete its formal complaint as the investigation is ongoing. It is alleged that Stylos misrepresented where she was living. Her contract stipulated she live in Sutter County. It appears that some county officials were aware she was out of compliance by residing in Sacramento while giving a false local address.

Charges assert that Stylos committed perjury while completing documents for voting, a concealed weapon permit application and other government paperwork.

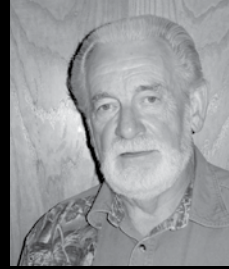

Voter Fraud Needs to Be Extinguished Al Franken May Have Won His Senate Seat Through Voter Fraud

It looks increasingly likely that at least one member of the United States Senate may owe his seat in the world's greatest deliberative body not to his charisma or the persuasiveness of his message but to voter fraud.

As the Wall Street Journal's John Fund reports, Minnesota Democrat Al Franken's narrow, 312-vote victory in 2008 over incumbent Sen. Norm Coleman may have come as the result of people being allowed to vote who, under existing law, shouldn't have been.

The certification of Franken as the victor came only after a series of recounts dragging out for almost half a year. It also sparked an investigation by Minnesota

Majority, a conservative watchdog group that compared the list of those recorded as having voted in the election against what Fund calls "criminal rap sheets." The group found, in what appears to clearly warrant further and official inquiry, that:

... At least 341 convicted felons voted in Minneapolis's Hennepin County, the state's largest, and another 52 voted illegally in St. Paul's Ramsey County, the state's second largest. Dan McGrath, head of Minnesota Majority, says that only conclusive matches were included in the group's totals. The number of felons voting in those two counties alone exceeds Mr. Franken's victory margin.

Thus far no one is

calling for the results to be overturned. Indeed Dan McGrath, who spearheaded the inquiry, told Fox News, "We aren't trying to change the result of the last election. That legally can't be done." He added: "We are just trying to make sure the integrity of the next election isn't compromised."

McGrath's point is a good one. The only question is how the integrity of U.S. elections can be maintained when senior policymakers inside the United States Department of Justice, through their actions and instructions to their staffs, do not seem to believe that voter fraud exists or, if it does, that it is not worth investigating.

interview with The Bee. "This is politics, and this is what makes voters apathetic."

"Rather than focusing on needless resolutions, the Democrats might want to fix the California budget deficit that they themselves created," Brulte added in the interview, accusing the party's leaders of misplaced priorities.

Snow Survey Must Lead to Improved Water Supplies

When state snow surveyors visit the Sierra Nevada, they will find a snowpack well above average for the date—and California agricultural organizations say they hope that translates into improved water supplies for the state's farmers and ranchers.

"You would think that a snowpack in the range of 175 percent of average would assure plentiful water supplies, but that link has long ago been severed," said Tom Nassif, president of the Western Growers Association. "Wildlife agencies often hold the key to determining how much water is available, because endangered-species laws reserve water for protected fish."

Nassif noted the passage of federal legislation called the Water Infrastructure Improvements for the Nation Act, which included short-term provisions to increase flexibility of the state's water system.

"Among its provisions, the WIIN Act allows water agencies to capture more water during winter storms and requires them to maximize supplies consistent with law. This winter will

be a good test of how agencies adhere to that law," said Paul Wenger, president of the California Farm Bureau Federation.

The WIIN Act also invests in California water storage and desalination projects, complementing the investments California voters made when they passed the Proposition 1 water bond in 2014.

"We've had to let too much water run out to sea this winter, because we didn't have any place to store it," said Bill Diedrich, president of the Califor-

nia Farm Water Coalition. "We should be doing everything we can to save today's rain and snow for use tomorrow."

The California Water Commission will decide later this year on water projects to be funded through the bond.

"We will continue to urge the commission to put that money to work as quickly as possible to build new storage facilities that can capture more water during future winters such as we've seen in 2017," Diedrich said.

Wolf protections prompt lawsuit

Saying the action was based on "flimsy evidence," ranching groups have sued to overturn state protection for the gray wolf. The Pacific Legal Foundation filed the suit Tuesday on behalf of the California Cattlemen's Association and California Farm Bureau Federation. The groups say the state Fish and Game Commission ignored healthy wolf populations elsewhere and undermined efforts to manage wolves entering California.

Strong storms test reservoir operators

As February begins following a month of above-average precipitation, reservoir managers review their response to the strong January storms. Many reservoirs had to release water before and during the storms, to make room for anticipated runoff, based on flood-control manuals for each facility. Groups representing water users say it's crucial to capture as much water as possible during storms while maintaining flood protection.

Rains help Southern California farms

In Southern California, January rains came as a relief to farmers whose

crops have suffered from ongoing drought. Much of the region remains classified as drought-stricken, but farmers call the January storms "a godsend." The rains did slow berry and citrus-fruit harvests, and delayed farmers from preparing fields for the season. Farmers who grow wheat without irrigation say the rains should provide enough soil moisture to justify planting.

Court reviews Klamath water cutoff

A trial underway in Washington, D.C., will determine whether farmers along the California-Oregon border could be compensated for a water cutoff in 2001. Farmers in the Klamath Project saw their water supplies cut off by government agencies that reserved the water for protected fish. The farmers contend the shutoff represented a taking of their property, in the form of water rights – the question a federal court will consider in the current trial.

Yuba County Waiting for OK To Begin Road Repairs

Marysville, Ca. The Yuba County Board of Supervisors approved funds to repair a number of washed out foothill roads, but actual work is on hold until Public Works gets approval from environmental regulatory agencies. On Tuesday the Board approved the use of \$370,000 in contingency money from the county’s general fund to pay for the needed repairs. Yuba County Public Works Director Mike Lee said six roads in the Bullards Bar region washed out during the early January storms and require significant repairs. Federal law requires the county to consult with environmental resource agencies before

proceeding with construction. Lee said a biologist hired by the county is currently performing tests to determine the potential for impacts to endangered species. The results will be submitted to agency regulators, after which it will be a matter of waiting for approval to begin repairs. Yuba County officials are hopeful much of the repair costs will eventually be covered by state and federal disaster assistance funds. Should the President declare a disaster as a result of the storms, Federal-aid reimbursement monies will become available to local agencies such as Yuba County. The county must adhere

to federal environmental laws or risk jeopardizing the opportunity to receive federal reimbursement. “We want to assure our residents who rely on these roads that we are ready to begin the repairs, as soon as we get the word,” Lee said. “The environmental requirements cannot be bypassed and unfortunately the repairs will be delayed until we get a green light from the regulators.” The six roads washed out by the storms include Oregon Hill Road, Indiana Ranch Road, Weeds Point Road, Pendola Road, Fountain House Road and Celestial Valley Way.

Juan Garrido 1480-1550

Juan Garrido was a black African-Spanish conquistador. He joined a Spanish expedition and arrived in Santo Domingo (Hispaniola) about 1502. He participated in the invasion of present-day Puerto Rico and Cuba in 1508. By 1519 he had joined Cortes' forces and invaded present-day Mexico, participating in the siege of Tenochtitlan. He married and settled in Mexico City. He continued to serve with Spanish forces for more than 30 years, including expeditions to western Mexico and to the Pacific. He is credited with the first cultivation of wheat in the New World.

Born in Africa, he went to Portugal as a youth. When baptized, he took the name Juan Garrido (Handsome John). He went to Seville, where he joined an expedition to the New World, possibly traveling as Pedro Garrido's (Handsome Peter) servant. Arriving in Santo Domingo in 1502 or 1503, Garrido was among the earliest Africans to reach the Americas. He was one of numerous African freedmen who had joined expeditions from Seville to the Americas, Africans participated both as voluntary expeditionaries and, more frequently, as involuntary enslaved colonists.

quest and pacification of this New Spain, from the time when the Marqués del Valle [Cortés] entered it; and in his company I was present at all the invasions and conquests and pacifications which were carried out, always with the said Marqués, all of which I did at my own expense without being given either salary or allotment of natives [repartimiento de indios] or anything else. As I am married and a resident of this city, where I have always lived; and also as I went with the Marqués del Valle to discover the islands which are in that part of the southern sea [the Pacific] where there was much hunger and privation; and also as I went to discover and pacify the islands of San Juan de Buriquén de Puerto Rico; and also as I went on the pacification and conquest of the island of Cuba with the adelantado Diego Velázquez; in all these ways for thirty years have I served and continue to serve Your Majesty—for these reasons stated above do I petition Your Mercy. And also because I was the first to have the inspiration to sow maize here in New Spain and to see if it took; I did this and experimented at my own expense.

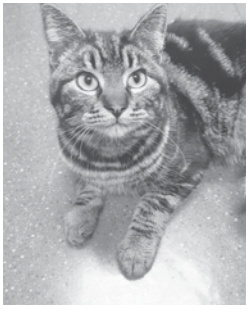



Fiscal Policy Unpredictable

The latest out from Federal Reserve Chief Janet Yellen gives rise to further interest rate increases in 2017. In a speech last week to the Commonwealth Club in San Francisco, Yellen indicated the economy is "close" in fulfilling the central banks objectives of stable prices and full employment. She expressed confidence that the economy will continue to improve. Yellen stopped short of pegging a date as to when the next rate increase might take place. Estimates by the Federal Open Market Committee predict that three increases of a quarter point apiece will likely take place by December of this year.

Only two increases have taken place in 6 years. The first increase was announced in December of 2015 with the second in December of 2016. Although the 2015 spooked the markets with a January 2016 sell off, the December 2016 announcement apparently had little effect.

The Federal Reserve controls monetary policy in the U.S. by raising or lowering interest rates, conducting open market operations (buying and selling assets back and forth to member banks) and using other variations of currency management. While monetary policy controls the money supply and is handled by the Federal Reserve under Janet Yellen, fiscal policy such as tax cuts, stimulus spending and other similar type of initiatives are the sole responsibility of policy makers in Washington. The two entities work together to hopefully steer the economy in the direction they want it to go.

Given the severity of the 2009 economic crisis, an argument could be made concerning the success of such policy implementation. Indeed, since the Federal Reserve and Washington have been working together since 1913 when the Federal Reserve was established by the Federal Reserve Act in December of that year, there have been 11 recessions (thebalance.com) and one depression. A recession is defined as contraction in Gross Domestic Product (GDP) for two consecutive quarters while a depression is regarded as a fall in GDP of at least 10% or a recession lasting for two or more years (Wikipedia).

Regardless of what one thinks about the effectiveness of monetary and fiscal policy, what the Federal Reserve does and says has a definite and sometimes immediate effect on world markets and in recent years, even more so. Although the movements of the central bank's monetary policy may be somewhat predict-

able given the public announcements by Yellen, what Washington does with their fiscal policy under the Trump administration is yet to be determined. The results of the two working in conjunction with each other will likely prove even more unpredictable.

Directors Jonathan Rosenberry and Ethan Elliot Williams will be present to accept their awards at the event.

Yuba Ball

Opening an old dusty barn door can cause my heart rate to go up. So why am I guilty of passing up opportunities? How many times have I passed the Mary Aaron Museum and not gone in the front door? I have often driven by the that large building on 12th and F and wondered what happened here? The warm inviting site of the Memorial Museum on Butte House Road has a staff that is commensurate in their helpfulness.

Having a cup of coffee with Lew Clift who grew up in Hammonton commented on the complete community with a school and a hospital was an eye opening flash to the past. My thanks and appreciation of our community minded people who made a great effort in time and money to save and restore the past such as Art Worledge and Buster Brugmann with a support of knowledgeable people like Lorry Dunning continues to grow. All of this ties together as I prepared to write this article preceding the Historic Faire celebrating the development of Marysville. I appreciate being allowed to use the pictures, text, time, and passion they have allowed me to share.

Opening the door to the past and discovering the heritage of our community allows us to better cope with the present, and be wiser in the future.

The Yuba Manufacturing facility at 1203 F Street was begun in 1909 by the Yuba Consolidated Goldfield Company to manufacture parts for gold dredgers and later the Yuba Ball Tread Tractors.

San Leandro was bustling with agricultural business in the early 1900s as was Stockton. C.I. Best, the son of Dan Best, was a very special man who sought quality well beyond the norm. The Holt Company was building a line of crawler tractors in Stockton as was Best in San Leandro. Holt sued Best for patent infringement rights. This became a long drawn out affair eventually leading to Best selling to Holt. Dan Best took the capital from the suit and funded his son C.L., Leo, who began another Company. These few sentences are a gross oversimplification of events.

C. L. was way ahead of his time in his management style and passion for excellence in engineering. His faith in alloys, bearings and headhunting staff was unique for the time. Many of his ex-staff became well known (White -Cletrac) among others. He hired Master Mechanic Clarence Henneuse who headed the team that conceived the idea of the roller bearing concept in lieu of the pin and roller arrangement which reduced friction thus making more efficient use of power. Best was not enthused and the team left and formed the Ball Tread Company in Detroit. W.P. Hammon the owner of the goldfields was also a man with a look for the future and recognized the potential for farming and mining in the area. The mules used to move materials had difficulty on the rocks. Hammon had peach and orange orchards in the Biggs region. Thus, he saw the need for a tracked vehicle to move the dredges and

corresponding parts on the rocks and more easily disc his orchards of softer soils. So in 1914 he bought Ball Tread, moved it to Marysville, and renamed it Yuba Ball Tread Tractor. Manufacturing the unit with a range of models on 12th Street. One of the notable sales pitches for a salesman was to push the tractor on a flat floor to demonstrate the reduced friction. The tractors' strength was also its achilles as the balls came out of the tracks rails fairly easily without constant track adjustments. Backing the Ball Tread could also pose problems. However, driving the Ball was very easy as each track side had a clutch and the front wheel could be steered. This arrangement allowed sharp turns and one could easily learn to drive the Yuba. I was graciously allowed to drive the one in the Wallace Collection by Jess Gilbertson of Knights Landing.

The tracks had an oiling system which helped keep the friction to a lesser degree. The Yuba came out with several models with the 12-25 being the most common. The 18-35 was later built in Benicia. The 12-20 introduced in 1919 had a Waukesha engine, weighed about 6,750 pounds and sold for \$2,900, the 20-35 sold for \$4,900 and was equipped with a Wisconsin, the giant 40-70 had a Yuba motor and weighed about 21,000 pounds.

The Ball Tread had a low profile, tight steering, and was appealing to farmers who had orchards on hilly ground. The Depression of 1921 made the Yuba Ball expensive for farmers, the roller balls coming out of the rails, and the constant need for maintenance led to its demise and manufacturing ended in 1931.

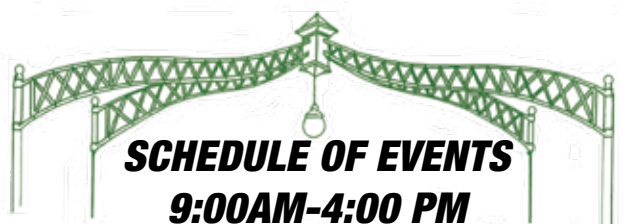
The Memorial Museum on Butte House Road has

a stunning example of a Yuba Ball Tread tractor. It's presence is because of the lead efforts of Art Worledge, Buster Bruckmann, and a large number of community members who donated time and money for the restoration.

The Model 12 was built in 1915 and has the serial number of 96. The outstanding restoration is one of the finest jobs I have ever seen. The early Ball Treads used Wisconsin and Continental all fuel engines. Coupled with power was the Hyatt high duty roller bearing transmission.

I invite you and your family to visit our museums, libraries, the Historic Faire festivities, and model for your children a curiosity for the past. Read to them the interesting words of our predecessors which will help better prepare them for the future.

After the parade is over the tractors will be parked for about 45 minutes for the public to view. They will be parked in front of the Territorial Dispatch Office on 4th Street. Visiting with the owners is invited.

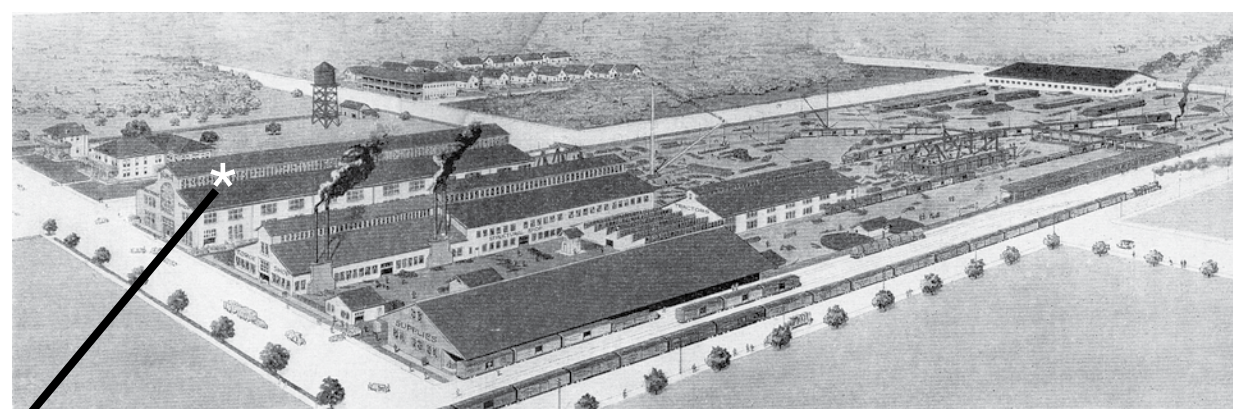
