Historic Marysville Store

Condemned to be torn down



The Nakagawa store on C Street, in Marysville, has been condemned and is in danger of being torn down. This is one of the last Japanese businesses left in Marysville. Only this business and two others are left standing.

Dr. Sue Fawn Chung, Professor Emeritus of History at the University of Nevada at Las Vegas and former Nevada State Trustee to the National Trust for Historic Preservation provided the following:

According to the National Register for historic districts #99000692, the Nakagawa Company at 306 C Street in Marysville, Ca. was part of the district. The grocery store was established in 1857 during the Gold Rush era. It is in the heart of Marysville's Chinatown on C Street. Miners flocked to the rich mining area and later

developed farming and textile manufacturing. In 1928 the Nakagawa family obtained an official business license (but may have been in business. longer). As a part of chain migration, the Nakagawa clan lived in Marysville, Yuba City, Sacramento, and other nearby areas. The store eventually became a community center and the family community leaders. In the 1960s Jim Nakagawa was known as the best fishing expert in the region and many purchased their bait and got fishing tips from him. He even provided the local newspaper with fishing news, including local salmon caught in the area, thus giving free publicity to the store. Asian Americans and community members purchased fresh fish and groceries from the store. When Mary Nakagawa was the owner, the

store brought in an annual revenue of \$50,000 and had two employees. The Nakagawa Company supported numerous community events and started some annual Japanese American festivals.

Lucky Jerome Owyang said he didn't believe anyone locally was working on this proj-

Dr. Chung said, "Some people are working on it. We would like to see the Professor Michelle Magalong, head of the Asian Pacific Islander Historic Preservation group, the Japanese American Citizens League, and other groups join the Chinese American Citizens Alliance in helping in the preservation movement. The National Trust for Historic Preservation has been informed and perhaps would provide a "saving place" grant."

STEM Conference for 8th Grade Girls

The STEM Conference committee has been working hard, and they are ready to welcome 720 girls from 26 different middle and K-8 schools throughout Yuba and Sutter Counties to the Conference for 8th grade girls at Yuba College on Thursday, January 12, 2017. The Marysville-Yuba City Branch of AAUW (American Association of University Women) has been putting on conference -formerly called the Math-Science Conference, for 8th grade girls - once a year since the mid-1980s. The event started out using local church facilities, but when more space was required they moved over to Yuba College where several buildings are used there during a time when the college is not in session.

This year 24 professional women have kindly offered to be session leaders and will be at Yuba College all morning on January 12th at 9 am, to talk to the girls about their careers in medical fields, veterinary science, and engineering (among others), and how the STEM subjects (Science, Technology, Engineering, and Math) have been important to them in the workplace.

The 8th grade girls will participate as a group in an opening presentation with the keynote speaker, Sutter County District Attorney, Amanda Hopper. Then each girl will attend three different sessions in the interest areas that they have selected. The day ends as they once again all join together with their teachers for lunch in the college cafeteria and an optional tour of the college campus.

The Math and Science teachers who bring their students to the event find it very beneficial in helping the girls prepare for high school. The Conference helps them to begin thinking about future careers, and most teachers bring their 8th grade girls back year after year.

Govt No Friend to Citizens

A 'new Marysville Medical Marijuana Dispensary' located at 1109 Chestnut Street is advertising on Craig's List - Sacramento for workers to fill a myriad of positions. The jobs include assistant manager, front desk, production and packaging, growers and farmers, bud-tenders, graphic design and marketing.

Compensation ranges from \$15-22 / hr. for potential employment starting this month. Applicants must be 21-years-of-age and meet sundry employment standards. The solicitation has been posted for more than 3 weeks. If the offer is legitimate it again raises questions about the fair-

ness and honesty of City of Marysville solicitations for applicants to compete for two marijuana dispensary licenses. Nine applicants paid approximately \$4000 each for a chance to start a marijuana business.

Dispensary licenses have yet to be 'officially' awarded.

Some competitors assumed the city would conduct an impartial process to determine who would be chosen. However, River City Phoenix and the Lanza family appear to know they are the chosen ones.

River City Phoenix purchased a building and was able to appeal their disqualification for having a felon on their board of directors N.C. Holistic was not allowed to appeal their proposed location being rejected by Public Services Director Dave Lamon.

David Lanza, insisting he had a deal with city government, was able to get his Chestnut Street (Cargill) building rezoned last week. It was initially rejected due to improper zoning. It is across town from the Medical Arts Zone originally noted for dispensaries.

Leaked emails from City Hall described council members having private meetings with David Lanza about his Cargill site being added to the dispensary running. These discussions appear to be a violation of the Brown Act which prohibits council members from doing city business in private.

David Lanza conveniently paid for the city's Measure C political campaign to push a sales tax increase from 7.5 to 8.5%. City government is legally forbidden from paying for or promoting the passage of ballot measures, essentially using the taxpayers' dollars against them.

However, other California cities throughout the state have skirted this prohibition by hiring public relation firms to do the work for them. These cities may end up in court. In Marysville's case Lanza did the work for council members by using private funds.

Was Lanza funding the political campaign for the council's favor and his monies to be returned via a dispensary license? Maybe the city should be renamed Lanzaville.

Politicians seem perplexed when hearing business people complain about over-regulation, corruption and arbitrary bureaucrats that have favorites.

Kumar Kairam, owner of Yuba City's Washington Ave. Market is subjected to an arbitrary prohibition against selling a single 16-ounce beer. There is no city ordinance. The city council did not make the decision. A lone city bureaucrat declared it so.

It is causing a loss of customers who have switched to Kumar's competitors. For Kumar, it is an embarrassment to be treated like an undeserving child when competitors can sell the product. Government doesn't understand about losing customers since citizens are legally bound to bow to bureaucrats.

Yuba City employees report being asked to create 'rules' where there are none to get business and building permit applicants to comply with the arbitrary whims of the development department.

Dollar General endured bureaucratic stonewalling by Sutter County and supervisors Larry Munger and Barbara LeVake. While supervisors describe themselves as 'public servants' there to protect and benefit the citizens, in most cases it is a crock.

Munger should get a plaque for how to discourage, lobby against and trash a reputable business that wanted to bring convenience and lower prices to consumers. Though supervisors claim they want more jobs they did not want jobs from Dollar General.

Three supervisors did eventually vote for Dollar General. Did they apologize to store representatives for the bureaucratic gauntlet?

Munger wanted to protect his 'retirement cash cow' grocery store in Sutter where Dollar General will be located. This was a crass act of self-interest by a rude supervisor. Businesses pay government thousands of dollars and then are harassed and cussed at.

The primary reason more businesses are not starting here, coming here or expanding here is that the government is a pain in the ass. Recently, Donald Trump noted that egregious regulations had as much or more to do with Carrier planning to leave Indiana for Mexico than employee pay.

Yuba – Sutter has its own swamp to drain. California has for years been rated the worst state to do business in. Yuba – Sutter is no exception.

A Look at the Housing Market

From the ashes of the real estate blow up in 2008/09, looking around today one could hardly imagine how devastating the crisis was. Having prompted the governments of the world to bailout not only the housing sector but literally the entire worlds banking system, they used trillions of dollars in giveaways, guarantees and a plethora of programs to stabilize financial markets. It's no surprise the real estate market took off like a skinned cat after such monetary injections.

Fast forward to today and few are of the opinion there remains any reason to be concerned about the health of the

housing sector.

Digging deeper into the current economic environment however and possibly supported by a variety of recent statistics, some are arguing that erring on the side of caution may be warranted when it comes to continuing to give the all clear on this market.

Interest rates have been near zero since the crisis. This means what housing recovery we have seen has its roots buried in historic low borrowing costs. Since rates cannot remain at zero forever and indeed the Federal Reserve has said as much in their meeting minutes, when rates do start their inevitable rise, fewer people will be able to qualify for home loans.

from the Federal Hous-Finance Agency (FHFA) the year-on-year single family house price index went up an eye-popping 5.8 percent in July. Compare that to a 5.6 percent increase in June. The National Association of Realtors added to the concern when it released its figures

On the flip side, out

showing pending home sales declined in August. That's the third time in four months and the lowest level since January of this year. Adding even more fuel to the controversy, the Census Bureau reported sales of new homes fell 7.6 percent in August.

With slowing home sales in the face of persistent rising home prices and with interest rates possibly set to rise, is the historic real estate market recovery coming to an end? The canary in the coal mine will likely be when home prices start to stall out, much like they did at the beginning of the housing blowup before investors realized what was happening.

Should home prices begin to fall or even just flatten out, that might be a sign buving demand is finally drying up. That might spell big trouble for a market that has been red hot since the end of the crisis. It's been a good run for the real estate investor and the industries that feed off of it but like all good things, it is likely to come to an end at some point.

Astute would be wise to keep their ears glued to the proverbial tracks and watch for indications this train may be coming to the end of its run or at the minimum, slowing considerably.

My last column included a story about a whale caught in crab pot lines, was rescued and swam away. I do not know where in California this took place or who the fishermen were. Now let me tell you another story which was similar and happened to me back in the 50's.

I was fishing French Creek. This stream is located above Oroville between Lake Madrone and Berry Creek on state route 162 on the way to Bucks Lake. I got an early start from Yuba City and arrived at the creek a short time before first light and forded the stream at the crossing in my car and parked in the old campground created by my family in the 40's. I decided to fish upstream and then fish back down later in the morning. It was the opening weekend of the general trout season and I was excited to be the first

on the water. By mid-morning the old fly rod had a good workout with lots of action. I lost track of how many trout I had caught and released that morning, but I had kept a half dozen for food and had carefully placed each fish in my wicker creel along with some green grass for moisture.

It was on the way down stream on my return when tobacco when I suddenly noticed a slight movement

As I concentrated my vision on that area I was able to pick out the object which got my attention. It was a water snake and he was sitting on the bottom in a half curl watching the small trout as they swam by. Water snakes in French Creek are among the ones which are rusty brown and blend in with rocks and gravel of the stream. I was fascinated to watch the scenario unfold before my eyes. One rainbow trout was swimming closer to the snake and suddenly the snake struck and had the fish in its mouth. The fish struggled and was frantically swimming sideways and upside down trying to get that snake off of it. To no avail the snake won out and I watched it swim with the fish to shore across the stream from where I sat. As the snake crawled out of the water I crossed the stream and reached down and grabbed the snake which released its grip on the trout. I threw the snake as far as I could into the

brush. I picked up the little

trout, which turned out to

be around six inches long,

and put it back into the wa-

ter slowly moving it back

and forth to get moving

water back into its gills. As I did this I examined the little guy and discovered two abrasions on his side where the teeth of the snake had grabbed him.

After a few minutes the fish became active, his gills were moving and I released my hold. The little guy just laid there on his side and finally became upright. I figured it was alright so I started downstream. What happened next was amazing. The little trout followed me as I walked along side of the creek. When I stopped, he stopped. This continued until the little trout came to faster water and it disappeared in the current. Just as the story last week about the whale. it looked like that little trout was thanking me for saving him from becoming the snake's breakfast.

It is, indeed amazing what is possible with wildlife in their natural habitat and that all creatures really do have feelings.

Closing thought: With the year coming to an end we should be thankful for what we have and be aware of the dangers of mixing holiday cheer with the automobile. Have a safe, Happy New Year.



A King's Ransom for 'Public Servants'?

Do Californians pay



Once upon a time we called them "public servants." Today, most taxpayers struggle to keep a straight face when this term is used to describe the well-paid, elite who govern us.

In a state where the median per capita income is just over \$30,000, Gov. Brown, legislators and other state elected officials will celebrate the holidays with a four percent pay raise. The California Citizens Compensation Commission. whose members are appointed by the governor, decided the improved economy and healthy state budget justified the raise. California lawmakers, who were already the most generously paid in all 50 states, will now receive \$104,115, earning them \$14,774 more per year than the next highest. Of course, this does not count the additional \$176 per day in "walking around money," living expenses lawmakers receive for every day the Legislature is in session, amounting to an aver-

The governor, too, is now the highest paid at \$190,100 — Pennsylvania's governor is actually slated to make \$723 more, but Gov. Tom Wolf does not accept the sal-

age of \$34,000.

their governor, the top executive of a state government responsible to nearly 40 million constituents, enough? The fact that there is never a shortage of candidates for this job is an indication that the pay is sufficient. So, the question arises, why do many government employees receive more than the governor?

At the local level, most cities have as their chief executive, a city manager. Of 479 cities - out a total of 482 - reporting to the state controller, 279 are paid more than the governor. Of these, 24 receive over \$300,000 annually.

For some cities, paying their top administrator a high salary seems to be a matter of vanity. Councilmembers, who approve generous compensation, will take the position that their city deserves a highly-paid manager, the same way some car buyers justify the purchase of a luxury vehicle. Just as the neighbors may be impressed by the new Mercedes, neighboring cities will be impressed with their city's ability to overpay the help. This, of course, puts pressure on surrounding cities to keep up with the Joneses.

While some city hall insiders will argue that higher pay is justified by a larger population, there seems to be no actual correlation.

Escondido, nia's most generous city, has been compensating its manager \$413,000 annually to serve a pop-

ulation of 151,000. In slightly larger Palmdale, the manager receives \$138,000 to look after 160,000 residents. And then there is Garden Grove with a population of 177,000 where the city manager gets \$89,000.

A few years ago, the city manager in Bell went to prison for ilcompensating legally himself \$800,000 per year. However, although it may not be illegal, the city of Vernon stands out as a candidate for the most profligate in the state. Its top executive is paid more than \$328,000. The city's population is only 210, which means that each resident is responsible for over \$1,560 to compensate the manager. (The rumor that Vernon's top executive insists on being called "Your Majesty" could not be verified.) Another small city, Gustine in Merced County, with a population of 5,482 gets the award for most frugal. It pays its city manager \$909 annually.

While there are other areas of government employee compensation that beg examination, the range of pay for city managers seems to be the most irrational.

Still, none of these local administrators is close to the state's top salary of \$3.35 million. But since the program generates the revenue to pay UCLA football coach Jim Mora, he is more likely to be criticized for his record more than his

Bear Yuba Land Trust (BYLT) will receive \$74,550 in grant funding from the Sierra Nevada Conservancy (SNC) Governing Board to complete a timber management plan on approximately 2,000 acres of mixed conifer forest in the North and Middle Yuba River watersheds.

The grant-funded Non-Industrial Timber Management Plan (NTMP) will guide BYLT's future management actions within forests of Rice's Crossing Preserve, a 2,706 acre property owned by BYLT located along a six-mile span of the river corridor.

For years, Sierra Nevada Conservancy has served as a primary contributor to research and land management planning projects on BYLT Preserves.

"BYLT is very excited to work with SNC on another project. Having the opportunity to study wildlife, plants and ecosystem functions on the lands we conserve is essential to upholding our goals of protecting critical wildlife habitats and restoring ecosystems to the best of our ability based on scientific data we collect," said Director of Land Stewardship Erin Tarr.

In 1989, the state legislature created a new option in the Forest Practices Act for "non-industrial" landowners - private landowners and organizations without a wood processing facility known as the Non-Industrial Timber Management Plan. It is designed to promote long-term management and planning on forest ownerships of 2,500 acres or less.

BYLT's plan for Rice's Crossing will guide a wide variety of forest management methods including: areas that would benefit from understory prescribed fire, critical wildlife habitat corridors that should remain untouched and areas that could benefit from sustainable harvesting. All funds BYLT receives from timber harvests will be applied back to Rice's Crossing Preserve for stewardship of the land.







debris that might have collected under them from falling petals, etc., should be cleared away and disposed of. It can harbor a fungal disease that is detrimental to the plants. Because there may be a fungus that has spores that can be easily blown into the surrounding area, this debris should not be put in a compost pile. Bag it and send it to the landfill. This is the time that any camellia that has completed its bloom cycle can be pruned if it seems necessary. They will start putting on new growth following the bloom cycle and that will help to

cover the "just pruned" look if you do it soon.

Bare root roses have been available for a while now. They come to us in bundles of five and have already been trimmed. Many gardening books will tell you that roses should be trimmed while they are dormant in the winter. That is the general rule that is followed, but not necessarily the one to be followed in our area. We have much milder winters than much of the country does, and roses don't necessarily go completely dormant here, except up in our higher mountains. In our area, trimming them is more apt to cause them to start leafing out wherever they've been trimmed making any new tender growth susceptible to damage on our cold, frosty nights which are mild by comparison to the extremes of the really cold areas. Just wait a bit longer into February and save the roses from having to repeat their welcome to spring.

We have lists at the nursery of what is available in bareroot fruit trees as well as other things like berries, artichokes, rhubarb, plus blueberries, figs, and pomegranates in containers. Pick one up if you are interested in pre-planning, and remember that your best selection is early in the season. We wish everyone a Happy New Year.

Almond Blossom Time

The Yuba Sutter Basin is blessed with many attributes that world travelers would love to enjoy. Our cultural diversity includes a rich variety generating a special strength. Our winter flocks of birds can dim the sun. Our rich soils are composed of ingredients over the centuries of sedimentary evolution allowing us to grow a wide spectrum of crops. Our water supplies are the envy of many.

As I have previously stated, "Man without tools is just an animal". The tool that has had a major impact is the tractor. The tractor moved us from the small farm to being a world class food producer.

One such tractor is this 1947 John Deere AO which was owned by the McPherrin family of Sutter.



The AO was purchased by an elder of the family then passed to Vern and onto Darwin and Robert. Hardy McFarland of Sutter purchased the John
Deere from Robert and
did much of the mechanical restoration. I bought
the tractor from Hardy

and completed the restoration. The finished unit was displayed at a Colusa Farm Show.

Marlene Mc Pherrin,

the daughter of Robert, worked at Brittan School in Sutter. The AO spent much of its working life pulling fruit sleds, discing. ridging, and pumping water in an orchard where the present Sutter High is and across the street in the block where the present swimming pools exists.

This John Deere was finished and moved to the warehouse on August 28, 1947 and shipped on September 5. It was originally meant to be exported, but was rerouted to Marysville Truck and Tractor. It came with the all fuel engine which had the ability to run on gasoline or after a warm up time could be run on distillate(a kerosene like fuel). It was an issue that was a base unit without the fancy fenders or electrical. Starting the engine was by hand spinning the external flywheel which was common in this time frame.

The AO was one of fourteen varieties of the John Deere A series. The AO was introduced in 1935. The AOS (streamlined) was manufactured from 1936 to 1941. The AO Unstyled was again introduced in 1941 to 1949 and the styled version ended the run of the AO in 1953. Average original sales price was in the

\$2,000 range depending on options. The kerosene version produced 18.7 hp at the drawbar and 24.7 at the belt. The gasoline version produced 34.9 hp at the drawbar and 39.1 at the belt. The AR(regular) had a single brake and the AO had a brake for each rear wheel allowing for sharper turns in the orchard rows. The AO was about 800 pounds heavier that the standard A. The exhaust came out the side of the engine and the intake air came through mushroom shaped tops. Operator seating was moved back and down. Controls for operation were modified. The full curve fenders reduced the likelihood of damaging the limbs. There is not a whole lot of room in the operator platform but it was considered as a trend setter for the time. Can't wait to fire up the old Johnny Poppe, get on a back road, and tour the almond orchards near the Sutter Buttes. That time is

Another special event that is growing in quality is the Historic Faire in downtown Marysville which will be held on February 11, 2017. The parade will include a number of Vintage Tractors. These old-timers will be parked on 4th Street after the parade and open to close up viewing for the public. The owners will be available for questions. The famous Pink Ford dedicated to Breast Cancer funding, the Purple Farmall dedicated to ending Domestic Violence will be joined by a new member of community service, a Blue Allis Chalmers dedicated to reducing Autism. This display doesn't exist anywhere else. Weaving in and out of the gathering will be a Rumley Oil Pull booming it's way at a slow speed, a sound the crowd will never forget and likely never see.
