## First Annual Ceremony Remembering Pearl Harbor "Never Forget"

Marysville, Ca.

On December 7, 2016 Veterans of Foreign Wars, Post 948 held a ceremony to remember the lives lost and the survivors of the sneak attack on Pearl Harbor. The 75th anniversary of the attack is a "date that will live in infamy", said President Franklin Roosevelt. The President further charged the people of the United States to "Never Forget."

VFW Post 948 Commander, Ray Bull, lead the Ceremony, which may be the first for the City of Marysville. Commander Bull said," This is not a pleasant anniversary but necessary that

we remember the survivors as well as those who made the ultimate sacrifice. It is necessary that these memories not fade from our youth of today."

The Commander referenced the similarities of the attack on Pearl Harbor and the 911 attack. Did we forget? Commander Bull also said he believed that we had lost our last local Pearl Harbor Survivor in Navy Lt. Commander, Joe Langdell who died on February 4, 2015 at the age of 100. Lt. Commander Langdell was the oldest living survivor of the USS Arizona. There were a total of 334 survivors from the Arizona, there are 8 left.

Navy Veteran Brock Bowen rang the bell 21 times signifying a 21 Gun Salute.

The ceremony was closed with a prayer.

## The Gore Effect

A sequel to Al Gore's 'Inconvenient Truth' will launch the 2017 Sundance Film Festival to give the global warming hoax new life. Hollywood is good at refreshing a story line that turned a profit.

Hoax plus cult is probably a better description of the movement. Some scientists and environmentalists cook the calculations to get a grant or regulation passed, but global warming is a religion for film folks and liberals.

Al Gore, since losing the 2000 race for president to George W. Bush, has put his mouth where his money is invested. Gore's government connections have funneled hundreds of millions of your dollars to green energy companies where he serves on the board or owns stock. Global warming has been good to Gore.

President Obama and Governor Jerry Brown claim that our inability to control the climate is the greatest threat of our time. Public educators and the media were easy converts to this teaching even when confronted with its absurdity. They're a cheap date for liberals since they still claim with a straight face that humans came from monkeys.

Students, k through college, must kneel at the climate altar or be scoffed at, mocked and marked down. Nay-saying scientists lose their grants, promotions and sometimes their careers.

Devil's Garden mustang adoptions began last week. One was a blue roan yearling gelding adopted by Tessa Glaze of Davis Creek, CA. She named him Tuffy.

For a mustang that had been living wild a short time ago, he loaded, traveled in the trailer for two hours, unloaded and settled into his new home with surprising calm. If Tuffy's temperament is typical, these horses promise to be very tractable.

More than 200 horses were gathered from Devil's Garden in the Modoc National Forest in September. Mares over the age of six that were gathered will be inoculated with the fertility drug PZP and returned to the territory.

There are currently more than 100 Devil's Garden mares, fillies and geldings available for adoption at the BLM Litchfield Corrals. The breakdown is GELDINGS: 9 weanlings; 13 yearlings; three 3 year olds; 8 four year olds and 1 five year old. FILLIES & MARES: 13 weanlings; 15 yearlings; 18 two year olds; 11 three year olds; 13 four year olds and 6 five year olds. Several more weanling to two year old stud colts are scheduled to be gelded this week and will be available for adoption around Dec. 20.

The colors are primar-



ily roan, bay and black with some brown, sorrel, chestnut and grays. Some have blue eyes. The average height is 14 to 14.2 hands. These horses descended mostly from ranch horses and there is some draft horse influence as well.

Due to budget constraints and the cost of holding these horses long term, they will only be available for adoption until June 2017. At that time any unadopted horses will be returned to the Devil's Garden Plateau Wild Horse Territory.

Green Pope AI also declared that polar bears were dying off. It makes sense. No ice. No sex. No little bears.



The current storm passing through our area



## **DUI/Drivers License Checkpoint Planned**

Yuba City, Ca.

The Yuba City Police Department Traffic Unit will be conducting a DUI/ Drivers License Checkpoint on Friday, December 16, 2016 in the central part of the city between 7:00 p.m. and 1:00 a.m.

The deterrent effect of DUI checkpoints is a proven resource in reducing the number of persons killed and injured in alcohol or drug involved crashes. Research shows that crashes involving an impaired driver can be reduced by up to 20 percent when well-publicized DUI checkpoints and proactive DUI patrols are conducted routinely. DUI Checkpoints are placed in locations based on collision statistics and frequency of DUI arrests, affording the greatest opportunity for achieving drunk and drugged driving deterrence. Locations are chosen with safety considerations for the officers and the public.

In California, this deadly crime led to 867 deaths and over 23,000 serious injuries in 2013 because someone failed to designate a sober driver. Nationally, the latest

data shows over 10,000 were killed by an impaired driver. Over the course of the past three years Yuba City Police Officers have investigated 47 DUI collisions which have resulted in over 80 injuries.

Officers will be looking for signs of alcohol and/or drug impairment with officers checking drivers for proper licensing delaying motorists only momentarily. When possible, specially trained officers will be available to evaluate those suspected of drugimpaired driving, which now accounts for a growing number of impaired driving crashes.

Recent statistics reveal that 30 percent of drivers in fatal crashes had one or more drugs in their systems. A study of active drivers showed more tested positive for drugs that may impair driving (14 percent) than did for alcohol (7.3 percent). Of the drugs, marijuana was most prevalent, at 7.4 percent, slightly more than alcohol. Everyone should be mindful that if you're taking medication - whether prescription or over-thecounter - drinking even small amounts of alcohol can greatly intensify the impairment affects.

Law Enforcement emphasizes the preventable nature of drunk driving reminding everyone that all it takes is a little planning ahead. Designate a sober driver or call a cab. But whatever you do, don't drink and drive. The California Office of Traffic Safety DDVIP (Designated Driver VIP) mobile app is now available for free download on iOS and Android devices. Launched last year, the new DDVIP app offers enhanced features, allowing users to "Map a Spot" with their current location to find DDVIP partnering establishments in their area or a "List of Spots" to search all participating bars and restaurants throughout California. Users will be offered free incentives at each bar to celebrate their life saving role. They can stay up-to-date with the latest from DDVIP and see what other users are saying via its social tab. Also through the app, for those who want to imbibe but also make it a point to plan ahead, users can easily order a sober ride from Uber, Lyft or Curb – all from one screen.

Drivers caught driving impaired can expect the impact of a DUI arrest to include jail time, fines, fees, DUI classes, other expenses that can exceed \$10,000 not to mention the embarrassment when friends and family find out.

Funding for this checkpoint is provided to the Yuba City Police Department by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration, reminding everyone to 'Report Drunk Drivers - Call 9-1-1'.

The news that the Empire of the Rising Sun had launched a stealthy, devastating attack on our naval base at Pearl Harbor first stunned, then distressed, and finally angered our citizens. Less

#### than four years later, American military and naval forces were accepting the unconditional surrender of the Japanese Empire aboard the battleship U.S.S. Missouri in Tokyo Bay.

**Remembering Pearl Harbor**

President Roosevelt's carefully worded opening was a cautionary warning to future generations of Americans. He knew that we always must remain vigilant to threats to our liberty and sovereignty, many of which may strike us unexpectedly. On September 11, 2001, we lived through a similar stealth attack from foreign terrorists because we had forgotten the ongoing relevance of that warning.

#### Farm Bureau Looks Toward Change

Pointing to the sacrifices made by previous generations to provide opportunity to family farmers and ranchers, California Farm Bureau Federation President Paul Wenger said farmers have the ability to change their future, if they commit the time and resources to the effort. Wenger spoke during the opening session of the 98th CFBF Annual Meeting in Monterey.

"Those people who came before us gave us this opportunity, and the big question is whether we are going to answer that bell," Wenger said, praising earlier generations who had the foresight to build reservoirs, roads and other infrastructure that allowed California to become the greatest agricultural region in the world. Now, he said, the struggle has focused on defending the resources farmers and ranchers need to maintain and enhance production of food and farm products. In order to be successful, Wenger said, farmers and ranchers must work together across commodities and across regions.

"We have to pool our resources, so we have the political might to change the future for this state," he said, adding that Farm Bureau would continue to work closely with other agricultural organizations and partners.

In discussing the election of Donald Trump as president and the implications of the incoming administration, Wenger acknowledged concerns about trade and immigration policy. But he said the new administration would likely focus on easing the impact of federal regulation on farms and other businesses.

"We can look to the federal level to help us, but folks, all politics is local. We have to be involved, we have to be engaged and we have to invest," he said.

At the end of his speech, Wenger returned to the theme of sacrifices made by previous generations of California farmers and ranchers to allow current generations to live a better life.

"What do we give back to make sure our children and grandchildren have that same opportunity?" he asked. "The baton is in our hands. What are we going to do with it?"

"We are launching an educational campaign to highlight the scandalous irony at the heart of the federal government's draconian water cutbacks in Central and Southern California," said Tony Francois, a PLF senior staff attorney. "In a so-called protection policy for two selected species -- a policy that may not even be helping them -- federal officials are causing outright harm for other ESA-listed animals by withholding water from their habitat, including the region's farms and open spaces. "Instead of developing a well-rounded, holistic approach to species regulation, federal officials are essentially saying, 'No water for you!' to a host of species that they are supposed to be protecting," Francois continued. "This is not just irresponsible, it is a violation of the regulators' duties to safeguard all endangered and threatened wildlife from further degradation. "In fact, we believe this myopic approach to smelt and salmon regulation is vulnerable to a legal challenge, precisely because of the government's failure to consider the interests of other protected species," said Francois. "We look forward to hearing from wildlife lovers and owners of habitat areas who share these concerns and would consider the possibility of becoming involved."

With the presidential elections now over and at least a partial ending to the circus of the absurd that it was, the economic question now on everyone's mind is what will happen to the stock market in the coming days, weeks and months ahead.

The markets illustrated their continuing volatility with a wild pre-market indicator on election night showing a drastic start to the next day's markets as Trump moved ahead during the vote counting only to turn back positive once it was confirmed he had actually won. Trump's talk of an amnesty period for repatriation of corporate overseas assets boosted a few asset classes but technology assets strangely did not exhibit the strength other areas saw.

The markets are likely to do some more digesting of what this all means for at least a few more weeks as upcoming statements from Trump will gradually give investors a window into just exactly what his plans are as far as the economy is concerned.

Tightly tethered to monetary policy as the market has been in the last decade or so since the start of the housing blow up and banking crisis, what the Fed does under a Trump administration will likely cause continuing volatility in the markets as the Trump show continues to unfold.

Since markets never do what anyone expects them to do, trading this market is likely to be next to impossible to accomplish with any sort of certainty at least for a while.

It is probably prudent for the average investor to sit tight and let the markets settle down a bit before committing large sums of money in any one direction or in any one area.



## **Safely Heating Homes** as Temperatures Dip

San Francisco, Ca. With temperatures expected to drop in Northern and Central California this week, Pacific Gas and Electric Company (PG&E) urges customers to be cautious when heating their homes.

Electric heating devices, such as space heaters, are a home fire hazard when not properly used or monitored. Fuel-burning appliances, such as gas furnaces, stoves and water heaters, can increase the risk of carbon monoxide, a toxic gas, when they are not working properly.

"We want our customers to be warm this winter, but most importantly we want them to be safe. Space heaters should only be used as a supplemental source of heat. They are not intended to replace the home's central heating system and, when not used properly, can create serious safety hazards," said Jake Zigelman, Director of Local Customer Experience at PG&E.

According to the National Fire Protection Association, heating equipment is the second

leading cause of home fires in the United States and from 2009 to 2013. accounted for 56,000 structure fires per year. Nearly half of these fires occur from December through February. The leading contributing factor to space heater fires is heating equipment too close to objects that can burn, such as furniture, clothing, mattresses or bedding.

PG&E urges customers to focus on safety heating their homes as temperatures dip and offers the following tips:

• Place space heaters on level, hard, nonflammable surfaces, not on rugs or carpets.

• Don't put objects on space heaters or use them to dry clothes or shoes.

 Turn off space heaters when leaving the room or going to sleep.

• Keep all flammable materials at least three feet away from heating sources and supervise children when a space heater or fireplace is being used.

 Never use cooking devices such as ovens or stoves for home heating

purposes.

 Install carbon monoxide detectors to warn you if concentration levels are high. As of 2011, all California single-family homes are required to have carbon monoxide detectors. Make sure they are installed near sleeping areas and replace the batteries at least twice a year.

 When using the fireplace to stay warm, make sure the flue is open so that the byproducts of combustion can vent safely through the chimney.

•Never use products inside the home that generate dangerous levels of carbon monoxide, such as generators, barbecues, propane heaters and charcoal.

If customers suspect there is a problem with a natural gas appliance inside their home, they should call PG&E at 1-800-743-5000. A gas service representative will be dispatched to do a thorough inspection. If you detect carbon monoxide in your home, you should get out immediately and call 911.

#### Farming still a family way of life

Farming remains overwhelmingly a family affair, according to a new report from the U.S. Department of Agriculture. Ninetynine percent of U.S. farms today are family-owned,

accounting for 89 percent of farm production. Small farms make up 90 percent of total farms, though large-scale family farms hold the largest share of overall production. Only 3 percent of large farms are nonfamily





corporations.

#### New navel orange offers early harvest

A new navel orange variety being planted in California may give citrus fans something to celebrate. Growers say the early-maturing M-7 navel variety offers color, juiciness and flavor that outperforms other early varieties. The M-7 could allow California growers to compete better for early-season markets. The M-7 navel orange was developed in Australia, with commercial plantings just beginning in California.

## **Sutter County Makes It Easier To Search Ordinances Online**

Sutter County The Counsel's Office announced Wednesday completion of a project to make it easier to search an online database of the County's local ordinances.

County ordinances are local laws that are adopted and enforced within a local government's jurisdiction. These laws are in addition to federal and state laws. The California Legislature provided for the codification of county ordinances in Sections 50022.1 - 50022.10 of the California Government Code.

Sutter County's ordinance code had been online before, but there was no way to conduct a search for topics through keywords. Finding what you were looking for

proved cumbersome.

The update allows users of the website to find all references to a word or topic in the County's Ordinance Code with either a simple search, or with more advanced phrase, wildcard, Boolean, and proximity searching techniques. The simple search feature will give you the results you're looking for in most instances — just like a Google search.

The online version of the Sutter County Code of Ordinances is revised as updates are available. While every attempt is made to keep this online version current, it should be used for reference only.

Sutter County's online version of the County Code of Ordinances is

hosted on the Municode website, and can be accessed through the County's website at www.suttercounty.org, at the bottom of the Sutter County Board of Supervisors page. The direct link is here: https://www. co.sutter.ca.us/doc/government/bos/ordinance
