## Pearl Harbor 75th Anniversary

December 7, 1941 was the day that the United States of America was thrust into World War II, forever changing our nation and the world. December 7, 2016 will mark the 75th anniversary of the attack on Pearl Harbor and the "date which would live in infamy." With the charge to "never forget" by President Franklin Roosevelt.

Patriot Gary Sinise will serve as parade Grand Marshal in saluting our Pearl Harbor Survivors. Over 4,000 parade participants, including marching bands, junior and active duty military units along with cultural and civic organizations will parade down Kalakaua Avenue, Waikiki, Hawaii, in front of nearly one hundred thousand appreciative spectators. This parade takes place annually and is the official parade of the Pearl Harbor commemoration.



This year's event will feature a 40' replica of the USS Arizona Battleship. It is the goal of the committee to introduce a new battleship each year until all eight battleships moored at Pearl Harbor during the attack are represented in the parade. This event is unique, as it provides an important element of reconciliation. The theme is to "remember past, honoring those whose service and sacrifice preserve our freedom, while celebrating the future and that once bitter enemies can become friends and allies".

## Becerra the Blowhard

Rep. Xavier Becerra (D-CA), the nominee to be California's next Attorney General (AG), issued a brash challenge of "Come at Us!" to President-elect Donald Trump over Trump's promise to enforce federal immigration law.

Sounds more like a gangbanger or third world dictator than the state's highest law enforcement official. A threat like this directed to terrorists and the like is understandable. But, calling out the next president who is pledging to enforce the law is amazing.

Becerra isn't speaking for all Californians, particularly the millions who voted for Trump including the majorities in 25 of 58 counties.

Nineteen of 21 counties with a Jefferson State declaration voted for Trump. Becerra, like most of the legislature ignores the rural north. However, when liberals don't get their way they want to take it to the streets, break windows and lift a pair of athletic shoes, liquor, or flat screen TV.

Becerra and his Sacramento homeboys gloat over their sanctuary cities that violate federal law by protecting illegal aliens and ignoring federal immigration detainees. Violent felons and repeat deportees remain free or are released from jail to assault the state's citizens. Illegals are also tapping free medical, education, food, welfare and subsidized housing, costing taxpayers hundreds of millions of dollars annually.

Becerra is proud of what he calls the state's "forward leaning" extremist response to the global warming hoax. He embraces Governor Brown's delusion that it is the greatest threat we face. "Forward leaning" means mandating coop sizes for chickens and now monitoring cow farts.

California conservatives and others that voted for Trump feel like strangers in a strange land. Becerra and his cronies obey the law when it suits them. They employ a heads we win, tails you lose philosophy.

Becerra's predecessor, current AG Kamala Harris, after learning that Planned Parenthood (PP) was selling body parts from aborted babies, is working to prosecute the group that discovered the atrocities, not PP. What kind of people act this way? Hitler, yes. Idi Amin, yes. But, the Attorney General of California?

Becerra and the CalExit movement feel like they are being held hostage by Trump who hasn't even taken office. Of course, CalExit folks want a new country not a new state.

Some feel that a state rebellion against federal law on immigration and sanctuary cities could result in a withholding of federal funding to various jurisdictions in the state of California. Would that lead to a secession move among state legislators?

It happened before. States seceded from the Union to create the Confederacy leading to the Civil War. When Virginia seceded and joined the Confederacy in 1861, what we now know as West Virginia chose to remain with the Union.

The two regions had existed as a single state in name, but not in geography, economy, climate, descent of its residents or way of life. It is similar to the 21 State of Jefferson counties versus the 37 remaining California counties.

The slave-holding plantation owners in the eastern part of Virginia dominated the state's economy and politics, leaving the self-sufficient farmers who lived in the distant western counties, where slavery was far less prevalent, feeling politically ignored and powerless.

The Civil War ended the secession move but created West Virginia, the only new state emerging out of the conflict.

Don't get CalExit confused with State of Jefferson advocates who respect others but just want fair representation via a 51st State. Jefferson people like America even when their choice for president doesn't prevail.

State of Jefferson residents have real differences from their southern neighbors. Becerra and his socialist friends couldn't care less about people in the north who want their borders secured and illegals arrested and removed.

Northerners want voters carded. They demand their rights to guns and ammunition back. Education should be offered in English-only and directed by local people, not from Sacramento or Washington D.C.

Businesses want their freedom from government harassment. Residents want to benefit from all their natural resources – timber, mining, water, oil / gas and fisheries.

Becerra and CalExit are troubled by Trump. Northerners see Becerra's agenda and the spirit of CalExit as the real trouble.

## Food and Farm News

**Rural residents oppose river proposal**  
Farmers and rural residents told state water officials Tuesday they're concerned about a proposal to dedicate more water to fishery flows in the lower San Joaquin River system. The State Water Resources Control Board held the first of five hearings in Sacramento on its plan to reserve more water for fish in the Stanislaus, Tuolumne and Merced rivers. Opponents urged the board to seek alternative solutions

to help fish. **Desert vegetable harvest starts early**  
Winter vegetable harvest has started early in the Imperial Valley. Farmers say warm autumn weather prompted lettuce, cauliflower, cabbage and other vegetable crops to be ready for harvest more than a week earlier than usual. Demand for winter vegetables can be affected by weather in Eastern states, farmers say, because a warm winter would en-

courage Eastern residents to eat more salads. **Pest fighters urge caution during holidays**  
A few simple steps when traveling or giving gifts this holiday season can prevent spread of invasive pests, according to the U.S. Department of Agriculture. USDA says pests can hitchhike on plants, produce or food brought in as gifts, or hide in firewood. It recommends buying plants, trees and wreaths from trusted sources that follow quarantine rules. The agency also cautions not to accept seeds, trees or plants sent from foreign countries.

**UC to revive study of tea production**  
A long-dormant test could become the foundation of commercial tea production in California. The University of California planted tea at its San Joaquin Valley research center in the 1960s, but ended the study in 1981. Some of the tea plants remain as ornamental shrubs at the center. Now, UC researchers say they want to use 21st century techniques to study the plants, to look again at whether tea can be grown commercially in the state.

# FISHIN' TALK

We hear from Eagle Lake near Susanville. The trout bite is still on the slow side, but the fish that have been caught are a good size, with some in the three to four pound range. Experts on this natural lake are dumbfounded in regard to why the fish are not as active this time of year. The tulle chub, which is a major food for the eagle lake trout species appear to be abundant and have reached larger sizes. This is more than likely due to the fish living for over 30 years of age. Let us face this fact...a fish that lives that long is bound to get bigger, provided the trout, who make this chub a mainstay in their diet, are in sufficient numbers to gobble up the little guys. Our report of this lake shows the fish are hanging out in shallower water and staying close to the tulle banks. In addition, we are still told the fishing is best at the north end of the lake in 15 feet of water.

We hear from our weather source. He advises to expect colder temperatures in the coming week, more overcast and more clouds than sunshine. He also told us to expect freezing temperatures in the valley before Christmas Day with occasional cold rain which might just drop some snow on top of south butte in the Sutter Buttes. I used to be a diehard stream guy, who excelled in an attempt to conquer the elusive trout, with it be the rainbow, the brown or a member of the char family of fish...the brook trout. Nowadays, I am content with reservoir and lake fishing for those fish, which by the way are not like they used to be. Back in the old days.... oh, my...when was that? How about the seventies or the eighties for the earliest I can recall.then let us go back to the forties and fifties. O.K. now that I have your attention...

catching trout back then was not only a blessing from the Lord, but a blessing in disguise....since those fish were wild and reproduced by their ability to be cautious and careful. It was not a big deal to fish the headwaters of the feather and Yuba rivers and catch and release (with crimped hooks) over a hundred trout, some of which were rainbows, others which were browns and of course some brook trout. I know those who are reading this column are asking..." A hundred trout...how long did it take?" Well, folks, about three hours on a stream. In fact, on the headwaters of

the north fork of the feather river, after hiking a couple of miles upstream, I caught one hundred and twenty nine trout, from first light to nine thirty in the morning, of which I kept nine, which were injured, for breakfast, along with eggs, bacon and fried potatoes cooked on my old Coleman gas stove. My, what a wonderful meal and what a wonderful I memory. Boots fishing tip for the week: "Remember the importance of conservation....release any fish you cannot eat or smoke... in this way we will retain some of the heritage that is left for our children and their children to come."

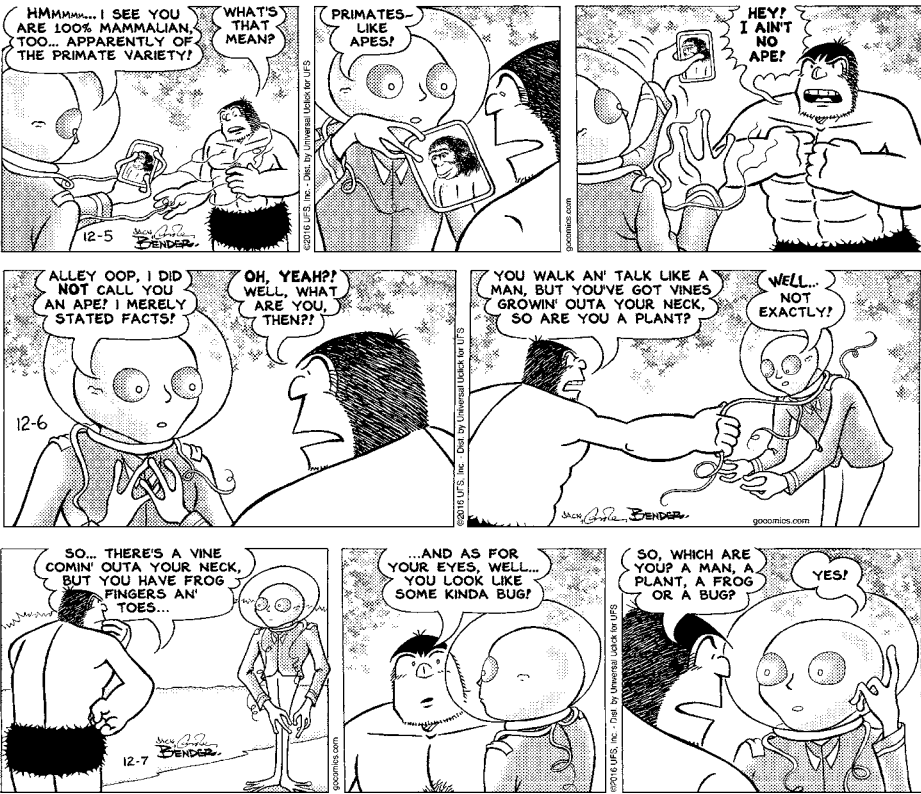

# Celebration of First 100 Days

Sutter County Superintendent of Schools Dr. Baljinder Dhillon

has met with principals and superintendents of all Sutter County schools and charter schools to assess the state of the county.

She remains dedicated to finding new ways to fund programs that benefit teachers, staff and students, including writing a proposal to fund the California Classified School Employee Teacher Credentialing Grant, and partnering with the four county offices for the California Collaborative for Educational Excellence Early Adopter Grant. And her financial acumen has led her to authorize cost-saving measures for the Sutter County Superintendent of Schools Office by becoming more energy efficient.

School safety is one of Dr. Dhillon's chief priorities. In her first 100 days, she immediately began working with District Attorney Amanda Hopper to facilitate active shooter and human trafficking informational training for staff across the school district.

And with education at the root of her mission, she made a presentation to Soroptimist International of Marysville-Yuba City about the role of the county office and her goals as Sutter County Superintendent of Schools. She aspires to meet with any other groups who are interested in learning more about the role of SCSOS and opportunities for students.

Dr. Dhillon's career in education began as a fifth-grade teacher at Tierra Buena Elementary School in the Yuba City Unified School District. After she earned her master's degree from California State University, Sacramento, she moved into administration, serving as assistant principal at Tierra Buena and Barry elementary schools from 1992-2006, and later becoming principal at Rio Del Oro Elementary in the Plumas Lake Elementary School District. She earned her doctorate in educational leadership and administration from CSU, Sacramento in 2013 and left Yuba-Sutter to serve as superintendent of the Cascade Union Elementary School District.

Dr. Dhillon was appointed Sutter County Superintendent of Schools in May as a replacement for retiring Superintendent Bill Cornelius. She will serve the remaining 2 ½ years of his term and is already eager to run for election in 2018.

"Returning to serve as Superintendent of Schools for Sutter County has been a true homecoming," Dr. Dhillon said. "Our area schools and youth are where my heart is and I'm eager to continue to improve the quality of education for our community's future."

The Sutter County Superintendent of Schools Office is dedicated to delivering successful solutions to the challenges of its local and regional partners by providing innovative support and services to promote quality education and self-sufficiency. SCSOS provides these services to more than 20,000 public school students located within 12 school districts and four charter schools, including direct service instructional programs to nearly 9,500 students annually through infant programs, special education, vocational and occupational programs, outdoor science and alternative education.

# Big Red

One of the many ways Vintage Tractor Fans have fun is to enter parades and show them to the public. Another great joy is to have someone invite us to see "Grandpa's Tractor". When the barn door is opened dirt, dust, pallets, old tires, and maybe rusted fence wire are hiding the "Diamond in the Rust". That jewel will quickly come into focus and lots of teeth can now be seen and the eyes light up as spotlights.

Such is the saga of Big Red.

Big Red worked for years on the Clark Ranch in Meridian. He plowed, disked, and sprayed many miles of tomatoes and beans. After years of hard work, the cancer of a cracked block occurred and Red was retired to the barn to convalesce. Red rested there for 20 years awaiting surgery so he could resume working. Eventually, the farm came up for sale.

When Jack Nail of Meridian opened the door-he smiled, his heart rate went up, and the blood began to race. Like a new born, Jack immediately bonded with Big Red. Hey Red, Dr. Jack has arrived!

Jack started his restoration in February of 2013. A new engine, lots of new parts, imagination, hours of work, and a bushel basket of money-Big Red was reborn in April of 2014.

Dr. Jack created dual wheels, installed a wide seat, and added some bling. Now, he and his lovely wife Veronica can be seen in

parades, going on a drive, playing games, square dancing, or being decor at a church fund raising.

Big Red now sits in the garage with the car outside and is a member of the family. Sort of like a stray cat that adopts you, moves in, and takes over.

The Farmall M began life in 1939 and was last manufactured in Rockville, Illinois in 1952 and continued in Doncaster England (BM) and Geelong Australia (AM) to 1954. 270,140 were built at Farmall Tractor Works and some suggest 290,000 overall being manufactured. The base M was evolved to the MD (diesel) in 1941. Other versions included the MTA (torque amplifier), MV (hi crop vegetable), MDV, MTAV, and the Super Series with greater horsepower and improved hydraulics. Other options included front ends of choice. The standard had a tricycle two wheels, the narrow (single wheel), and the wide front. Eventually, the M was renamed and improved to become the 400. The base M was an evolution on the W6 which was a four wheel squat utility design and there was also an I 6 industrial as part of the line. In 1940 the M could be purchased for \$1,100 and the MD for \$1,700. By 1952 the price was about \$2,400, Weight ranged from 4,858 pounds to 6,770 pounds.

The M and the H used the same frame so that implements were interchangeable. The C 248 en-

gine claimed 25hp at the drawbar and 33 at the pto/belt. It tested 33.1 at the drawbar and 36.03 at the pto/belt. The M could pull 3 plow blades easily and in some soils 4. The M was a major seller for IH and many are still in regular use.

Collectors who include Ms need to have at least a 3/4 ton truck and a substantial trailer. While the M isn't for all collectors, it is still possible to love them - Right Jack!

There are parades and then there are parades. I was able to talk drivers from Bakersfield to Red Bluff into the 2016 Marysville Veterans Day Parade. We presented 38 Vintage Tractors. The parade was well run and parking was made easy thanks to Superior Radiator. A big warm crowd was present. The loop is easy to drive and provides multiple announcers. Griggs of KKCY does a great job.

We have a very diverse culture and many active and retired service persons. To me and to many of the "Tractorologists" the highlight of the parade was the crowd. I had several comments about how friendly and enthusiastic the spectators were. One community service member was taken aback by so many thank yous and smiles as he gave out candy to the youngsters.

Thank you crowd for being so gracious and let us share our old tractors. I'll bet they smiled too!

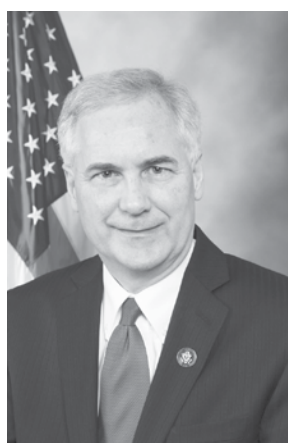

## Paying for Infrastructure Without Soaking the Taxpayer Congressman McClintock Remarks on House Floor



President-elect Trump has many difficult fiscal tasks ahead – one of which is to promote long-overdue infrastructure construction at a time when the national debt exceeds our entire economy and interest costs alone are eating us alive.

Some have said that a rebounding economy resulting from tax reform will pay for it. That may be, but it's not guaranteed; it cannot be accurately forecast; and we'll need any new revenues to beef up our defenses and reduce our deficit – two other critical objectives of the new administration.

Others have proposed tax credits to leverage private capital for infrastructure improvements. But tax credits reduce revenue and widen the deficit. Worse, such public-private partnerships have also proven a fertile breeding ground for corruption, crony-capitalism, waste and fraud.

And as we learned during the Obama stimulus fiasco, massive government spending might stimulate government, but it does little to stimulate the economy when it is squandered for boondoggles like subsidizing Solyndra and paying cash for clunkers.

So how do we avoid the mistakes of the past, control the deficit, protect taxpayers and yet add a trillion dollars of new infrastructure in a way that helps the economy and not merely lines the pockets of politically well-connected interests?

FIRST: Get government out of the way! Stop obstructing major infrastructure projects like the Keystone Pipeline. Keystone and many other projects like it across the country already have private capital ready to finance them. Keystone by itself would unleash an estimated \$8 billion of privately financed infrastructure construction and would deliver a half million barrels a day of Canadian crude oil entering U.S. markets.

In my district alone, one abusive official at the

Sacramento office of the Army Corps of Engineers single-handedly blocked tens of millions of dollars of critical infrastructure construction desperately sought by local governments in the region. Multiply that across the country, and you can see how much infrastructure is ALREADY financed but cannot move forward because of federal obstructionism.

SECOND: Streamline radical regulations that have made many infrastructure projects cost-prohibitive.

In my district, the little town of Foresthill gets its water from the Sugar Pine Reservoir, formed by a dam that has an 18-foot spillway, but no spillway gate. The town is trying to increase the reservoir's capacity by adding the missing gate. The gate will cost \$2 million. But environmental studies, environmental mitigation and U.S. Forest Service Fees have inflated that cost to at least \$11 million – so this project has stalled. Multi-billion dollar expansion of Shasta Dam is stalled for the same reason. Once again, multiply this across the rest of the country.

THIRD: Use revenue bonds to finance capital-intensive projects like dams and bridges. California built its iconic Golden Gate and Bay Bridges with loans from private investors – repaid by tolls charged only to the users of the bridges. The taxpayers were never on the hook for a dime, and the loans were paid back ahead of schedule.

The famous California Water Project constructed 21 dams and more than 700 miles of canals. The revenue bonds and

self-liquidating general obligation bonds that financed it were paid back not by general taxpayers, but by the users of the water and power.

FOURTH: Restore the integrity of our highway trust fund. We built the modern Interstate system with the federal excise tax paid only by highway users at the gas pump. The more you drove, the more you paid for the roads you were using. But over the decades, more and more of these funds were bled away to subsidize mass transit and other purposes unrelated to highway construction. Restoring highway taxes for highways would go a long way toward addressing the maintenance and construction backlog.

FIFTH: Repeal the outdated Davis-Bacon Act that requires federal projects to pay grossly inflated wages. Think tanks like the Heritage Foundation and the Competitive Enterprise Institute estimate that Davis-Bacon alone inflates total construction costs by roughly 10 percent. Just repealing this act alone would add one new project for every ten existing ones at no additional cost.

These are just a few ways that massive infrastructure projects can be financed at zero cost to general taxpayers. And because these reforms are actually directed at projects for which there is a demonstrated economic need, political favoritism and corruption inherent in government-directed programs can be greatly reduced.

Mr. Speaker, freedom works. And it is time we put it – and America – back to work.

- We have one existing board member who is a worthless bully that is ignorant and vindictive;
- We have a bankruptcy in the making after years of waste and abuse;
- We have to pay nearly \$700,000/year for salaries and benefits for only eight employees;
- We have old piping, unmanaged open ditches, a dated treatment plant, aluminum toxicity issues, problematic fire hydrants and too small of a customer base to cover the necessary costs to take care of all of this aging

infrastructure;

- We have arranged to sell thousands of acre-feet of water to valley towns and SoCal before serving customers first;
- We have over 1,500 taxpayers, many who unknowingly pay taxes to the district, but don't receive a drop of water;
- We have a county supervisor who does nothing to help the situation except seeding his people on the board who will help him gain control of community properties and water;
- We have an apathetic, fearful, uninformed and divided community, some voting in support of this entire mess and the rate hike that will eventually hit them just to support more messiness.

It looks like we're not going to be better off after all. Sure, people will cry, "Give the new board time to tackle the problems," but the problems are perhaps too great and the team too polluted. We can only hope that water district soon declares bankruptcy and is taken over by another agency. It's the best option for everyone.

Using a funnel, pour your used oil into the original container or re-usable clean plastic container with a tight-fitting screw-top lid. Do not contaminate used motor oil with other hazardous fluids. Place your used oil filters in a sealed, leak-proof plastic bag.

### RECYCLE IT...

Take your used oil and filter to the nearest used oil recycling center. Call first for hours and quantities accepted. Recycling used oil and oil filters is FREE.

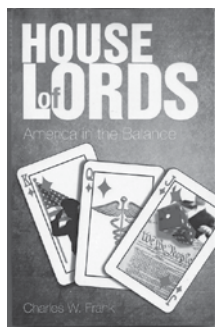

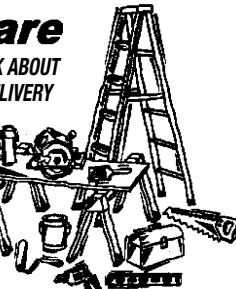

## Jewish Settlers 1849-1880

During the past two months, an overview of Jewish pioneers who settled in our area has included a brief history of their arrival, their countries of origin as well as names of prominent individuals who remained for many years, beginning with the Gold Rush era. Unfortunately, major tragedies also took place during the time period from 1849-1880.

### A DROWNING

On June 3, 1850, the Placer Times newspaper reported that during a downward trip of the steamboat Gov. Dana, Harris Goldstein, a Marysville merchant, fell overboard in an attempt to get a bucket of water from the Feather River, about four miles below Marysville.

According to newspaper accounts, "he swam well at first, and all aboard, including his son about 14 years of age, had perfect confidence that he would reach the shore". . . "He was observed to turn on his back, as if to rest himself, and sank to rise no more".

The newspaper also added that "Goldstein had some \$1,600 in (gold)

dust on his person". The Placer Times was reportedly furnished with numerous testimony to Capt. Young's exertion to rescue him. Additional accounts related that "the scene. . . was most distressing". "The agony of his son (Jacob) drew forth many a manly tear of sympathy for the wife (Rosina) and children home in New Orleans".

Goldstein's remains were re-interred in the Jewish Cemetery on J Street in Sacramento.

### MURDERS

Among the Marysville Jewish Cemetery's more dramatic headstones is that of Simon Glucksman, a native of Prussia, who was murdered on August 26, 1859 on the highway between La Porte and St. Louis. He was 24 years of age at the time.

Equally tragic is that of Julius Pier who, on the night of May 1, 1895 was murdered at the rear of his second hand store on C Street and Third. Although Pier's tragedy is after the time period covered, nevertheless; he had been a member of the Marysville Jewish Community and his death

shocked the entire area.

According to newspaper accounts, Pier, a native of Germany, was found gagged and hog-tied, while showing signs of having made a "fight for his life". Police Officer Hugh McCoy discovered a portion of a shirt which was used to throttle Pier to death in a toilet bowl at the rear of the premises. This clue led to the arrest of Stuart A. Green, a young electrician, who, a few days before, had installed an electric bell in the police station. It appears Green was wearing the same shirt at that time, and McCoy remembered its "flashy pattern".

Shortly after, Green confessed and also implicated Marshall J. Miller, his barber accomplice, who owned a shop on Second Street near C. They had planned to rob Pier for his money. It appears Green was well connected in the East. His father came to Marysville and employed counsel who saved him from the gallows, and the jury voted for life imprisonment. Miller was not so lucky and was executed at San Quentin prison on September 28, 1896.

Pier was buried in the Jewish Section of the Marysville Cemetery which was established in 1853 by the Hebrew Benevolent Society.

According to accounts in the 1879 History of Yuba County, this Society was described as a "purely benevolent association. Article two of the Constitution stated . . . "The funds of the society shall be appropriated as follows: relief to the poor, needy, sick and the burial of the dead of the Jewish persuasion in Marysville and vicinity" known as the Jewish Burial Ground near the City Cemetery".

The cemetery was described as one block square surrounded by a high block wall that cost \$1,000. In addition, there was a brick house which was used in connection with the cemetery. At one time, membership in the Hebrew Benevolent Society reached 45. However, by 1879, there were only 22 members with a treasury of \$500.

Among the approximately fifty headstones in the Jewish section is that of Gabriel Katzenstein, a native of France and member of the Marysville Pioneer Society. Established in 1869, the Society was composed of native Californians, foreigners and citizens of the United States resident in California prior to the ninth of September, 1850, making Katzenstein the first Jewish pioneer in Marysville.

This concludes the series about the Jewish settlers in our area during 1849-1880. For those who stopped briefly or those who remained permanently, each, in their own way helped to enrich the histories of Yuba and Sutter Counties.

Born in Childress, Texas, longtime California resident, Sara Sealander earned both Bachelor of Arts and Master of Fine Arts degrees in visual arts from the University of California at San Diego. For many years, Sara was a Professor of Art at Yuba College leading classes in drawing, printmaking and art history.

Sara offered this introduction to the current exhibit saying, "It includes symbolic work from the late 1980s, twenty small pieces done just four years ago in response to a class assignment I had given my advanced students and a dozen botanical drawings created three years ago during a beautiful visit to Hawaii. The newest piece from 2015 was drawn as a gift to celebrate my niece's 30th birthday. I was pleased to see the way the newest and the oldest pieces worked together, and I look forward to continuing to draw with renewed energy in the years to come."

Sara added, "I love to make drawings and prints. I love drawing as much today as I did when I was a small child, and that's saying a lot, since many of my best childhood memories involve hours spent with pencils and pieces of paper. I have spent quite a lot of time in Italy over the years and have had the pleasure of working in the Santa Reparata printmaking studio in Florence," said Sara.

At once profound and also whimsical, the work challenges the observer to look deeper into what may seem familiar and comfortable and to see with a more open mind.

Longtime friend and admirer, Julie Kennard, said, "I was always struck by the beauty and detail in Sara's art. We are surrounded by a world full of art created by Mother Nature and artists simply try to recreate what nature has already created. What inspiration both nature and artists like Sara can provide."
