## Sutter County Gov-Waste and Incompetence

District Attorney (DA) Amanda Hopper's appearance before county supervisors on October 25 offered a glimpse into the culture of waste and incompetence in Sutter County government. An exasperated Hopper was there to request \$414,500 to purchase vehicles for investigators, attorneys, office staff and victims witness.

Interim County Administrator (CAO) Curt Coad opposed the purchase preferring to have more meetings to resolve differences with the DA's office. Supervisor Whiteaker said he is more comfortable with department heads settling their differences in private, but Whiteaker was aware that the DA and administration met 30 times over two years with no results.

After being elected on November 3, 2014 DA Hopper met with former CAO Jim Arkens on November 10 to discuss the upcoming move of the courts from Second Street to Civic Center Blvd. At that time the DA's office occupied space in the courthouse and across the street.

The courthouse move had been in the works for more than 10-years, but Hopper was shocked county leadership made no plans to move the DA's office with the courts to avoid massive wastes of time and money. In fact, when CAO Arkens was informed by Hopper about the upcoming fiasco created by the January 19, 2016 move, he had no clue about any negative impact upon the DA's office.

Previously, appearing in court, filing and retrieving documents, and assisting victims had been an efficient short walk for DA and Victim Witness employees. Hopper said her attorneys handle up to 200 cases per week moving from one courtroom to another. Secretaries, 1-5 times per day, file and retrieve documents with the courts. Investigators make court appearances, as well.

With the courts now across town, DA employees travel back and forth multiple times per day. Meeting after meeting with the CAO provided no new home for the DA's office or county vehicles for employees to commute.

Finally, the CAO authorized the most wasteful option, rent vehicles from Enterprise Rent-A-Car at \$8668.00/month. Hopper said \$60,328 has been wasted on rentals so far.

Hopper hoped General Services would research cost proposals to obtain vehicles. That is their job. None were forthcoming so desperate DA investigators visited local car dealerships looking for vehicles.

Chief investigator Jason Parker said dealerships offered great prices on vehicles in stock including some that were slightly used. Parker saw significant savings versus purchasing new from the factory and the purchases would benefit local businesses. Unfortunately, the CAO said they had no system to buy used vehicles from local dealers.

What is the cost of top county administrators meeting 30-times over two years to accomplish nothing? According to Transparent California's 2015 salary figures, CAO Arkens earned \$267,598.95, Hopper \$213,671.56 and General Services Director Megan Greve \$183,206.82. For 30-meetings utilizing two administrators and two hours including travel, a minimum of \$15,000 was wasted.

This does not include the cost to coordinate the meetings or investigators shopping for car deals rather than General Services. The lost time/value of DA employees commuting back and forth to court is not considered as well.

In government today, rarely is anyone held accountable. Discussions about the courts relocating began under CAO Larry Combs and continued with subsequent CAOs. Former DA Carl Adams and county supervisors were also involved.

It is hard to believe that none of these people made plans to move the DA's office to complement the courts. It reveals gross incompetence and a lack of regard for wasting taxpayers' dollars. Is Hopper the lone voice crying-out about government incompetence?

With the announcement that Peach Tree Clinic will not renew their contract for space at the health department near the courts, the DA's office will eventually move there. However, the skeptical DA is not expecting the building to be remodeled for two years. It takes two years and 30-meetings for the county to decide to buy a car.

This is government, where people are paid whether they accomplish anything or not and taxpayers cover for lame decisions.

# Area Jewish Settlers - 1849-1880

As Marysville was one of the three main supply communities to the Gold Country, many Jewish settlers joined the "thongs" who descended in the area during the 1850s. Although many remained only a brief period of time, others such as the Marcuse brothers became prominent area Jewish community leaders as well as successful businessmen in both Yuba and Sutter counties.

## THE MARCUSE BROTHERS

Jonas, born in 1832, and Meyer Abraham, born in 1835, were sons of Abraham and Jeanette Marcuse who arrived in America in 1848. Natives of Prussia, the family first settled in Philadelphia where they remained for around five years.

In 1853, the Marcuse family moved to Marysville where Meyer would eventually become a merchant for many years. His Cigar Store on First and D streets was advertised as "importers and dealers in cigars, tobacco and fancy goods."

According to research, Meyer registered to vote in 1867 and had become a citizen "by virtue of his father's naturalization". Two years later, Meyer was elected treasurer of the Agricultural, Horticultural and Mechanical Society of the Northern District of California and remained in that position until 1874. He was also a member of Marysville Lodge No. 38, Ancient Order of United Workmen and was a trustee of the Marysville Woolen Factory.

During this time, no other organization "captured the character of the nineteenth century American Jewish communal culture" as clearly as the Independent Order B'nai B'rith whose objects were charity and benevolence.

These lodges initially collected "an allowance

of eight dollars per week which could be given to a member in good standing in case of sickness. When a death occurred, the widow, or heirs, of the deceased received one thousand dollars. Many merchants and clerks attended their B'nai B'rith Lodge meetings once or twice a month and the local Lodge would be no exception.

When the Miriam Lodge, No. 56 was organized the fifth of May, 1864, Meyer Marcuse became a charter member. At one time the Lodge met at the corner of Third and High streets and had a membership of up to 62 members.

Ten years later, the Ancient Jewish Order--Keshet Shel Bassel, Fidelity Lodge, No. 14, similar to the B'nai B'rith and Odd Fellows, was established in Marysville. However, it soon became evident that there were not enough Jewish people to sustain this lodge so it was disbanded in 1877.

The Rebecca Lodge, No. 6, a degree of the same order into which women were admitted, suffered the same fate and also surrendered its charter in 1877.

As with many families during those years, early death especially of babies and young children became a frequent occurrence. The local Marysville Jewish Cemetery can attest to that. Meyer and his wife Rosetta May were among the fifteen families whose tombstones bear such sad inscriptions. On January 14, 1873 their baby daughter died within 40 hours of her birth. Fortunately, they had a daughter Ida, born in 1865 and a son Henry Meyer, born in 1869 who would later follow in his father's footsteps, becoming a prominent Marysville businessman up until his death in 1914.

## JONAS MARCUSE

Although he remained a relatively brief period of time in the area, Jonas Marcuse definitely left his mark in Sutter County. First settling in Philadelphia with his family in 1848, Jonas did not officially make his home in Sutter County until 1869 when he brought his wife, the former Mrs. Mitteldorfer, and family from their home in Richmond, Virginia. According to history, Jonas had many years earlier purchased property in the Sutter Basin from Samuel Brannan along with Phil Drescher and six others.

Upon his arrival, Jonas first engaged in the mercantile business as well as farming. Eventually he became known as one of the "prime movers" in reclaiming land by adding to his initial earlier investment by purchasing more land from Brannan. In fact, a small community named after him once boasted of a post office, hotel, stores, water works, warehouses and residential homes located on the Sutter Basin Reclamation Road eleven miles from Yuba City.

In 1872, Jonas was elected Sutter County Treasurer, a position he held for two terms. In addition, he operated a grocery business with establishments in Yuba City, located near Second and Bridge streets as well as one in the Basin. Also in 1872, Jonas, along with Caleb Wilcoxon and J.H. Esselstyn, was appointed to "discharge the duties of arranging for a building of a new school house in Yuba City" by Phil W. Keyser, District Judge.

In addition, following the December 1871 courthouse fire, Jonas was once again appointed to serve on a committee regarding the general supervision of the building of a courthouse and jail in Yuba City.

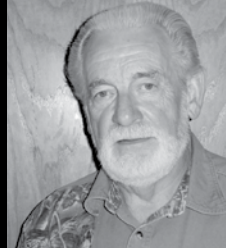
Despite his many prominent roles in the Sutter County area, Jonas returned to Virginia between the 1880s to 1900. His sons, however, remained to develop the family holdings in the Sutter Basin. All that is left to this day is the sign--Marcuse Road.

# Food and Farm News

## Wet October helps reservoir storage

As California ends the first month of its rainfall season, reservoir storage has improved, compared to a year ago. Figures from the California Department of Water Resources show the state's largest reservoir, Shasta, holds just more than average, as do Don Pedro Reservoir and Millerton Lake. Many other reservoirs remain below average for the date, despite a wet month, but hold more water than they did at the end of October last year.

## Kiwifruit farmers see demand grow

Kiwifruit has become increasingly popular as more people learn of its health benefits, and that has led California farmers

to plant more. The Sacramento-based Kiwifruit Administrative Committee says growers are planting new vineyards of both the standard, green-fleshed fruit plus new, gold-fleshed varieties. Kiwifruit harvest in Central and Northern California began in early October and will continue through November, with growers reporting improved yields.

## Farmers report good pepper yields, quality

Farmers continue to harvest peppers both in Northern California and in desert growing regions. Growers say they've seen good quality and yields for both bell peppers and chili peppers. October rains interrupted harvests briefly, but farmers say they remain long-term concern

about water availability. California farms produce about 60 percent of the bell peppers grown in the U.S., and nearly 70 percent of the chili peppers.

## Grant program benefits new food products

New California food products will benefit from a set of federal grants. The U.S. Department of Agriculture provides the grants to help farmers, ranchers, small businesses and cooperatives develop new products or promote new uses for established products. The 15 California projects to receive funding involve products such as lamb jerky, apple granola, persimmon vinegar and a variety of other foods.

**Jack Reacher: Never Go Back**

This is the second installment of the Jack Reacher franchise to be adapted to the big screen. The movie begins at the end of another story and enjoys a segue into the next round of smashing, breaking, and maiming. Retired Major Reacher, returns to visit his old unit only to find the commanding officer arrested for espionage. Well, the formidable Mr. Reacher has no capacity to stand for that and violence ensues. With the subtlety of a brick through the windshield Reacher brings the hard fist of justice down so forcefully the camera shakes and swings wildly at times. The story rolls along at a moderate pace and the action covers most plot holes and the acting is pretty good. What Tom Cruise lacks in stature for the Jack Reacher character he makes up for in intensity and spirit.

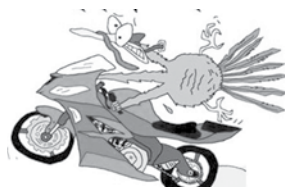

# Many At-Risk Airbag Inflators Remain on Cars in California

California State departments that oversee vehicle and driver safety are warning that owners of tens of thousands of vehicles, particularly Hondas and Acuras, may not have received or have overlooked the recall notices urging replacement of potentially deadly Takata airbag inflators. Recall repairs are free of charge to all vehicle owners.

The California Office of Traffic Safety, California Highway Patrol, California Department of Motor Vehicles and Bureau of Automotive repair are working together to urge Californians who own certain 2001-2003 Honda and Acura vehicles to immediately take their cars to an authorized dealer for repair of potentially deadly Takata airbag inflators.

Recall notices have already been sent to registered owners of affected vehicles, but who have not yet taken action on the required recall repair. These vehicles are at high risk of an airbag inflator rupture. When a recalled airbag inflator ruptures, pieces of metal could shoot through the airbag cushion and hit the driver or passengers, resulting in serious injuries or deaths. While all areas of the state are affected, portions of certain counties have the greatest concentrations of recalled vehicles with owners who have not been heard from. These include east and south Bay Area regions, northern Monterey County, the Central Valley, northern and central Los Angeles County, western Riverside and San Bernardino counties, and San Diego County along the border. However, not being in one of these areas does not mean your airbag is safe.

Honda/Acura urges affected drivers to immediately call 1-888-234-2138 for repair information. The U.S. Department of Transportation recommends that these vehicles only be driven to an authorized dealer in order to have the Takata airbag inflators replaced as rapidly as possible. To search for an authorized dealer, consumers can visit [www.recalls.honda.com](http://www.recalls.honda.com) or [www.recalls.acura.com](http://www.recalls.acura.com) depending on the make of their vehicle.

Consumers also can find answers to general questions about the Takata airbag inflator recalls, including about the higher risk inflators in these vehicles, at the following site: <http://hondaairbaginfo.com/faq/>.

Any concerned customer can also contact Honda/Acura's Automobile Customer Service at 888-234-2138.

The replacement of the Takata airbag inflator is free of charge for all customers. Customers are not obligated to have unrelated maintenance or other vehicle issues fixed at the same time as the recall repair. Honda/Acura will provide a loaner car, if necessary, while a customer's car is being repaired and a Honda/Acura dealer can also arrange to tow a vehicle to and from the desired location at no cost.

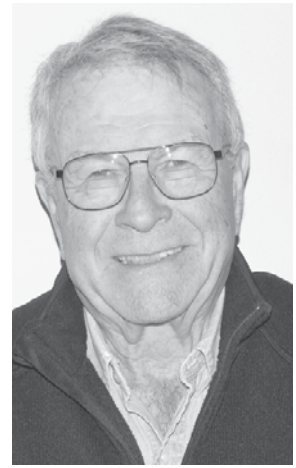

### Fairness Initiative, Anything But Fair to the Citizens of Yuba County

In 1958 the Yuba County Water Agency was formed as a result of the devastating flood of 1955. After seven years of acquiring permits and an engineering design, a Federal Power Commission License was approved in 1966 to construct the Yuba River Development Project. With over 90% voter approval, the citizens of Yuba County approved a bond issue for \$ 180 million which was two and a half times the total assessed value of all the private property in Yuba County. The people of Yuba County were united in building for the future. In today’s world of political polarization this does not happen. May of 1966 Yuba County Water Agency entered into a 50 year power purchase contract with Pacific Gas and Electric Company. This was known as a “Hell or High Water” contract

whereby PG&E guarantees the payment of the bonds, maintenance and operations and improvements in return for all of the power produced.

The Yuba County Water agency was created to benefit ALL citizens of Yuba County!

If you RENT property you do not participate in any portion of this. How many of the water right holders have taken advantage of groundwater stabilization, created by YCWA, to pump and sell millions of dollars of water down south? This initiative was written to benefit a few large landowners and public entities that are in desperate need of cash. In doing so they are attempting to re-write the State legislation that created the agency.

# History of Veterans Day

World War I, known at the time as "The Great War", officially ended when the Treaty of Versailles was signed on 28 June 1919 in the Palace of Versailles outside the town of Versailles, France. However, fighting ceased seven months earlier when an armistice or temporary cessation of hostilities between the Allied nations and Germany went into effect on the eleventh hour of the eleventh day of the eleventh month. For that reason 11 November 1918 is generally regarded as the end of "the war to end all wars".

In November 1919, President Wilson proclaimed 11 November as the first commemoration of Armistice Day with the following words: "To us in America, the reflections of Armistice Day will be filled with solemn pride in the heroism of those who died in the country's service and with gratitude for the victory, both because of the thing from which it has freed us and because of the opportunity it has given America to show her sympathy with peace and justice in the councils of the nations." The original concept for the celebration was for a day observed with parades and public meetings and a brief suspension of business beginning at 11:00 a.m. The United States Congress officially recognized the end of World War I when it passed a concurrent resolution on 4 June 1926, with these words: Whereas the 11th of November 1918, marked the cessation of the most destructive, sanguinary, and far reaching war in human annals and the resumption by the people of the United States of peaceful relations with other nations, which we hope may never again be severed, and Whereas it is fitting that the recurring anniversary of this date should be commemorated with thanksgiving and prayer and exercises designed to perpetuate peace through good will and mutual understanding between nations; and Whereas the legislatures of twenty-seven of our States have already declared 11 November to be a legal holiday: Therefore be it Resolved by the Senate (the House of Representatives concurring), that the President of the United States is requested to issue a proclamation calling upon the officials to display the flag of the United States on all Government buildings on 11 November and inviting the people of the United States to observe the day in schools and churches, or other suitable places, with appropriate ceremonies of friendly relations with all other peoples. An Act (52 Stat. 351; 5 U. S. Code, Sec. 87a) approved 13 May 1938, made the 11th of November in each year a legal holiday; a day to be dedicated to the cause of world peace and to be thereafter celebrated and known as "Armistice Day". Armistice Day was primarily a day set aside to honor veterans of World War I but in 1954: after World War II had required the greatest mobilization of soldiers, sailors, Marines and airmen in the Nation's history; after American forces had fought aggression in Korea, the 83rd Congress, at the urging of the veterans service organizations, amended the Act of 1938 by striking out the word "Armistice" and inserting in its place the word "Veterans". With the approval of this legislation (Public Law 380) on 1 June 1954, 11 November became a day to honor American veterans of all wars. Later that same year, on 8 October, President Dwight D. Eisenhower issued the first "Veterans Day Proclamation" which stated: "In order to insure proper and widespread observance of this anniversary, all veterans, all veterans' organizations, and the entire citizenry will wish to join hands in the common purpose. Toward this end, I am designating the Administrator of Veterans' Affairs as Chairman of a Veterans Day National Committee, which shall include such other persons as the Chairman may select and which will coordinate at the national level necessary planning for the observance. I am also requesting the heads of all departments and agencies of the Executive branch of the Government to assist the National Committee in every way possible".

On that same day, President Eisenhower sent a letter to the Honorable Harvey V. Higley, Administrator of Veterans' Affairs (VA), designating him as Chairman of the Veterans Day National Committee. In 1958, the White House advised VA's General Counsel that the 1954 designation of the VA Administrator as Chairman of the Veterans Day National Committee applied to all subsequent VA Administrators. Since March 1989 when the VA was elevated to a cabinet level department, the Secretary of Veterans Affairs has served as the committee's chairman. The Uniform Holiday Bill (Public Law 90-363 (82 Stat. 250)) was signed on 28 June 1968 and was intended to ensure three-day weekends for Federal employees by celebrating four national holidays on Mondays: Washington's Birthday, Memorial Day, Veterans Day, and Columbus Day. It was thought that these extended weekends would encourage travel, recreational and cultural activities and stimulate greater industrial and commercial production. Many states did not agree with this decision and continued to celebrate holidays on their original dates. The first Veterans Day under the new law was observed with much confusion on 25 October 1971. It was quite apparent that the commemoration of this day was a matter of historic and patriotic significance to a great number of our citizens and so on 20 September 1975 President Gerald R. Ford signed Public Law 94-97 (89 Stat. 479) which returned the annual observance of Veterans Day to its original date of 11 November beginning in 1978. This action supported the desires of the overwhelming majority of state legislatures, all major veterans' service organizations and the American people. Veterans Day continues to be observed on 11 November regardless of what day of the week on which it falls. The restoration of the observance of Veterans Day to 11 November not only preserves the historical significance of the date but helps focus attention on the important purpose of Veterans Day: A celebration to honor America's veterans for their patriotism, love of country and willingness to serve and sacrifice for the common good. ---To all who have served, who signed that blank check to the United States of America.

Munger said referring to DG, "Those f..ers. I'm going to be hard to get along with. That's my retirement that store (referring to the store he owns)."

However, to Sutter County's Munger they are "Those F..ers" since he wants no competition in the town of Sutter. To normal people Dollar General is the class act. Munger's behavior embodies what the public despises in politicians.

## Yuba County Gets \$75,000 Grant for Car Seat Education

There are steps we can all take to make sure children are better protected when riding in vehicles, and a new \$75,000 grant to Yuba County Health and Human Services Department will help get that information to area residents.

The grant from the California Office of Traffic Safety (OTS) will be used by county staff to conduct a year-long education and awareness program on how to protect children in and around vehicles. The outreach effort will be part of Yuba County Public Health's ongoing commitment to child passenger safety.

According to the National Highway Traffic Safety Administration (NHTSA), car crashes are a leading cause of death for children ages one to thirteen years old in the United States. The best way to protect children in cars is to put them in

the right seat at the right time, and to use the car seat the right way.

"The American Academy of Pediatrics (AAP) advises parents and caregivers to keep their children in rear-facing car seats until age two," said Yuba County Health Officer Dr. Nichole Quick. "A rear-facing car seat does a much better job of supporting and preventing injury to the head, neck, and spine of children under two."

This recommendation from the AAP is the reason for the new car seat law being implemented January 1, 2017. Children in California must remain in a rear-facing car seat installed in the back seat of the vehicle until they are at least two years of age.

Making sure that a child's car seat is age and size appropriate is one of the best ways of keeping them safe. Most children need to ride in a belt-positioning booster seat until they have

reached four feet, nine inches tall and are between eight and twelve years of age.

This grant funding will provide opportunities to educate parents, caregivers, community agencies and children on the importance of safety in and around vehicles. Yuba County Public Health will hold free monthly car seat education classes in English, Spanish, and Hmong. Yuba County residents will get education on proper car seat installation and use, learn about California laws, and be shown ways to keep children safe in and around vehicles. Free car seats are available at the conclusion of each class.

# Beauty Is In The Eye of the Perceiver

As seen in the Veterans Day Parade

One of the wonderful things about the Vintage Tractor Hobby is that it is a great medium for creative efforts. You can parade, take grandkids for rides, teach people how to drive them, (yes they have manual clutches) go on drives, play games, dance with them, and paint them as you see fit. They can be turbo-charged for competition pulling. You can make them wide for big seats, and you may decide to put dual wheels on them just because you like them that way.

Old tractors, like Nanotechnology, going to the moon, or creating a vehicle for hypersonic flight-if you can think it you can do it!

One such dreamer is Walt Keller of Brownsville. His vision was a Big Brother-Little Brother look alike. He chose the John Deere G and the John Deere H for his creation.

A goal powered by persistence, a little money, and a great work ethic developed the pair to reality. He picked two perfect tractors for the achievement.

I have heard many stories about the G cutting beans in the Basin. They were the big boys of the time and are a favorite of the "Pullers" these days. The little guy H was designed for the small farm. The H replaced a team, and performed a variety of tasks on the larger farms such as mowing small fields, cutting wood, pumping water or maybe pulling fruit on a wagon.

The early form of the G was built from 1938 to 1941. The later configuration was manufactured from 1941 to 1953. About 64,000 left the factory. Early Gs developed 27.63 hp on the drawbar and 35.91 on the belt/pto. Weight was approximately 4,000 pounds and cost in the neighborhood of \$1,185. The price grew to \$2,600 by 1953 as new improvements were included.

1938 and 1939 featured the famous low radiator and the large radiator came on line to 1941. World War II forced changes with electrical and rubber mostly and the GM was sold in this time frame. Production stopped on September 21 1942 and resumed on October 16th 1944. The steel wheeled GM required a Four Speed transmission. The later unit provided 34.49'hp on the drawbar and 38.10 on the belt/pto. Power ran through a six speed transmission and weight rose to 5,624 pounds Maximum pull rating was 4,394 pounds. The G came out as a G, GM, GW(wide, GN(narrow), and GH (hi crop). The standard G sold for \$1,8879, the GW for \$1,970 and the GH for \$3,180. The GW was the most popular and production ended February 19, 1953.

The little H was built from 1939 to 1947. About 58,263 were manufactured and some claim 60,000. The two cylinder engine developed 12.48 hp on the drawbar and 14.80 on the belt/pto. Max pull was 1,839. The power was transferred through a

three speed transmission. Weight was near 3,000 pounds depending on options. The price in 1939 was in the area of \$600 for a standard H and became \$639 by 1944.

It was produced as a H,HN,HWH, and HNH. Nearly 1,100 HNs were produced, about 126 HWHs and 37 HNHs were shipped. Most of the HNH and HWHs came to California.

Production stopped on April 29, 1942 and resumed on April 29, 1943.

The design goals for the H were met. A lower price was achieved by using

fewer parts, and improved materials. Lower operating costs included an all fuel engine for using fuels that were of lesser price, light weight, large rubber tires and a foot throttle override for higher road speeds. The pto came off the camshaft, not the crankshaft and by using a larger belt pulley speeds were reduced. This concept caused the belt to go in a reverse direction and this is unique to the H.

Walt's creations can be seen in local parades and he invites you to take a peek, smile, and wave as he goes by the crowds.

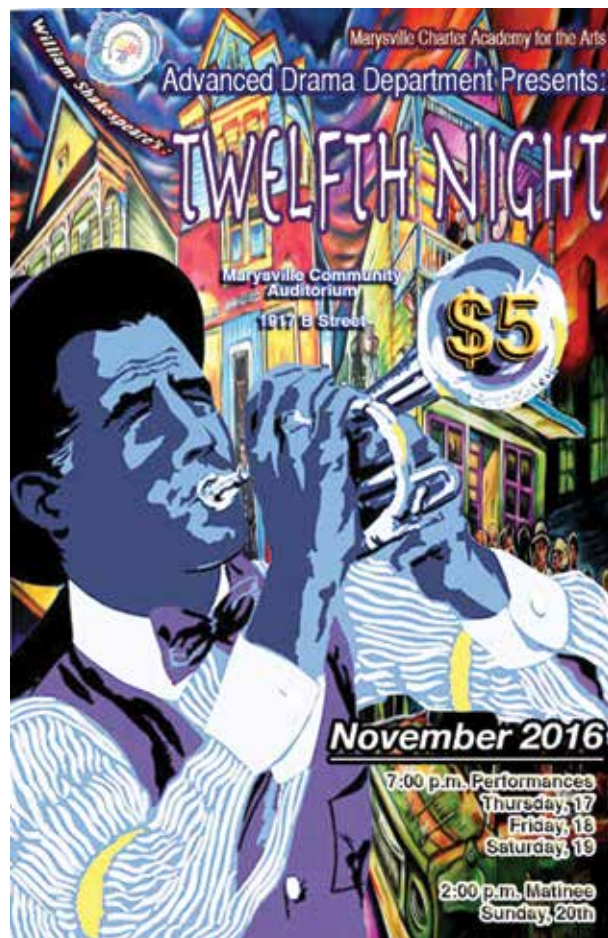

## Walnut Buying Period Announced

Yuba County and Sutter County Began November 1

The Walnut Buying Period began November 1, for Yuba and Sutter County's pursuant to county Walnut Theft Prevention ordinances.

The Walnut Buying Period is the declared conclusion of harvest of the Chandler variety of walnuts, during which non-processing walnut buying operations within the county's may lawfully purchase and receive walnuts that have not been dried or processed.

The walnut industry has been vulnerable to

theft due to the manner in which the nuts are harvested. Typically the walnuts are shaken from the trees and left in windrows until they are collected by harvesting equipment. Unfortunately some people steal them from orchards and sell the walnuts illegally. The Walnut Theft Ordinance is intended to deter such activities.

Walnuts are the highest valued agricultural commodity in Yuba County. According to the Yuba County 2015 Crop Report, there were 14,020 harvested

acres in Yuba County with a market value of over \$52 million.

Walnuts are the second highest valued agricultural commodity in Sutter County. According to the Sutter County 2015 Crop Report there were 26,496 harvested acres in Sutter County with a market value of \$77,454.00.

"In addition to establishing the buying period, the ordinance also establishes requirements regarding the transportation and identification of walnuts as well as requiring "proof of ownership" documentation for possessors and buyers of walnuts.
